(57) **CLAIM**

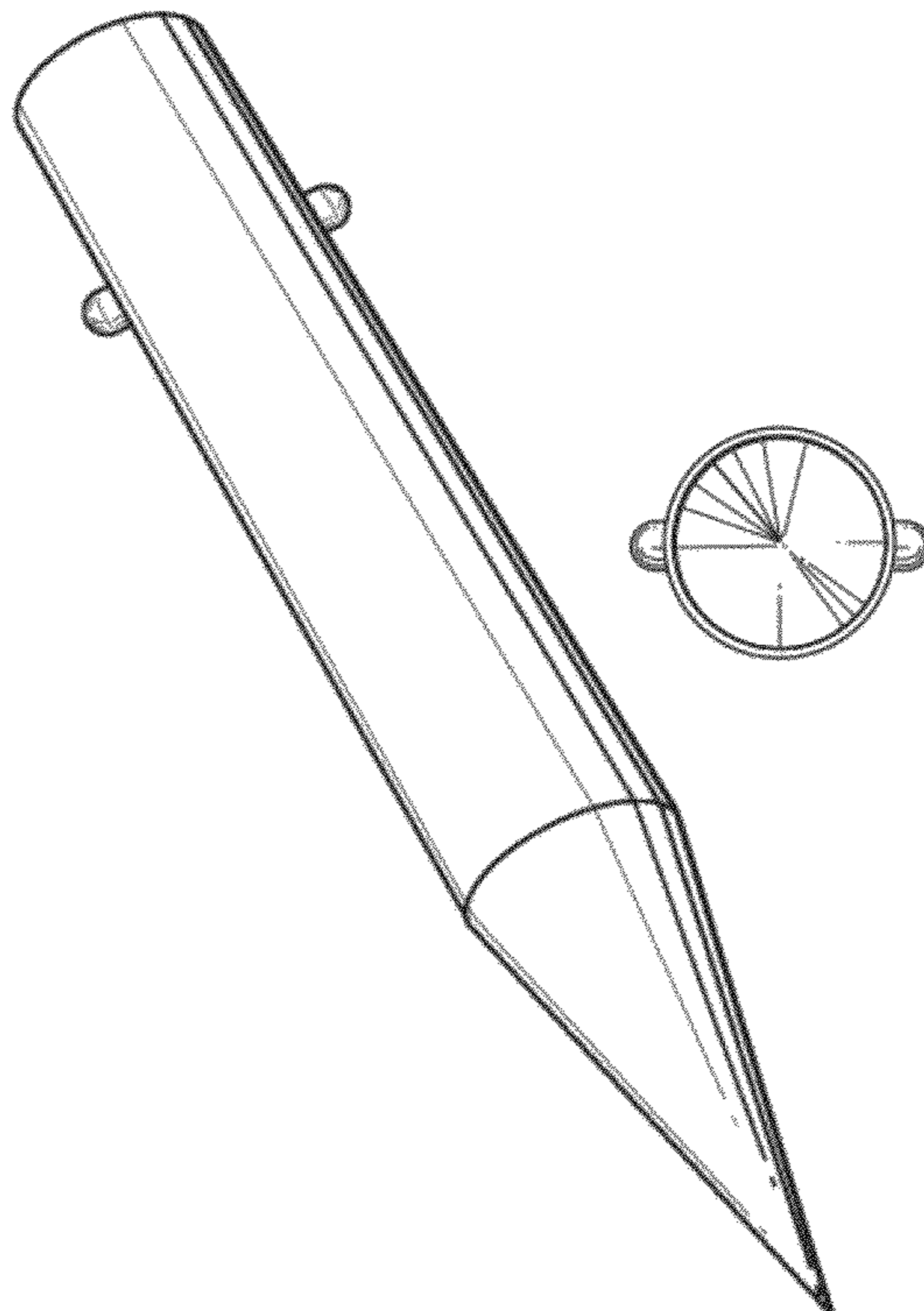
The ornamental design for a flag holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flag holder showing my new design in a position of use;
FIG. 2 is an enlarged perspective view of a flag holder;

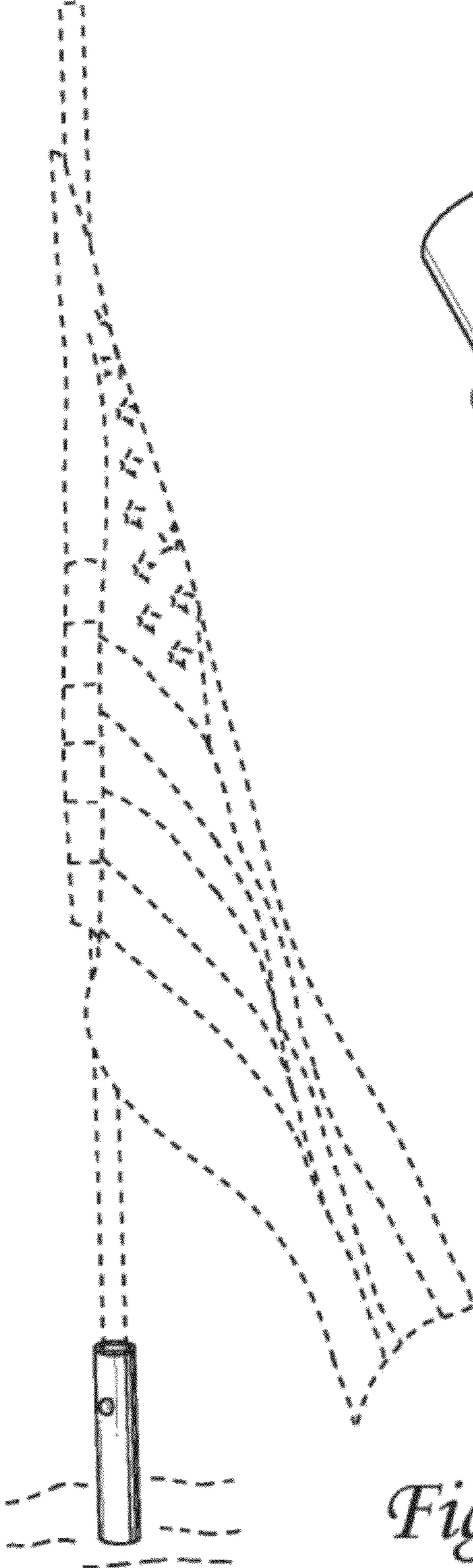

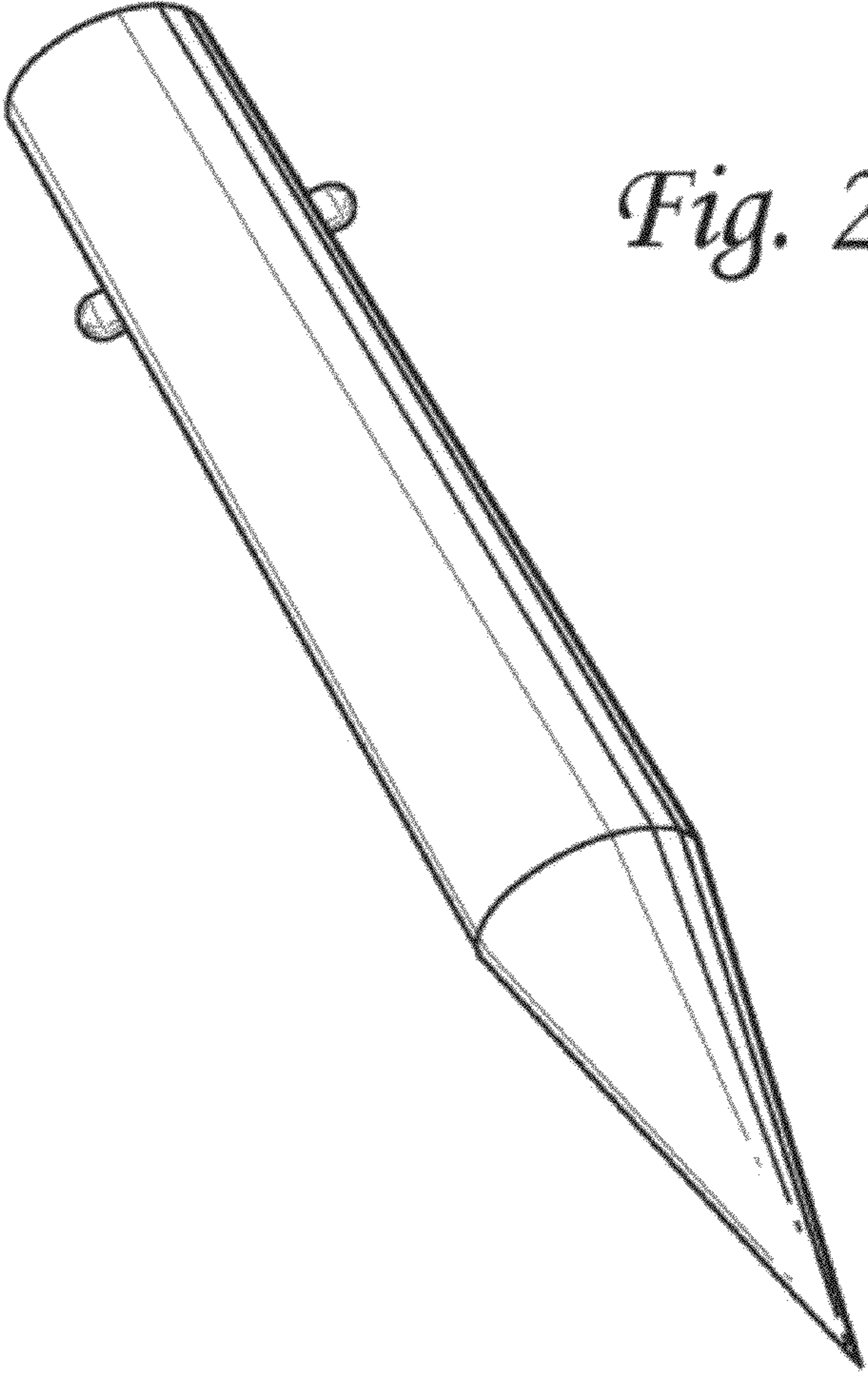

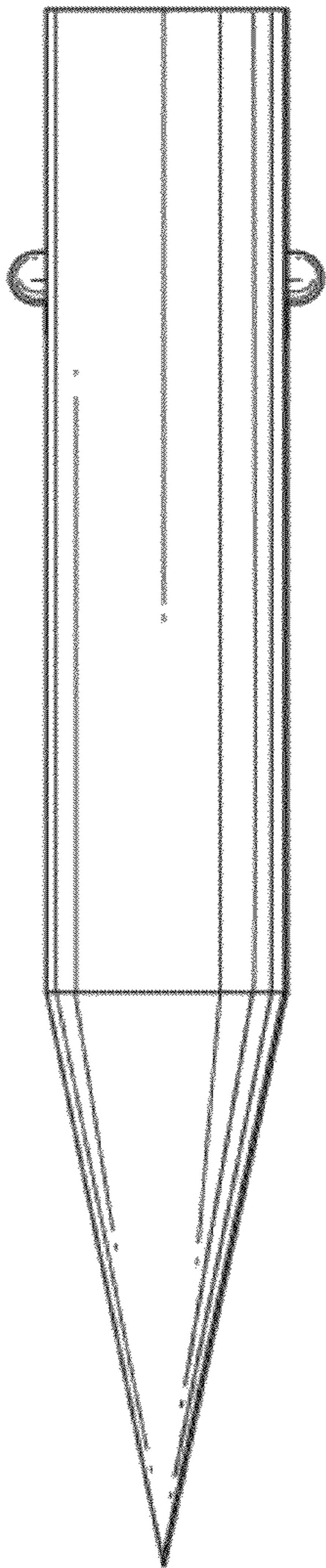

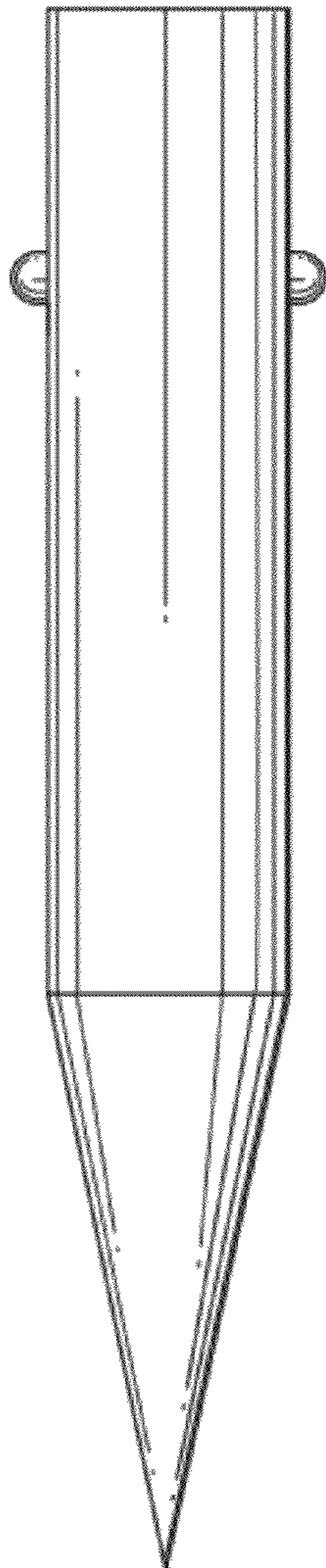

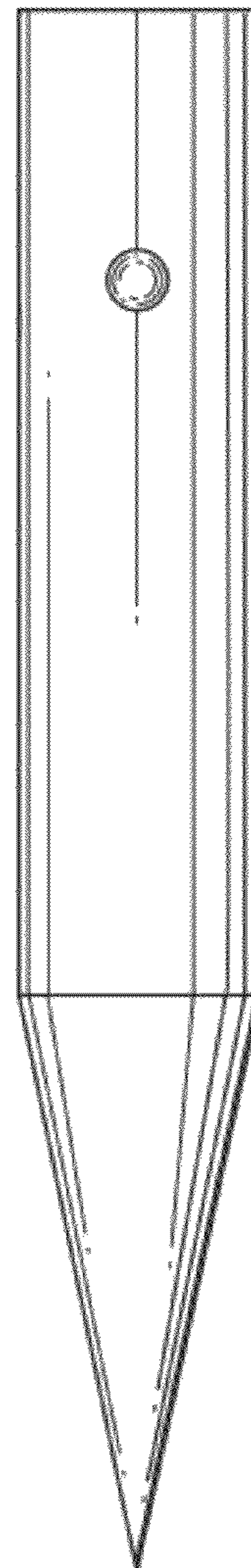

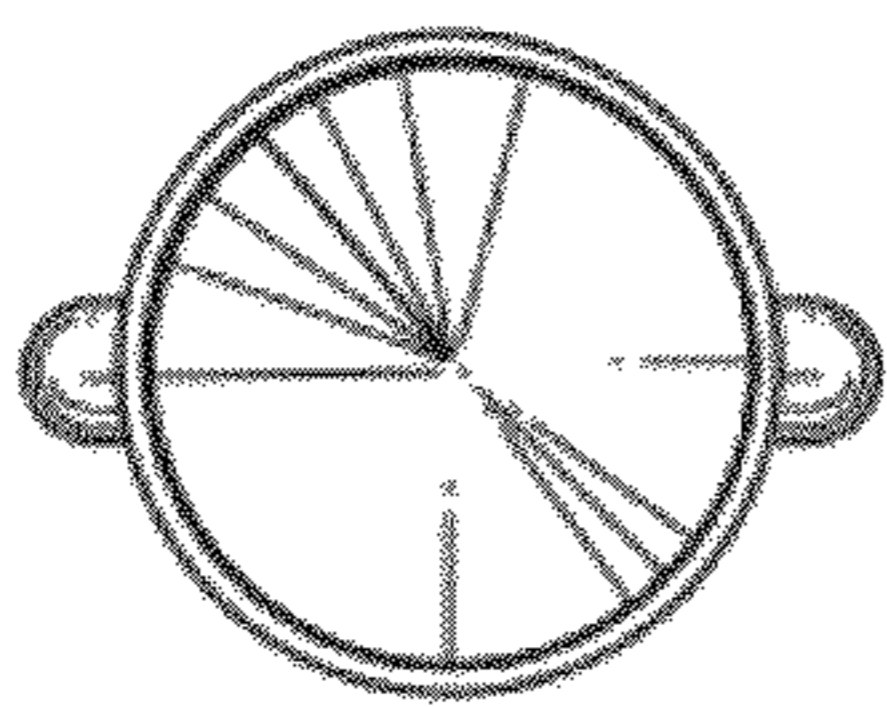

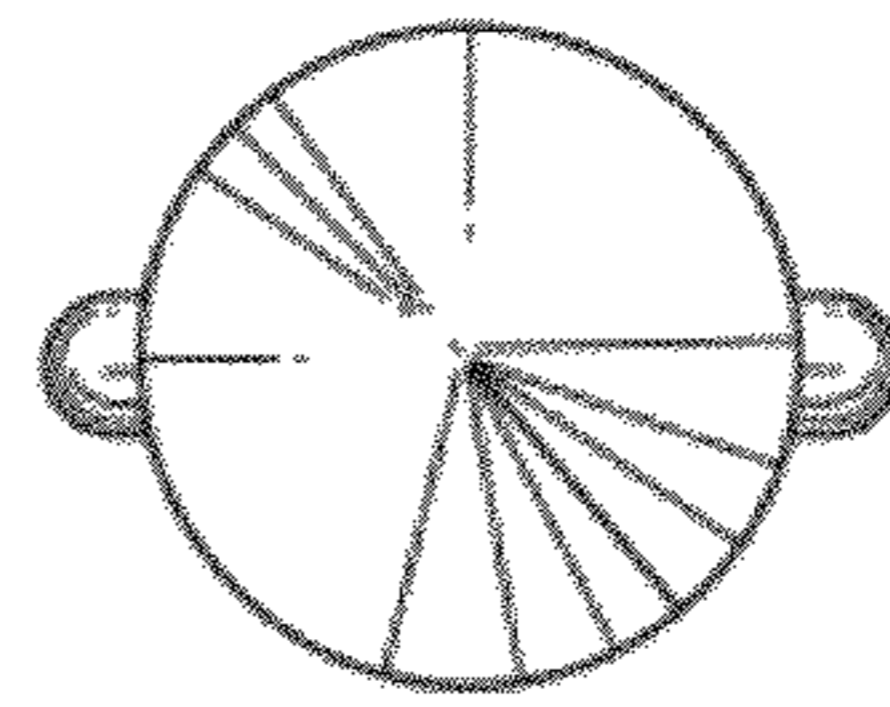
