FIG. 4 is a plan view of the hand covering.

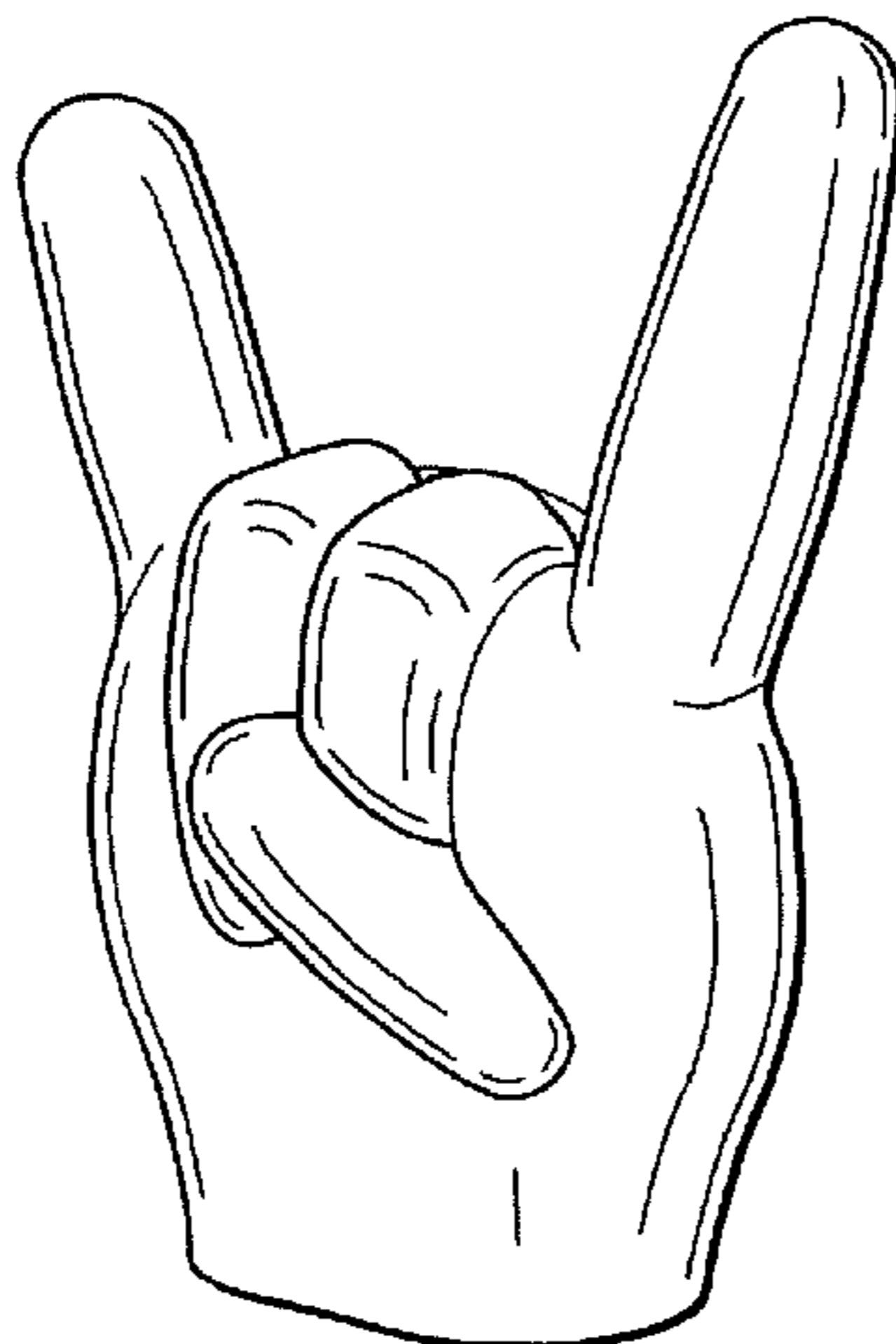
FIG. 5 is a back elevation of the hand covering.

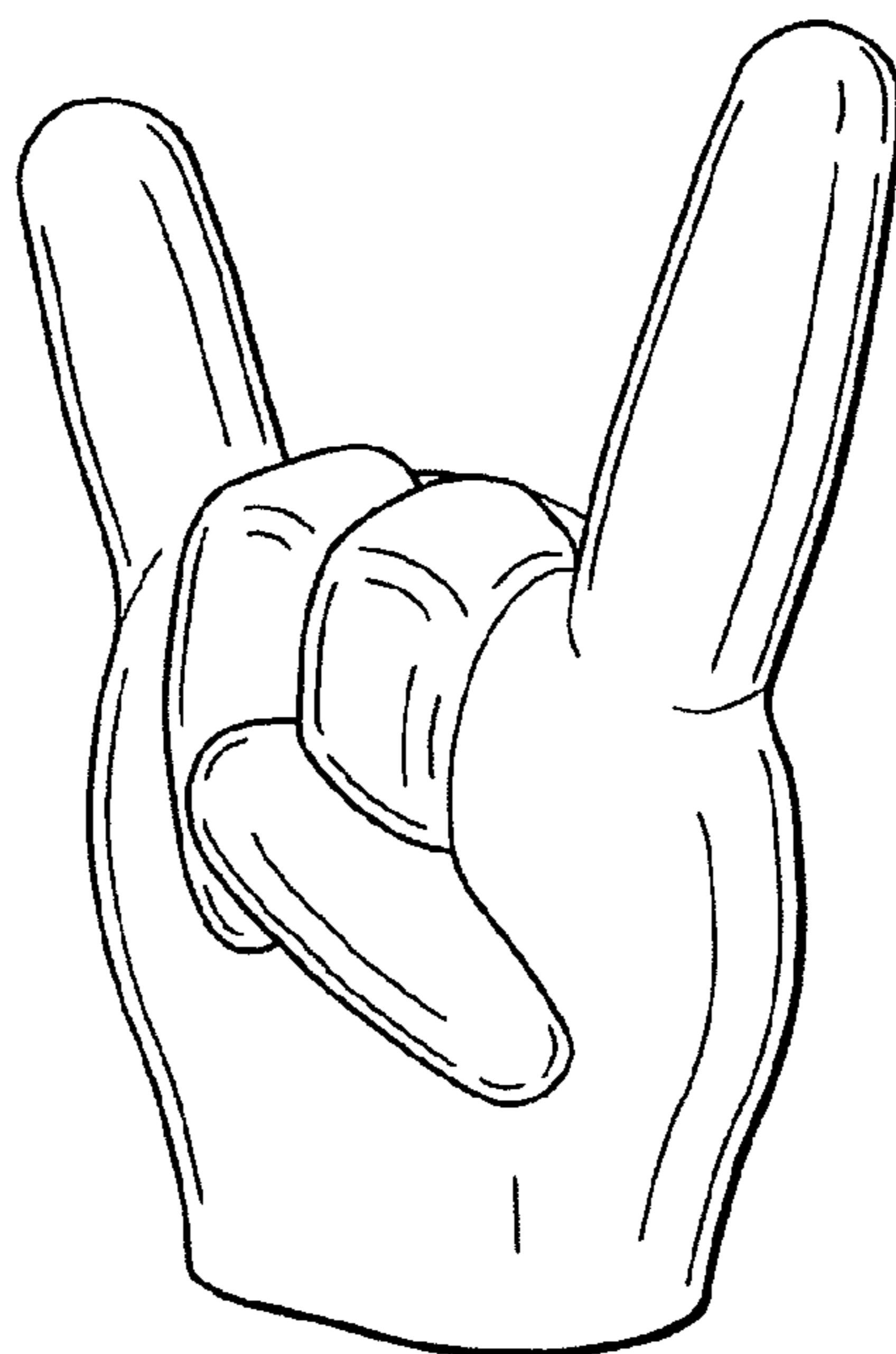

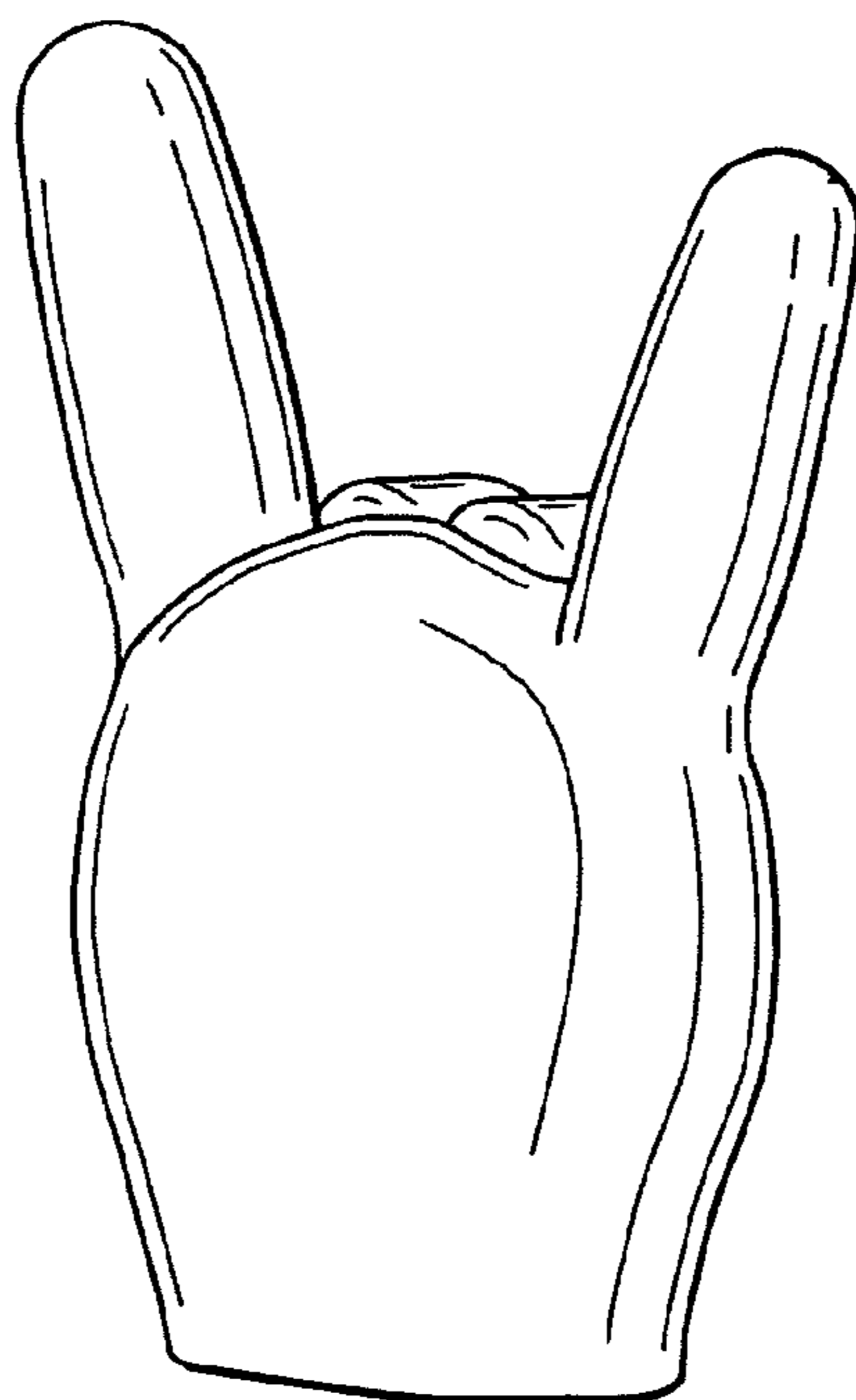

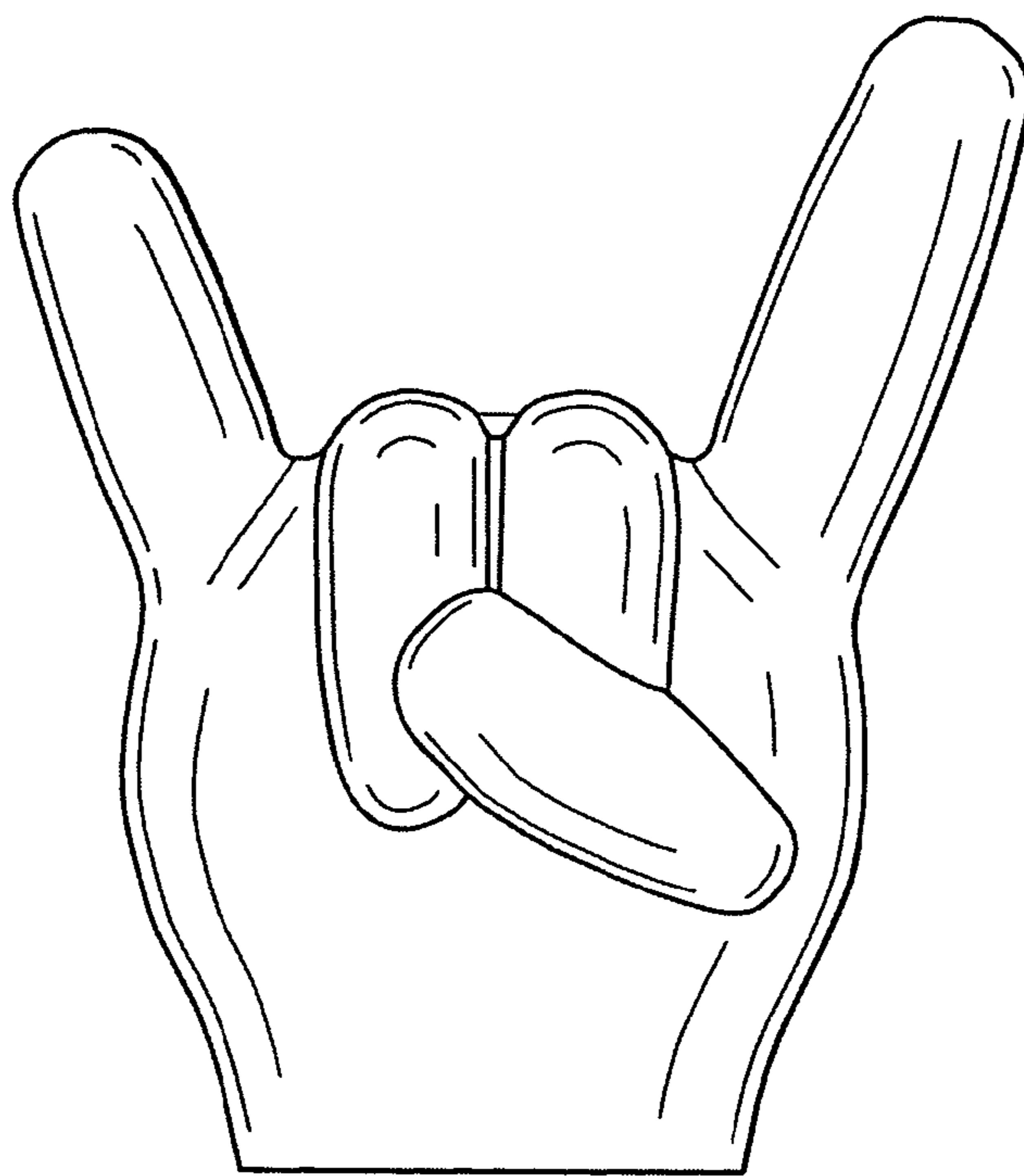

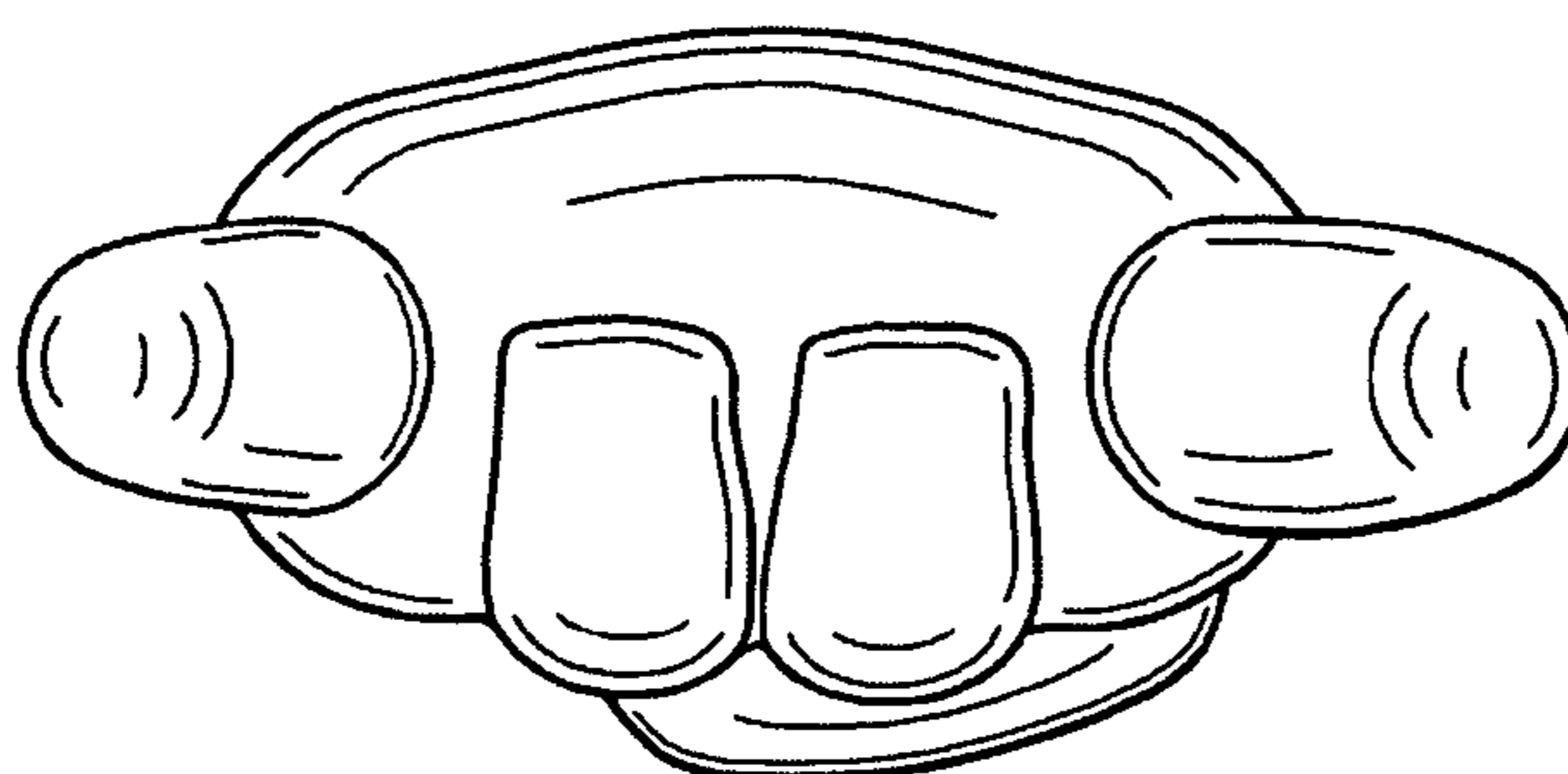

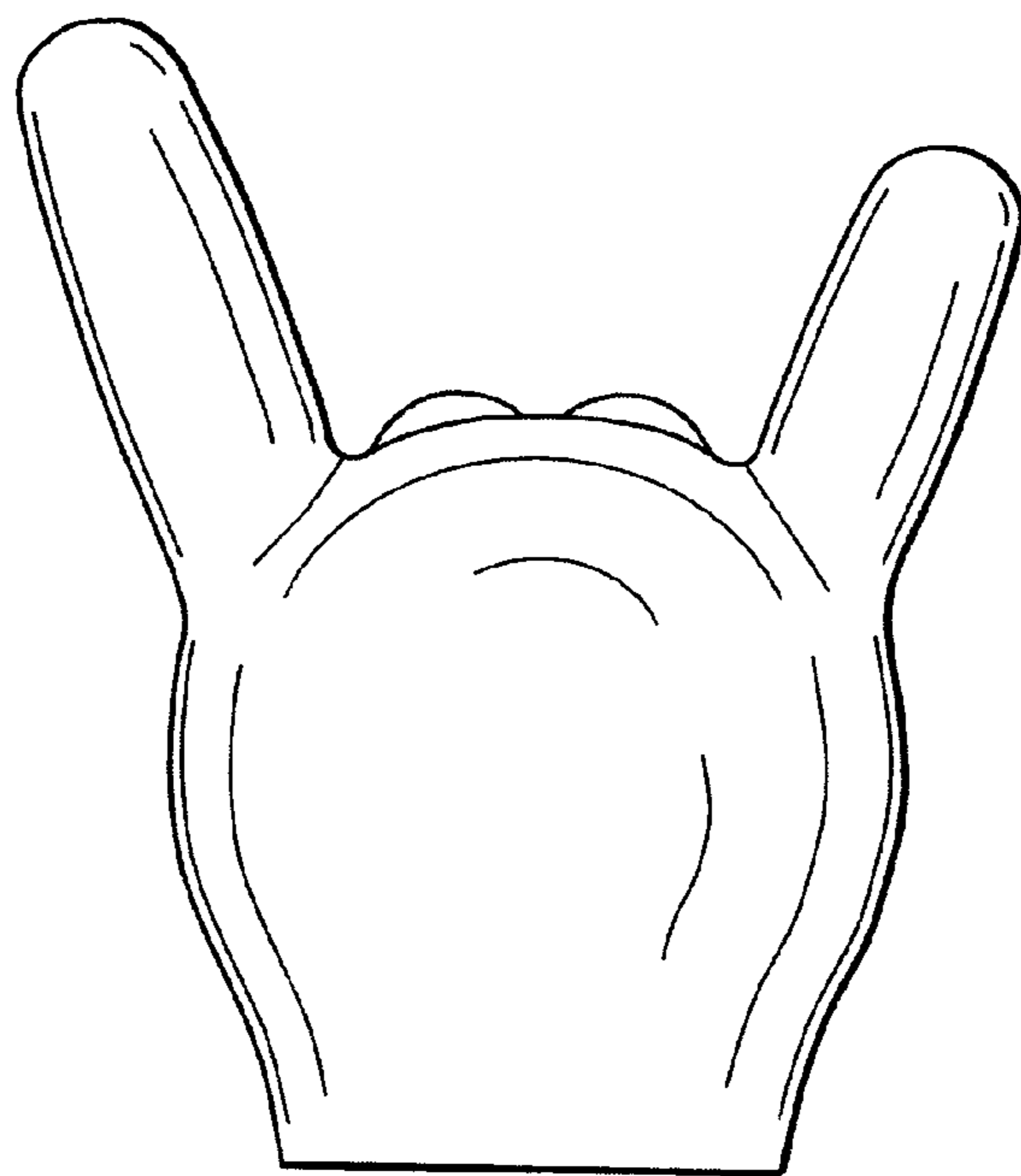

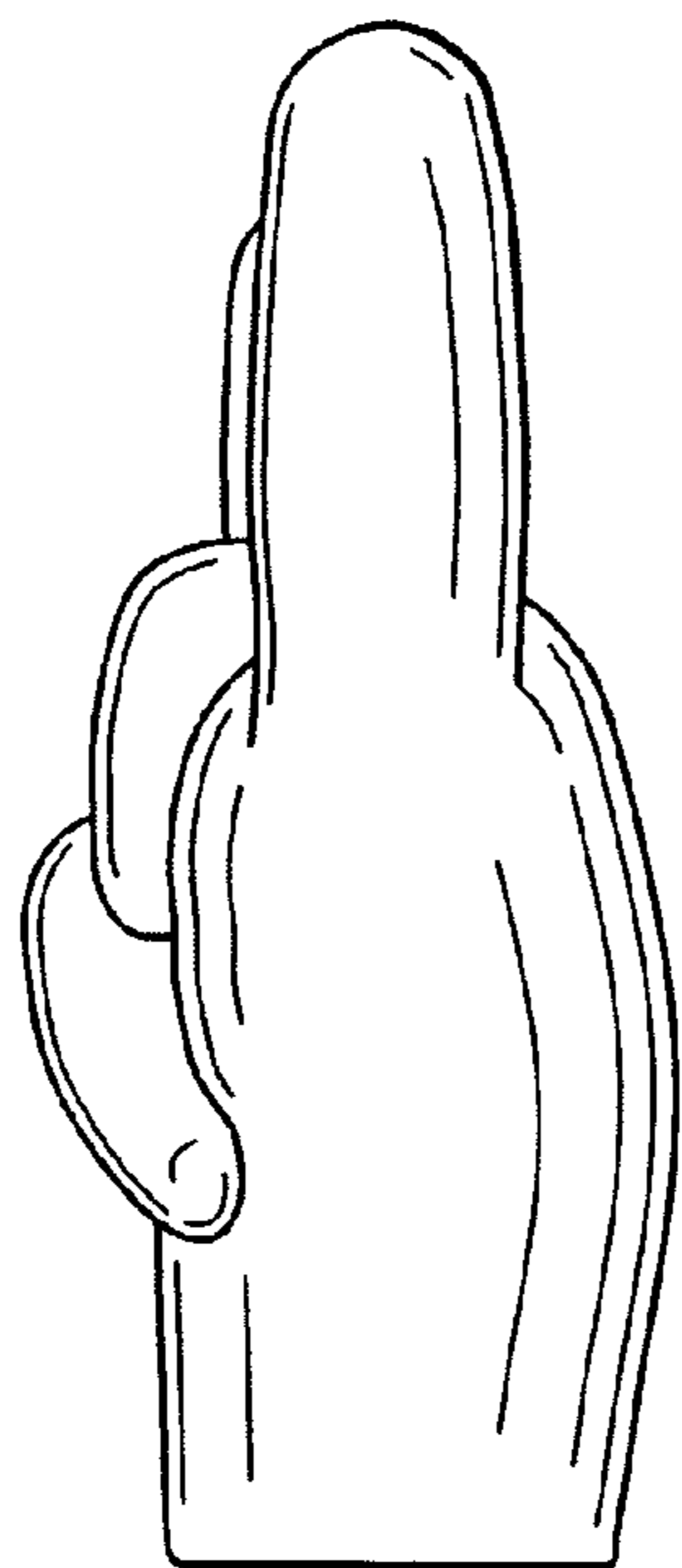

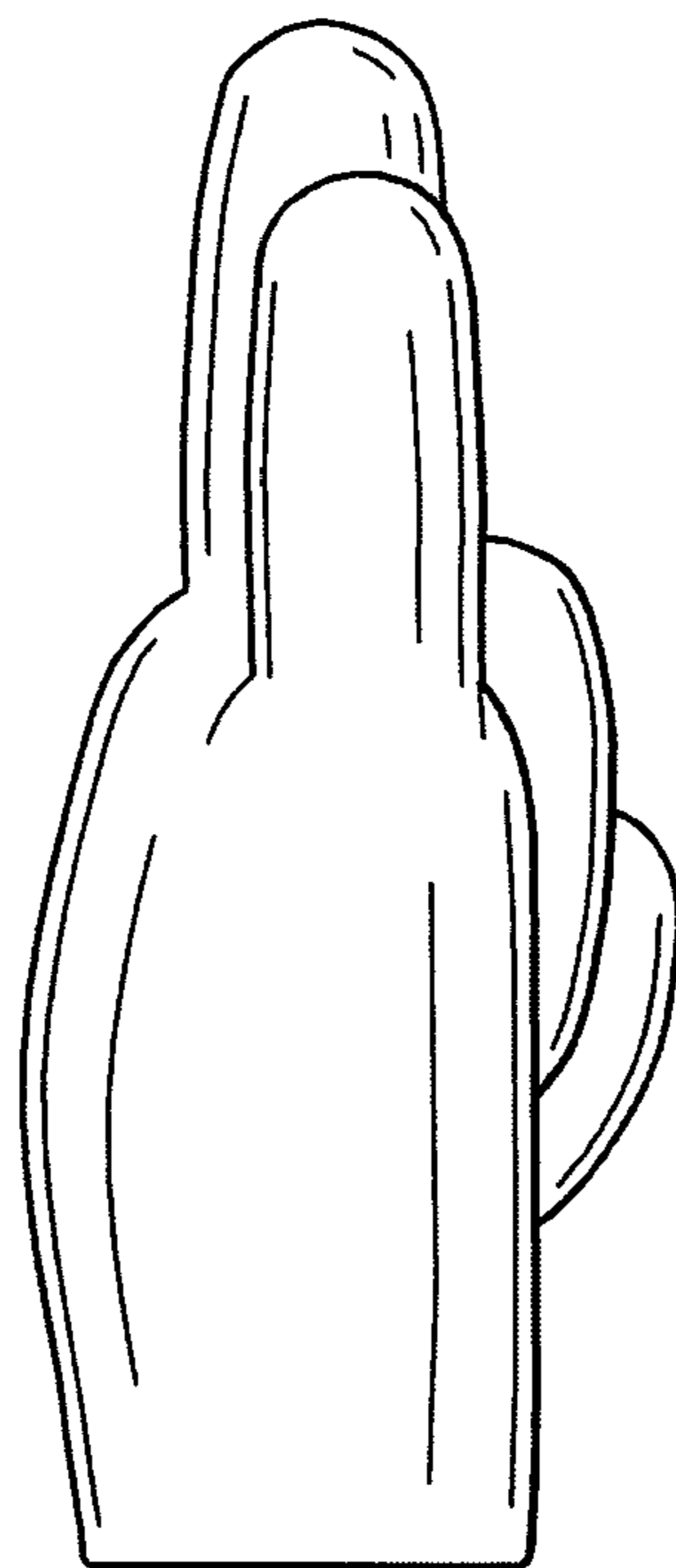

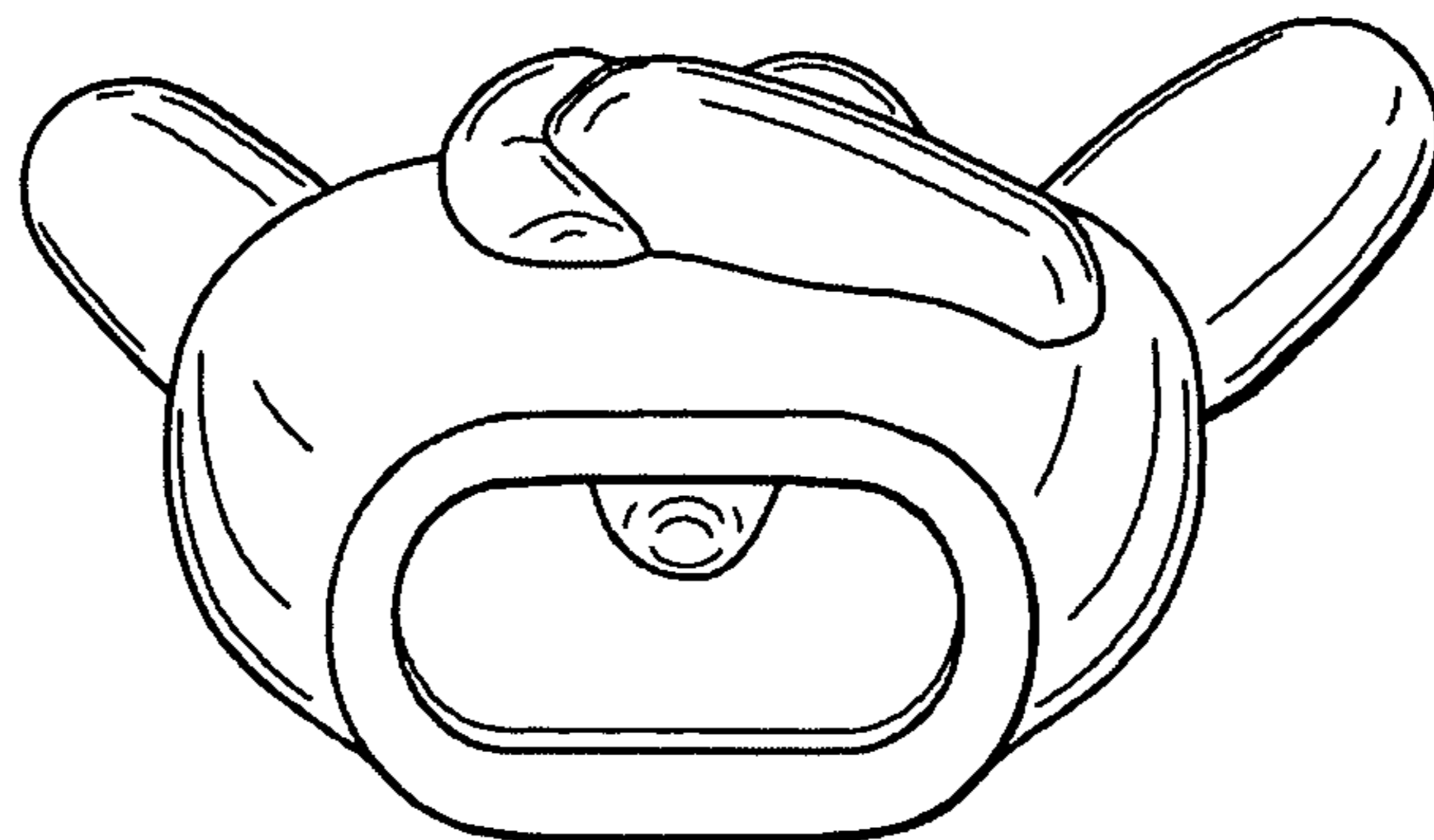
