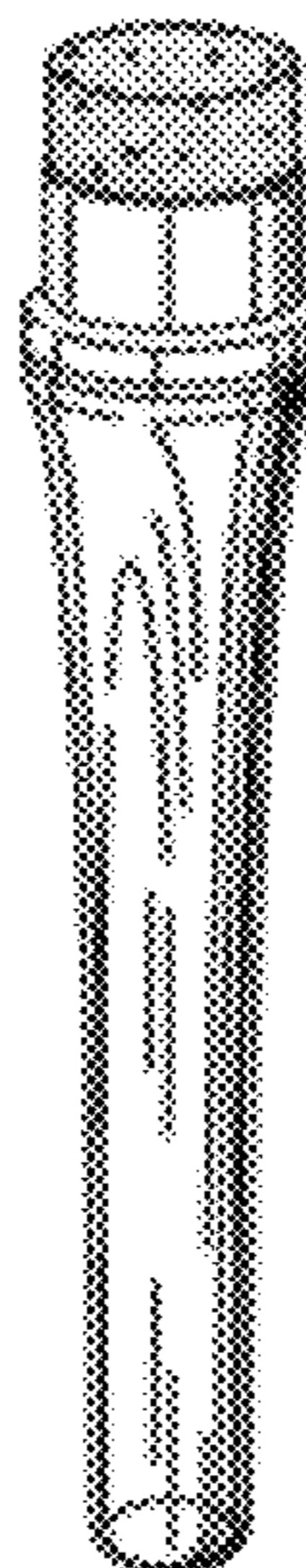
(57) **CLAIM**

The ornamental design for an oral care applicator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an oral care applicator, embodying the new design;
FIG. 2 is a rear side view of the oral care applicator of FIG. 1;
FIG. 3 is a top planar view of the oral care applicator of FIG. 1; and,
FIG. 4 is a bottom planar view of the oral care applicator of FIG. 1.

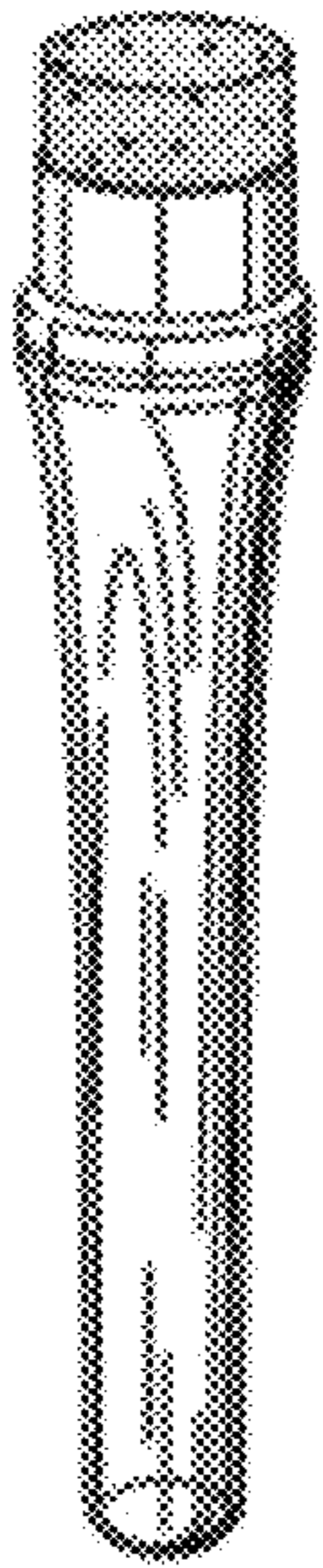

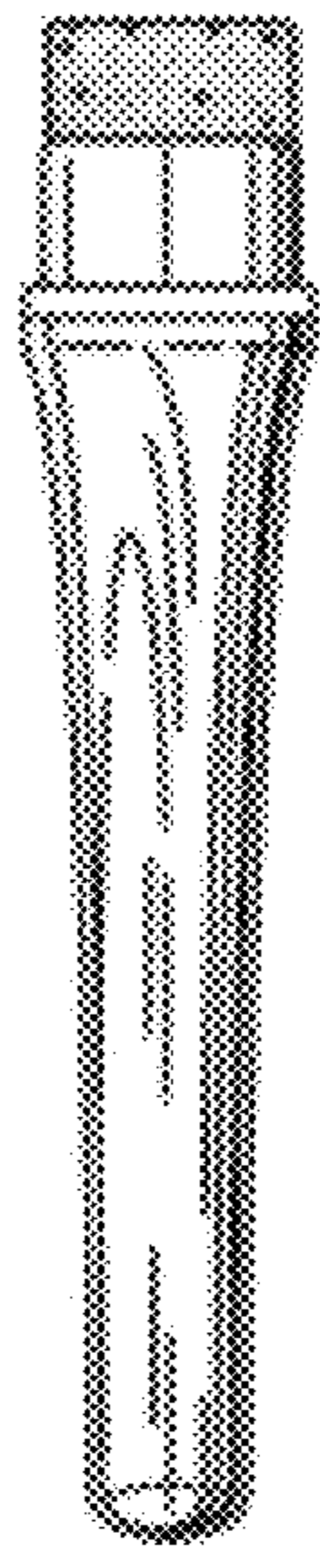

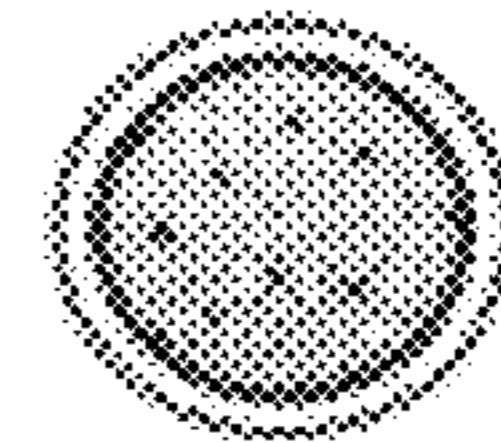
