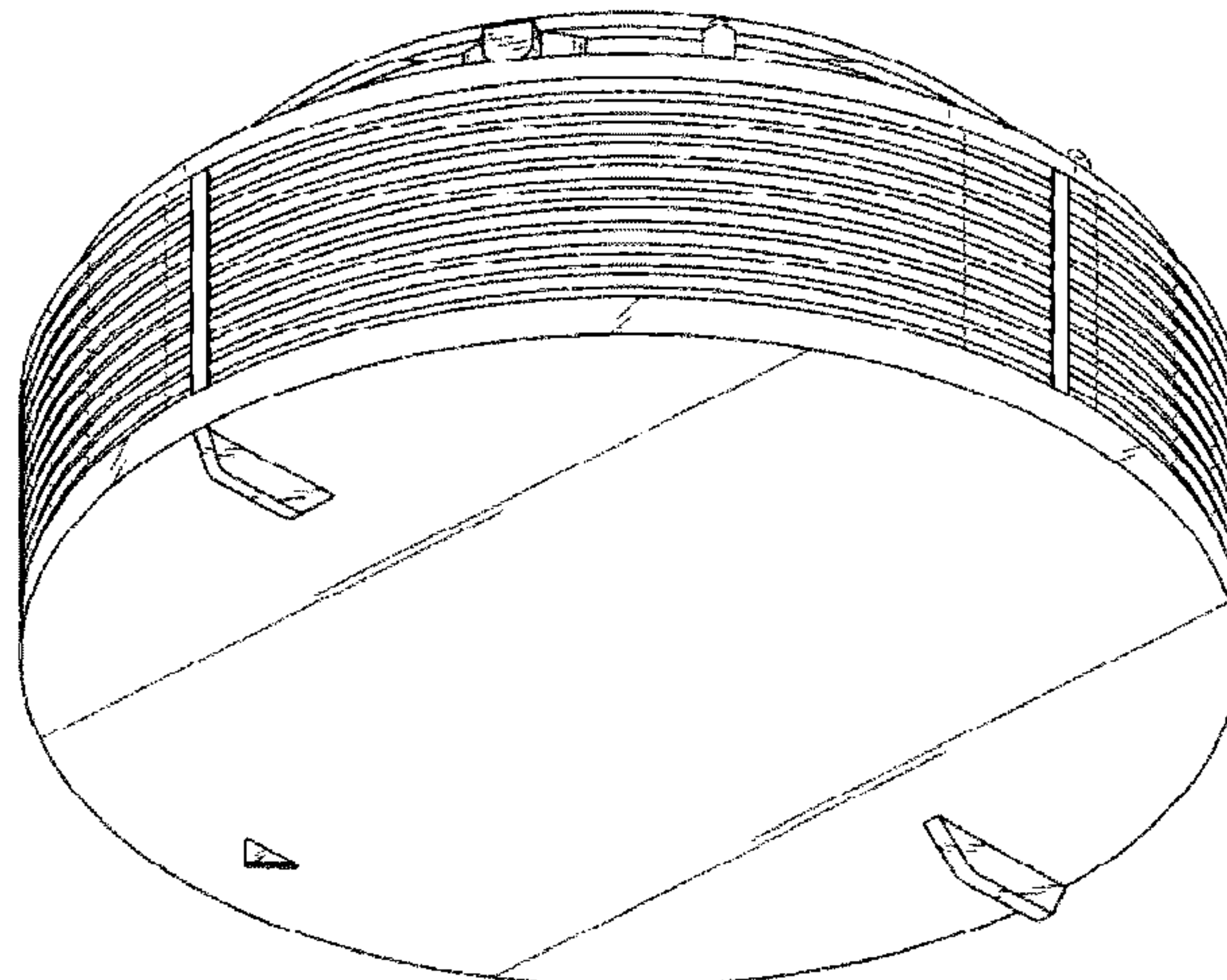
(57) **CLAIM**

The ornamental design for a light emitting diode lamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light emitting diode lamp showing our new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top view thereof;
FIG. 8 is a bottom view thereof; and,
FIG. 9 is a cross-sectional view taken along line 9-9 in FIG. 8. The portion shown in double cross-hatched lines in FIG. 9 is pervious to light. The broken lines shown in FIGS. 1-7 and 9 are for illustrative purposes only and form no part of the claimed design.

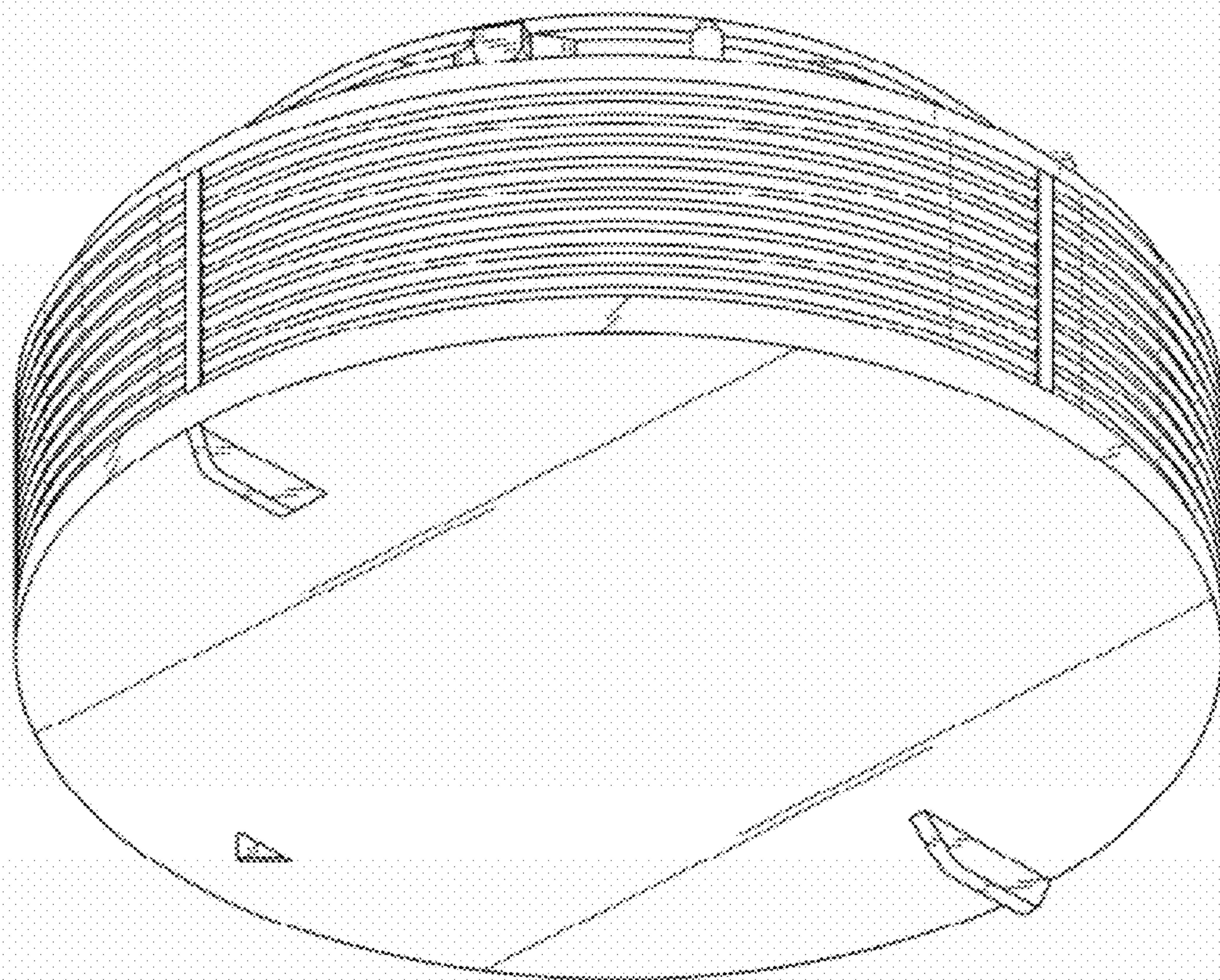

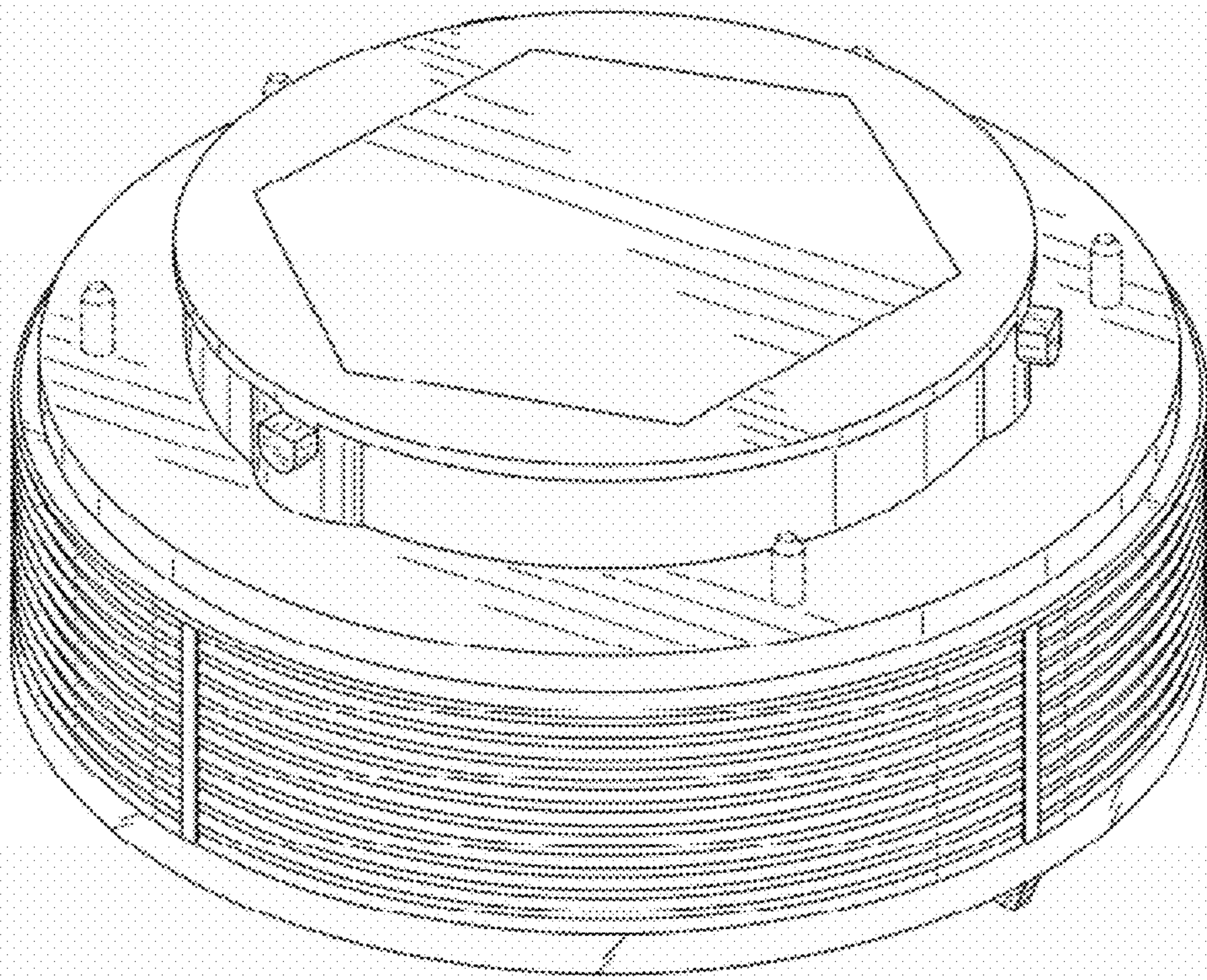

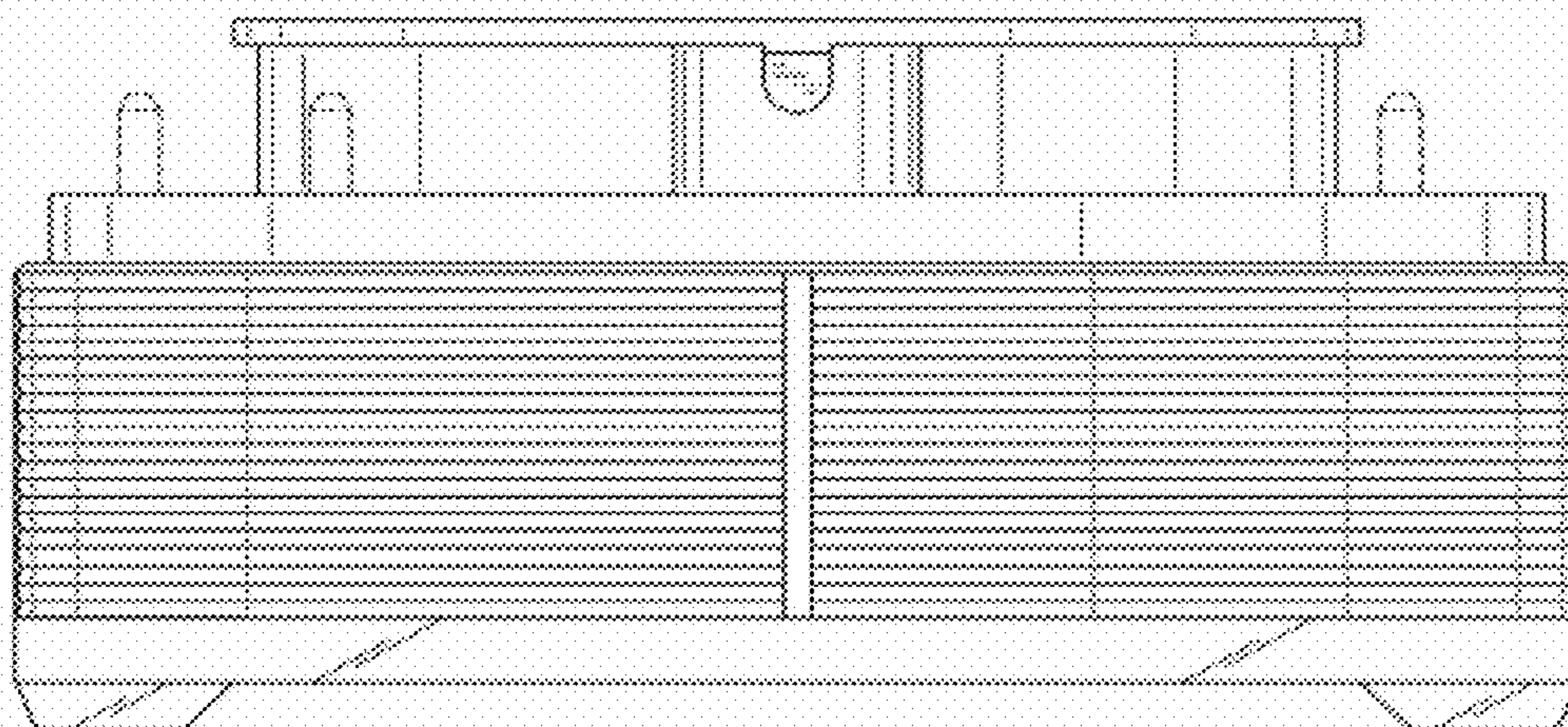

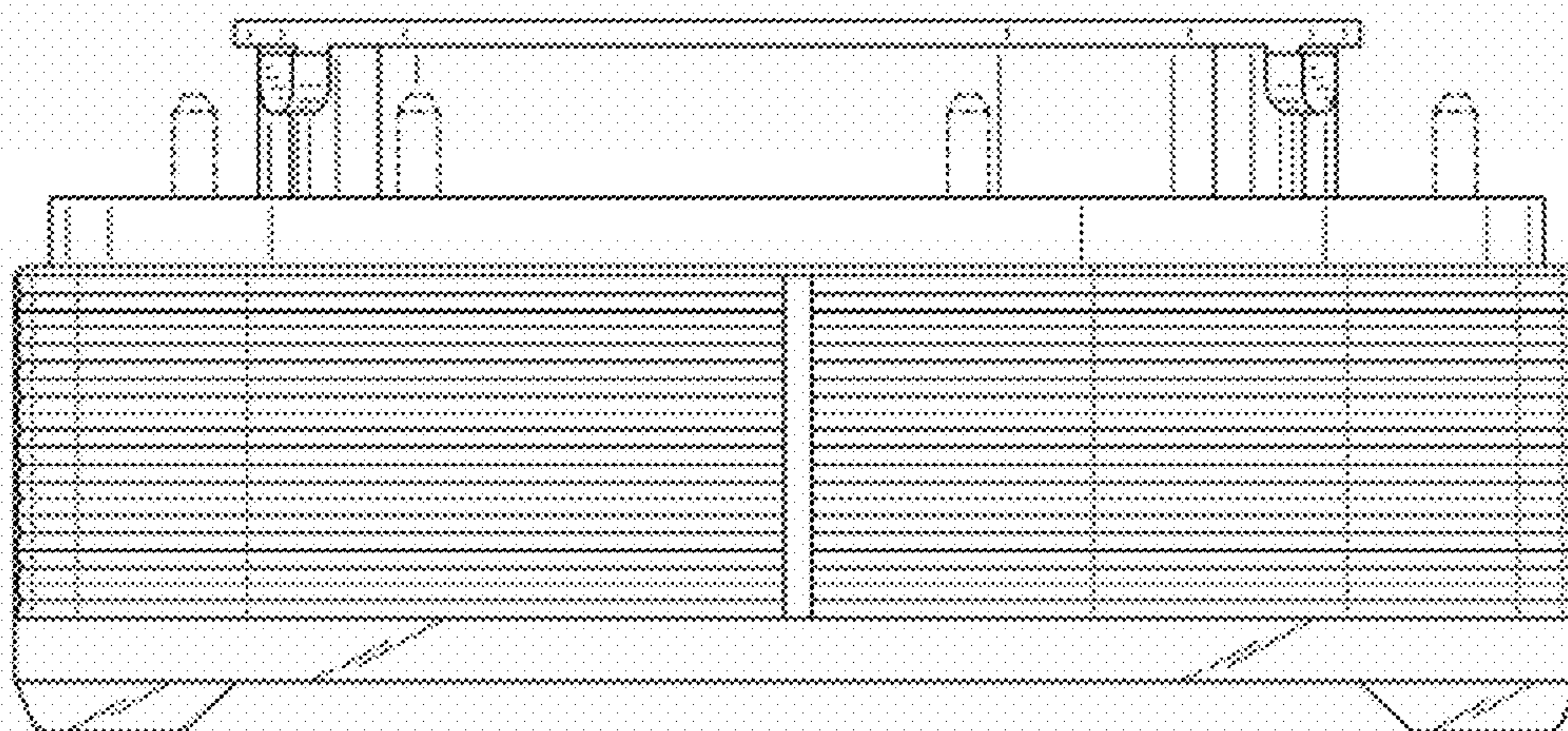

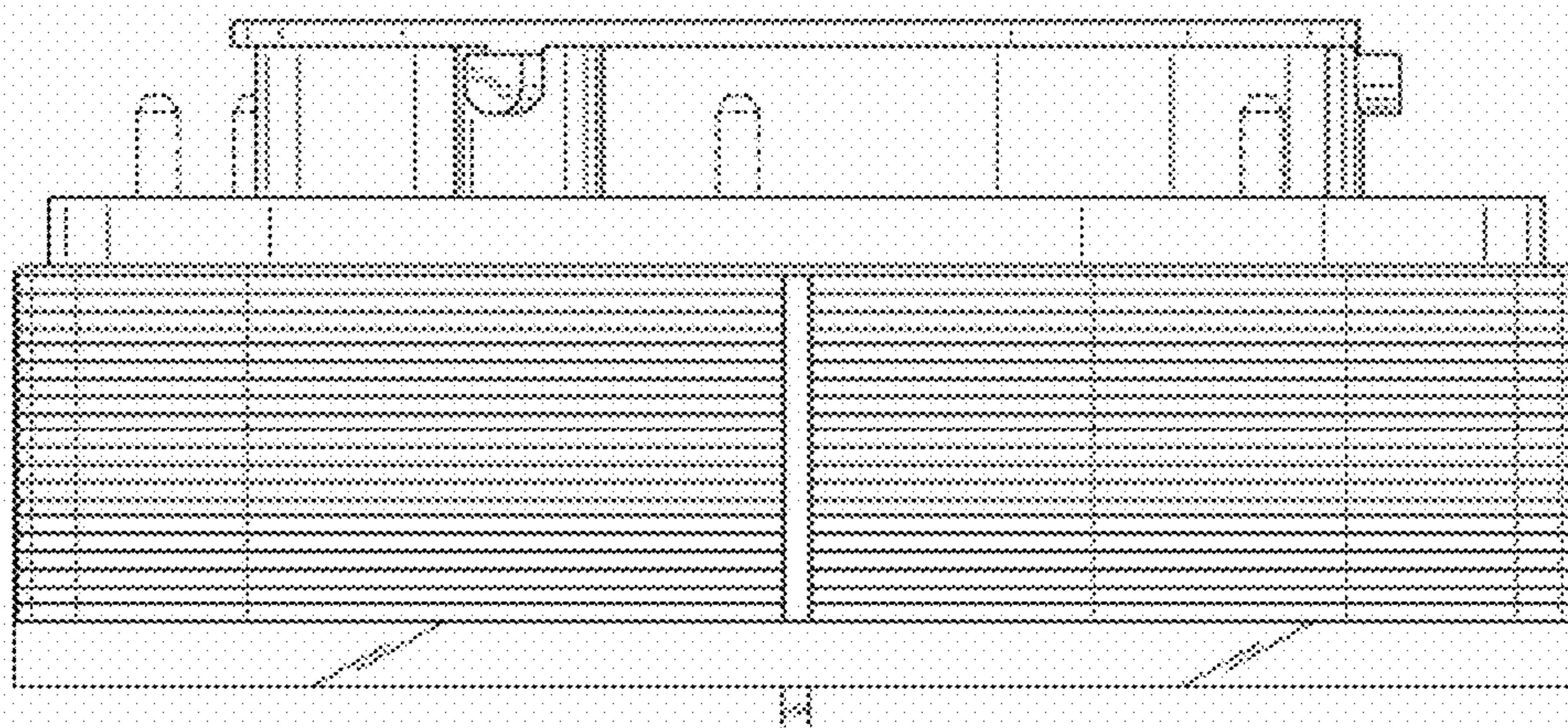

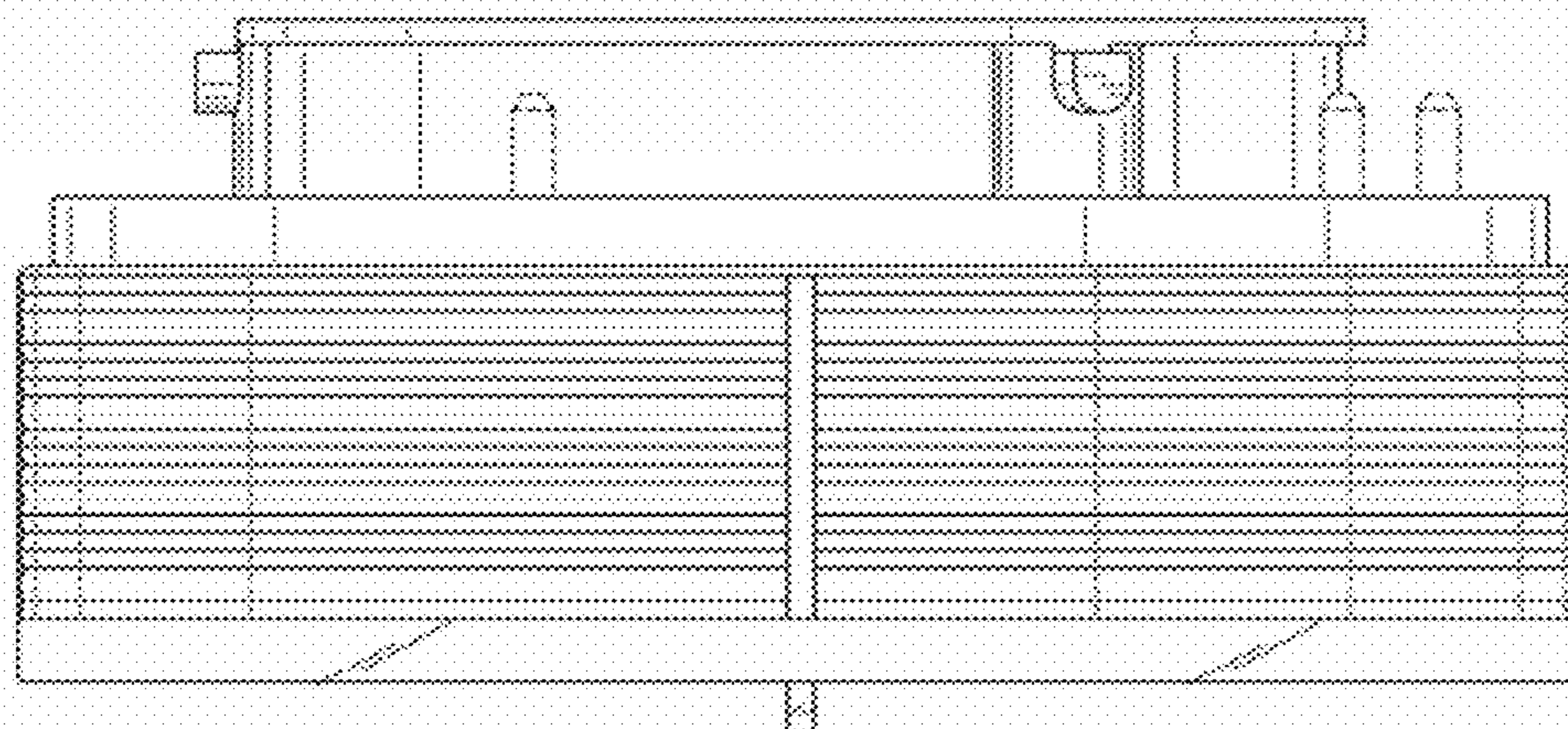

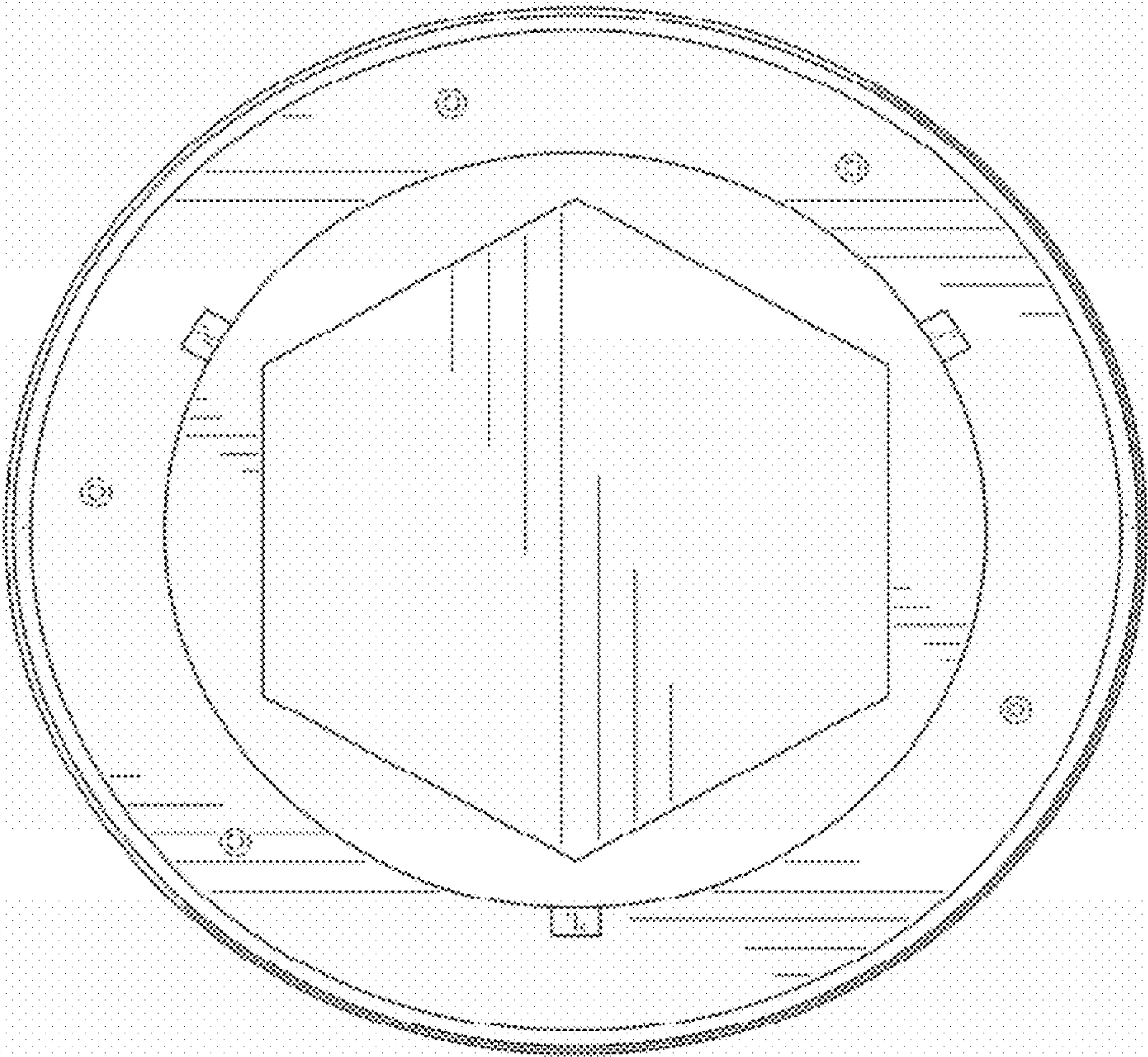

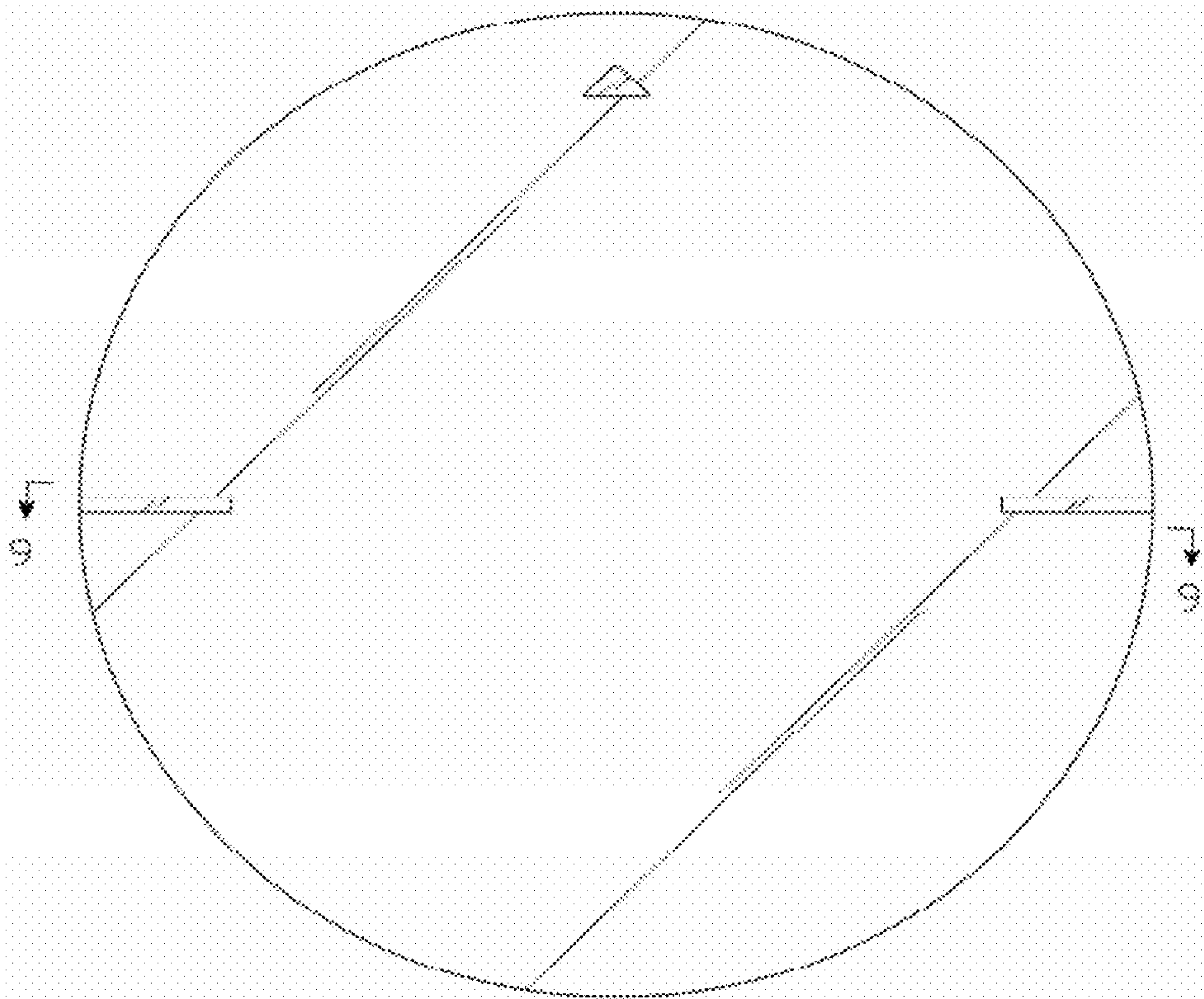

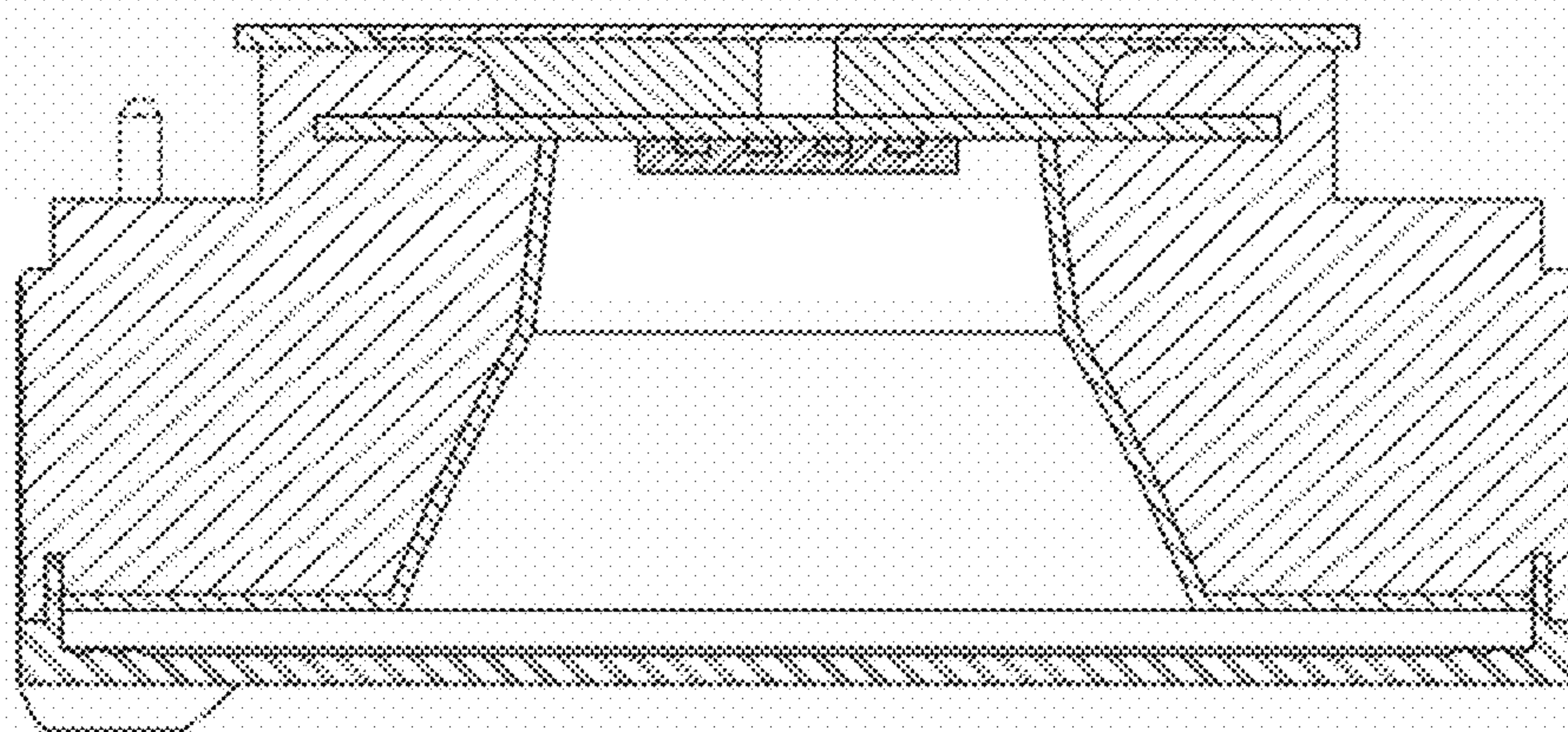
