The ornamental design for a lighter holder and tool, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view our lighter holder and tool showing a poker extended therefrom; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof; FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a left side elevational view thereof. The broken line showing a cigarette lighter in the figures depicts an intended use for the lighter holder and tool that form no part of the claimed design.

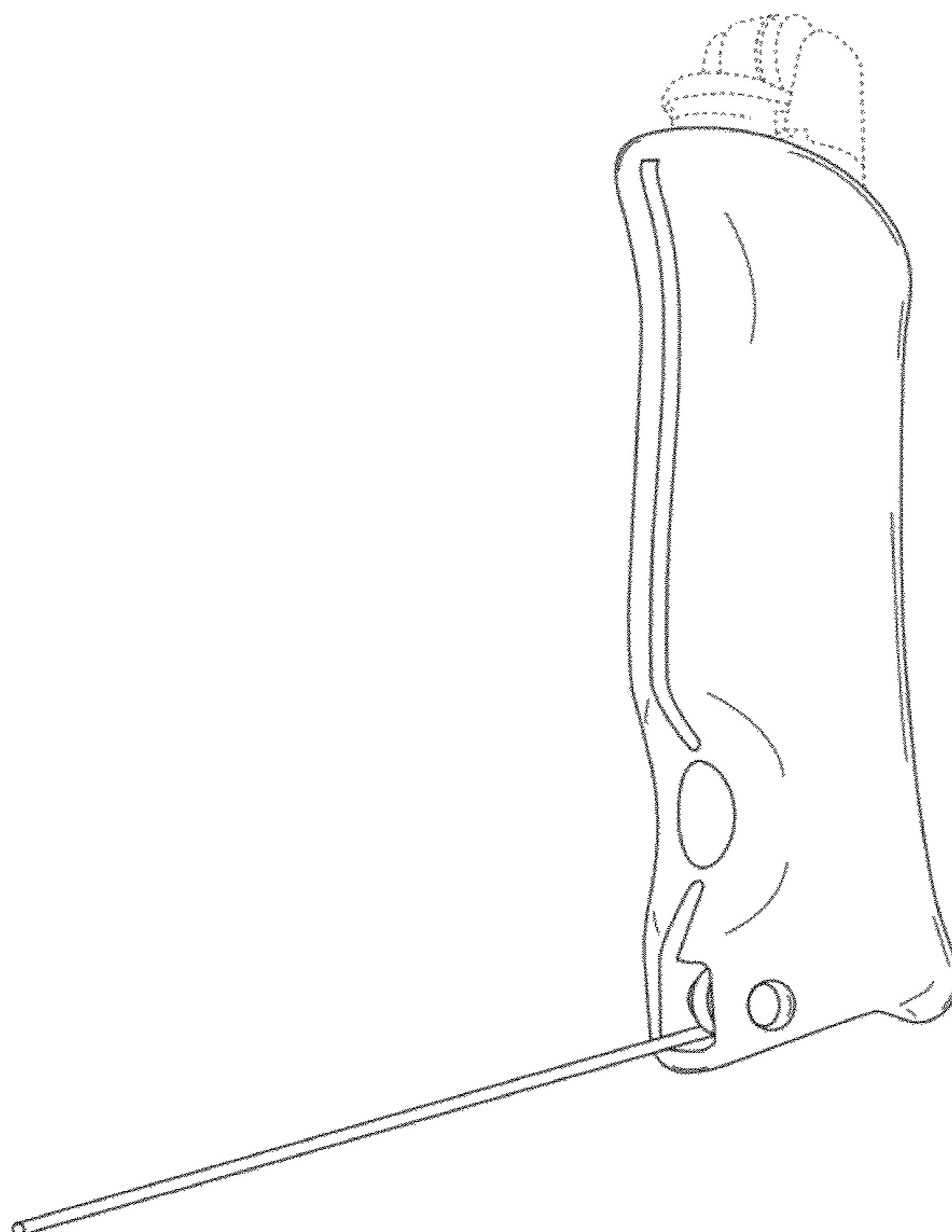
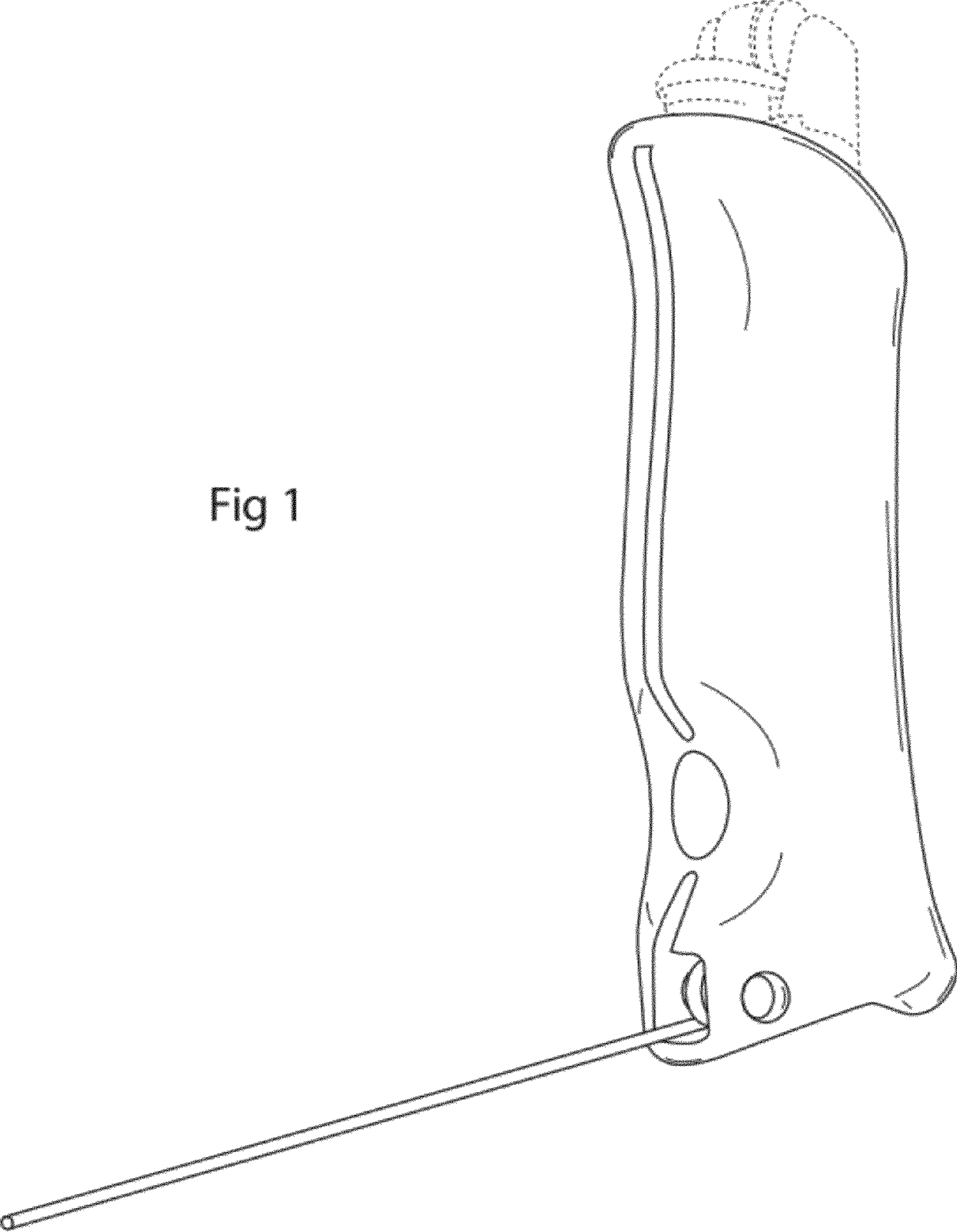

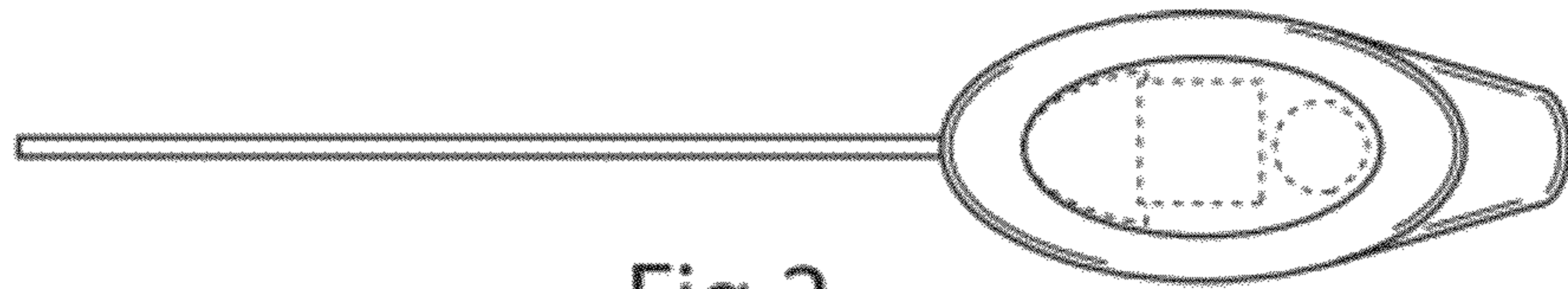

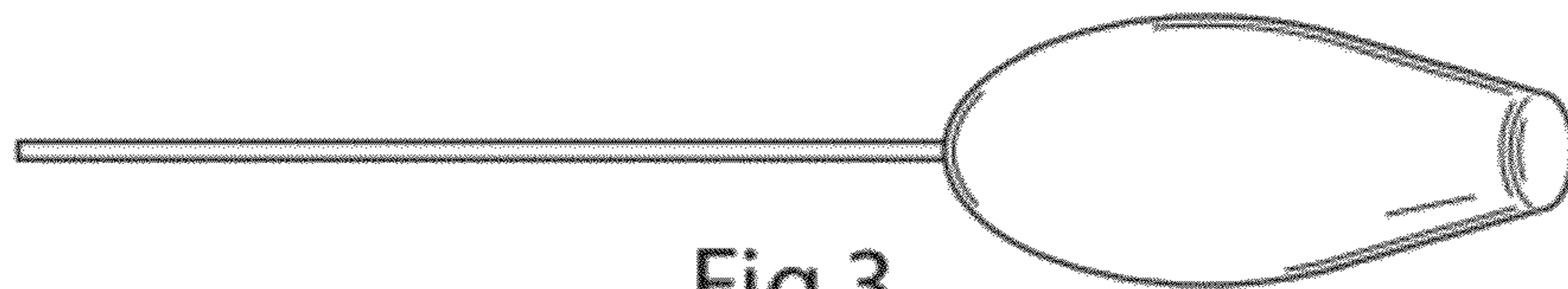

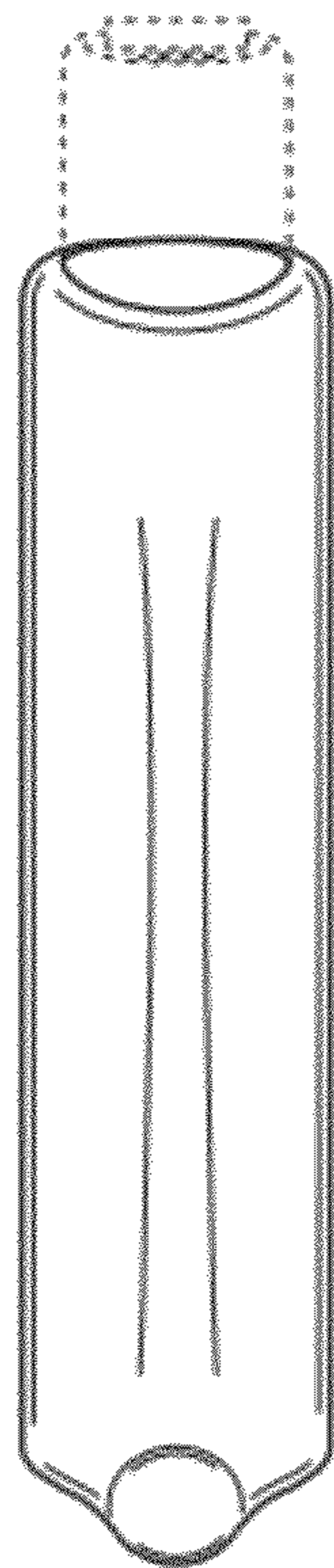

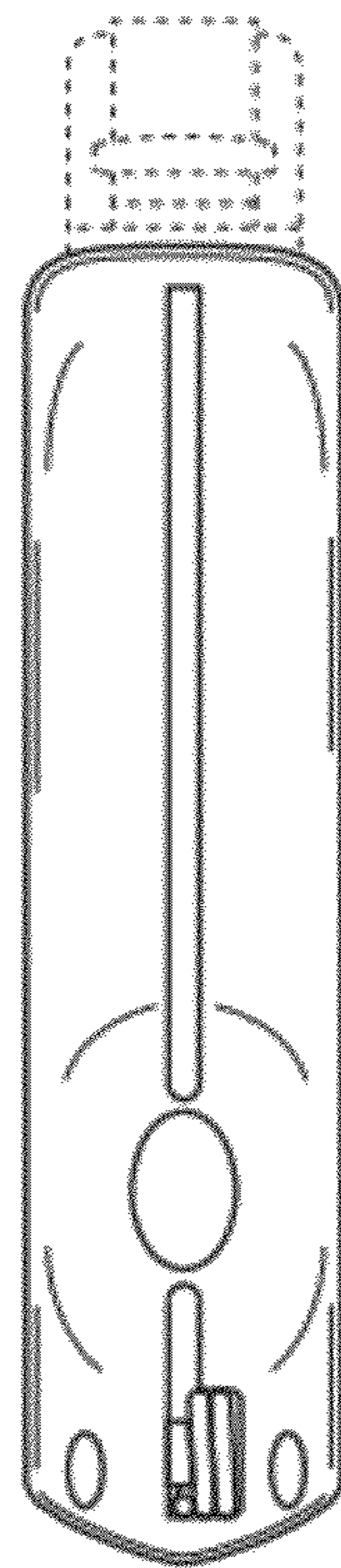
