(57) **CLAIM**

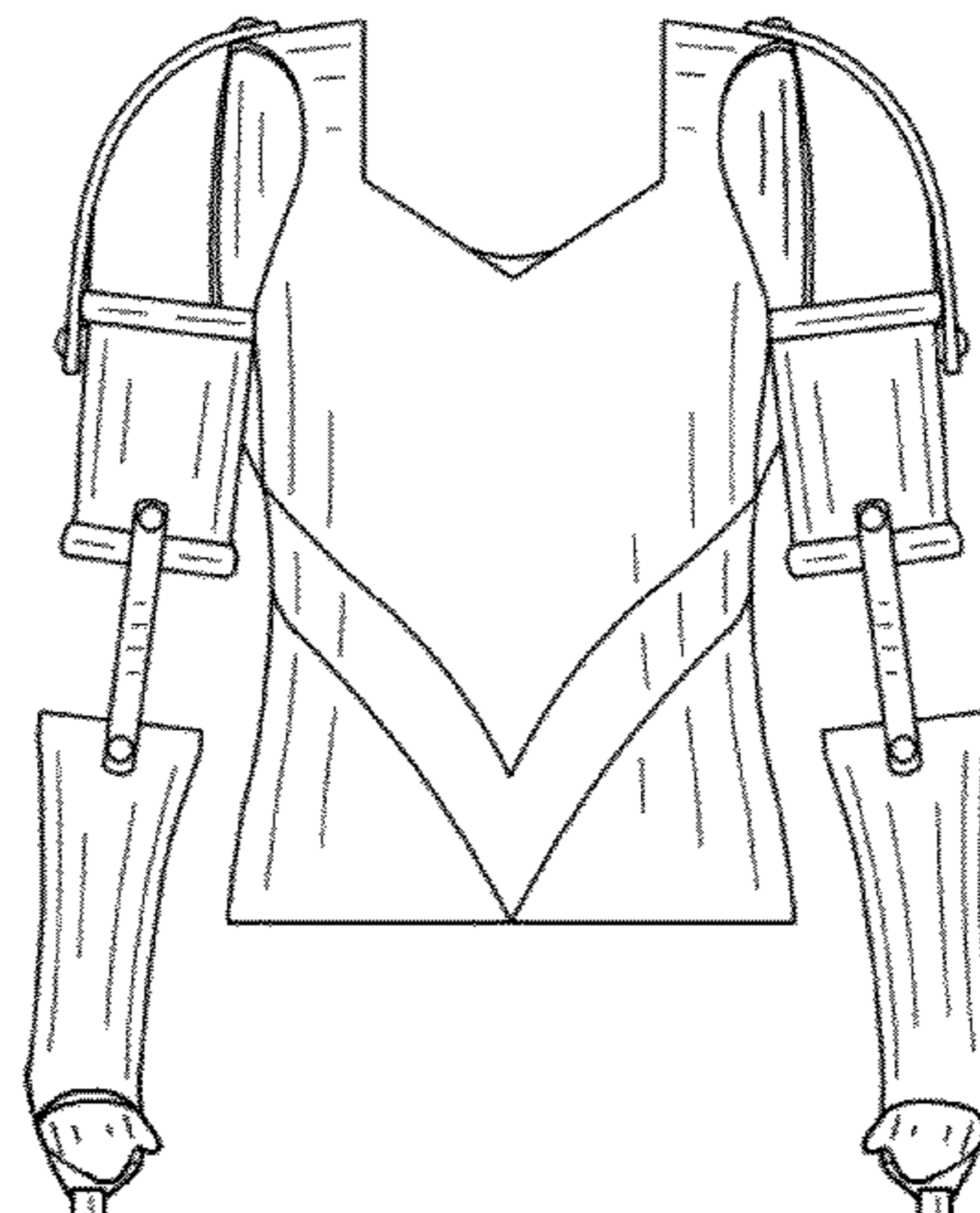
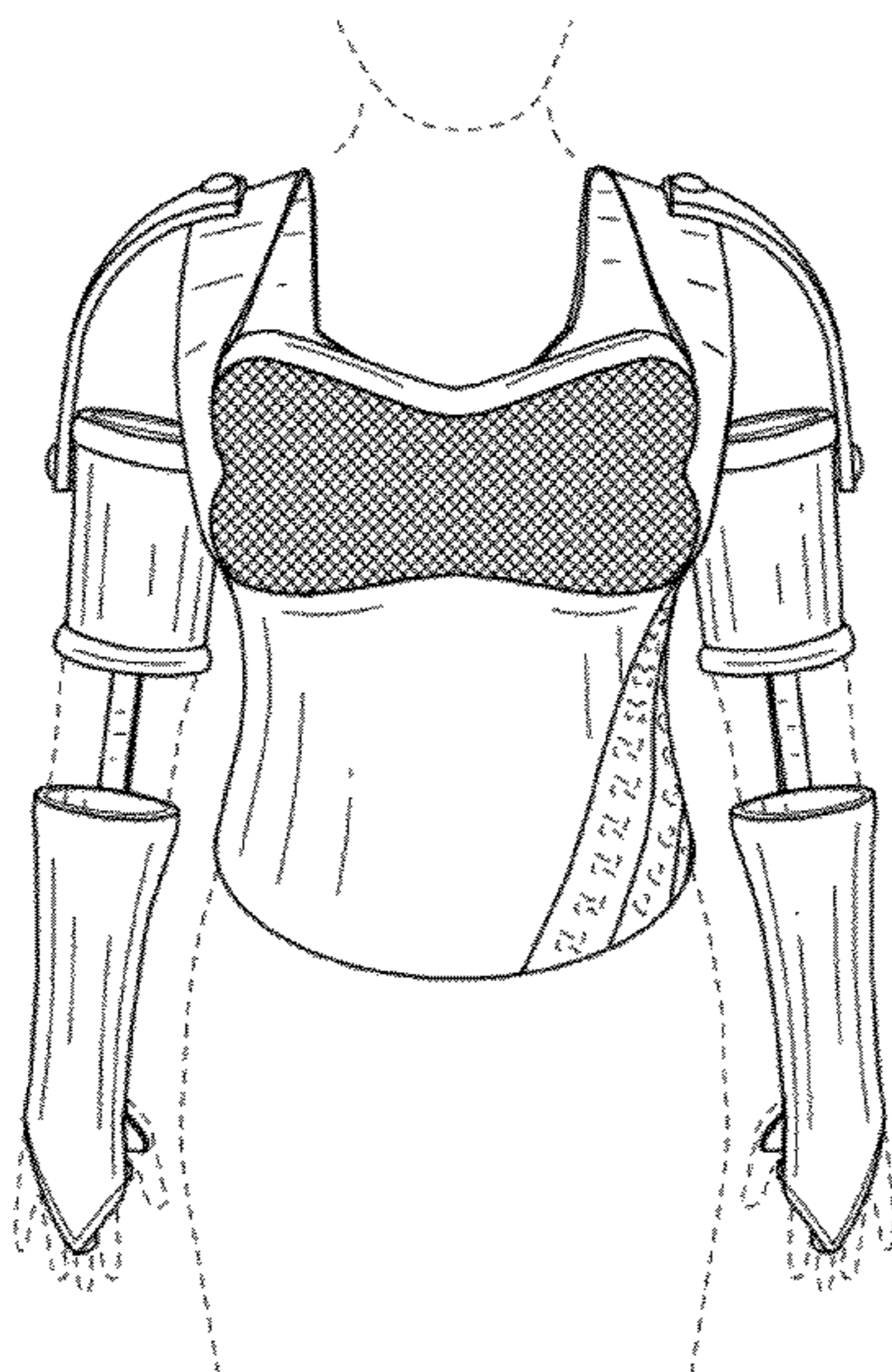
We claim the ornamental design for an exercise garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an exercise garment, showing a first embodiment of our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a right-side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines showing a person in FIG. 1 and design elements in FIGS. 1, 2, and 4 depict environmental matter and form no part of the claimed design.

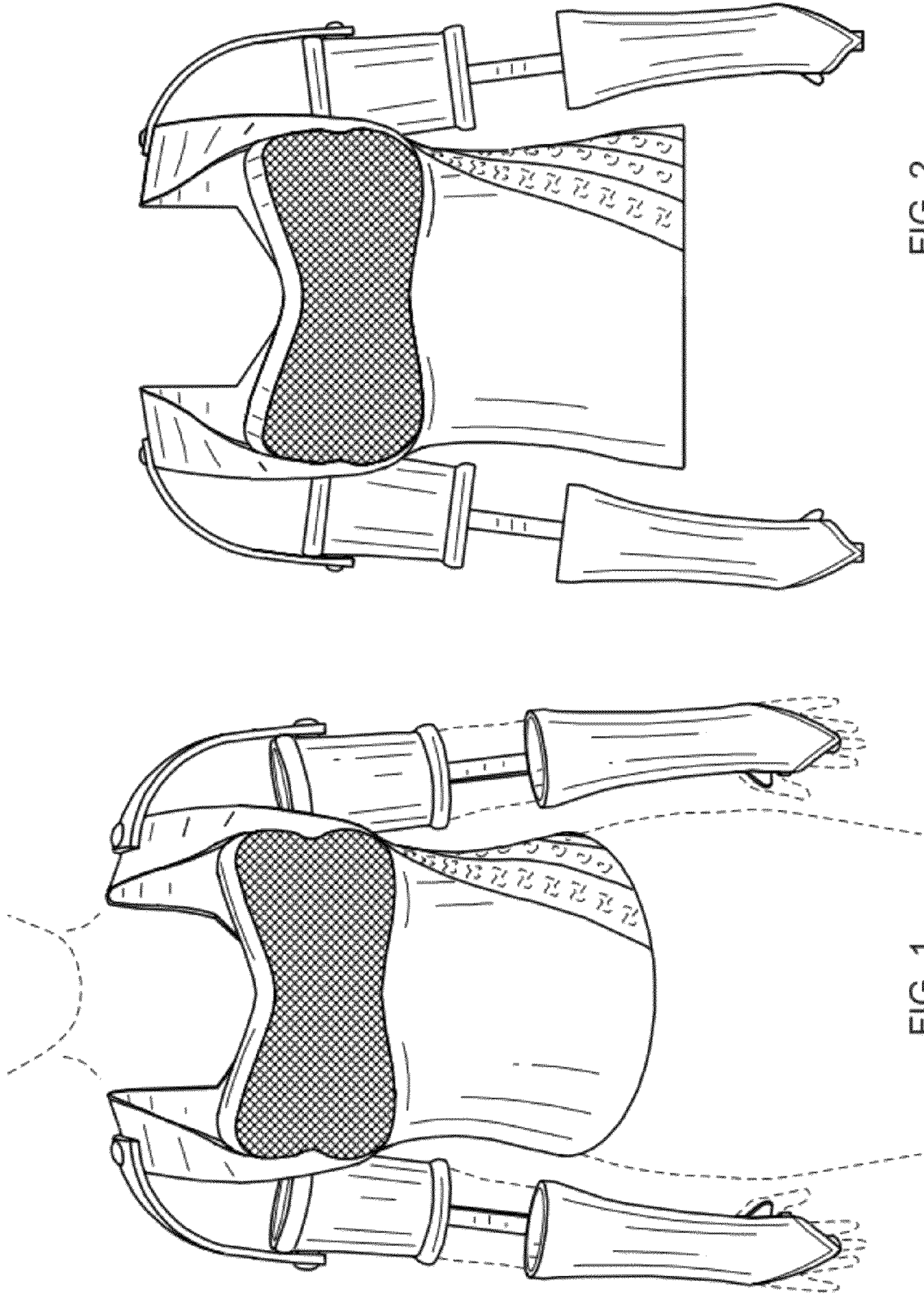

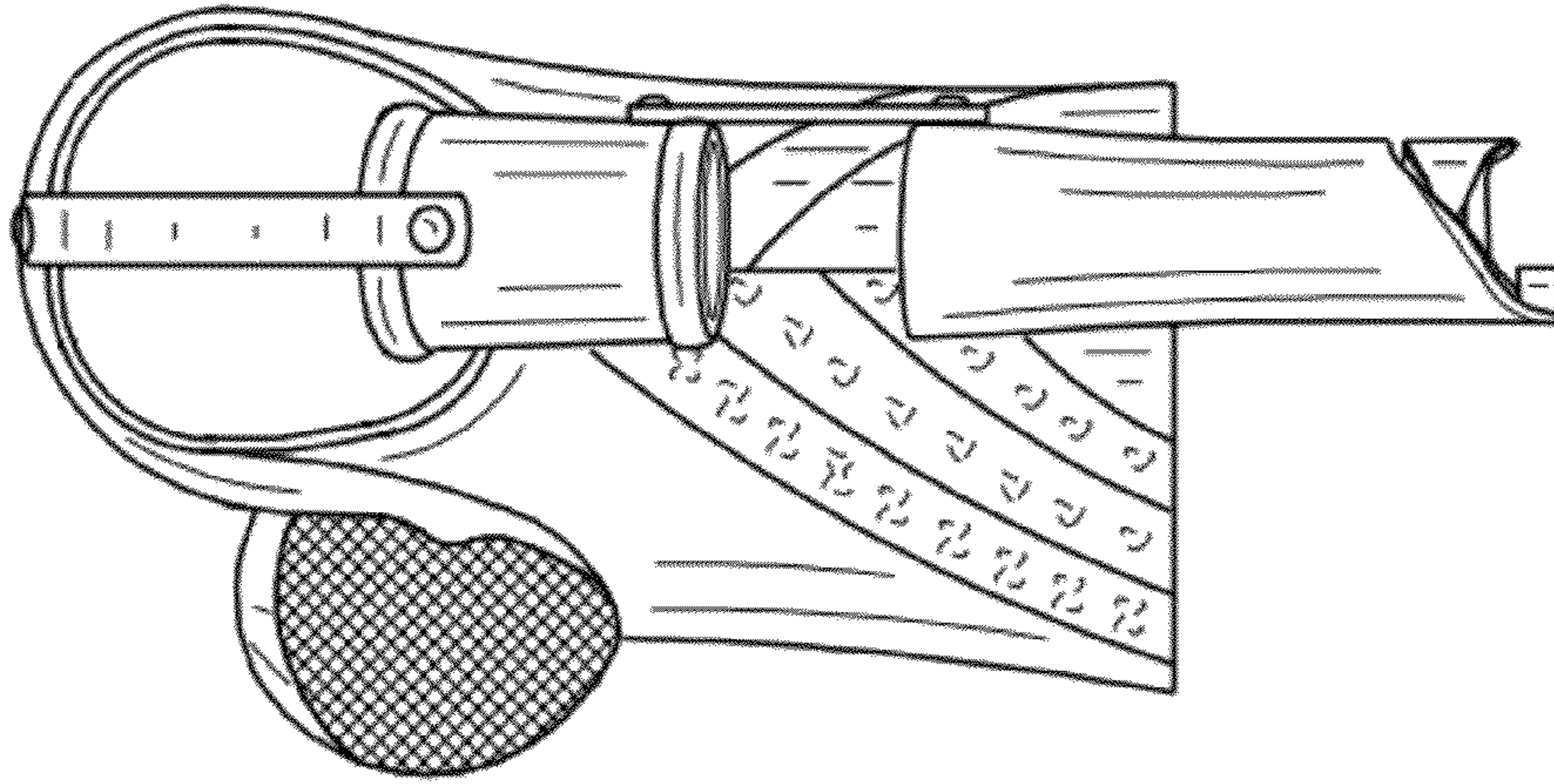

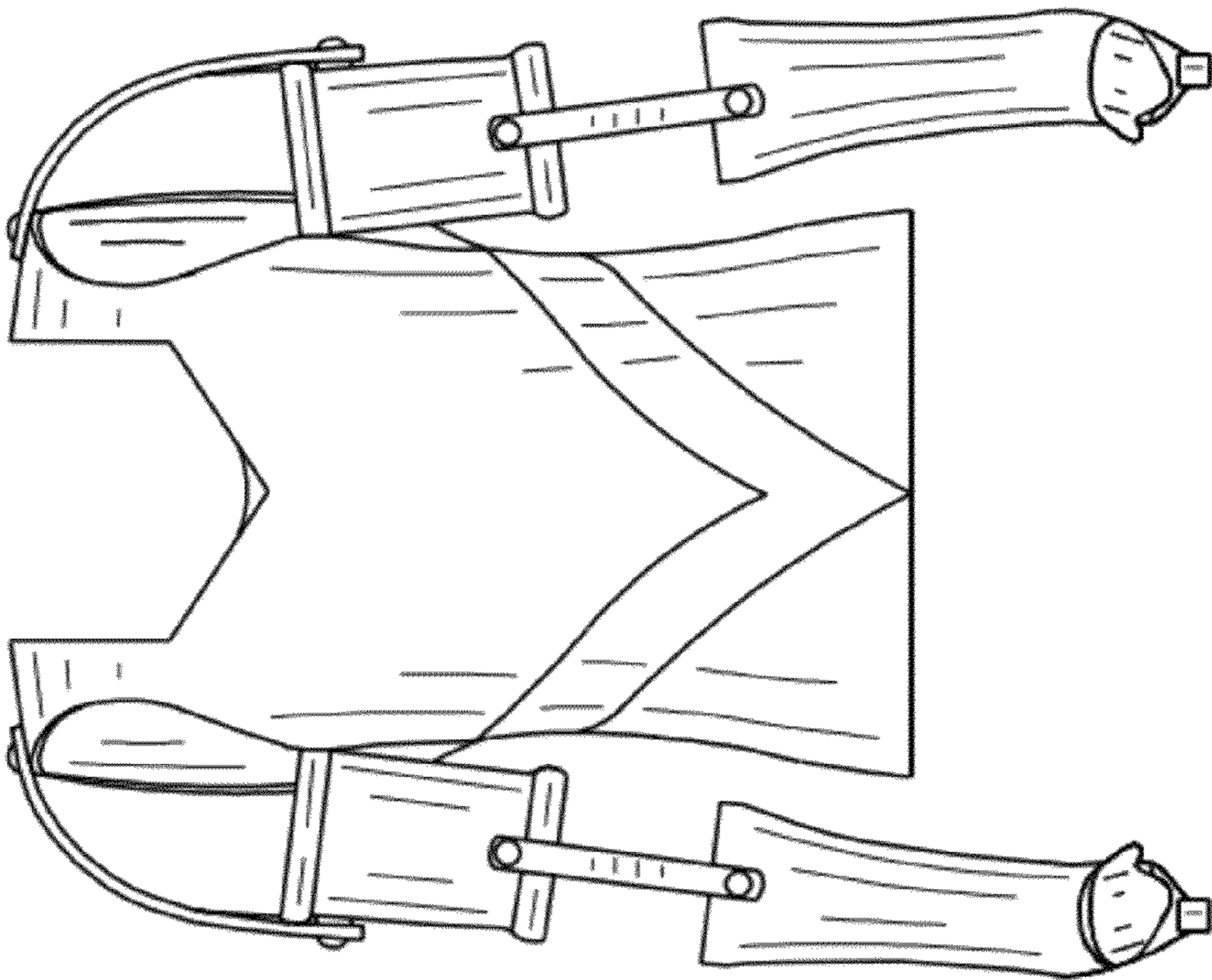

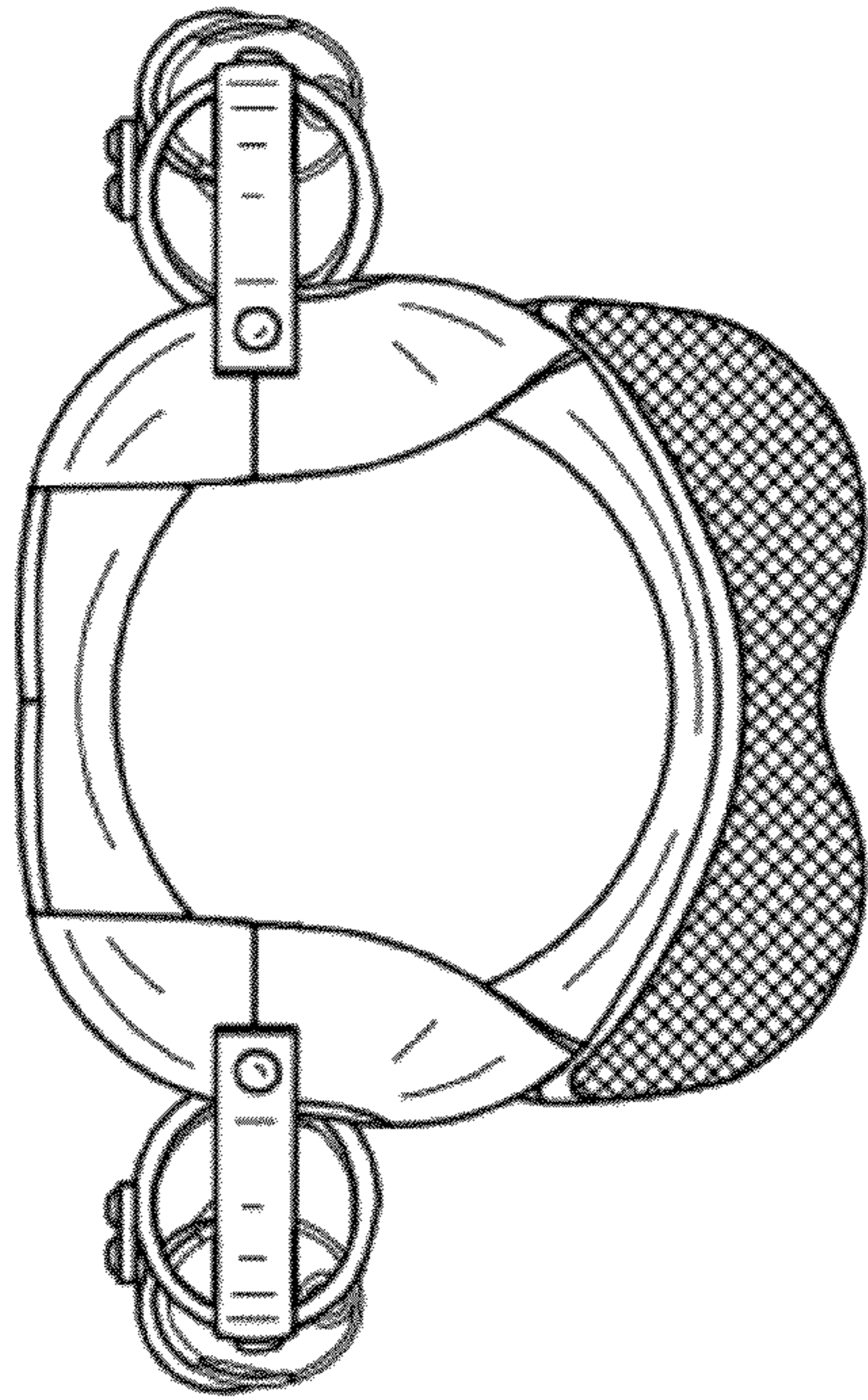

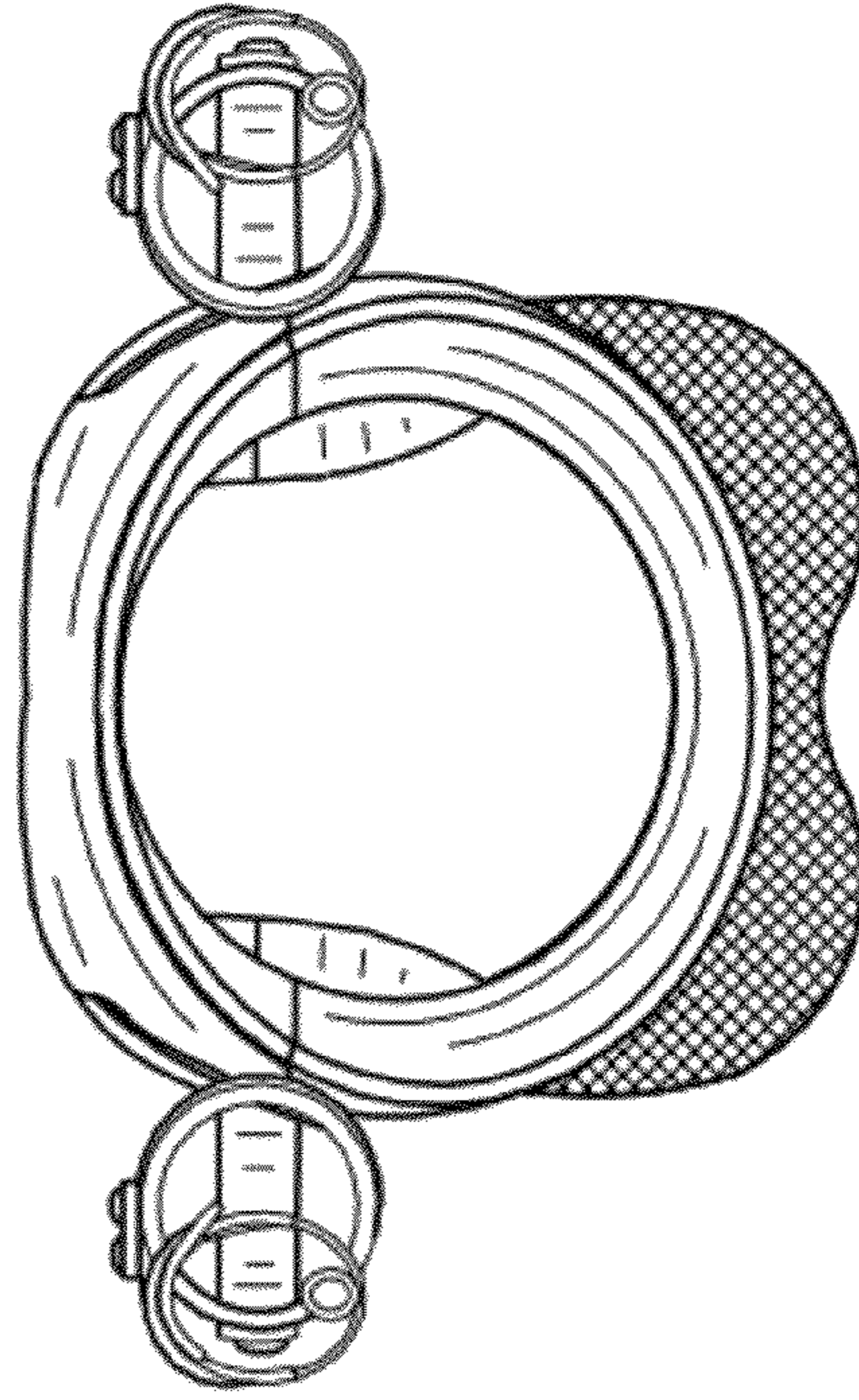

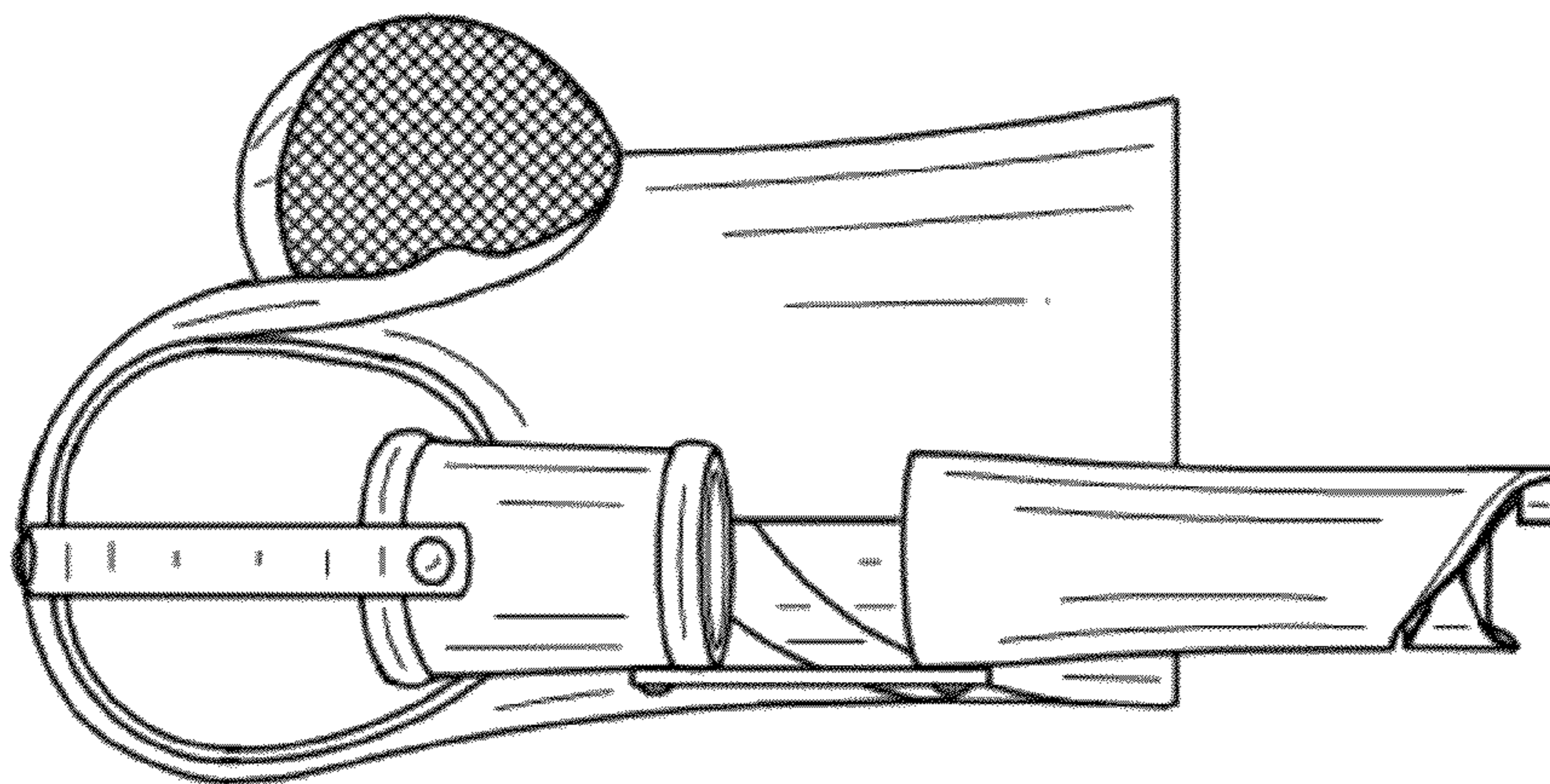
