DESCRIPTION

FIG. 1 is a perspective view of the mattress with quilt motif of
the present invention.

FIG. 2 is a top view of the mattress with quilt motif of FIG. 1.

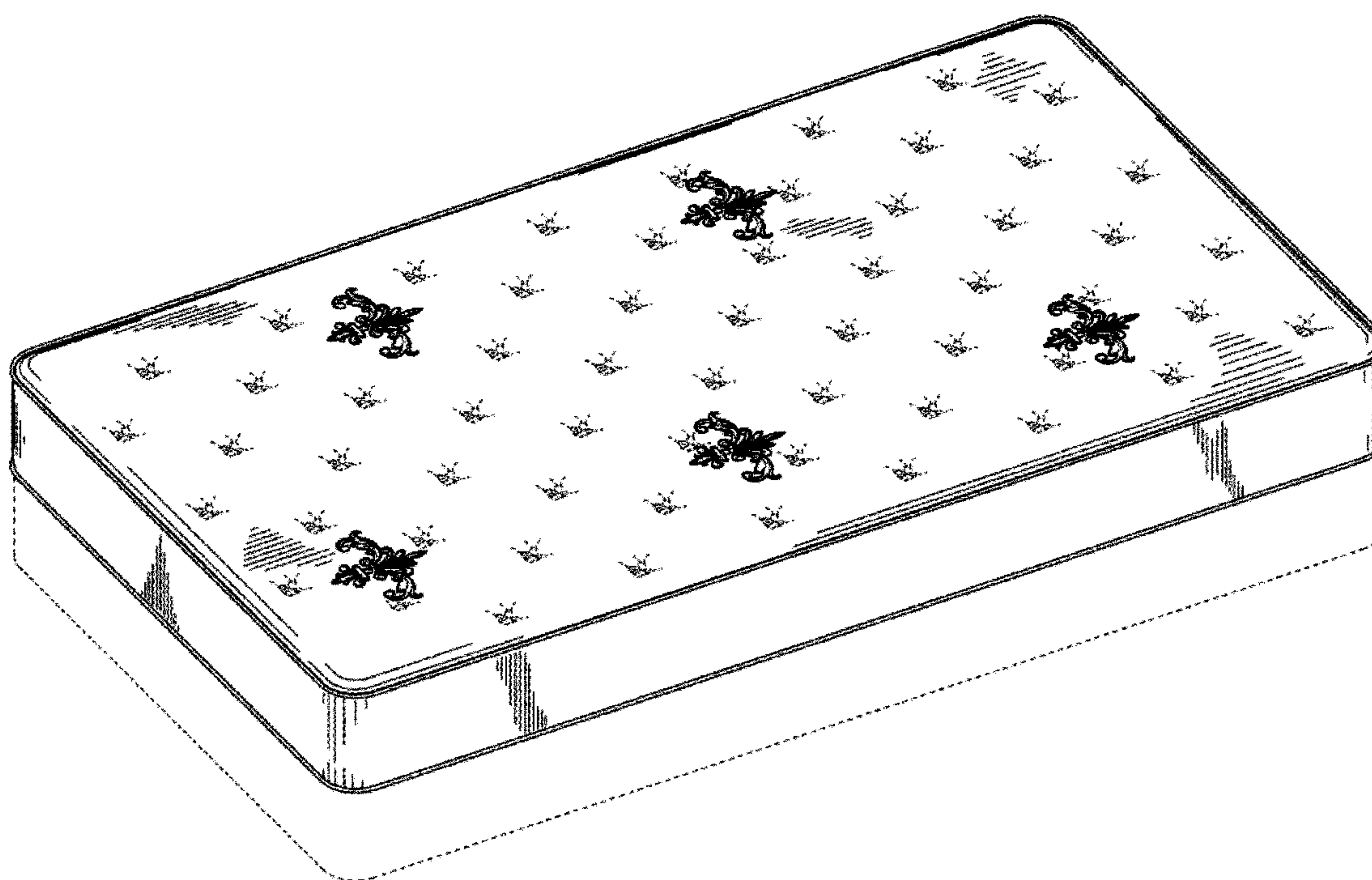
FIG. 3 is a bottom view of the mattress with quilt motif of

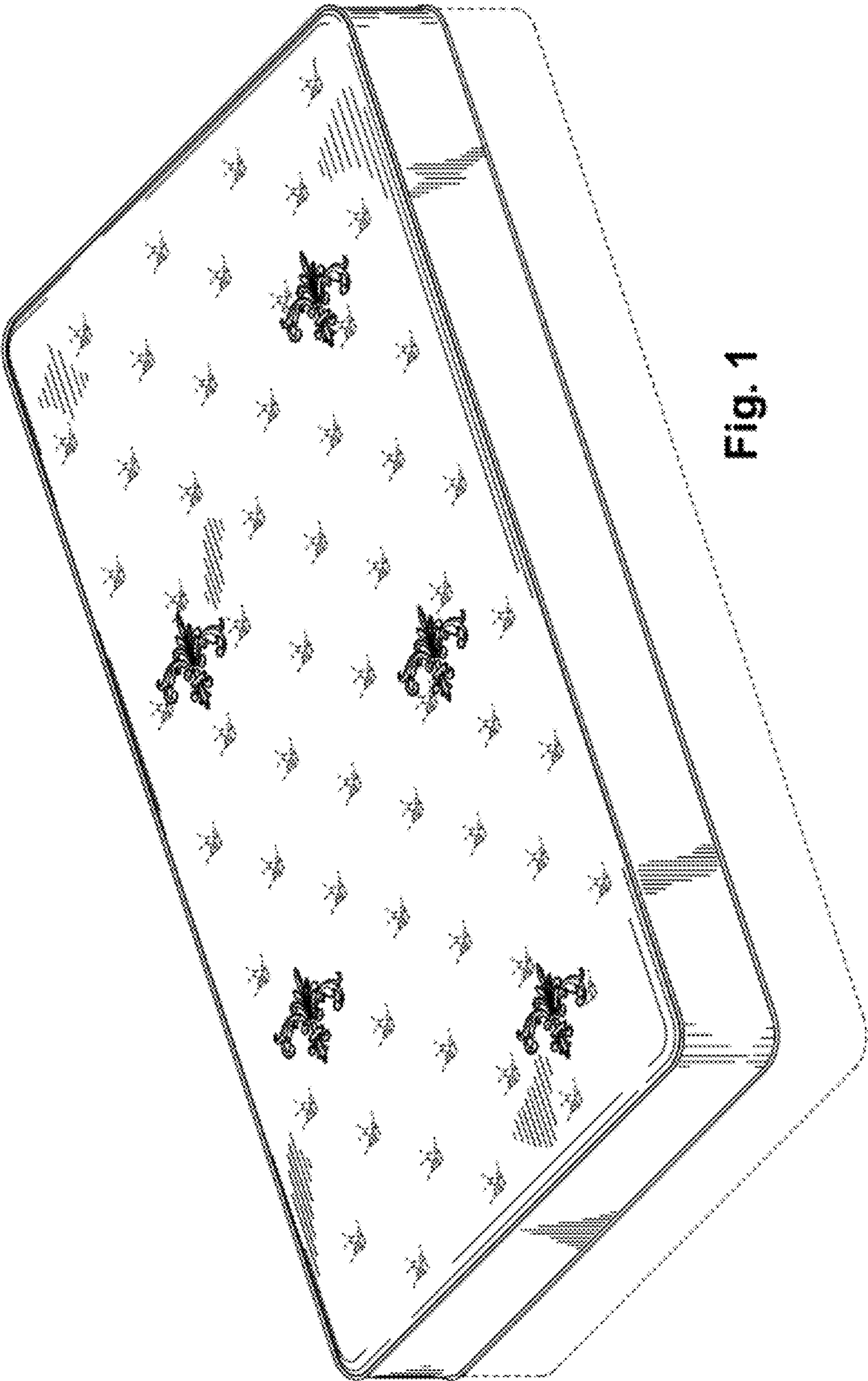

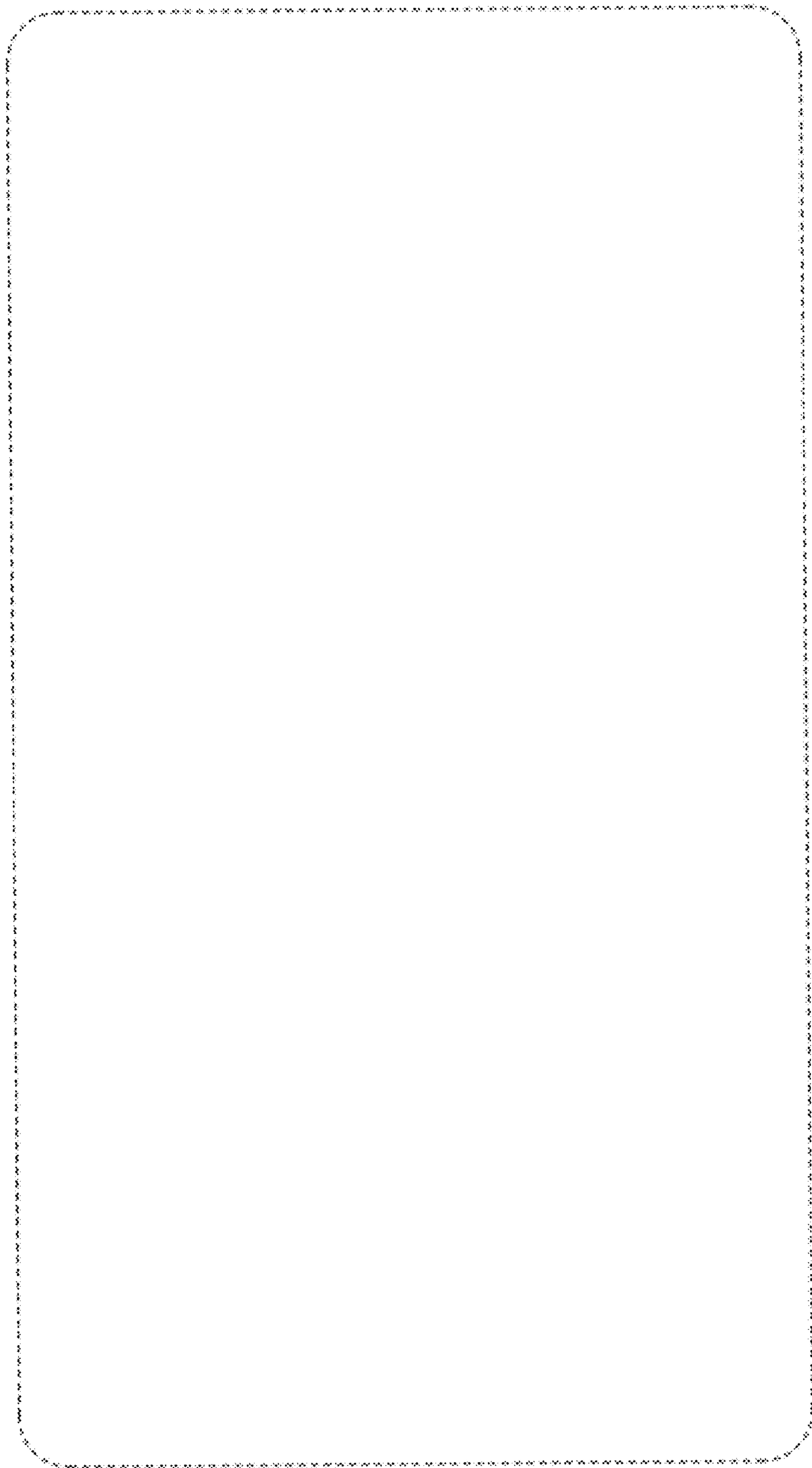

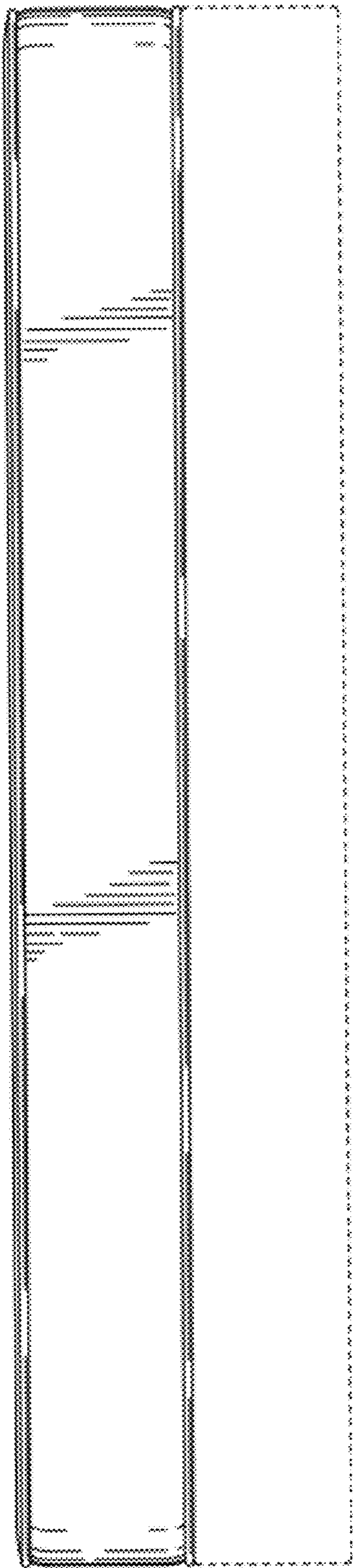

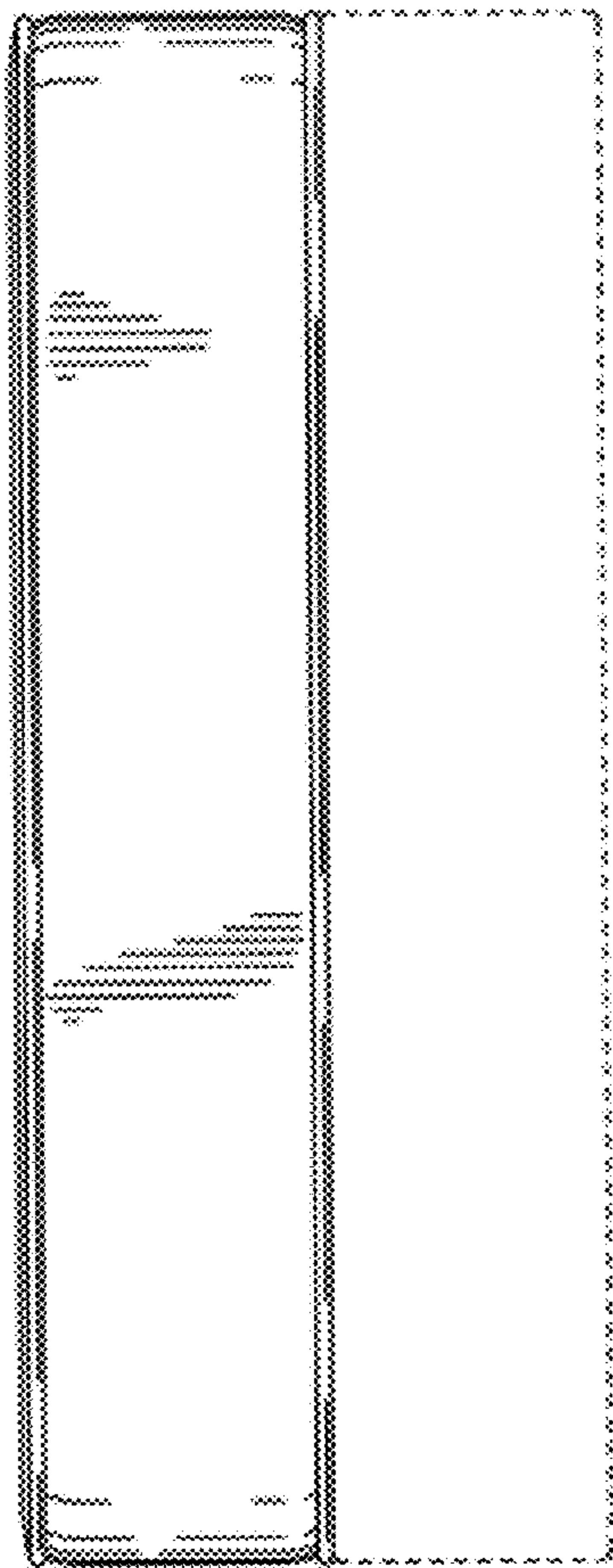
