FIG. 1 is a perspective view of the pillow top mattress foundation.

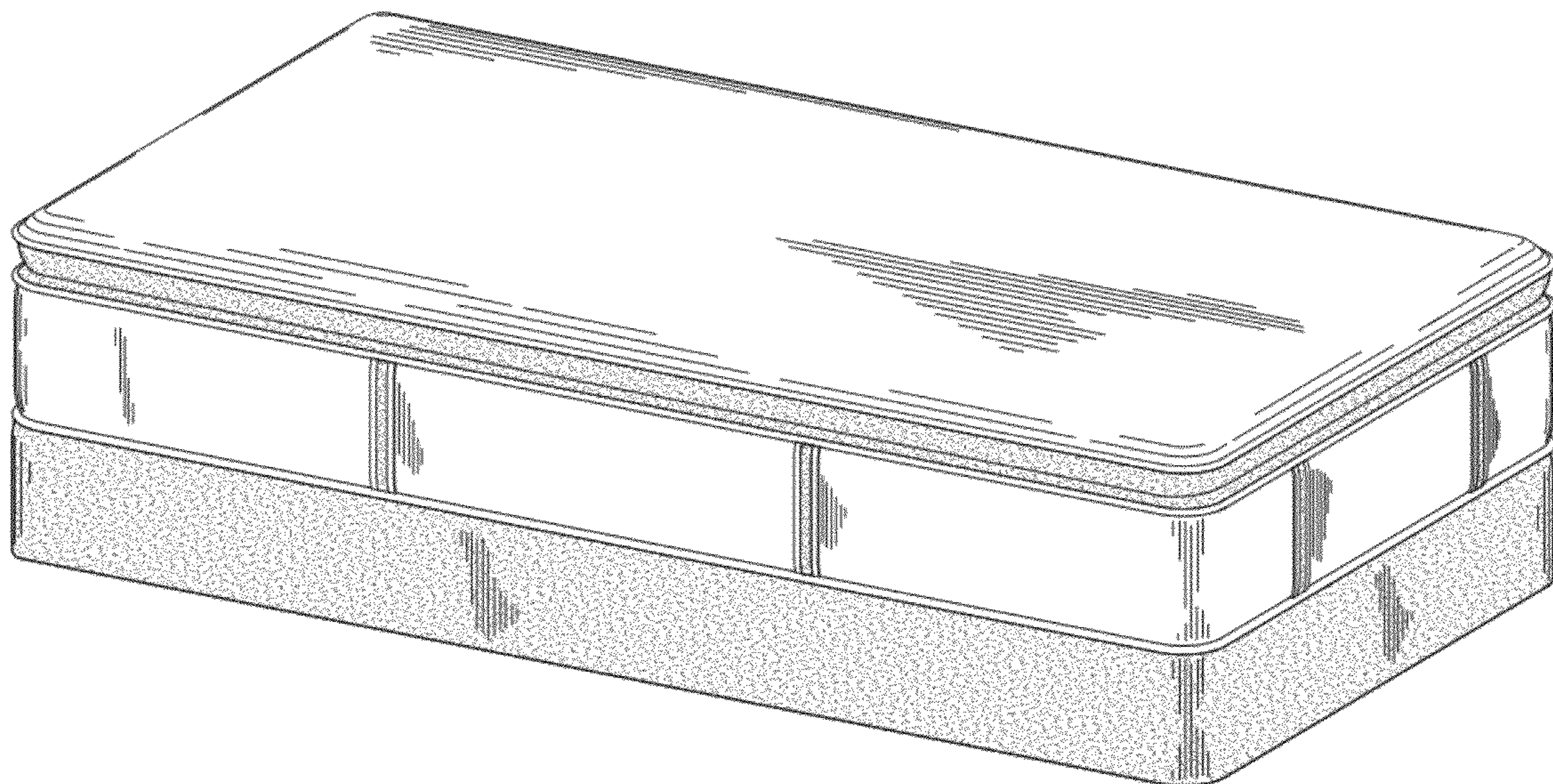
FIG. 2 is a side view of the pillow top mattress foundation of FIG. 1, which is identical to the opposite side view thereof.

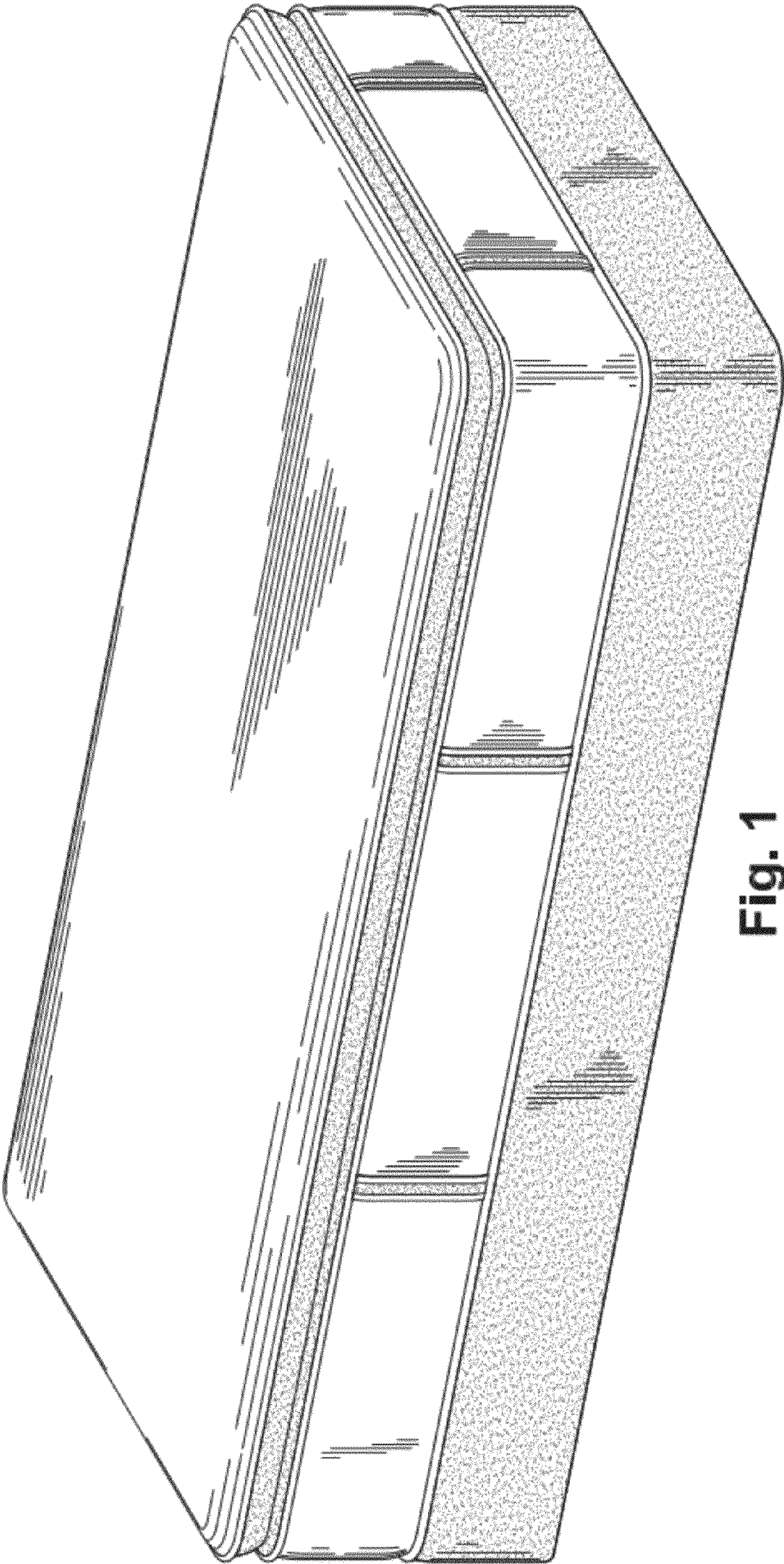
FIG. 3 is an end view of the pillow top mattress foundation of FIG. 1, which is identical to the opposite end view thereof.

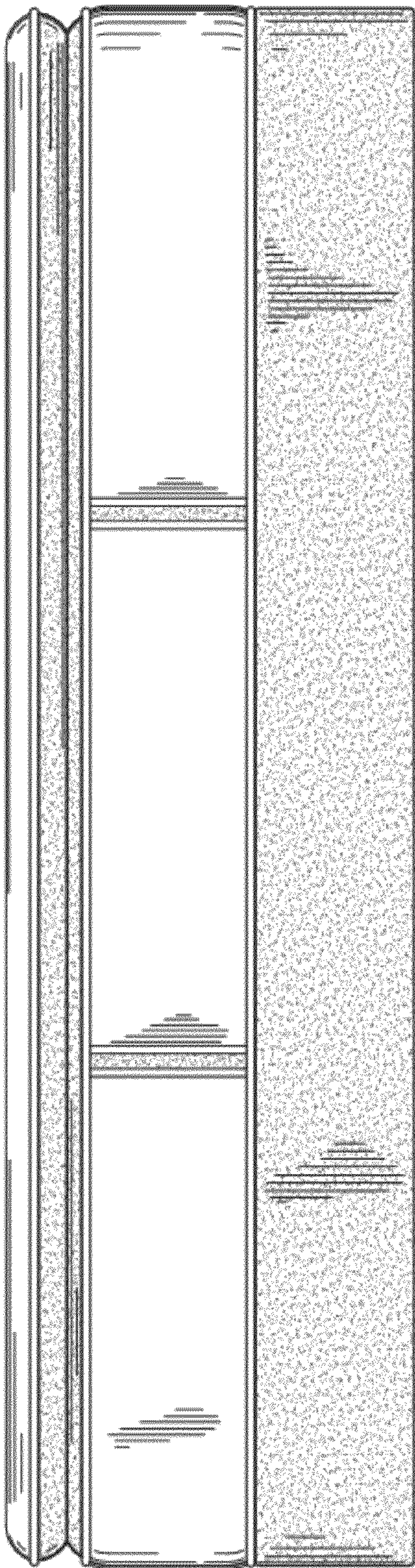

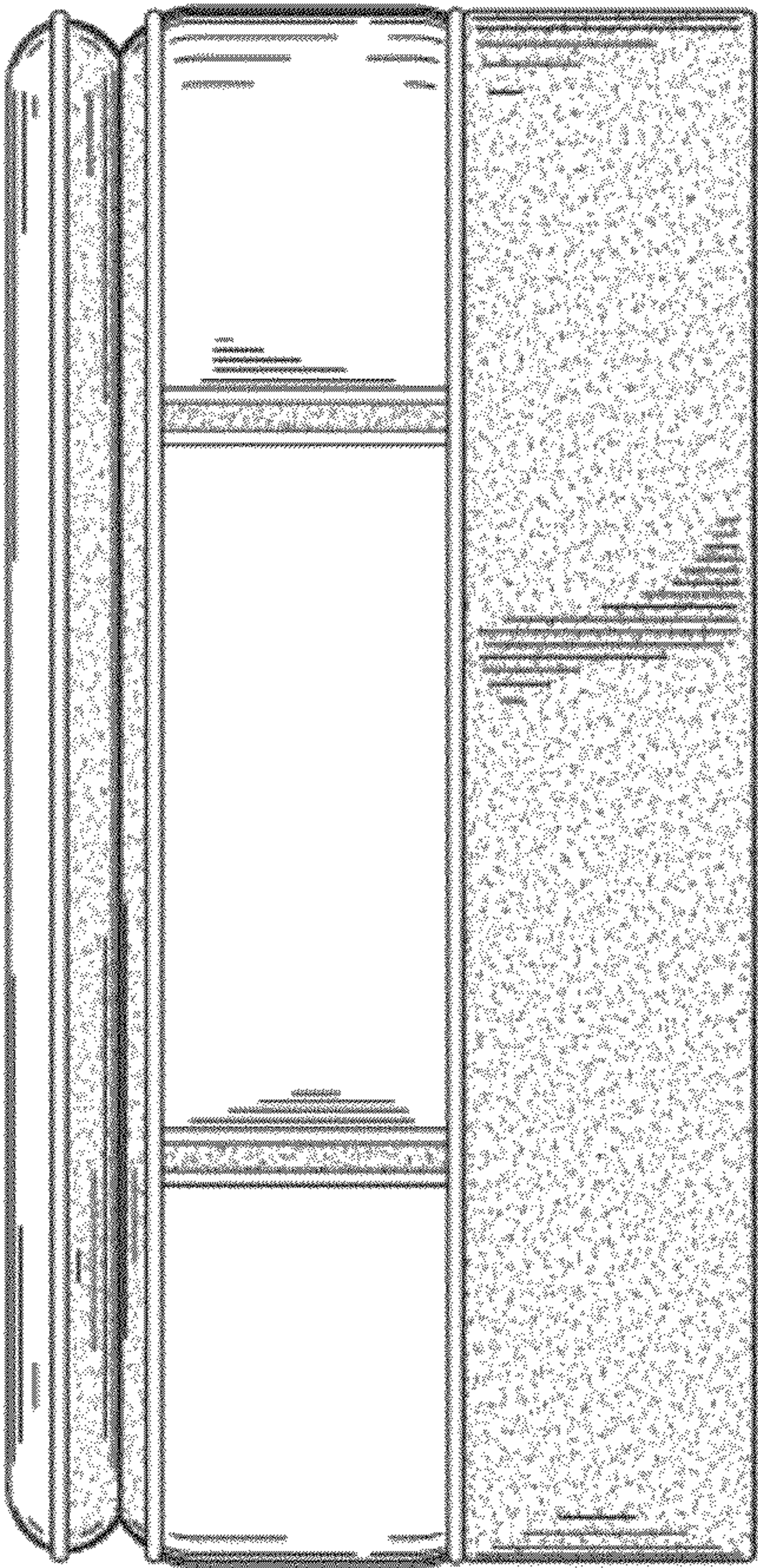

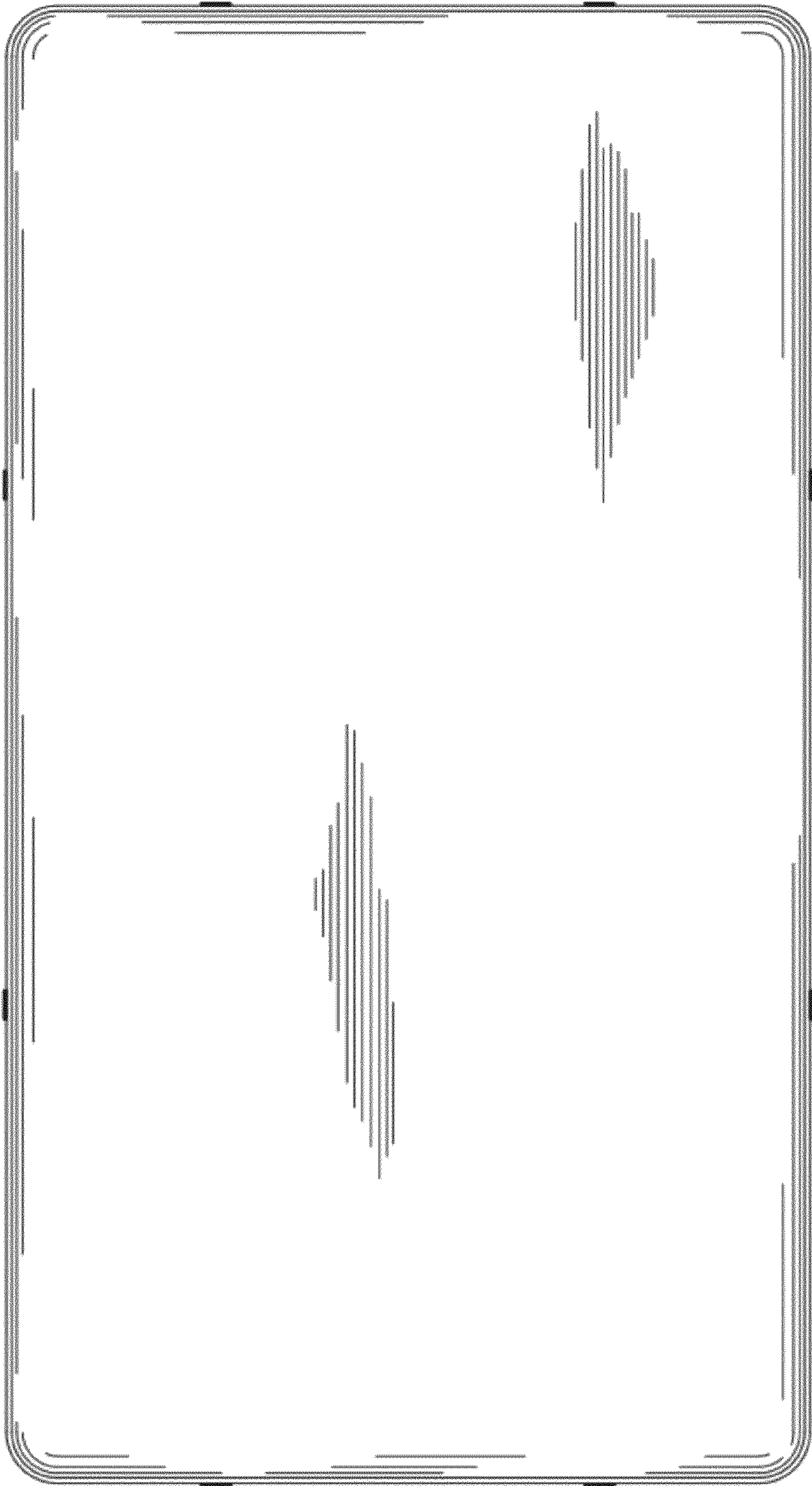

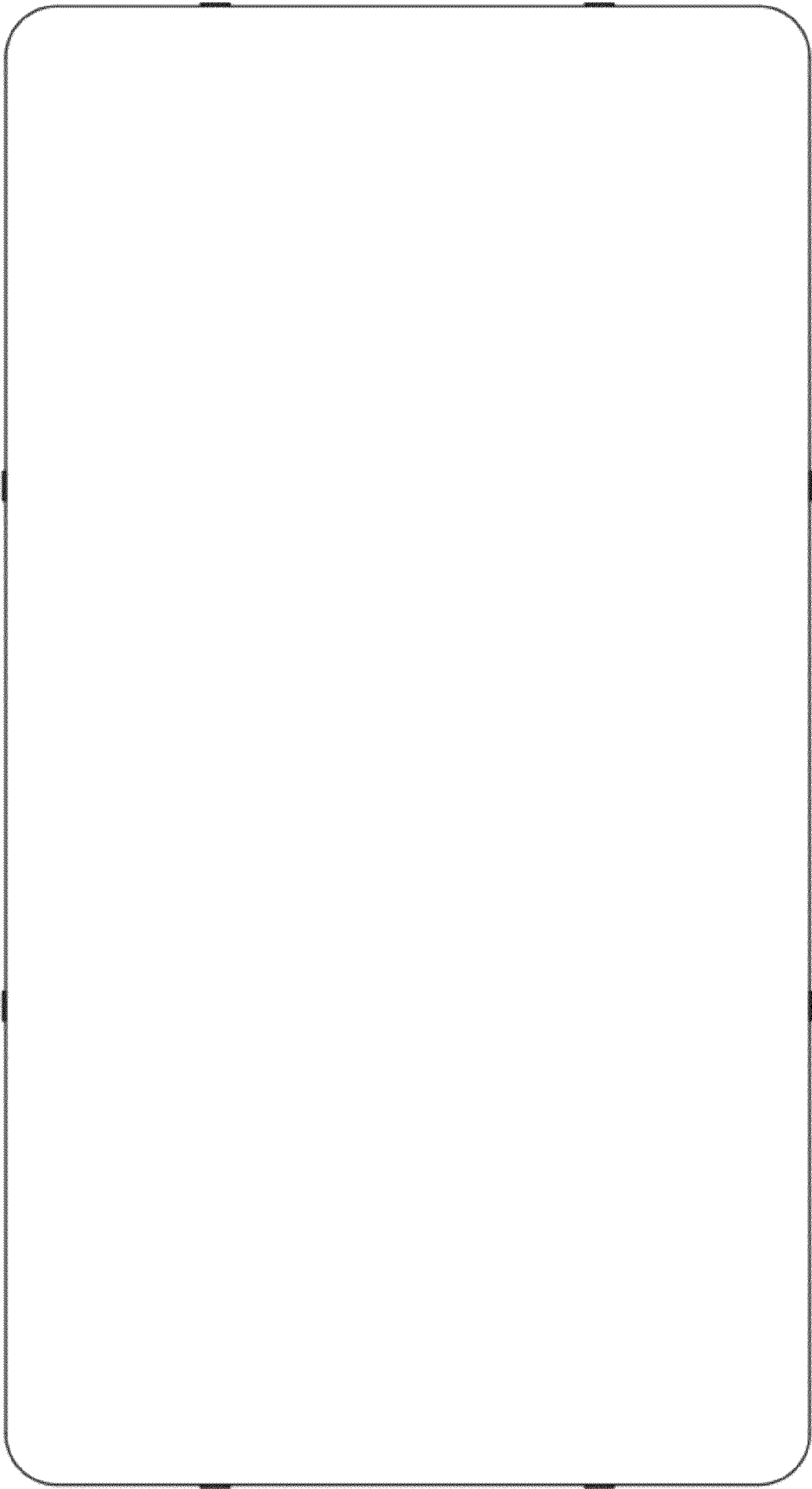
