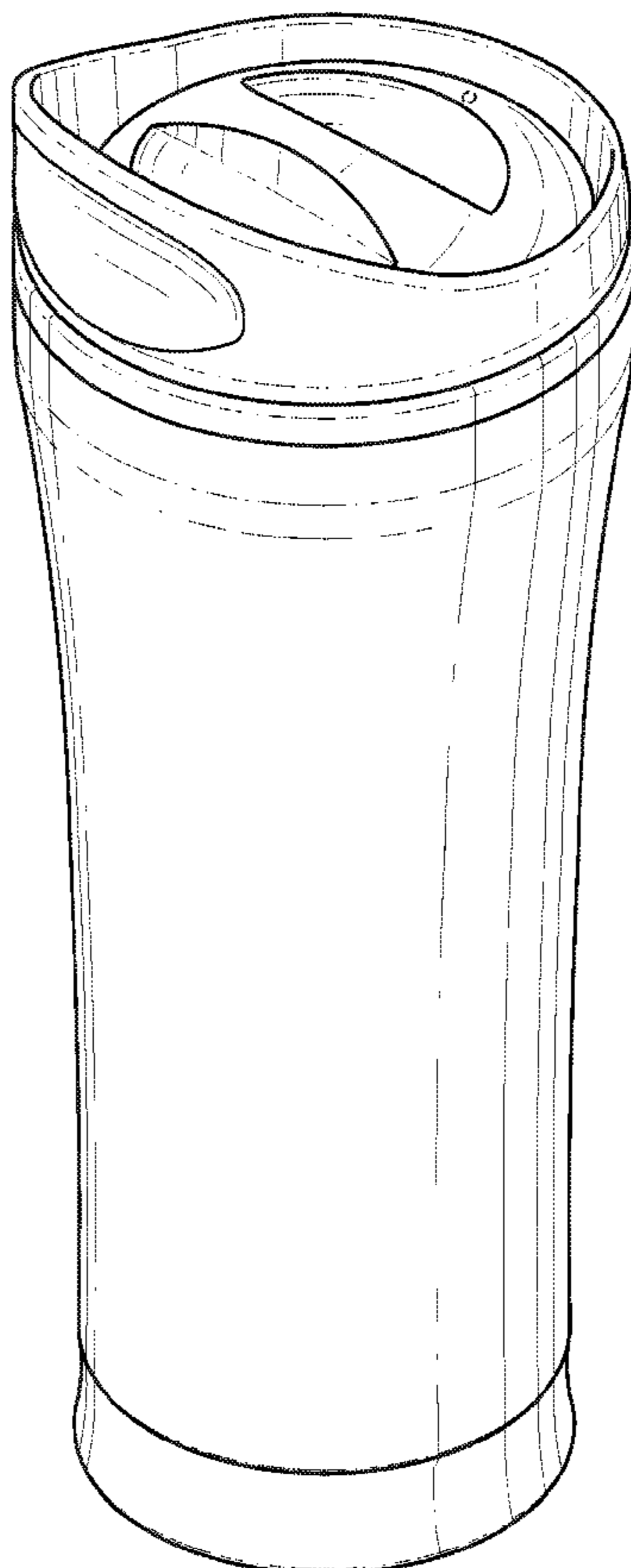
(57) **CLAIM**  
The ornamental design for a beverage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a beverage container showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a side view of the beverage container of FIG. 1, the right and left sides being mirror images.  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

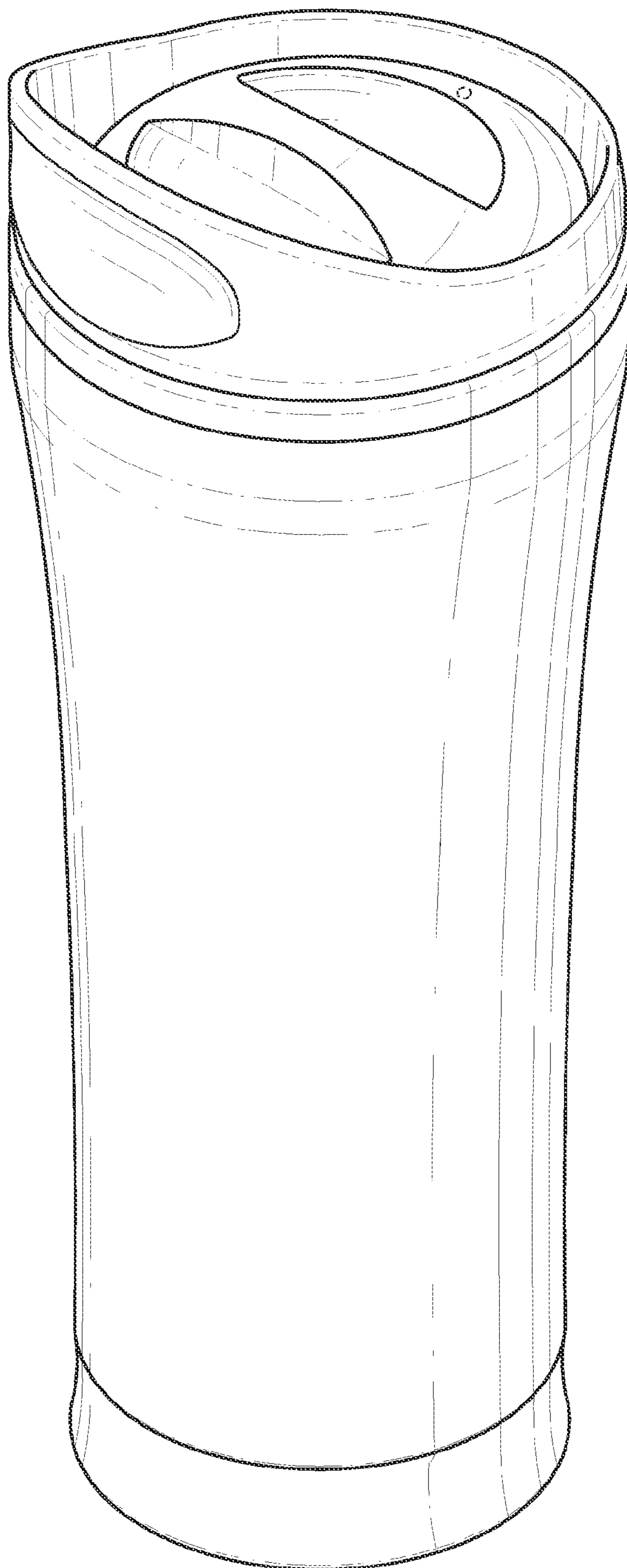

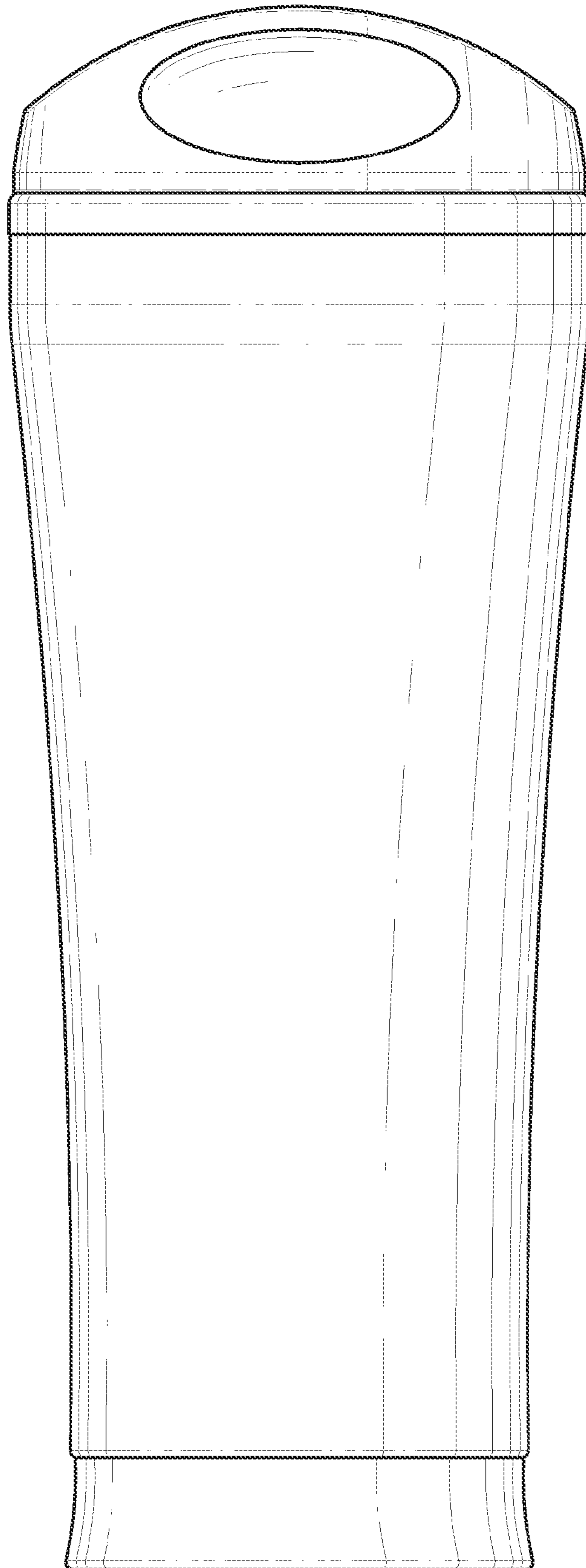

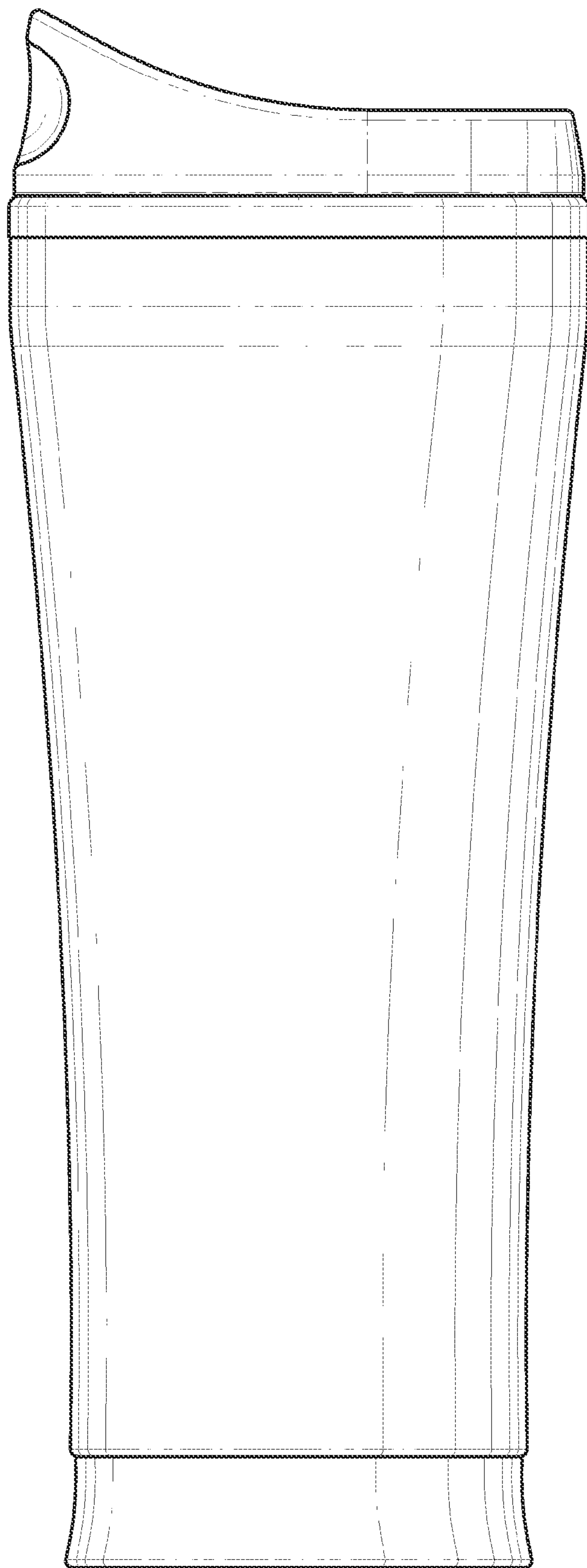

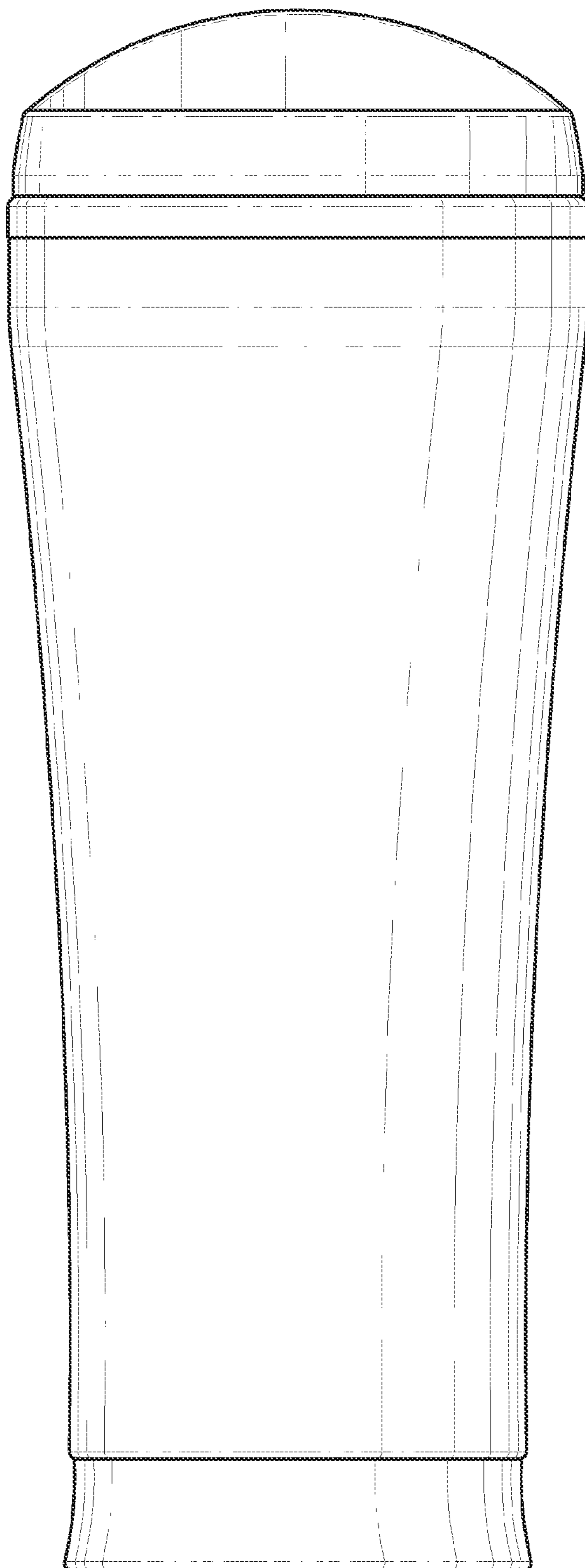
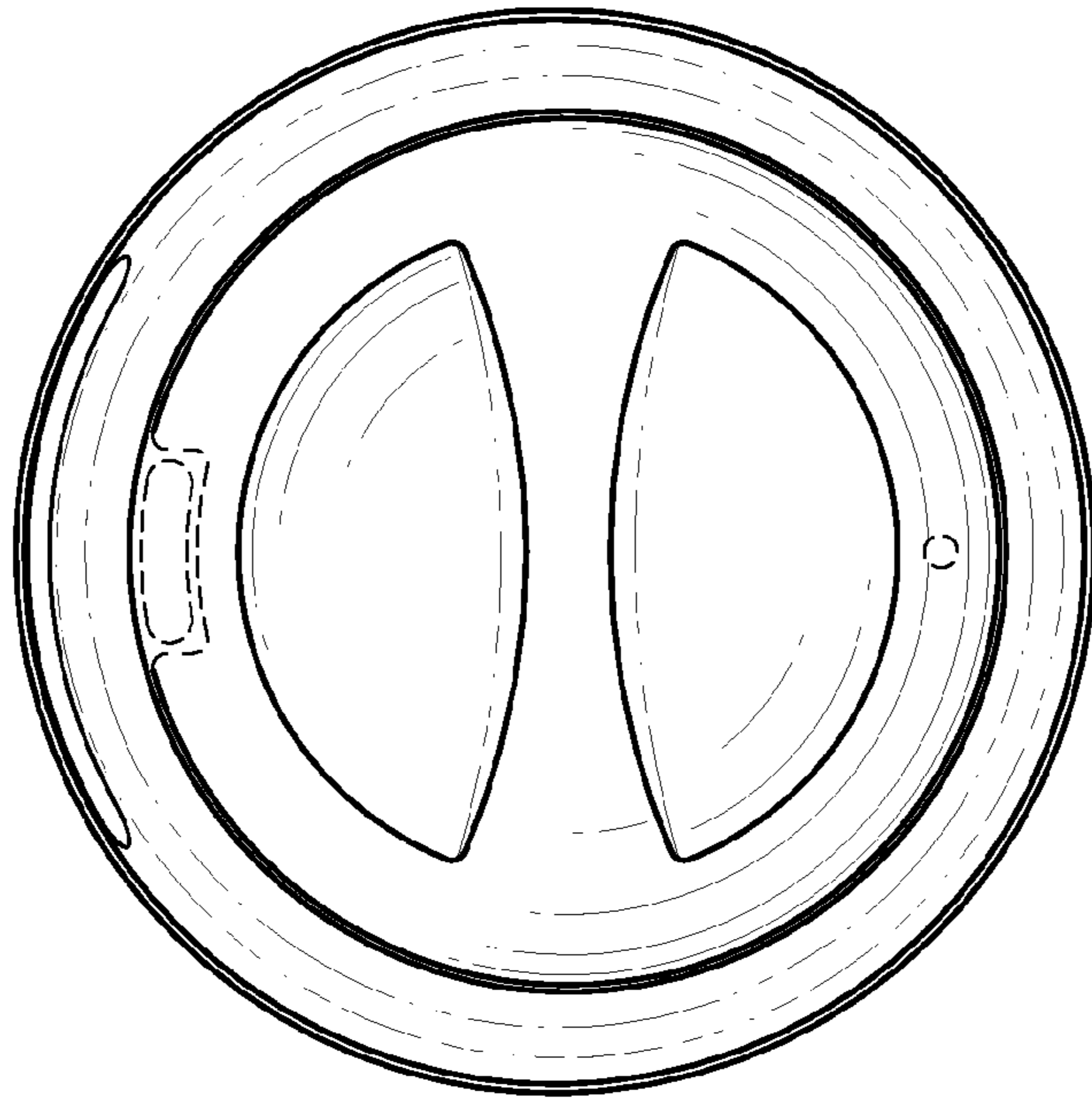
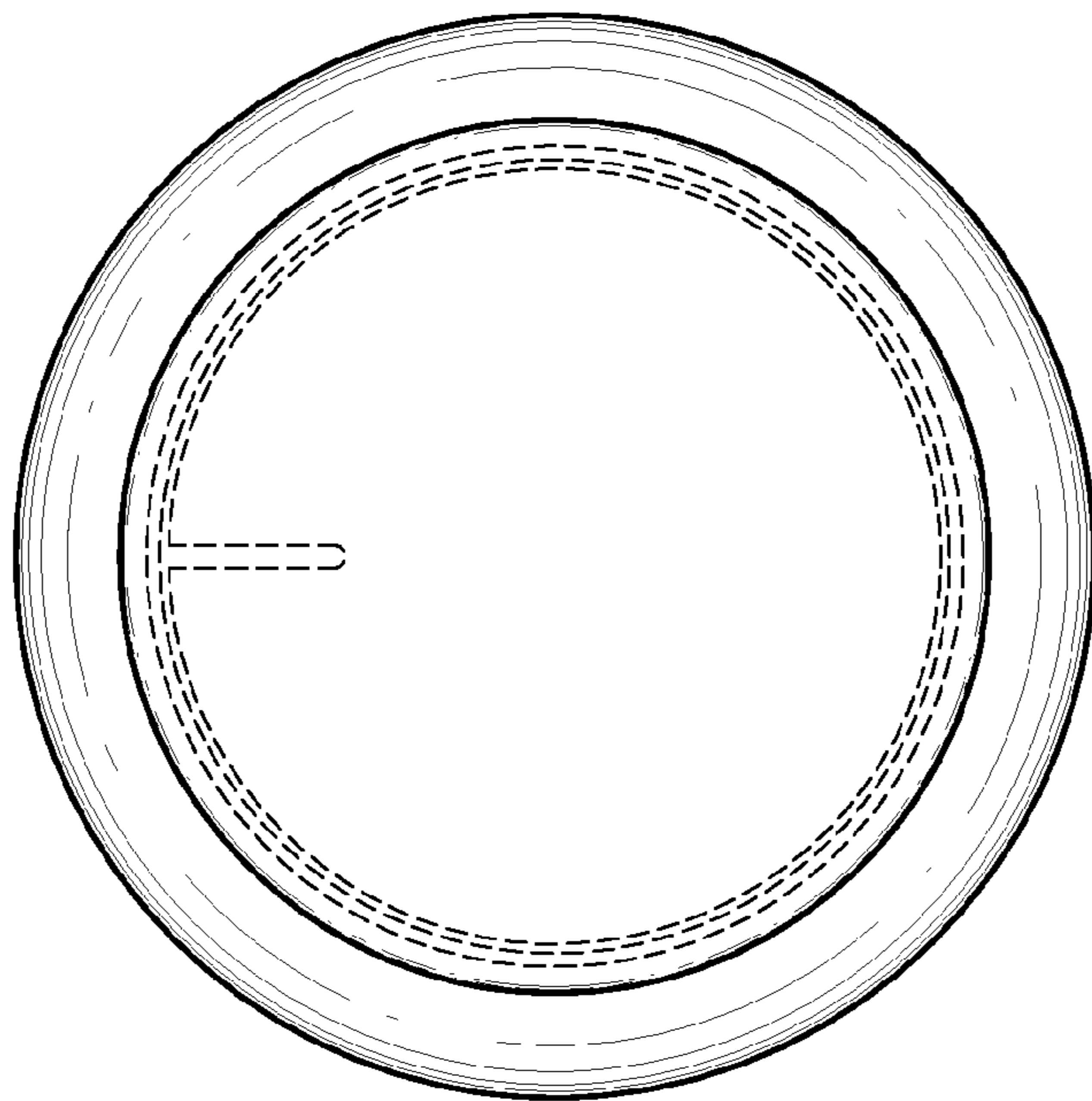
