FIG. 6 is a top view of the grater.

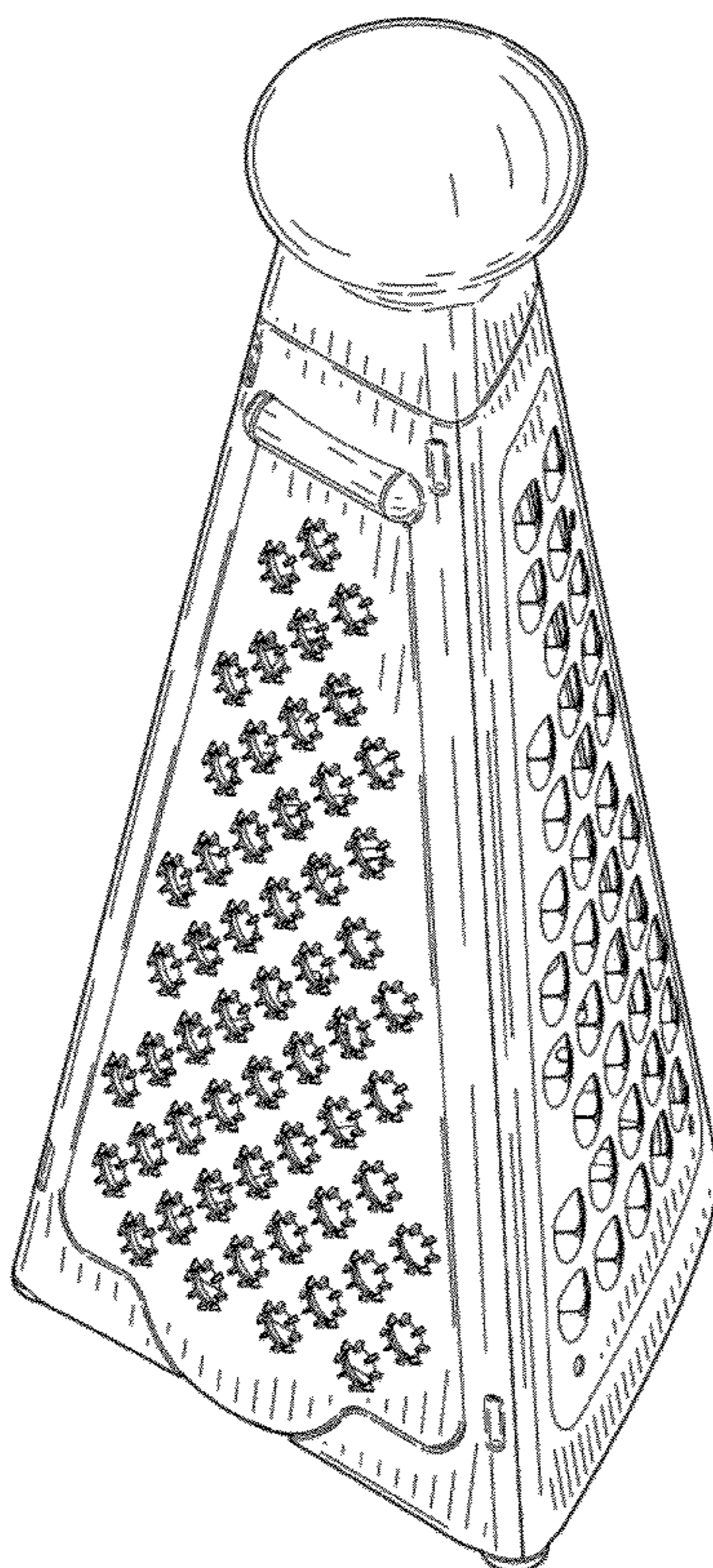
The bottom view is unornamented and not shown.

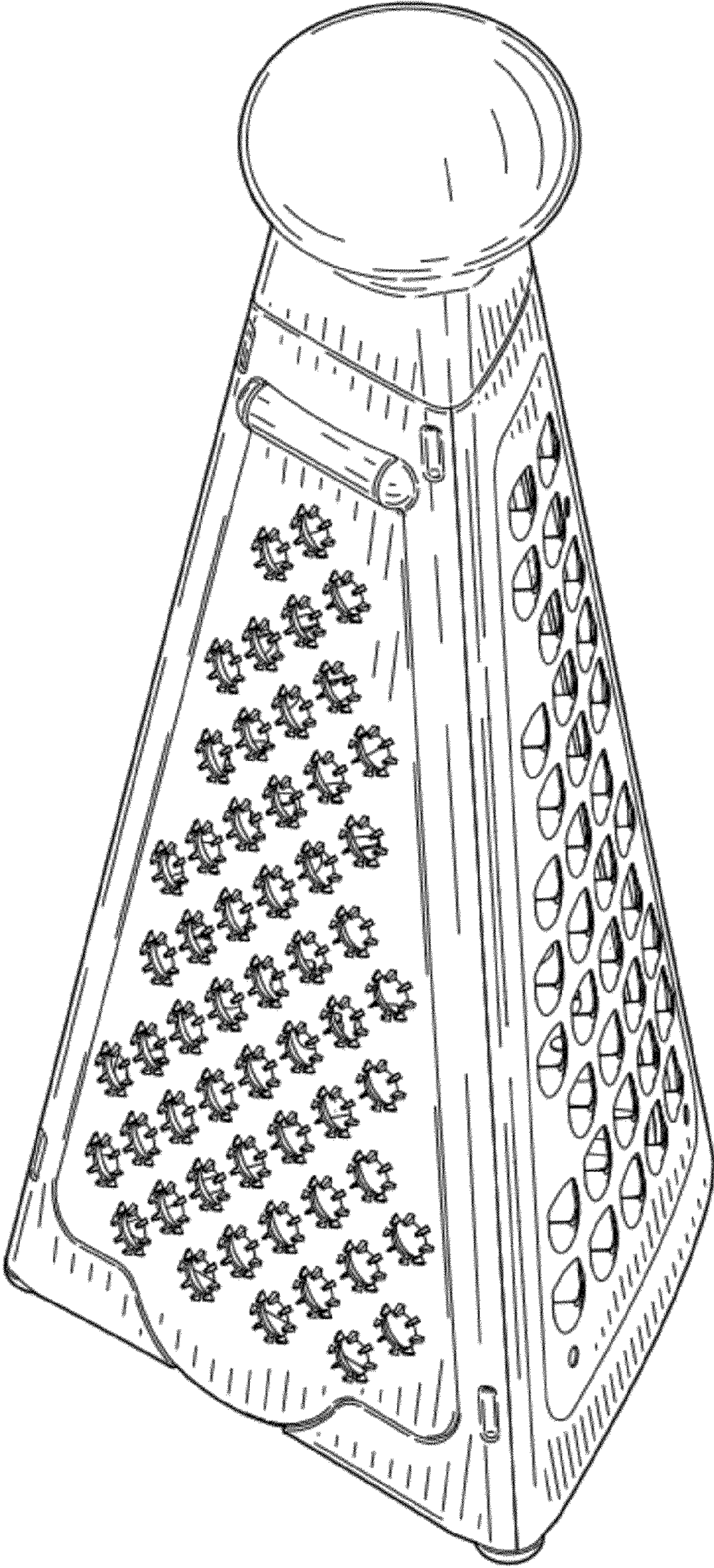

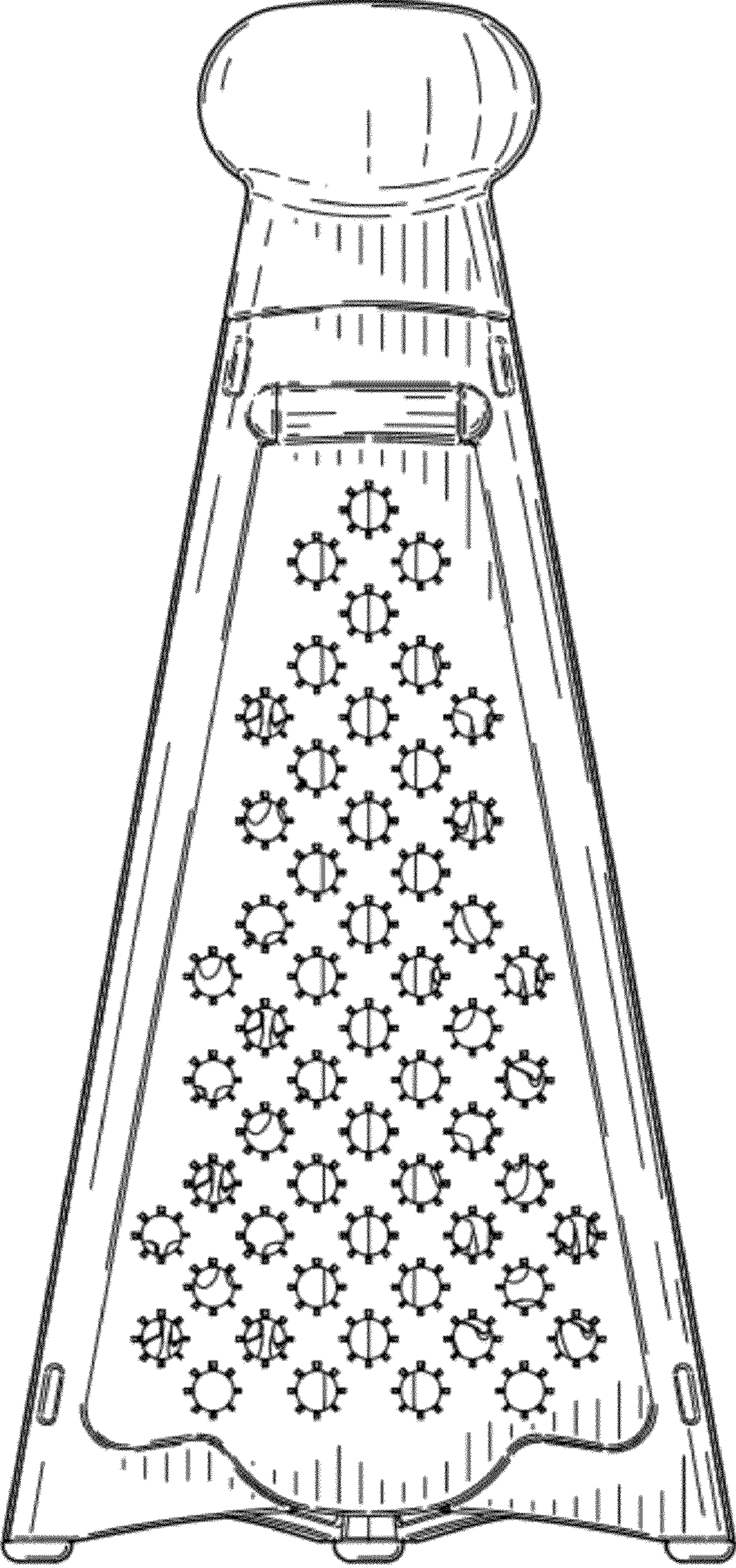

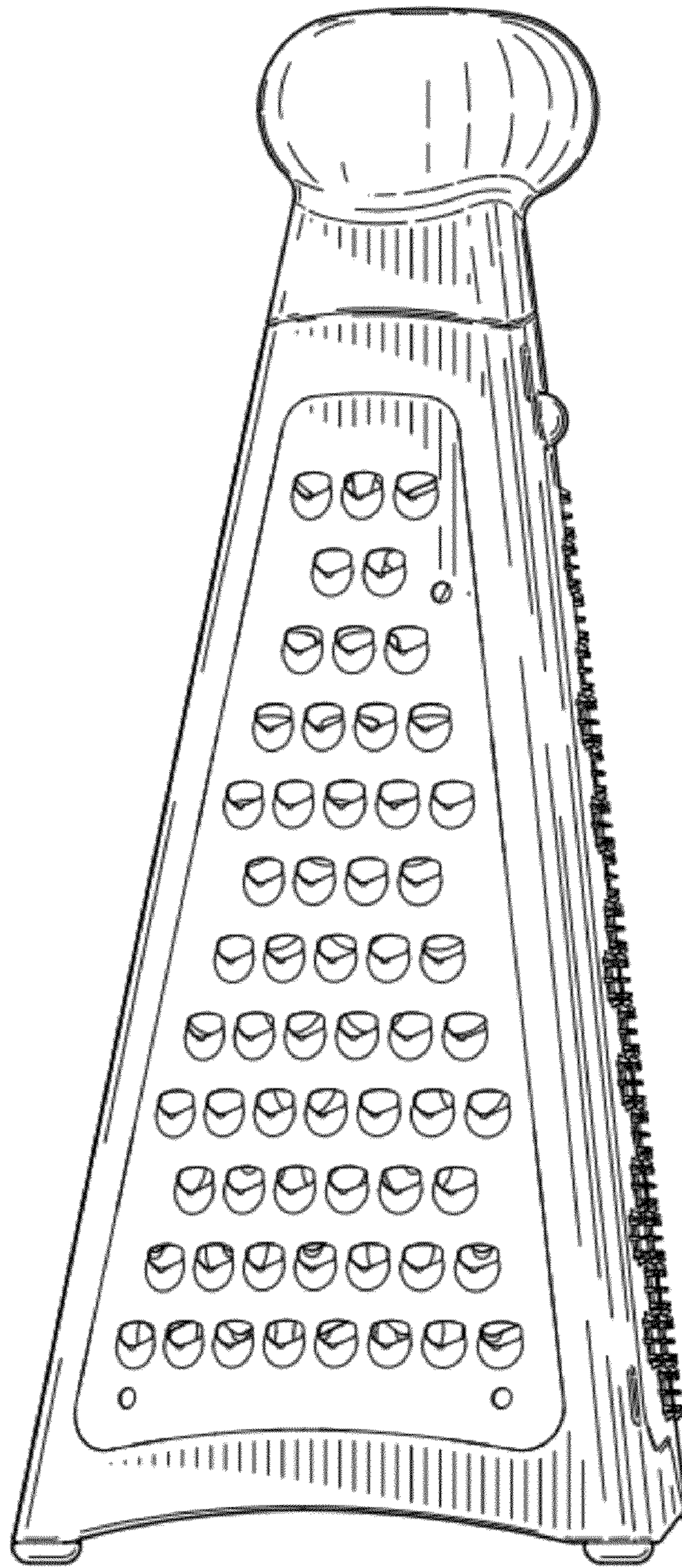

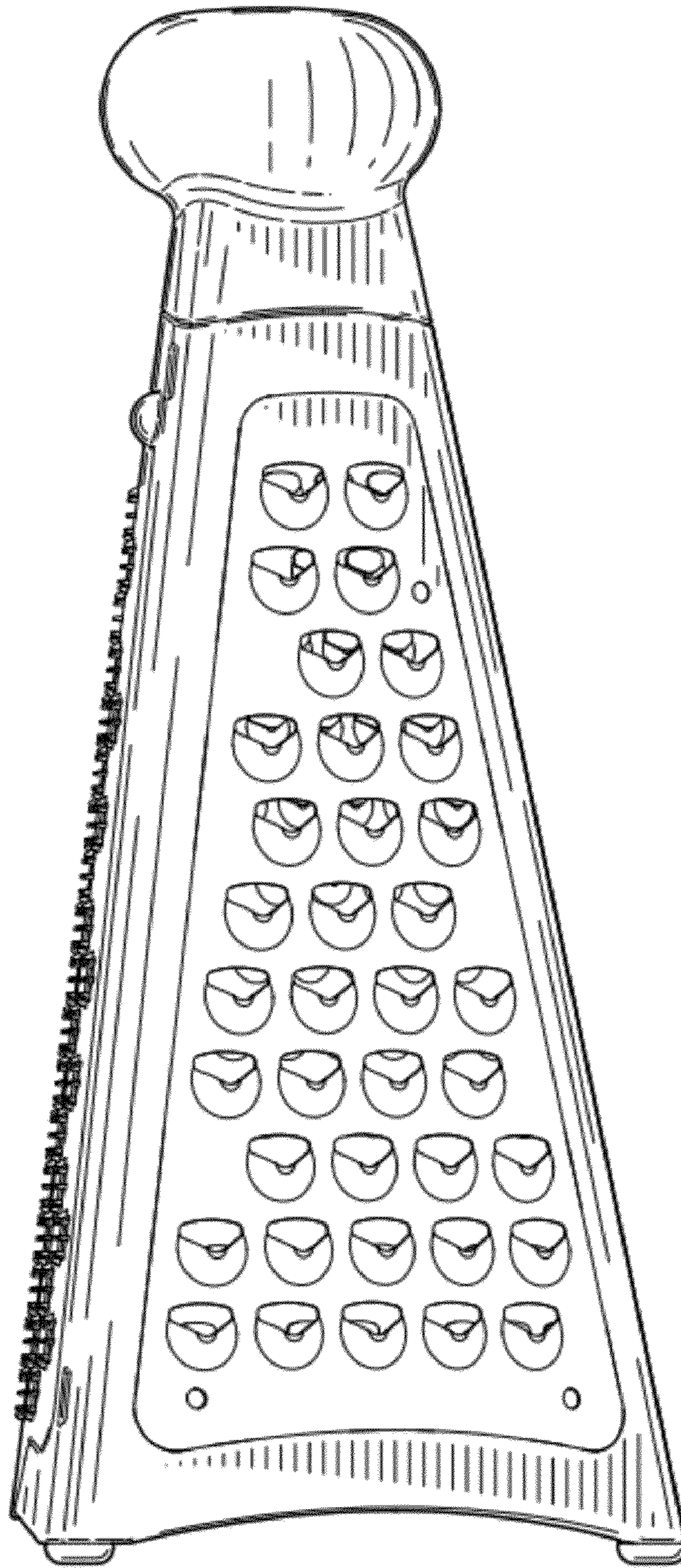

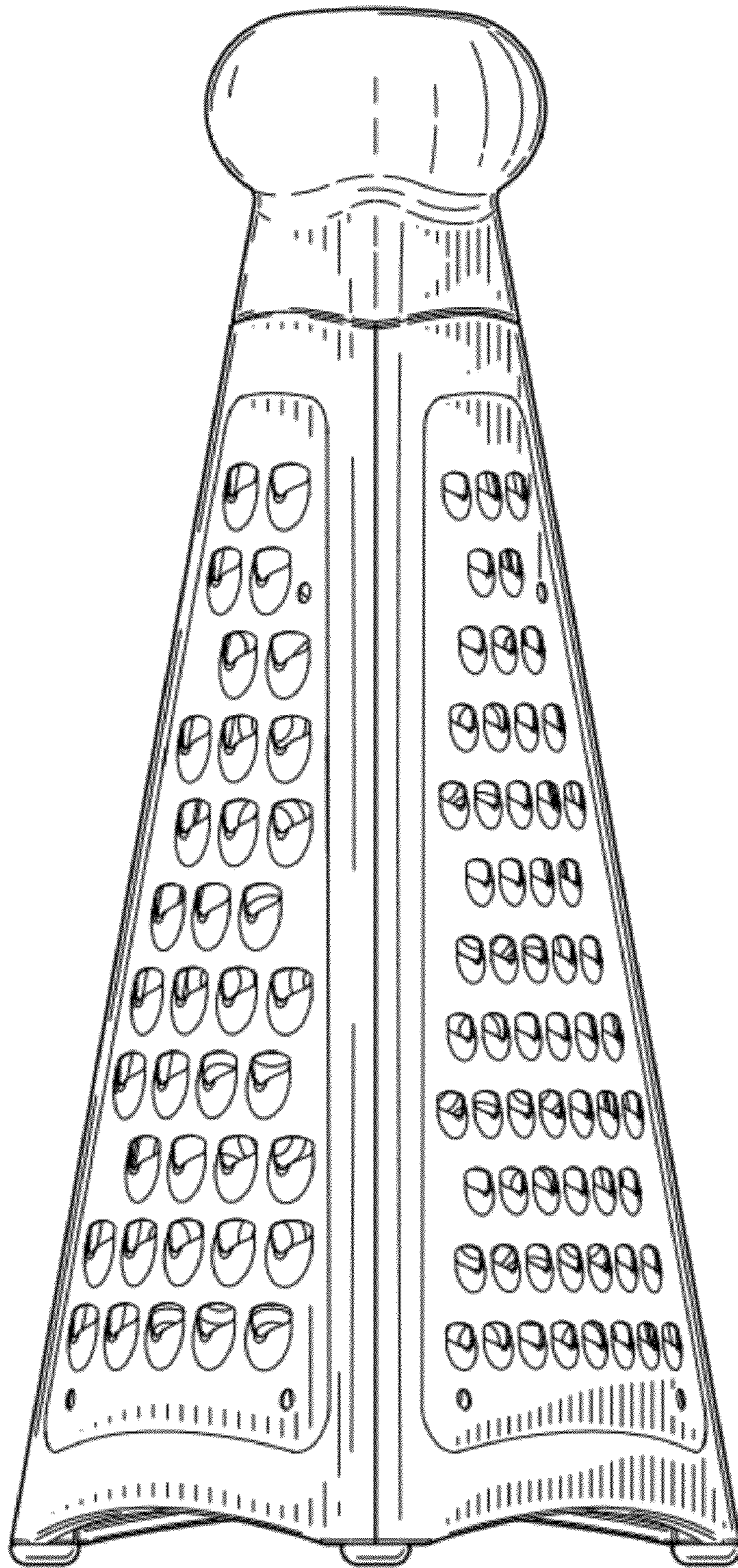

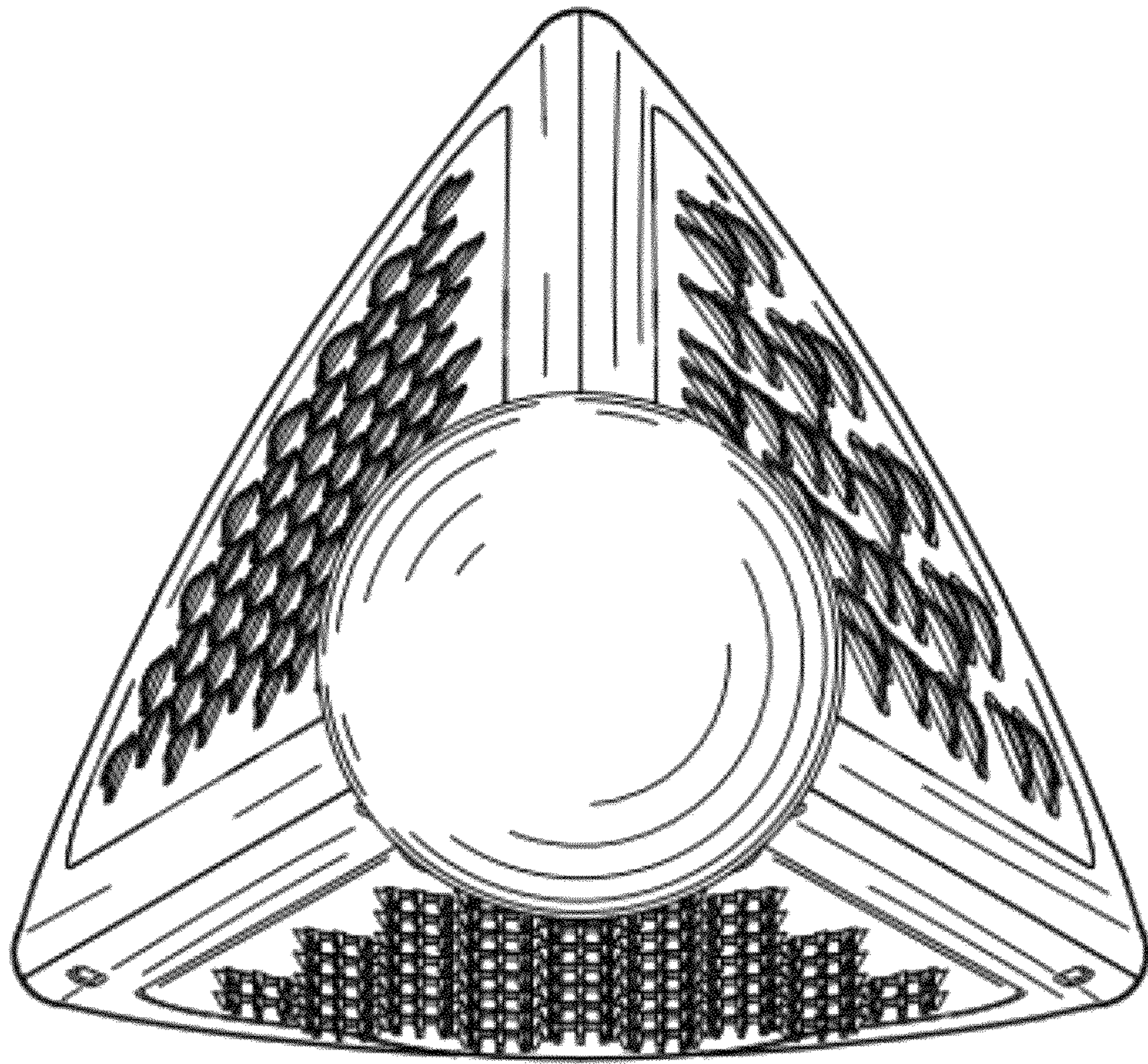
