DESCRIPTION

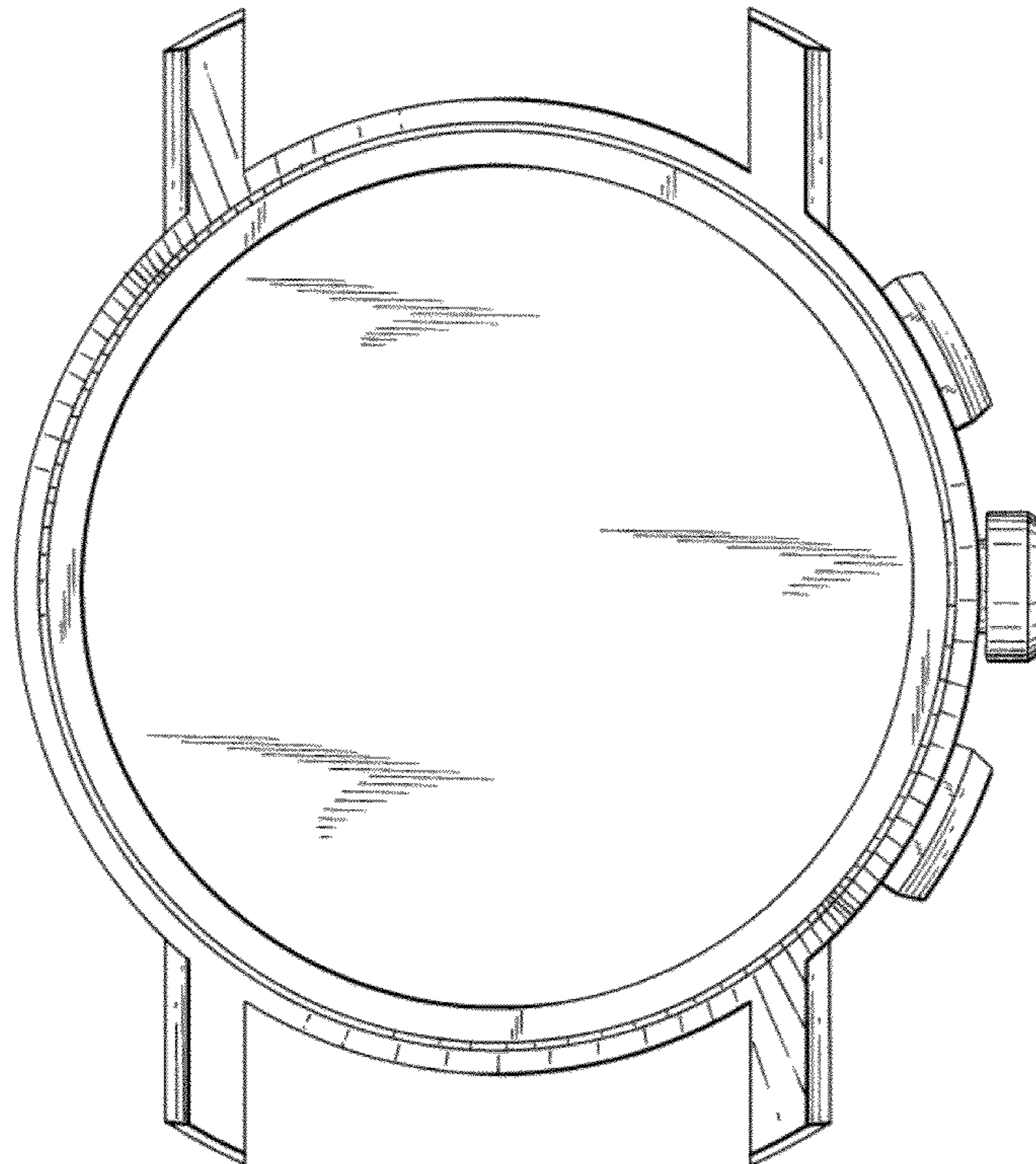
FIG. 1 is a perspective view of a wrist watch case in accordance with my design;

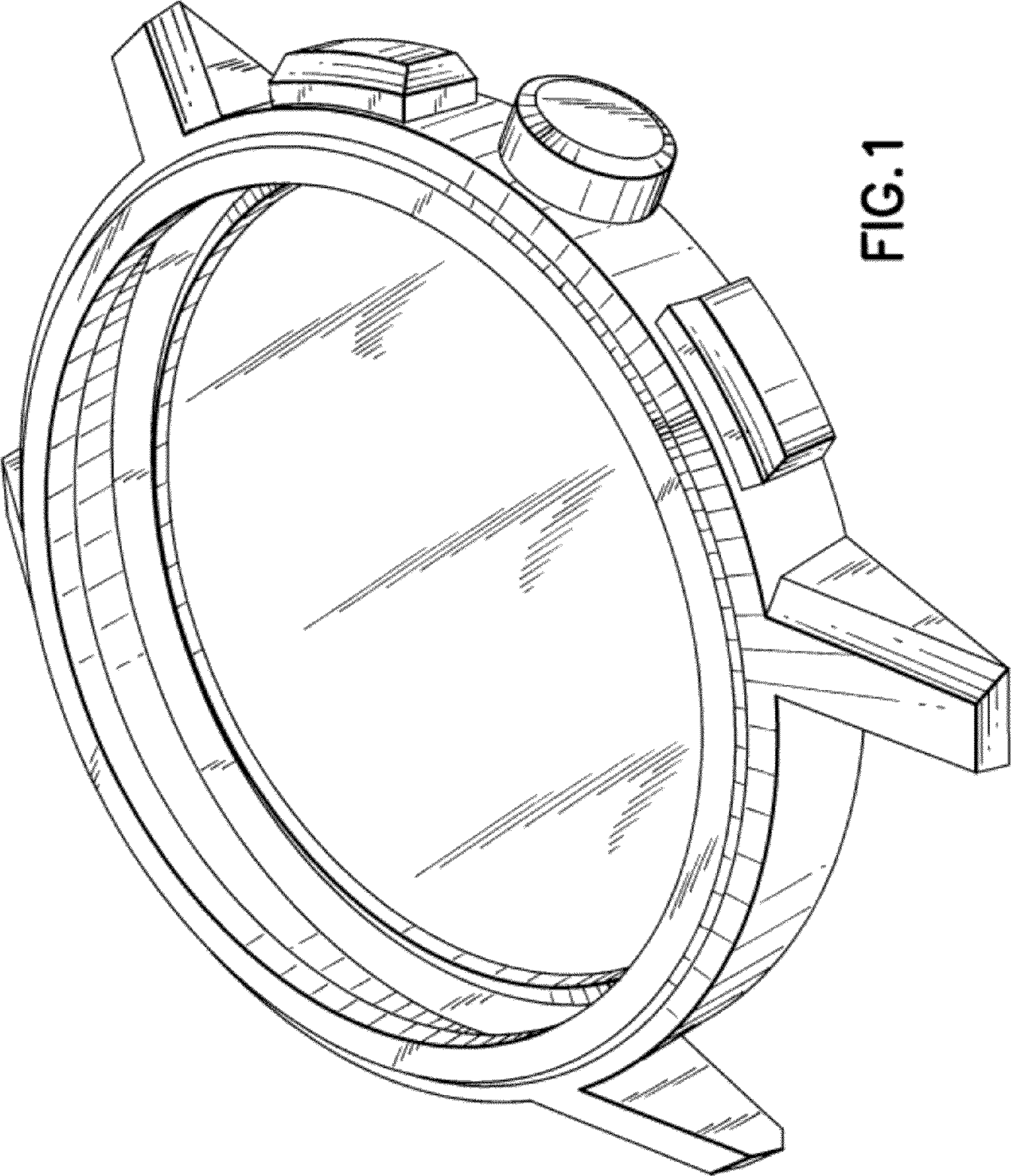

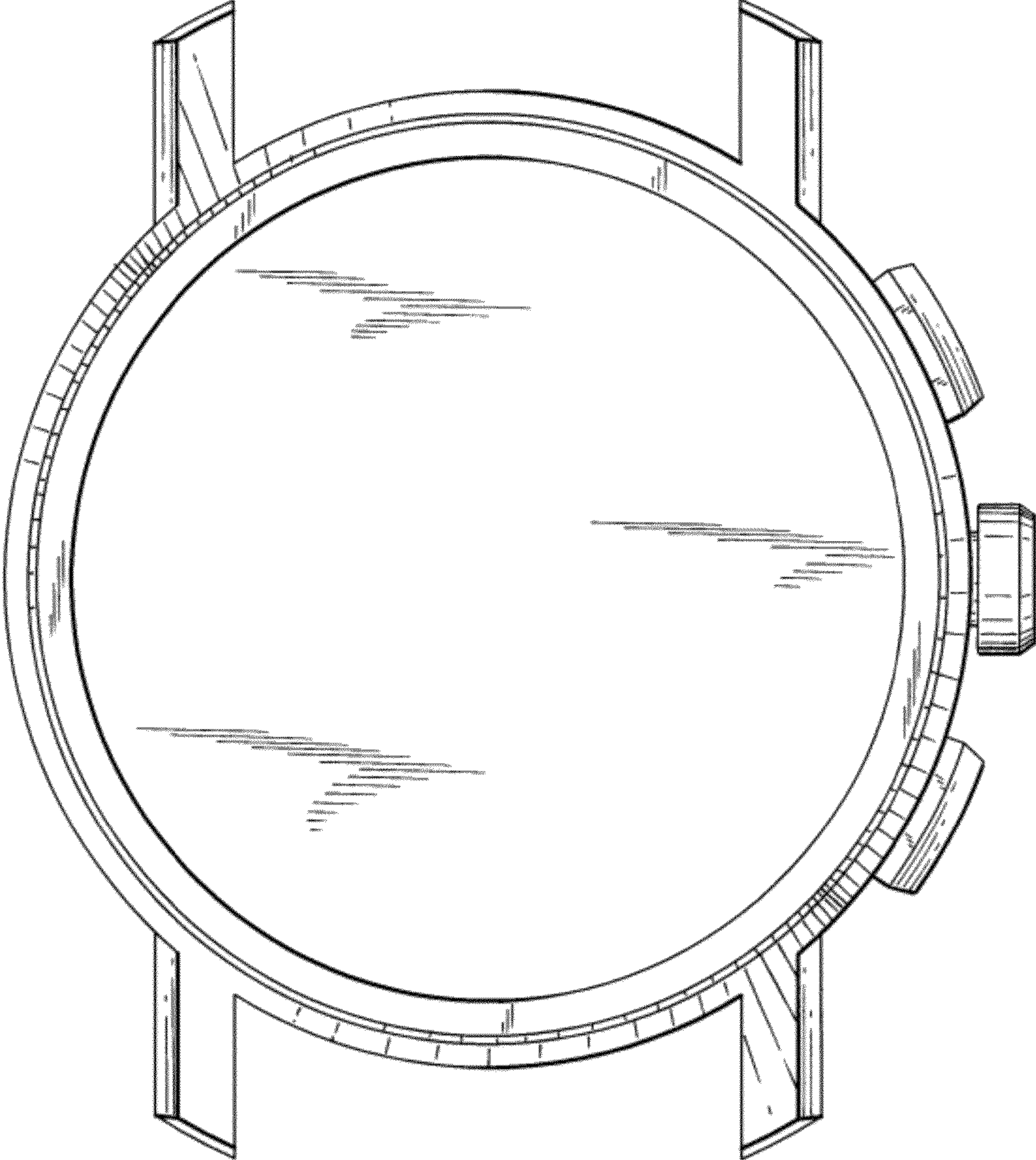

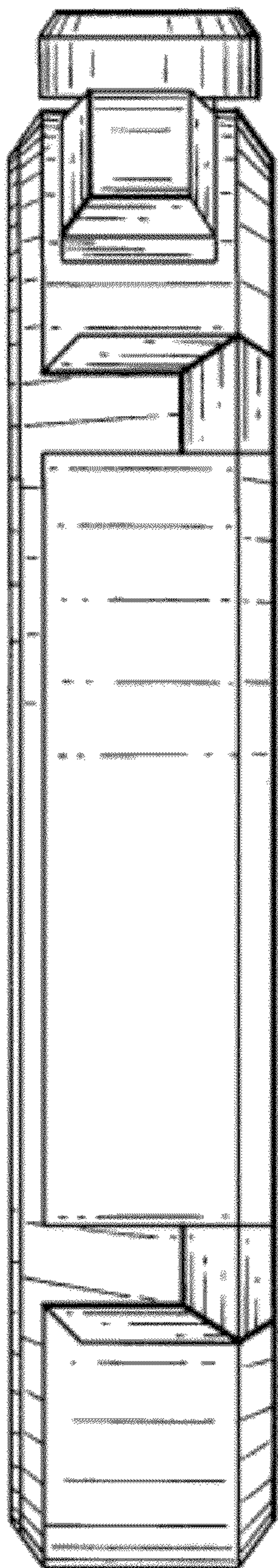

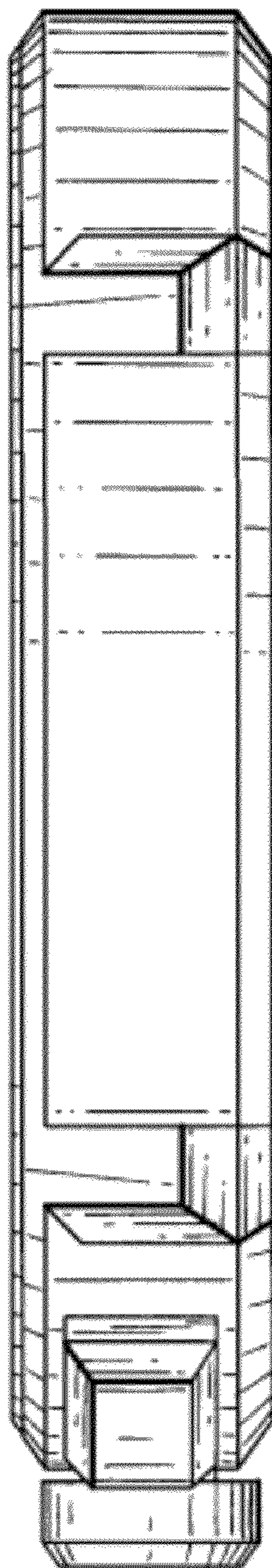

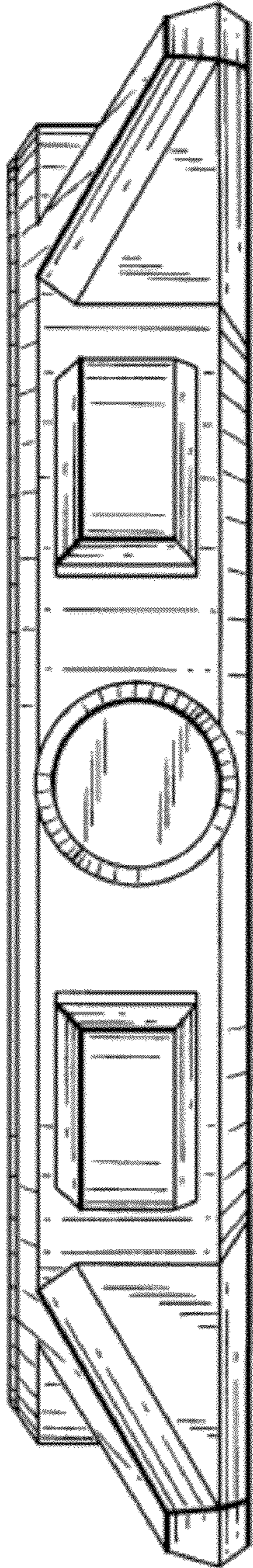

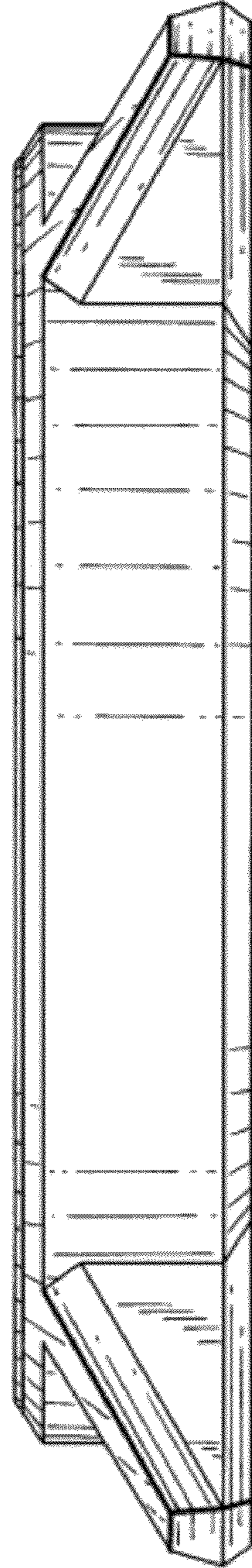

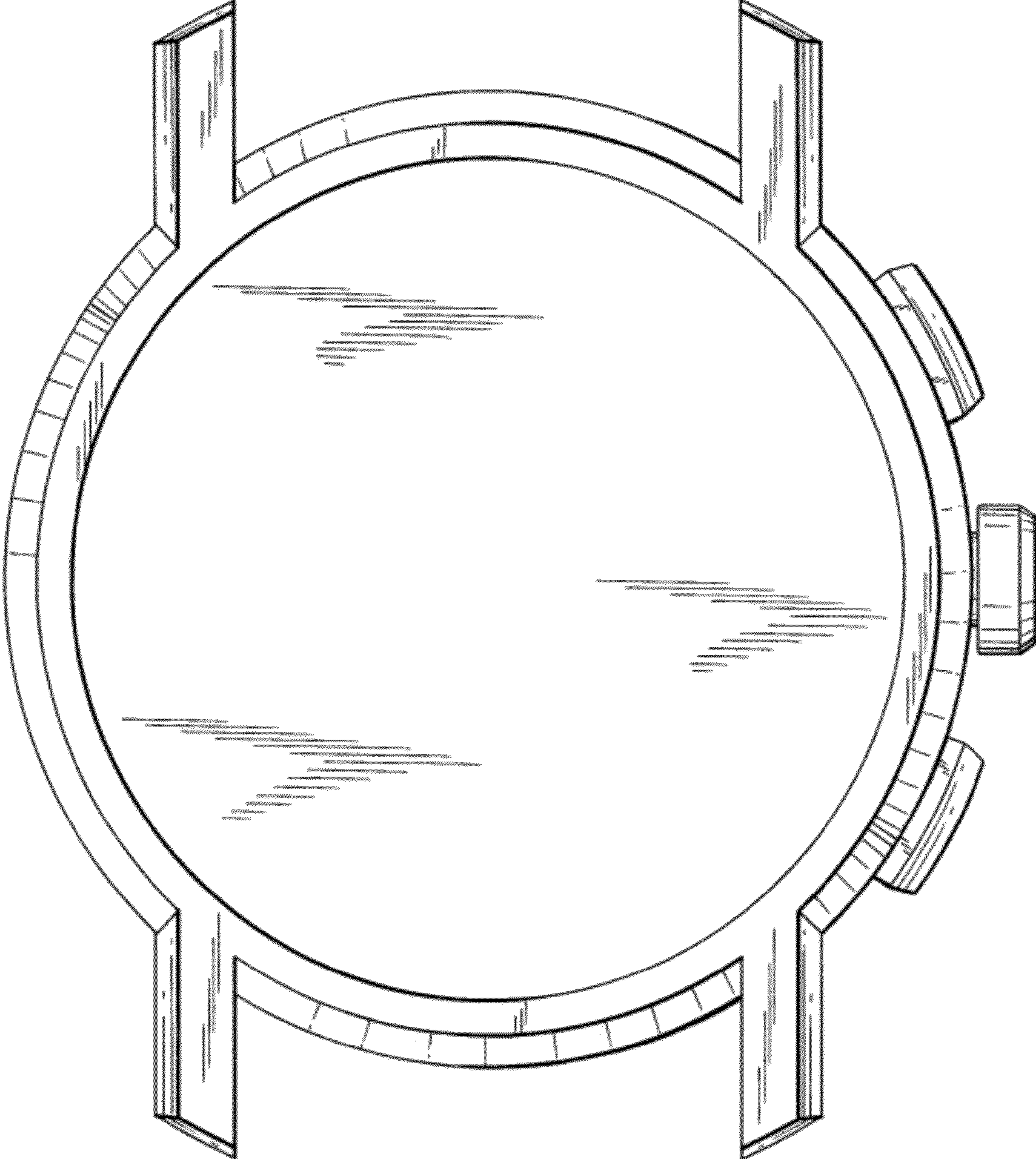
