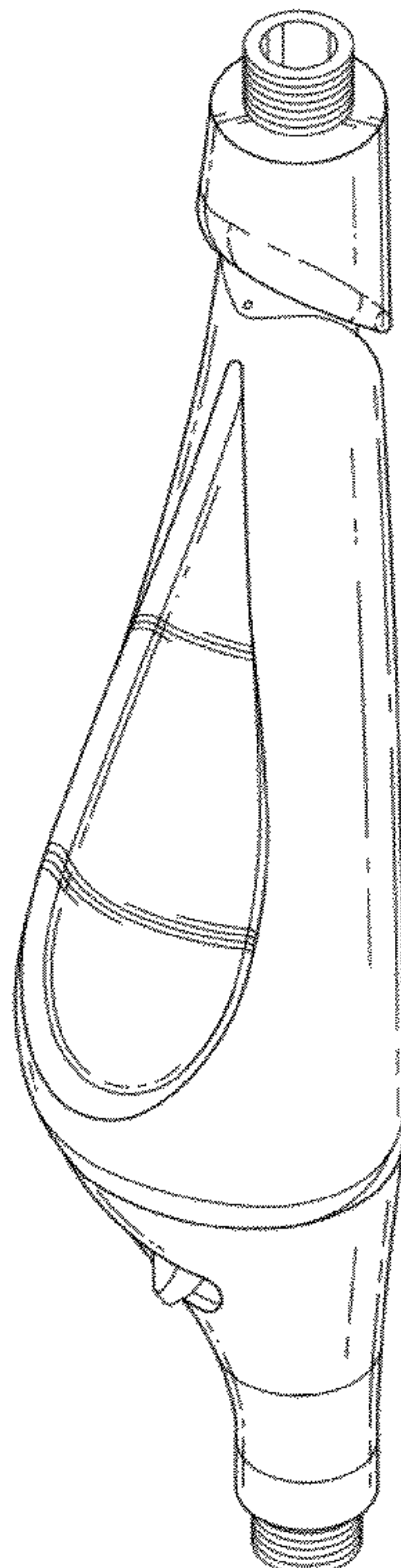
(57) **CLAIM**

The ornamental design for a bottle and bottle mixing unit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the bottle and bottle mixing unit of the present design;
FIG. 2 is a top view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a perspective view thereof;
FIG. 5 is an elevational view similar to FIG. 1 but illustrating the bottle removed from the mixing unit of the present design;
FIG. 6 is an elevational view of the design shown in FIG. 5 substantially as seen from the left side of FIG. 5;
FIG. 7 is a top elevational view of the design shown in FIG. 5; and,
FIG. 8 is a perspective view of FIG. 5.

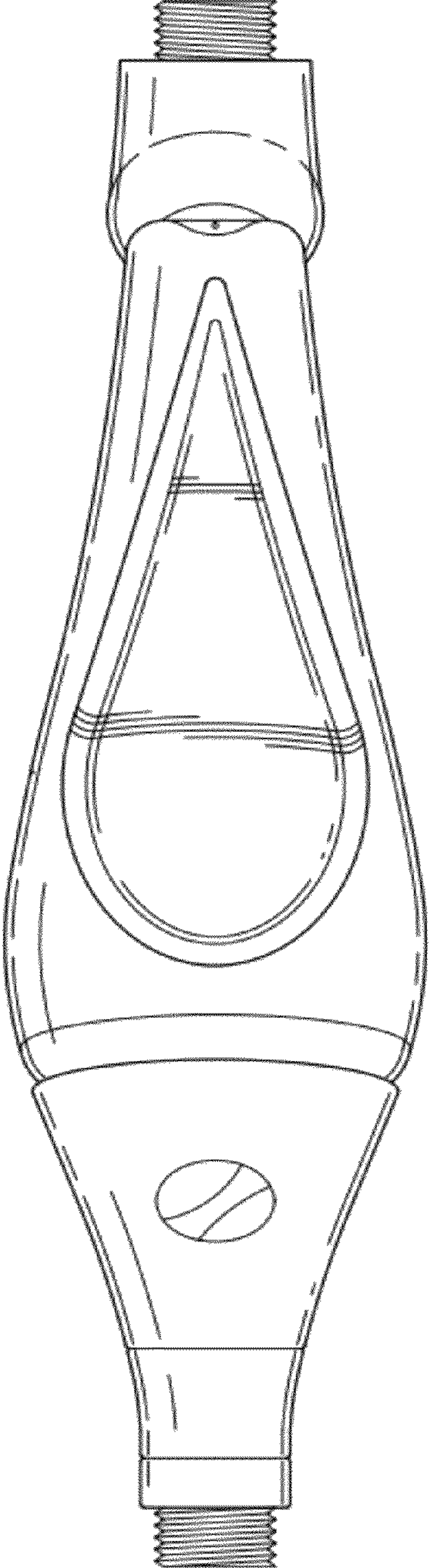

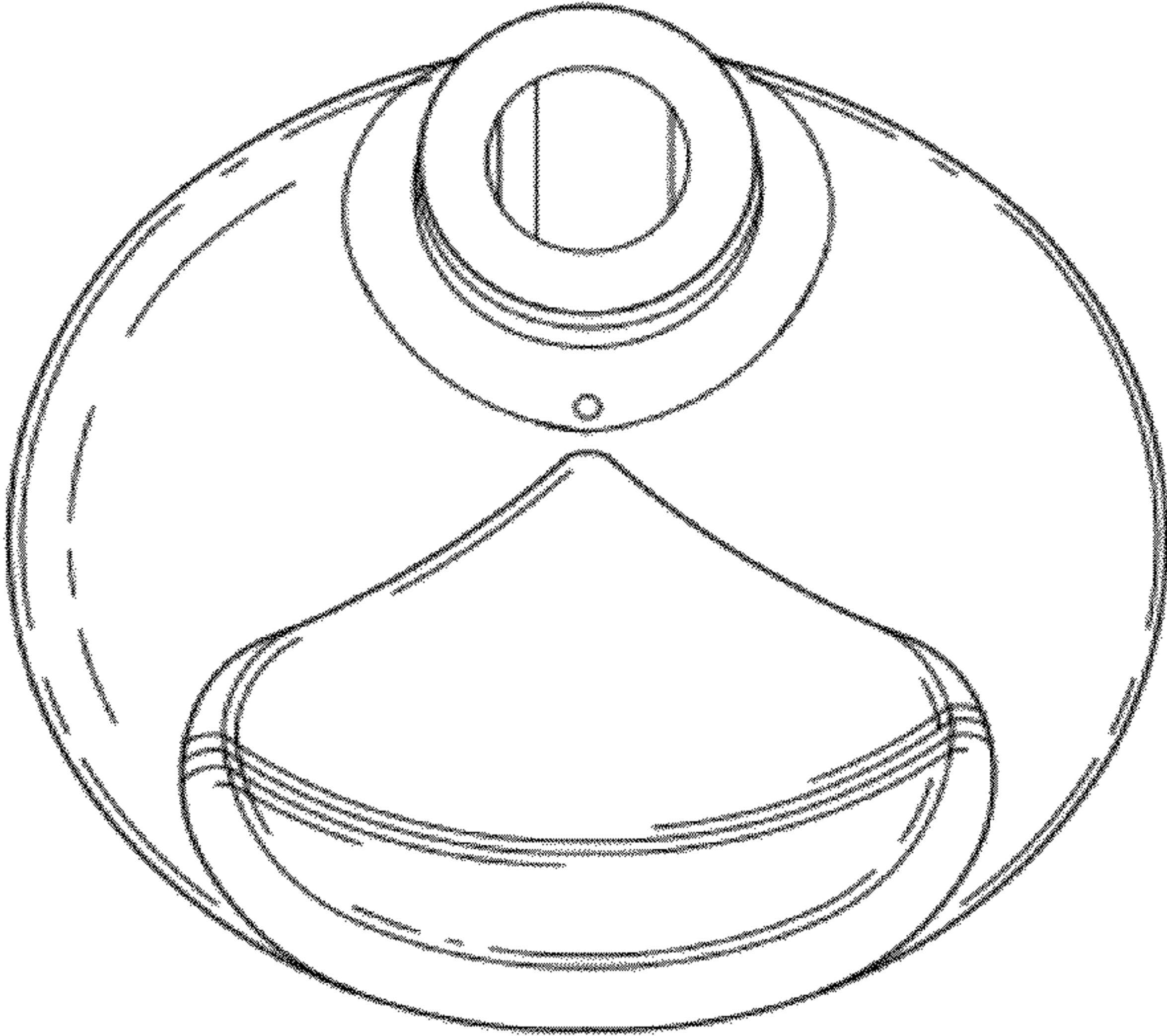

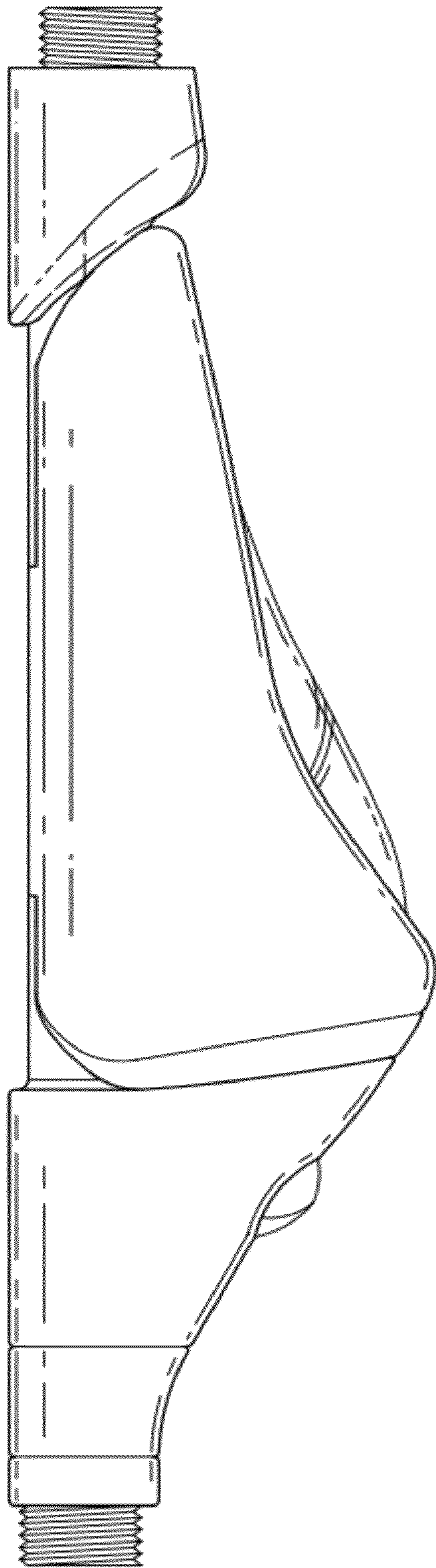

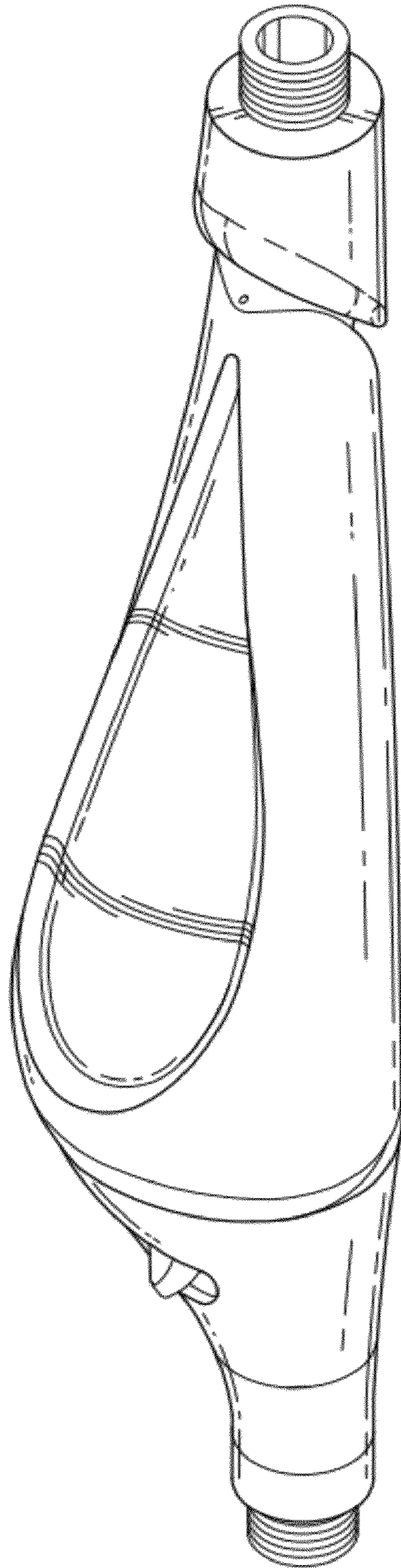

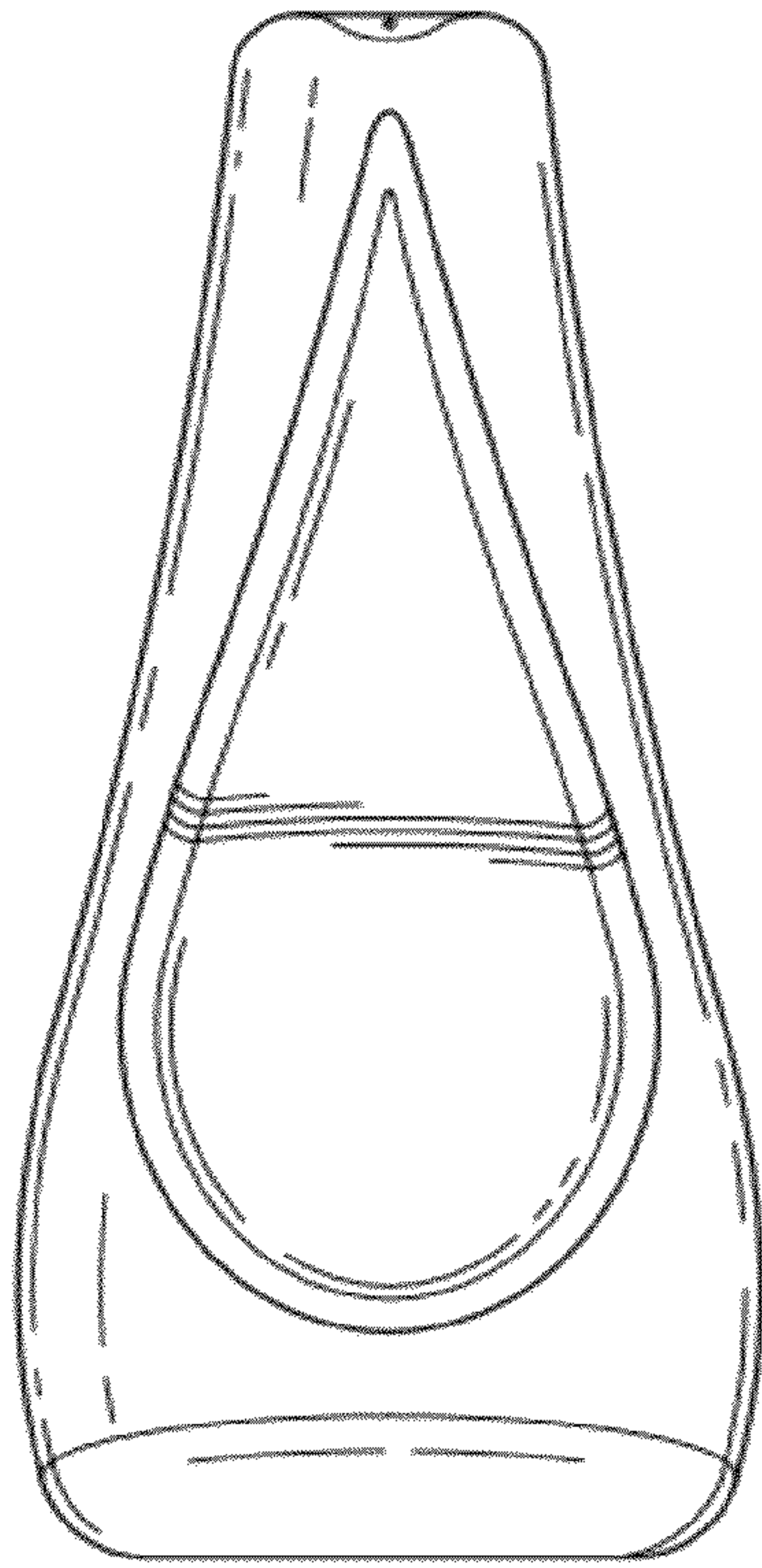

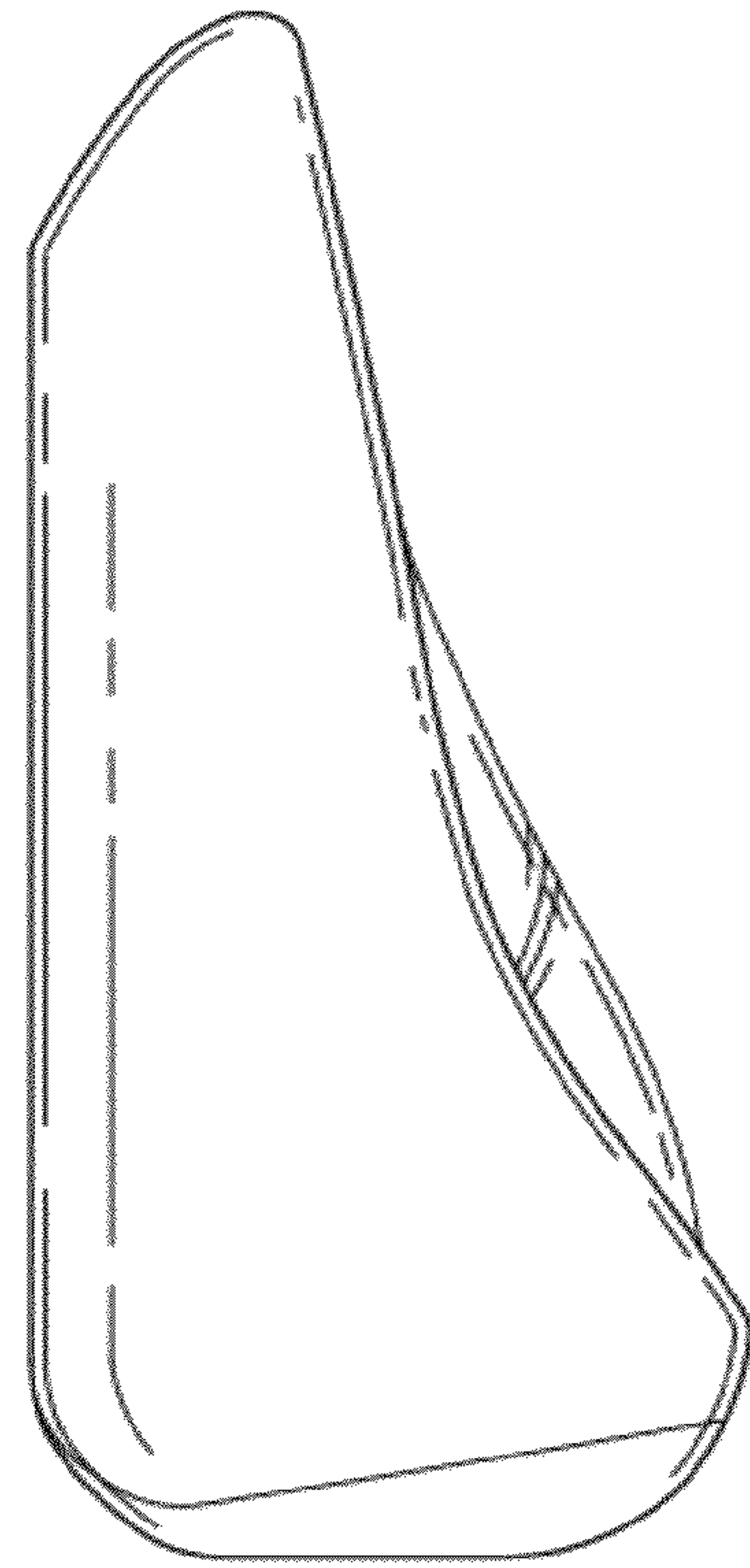

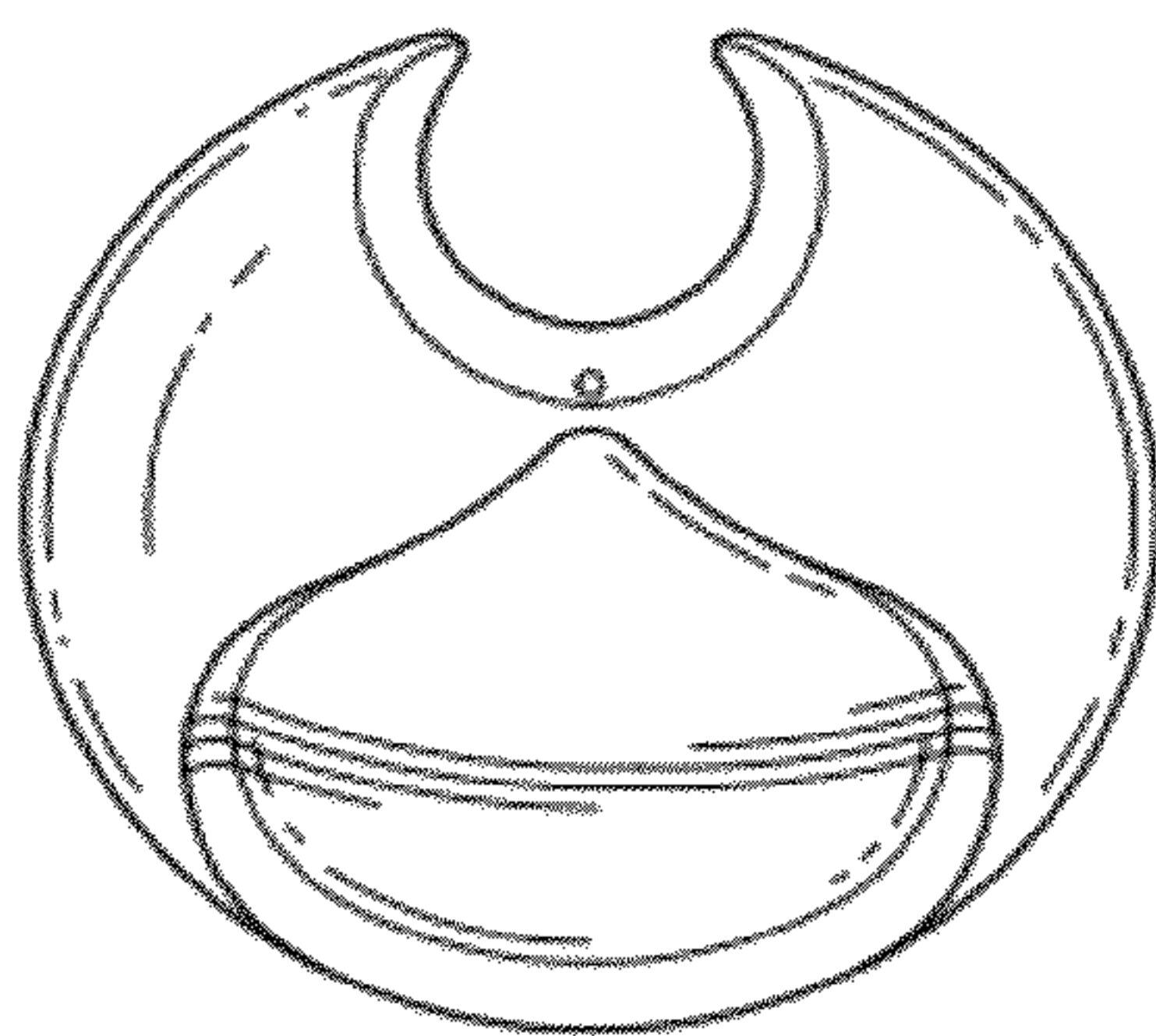

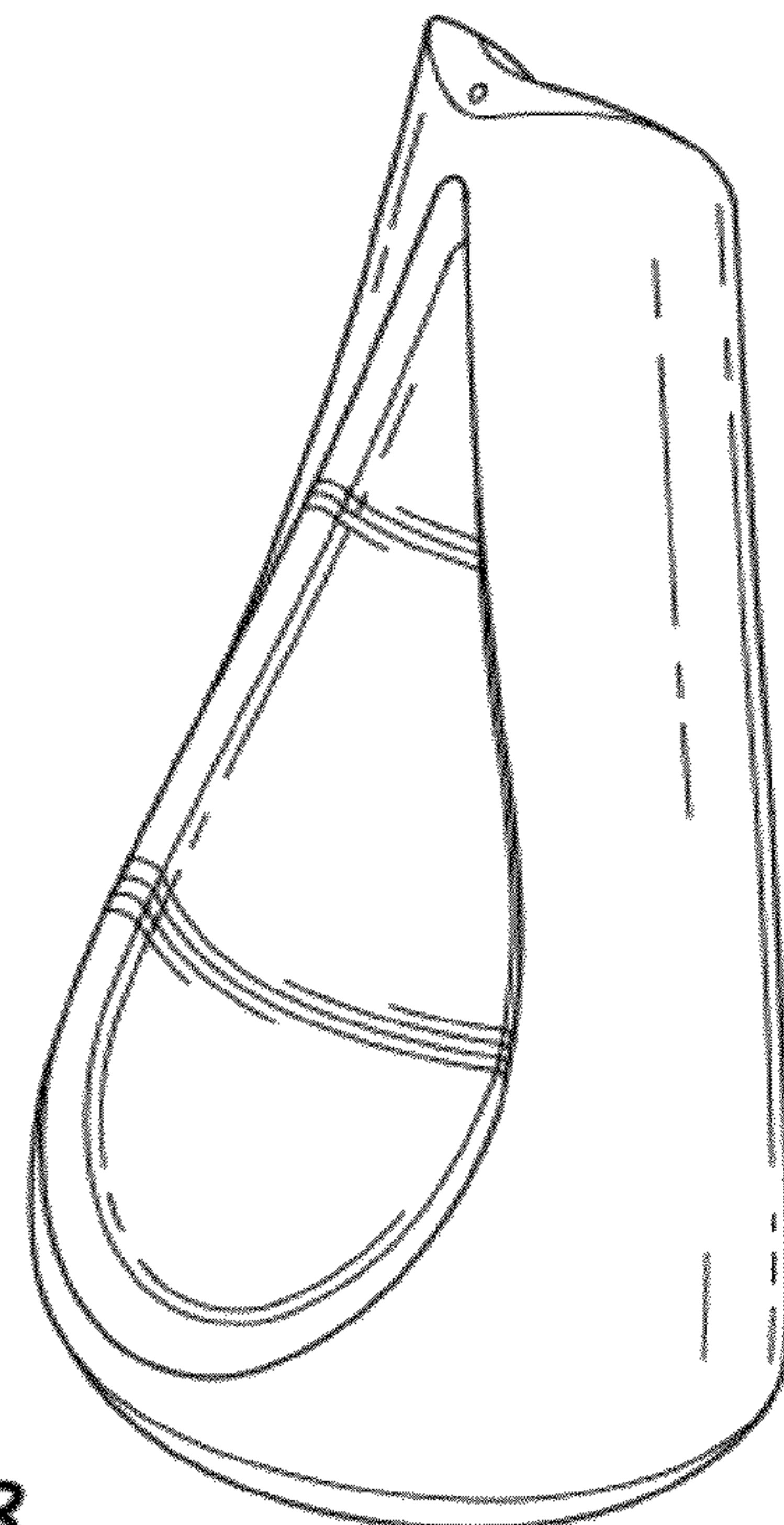
