**DESCRIPTION**

FIG. 3 is a rear elevation view thereof,

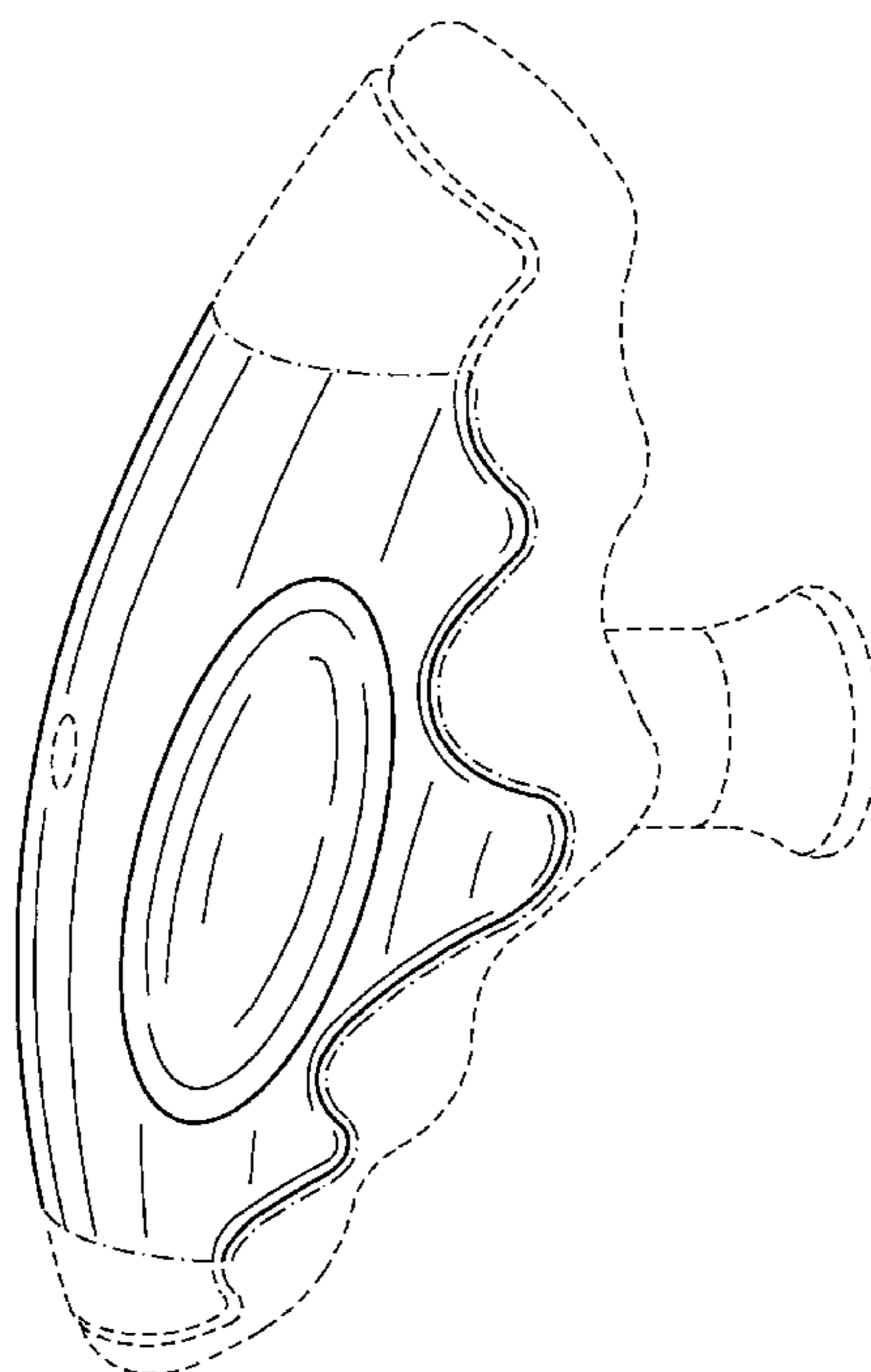
FIG. 4 is a top plan view thereof;

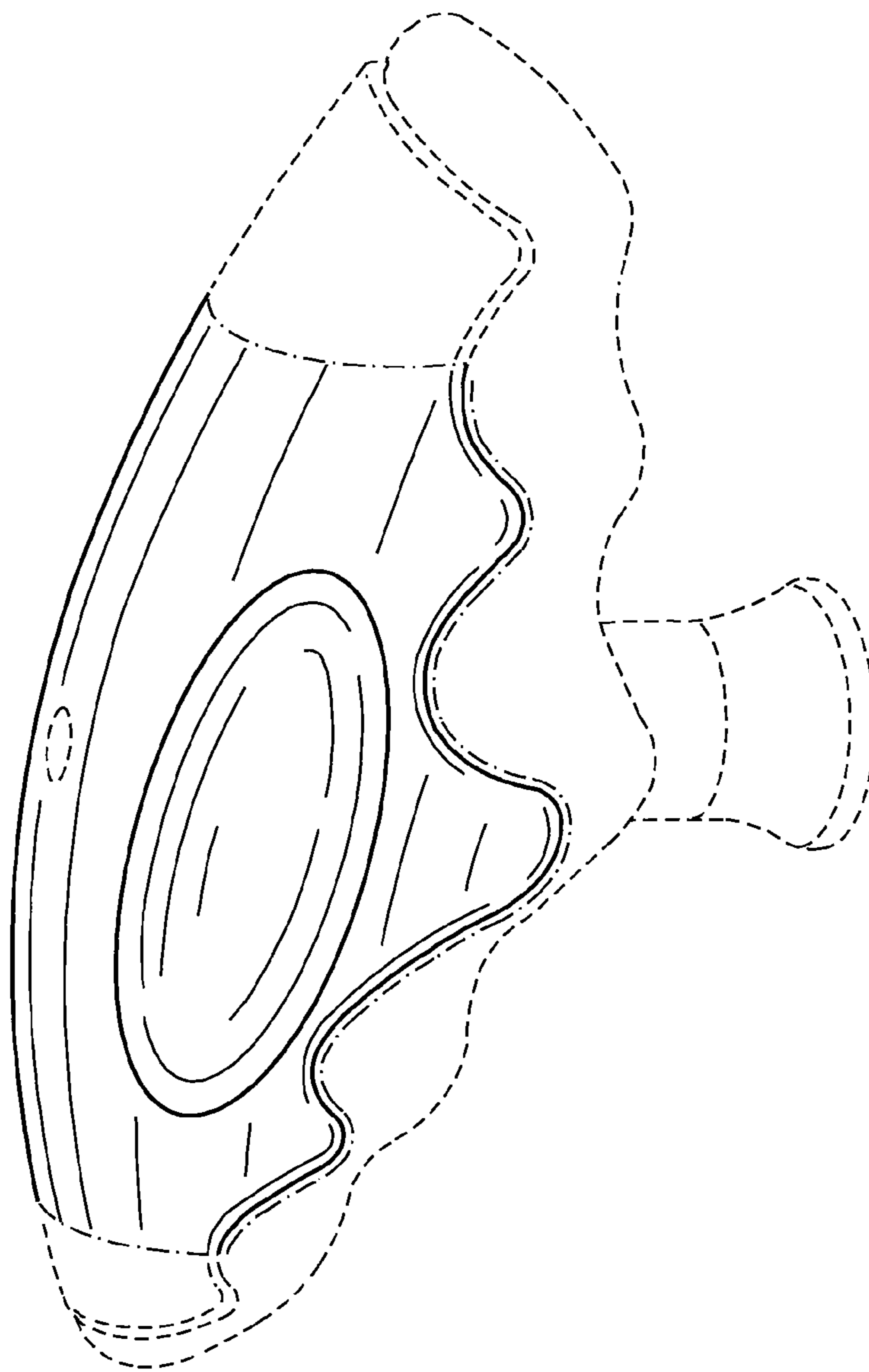

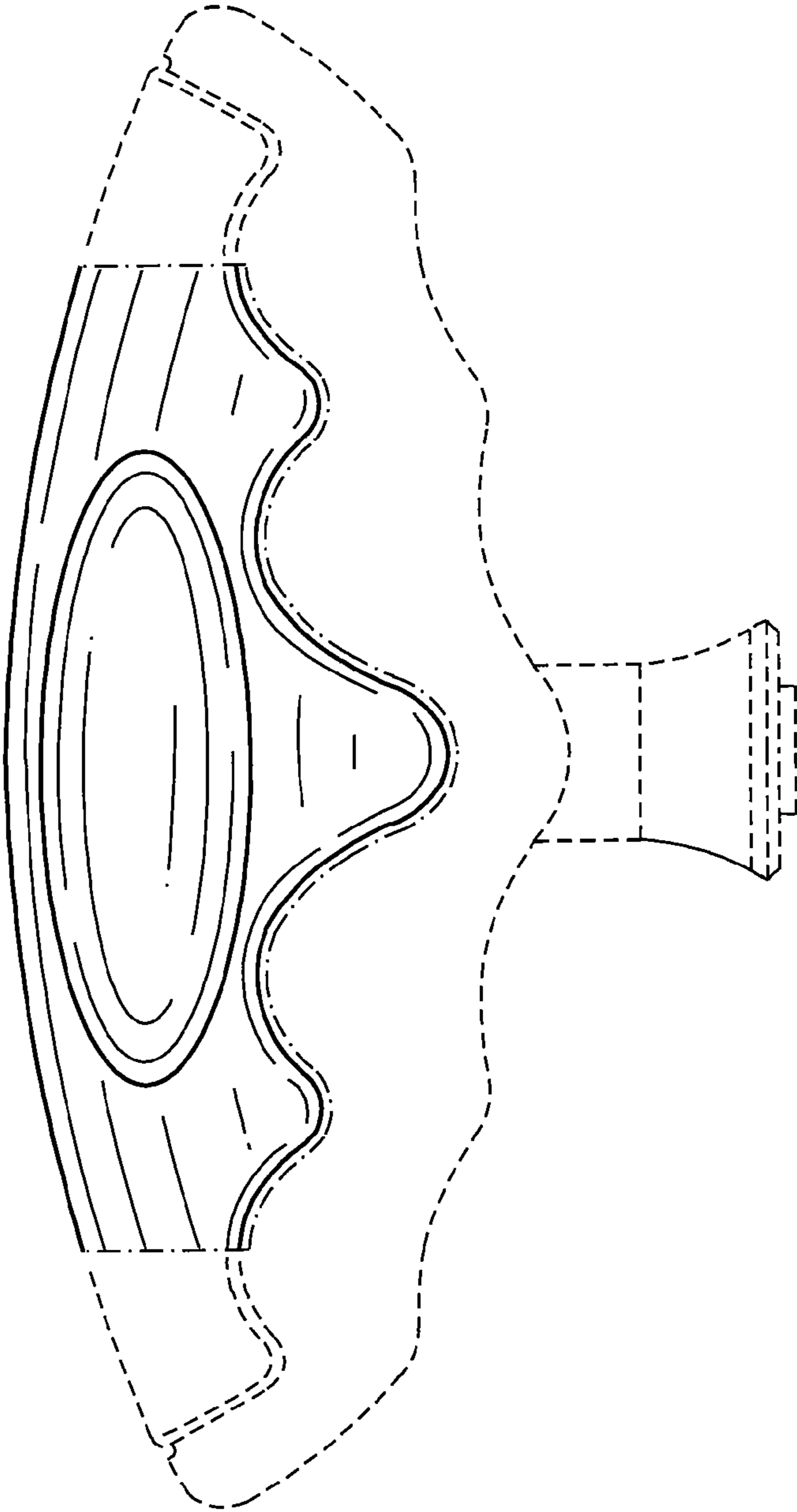

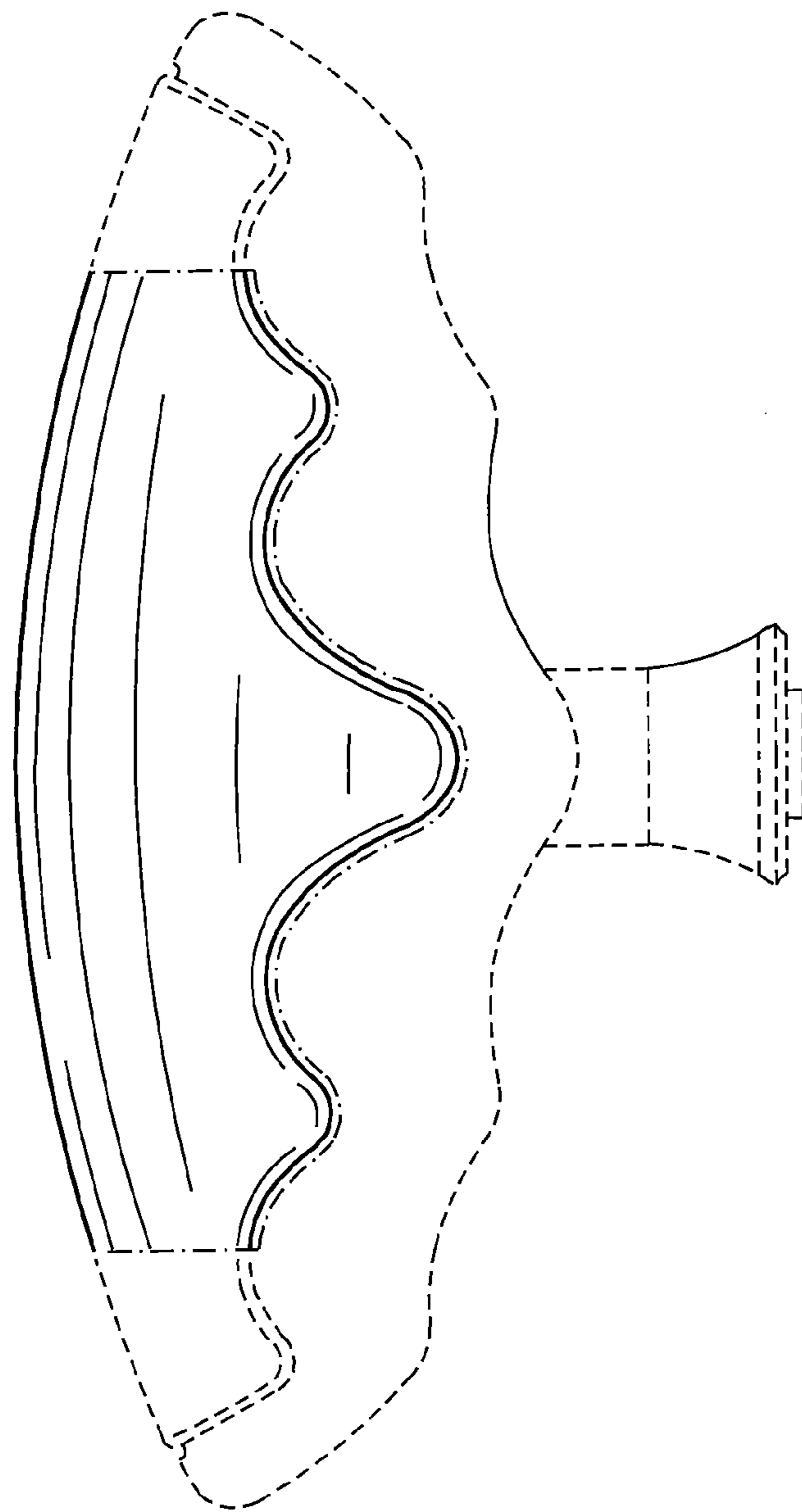

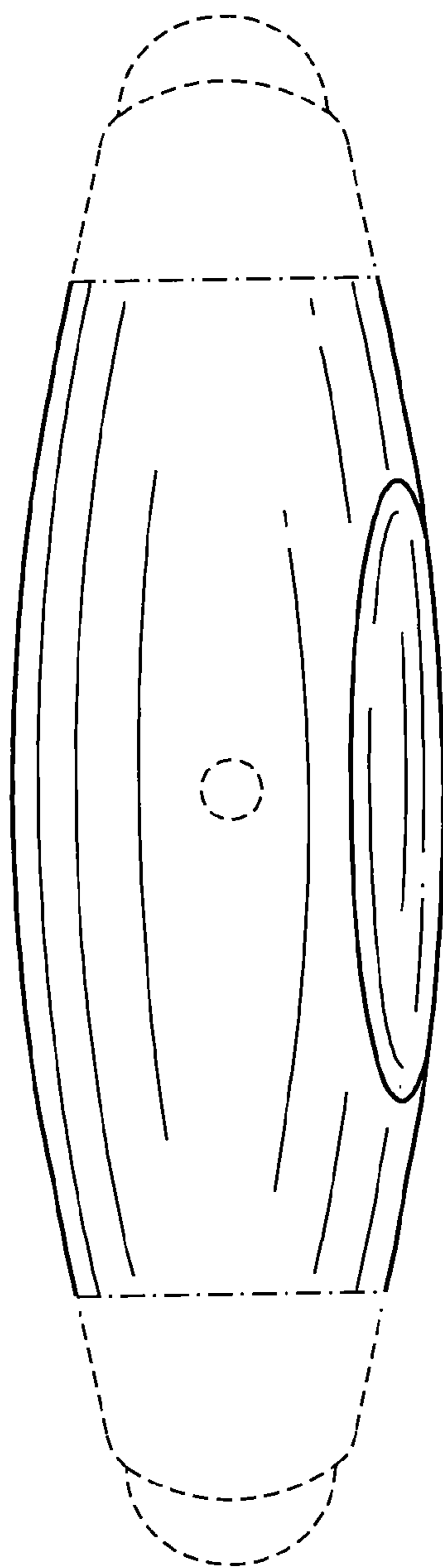

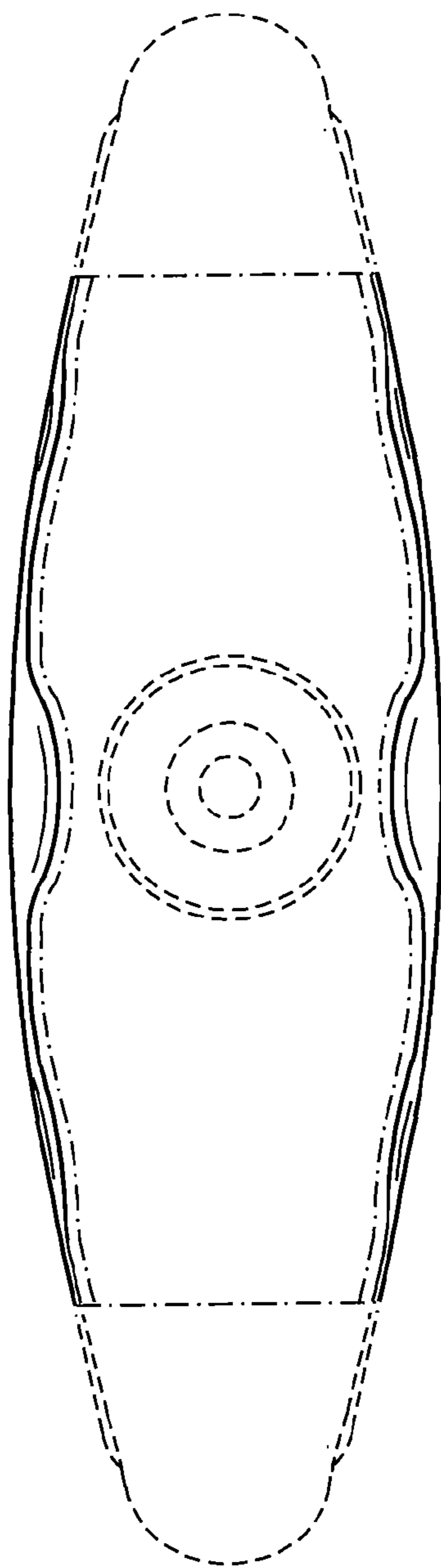

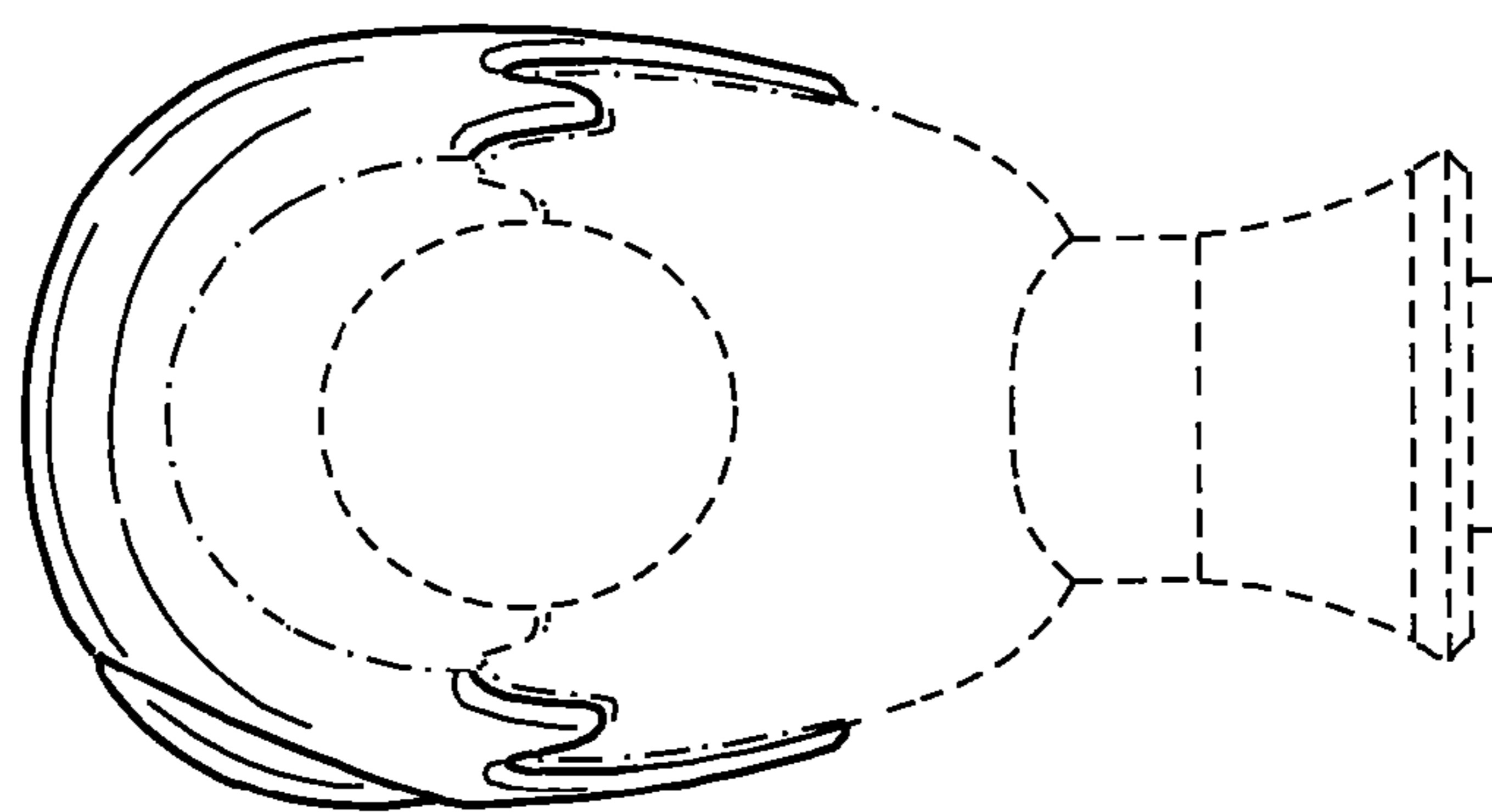
