FIG. 1 is a front view of a snack food showing my new design, the rear view being identical;

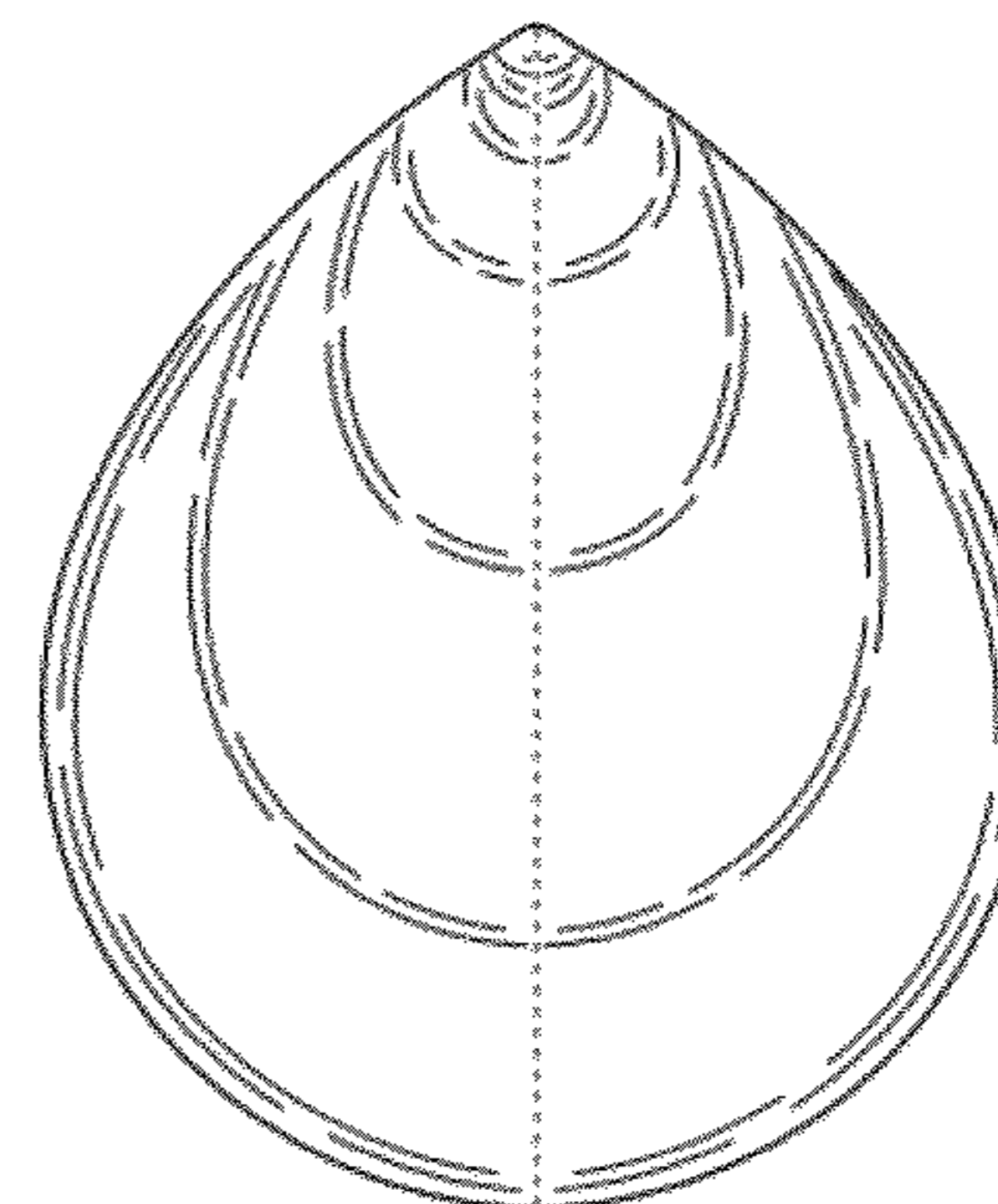
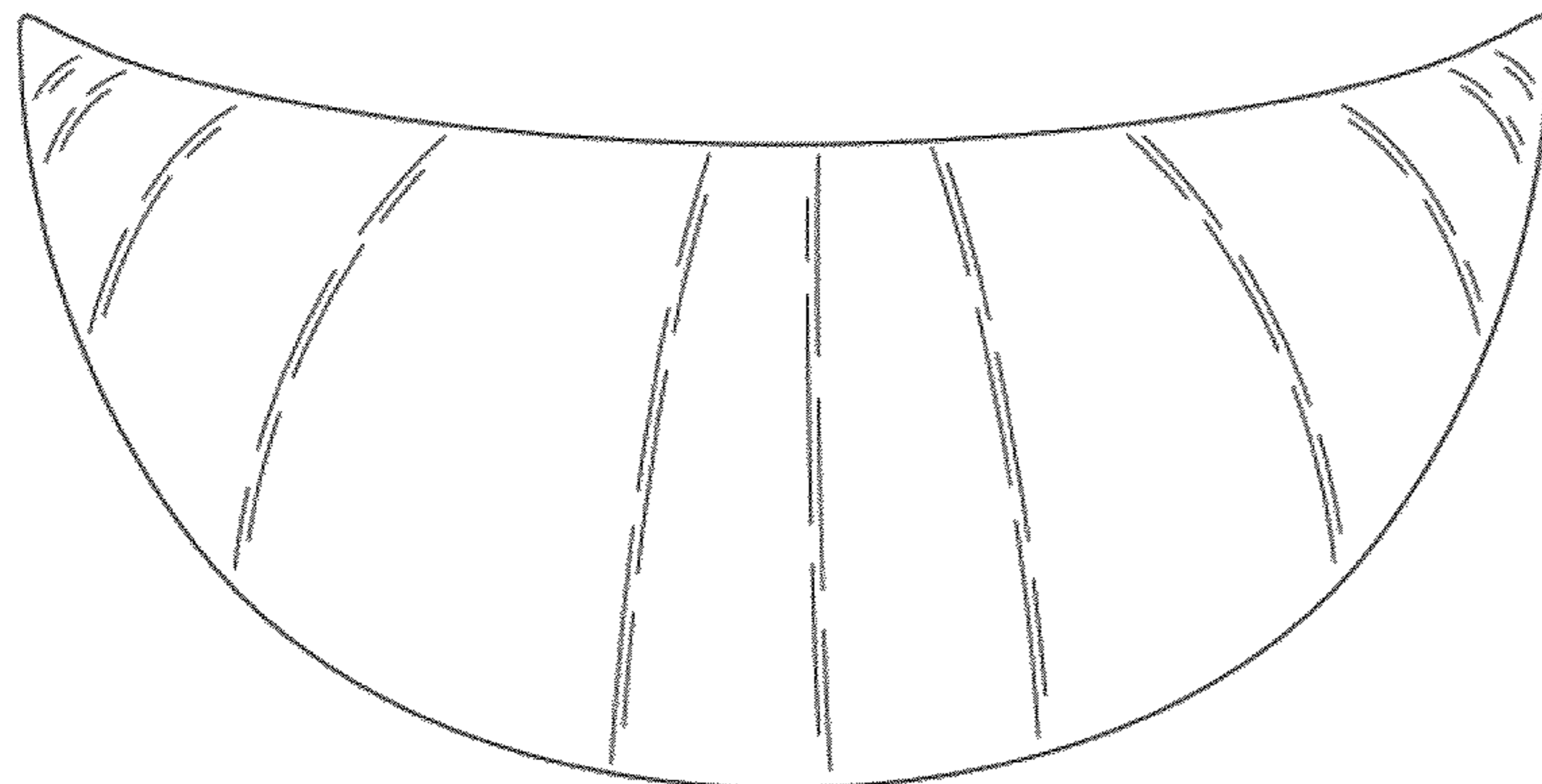
FIG. 2 is a right-side view thereof, the left-side view being identical;

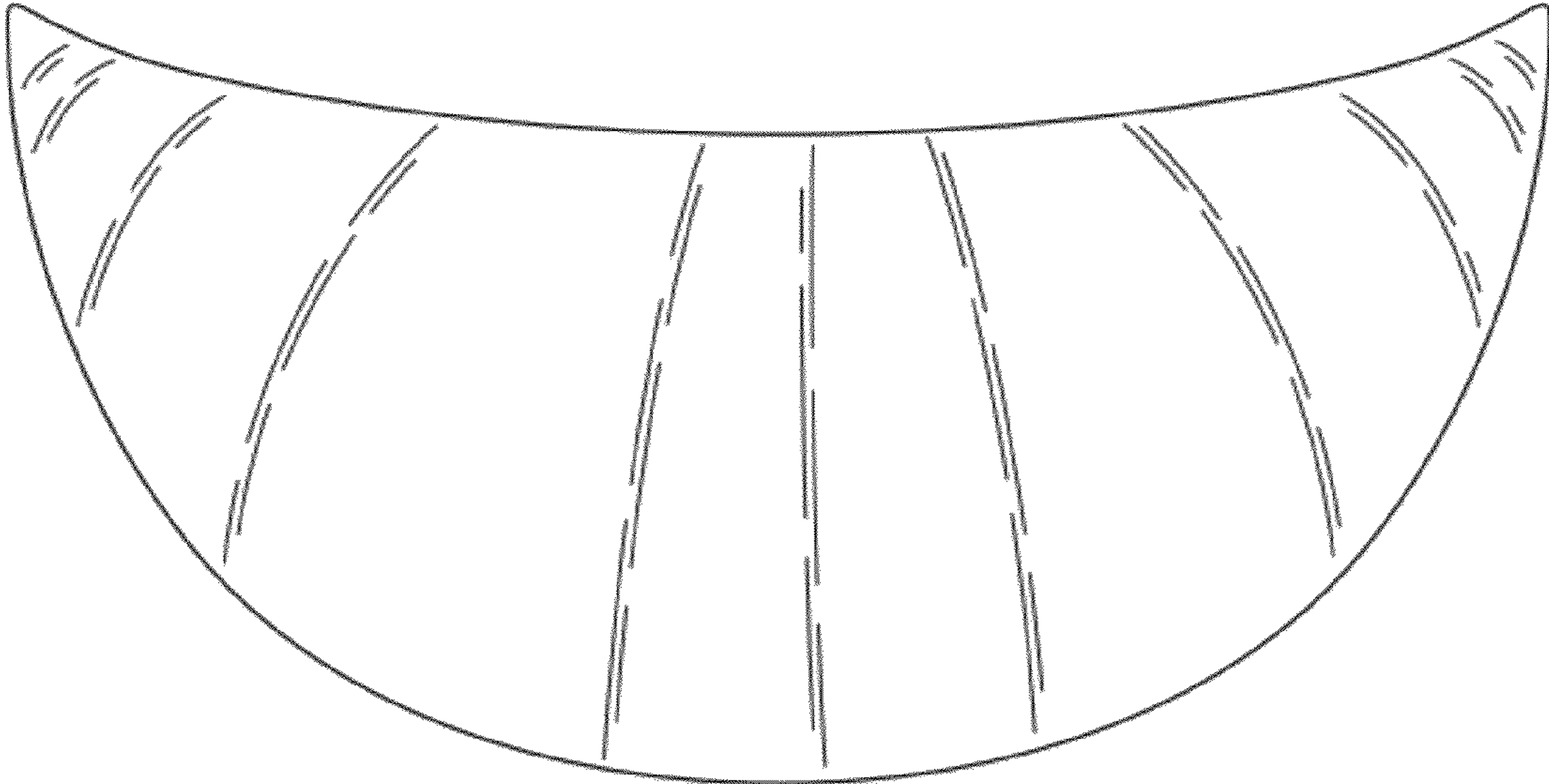

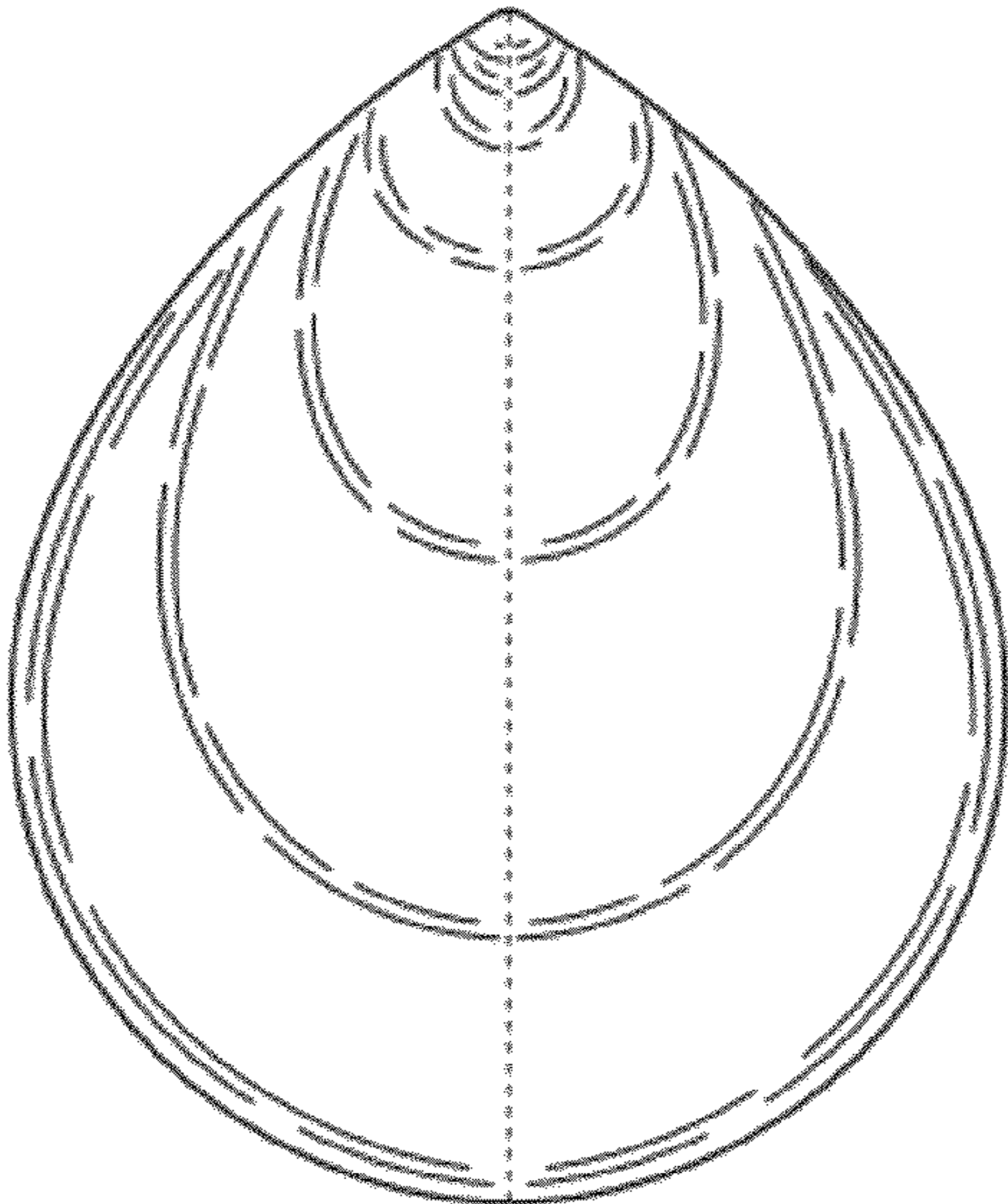

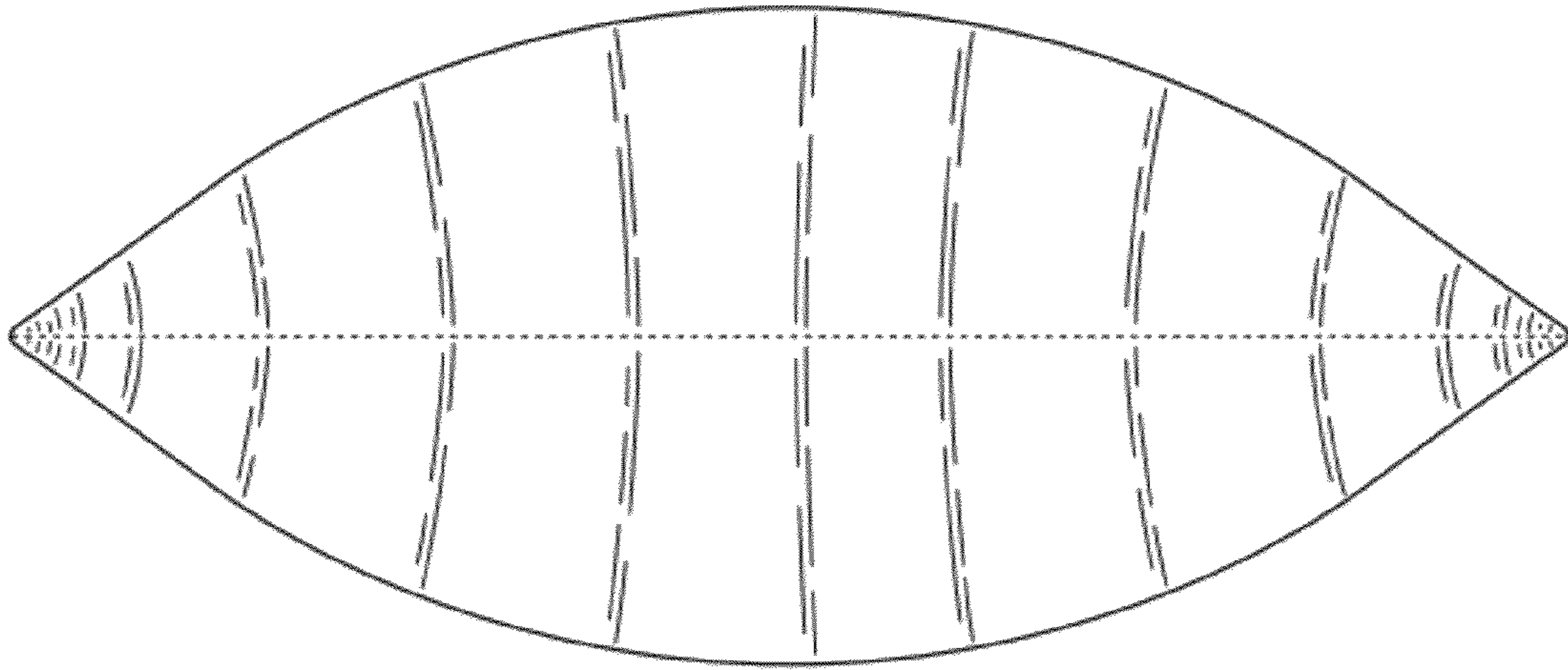

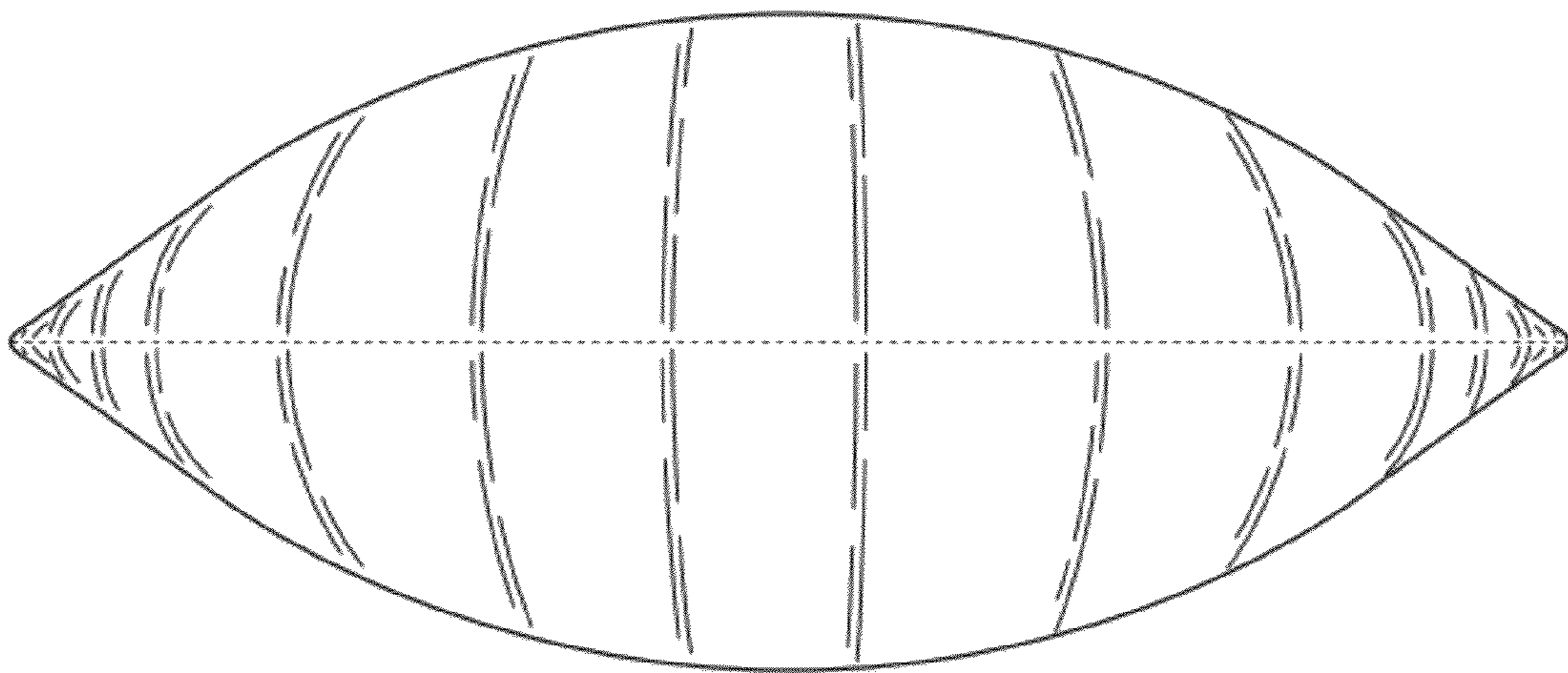
