(57) **CLAIM**

I claim the ornamental design for a pair of shorts, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pair of shorts, showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a cross-sectional view thereof, taken generally along lines 7-7 of FIG. 5.  
The broken lines showing a person in FIG. 1 depict environmental matter and form no part of the claimed design.

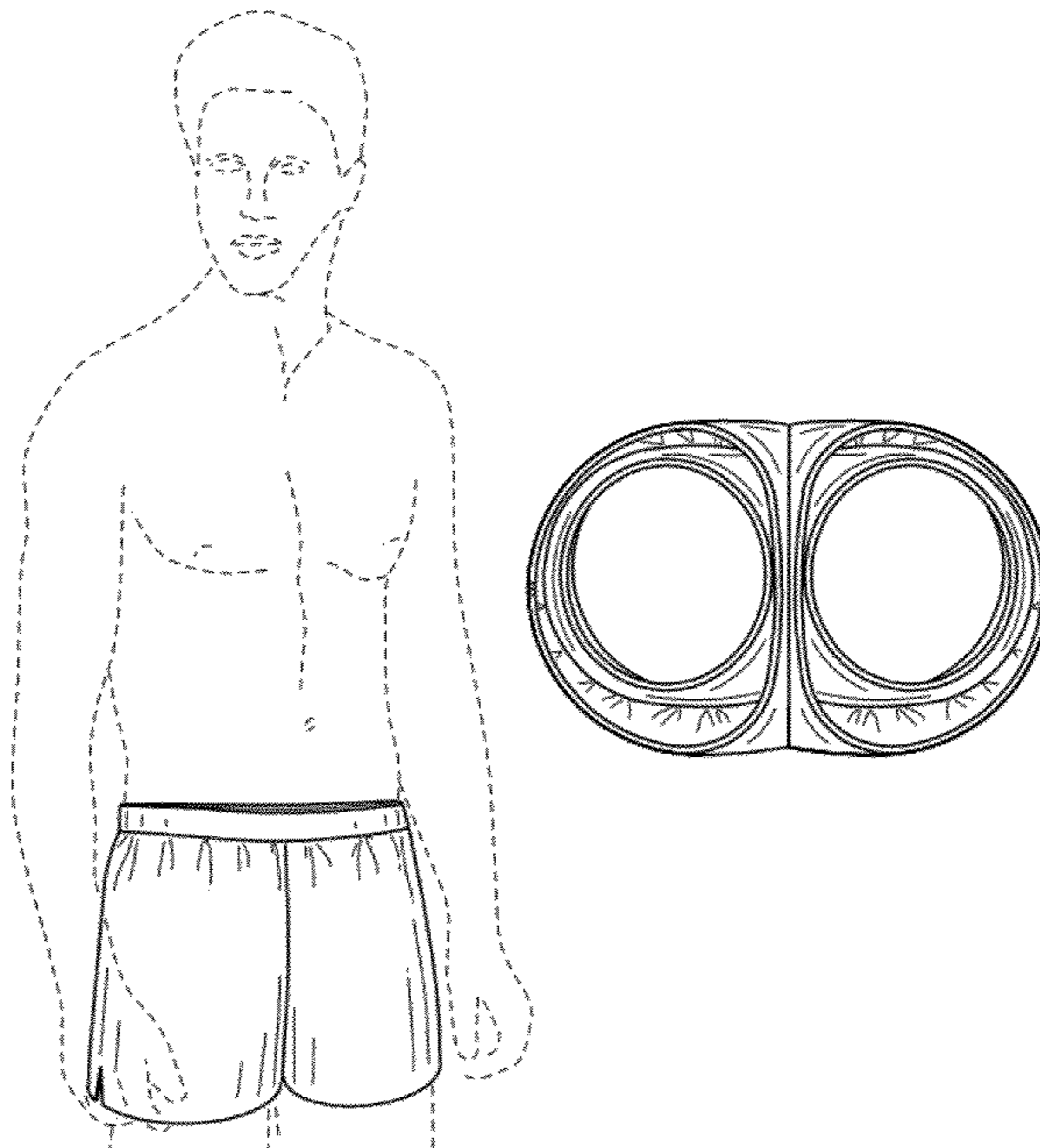

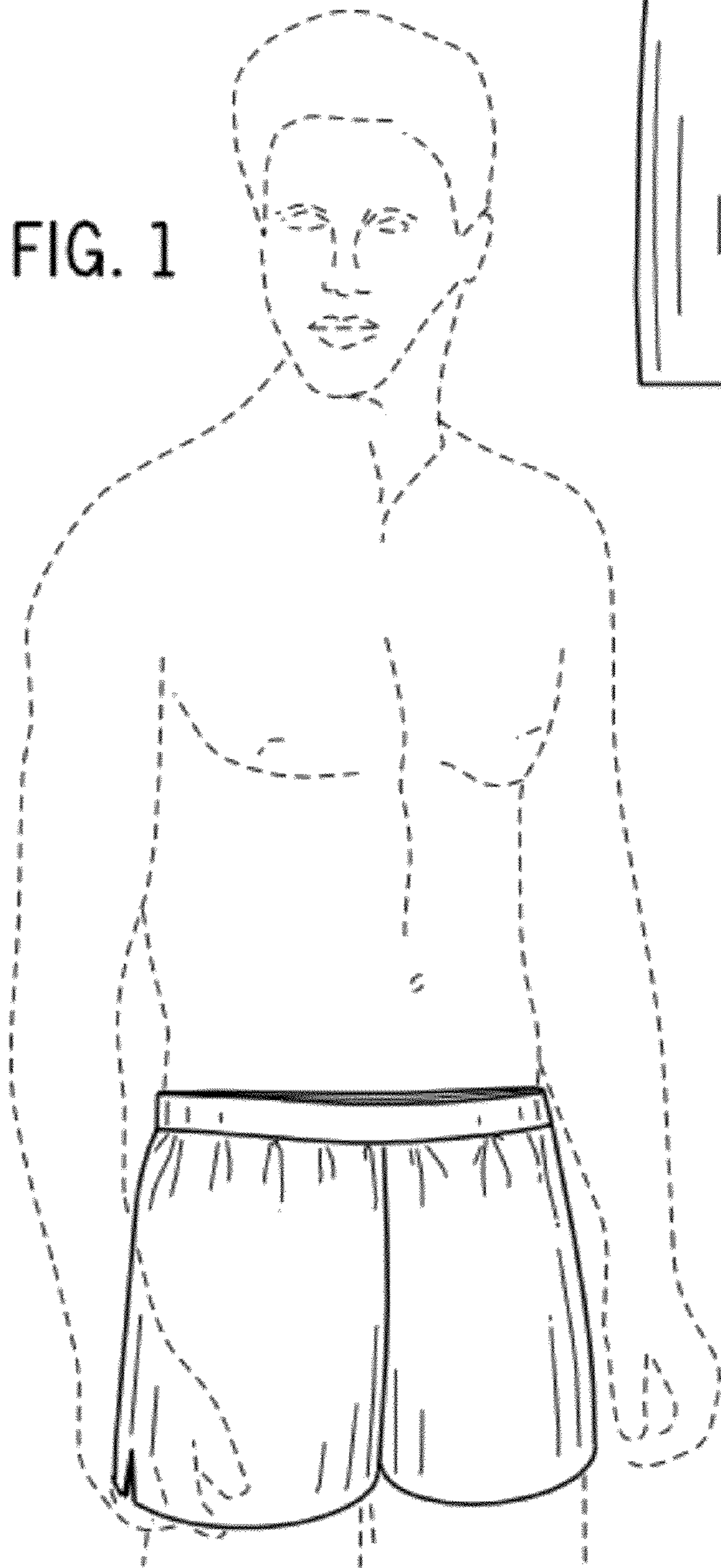

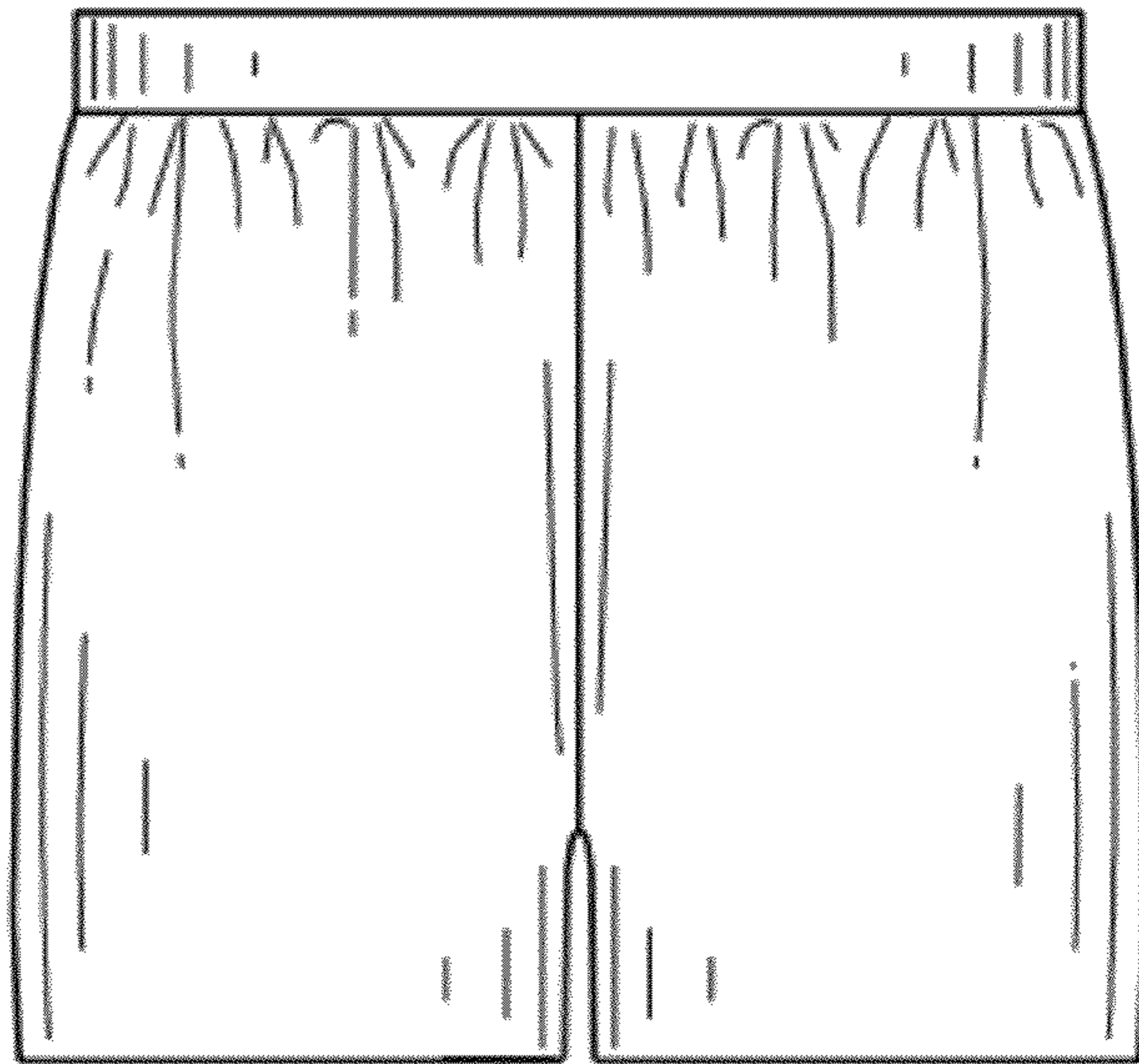

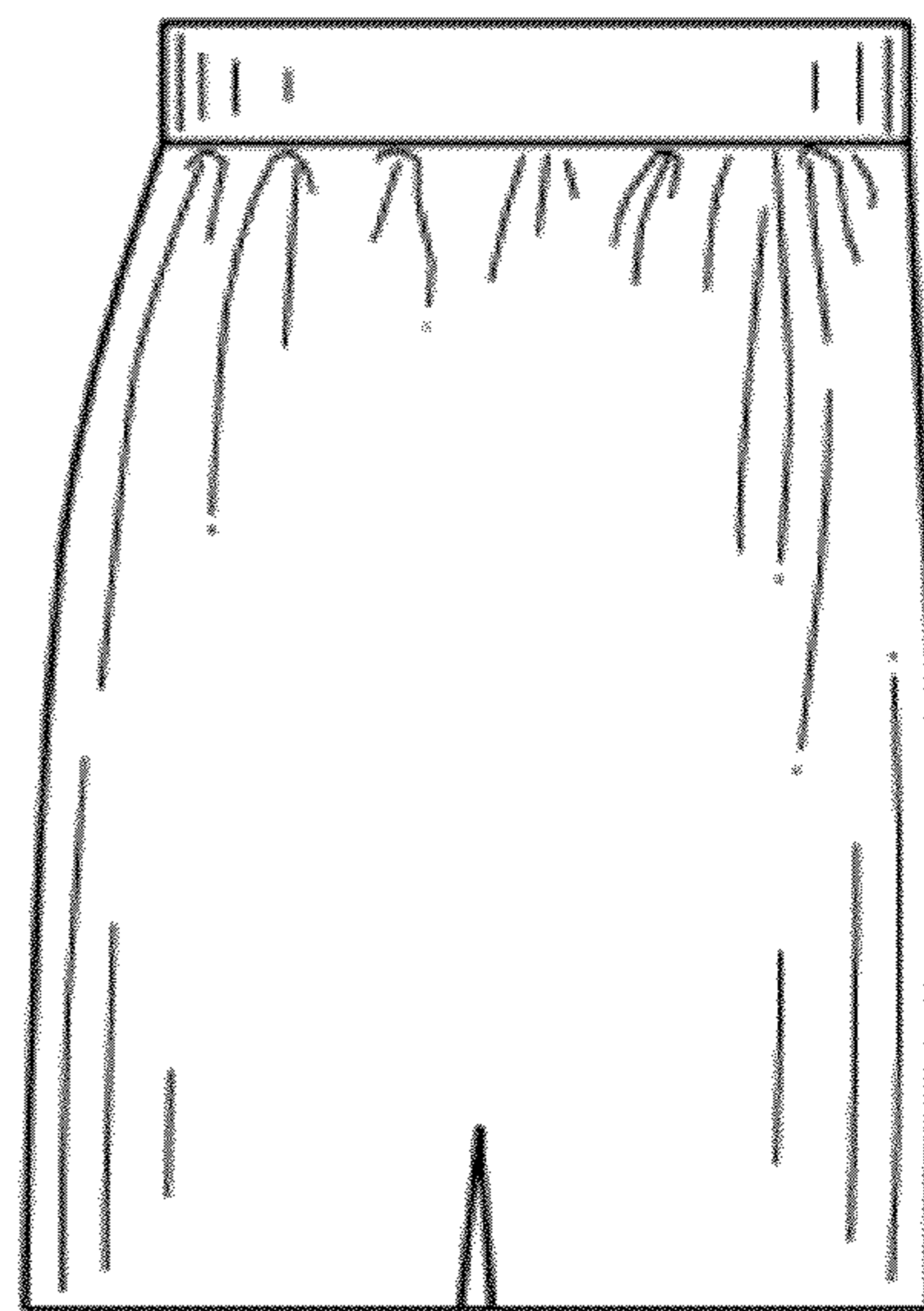

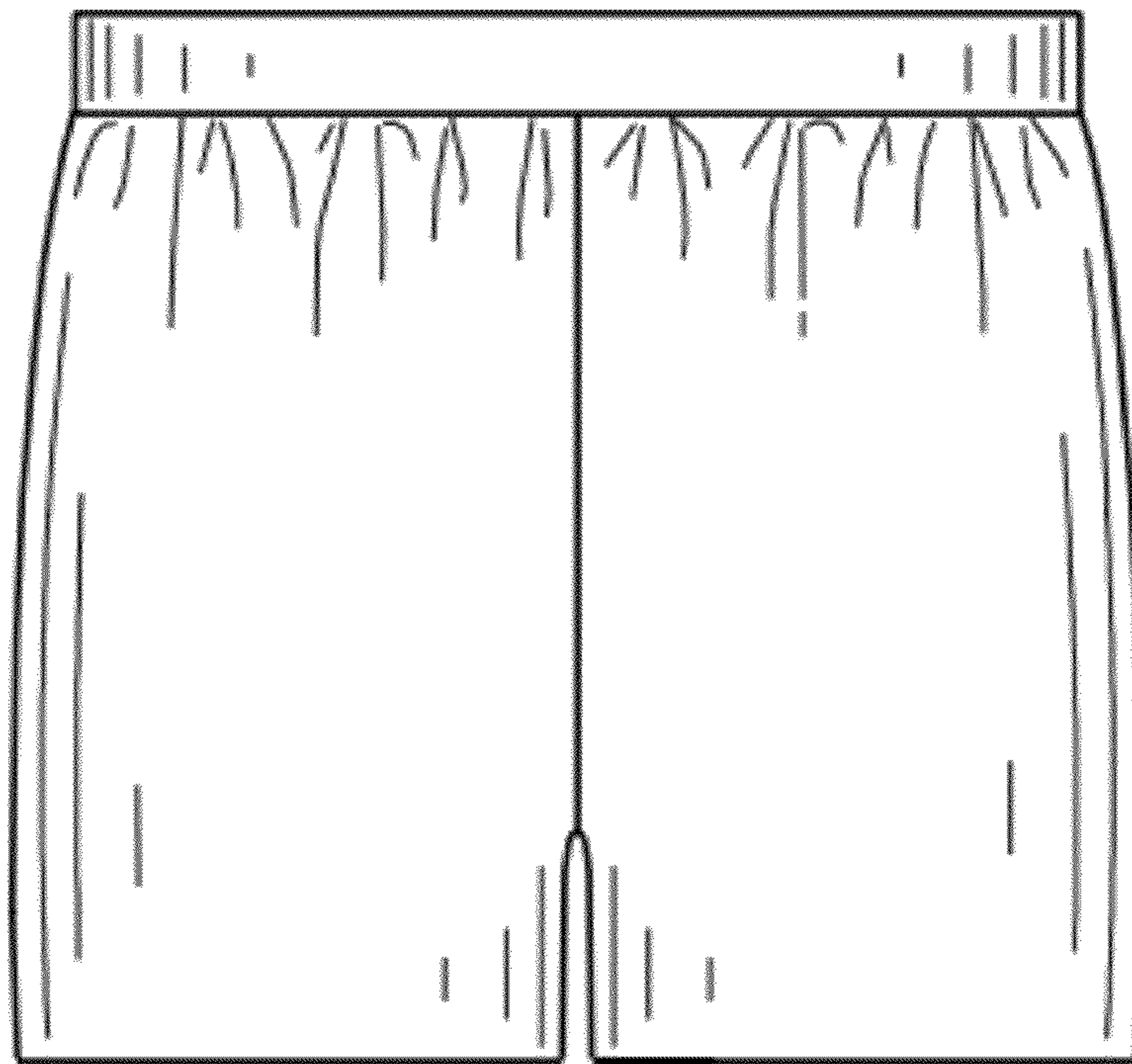

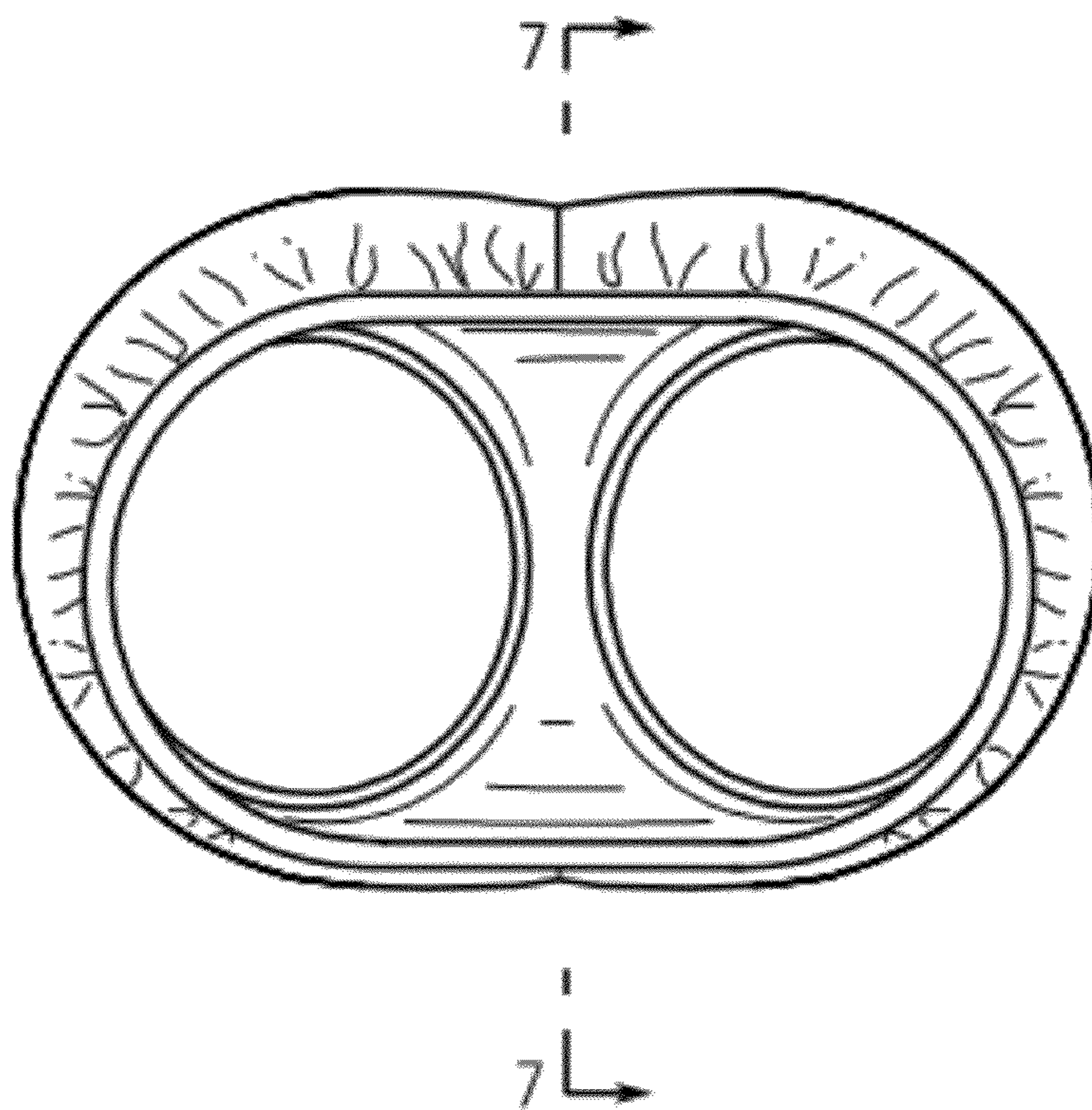

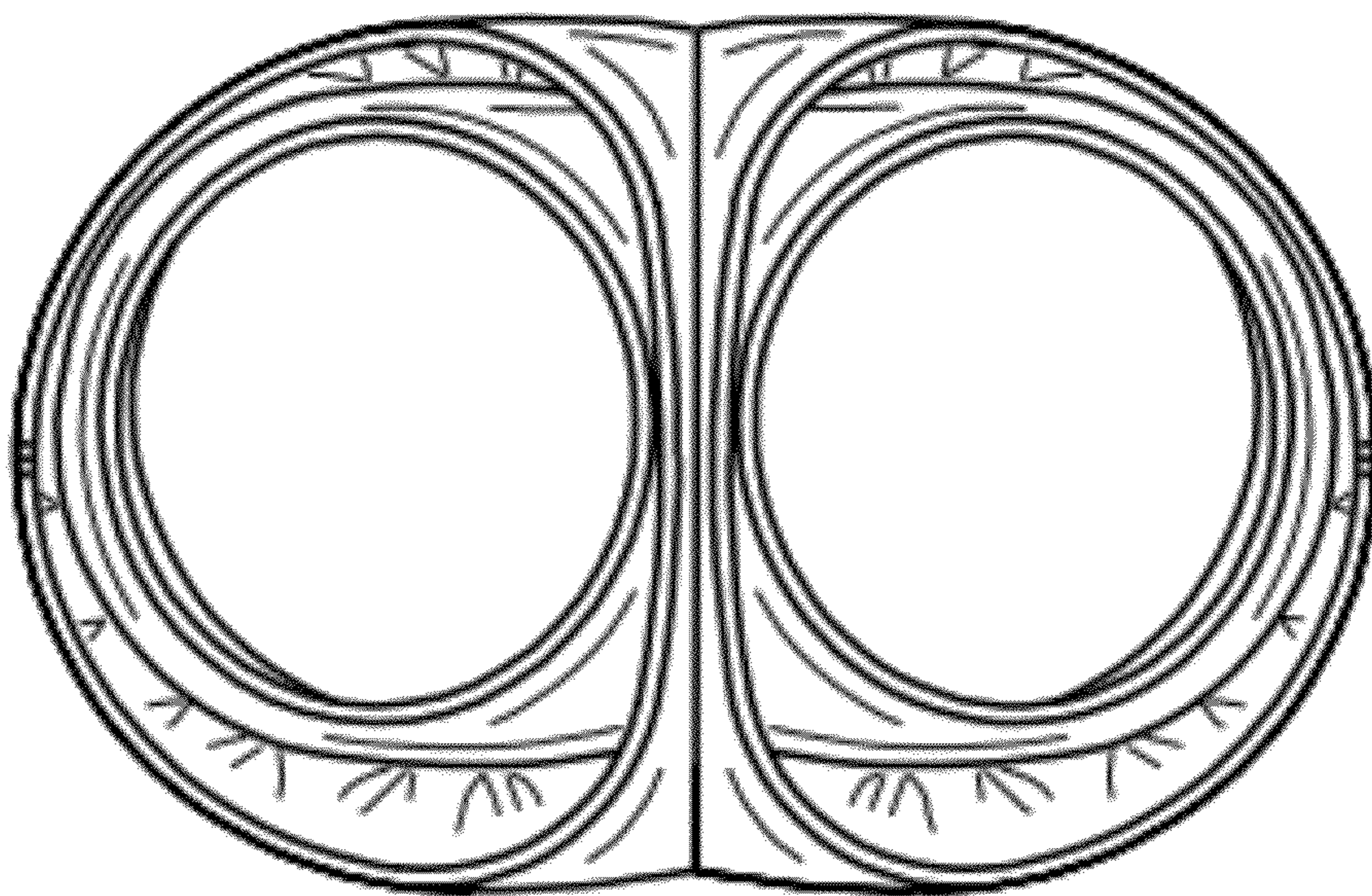
