FIG. 3 is a rear view of the same;

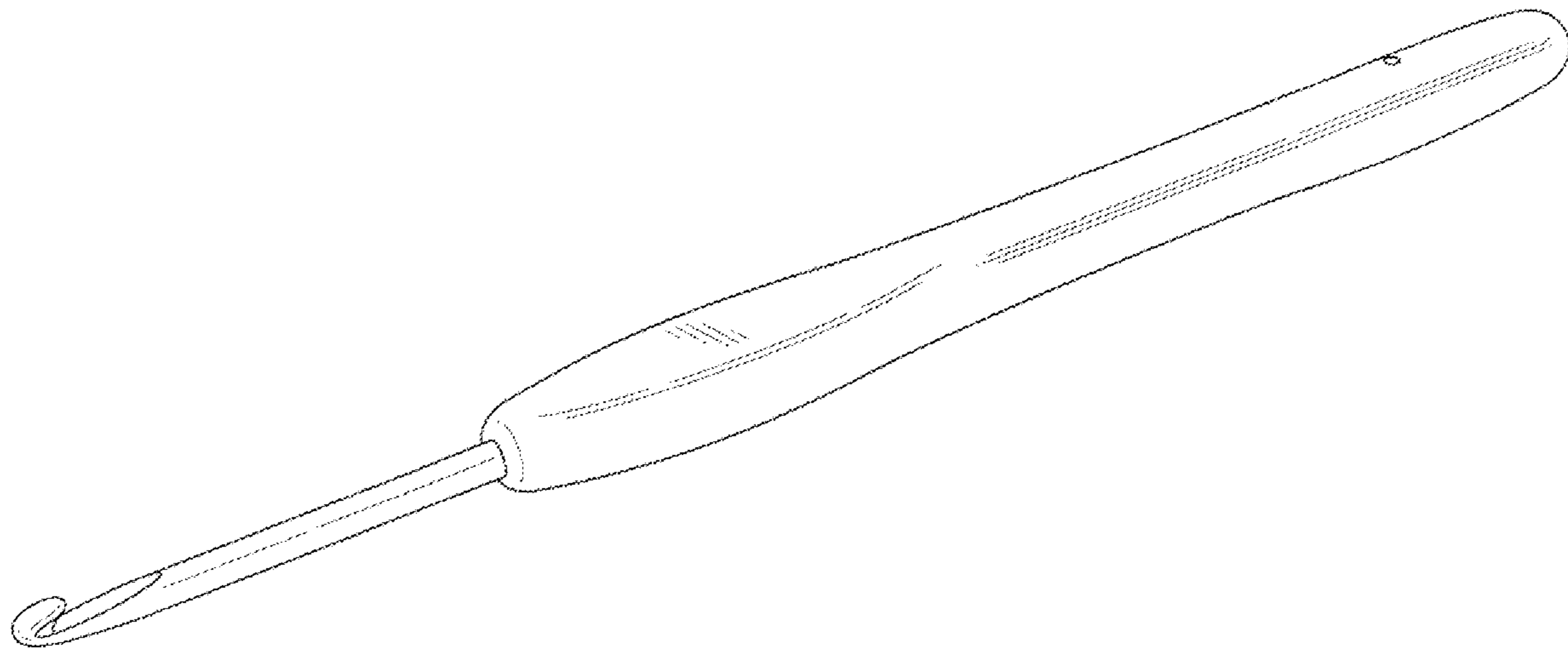
FIG. 4 is a top plan view of the same;

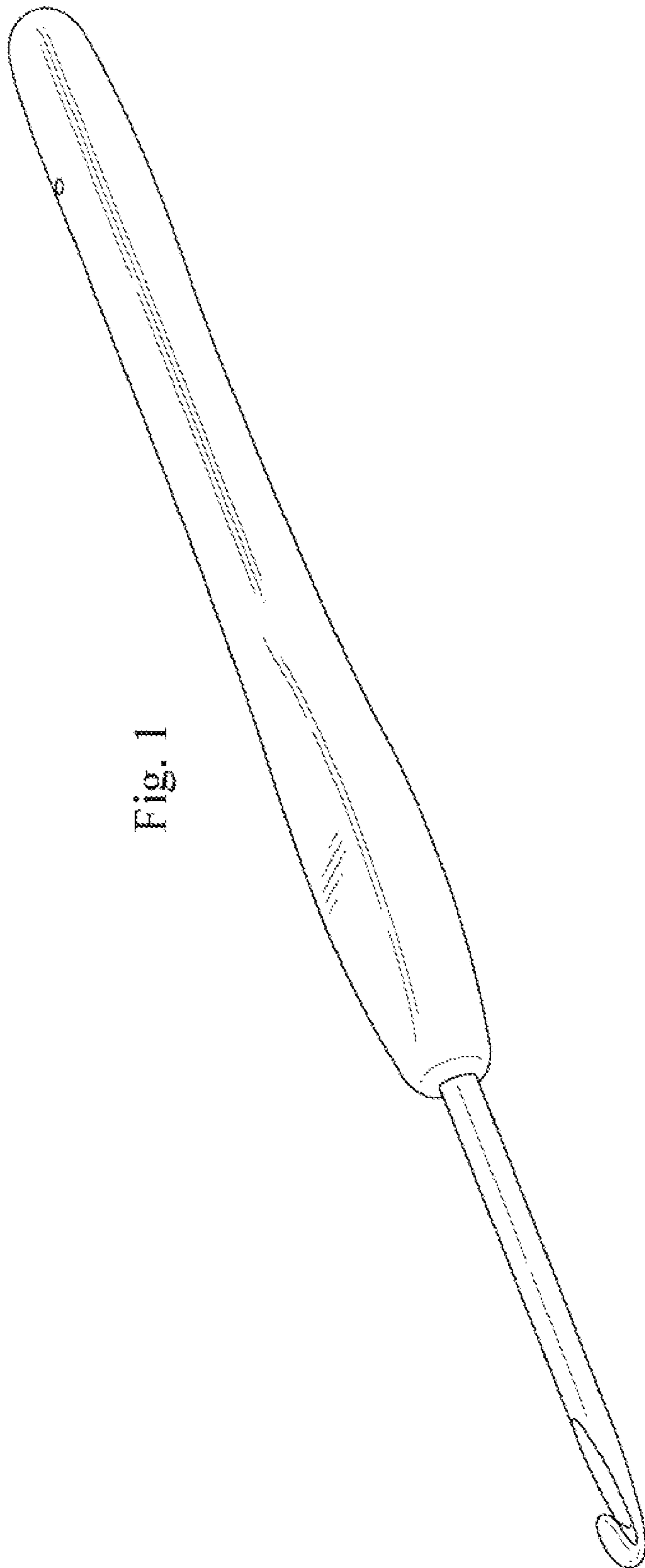

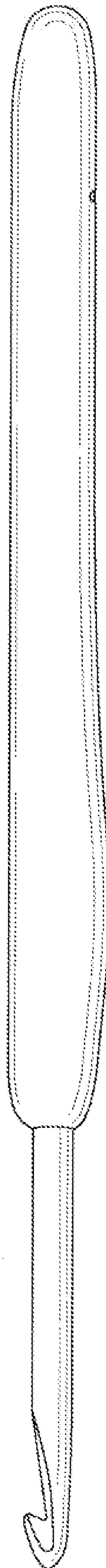

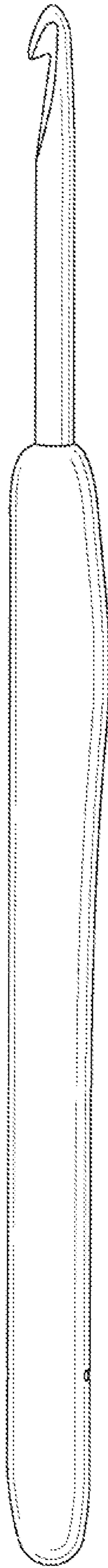

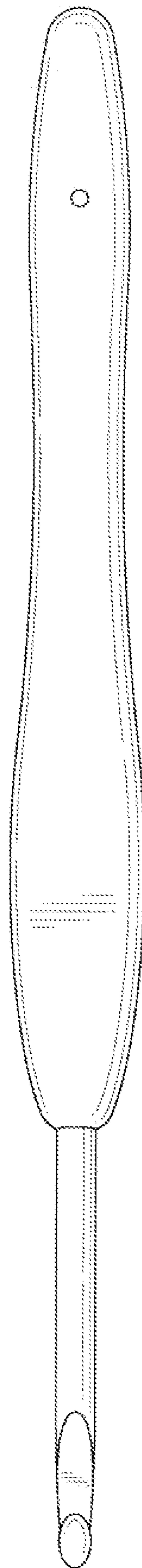

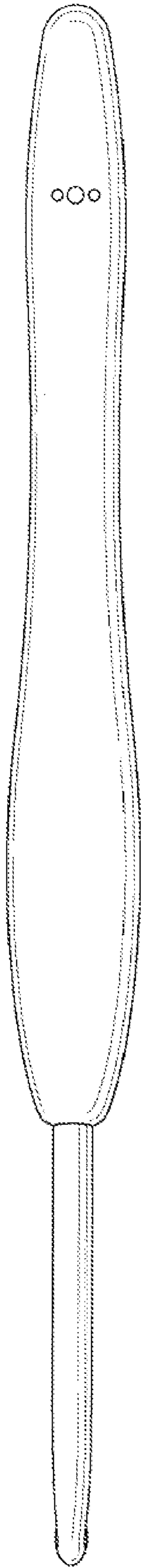

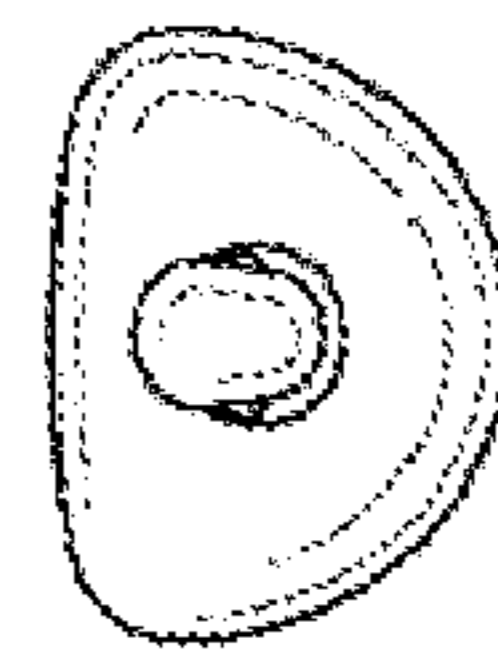
