(57) **CLAIM**

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a chair with a one-piece seat shell supported by four single legs;
FIG. 2 shows a front elevational view of FIG. 1;
FIG. 3 shows a right side view of FIG. 1, the left side being a mirror image thereof;
FIG. 4 shows a rear elevational view of FIG. 1;
FIG. 5 shows a top plan view of FIG. 1; and,
FIG. 6 shows a bottom plan view of FIG. 1.
