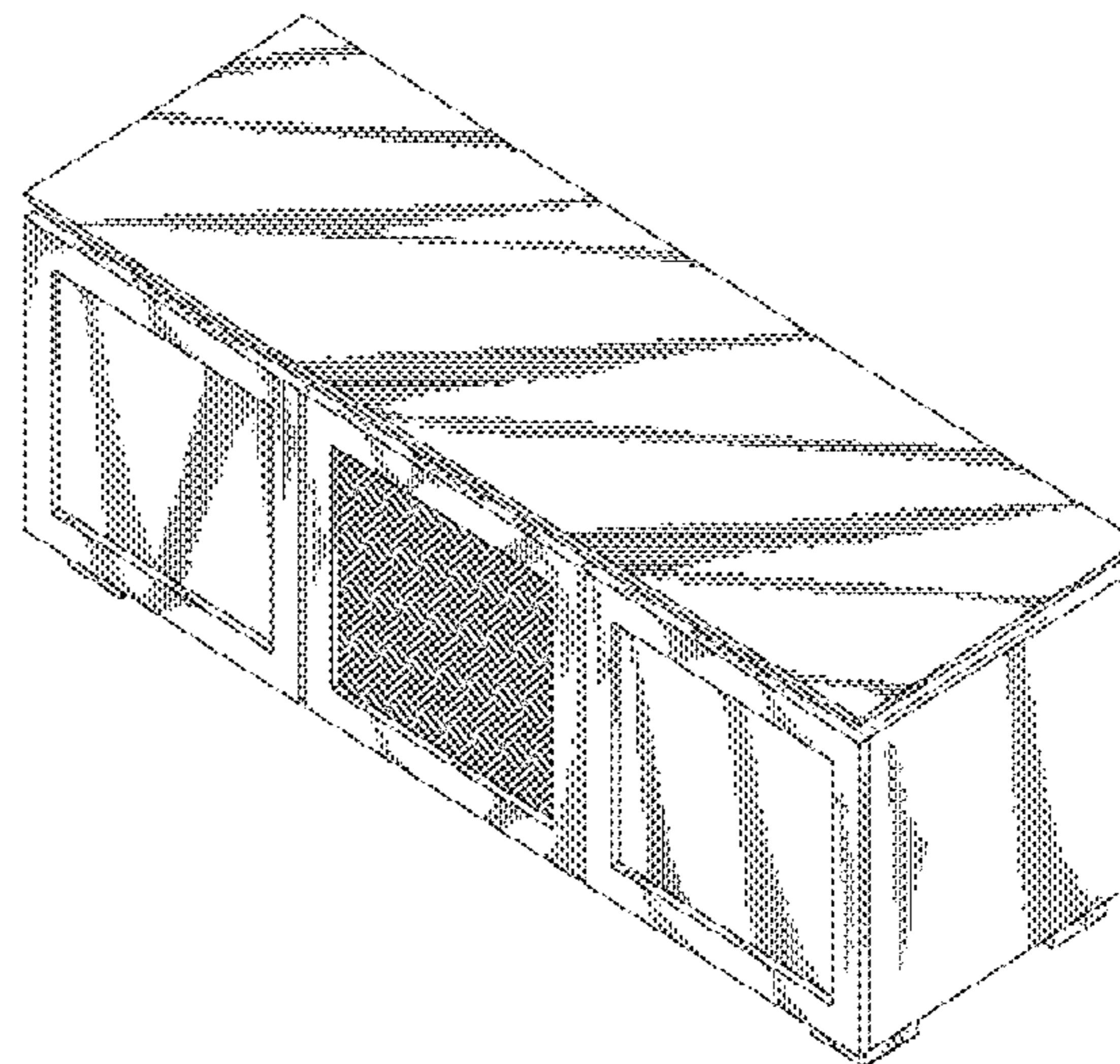
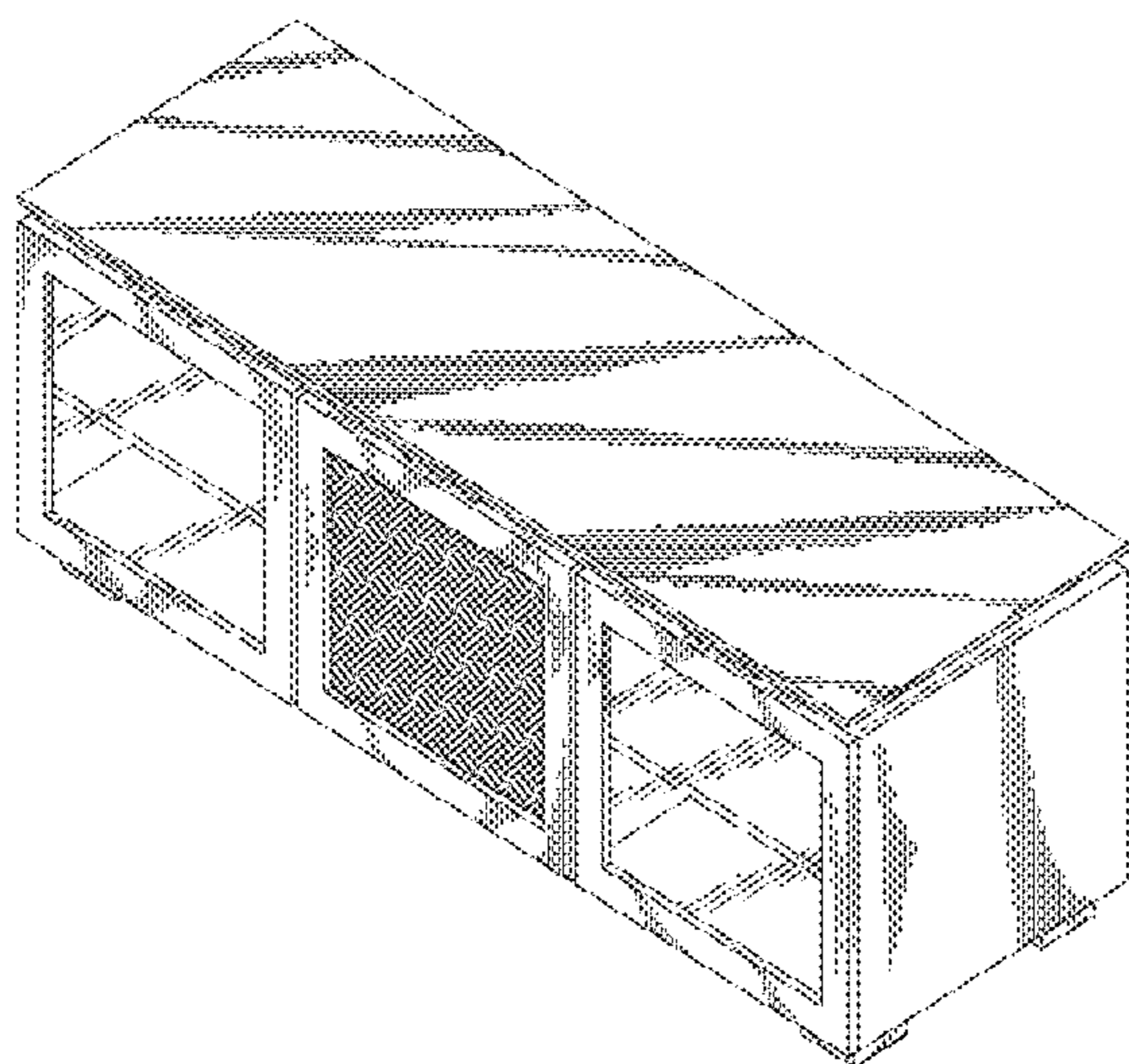
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the subject audio video shelving unit;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;

FIG. 5 is a right side view thereof (the left side view is a mirror image of the right side view); and,

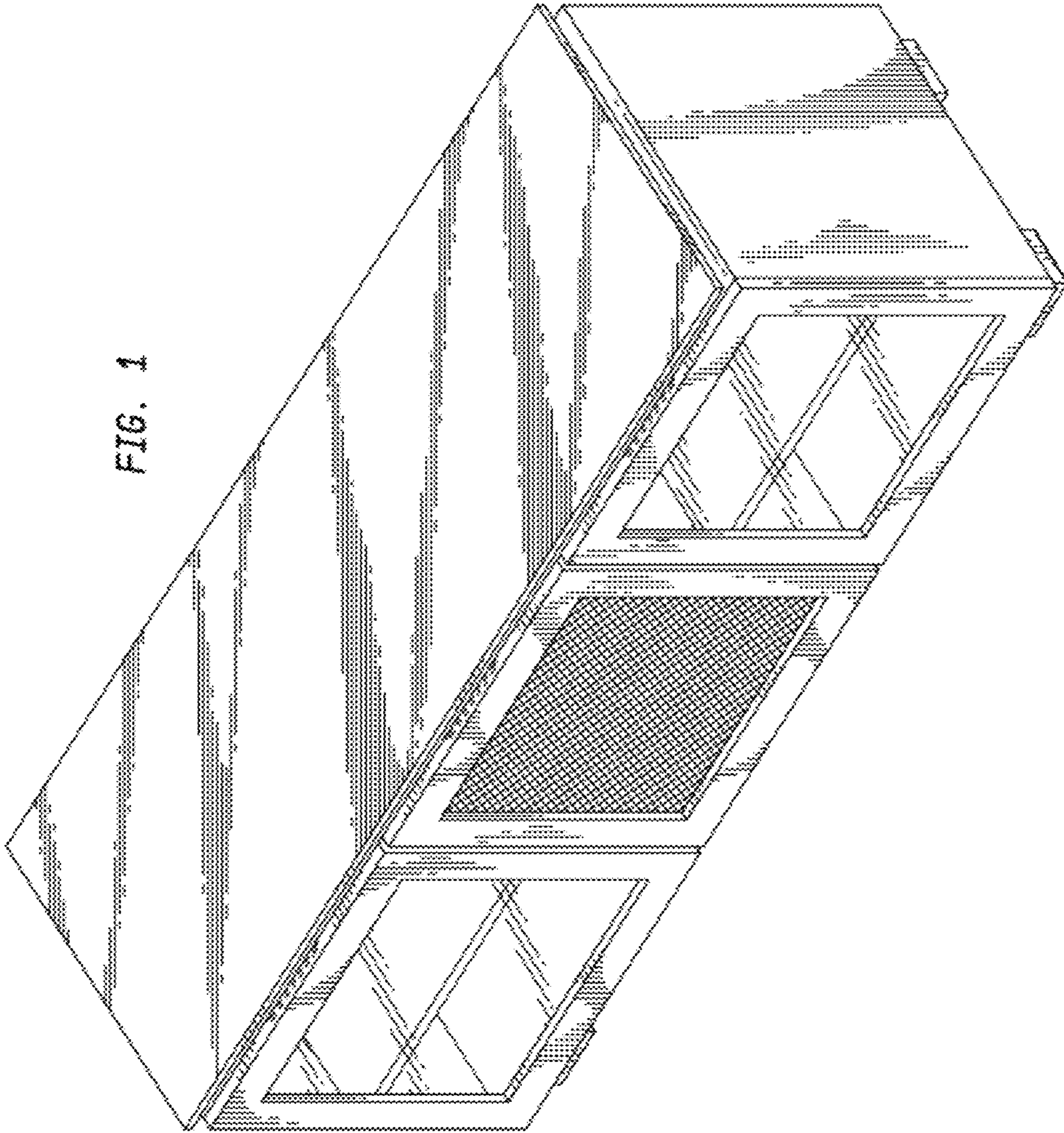

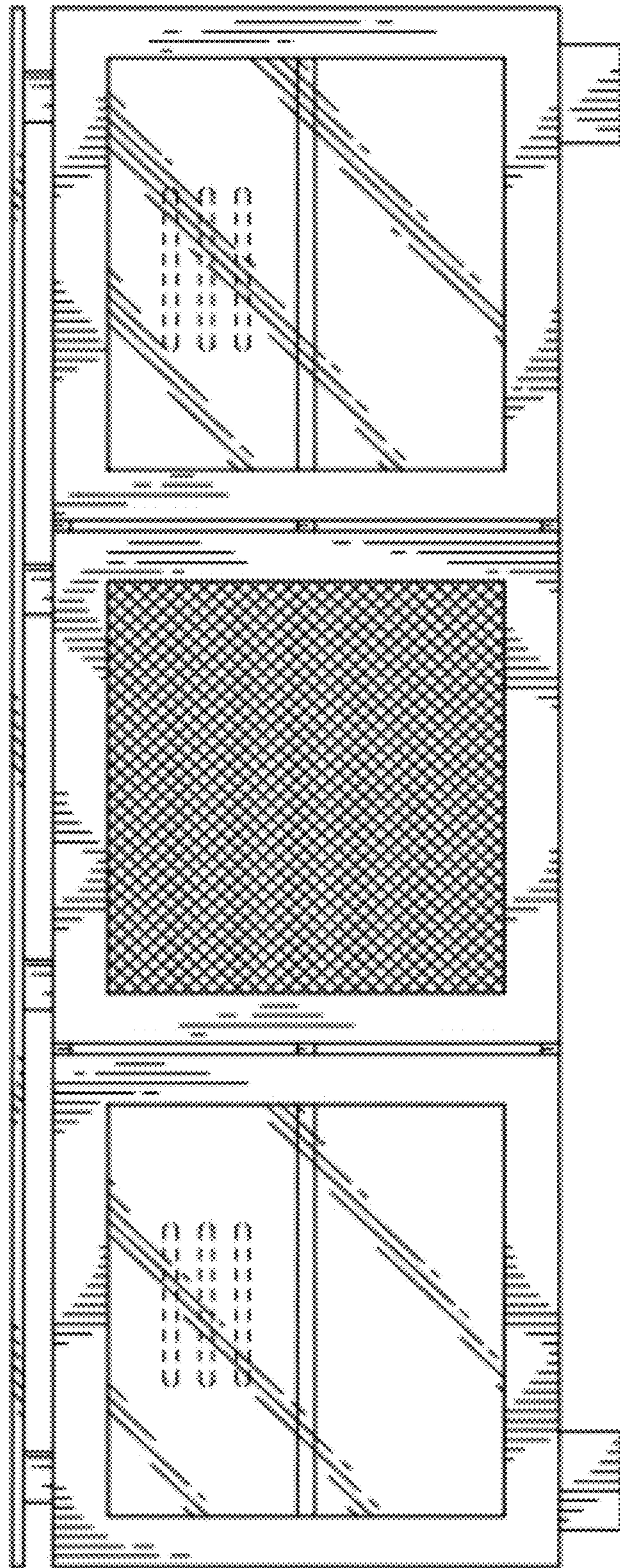

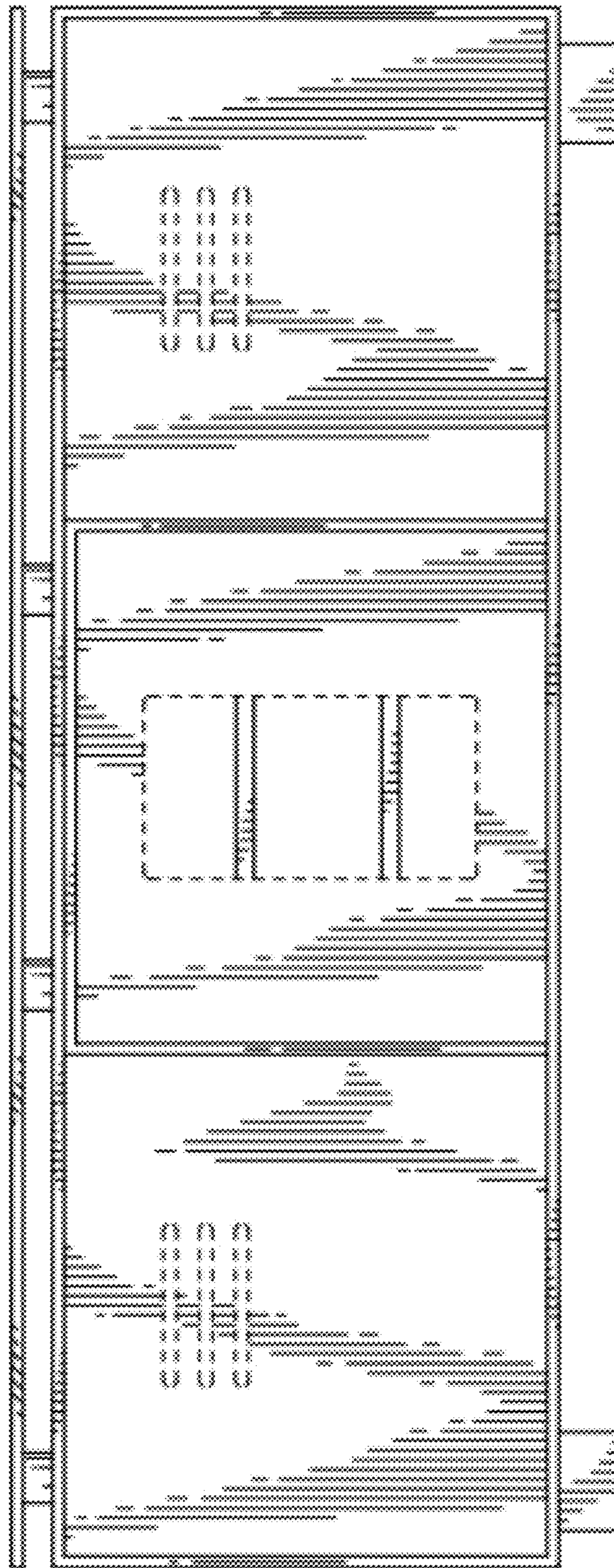

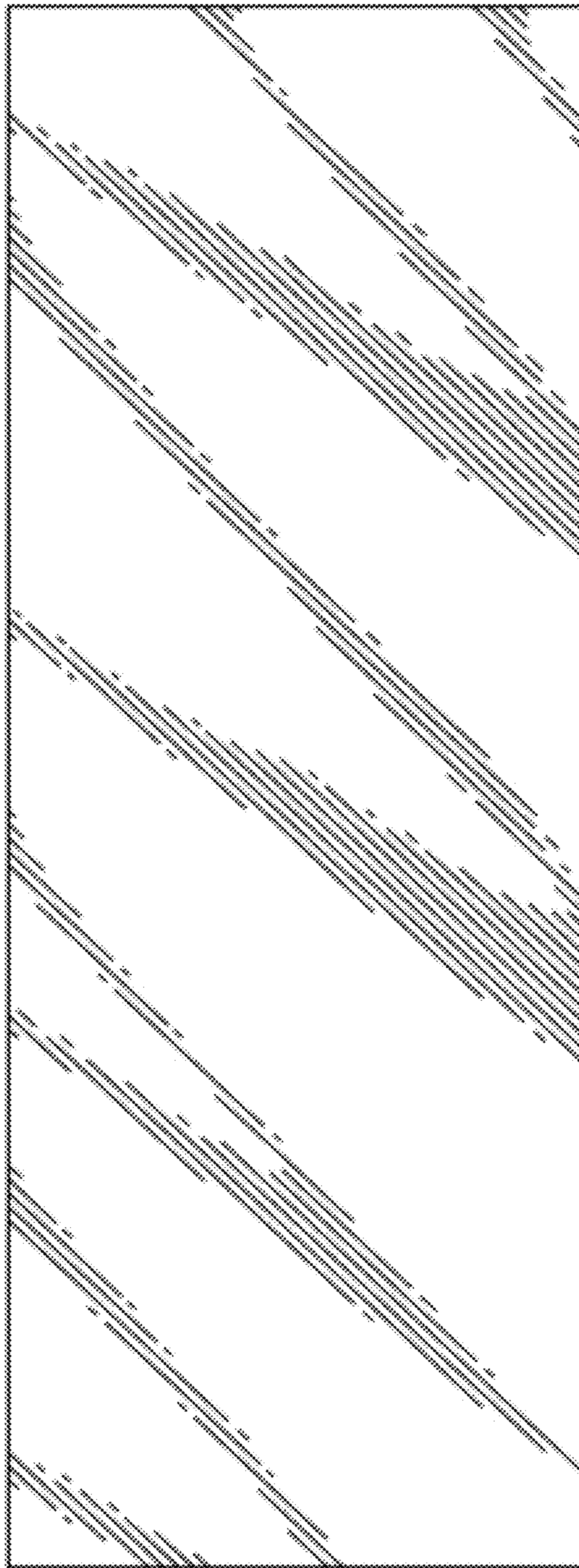

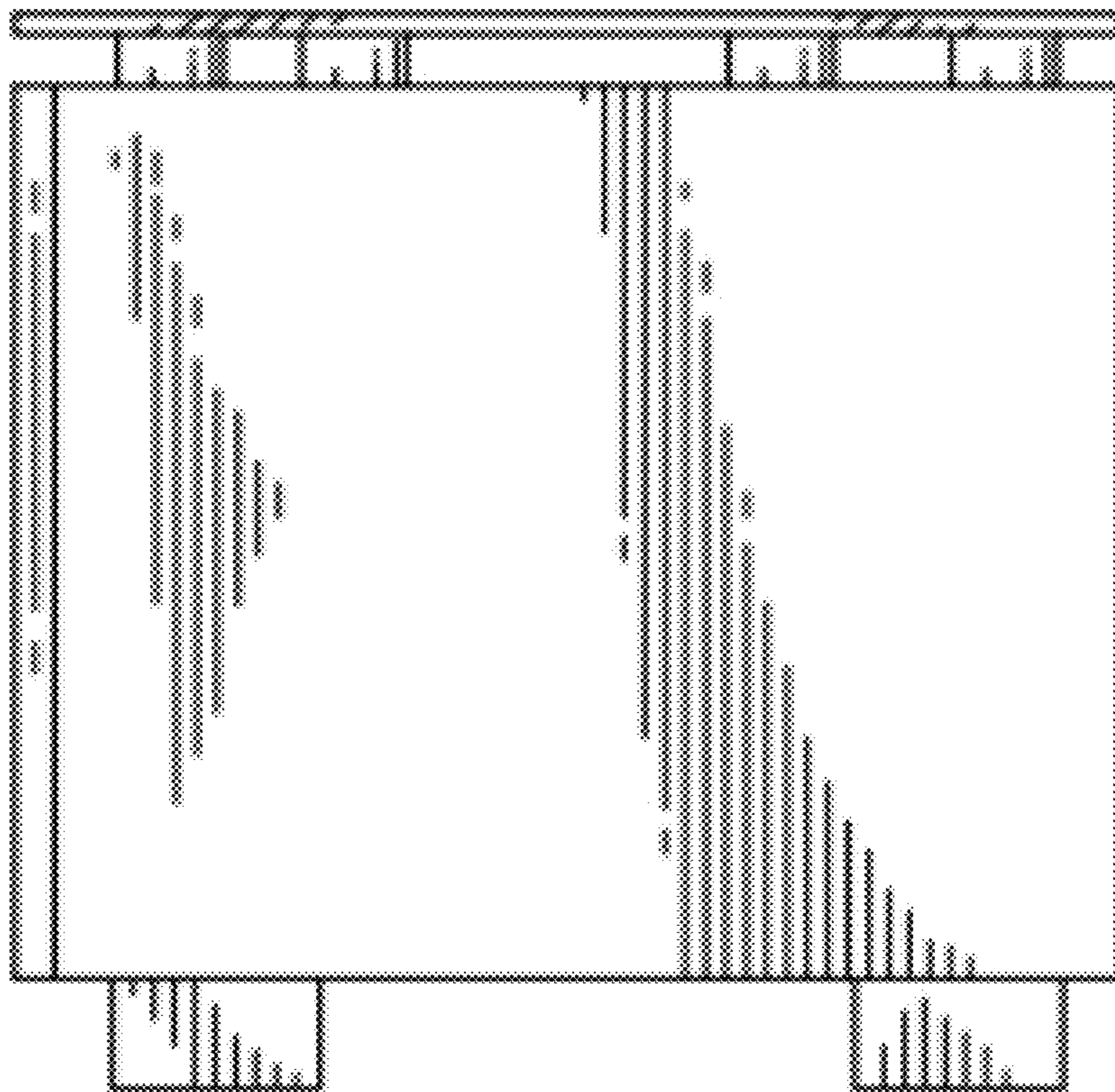
