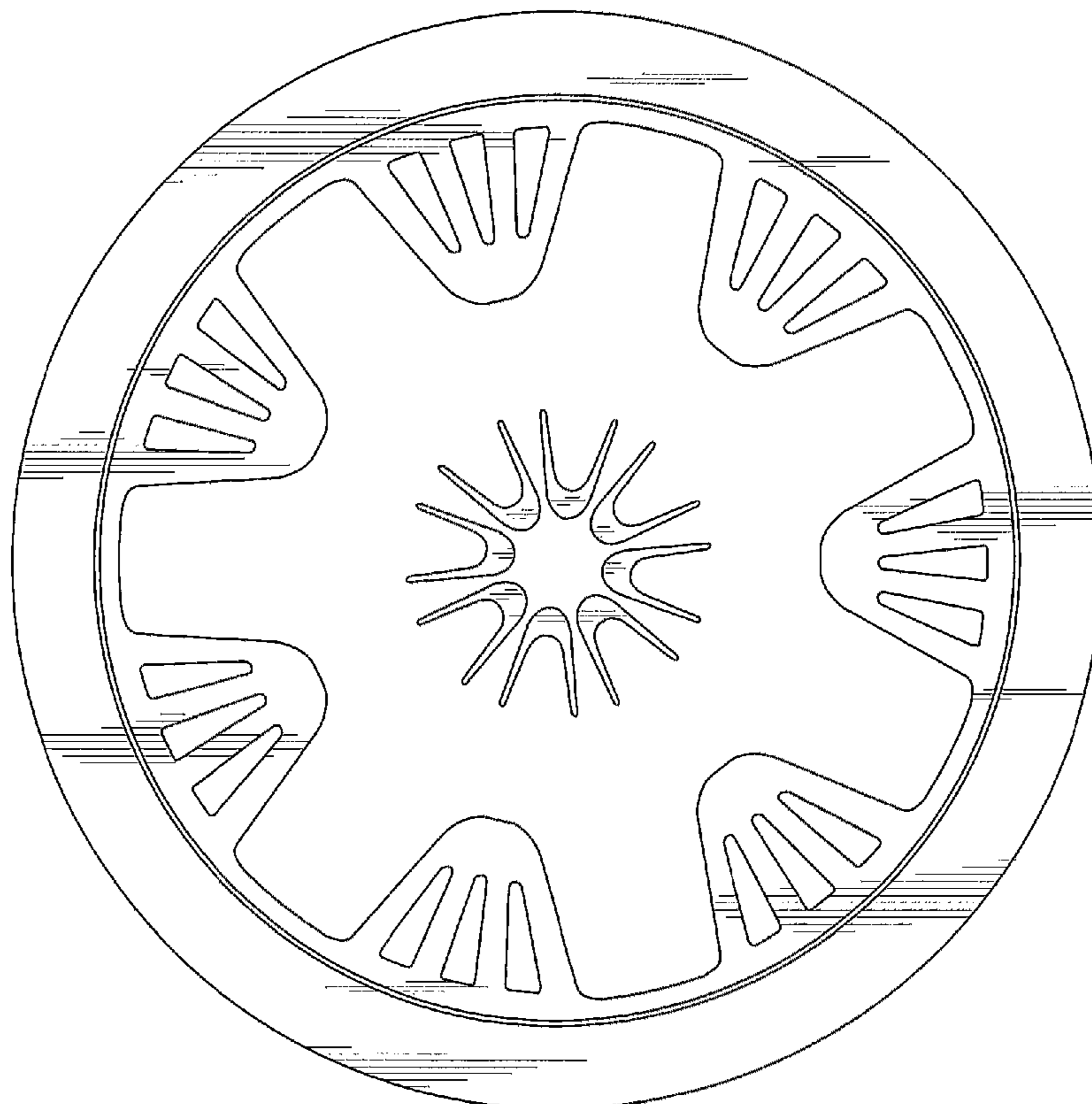

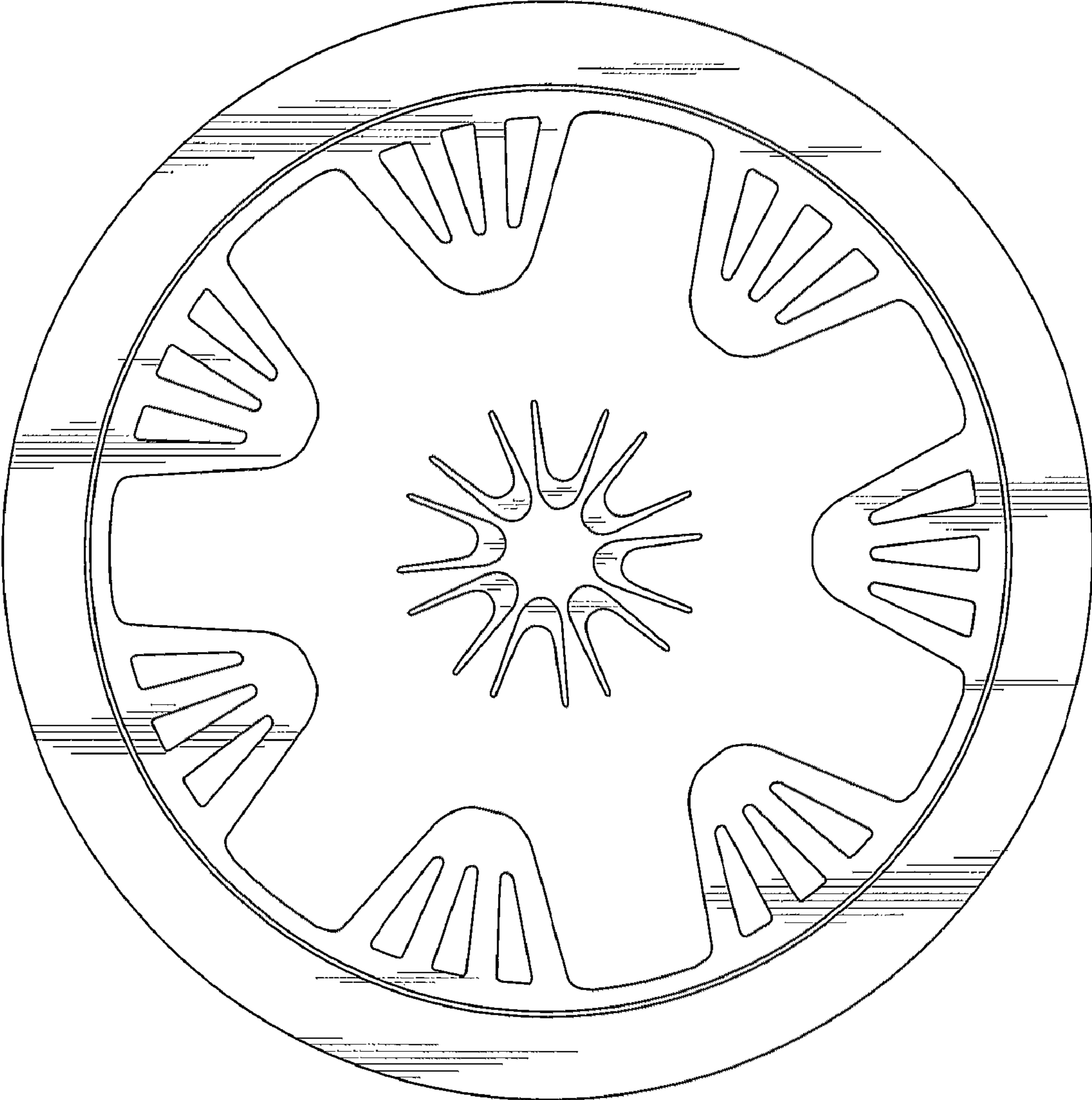
The ornamental design for a cooking utensil bottom with pattern, as shown and described.

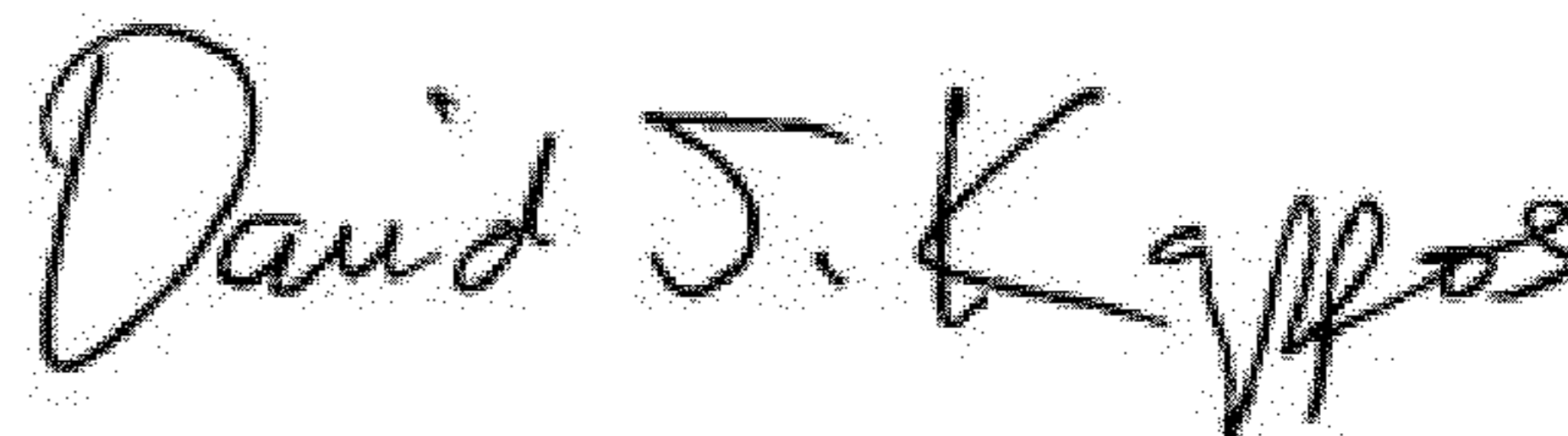
