DESCRIPTION

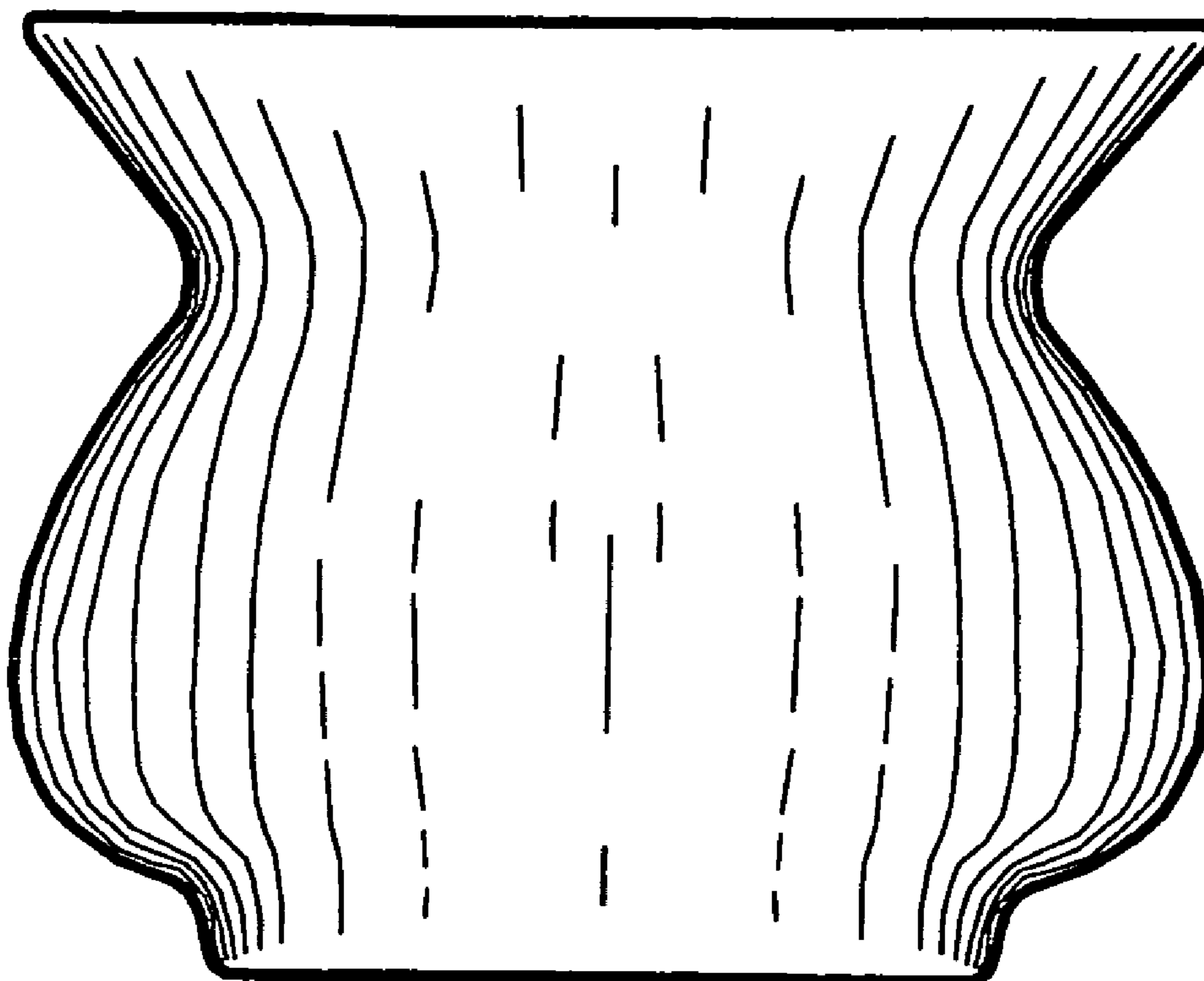
FIG. 1 is a top plan view of a alcohol beverage and spirits nosing, tasting, drinking, and sampling vessel showing our new design;

FIG. 2 is a cross sectional view thereof taken along line 2-2 of FIG. 1;

FIG. 4 is a bottom plan view thereof.

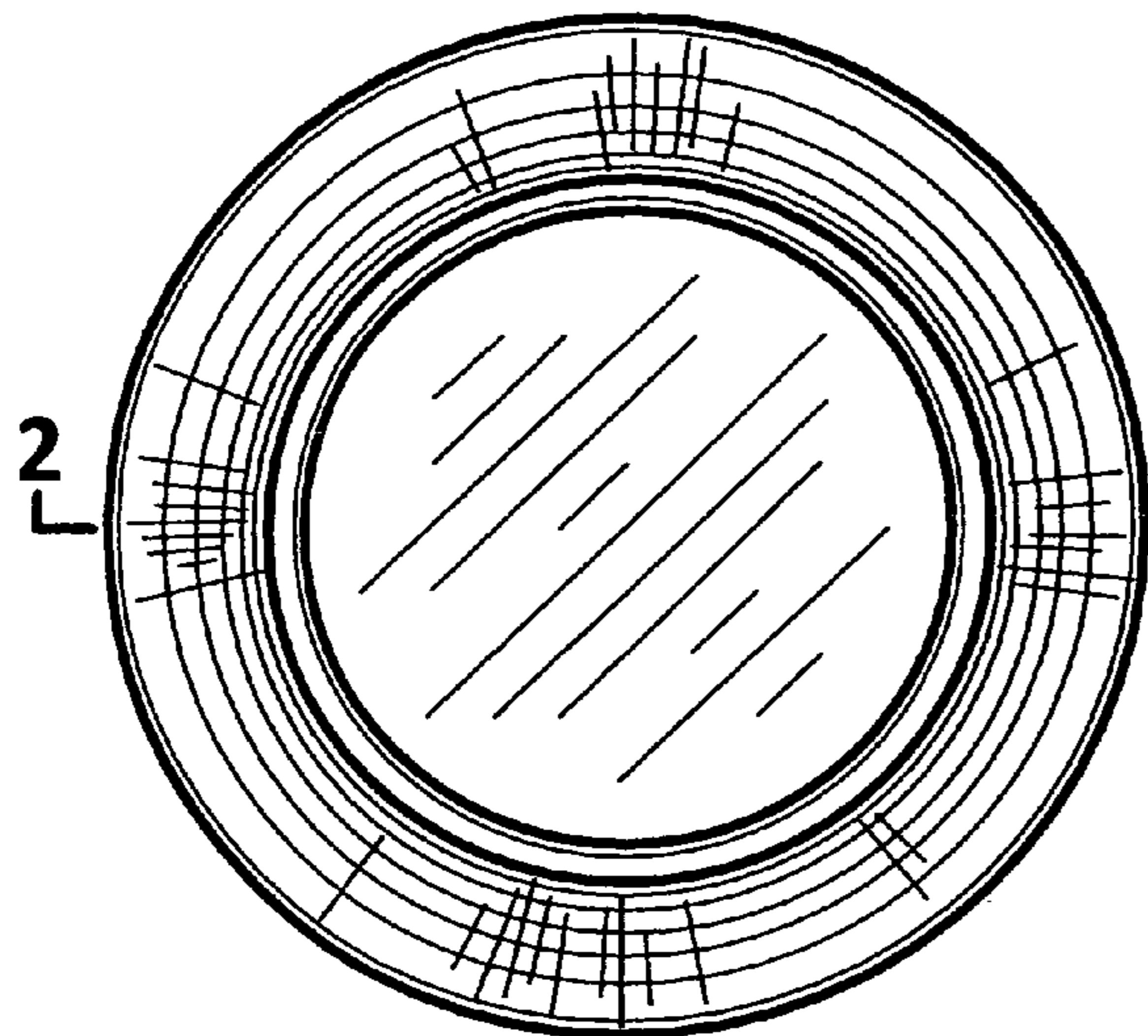

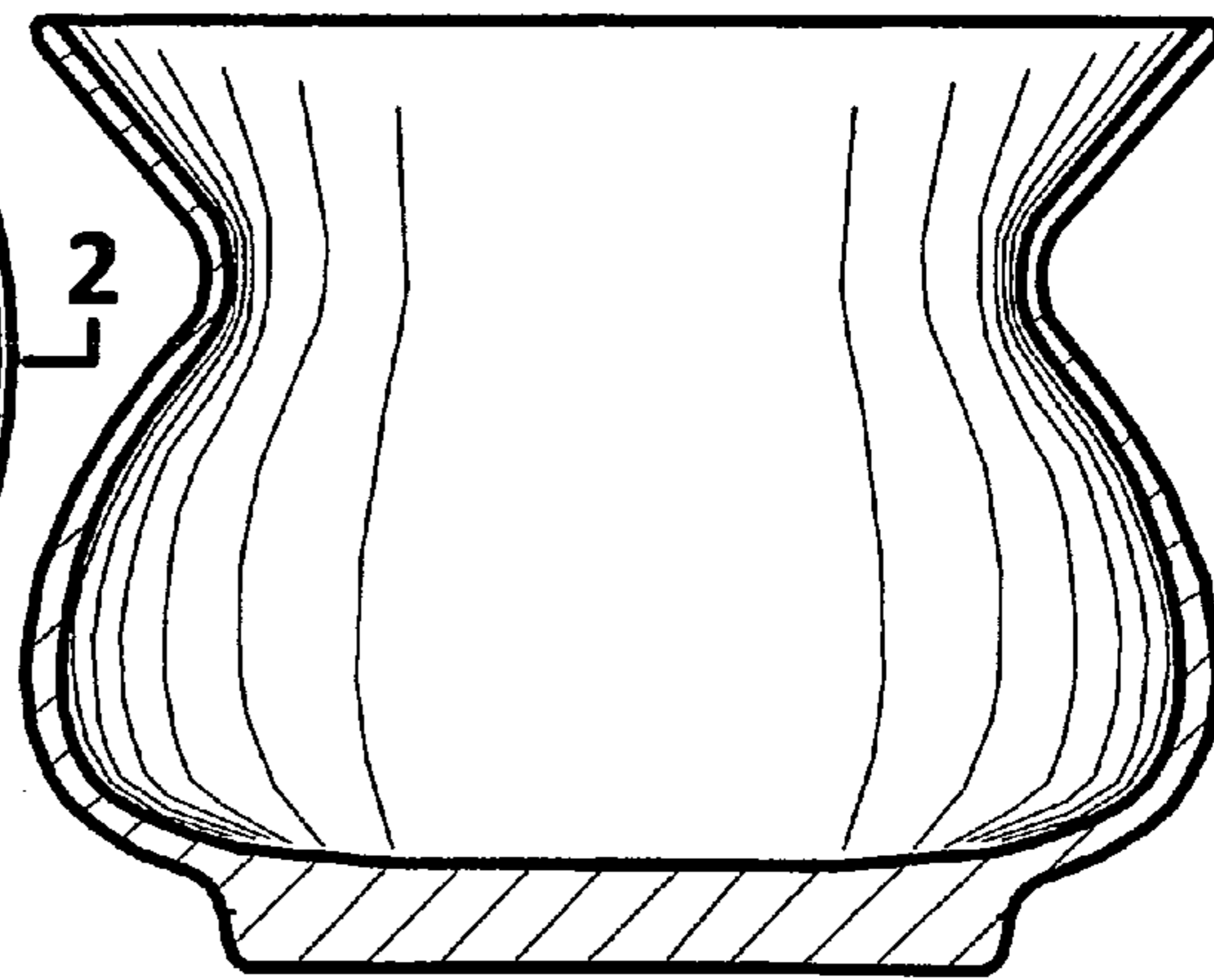

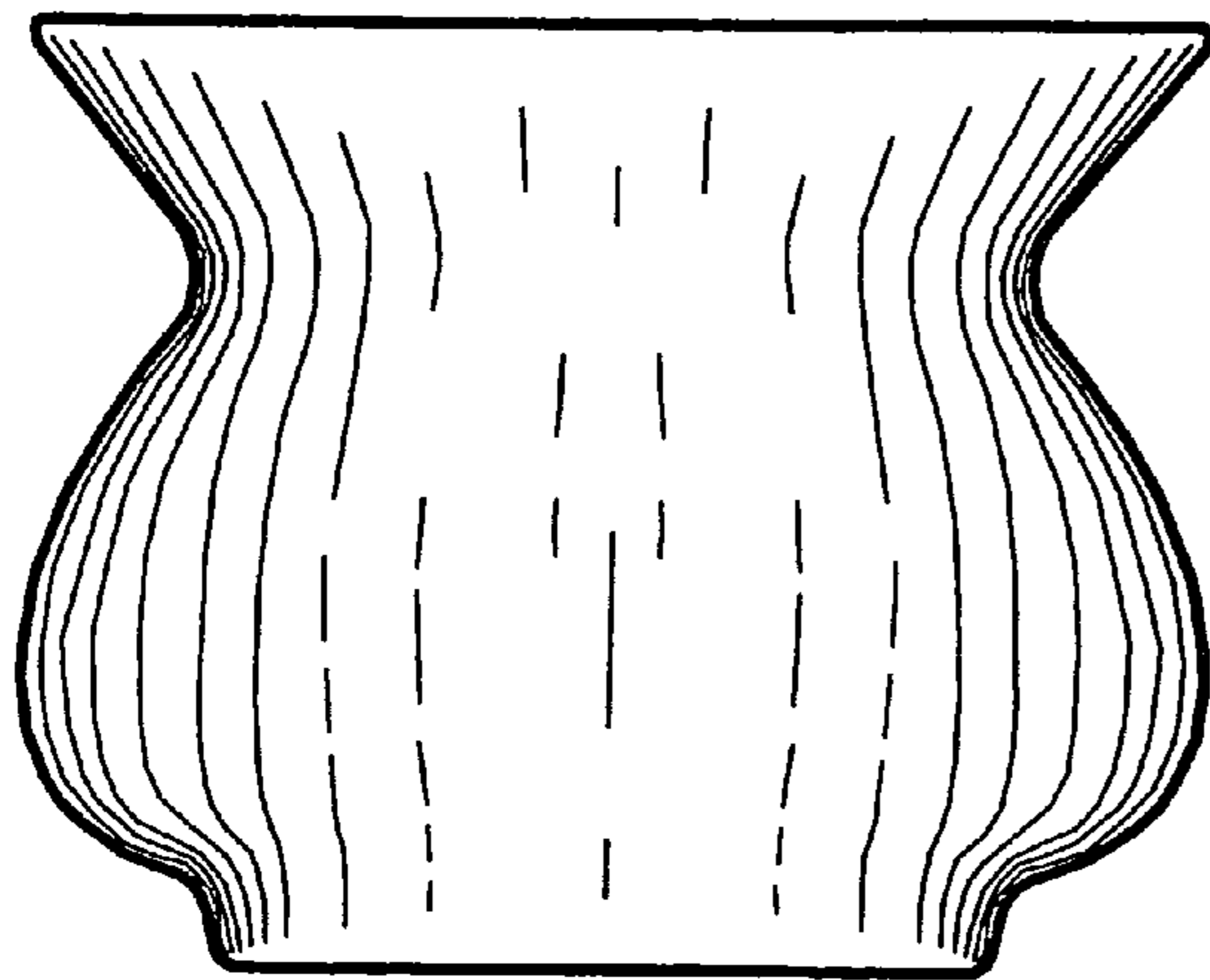

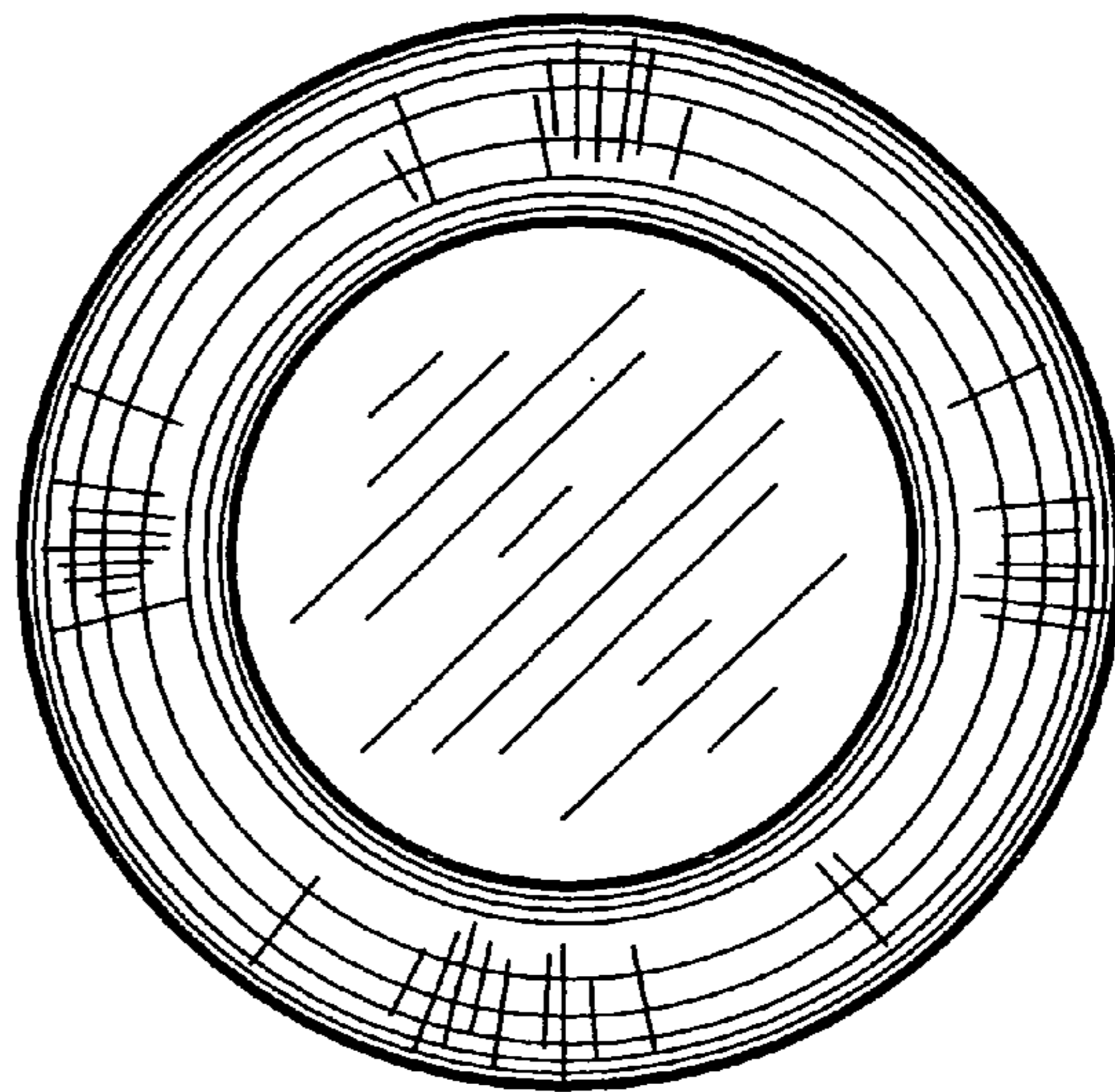
