DESCRIPTION

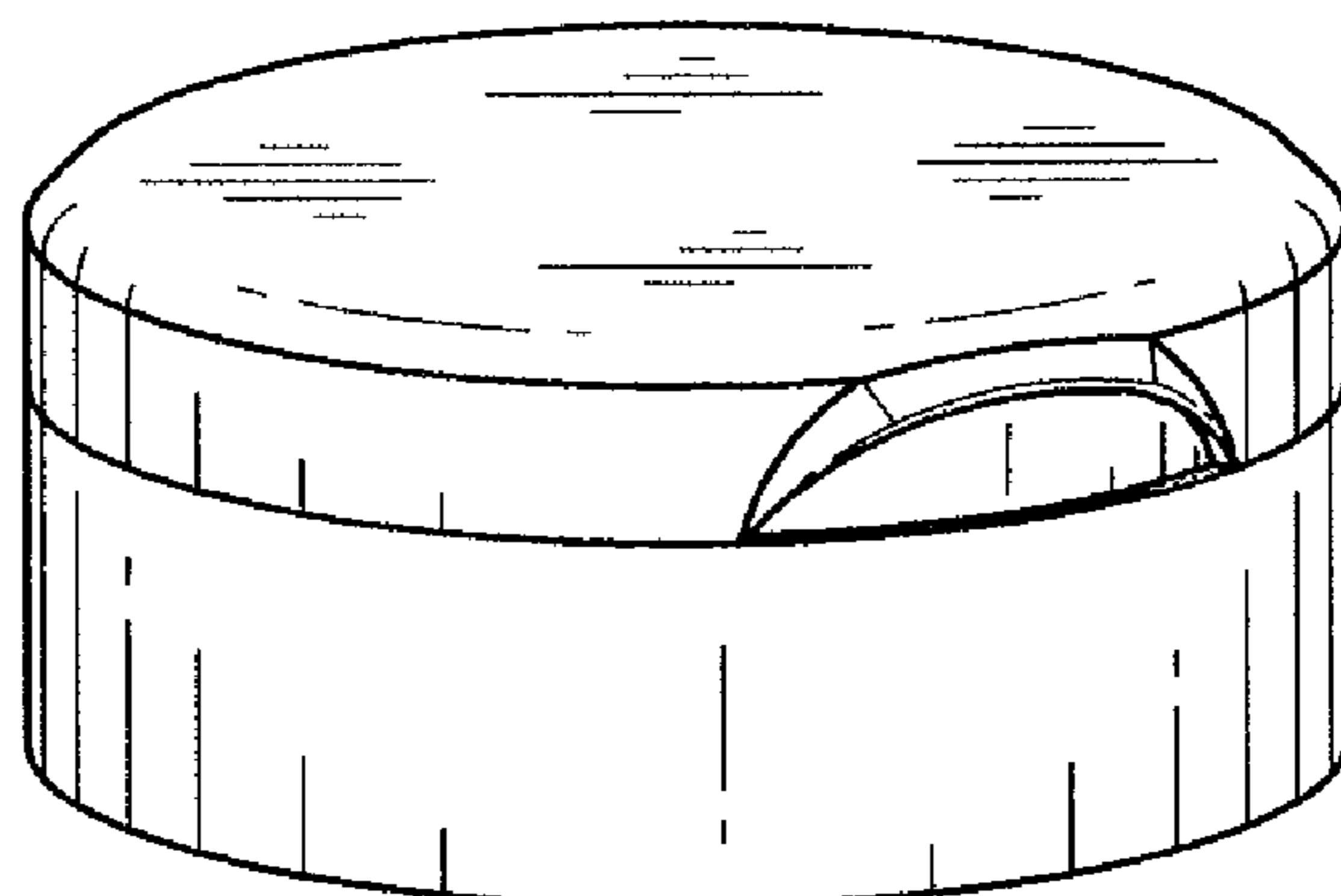
FIG. 1 is a perspective view of a bottle closure in accordance with our new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a top plan view of the bottle closure of FIG. 1, shown in an open configuration;
 FIG. 7 is a front elevational view thereof;
 FIG. 8 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; and,
 FIG. 9 is a front elevational view thereof.
 The broken lines in the figures are for illustrative purposes only and form no part of the claimed design.
 The bottom view of the bottle closure is not shown in the drawings or described in the specification and, therefore, forms no part of the claimed design.

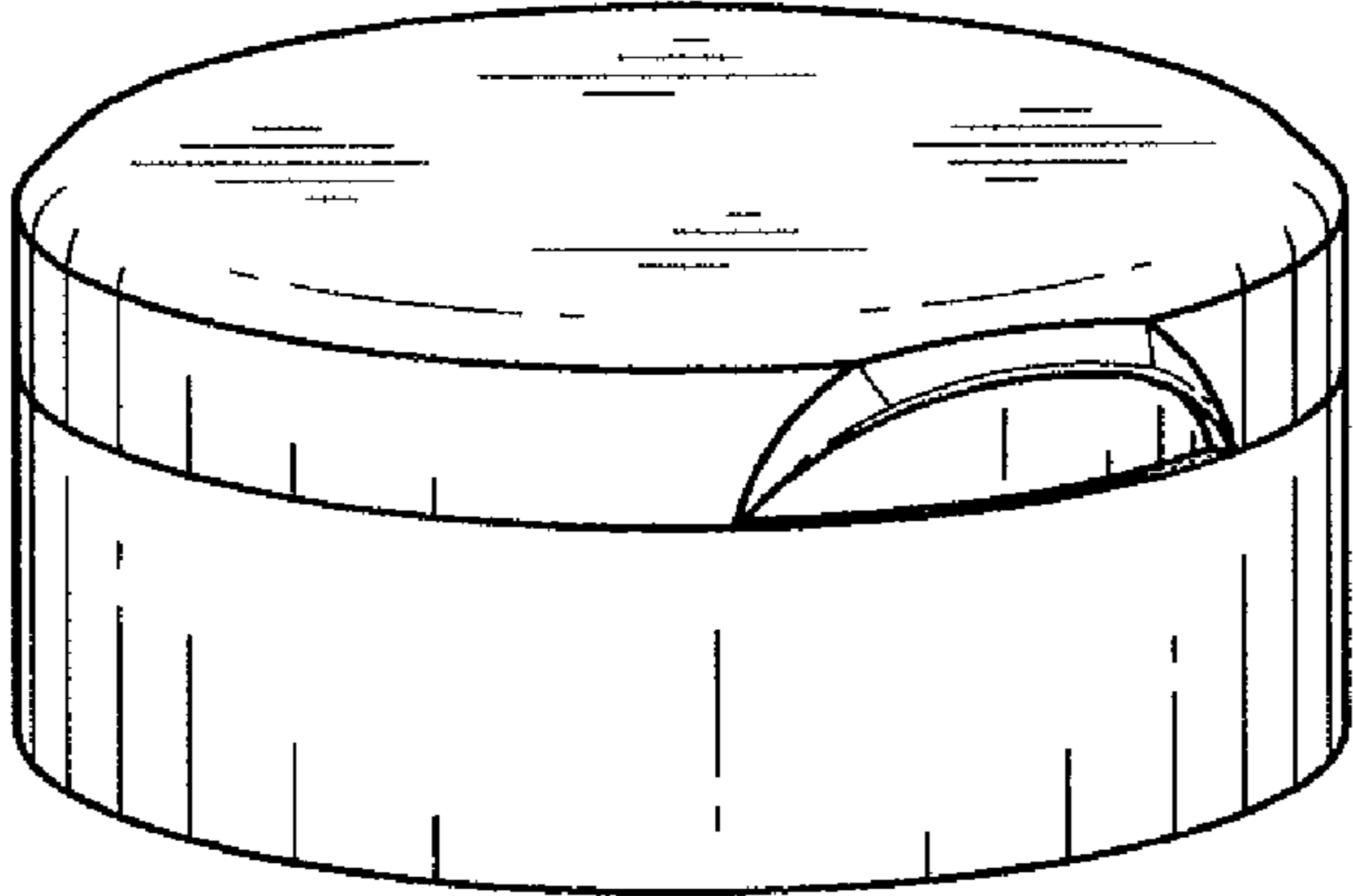

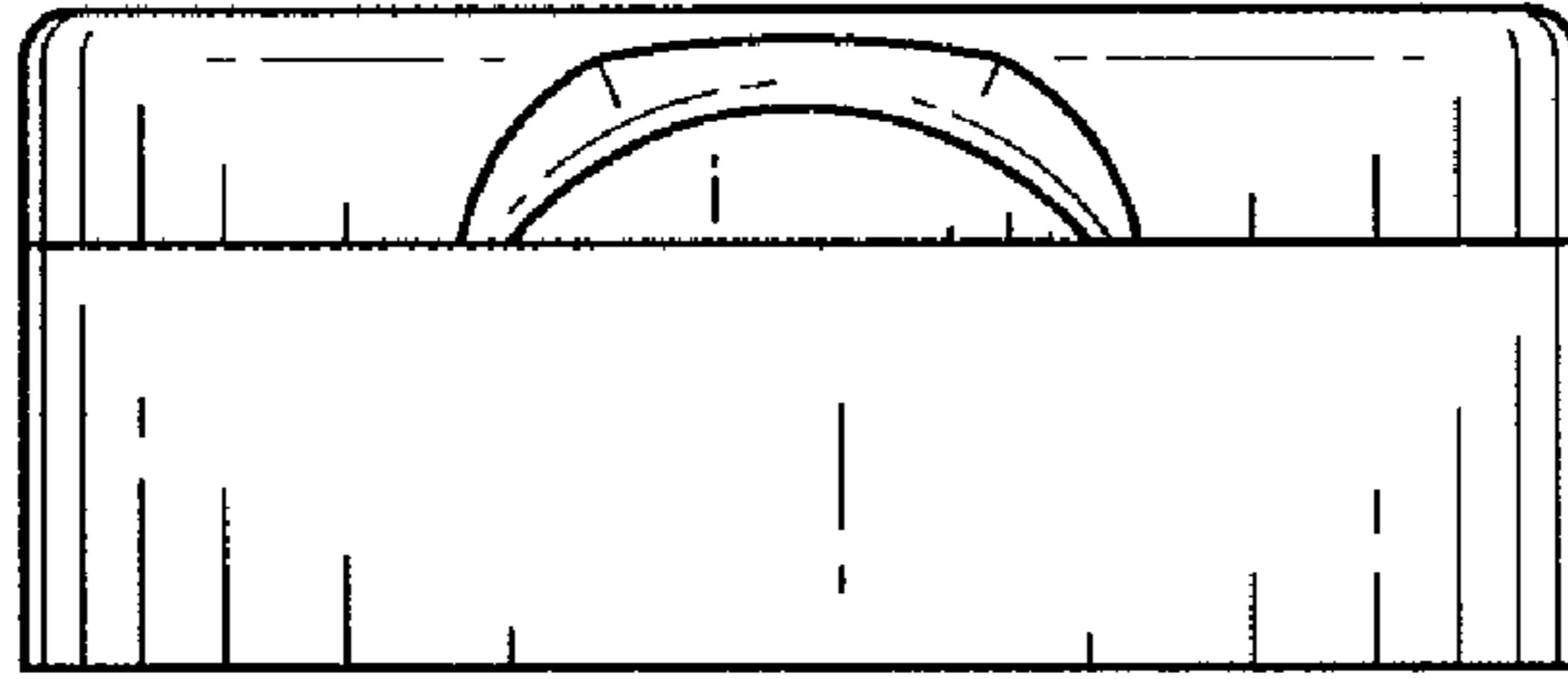

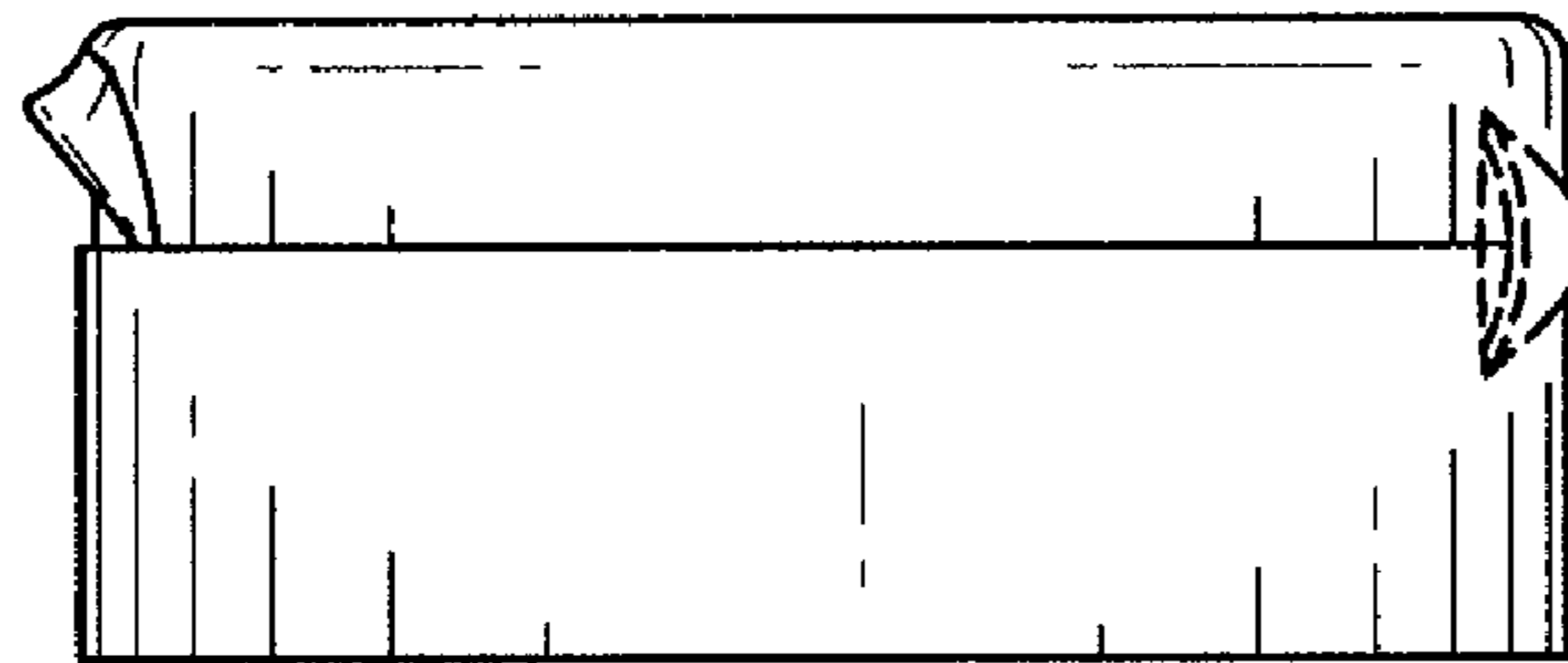

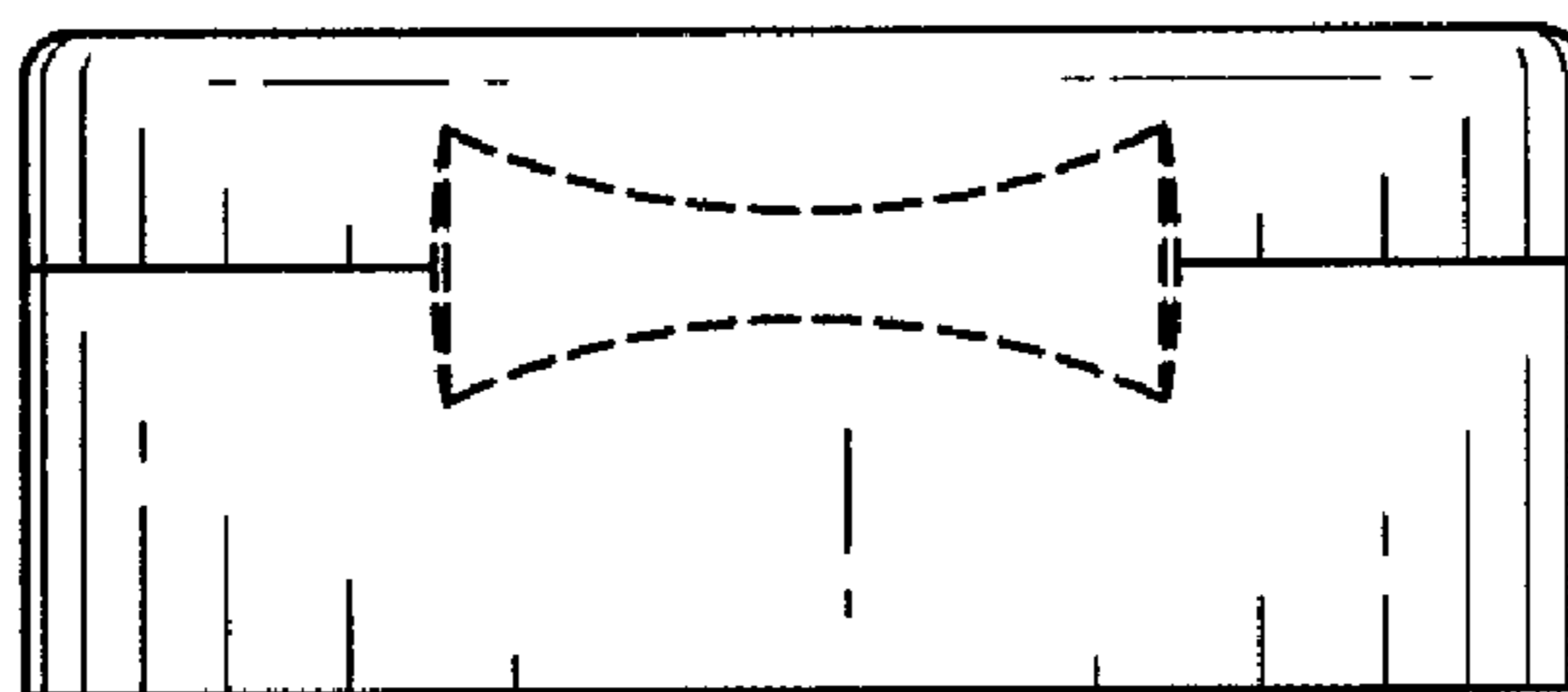

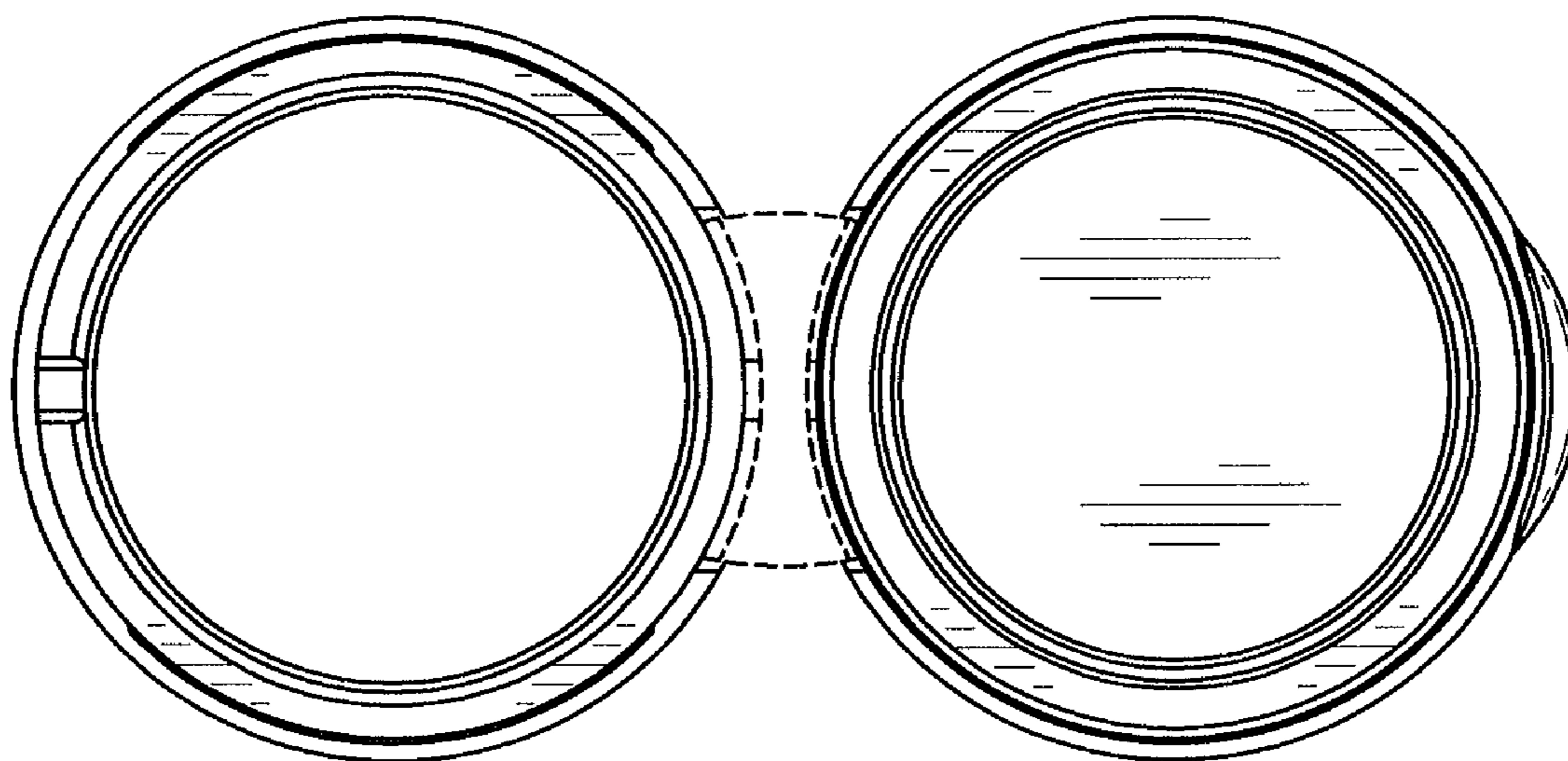

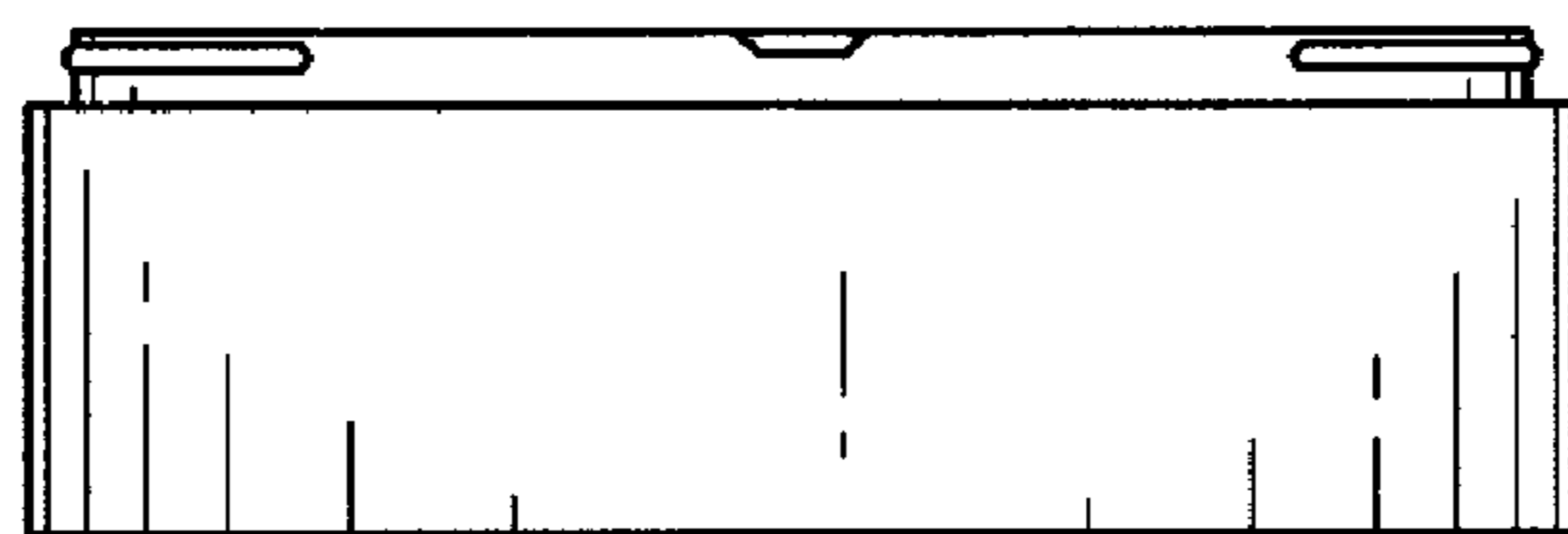

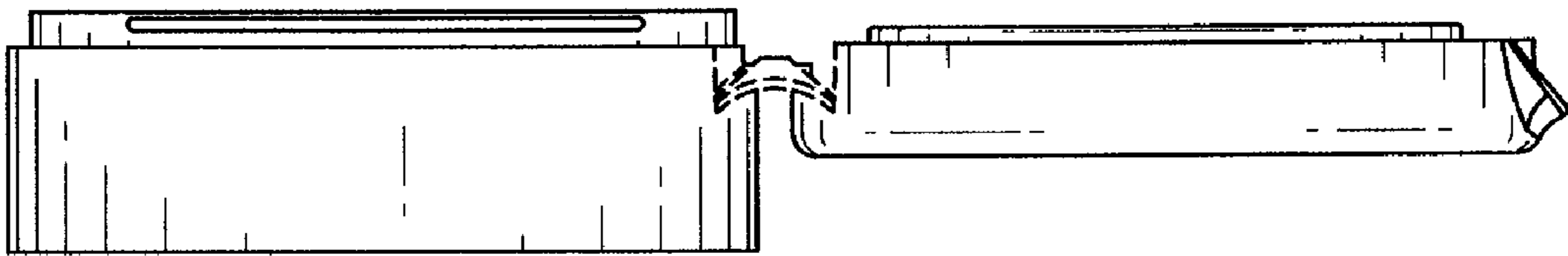

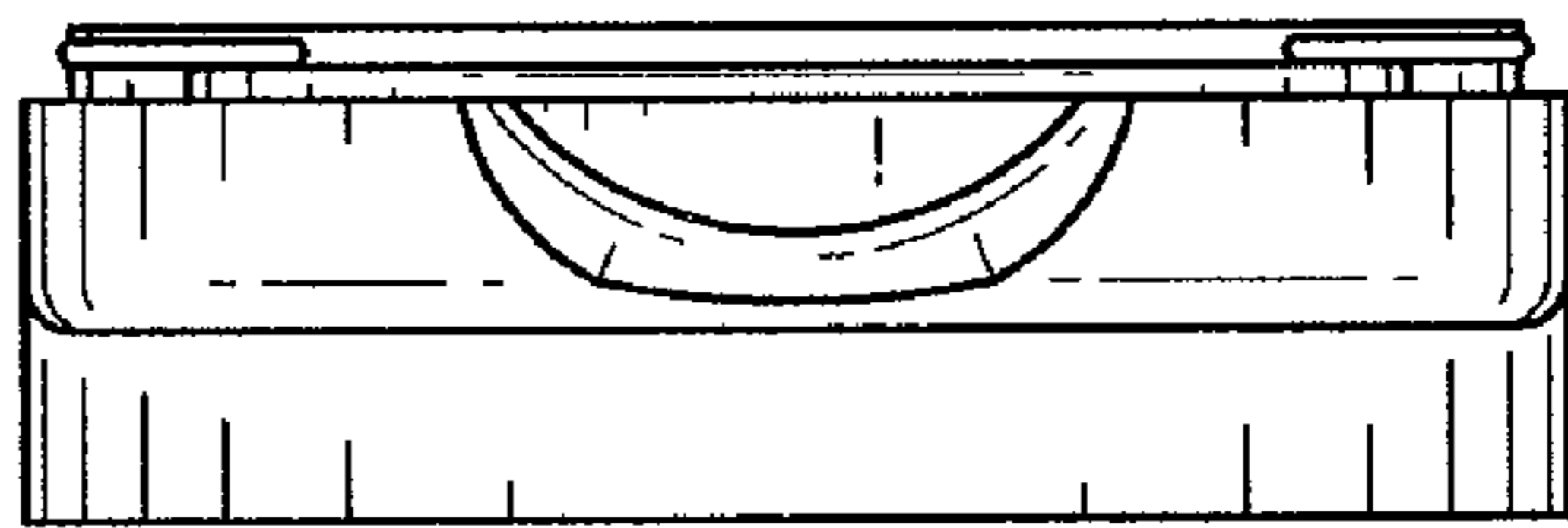
