(57) **CLAIM**

The ornamental design for a Reiki ornament, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged perspective view of a Reiki ornament showing my new design, shown partially opened with two petals shown broken away for ease of illustration;

FIG. 2 is an enlarged perspective view thereof; with the opposite petals shown broken away for ease of illustration;

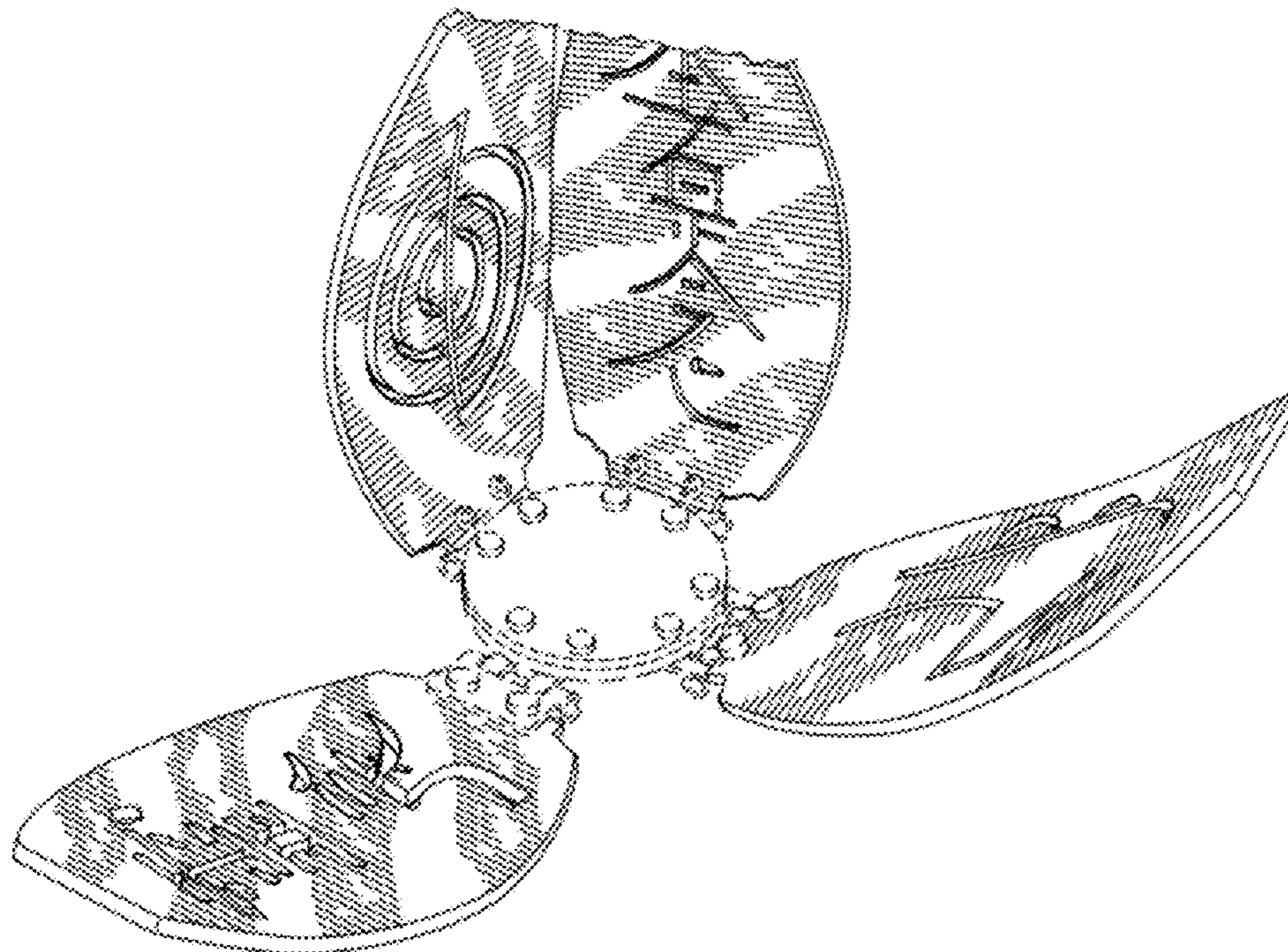
FIG. 3 is a perspective view thereof, with the Reiki ornament in a closed position, and fully showing two of the four petals of the design;

FIG. 4 is a perspective view thereof, with the Reiki ornament in a closed position, and fully showing one of the four petals of the design; and,

FIG. 5 is a perspective view thereof, with the Reiki ornament in a closed position, and fully showing two of the four petals of the design.

The broken line showing of the base of the Reiki ornament is included for the purpose of illustrating environment and forms no part of the claimed design.

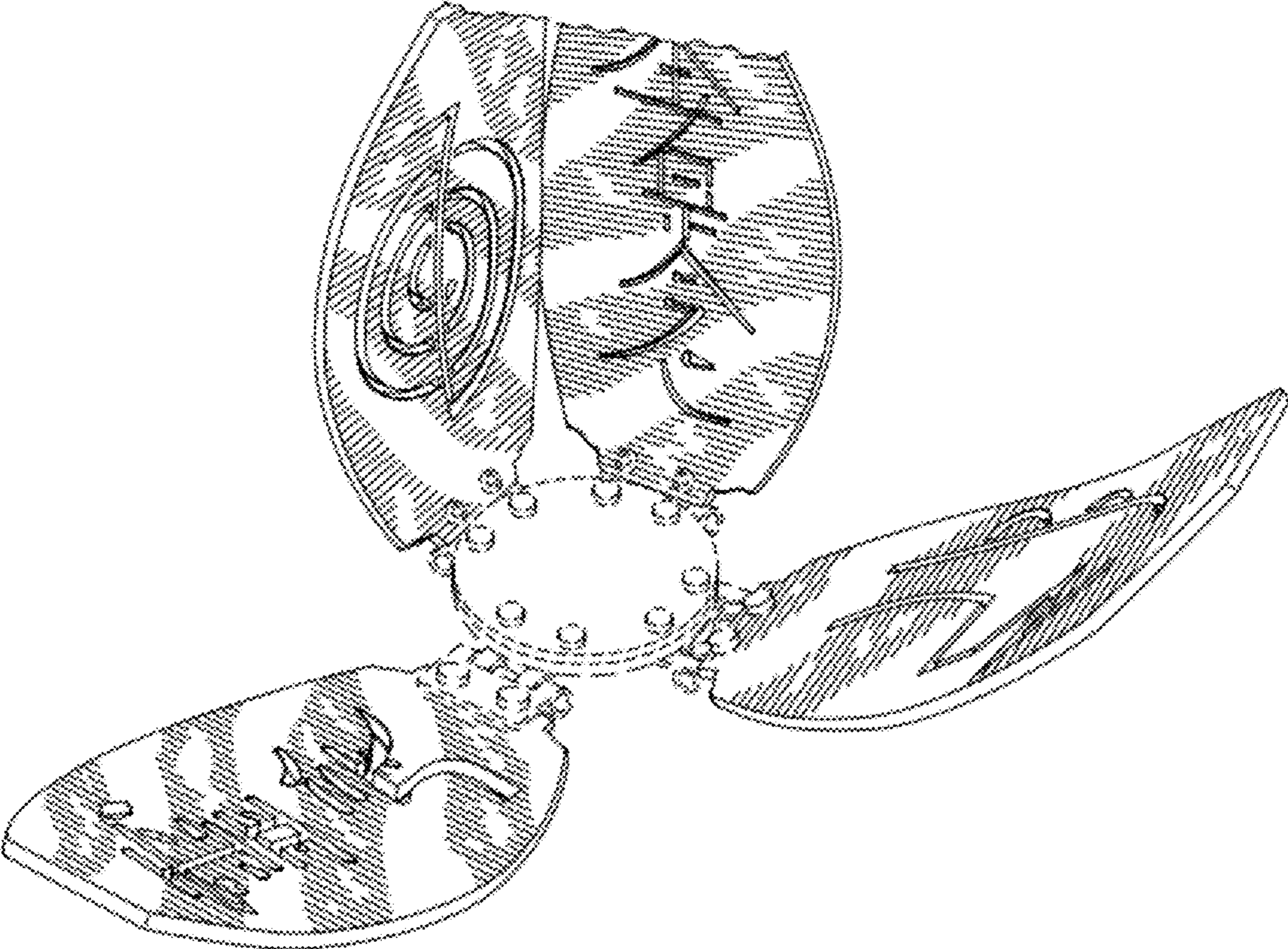

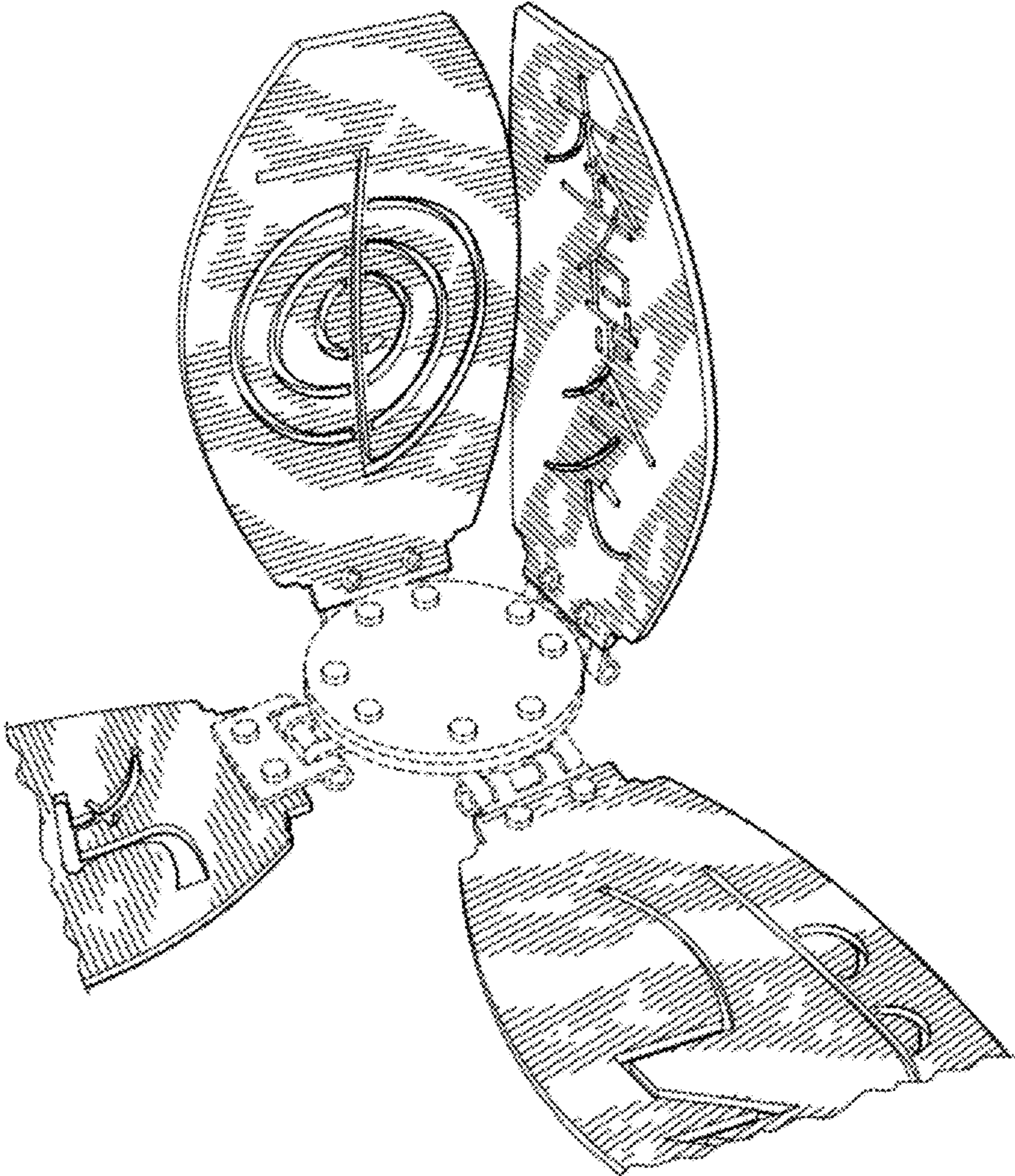

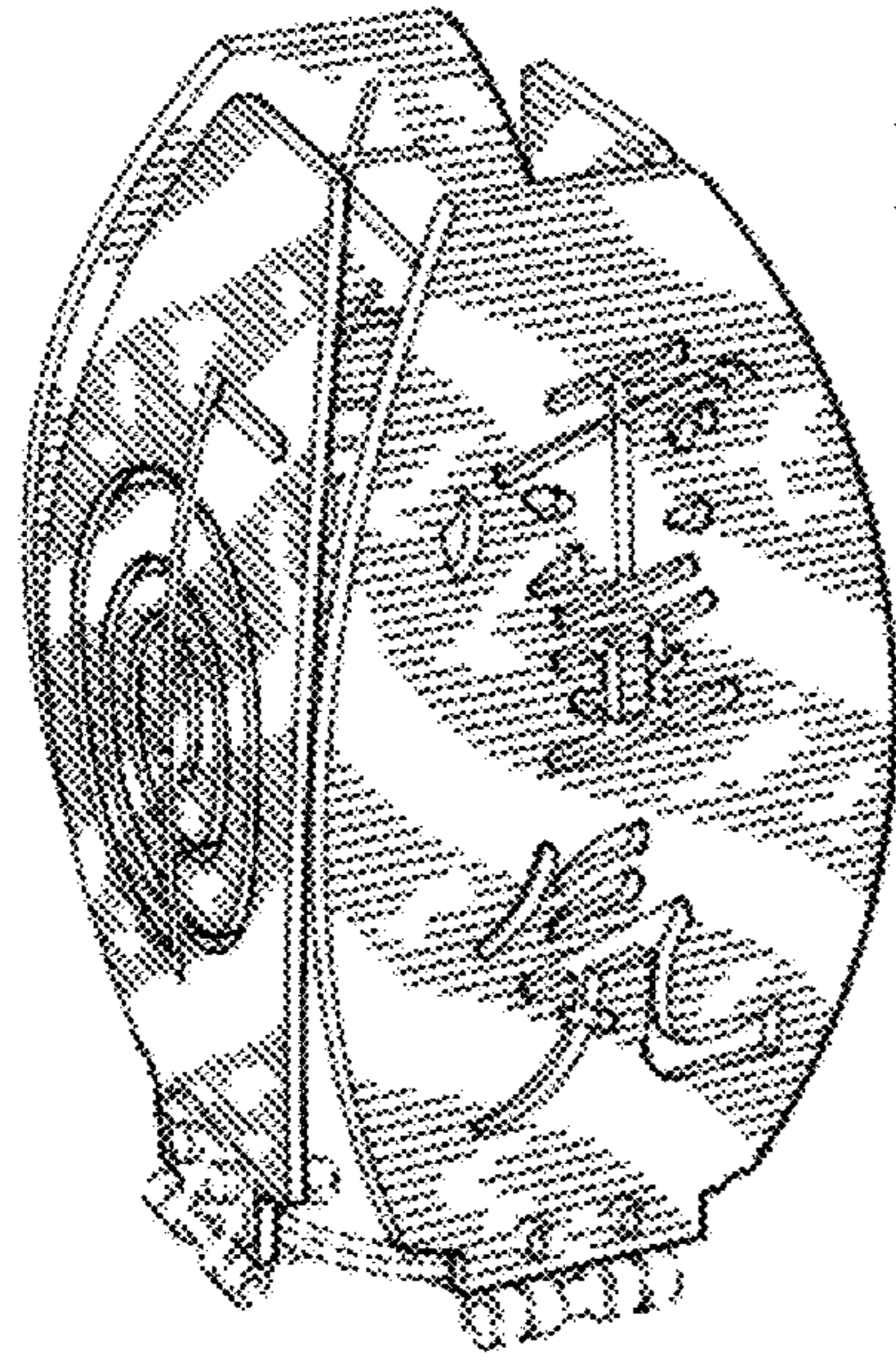

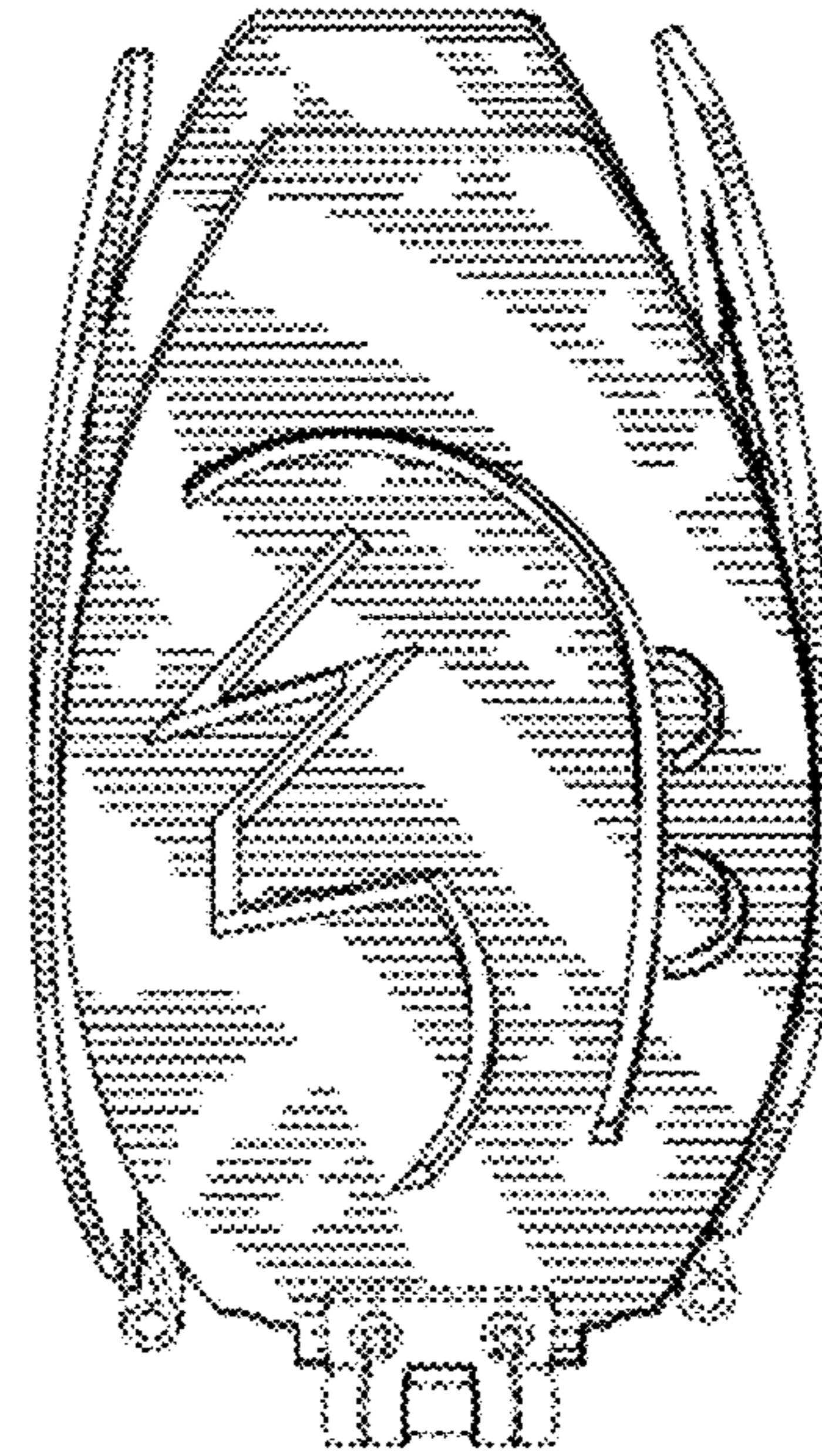

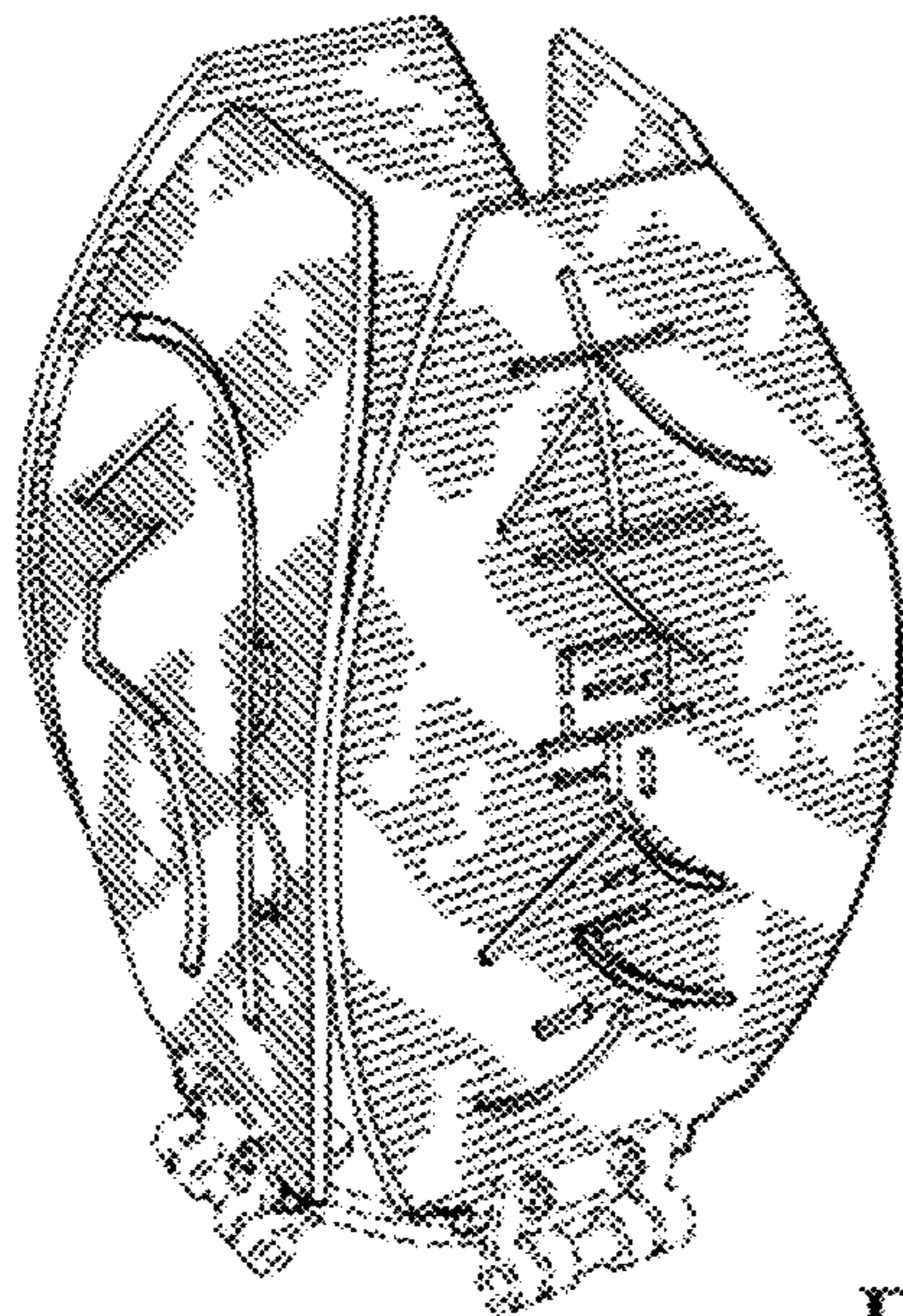
