(57) **CLAIM**

The ornamental design for a motor vehicle, toy and/or replica, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a motor vehicle, toy and/or replica;

FIG. 2 is a front elevation view of the motor vehicle, toy and/or replica;

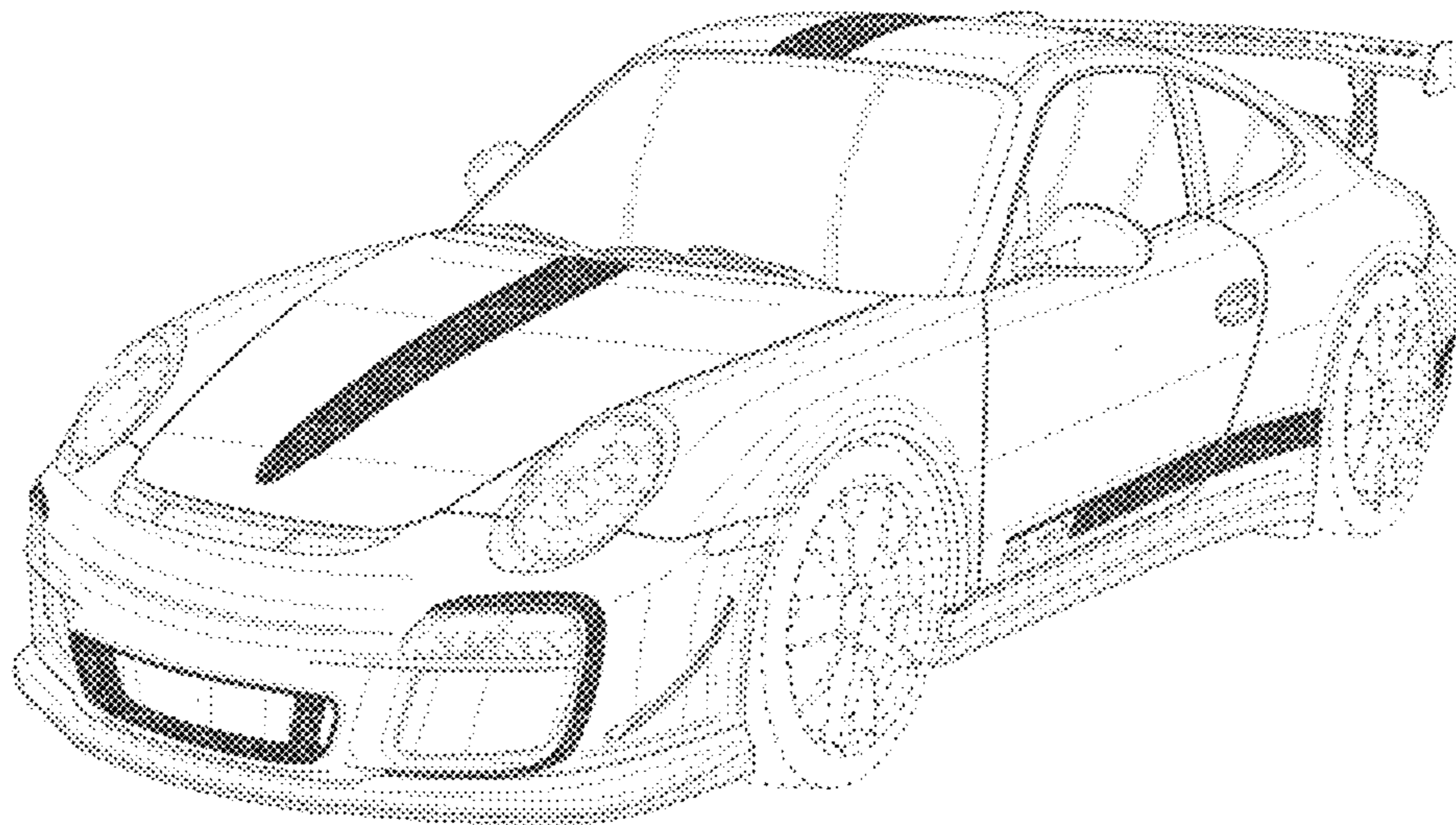
FIG. 3 is a rear elevation view of the motor vehicle, toy and/or replica;

FIG. 4 is an elevation view from the left side of the motor vehicle, toy and/or replica, the right side being a mirror image thereof; and,

FIG. 5 is a top plan view of the motor vehicle.

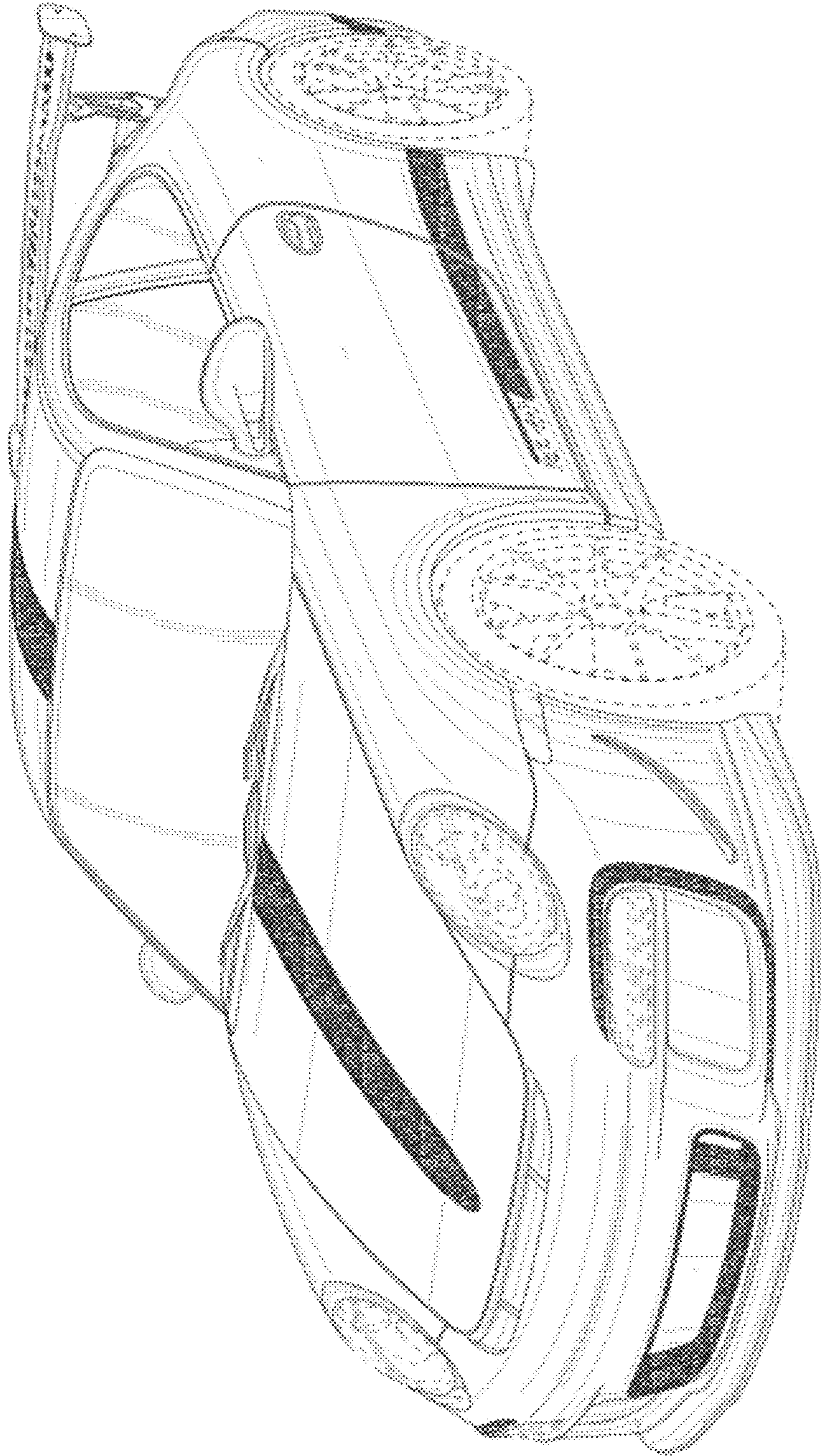

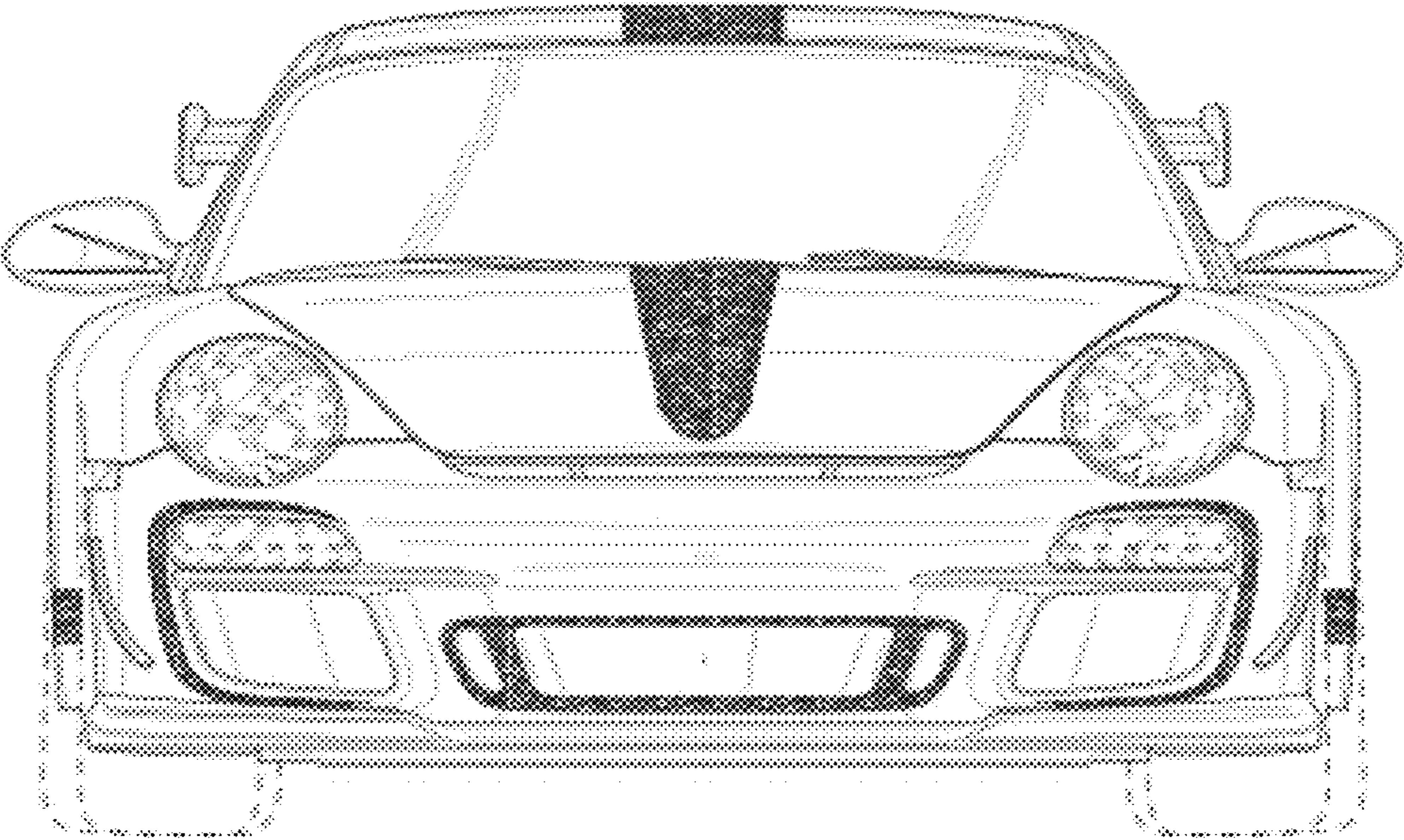

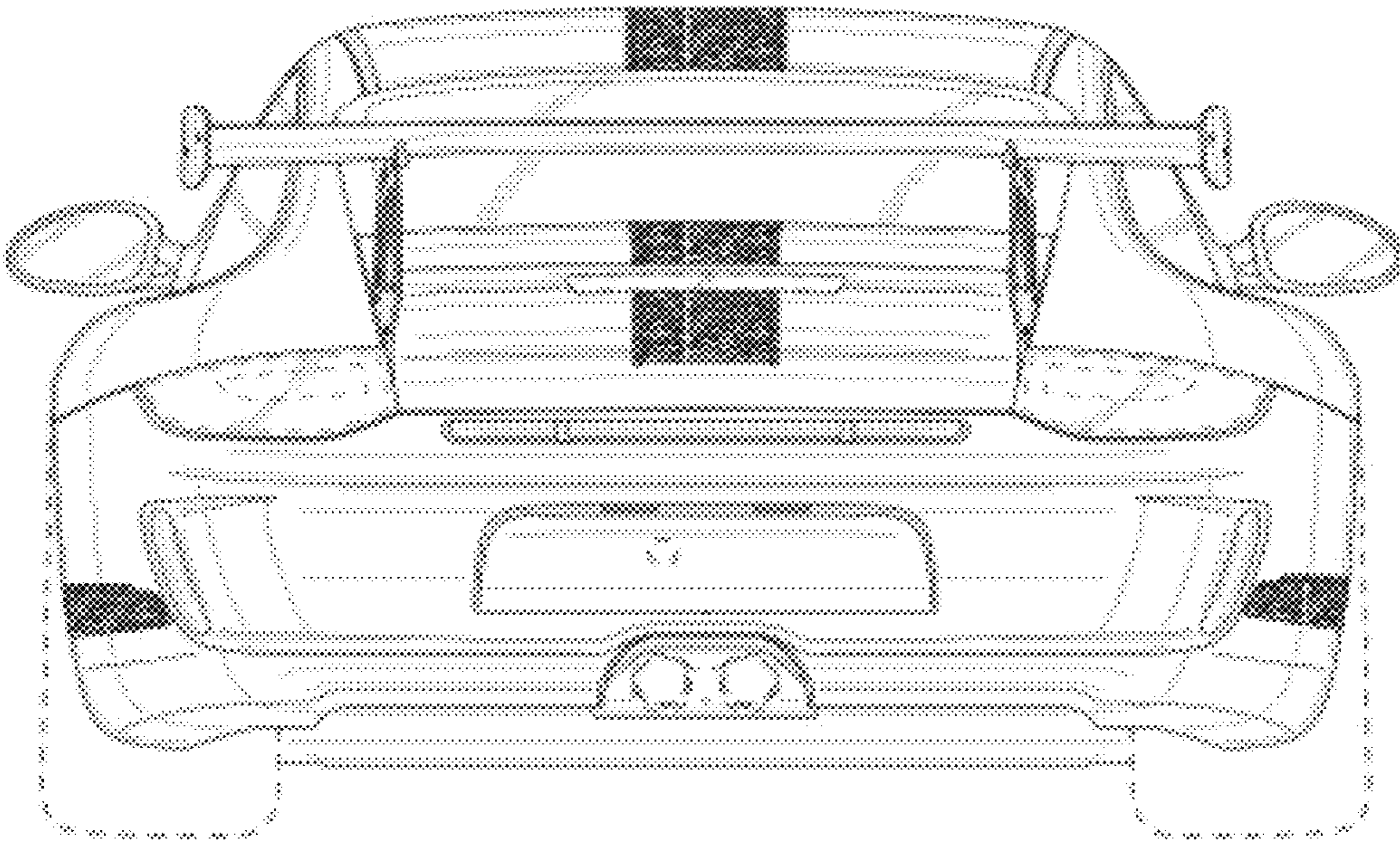

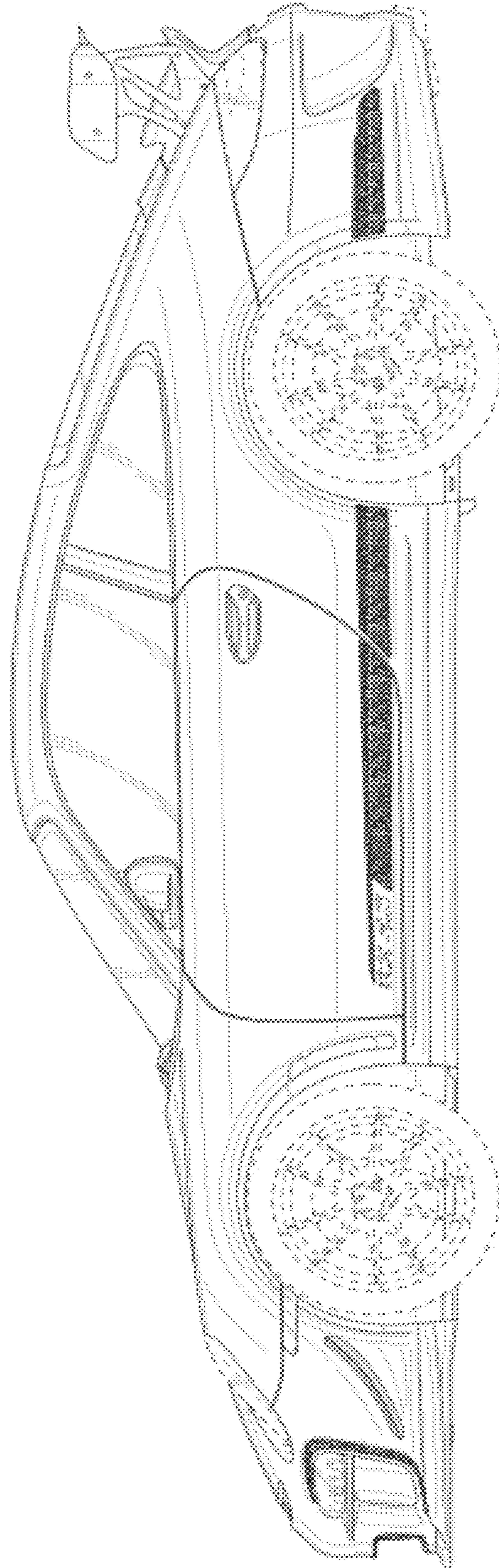

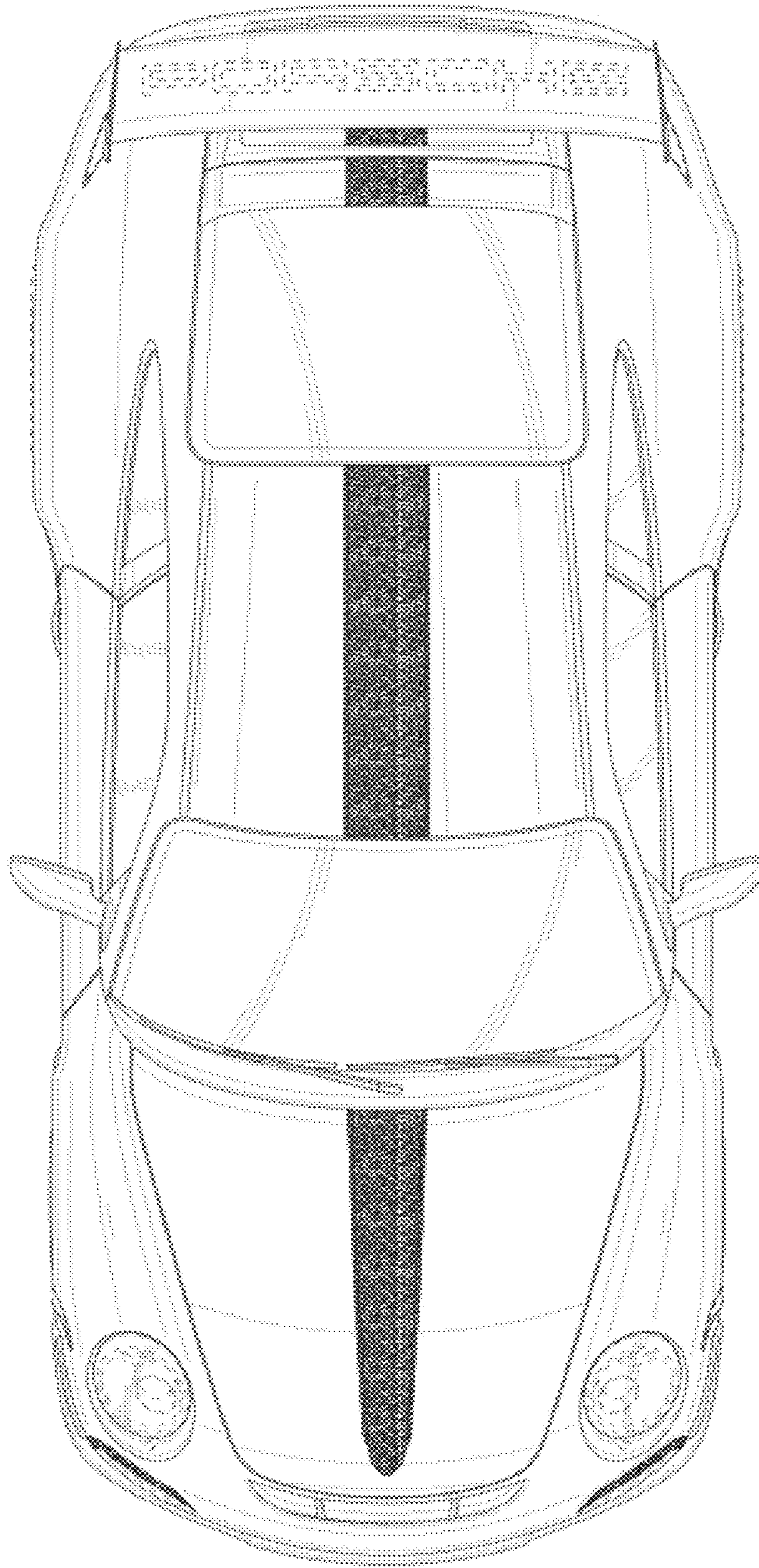
