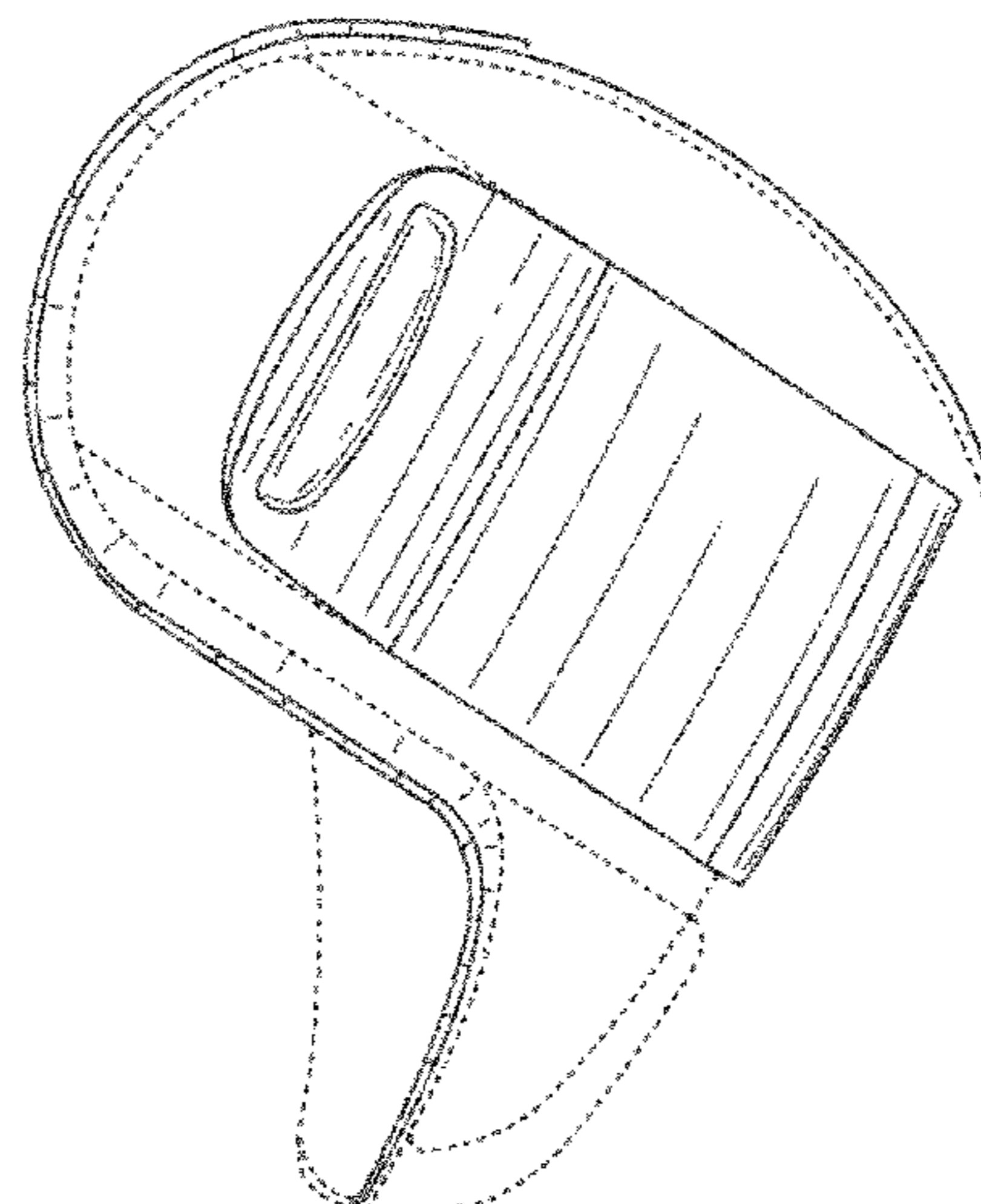
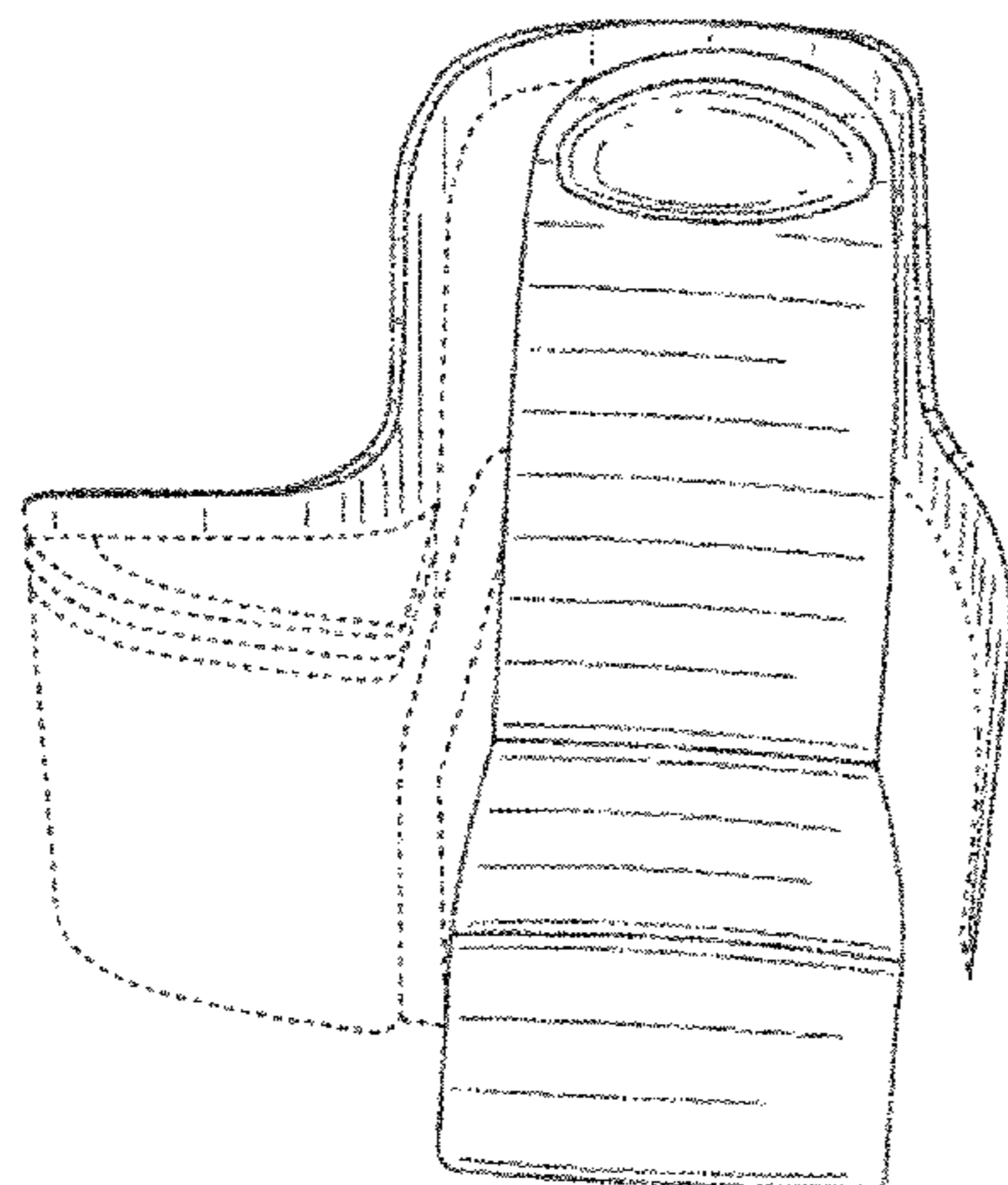
(57) **CLAIM**

The ornamental design for a commercial aircraft passenger cabin seat and partition, as shown and described.

DESCRIPTION

FIG. 1 is a front, left perspective view showing a commercial aircraft passenger cabin seat and partition with the seat in a sitting position according to an embodiment of our design, shown with commercial aircraft passenger cabin furniture; FIG. 2 is a top plan view thereof; FIG. 3 is a top plan view of the commercial aircraft passenger cabin seat and partition of FIG. 1 with the passenger seat in an extended position; and, FIG. 4 is a rear, left perspective view of the commercial aircraft passenger cabin seat and partition of FIG. 3. Throughout the Figures, broken lines showing environment or structure illustrate unclaimed portions of the commercial aircraft passenger cabin seat and partition and form no part of the claimed design. Unshaded portions of the articles and portions of the articles not shown in the drawings form no part of the claimed design.

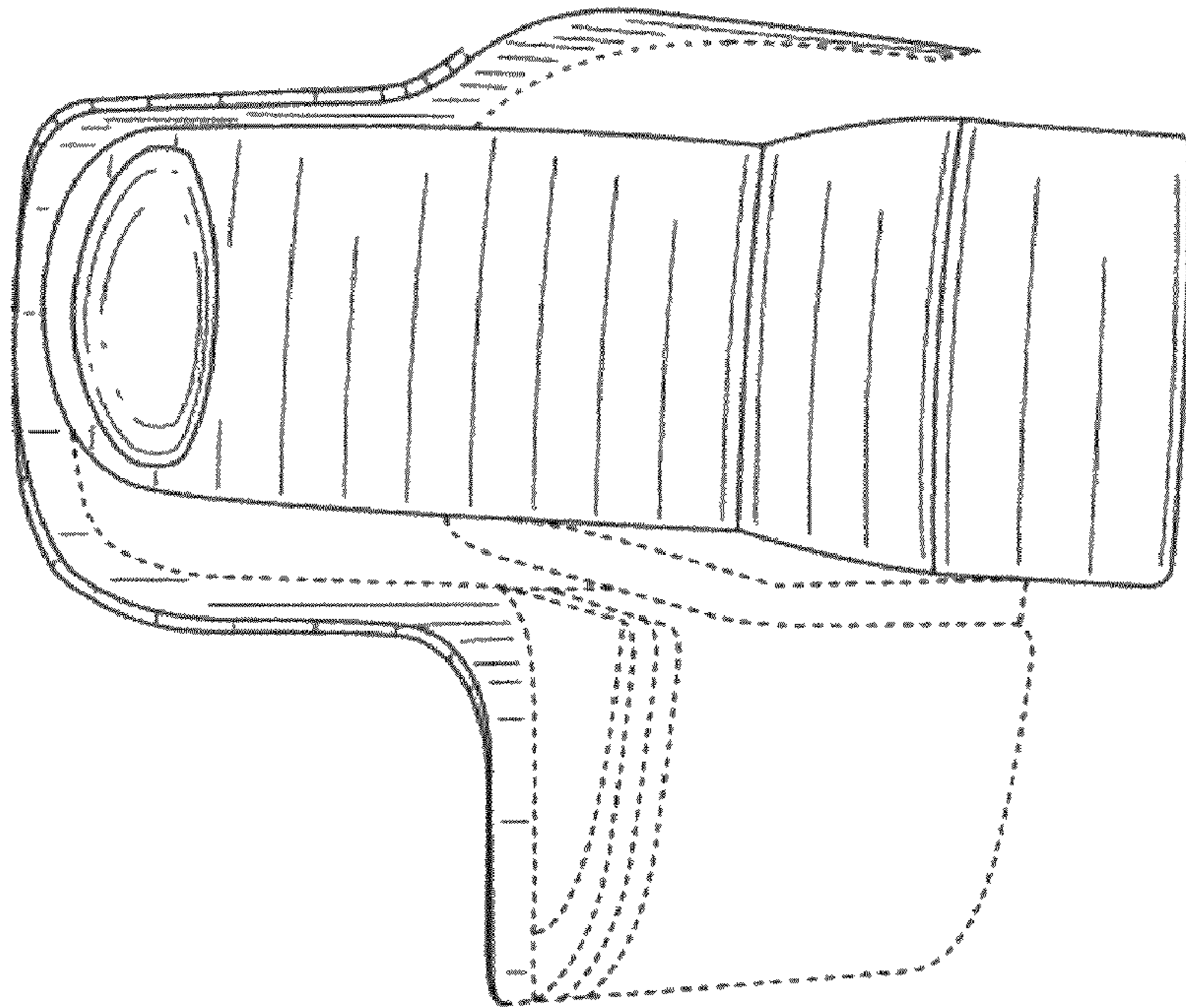

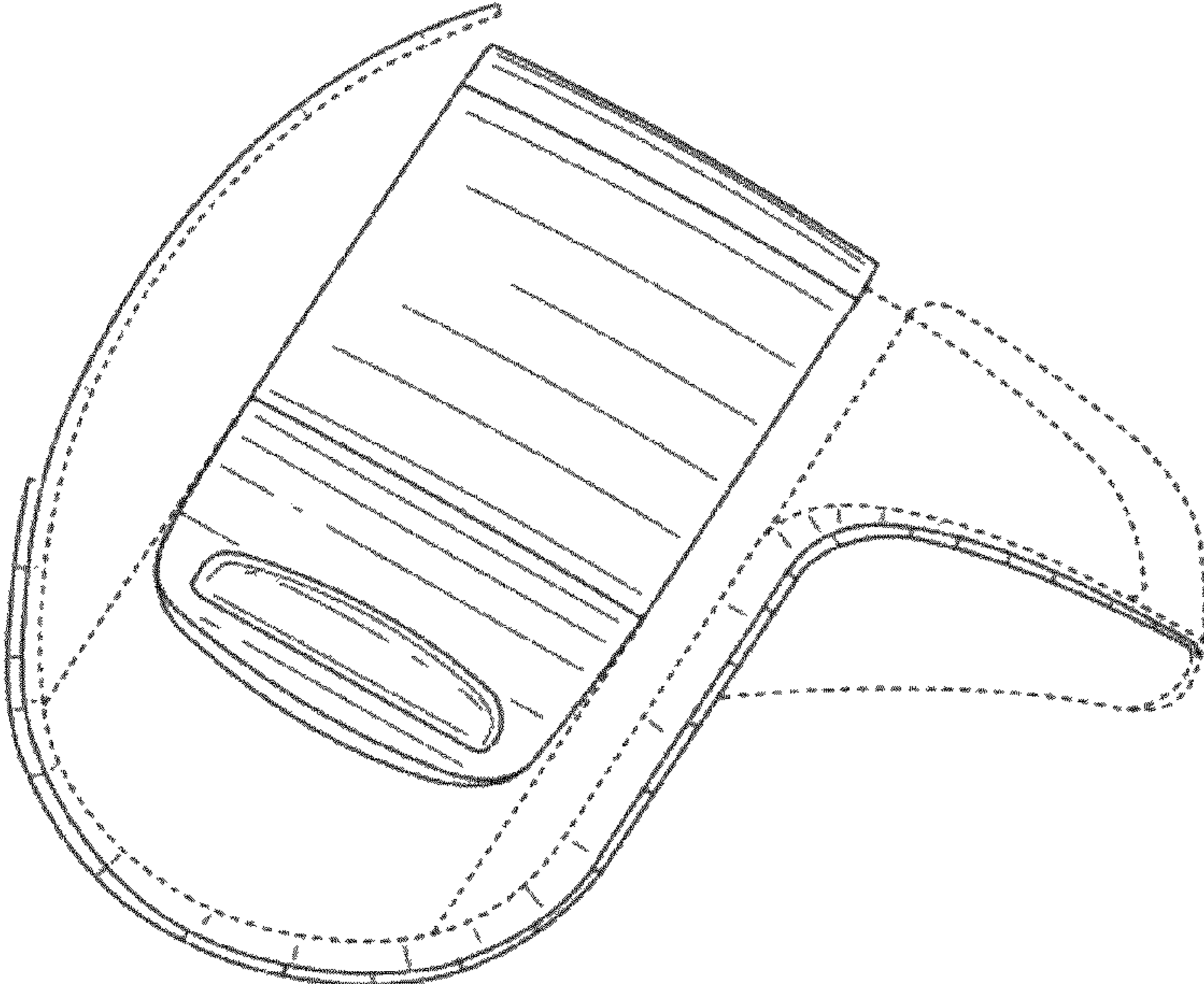

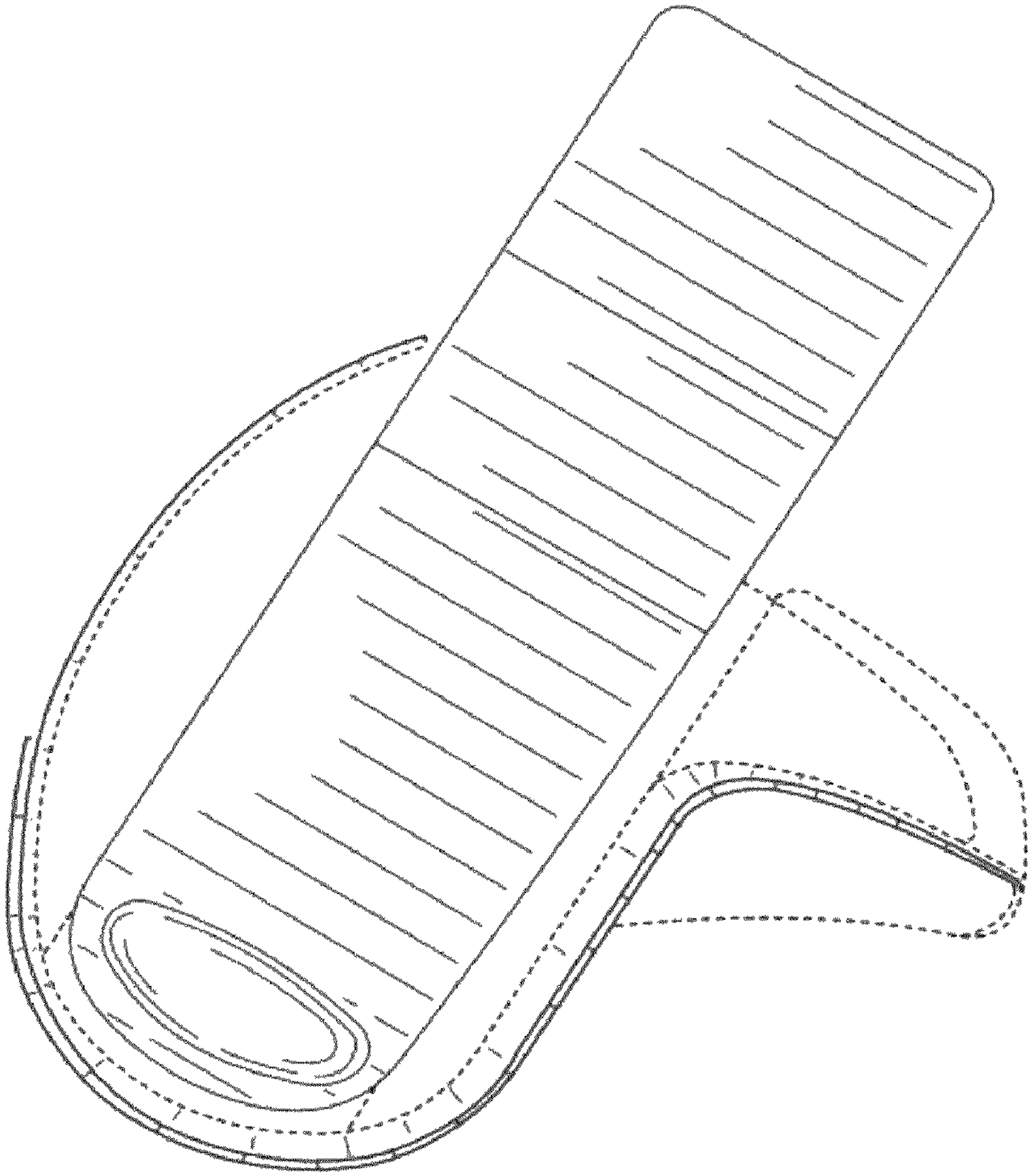

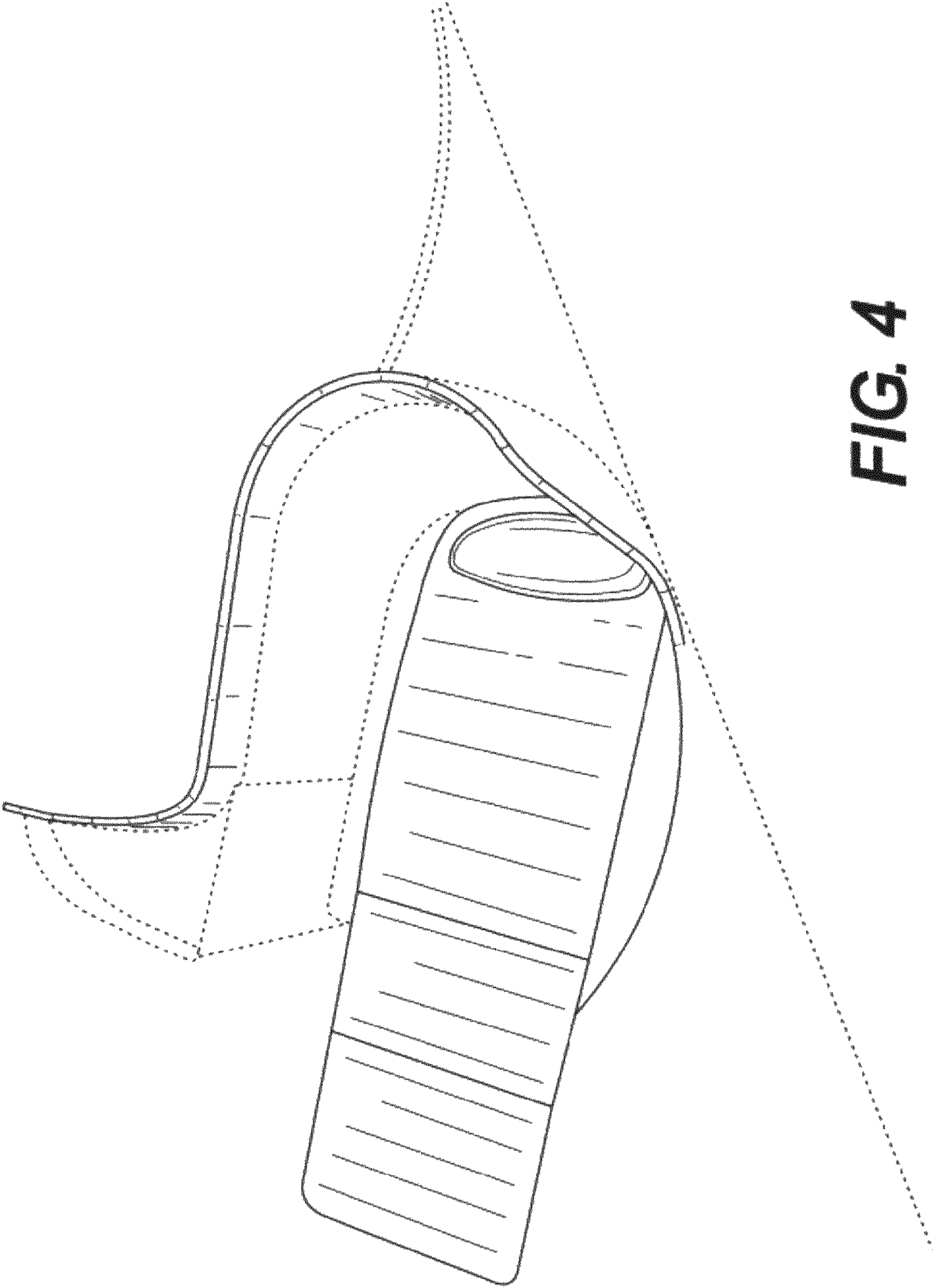
