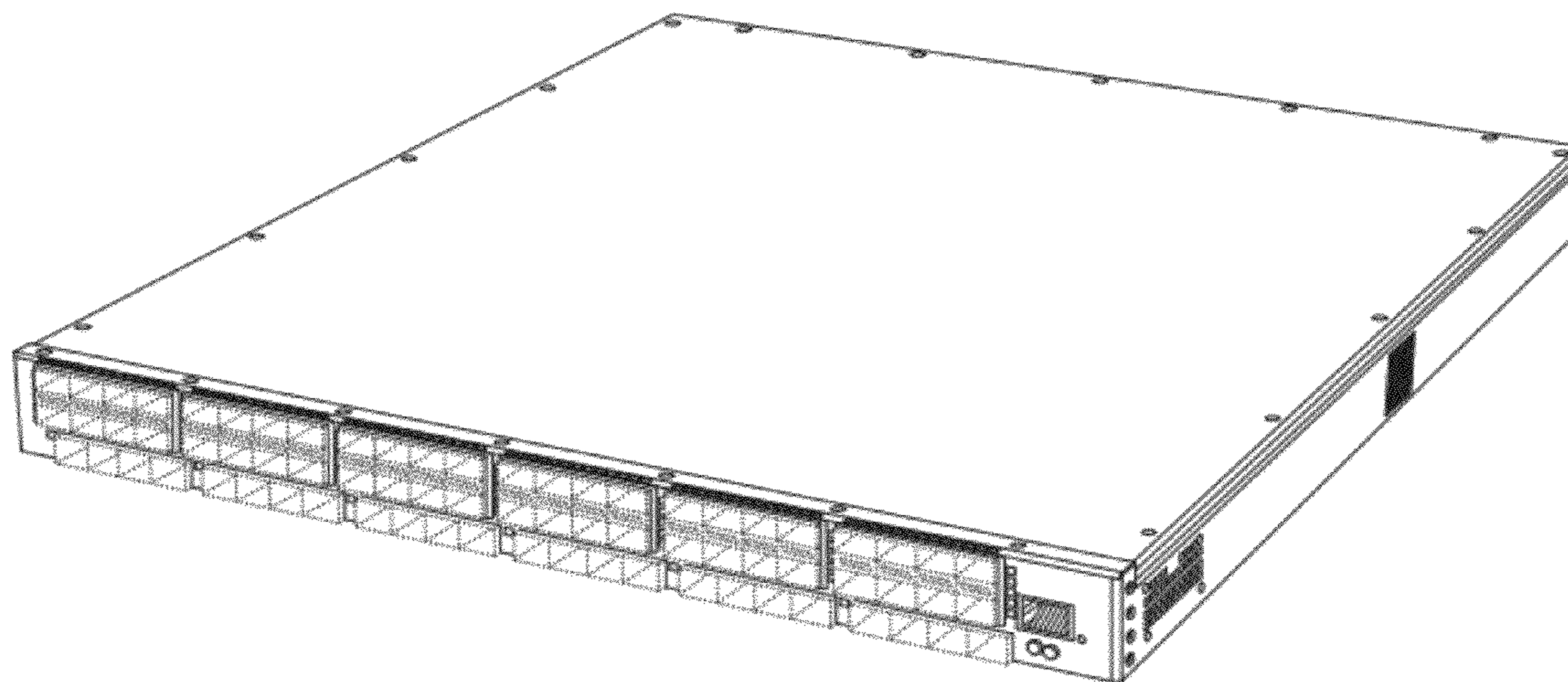
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a container for electronic equipment in accordance with the design;
FIG. 2 is a front view of the container for electronic equipment in accordance with the design;
FIG. 3 is a back view of the container for electronic equipment in accordance with the design;

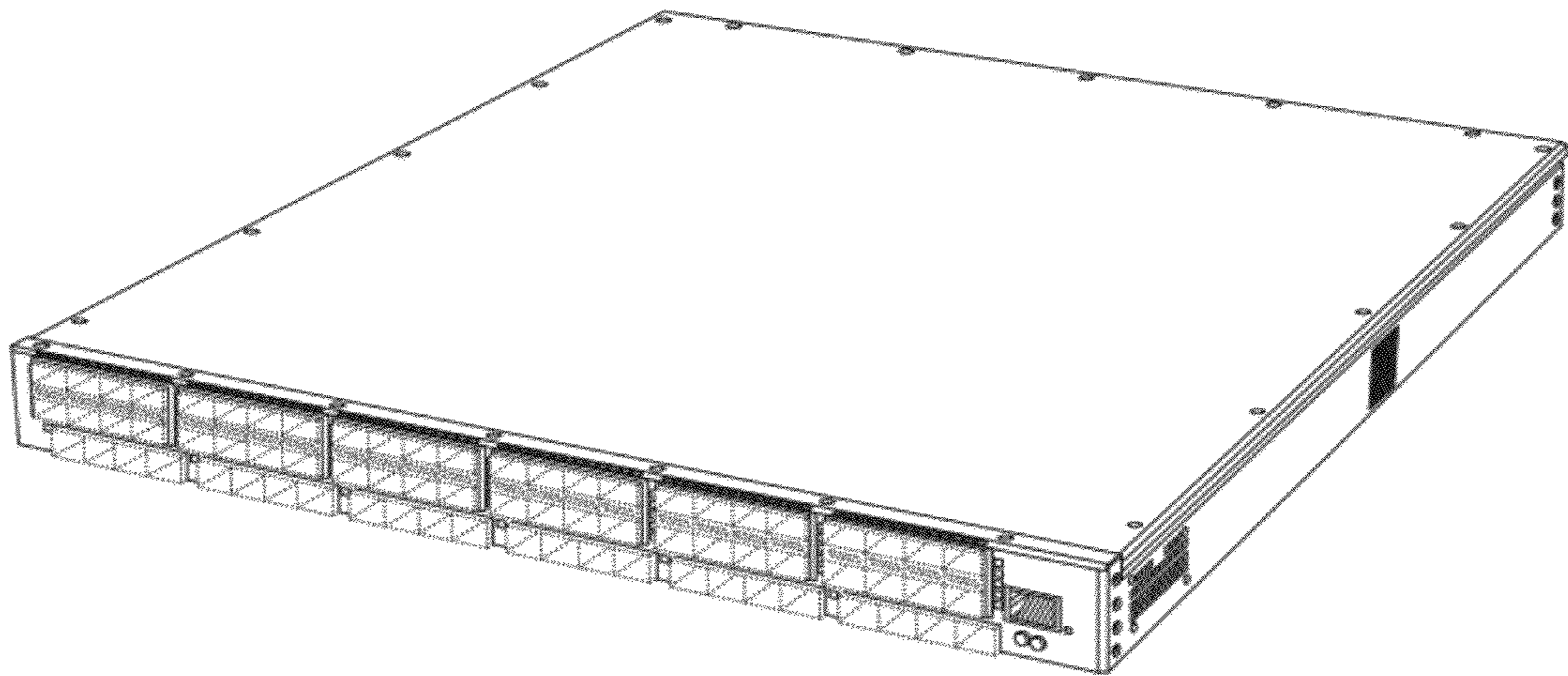

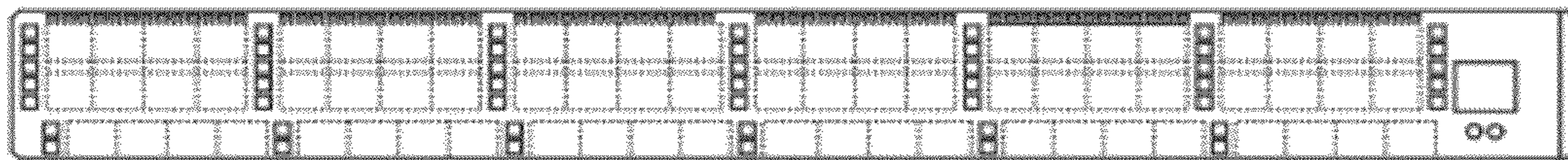

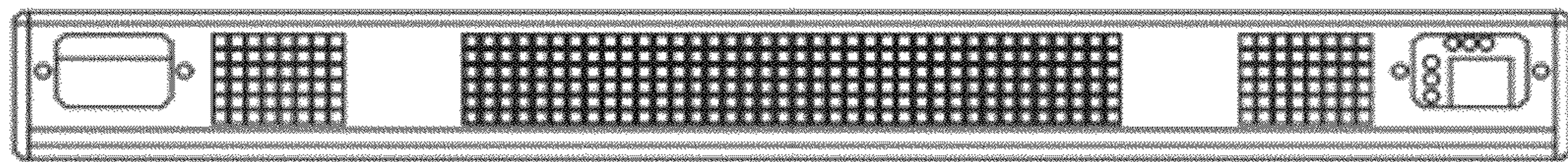

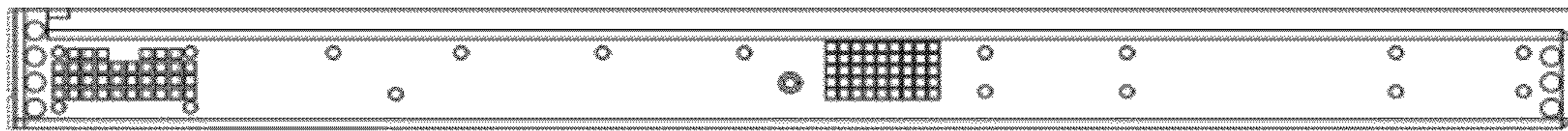

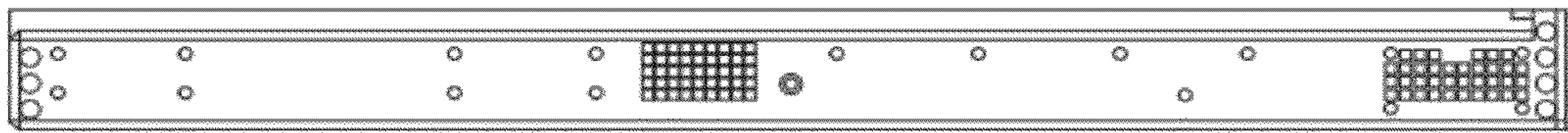

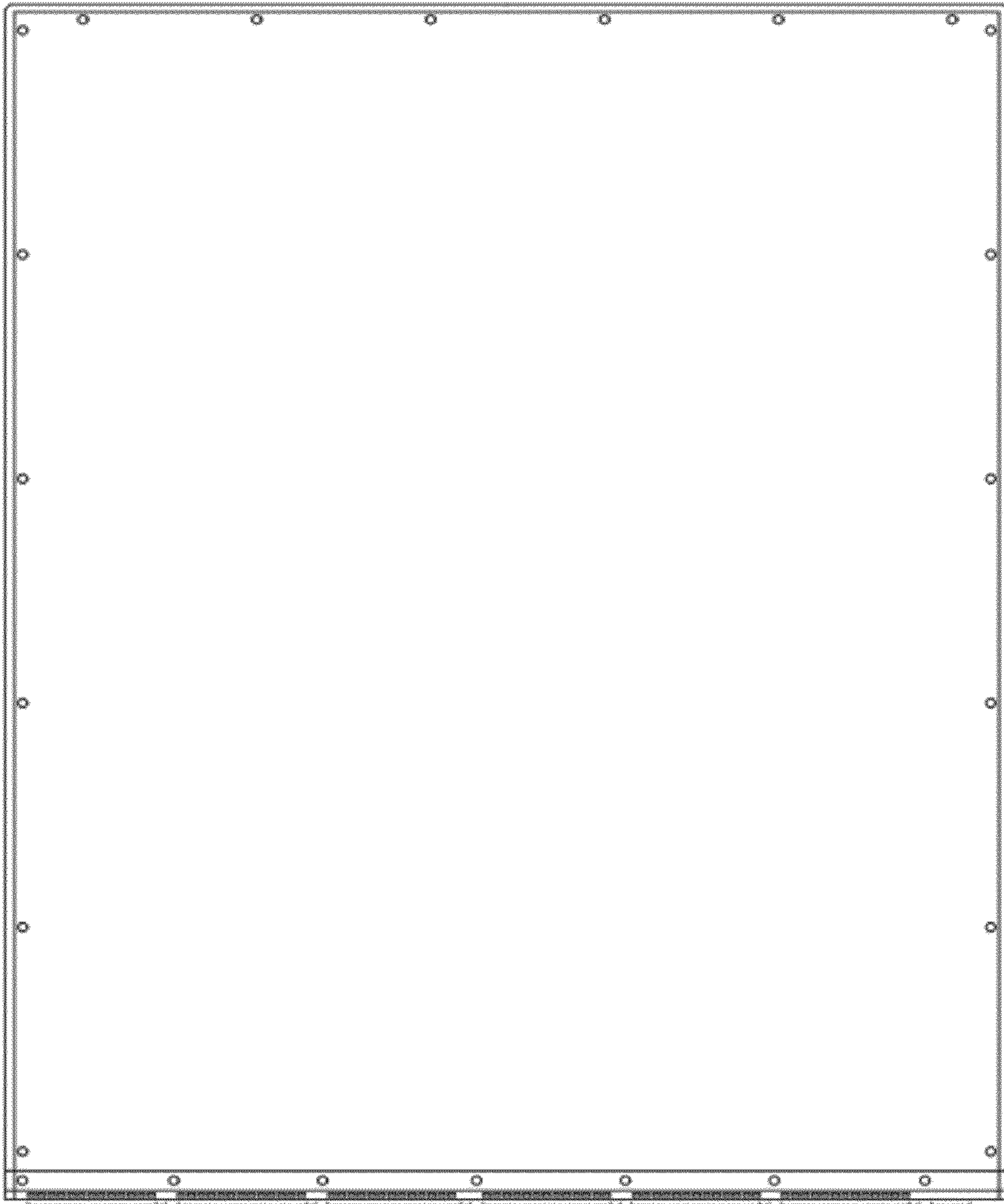

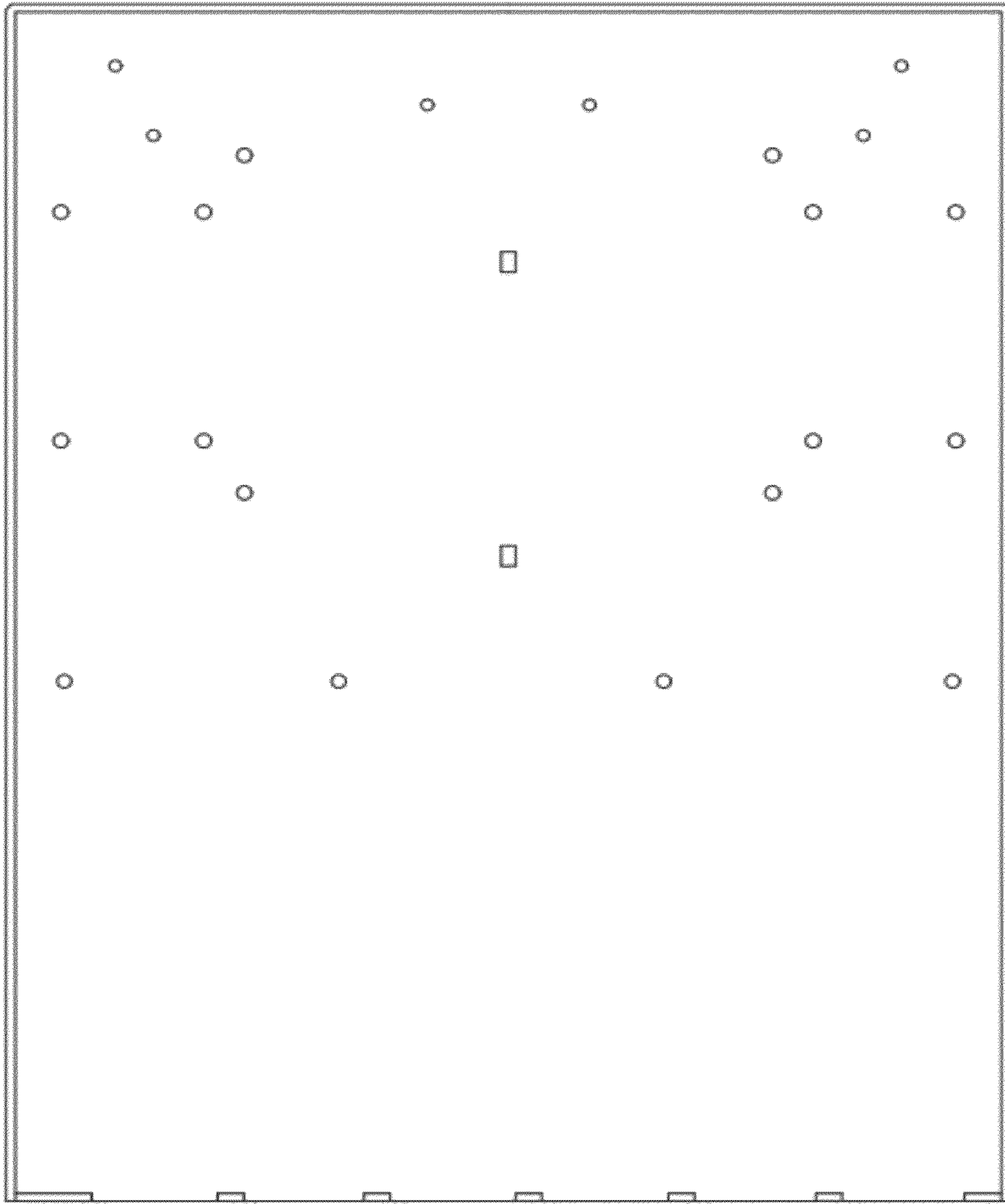
