(57) **CLAIM**

The ornamental design for a hand sign, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a first embodiment of the hand sign according to the invention;

FIG. 2 is a right side elevational view of the hand sign of FIG. 1;

FIG. 3 is a perspective view from below the front of the hand sign of FIG. 2;

FIG. 4 is a perspective view from above the rear of the hand sign of FIG. 2;

FIG. 5 is a top plan view of the hand sign of FIG. 1 with the left side above the right side;

FIG. 6 is a rear elevational view of the hand sign of FIG. 1;

FIG. 7 is a front elevational view of the hand sign of FIG. 1;

FIG. 8 is a bottom plan view of the hand sign of FIG. 1 with the right side above the left side;

FIG. 9 is a right side elevational view of a second embodiment of the hand sign according to the invention;

FIG. 10 is a left side elevational view of the hand sign of FIG. 9;

FIG. 11 is a perspective view from below the front of the hand sign of FIG. 10;

FIG. 12 is a perspective view from above the rear of the hand sign of FIG. 10;

FIG. 13 is a top plan view of the hand sign of FIG. 9 with the right side above the left side;

FIG. 14 is a front elevational view of the hand sign of FIG. 9;

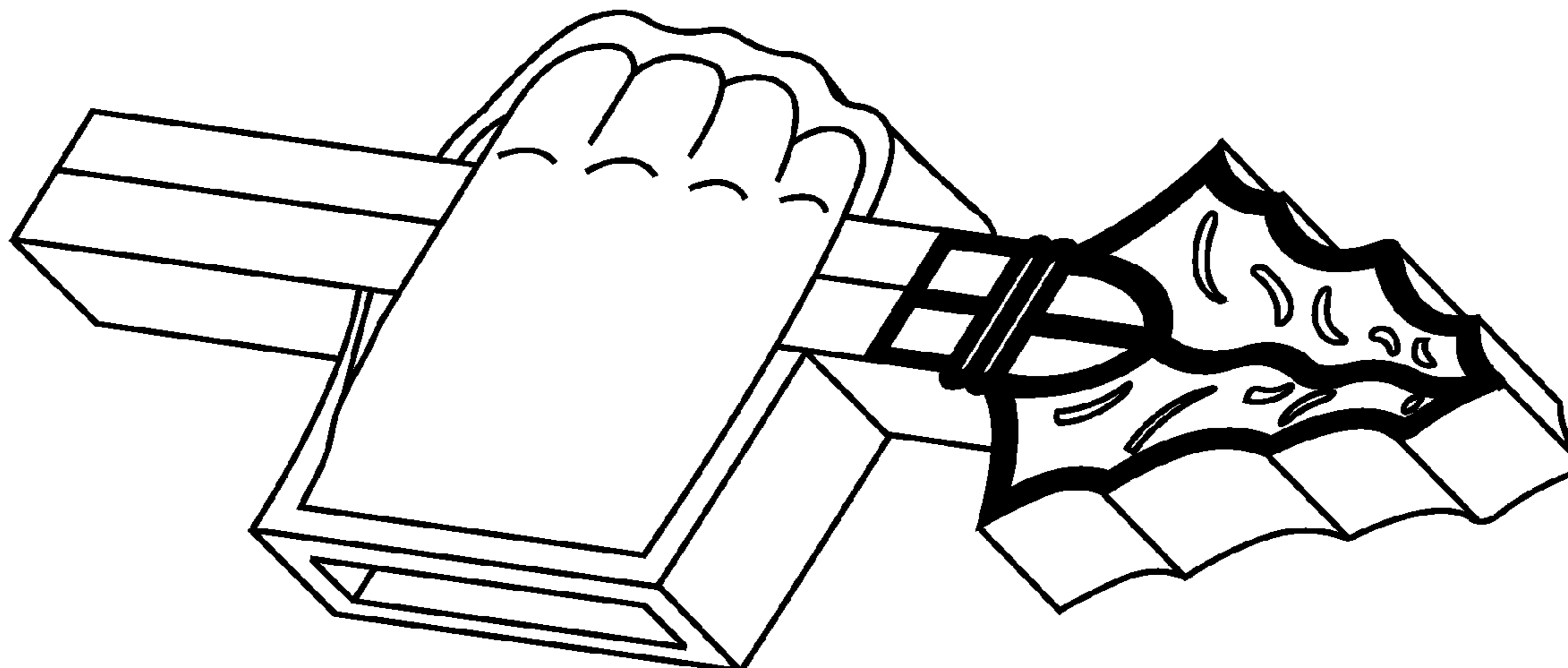
FIG. 15 is a rear elevational view of the hand sign of FIG. 9;

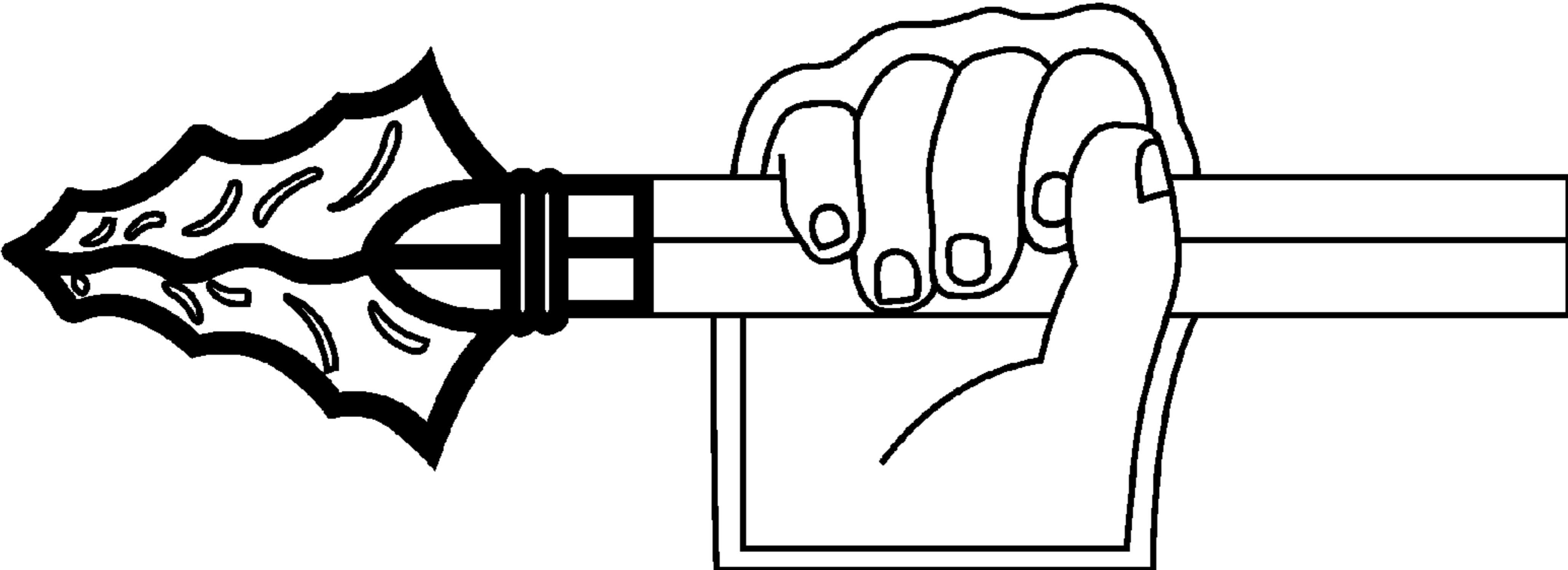

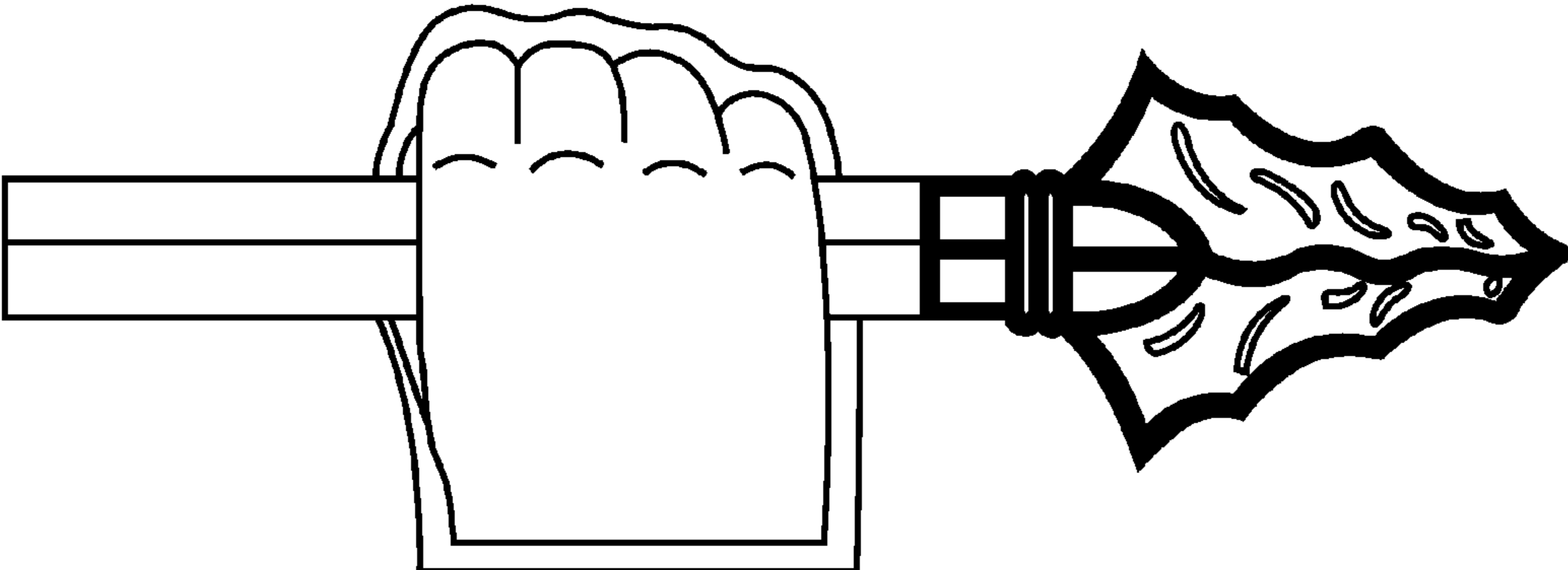

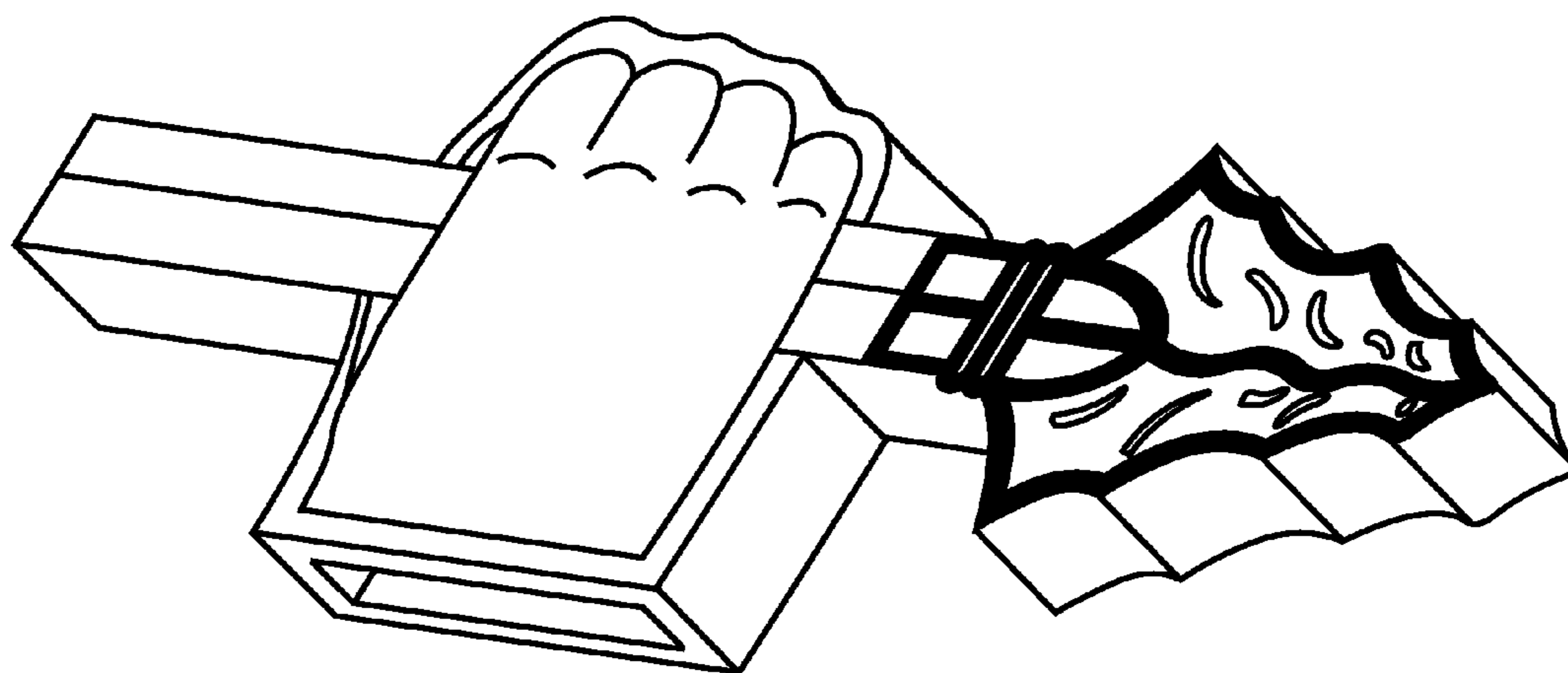

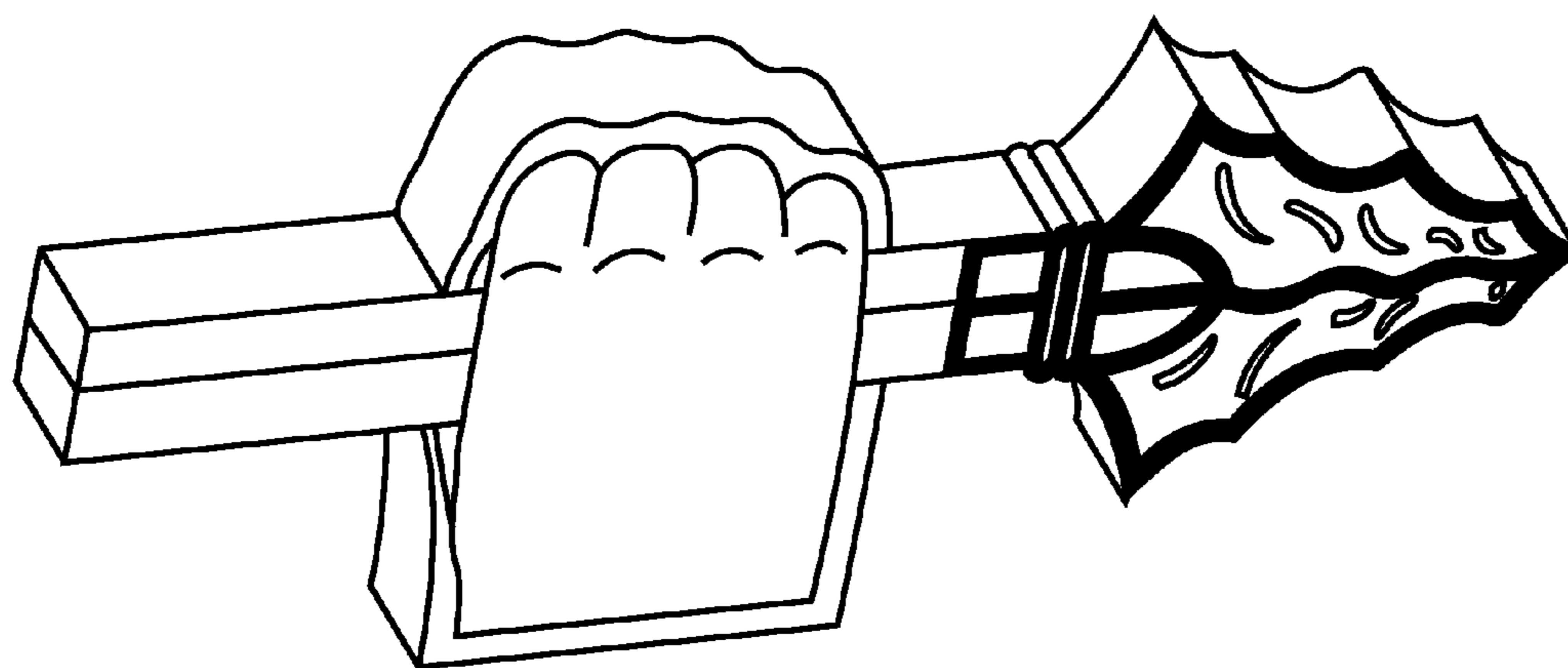

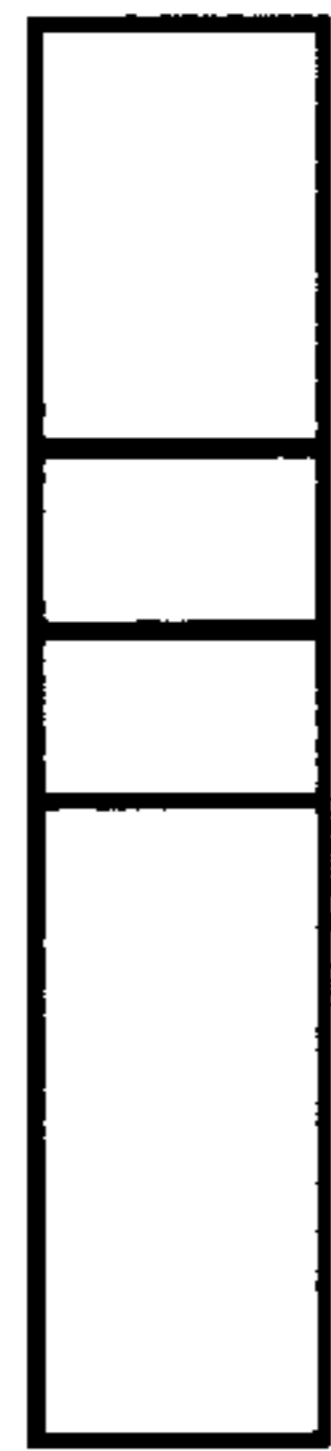

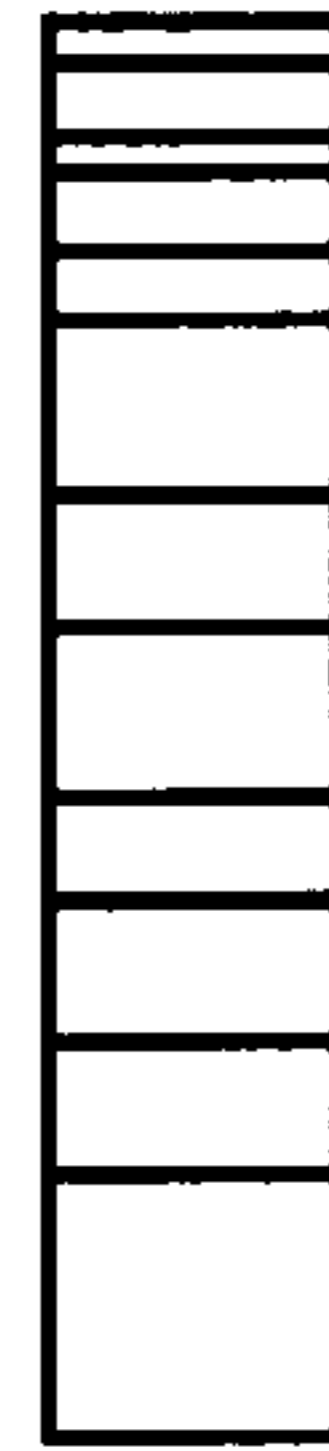

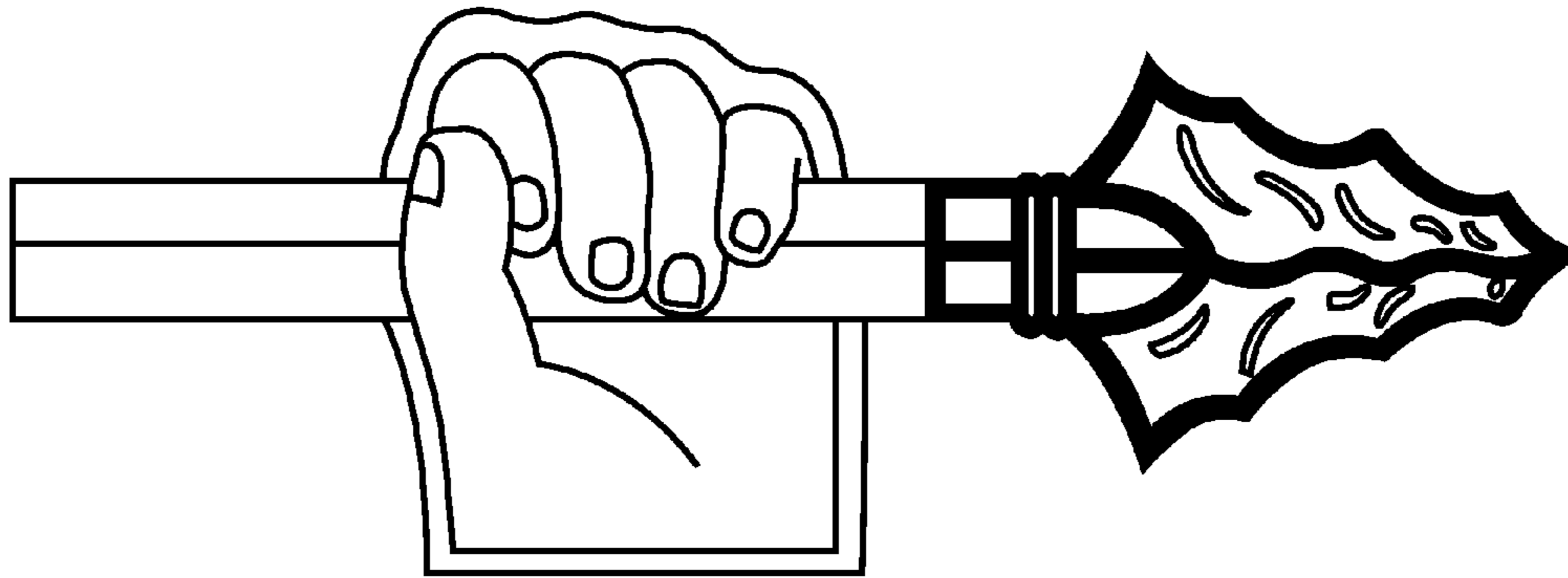

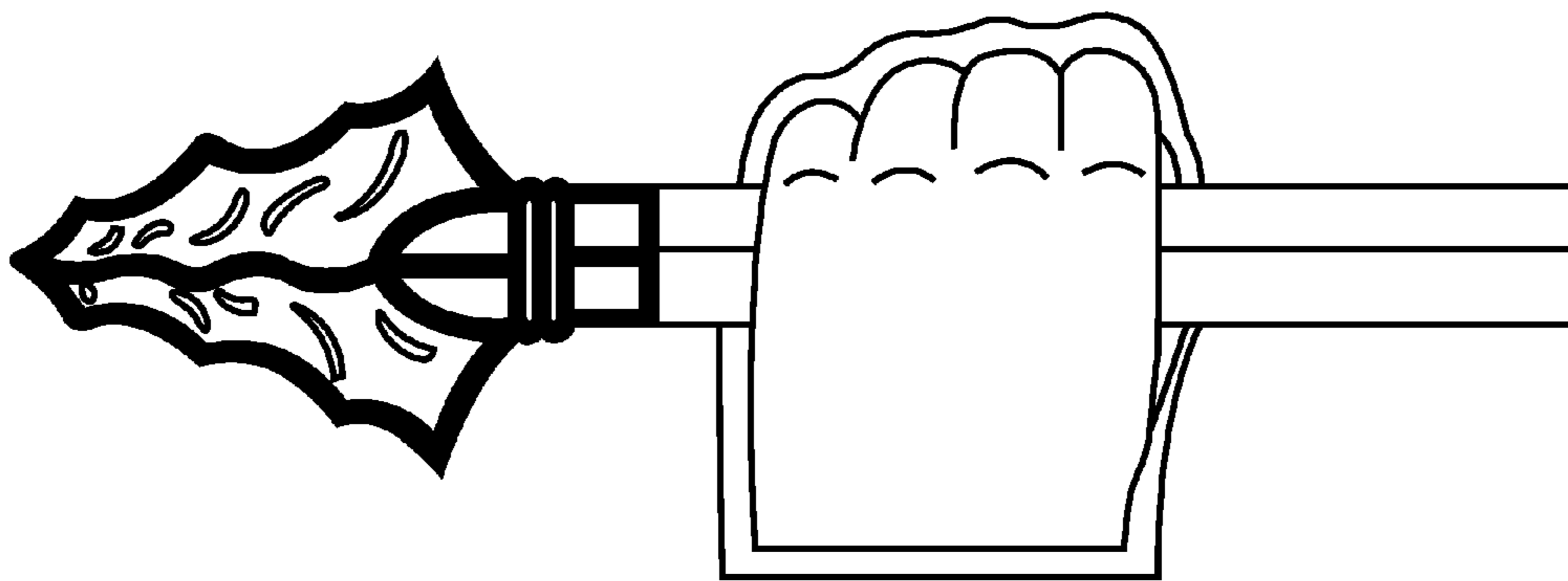

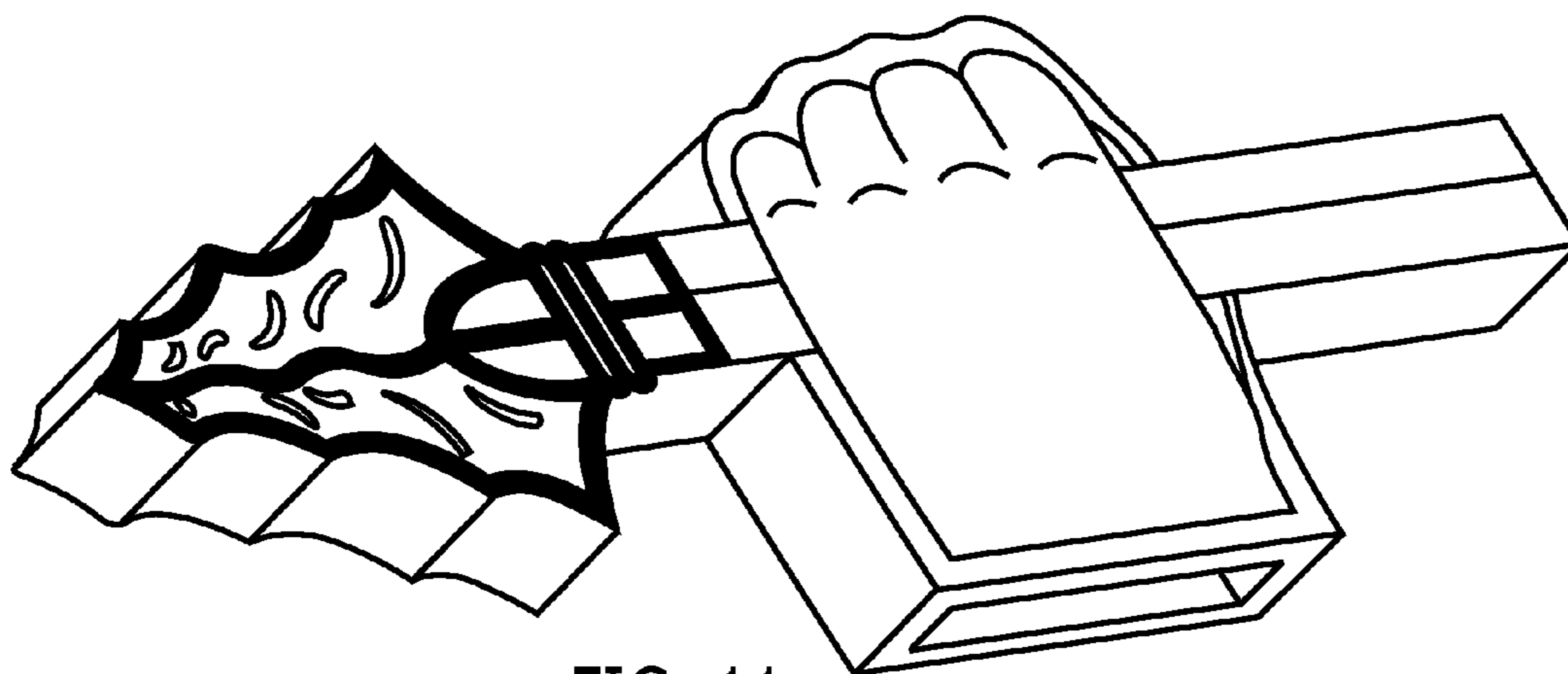

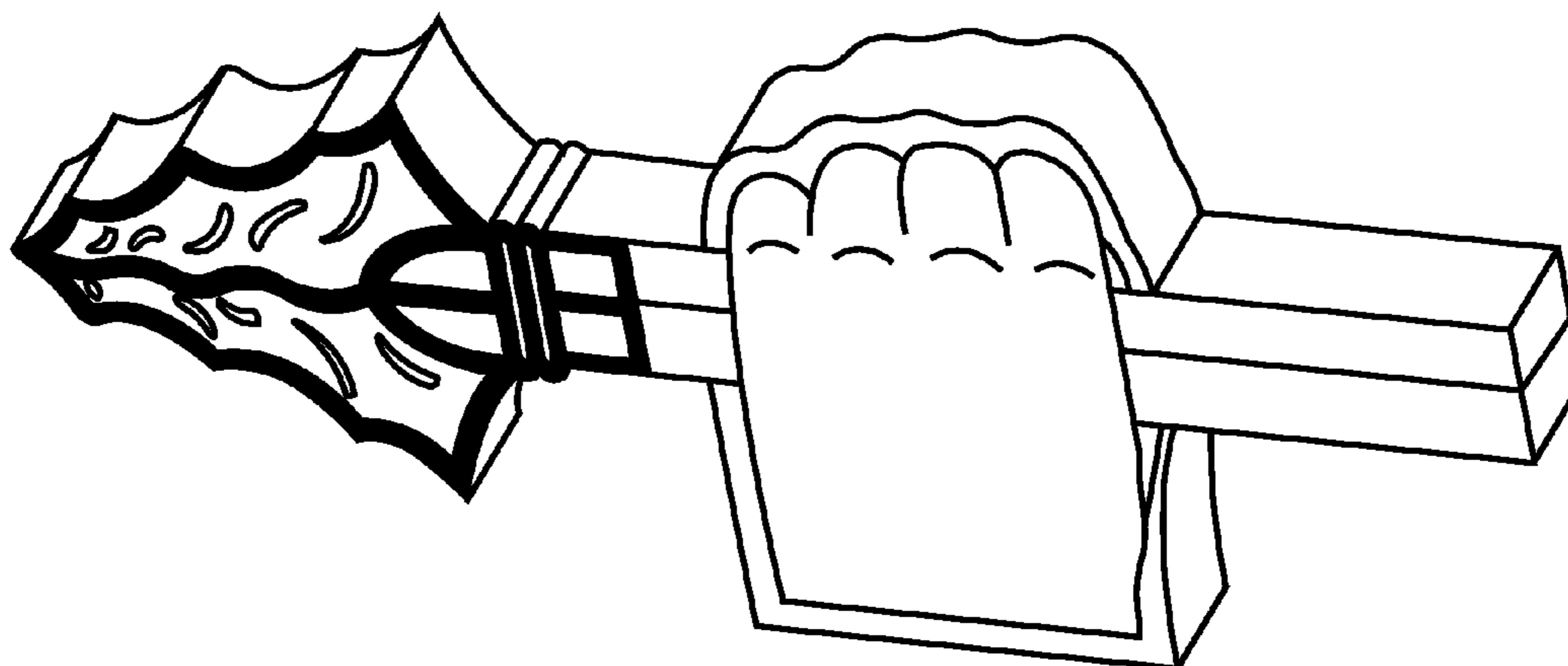

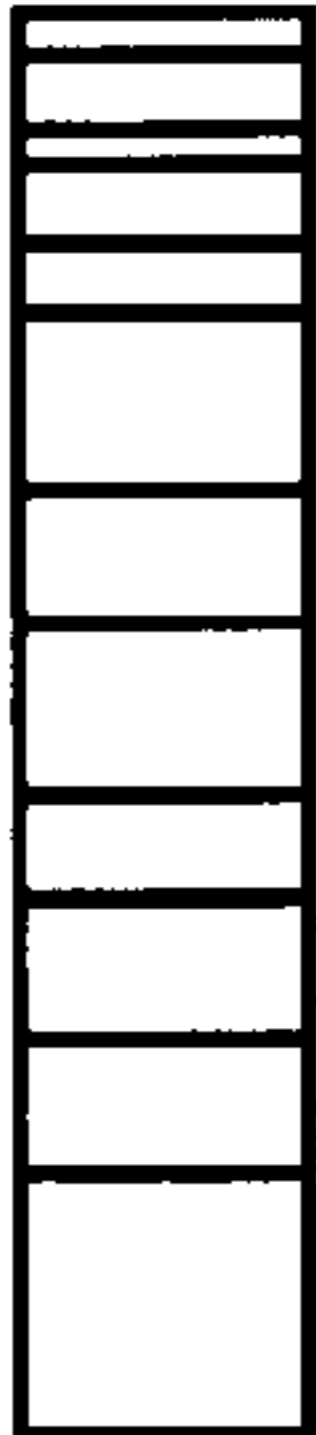
