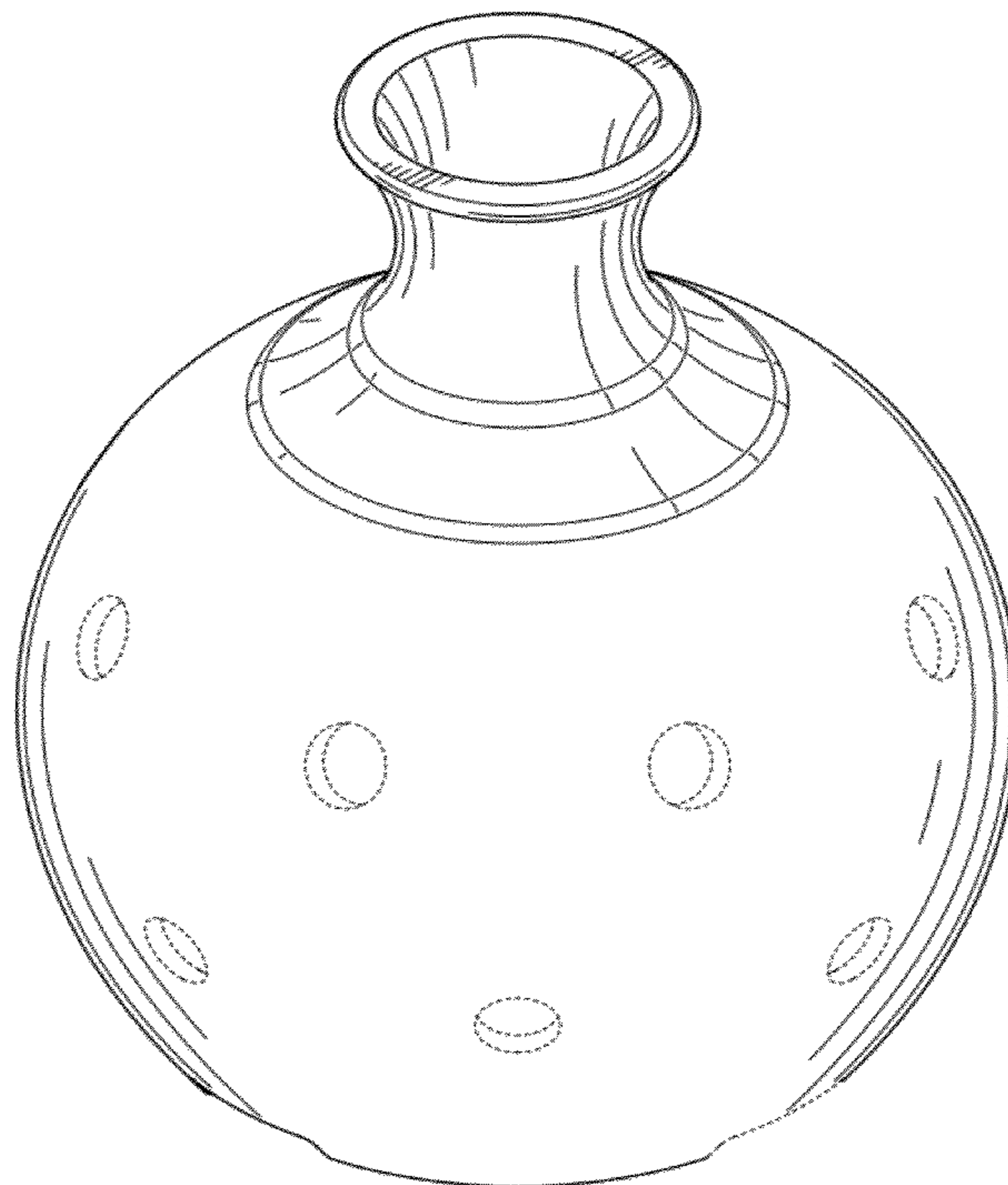
(57) **CLAIM**

The ornamental design for a cover for light and/or fragrance emitter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cover for light and/or fragrance emitter showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a left side view thereof, the right side view being a mirror image thereof;
FIG. 4 is a back view thereof;
FIG. 5 is a top view thereof; and,

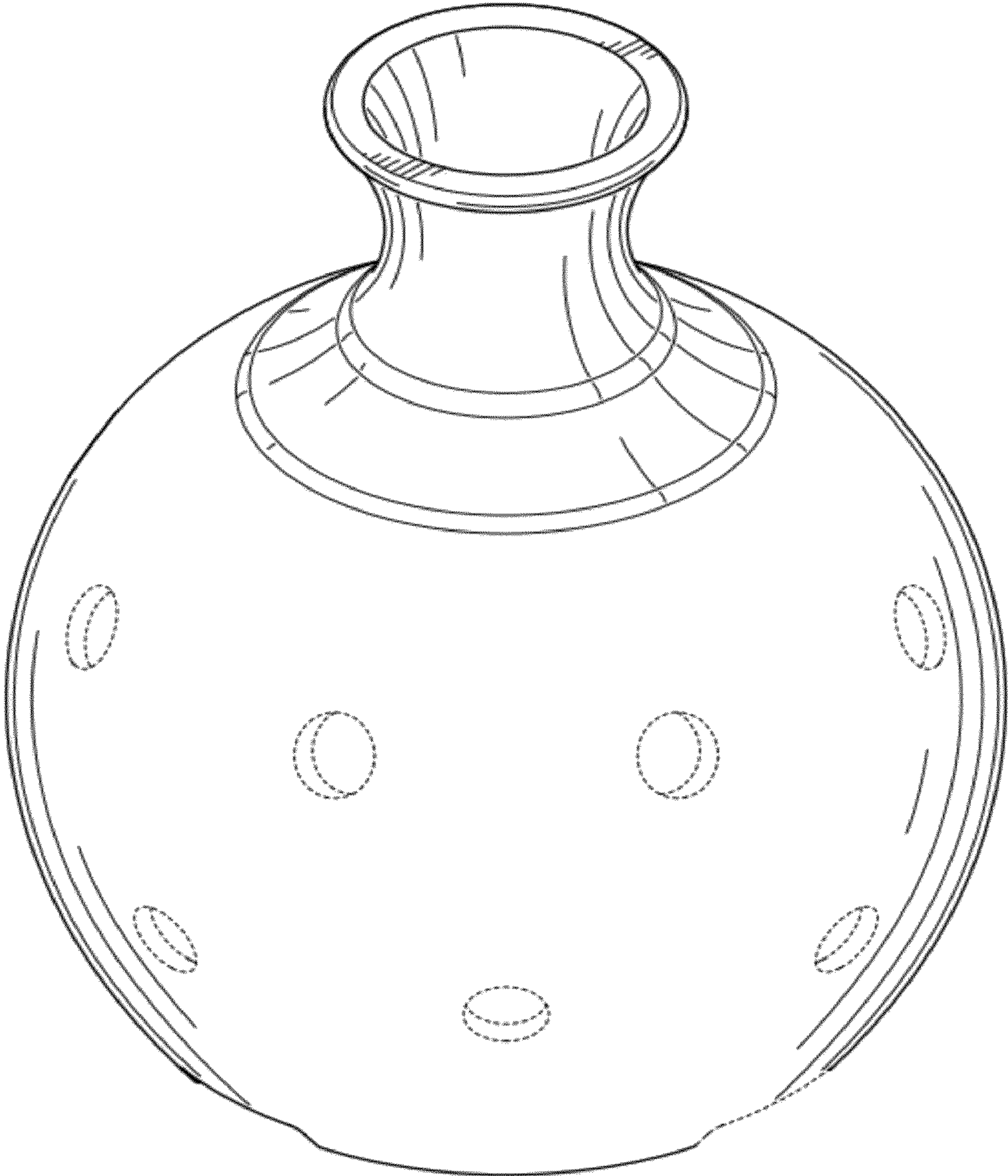

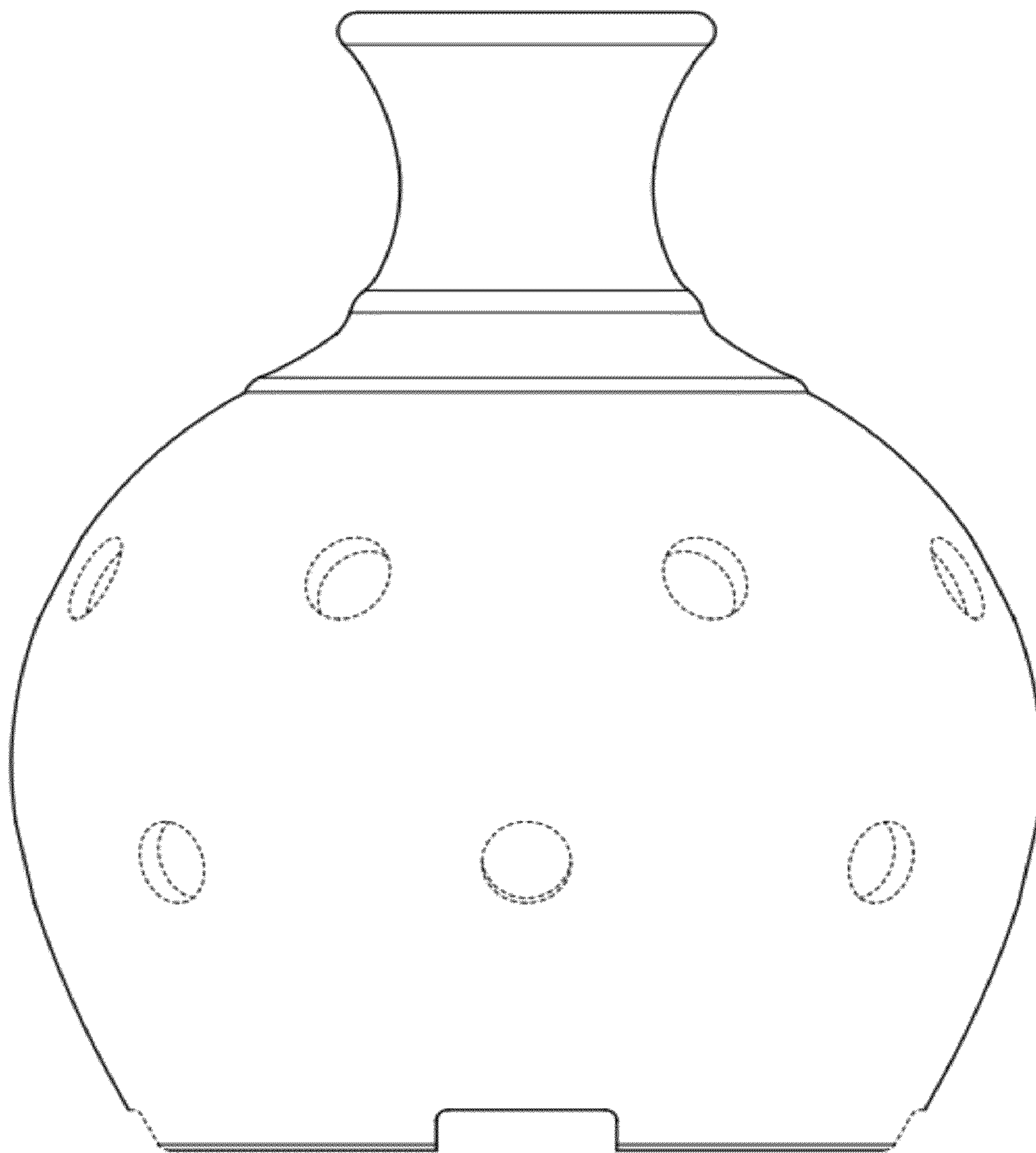

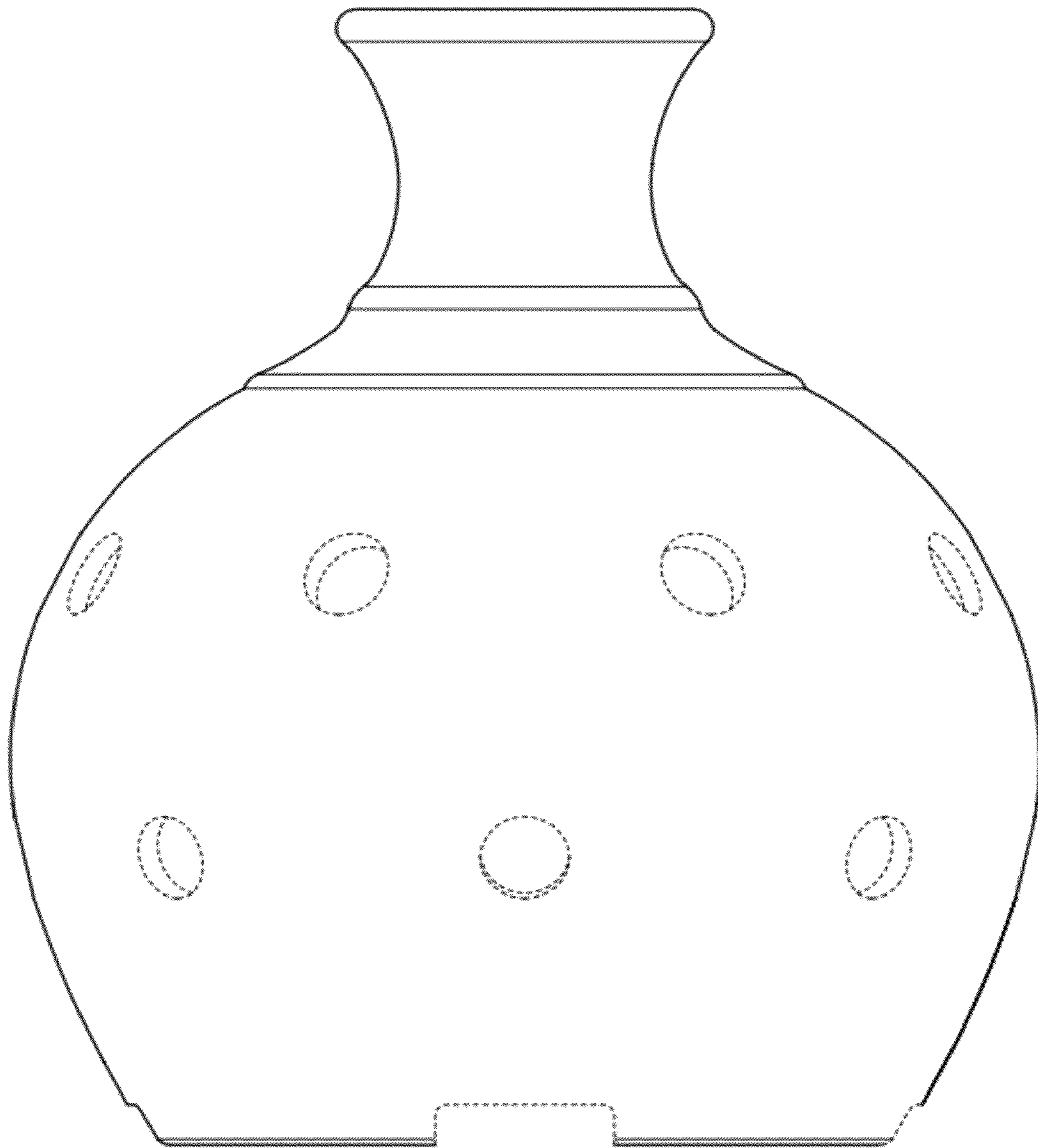

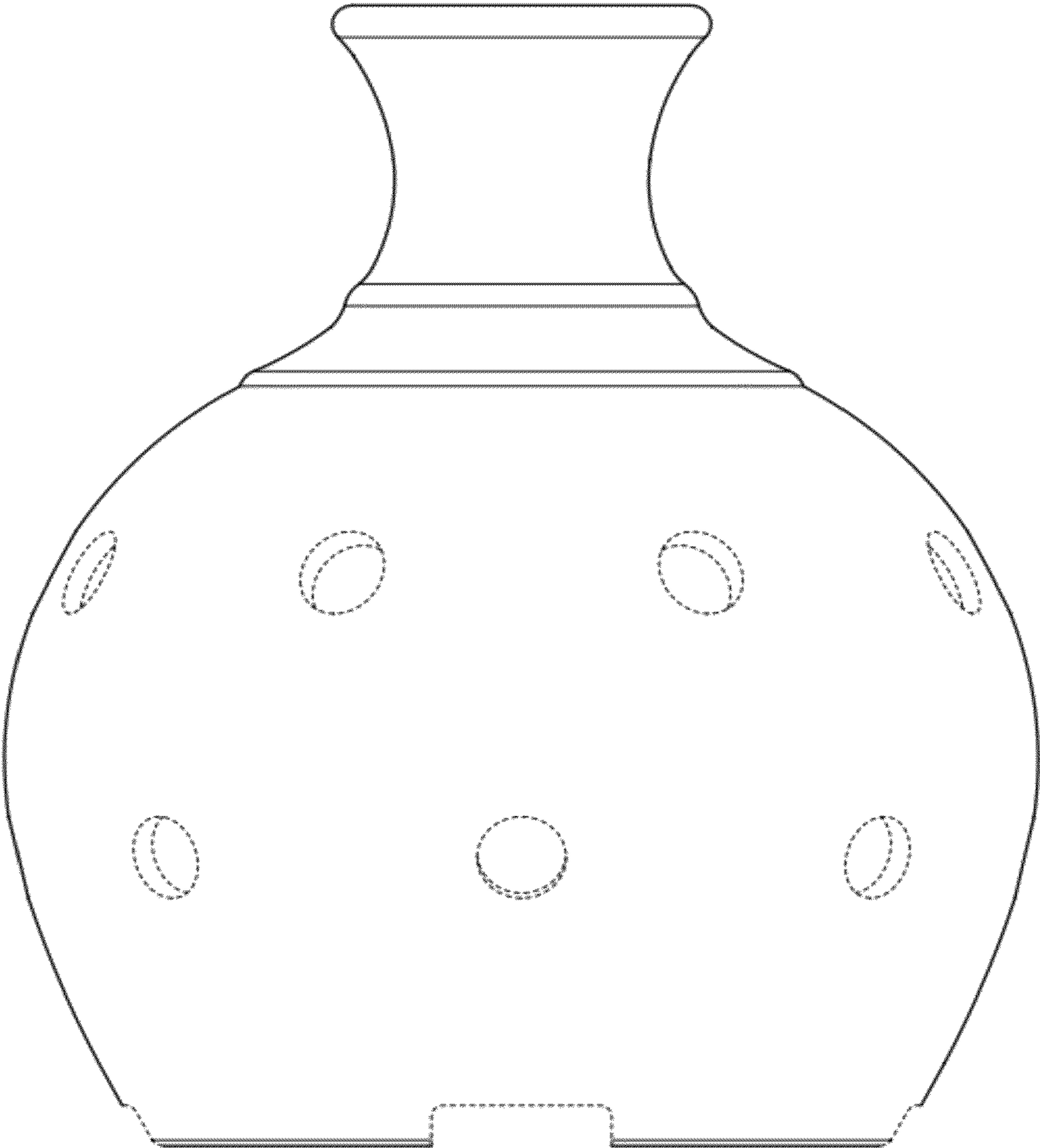

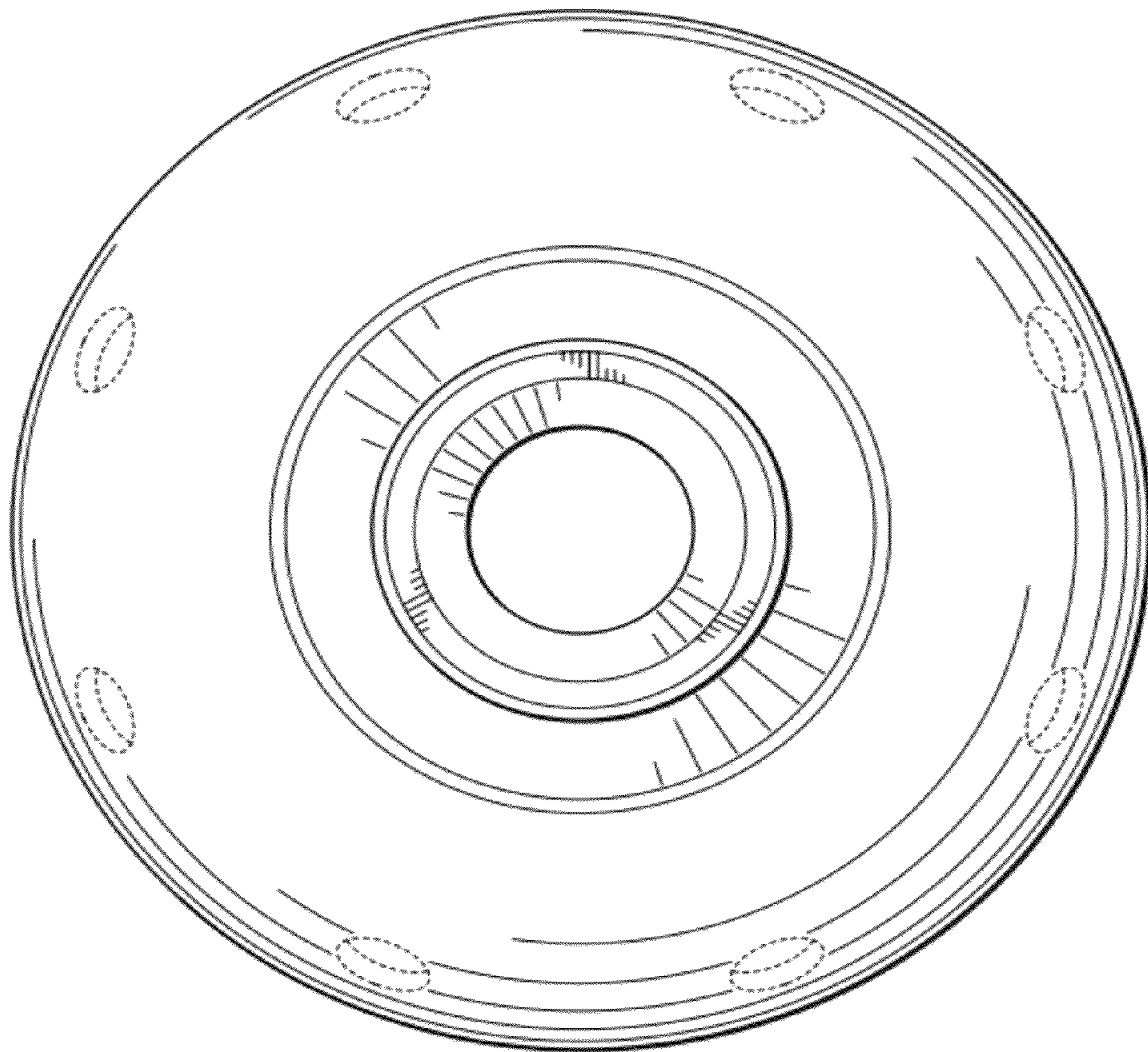

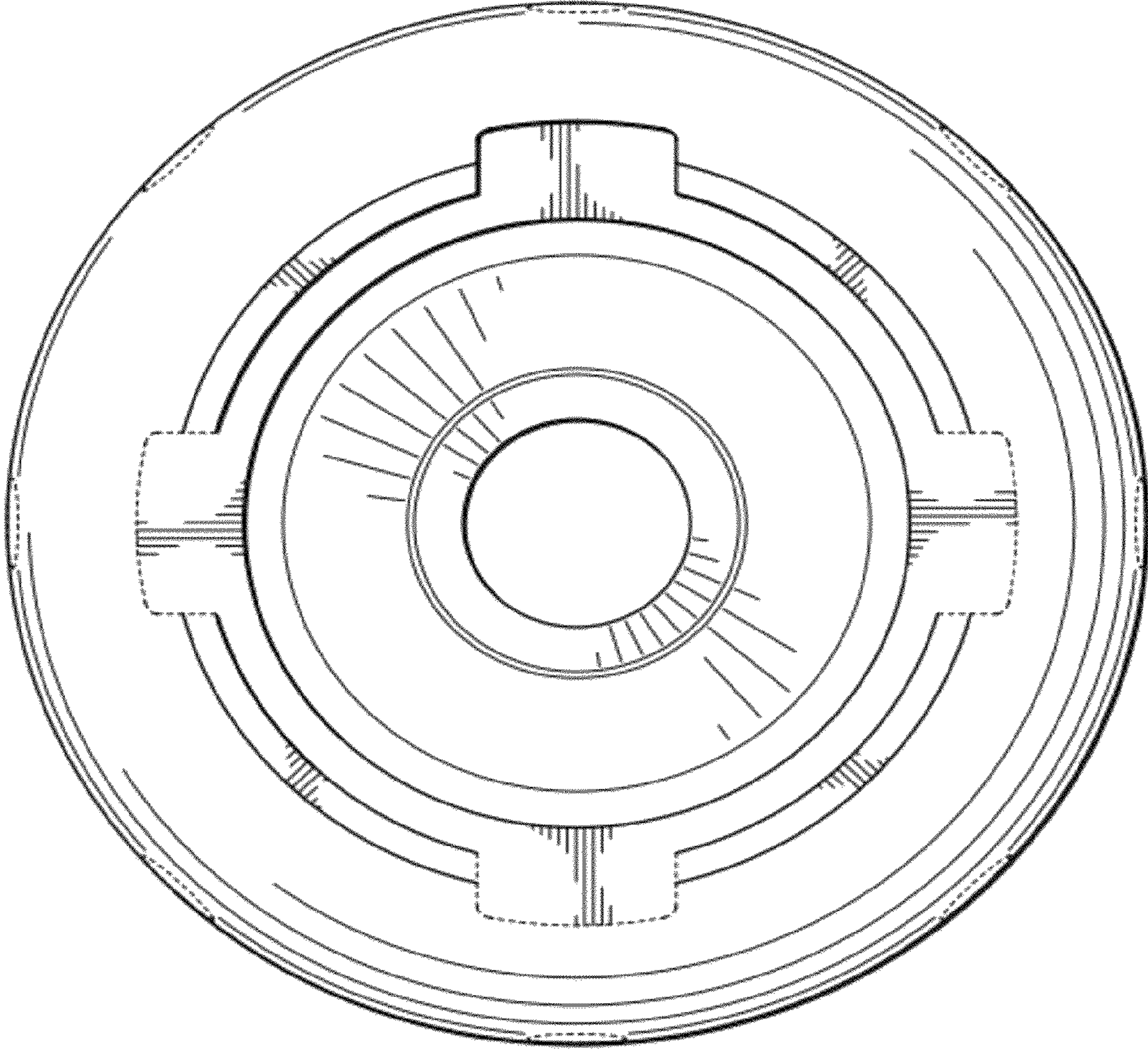
