(57) **CLAIM**

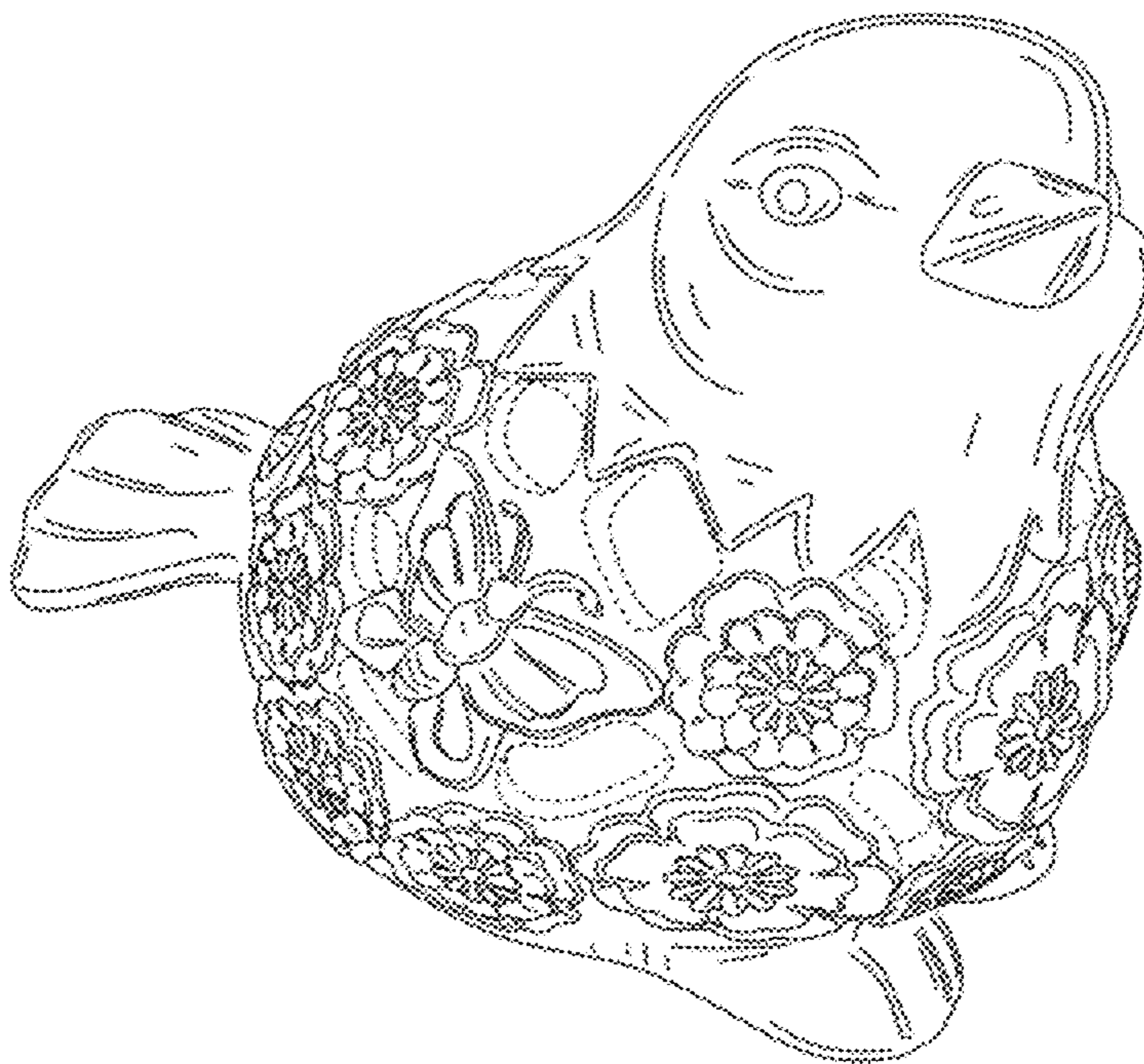
The ornamental design for a cover for light and/or fragrance emitter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cover for light and/or fragrance emitter showing my new design;

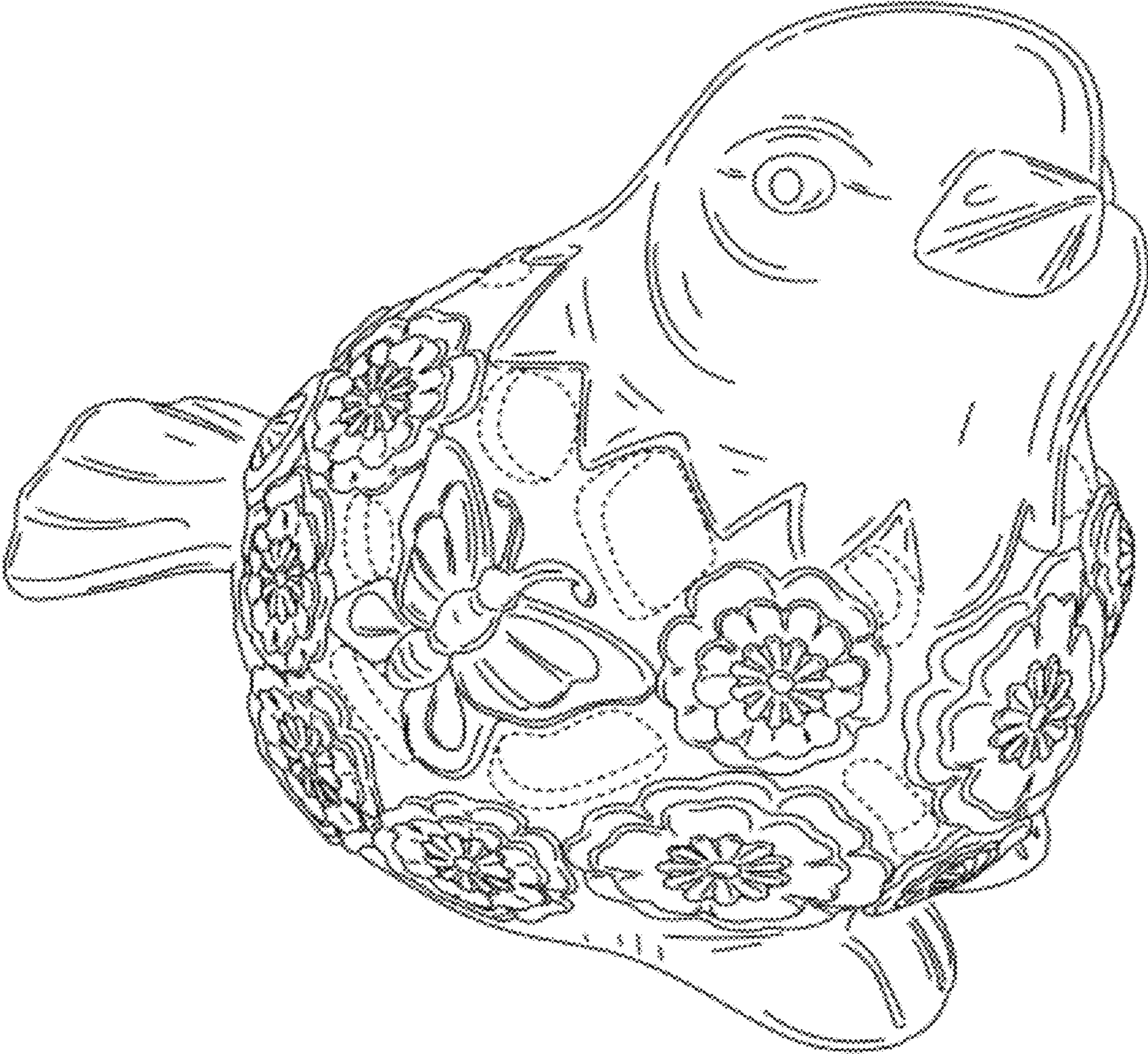

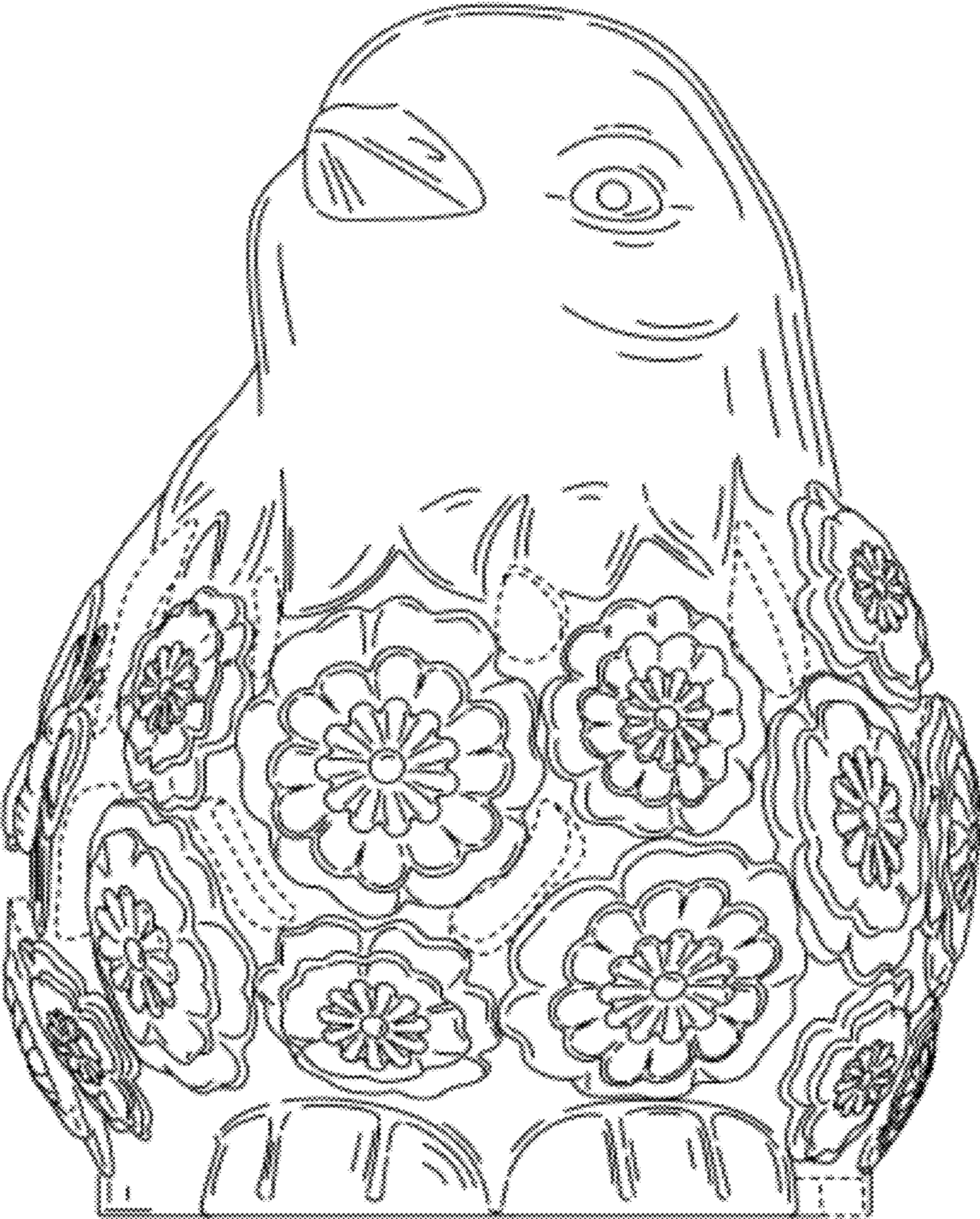

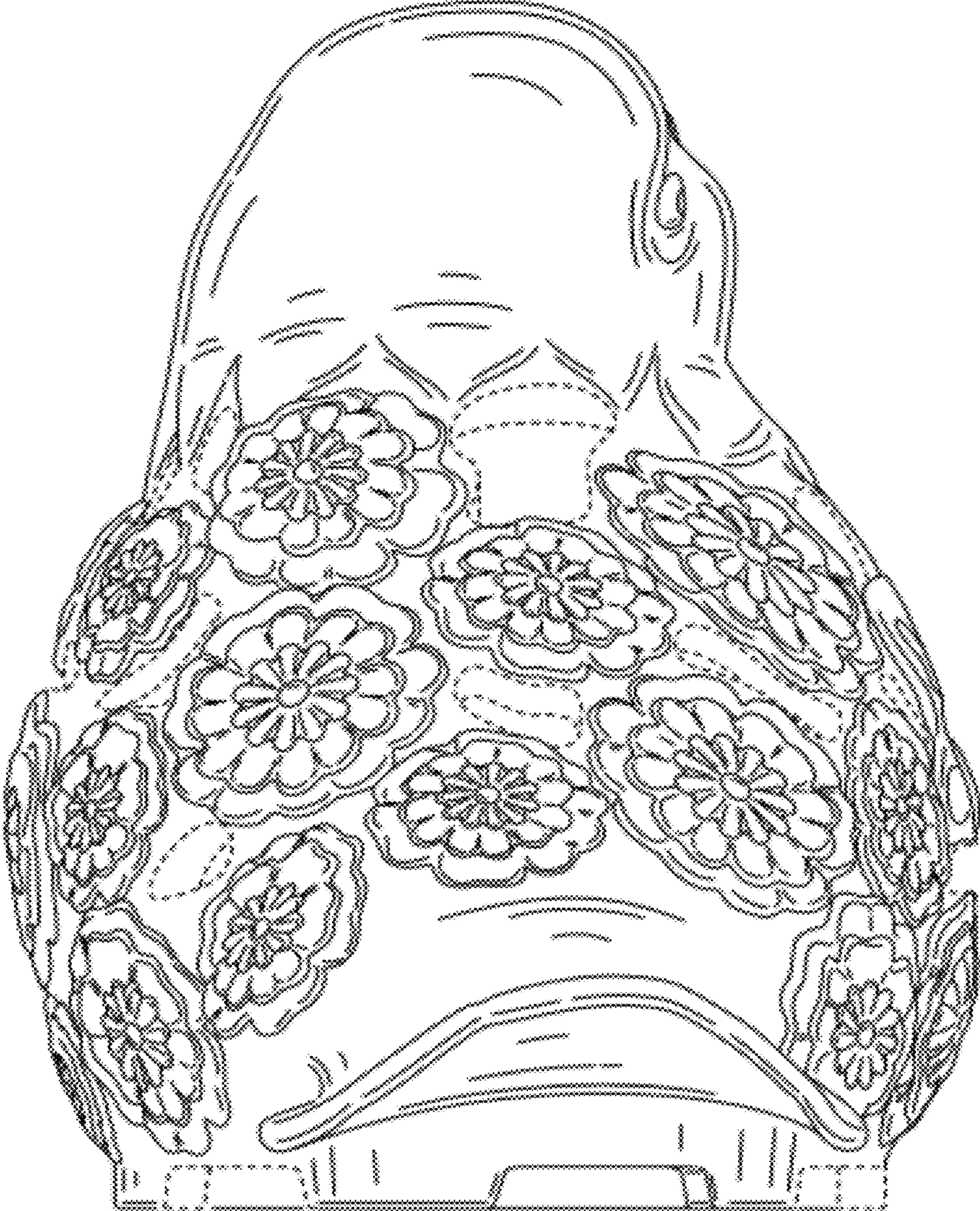

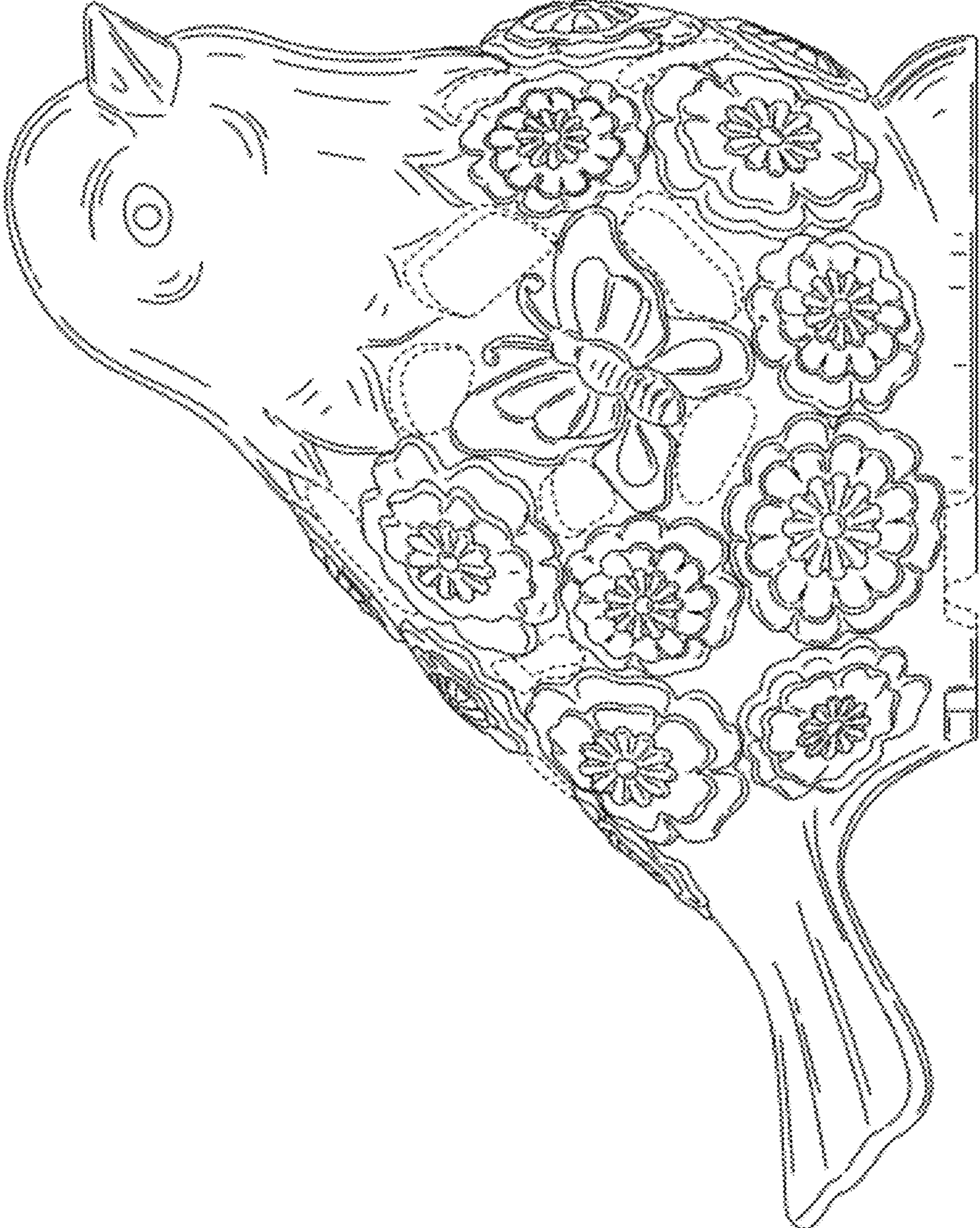

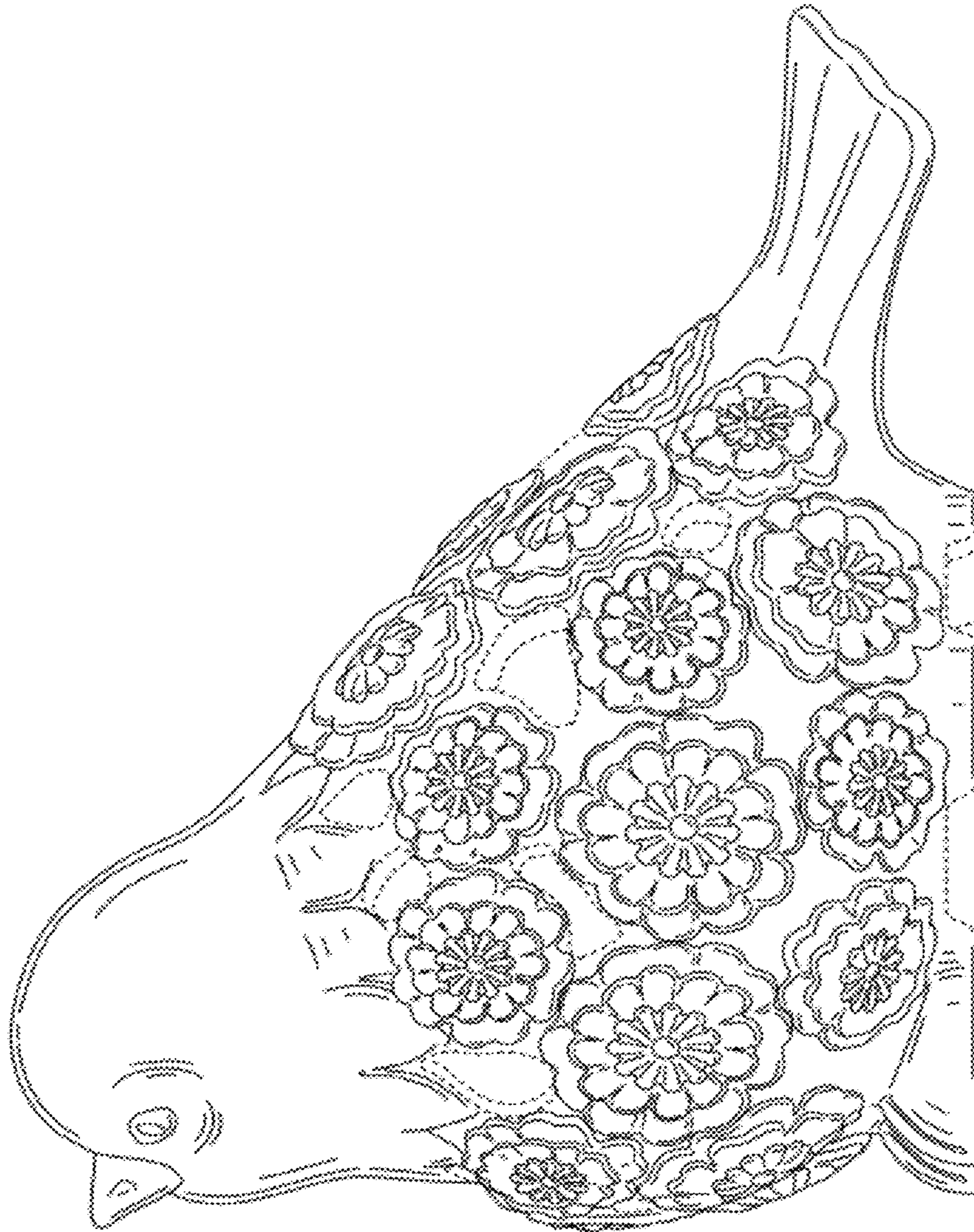

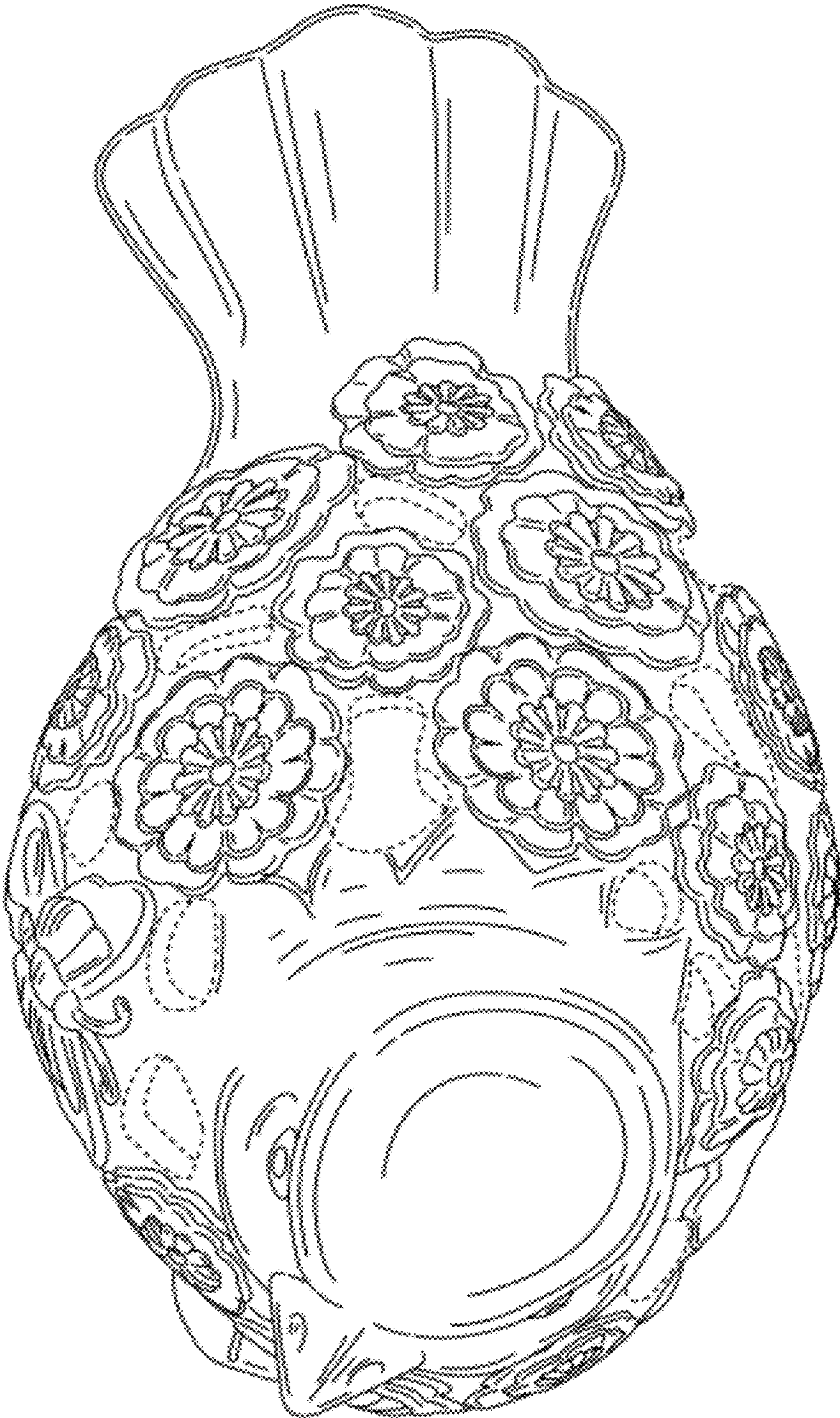

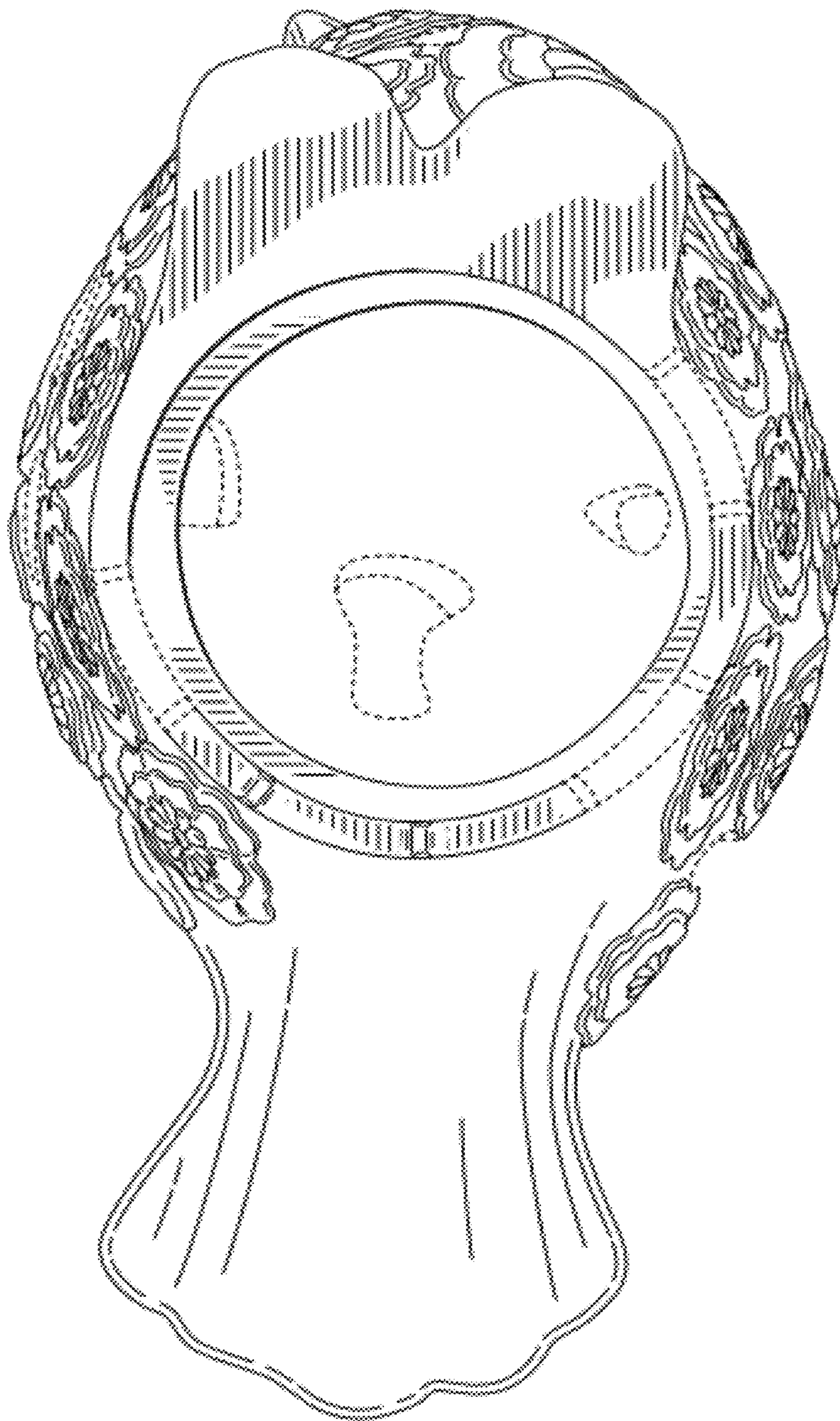
