The ornamental design for a sheet of eyelash stickers, as shown and described.

**DESCRIPTION**

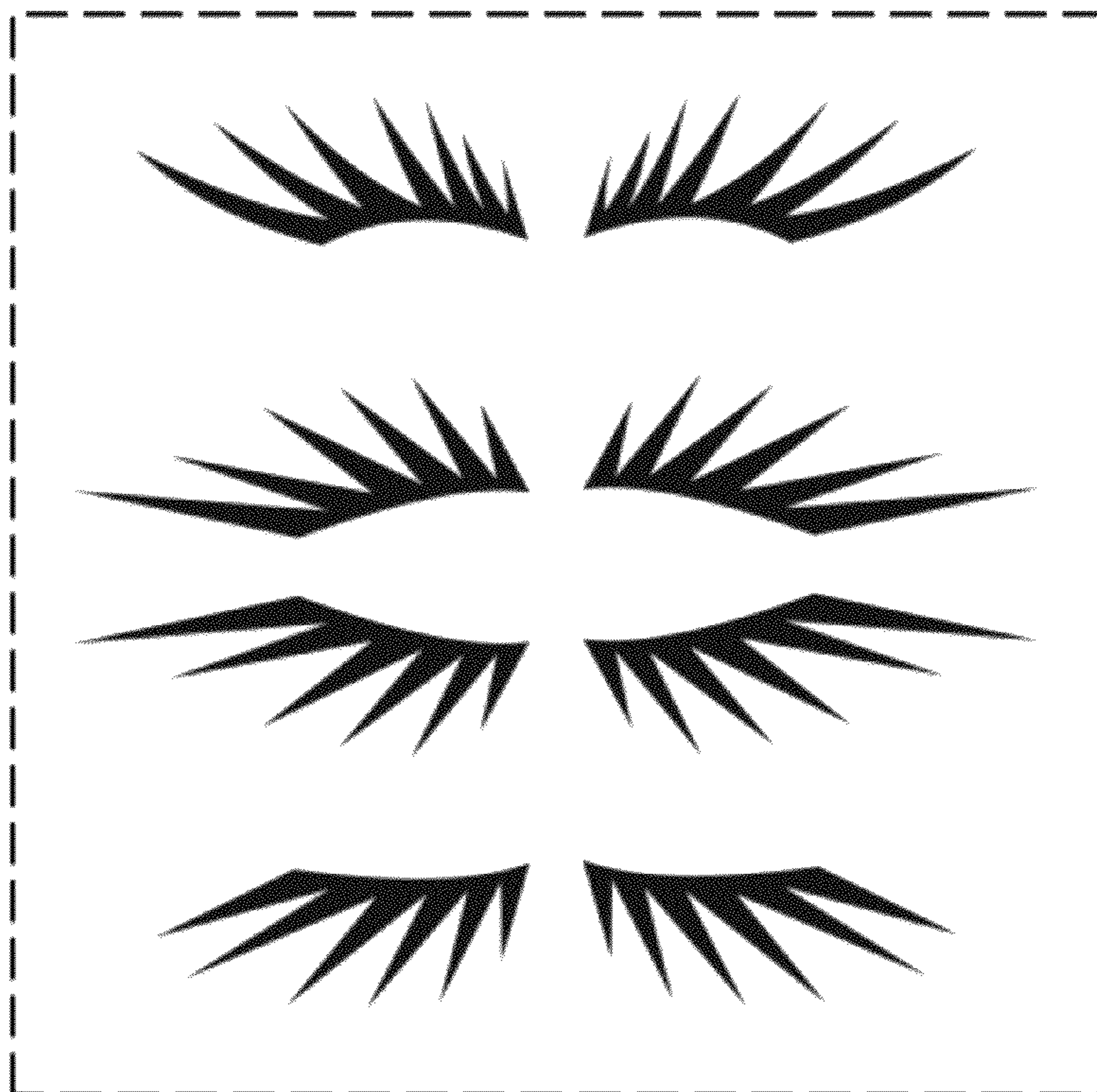
FIG. 1 is a top plan view of a sheet of eyelash stickers showing my new design.

FIG. 2 is a front elevation view showing an environmental application of two of the eyelash stickers; and,

FIG. 3 is an additional top plan view showing my design of a sheet of eyelash stickers.

The broken lines indicating the sheet, the eye, the overpaint and the text elements are shown to illustrate the environment and form no part of the design.

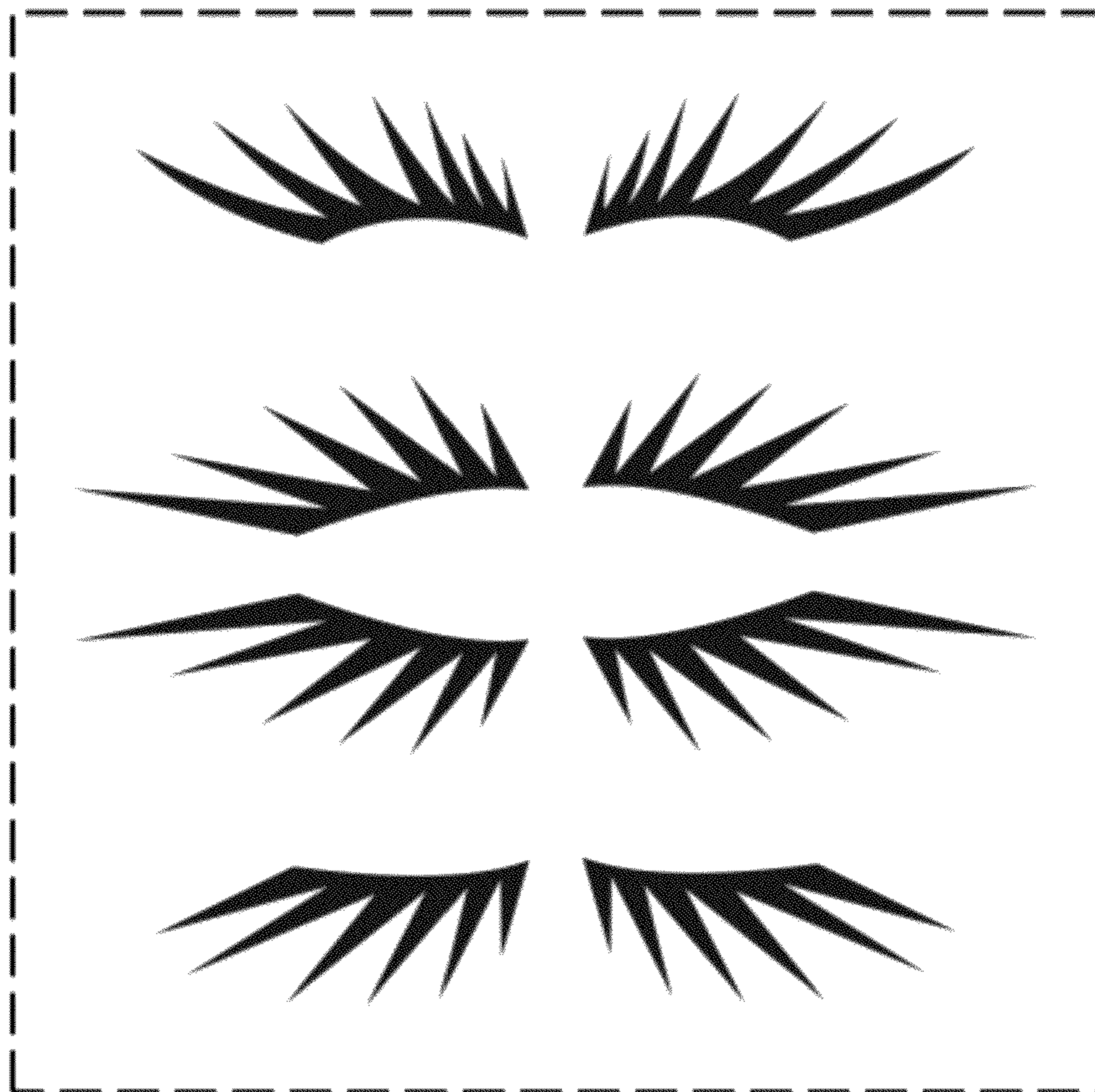

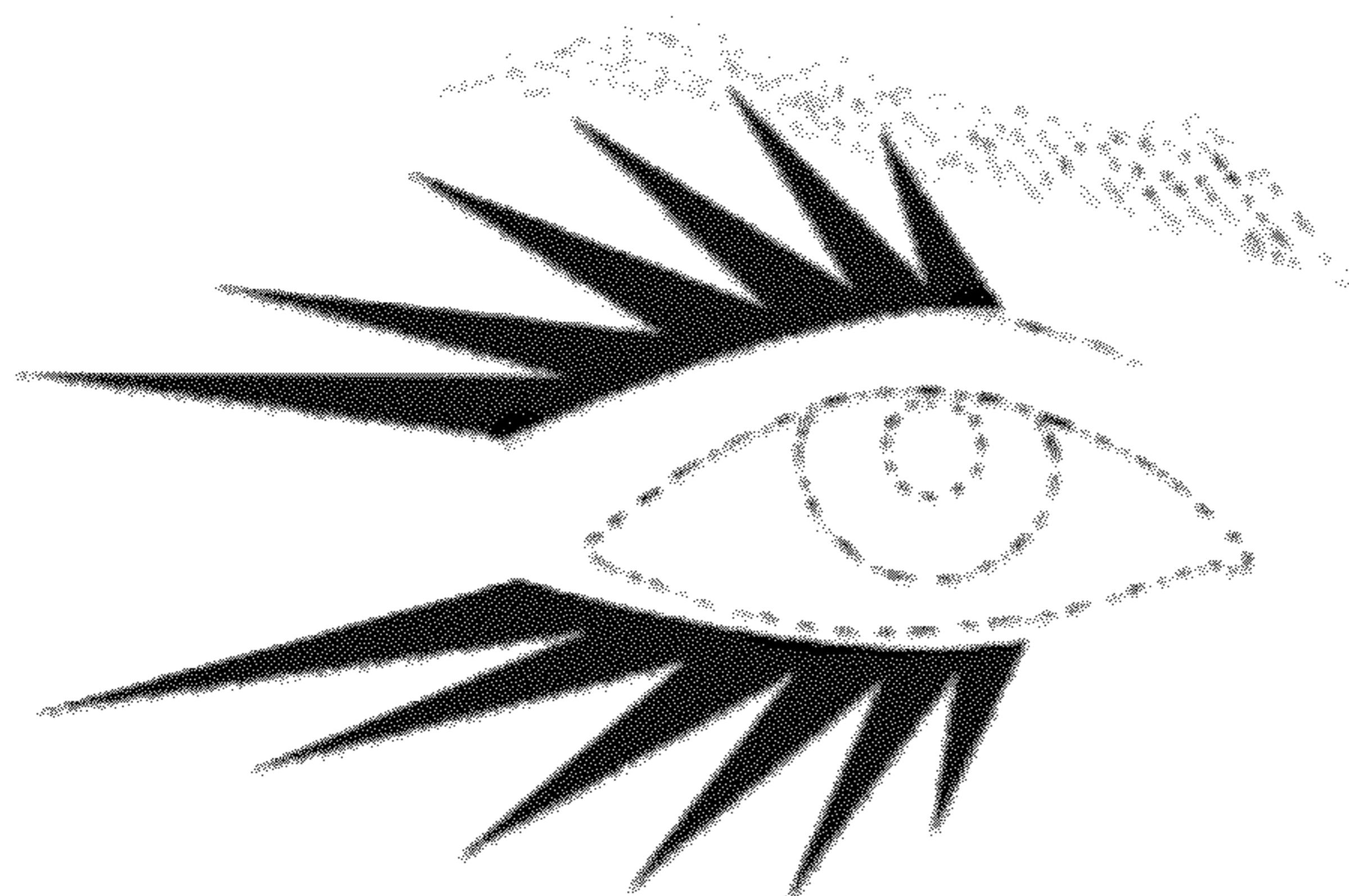

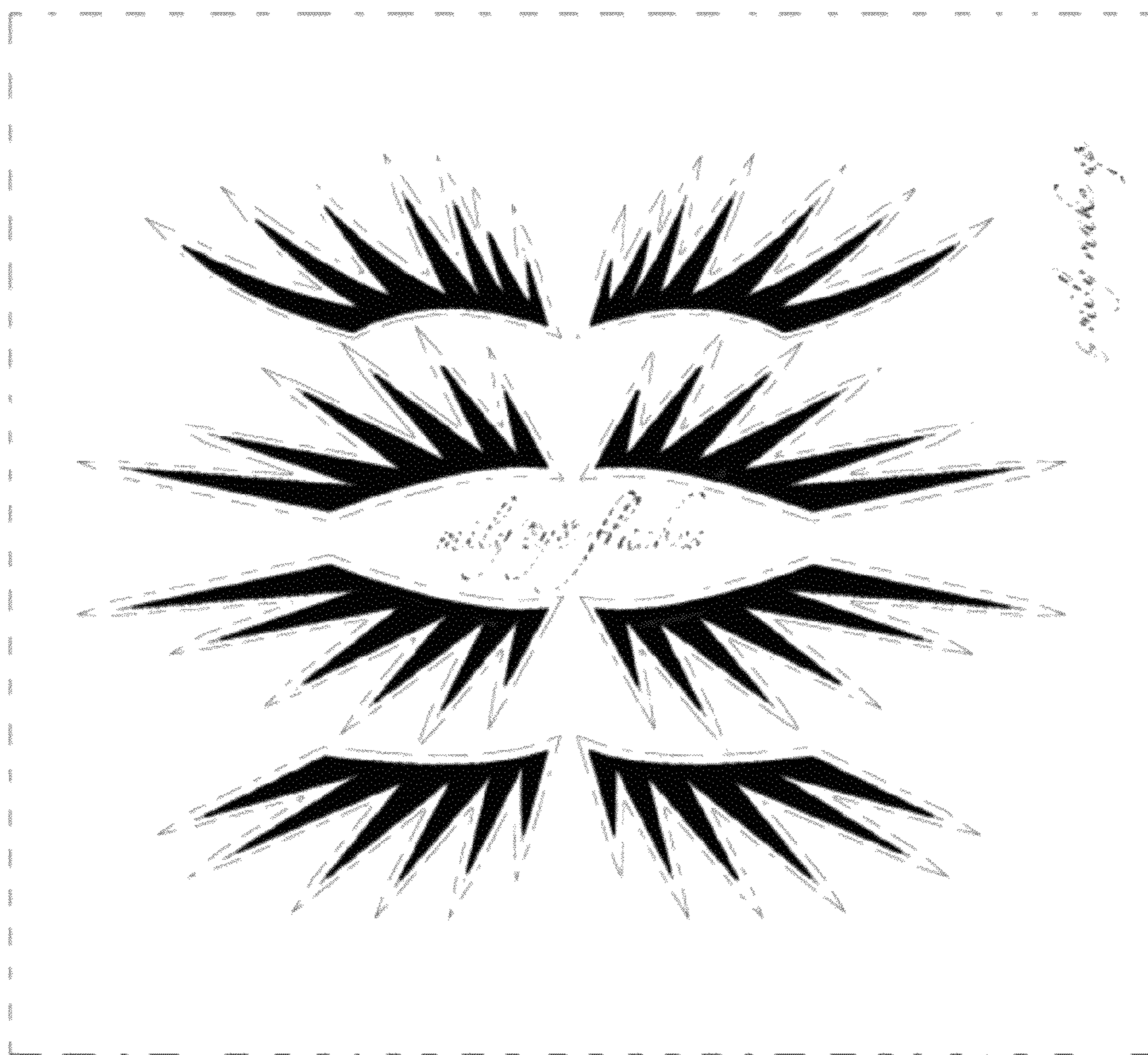
