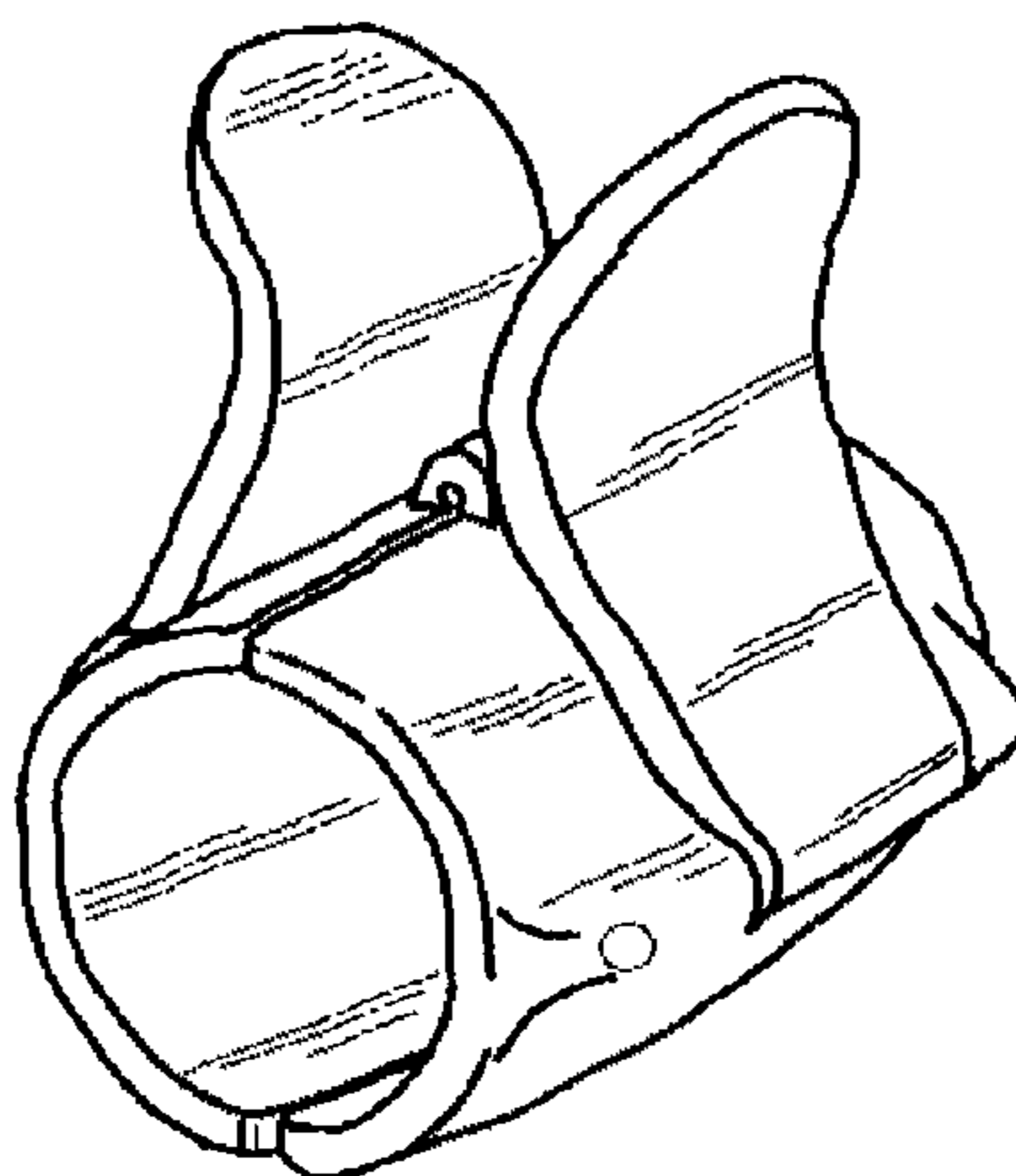
(57) **CLAIM**

The ornamental design for a clip for producing pinch-induced behavioral response, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a clip for producing pinch-induced behavioral response showing our new design; FIG. 2 is a left elevational view thereof; FIG. 3 is a right elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view; and, FIG. 7 is a bottom plan view thereof.

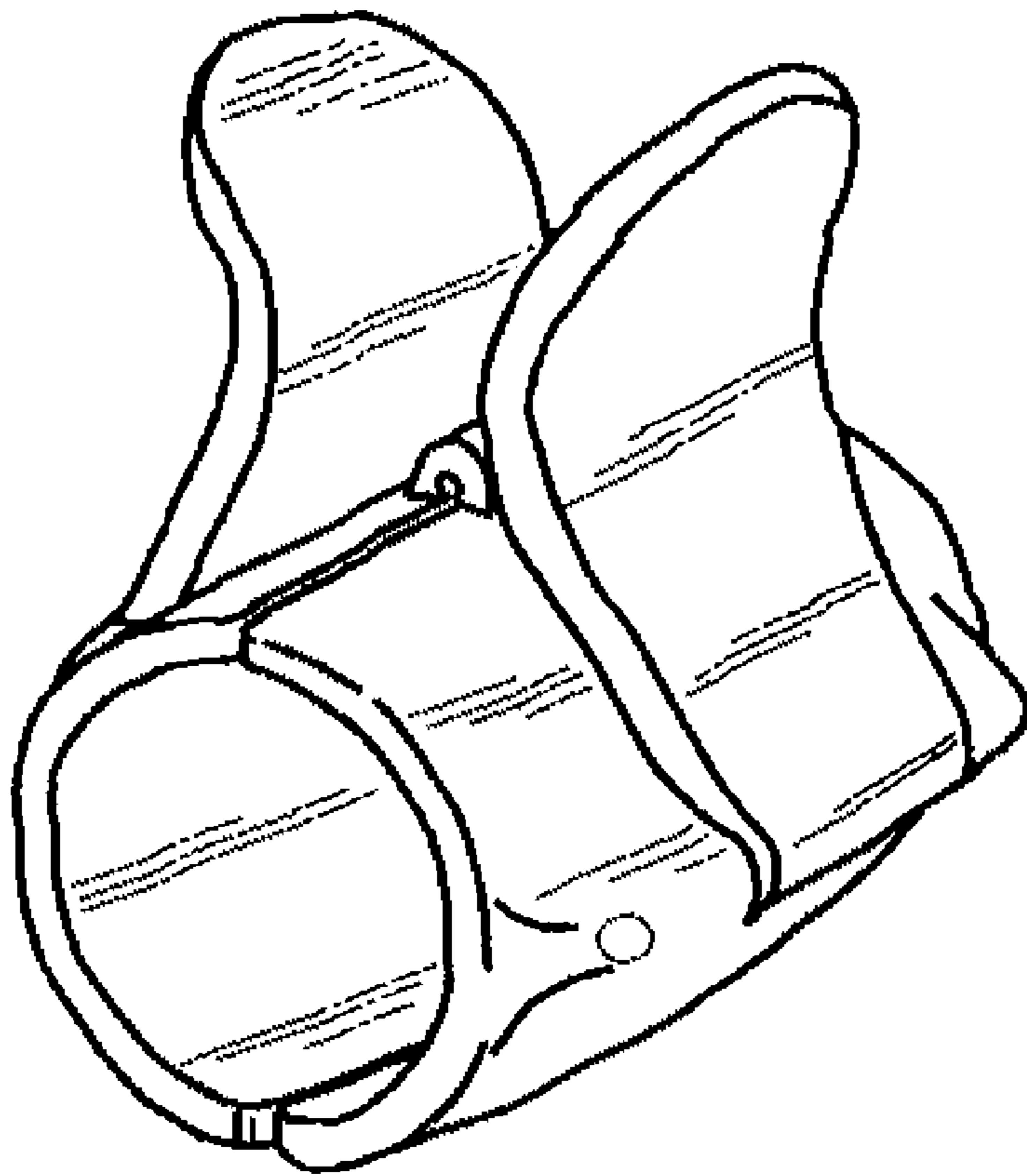

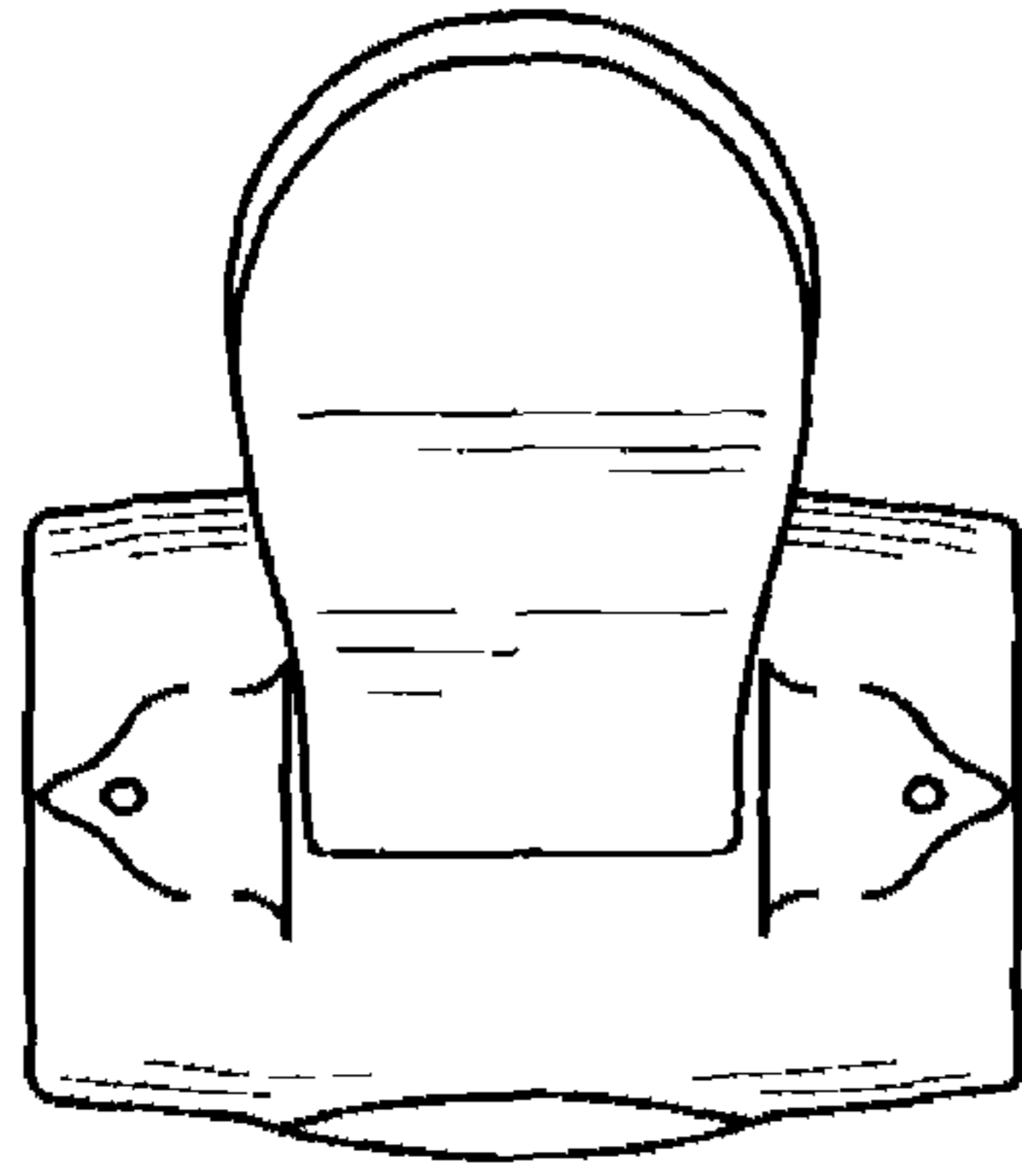

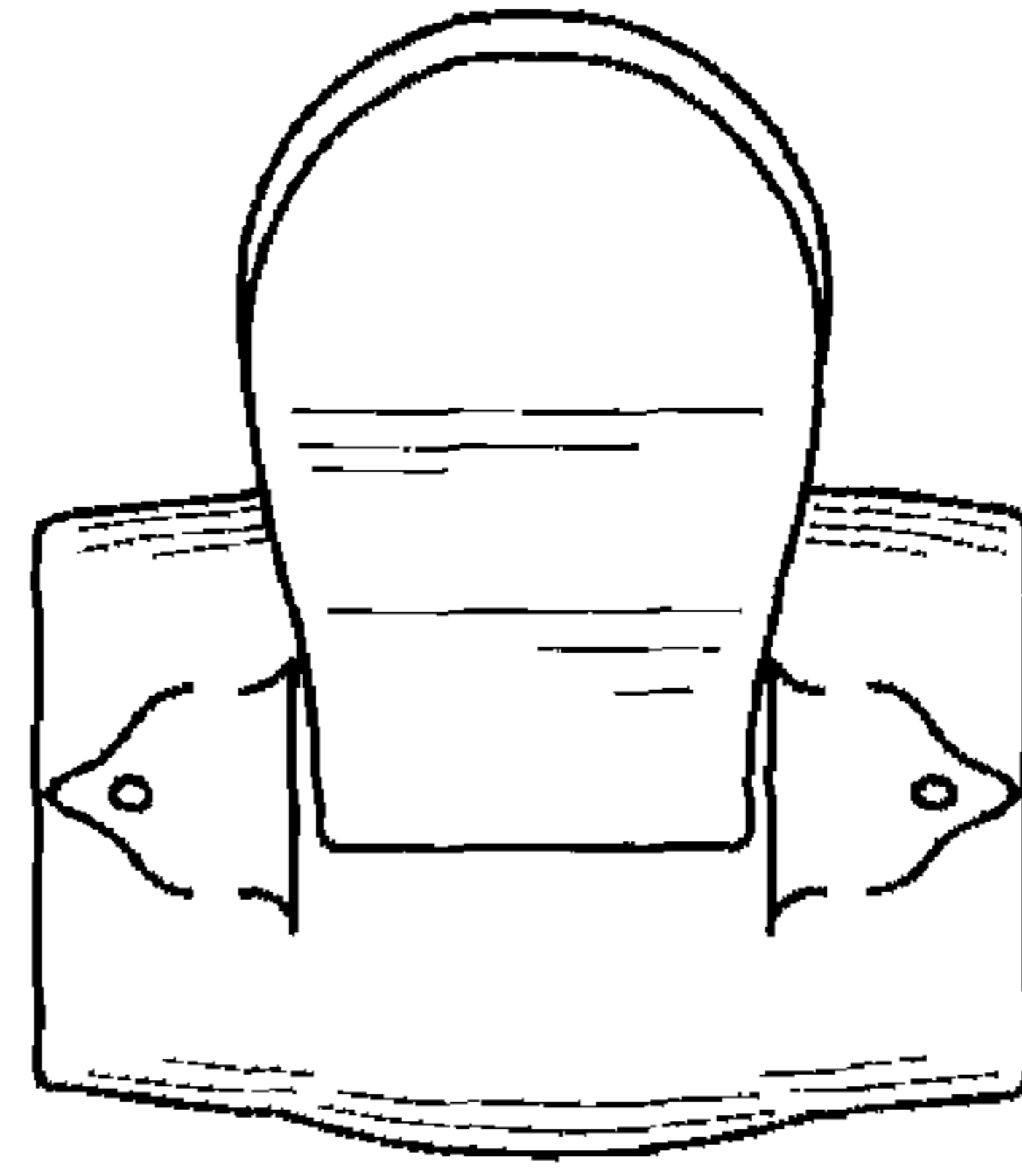

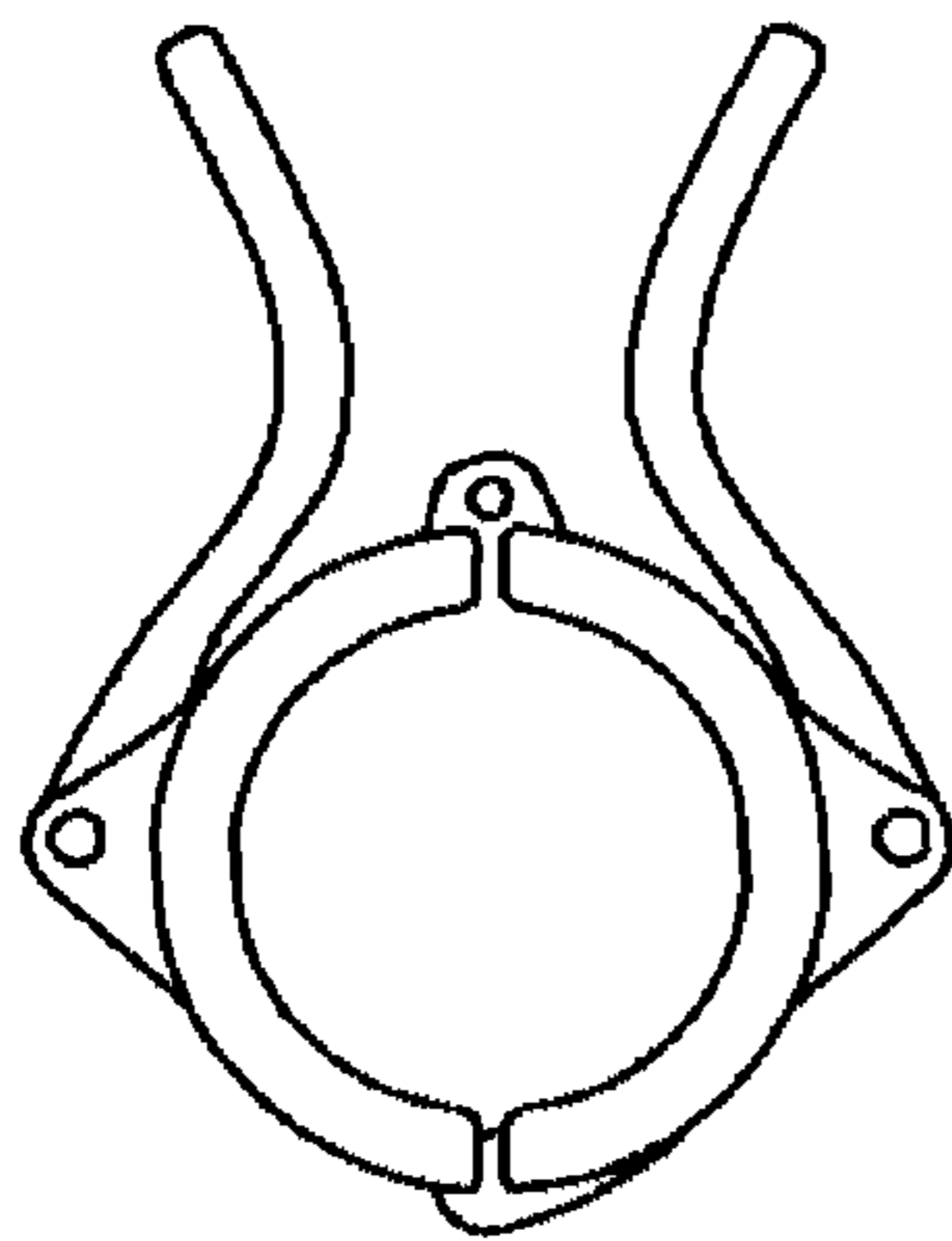

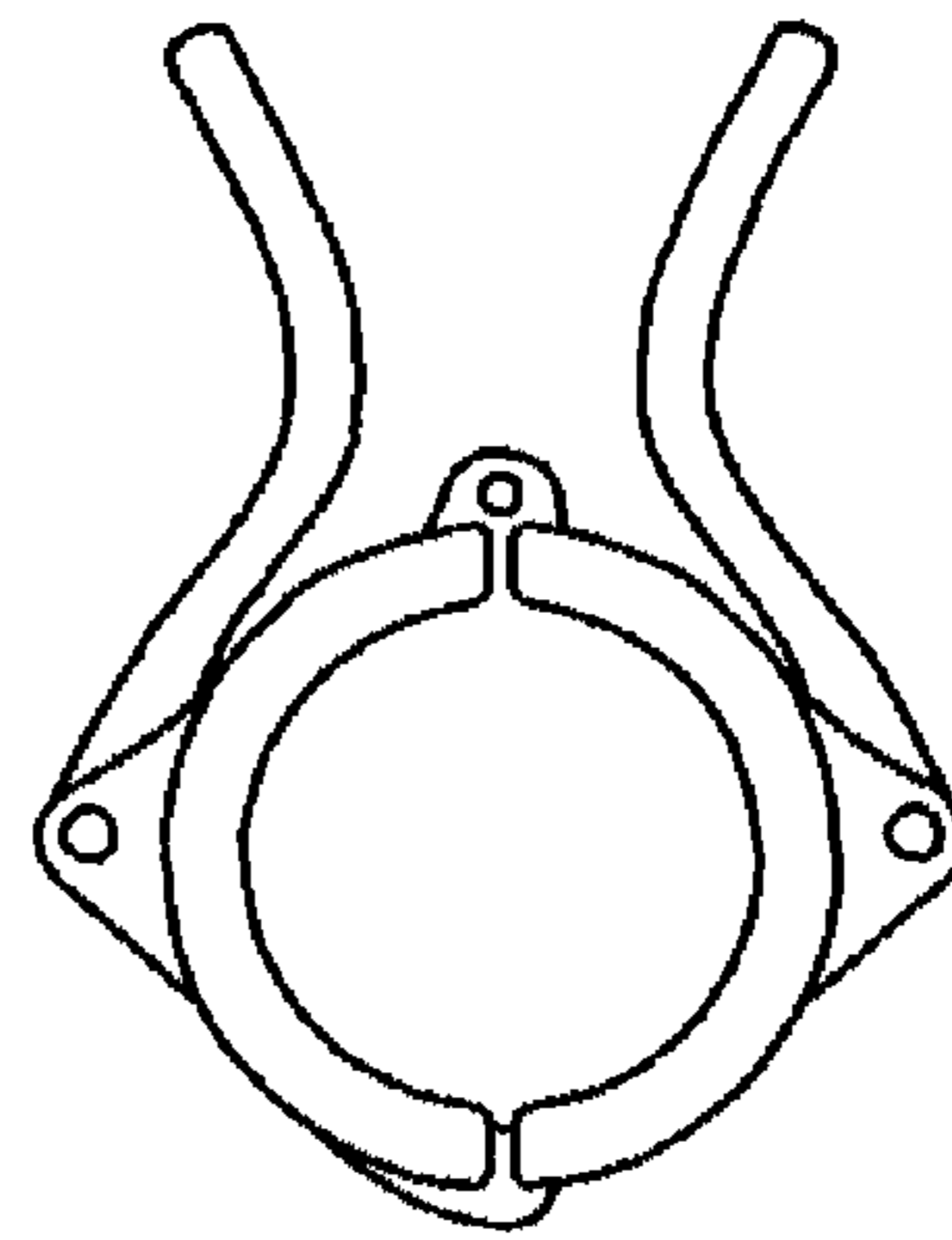

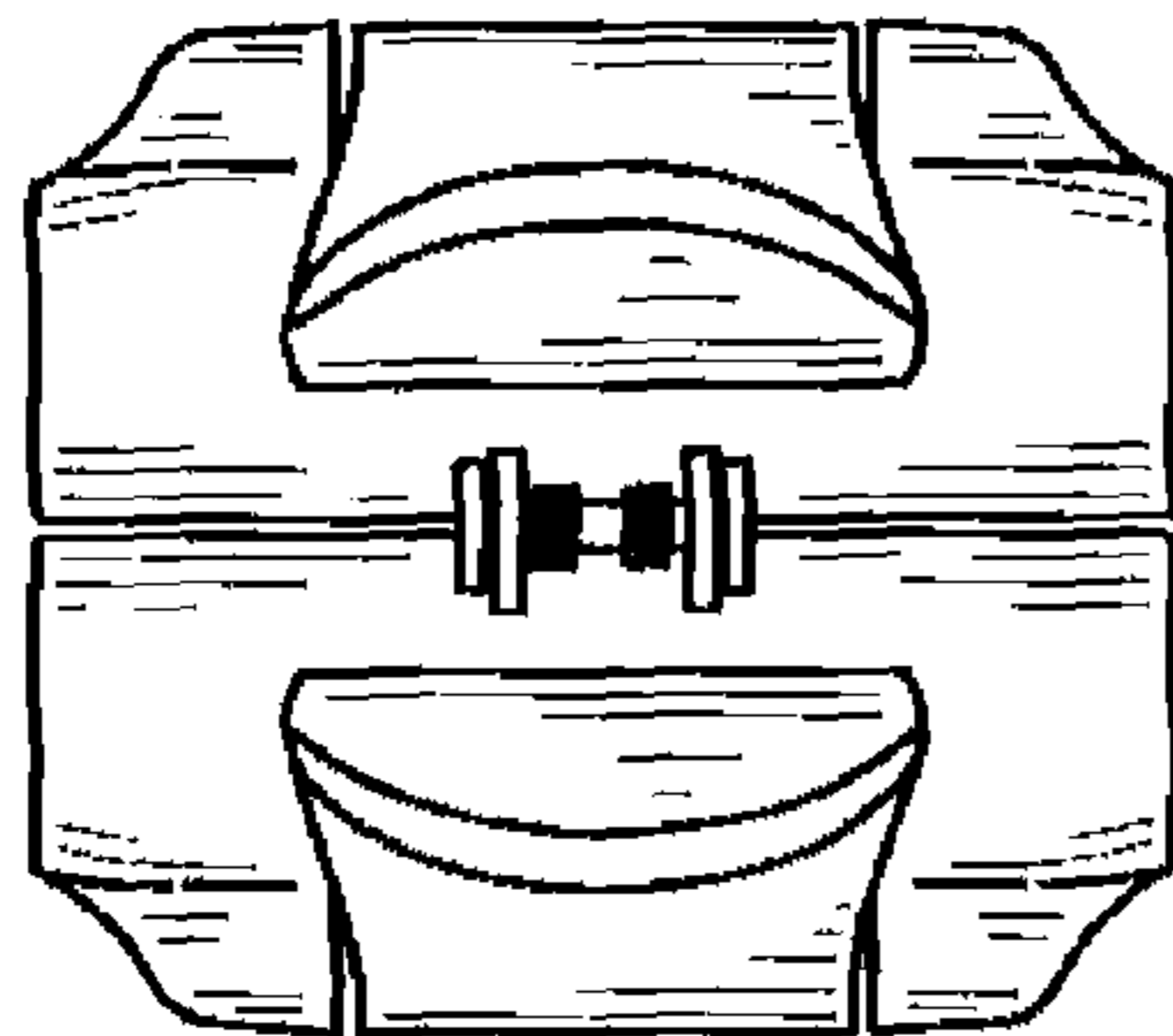

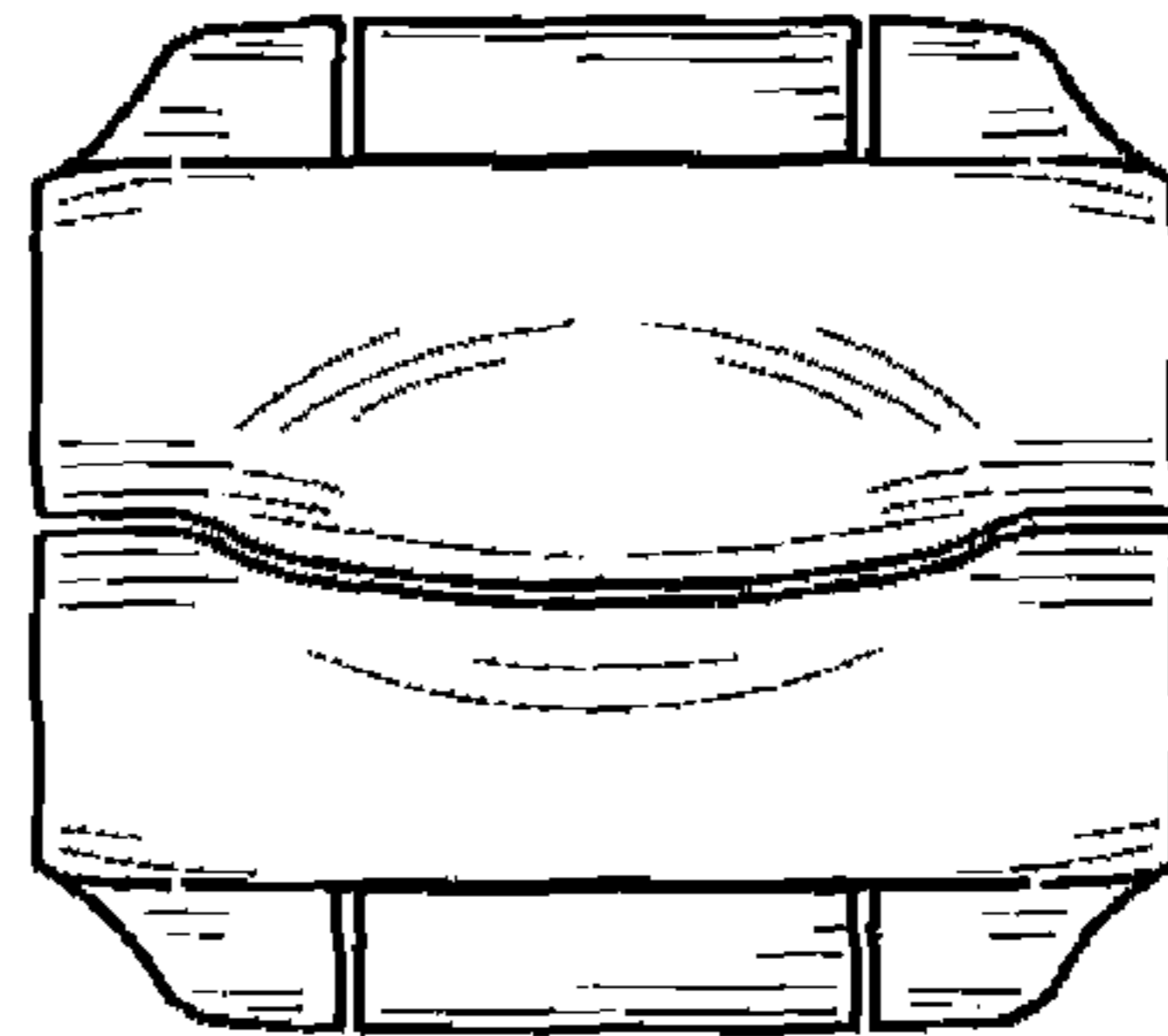
