FIG. 5 is a side view of a footbed shown in FIG. 1;

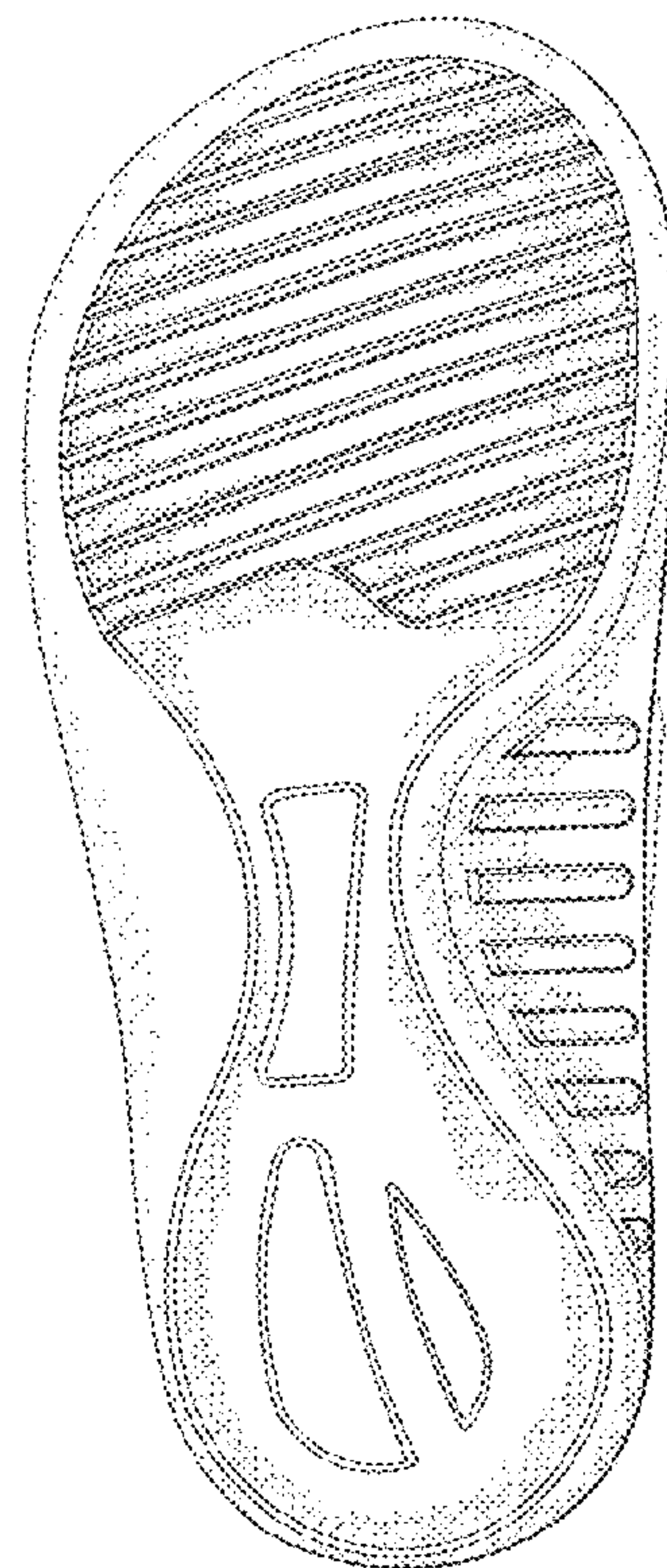
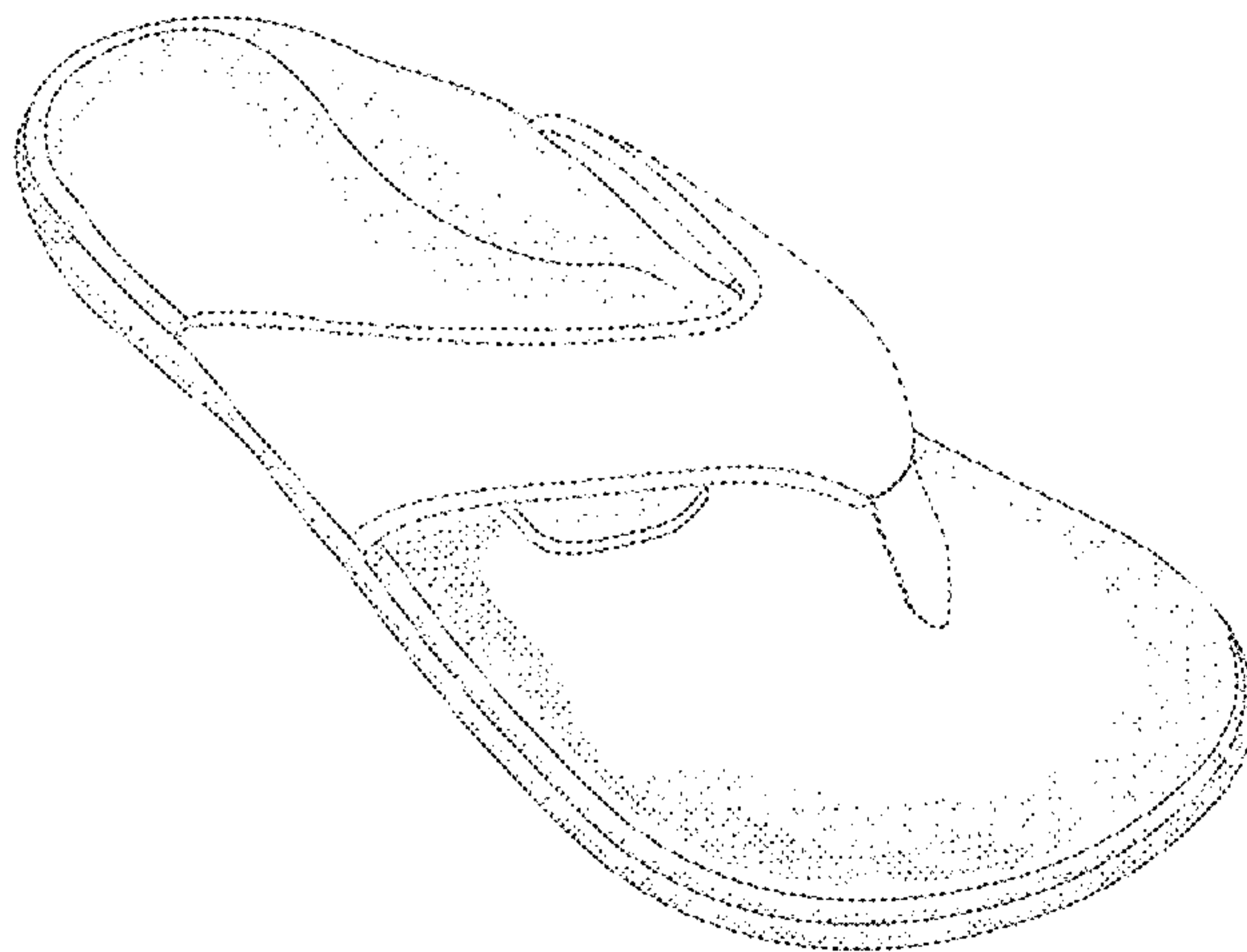
FIG. 6 is a top view of a footbed shown in FIG. 1;

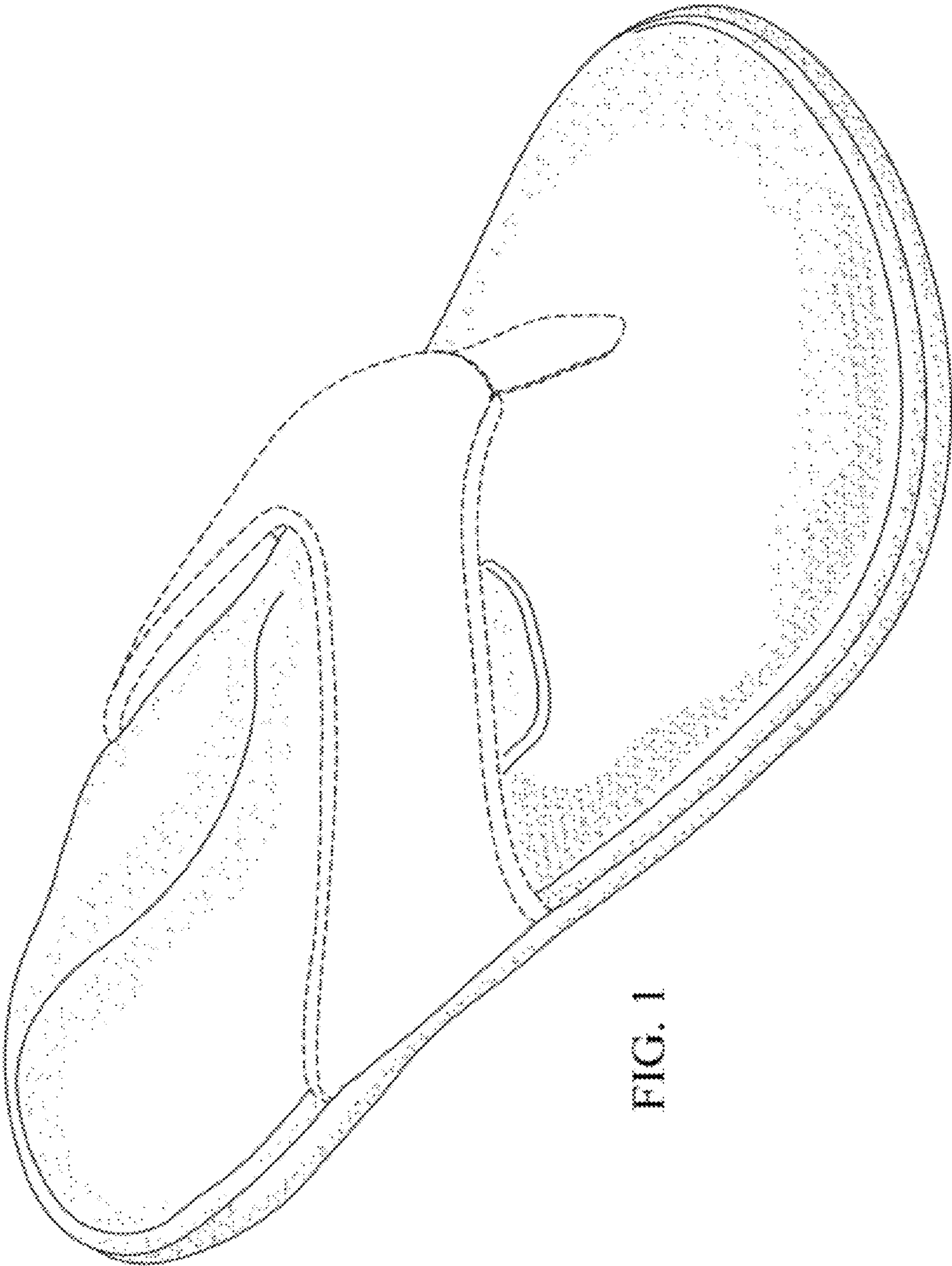

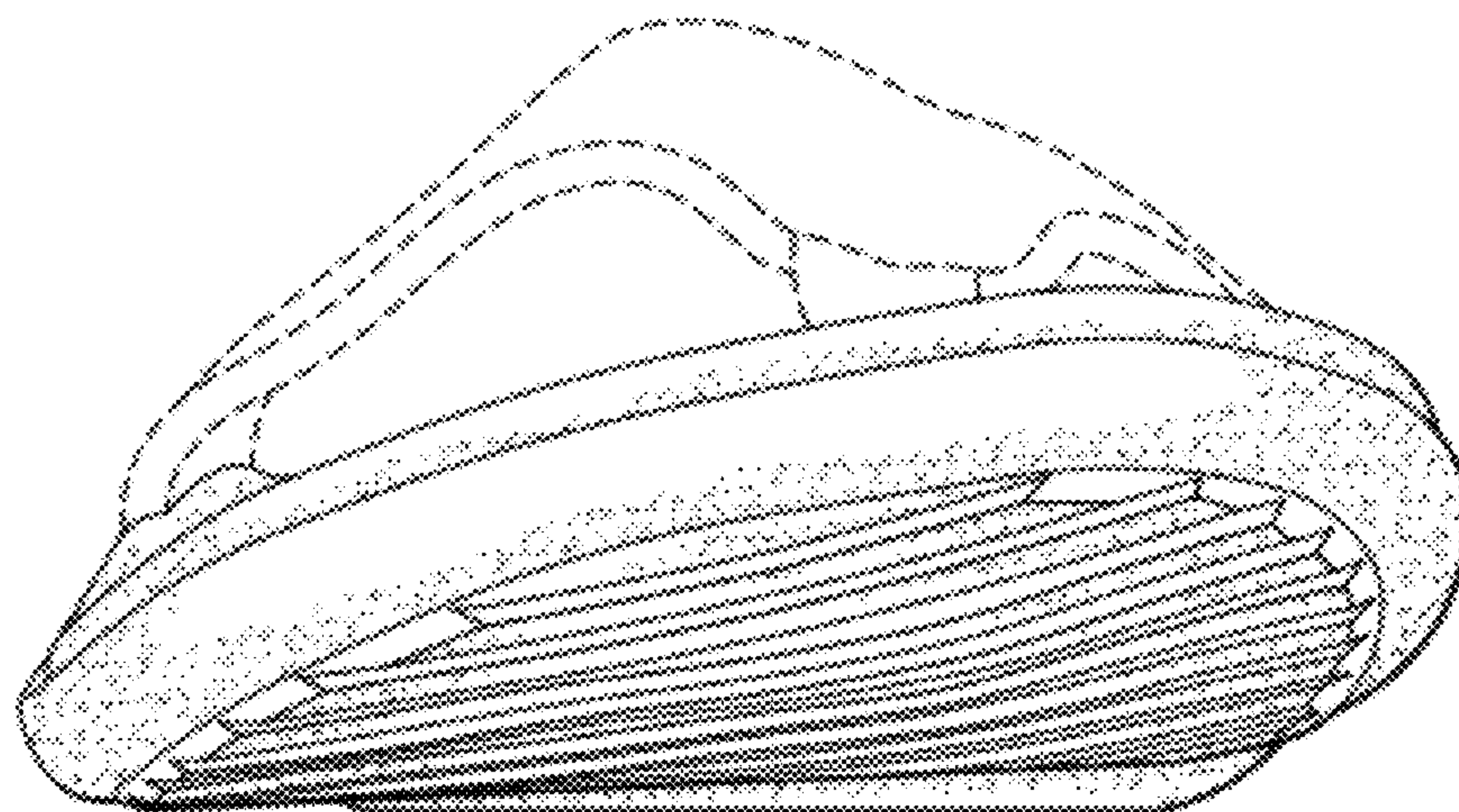

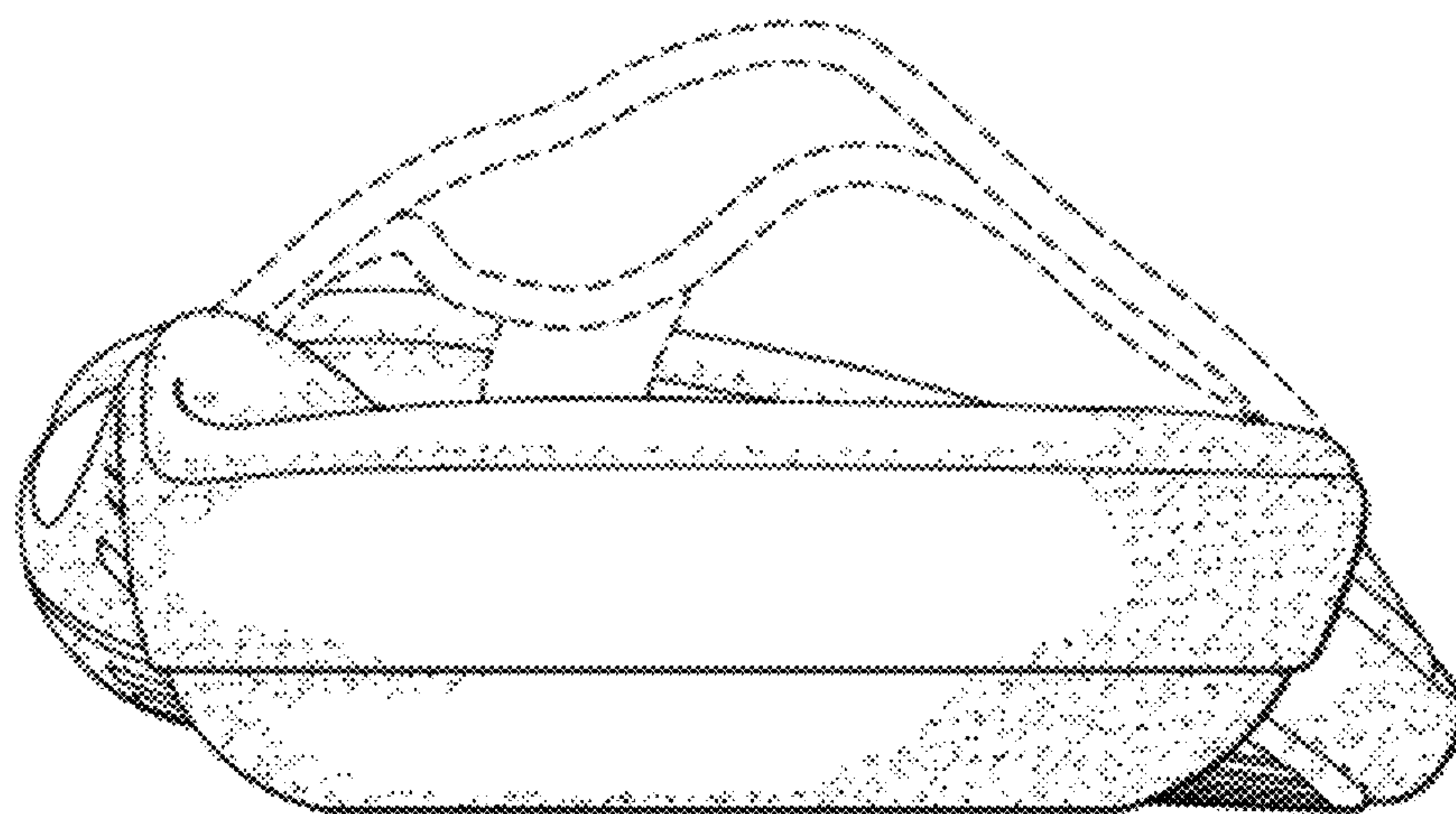

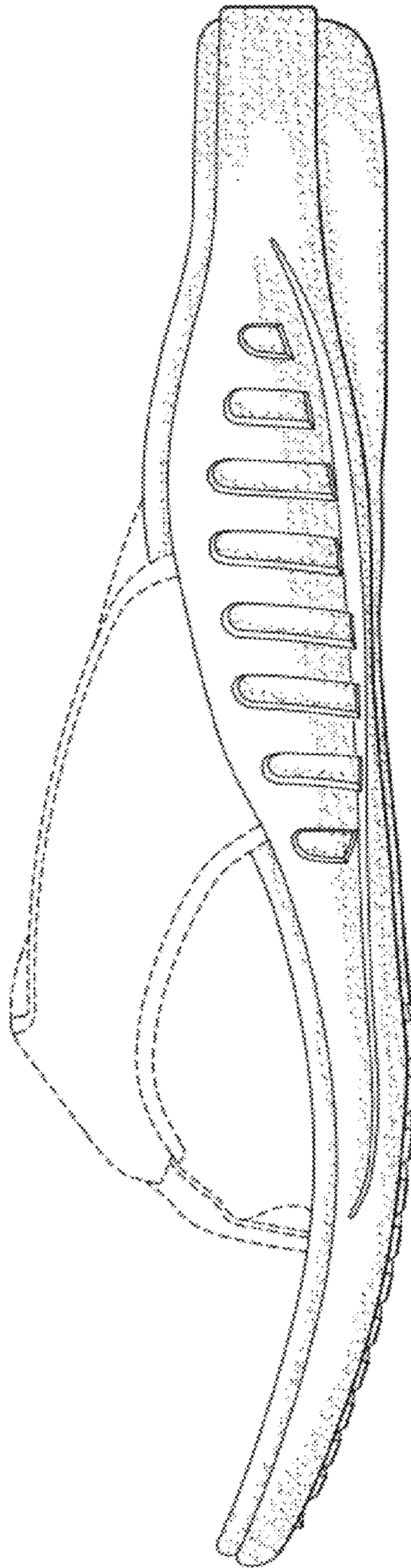

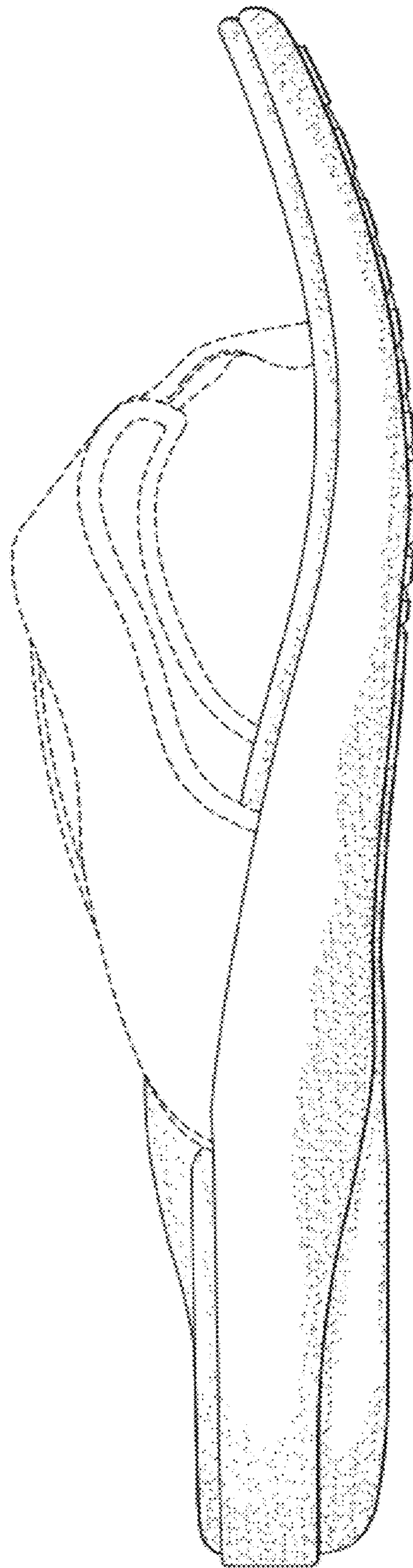

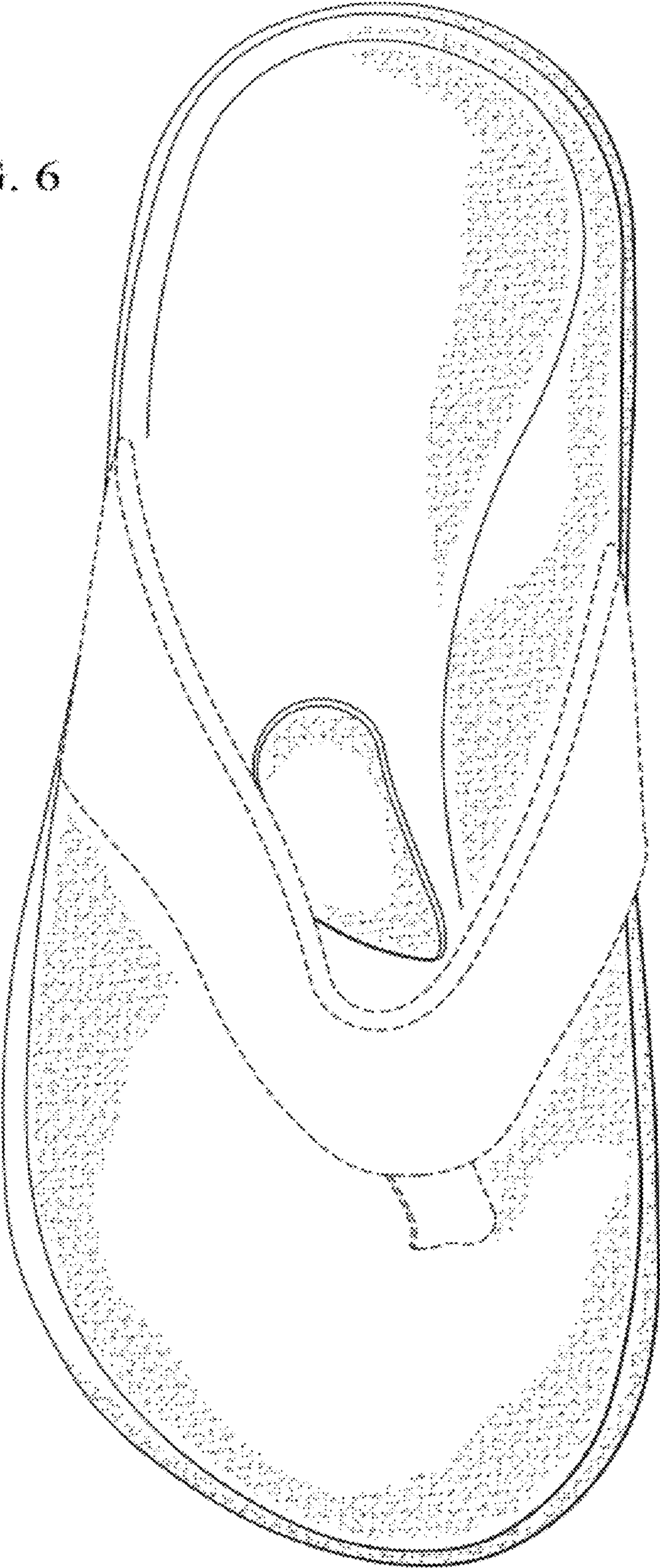
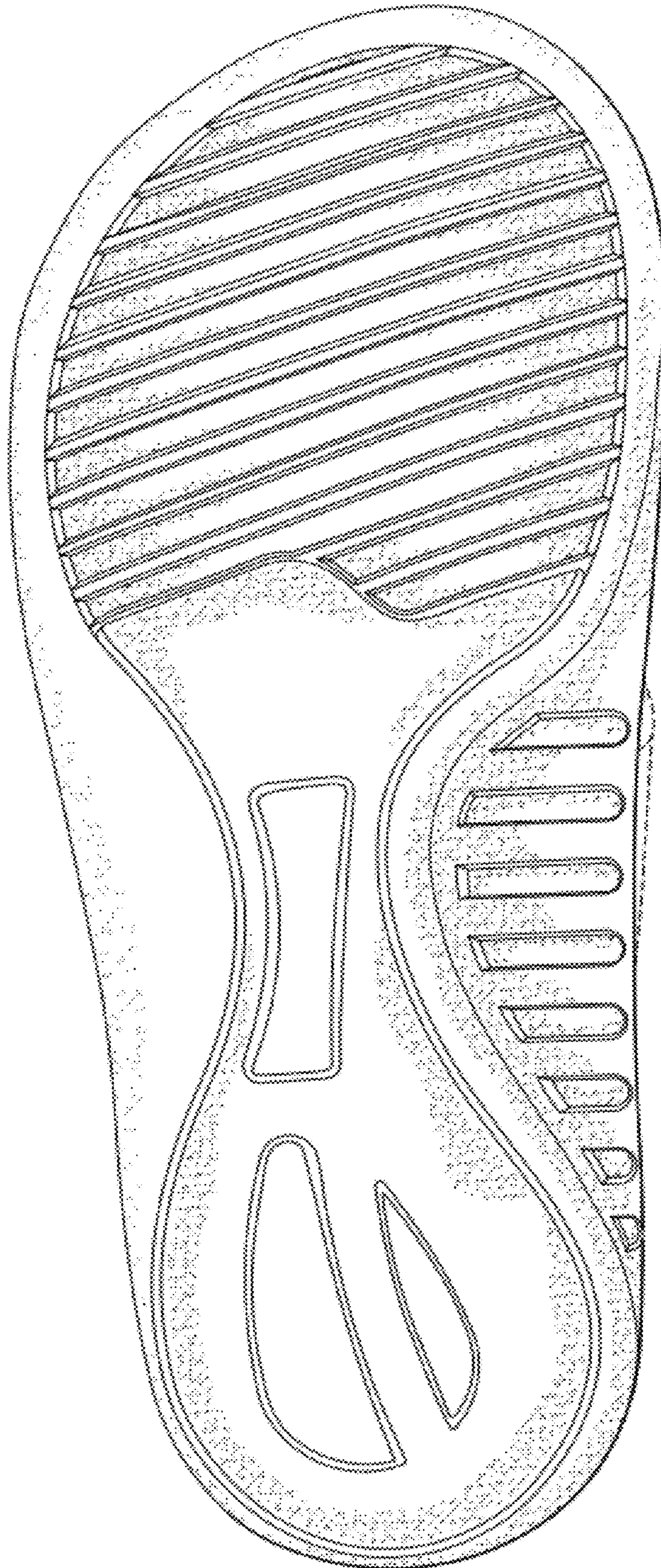

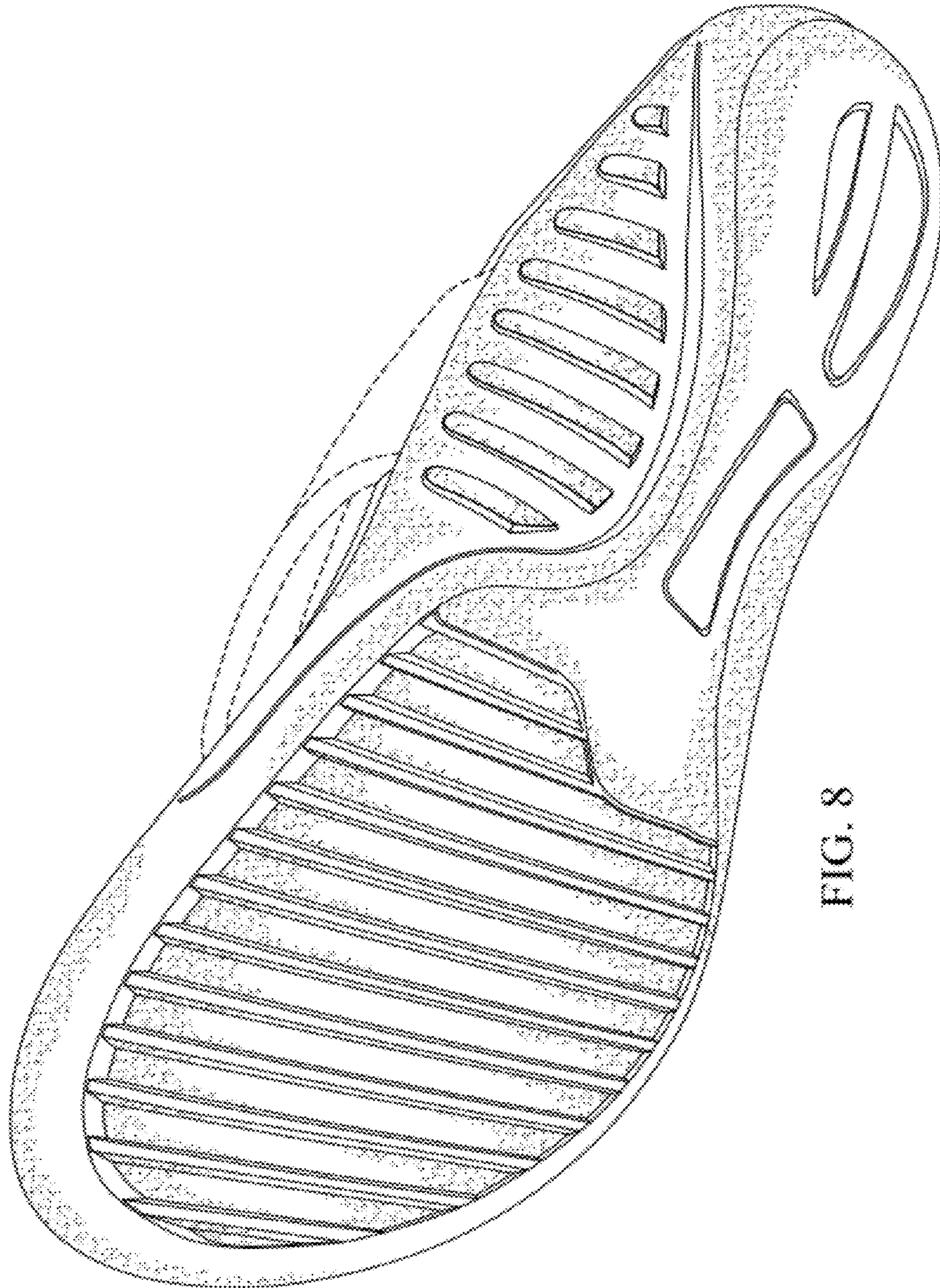
