(57) **CLAIM**

I claim the ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the shoe upper design;

FIG. 2 is a detail view of the shoe upper of FIG. 1, taken generally in the area indicated by the line 2-2 in FIG. 1;

FIG. 3 is a top view of the shoe upper of FIG. 1;

FIG. 4 is a right side elevation view of the shoe upper of FIG. 1;

FIG. 5 is a left side elevation view of the shoe upper of FIG. 1;

FIG. 6 is a front view of the shoe upper of FIG. 1;

FIG. 7 is a back view of the shoe upper of FIG. 1;

FIG. 8 is a perspective view of another embodiment of the shoe upper design;

FIG. 9 is a detail view of the shoe upper of FIG. 8, taken generally in the area indicated by the line 9-9 in FIG. 8;

FIG. 10 is a top view of the shoe upper of FIG. 8;

FIG. 11 is a right side elevation view of the shoe upper of FIG. 8;

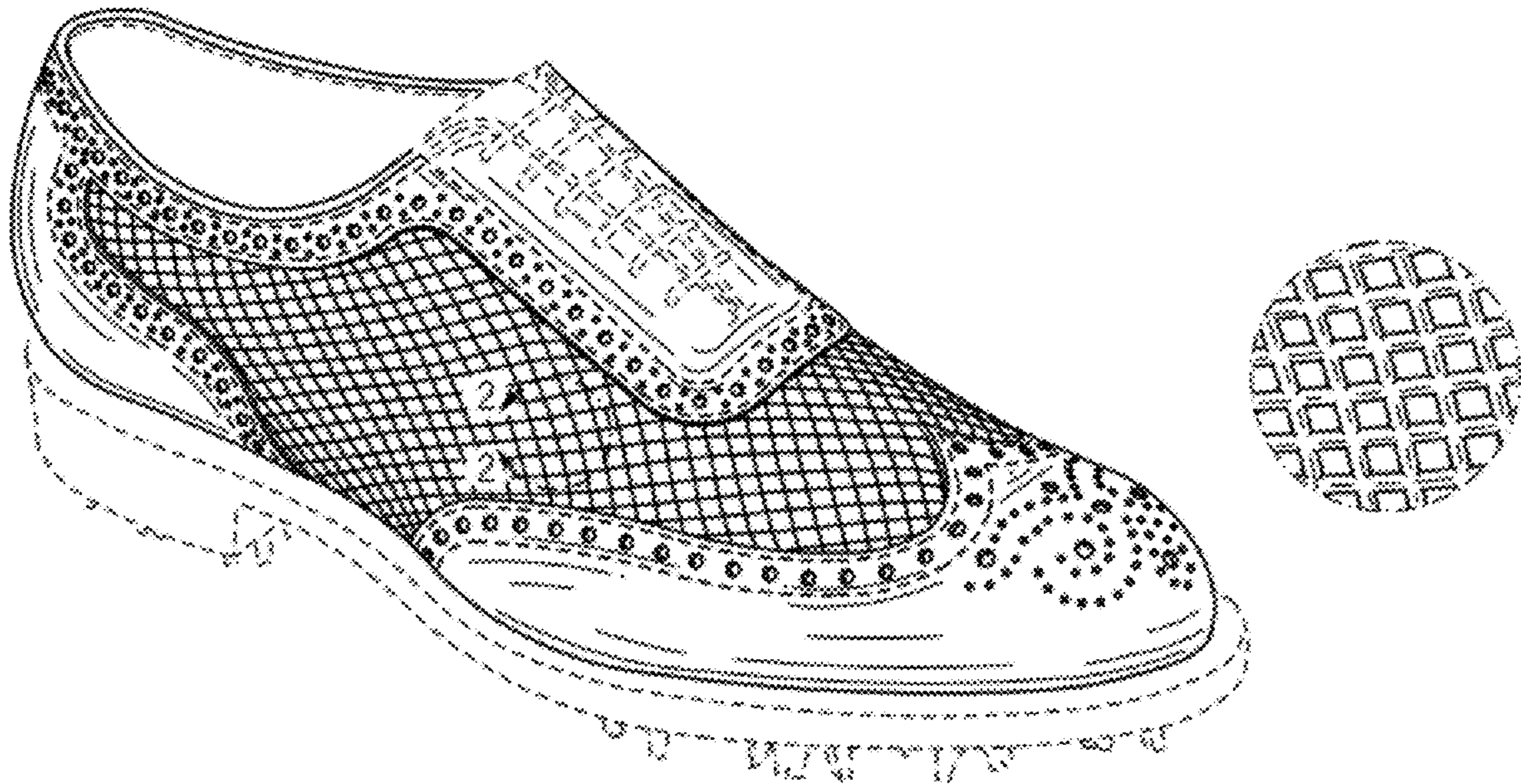
FIG. 12 is a left side elevation view of the shoe upper of FIG. 8;

FIG. 13 is a front view of the shoe upper of FIG. 8; and,

FIG. 14 is a back view of the shoe upper of FIG. 8.

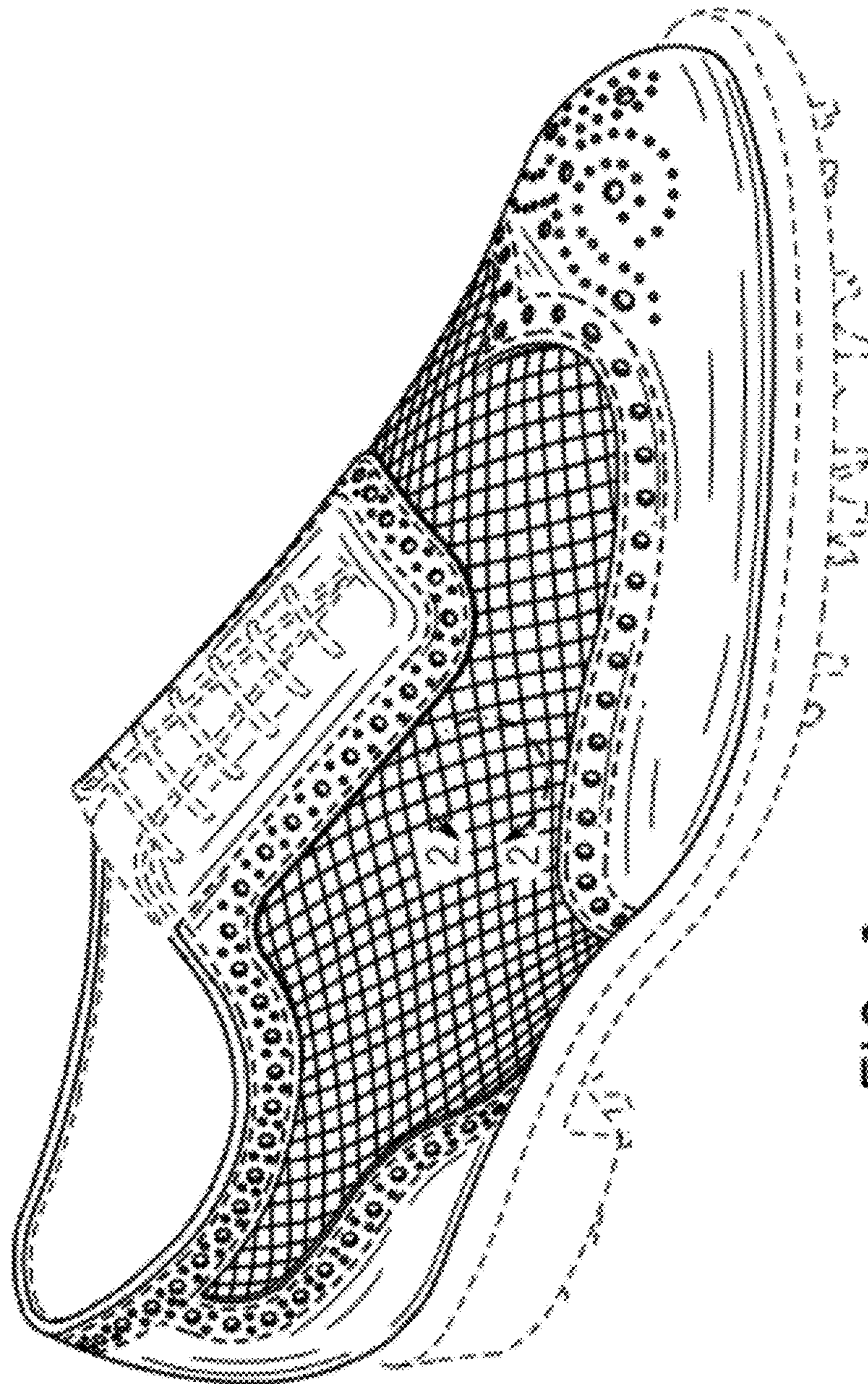

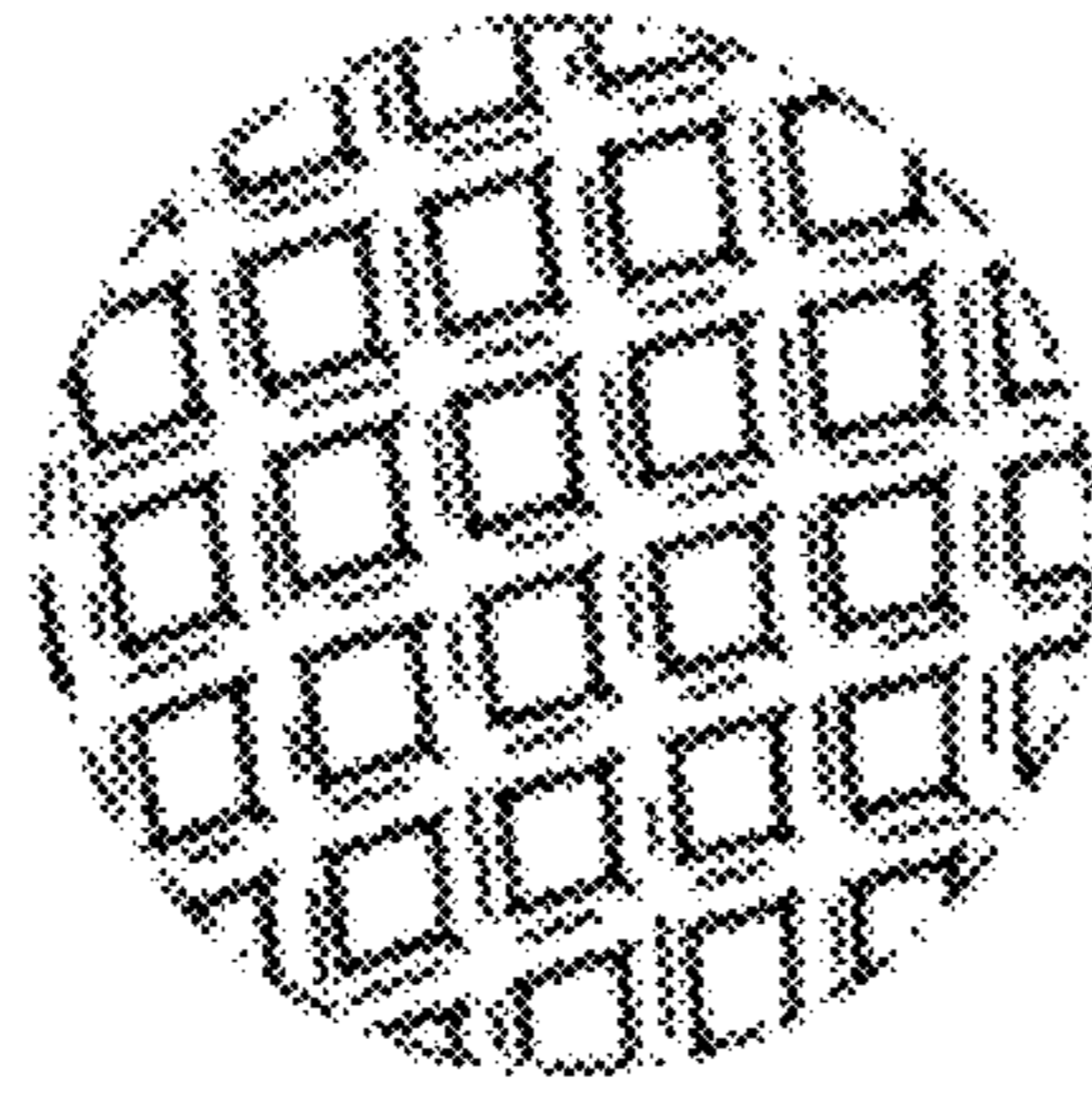

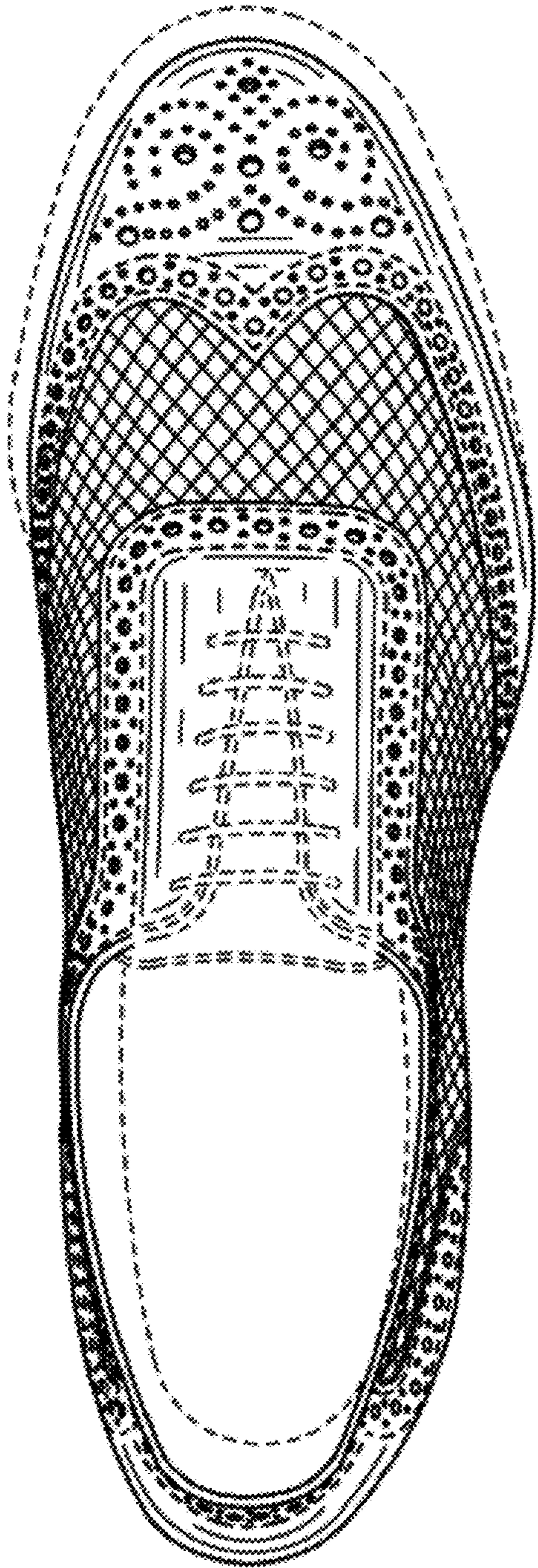
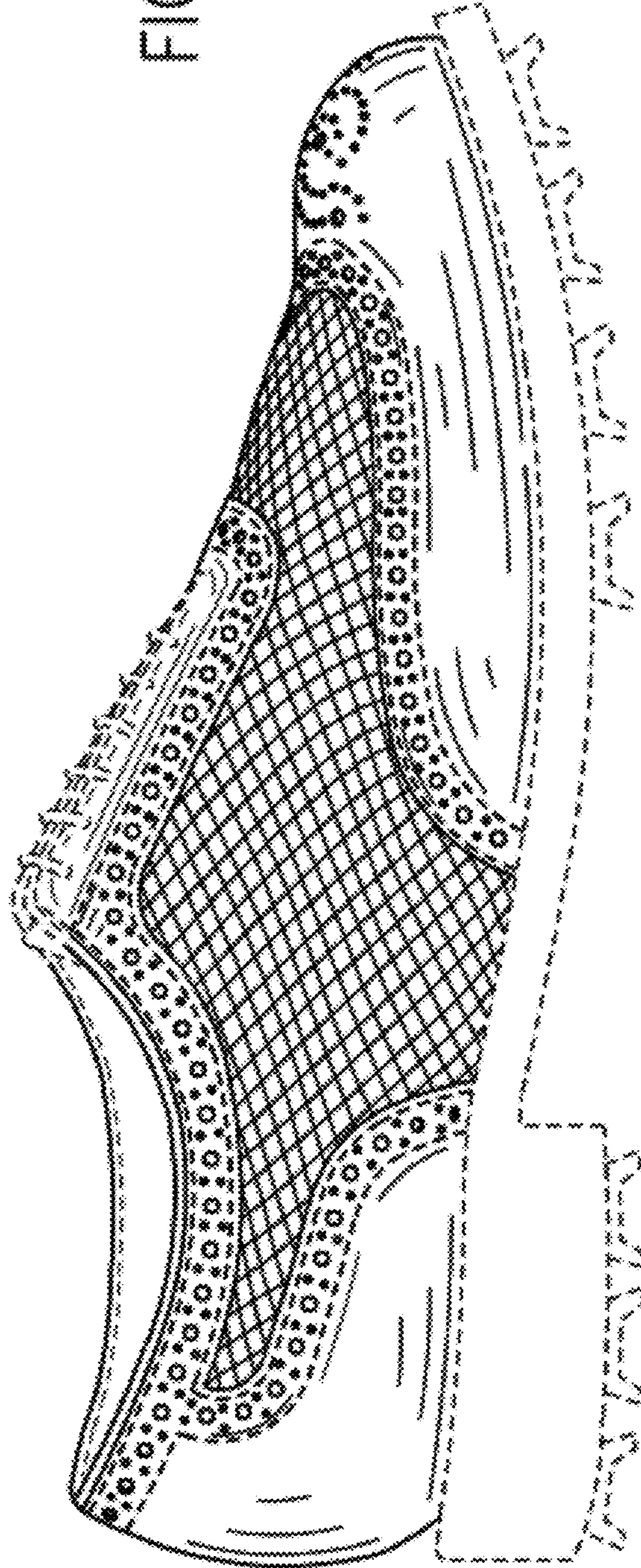

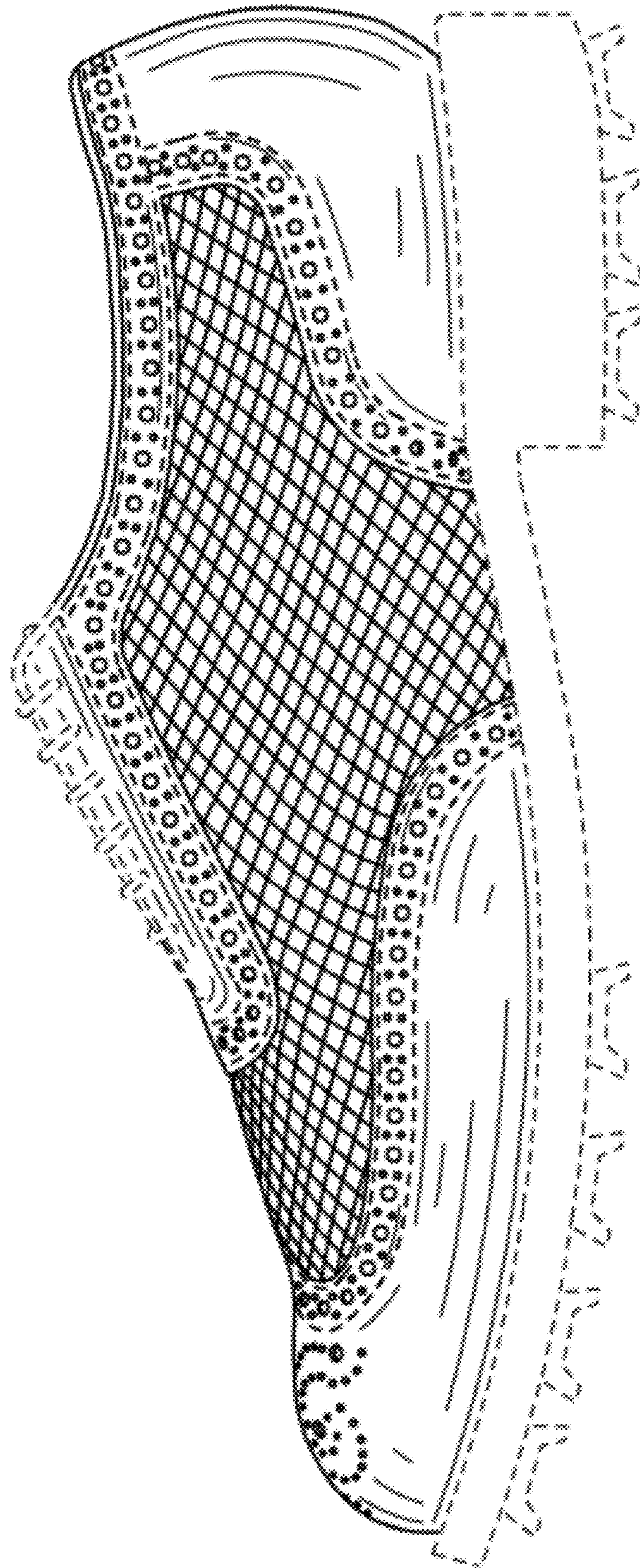

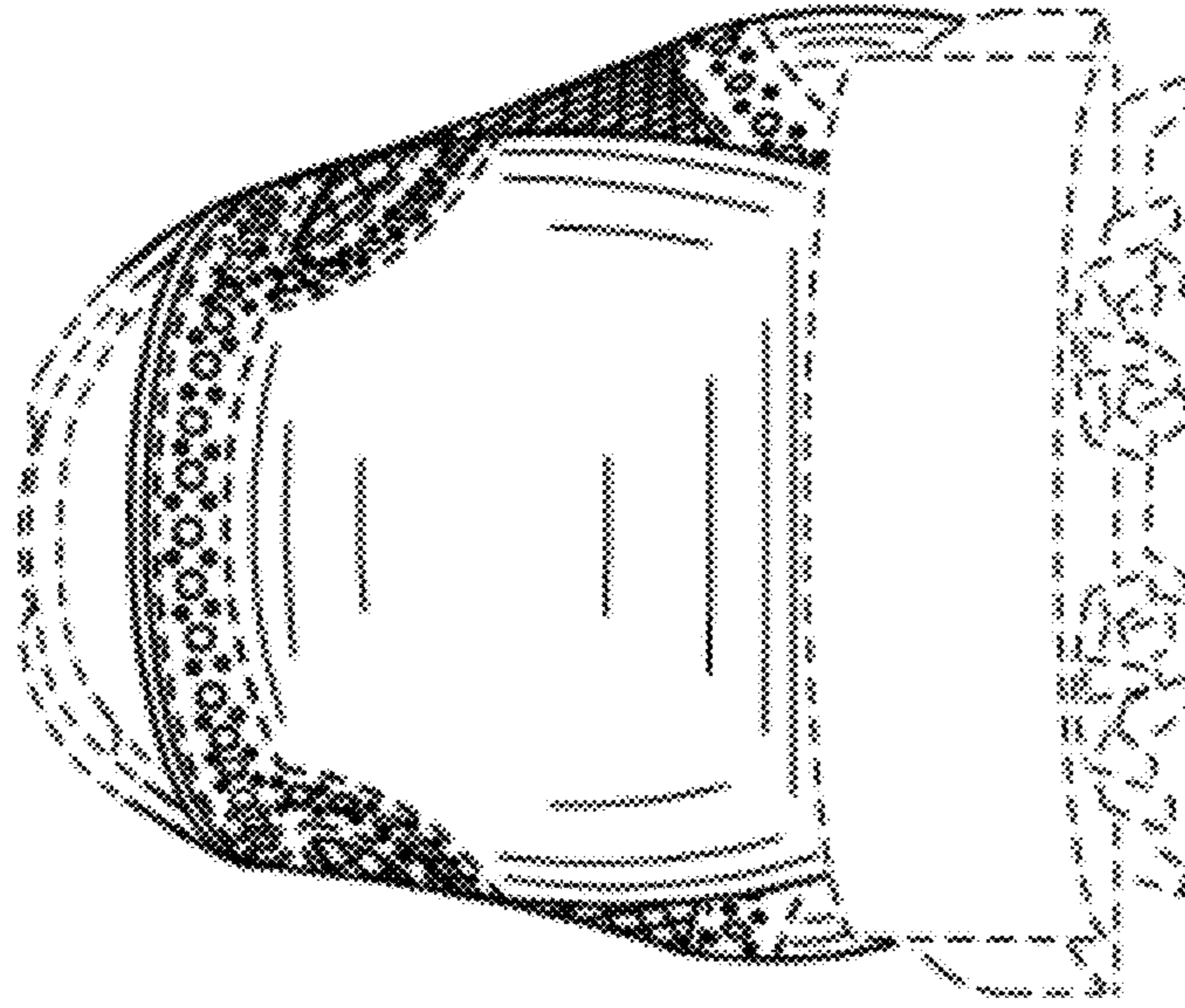

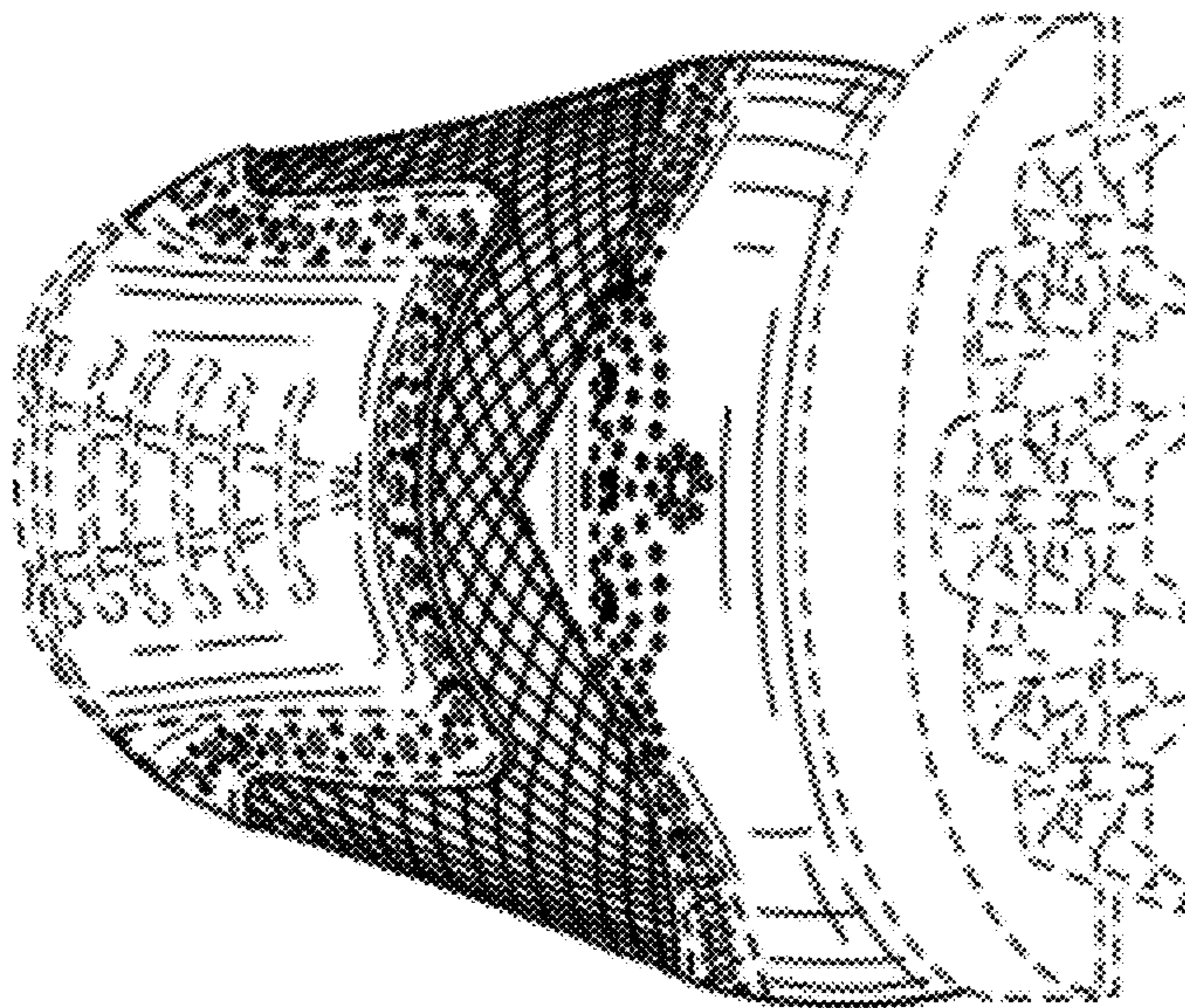

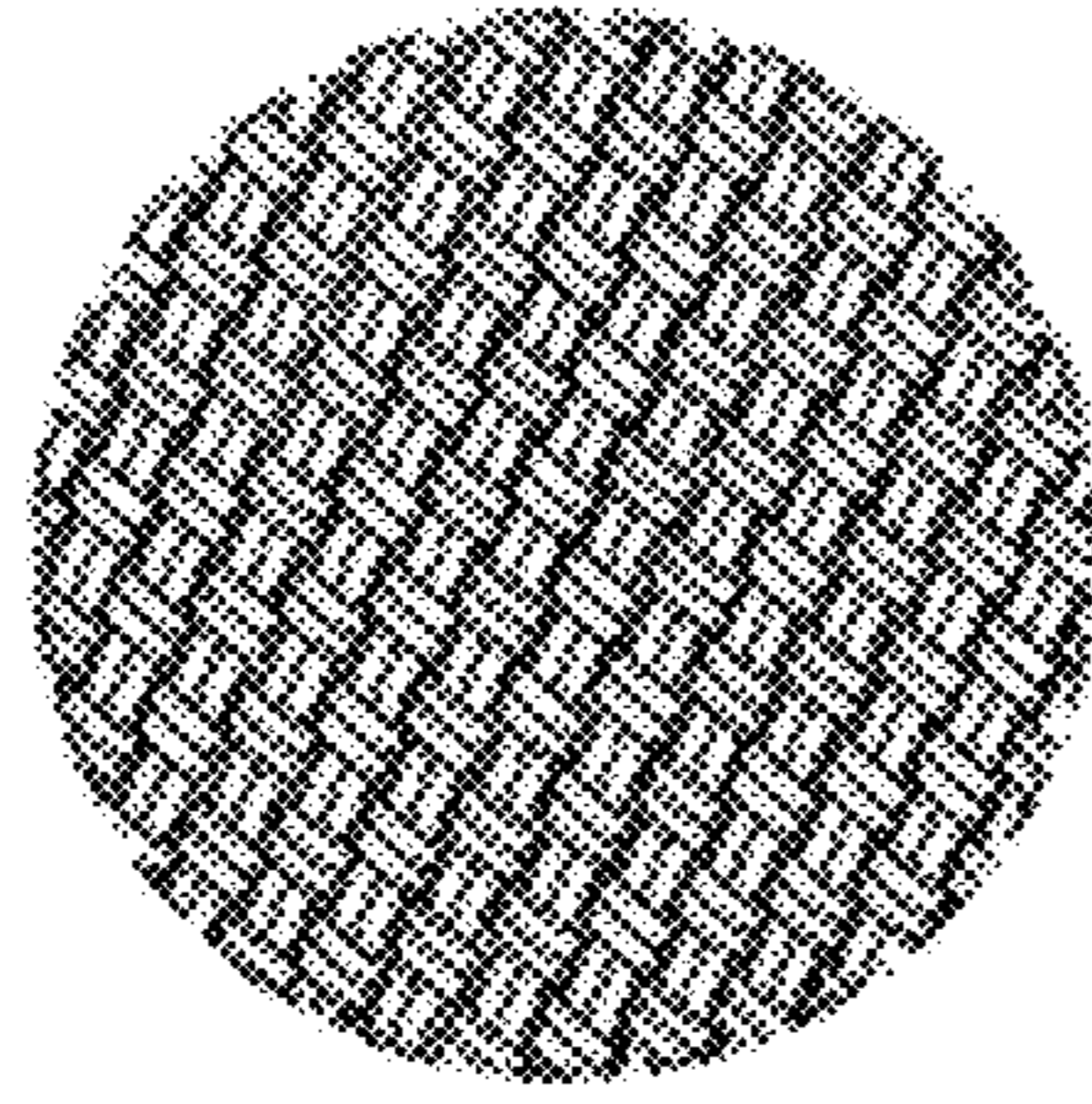

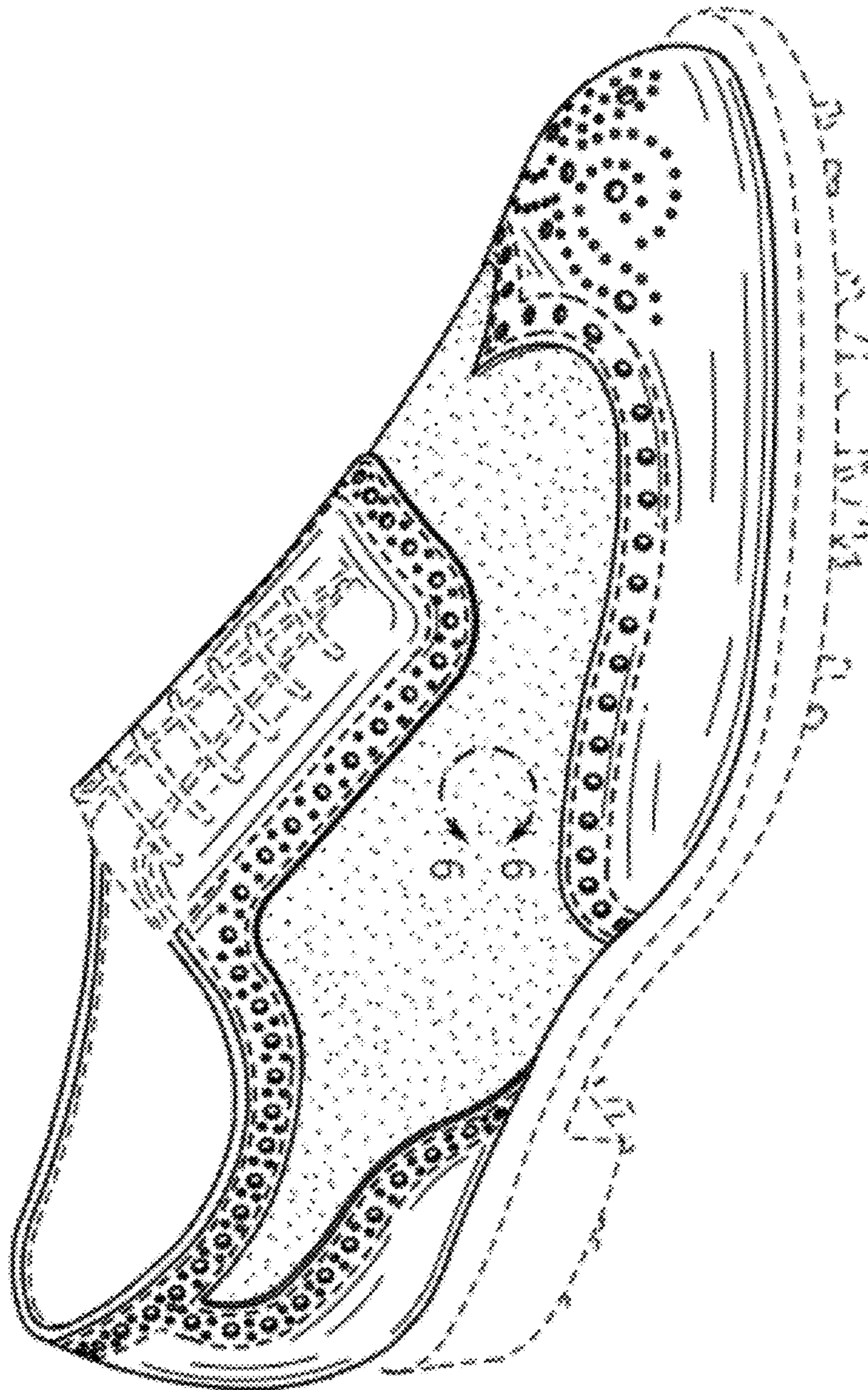

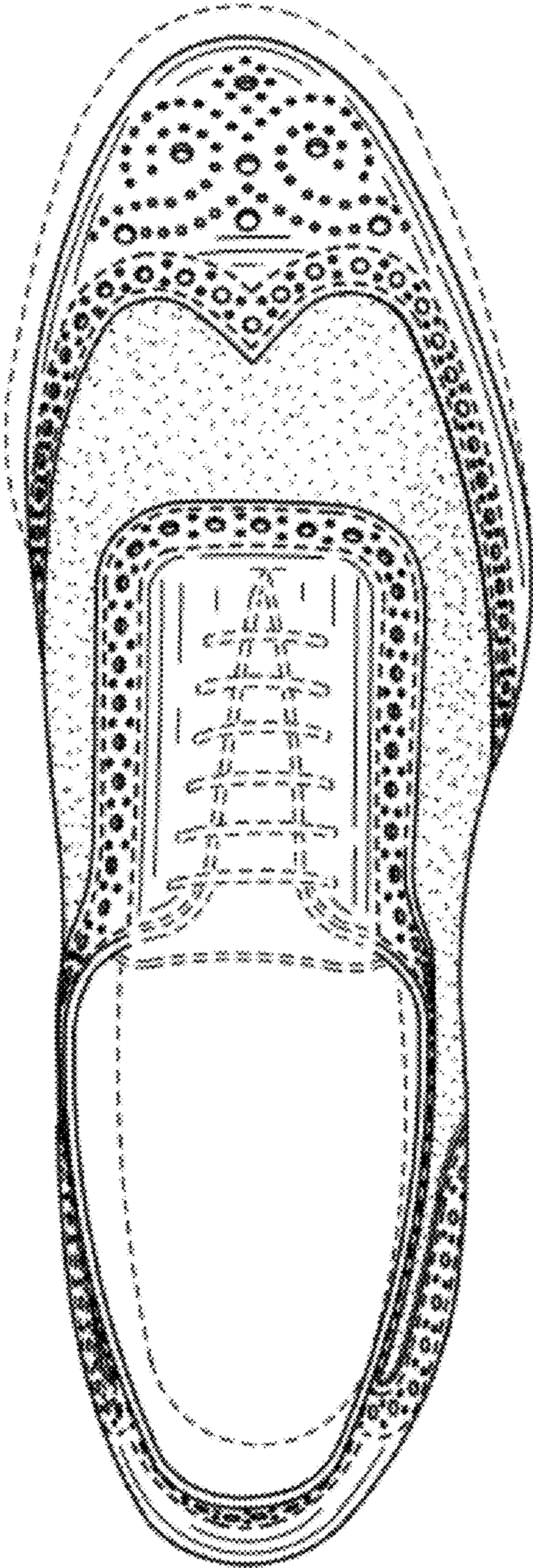
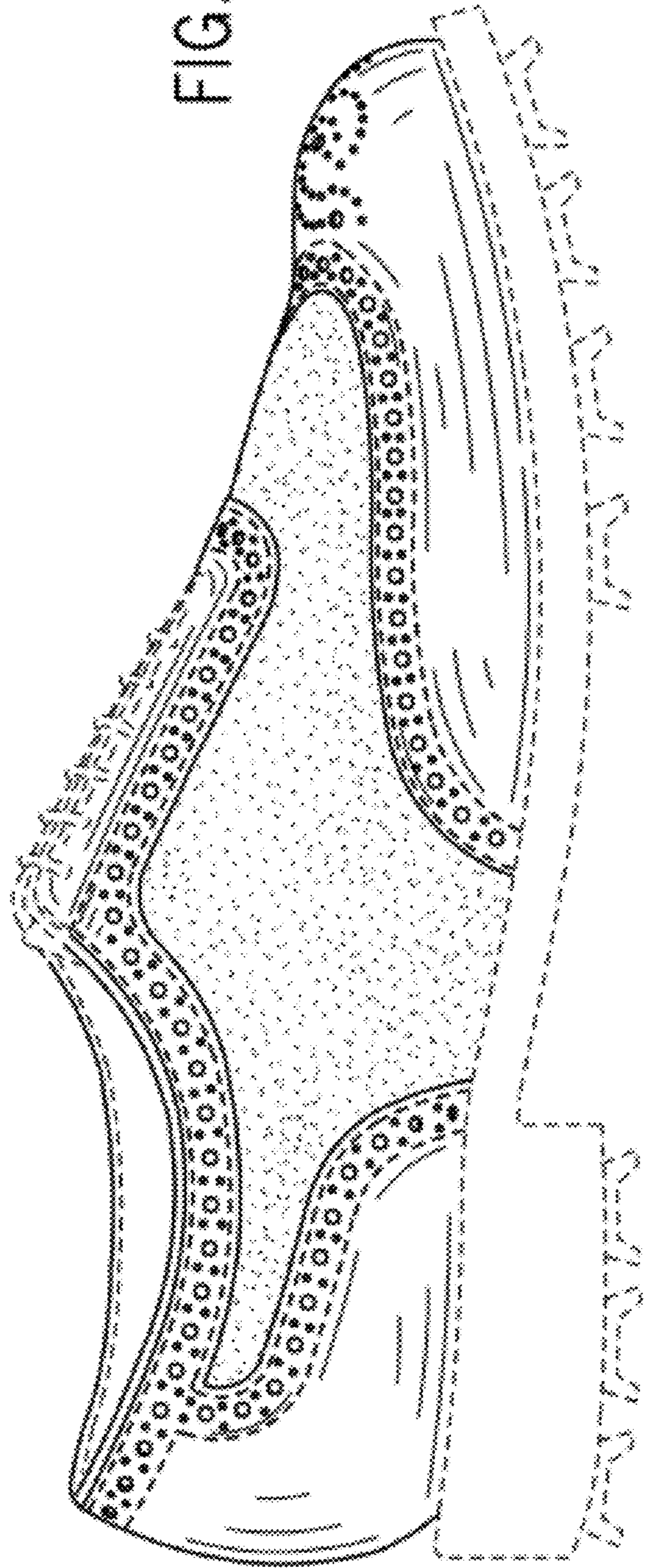

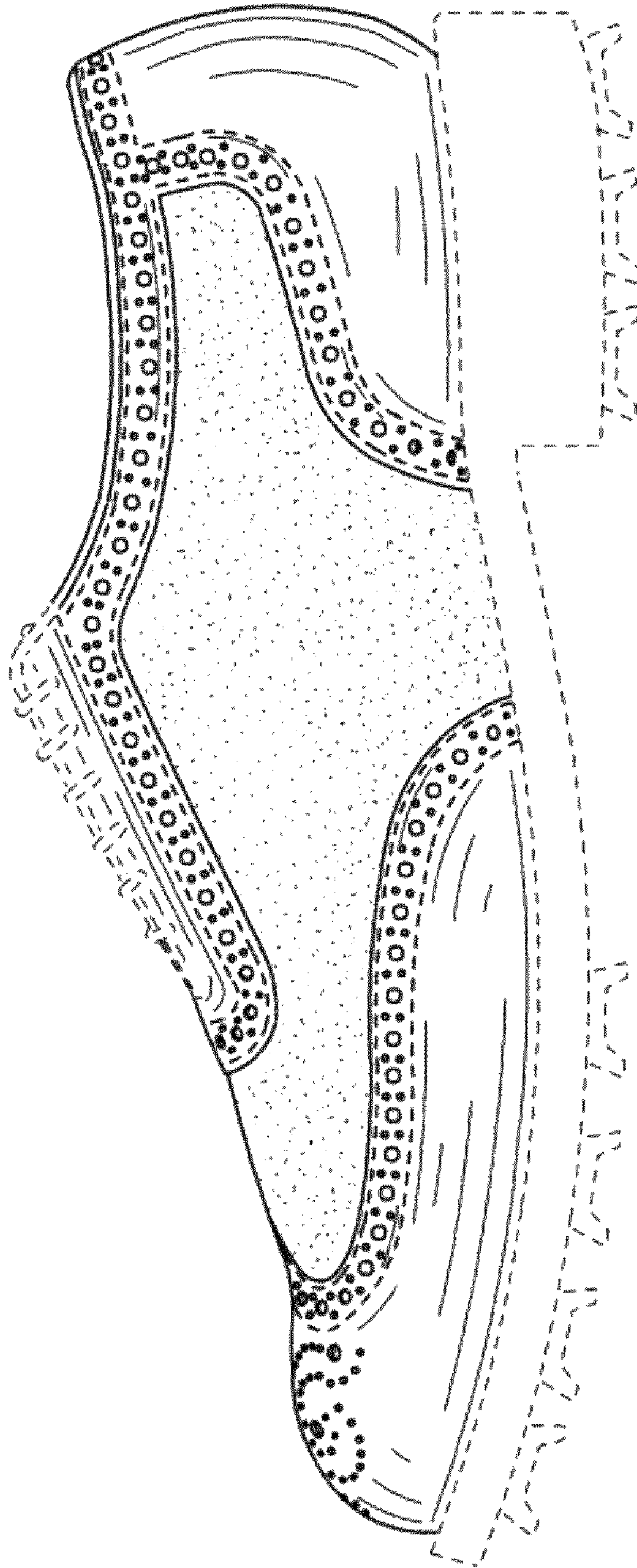

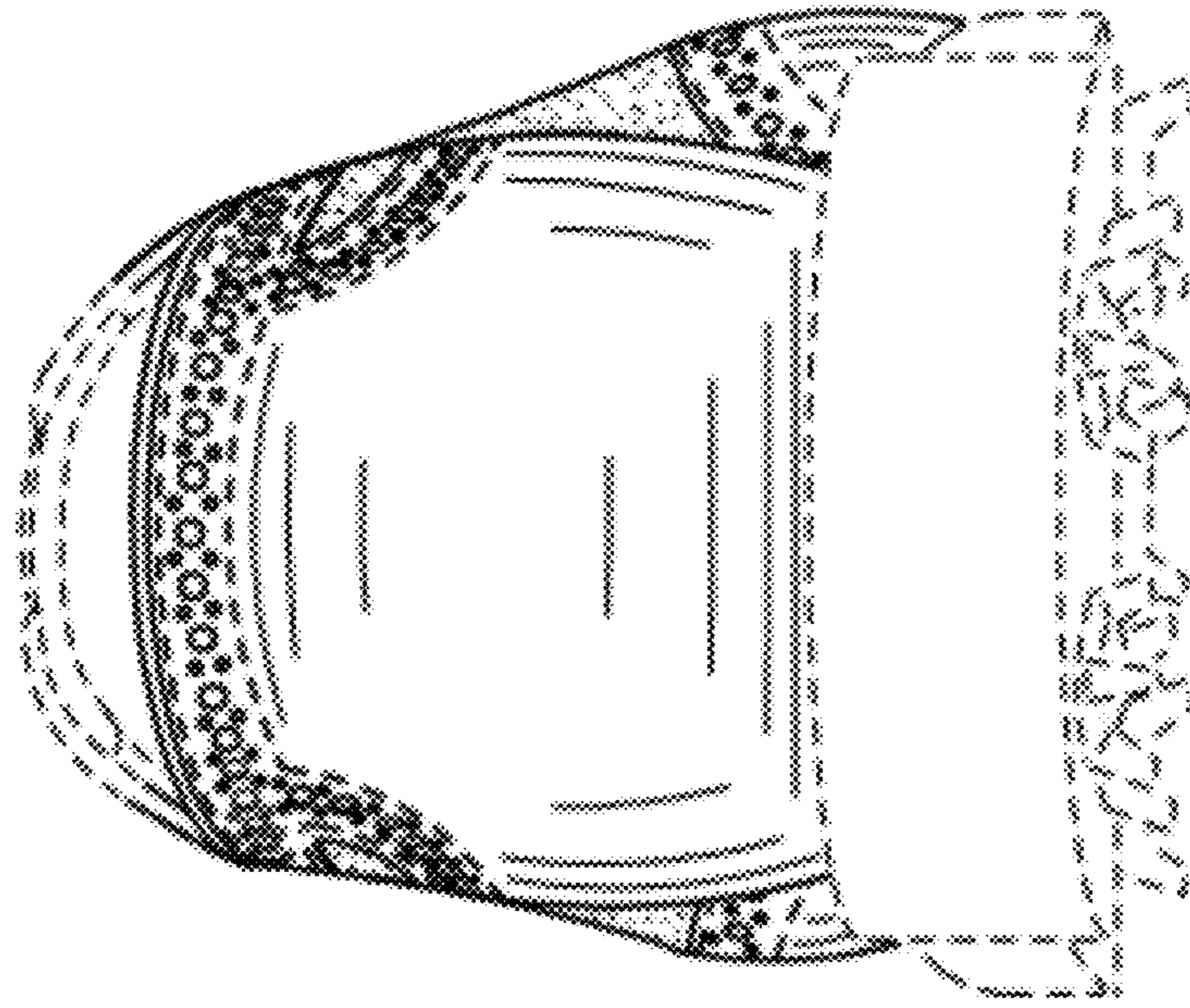

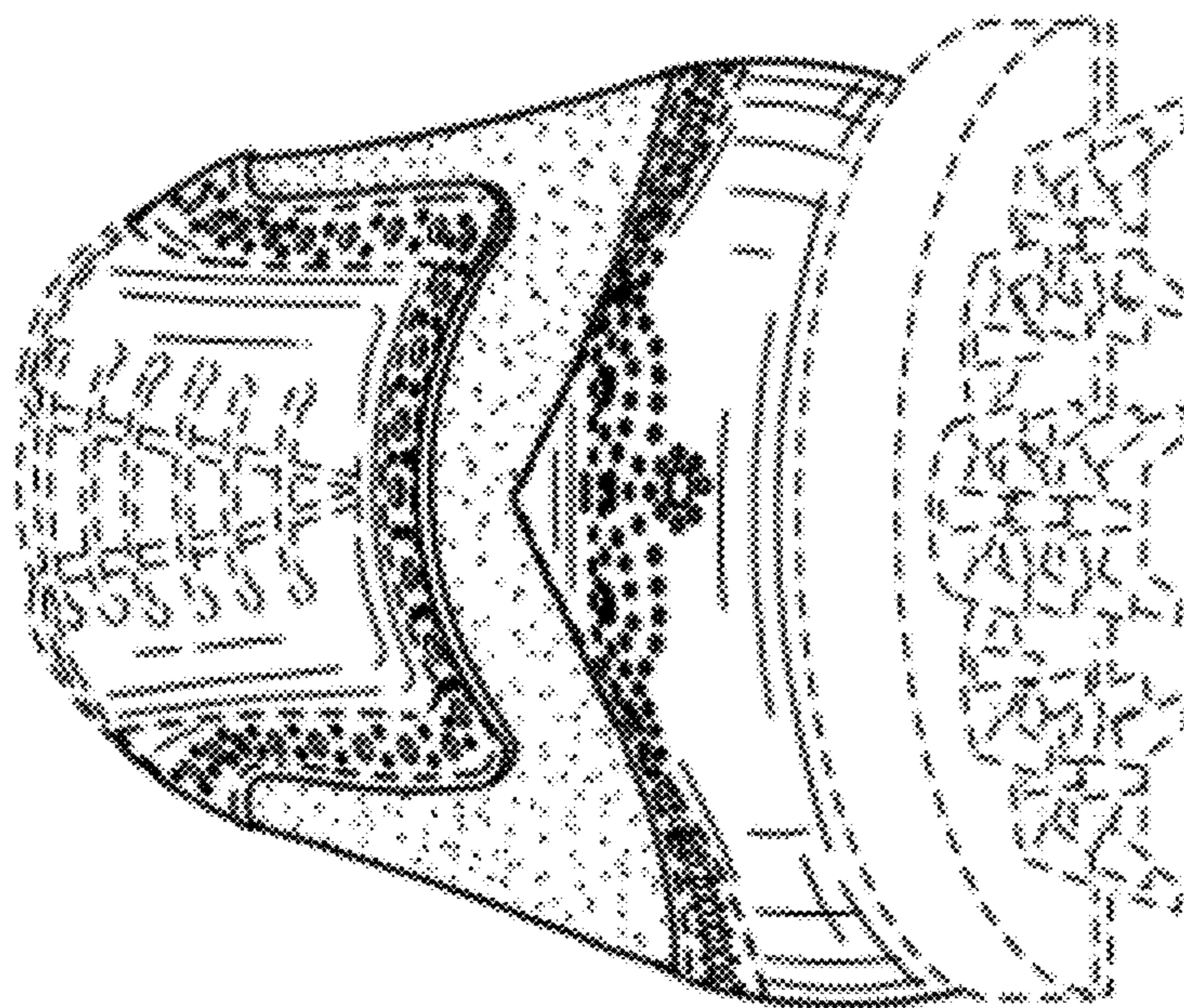
