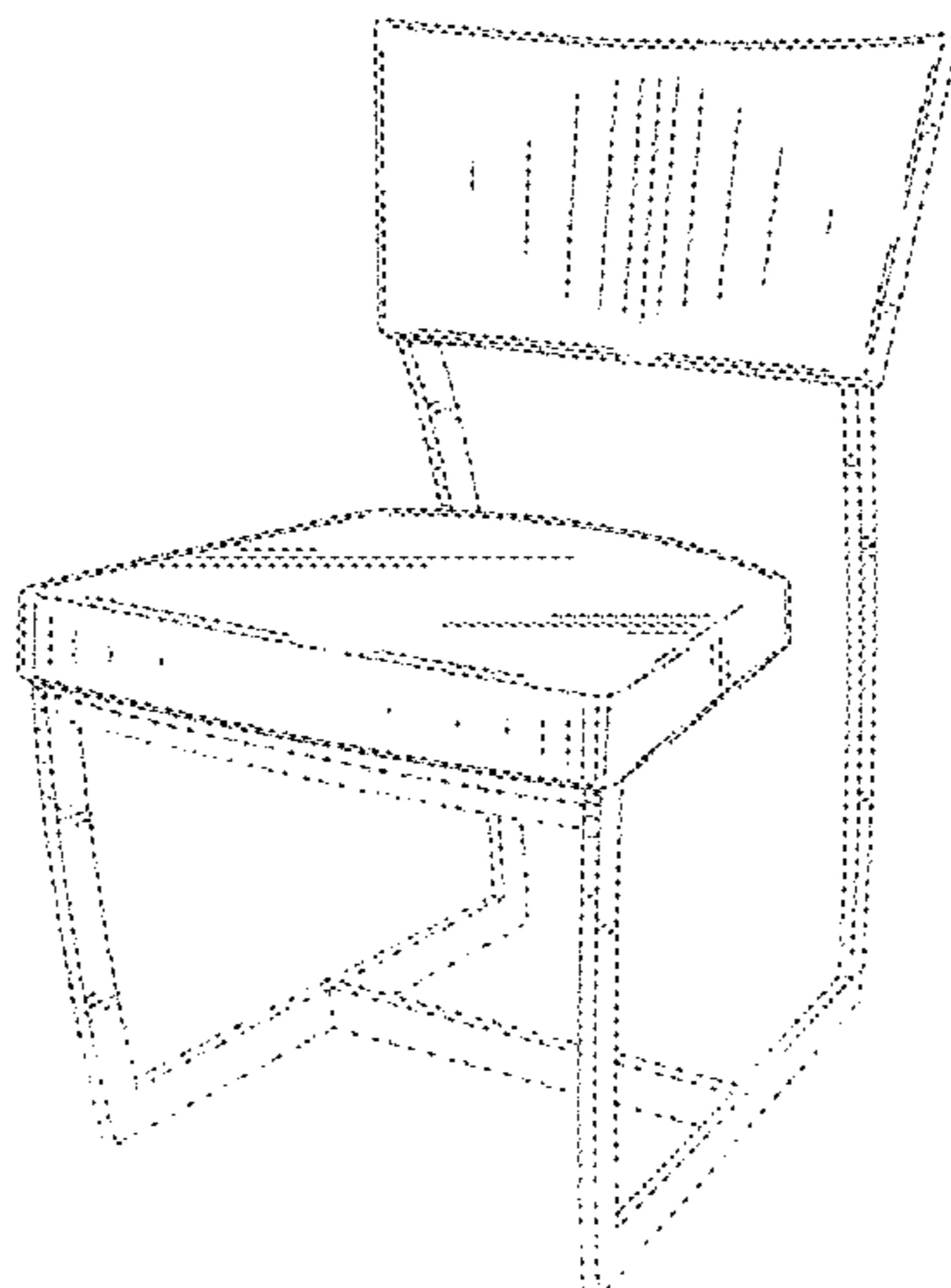
The ornamental design for a seat frame, as shown and described.

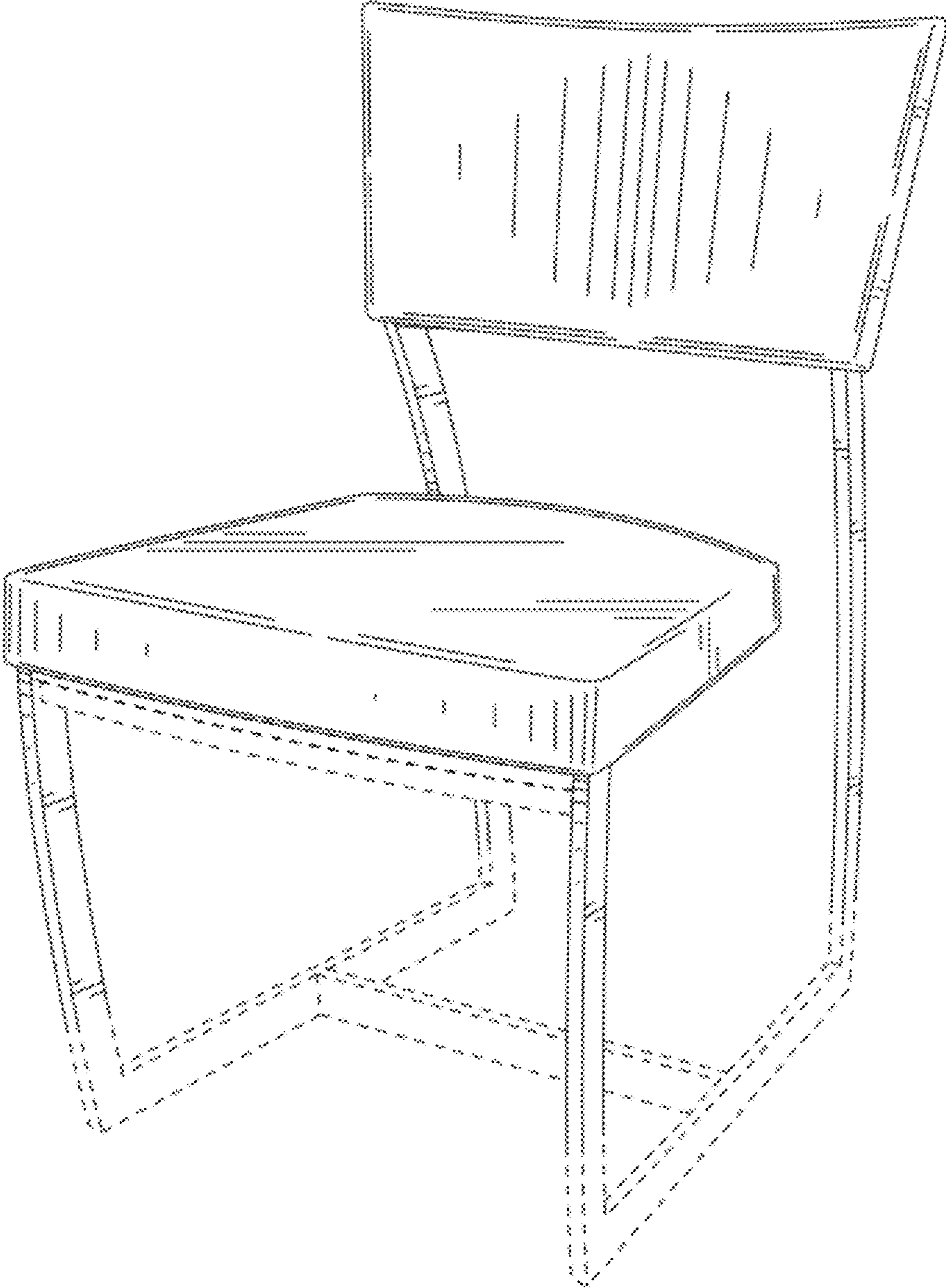

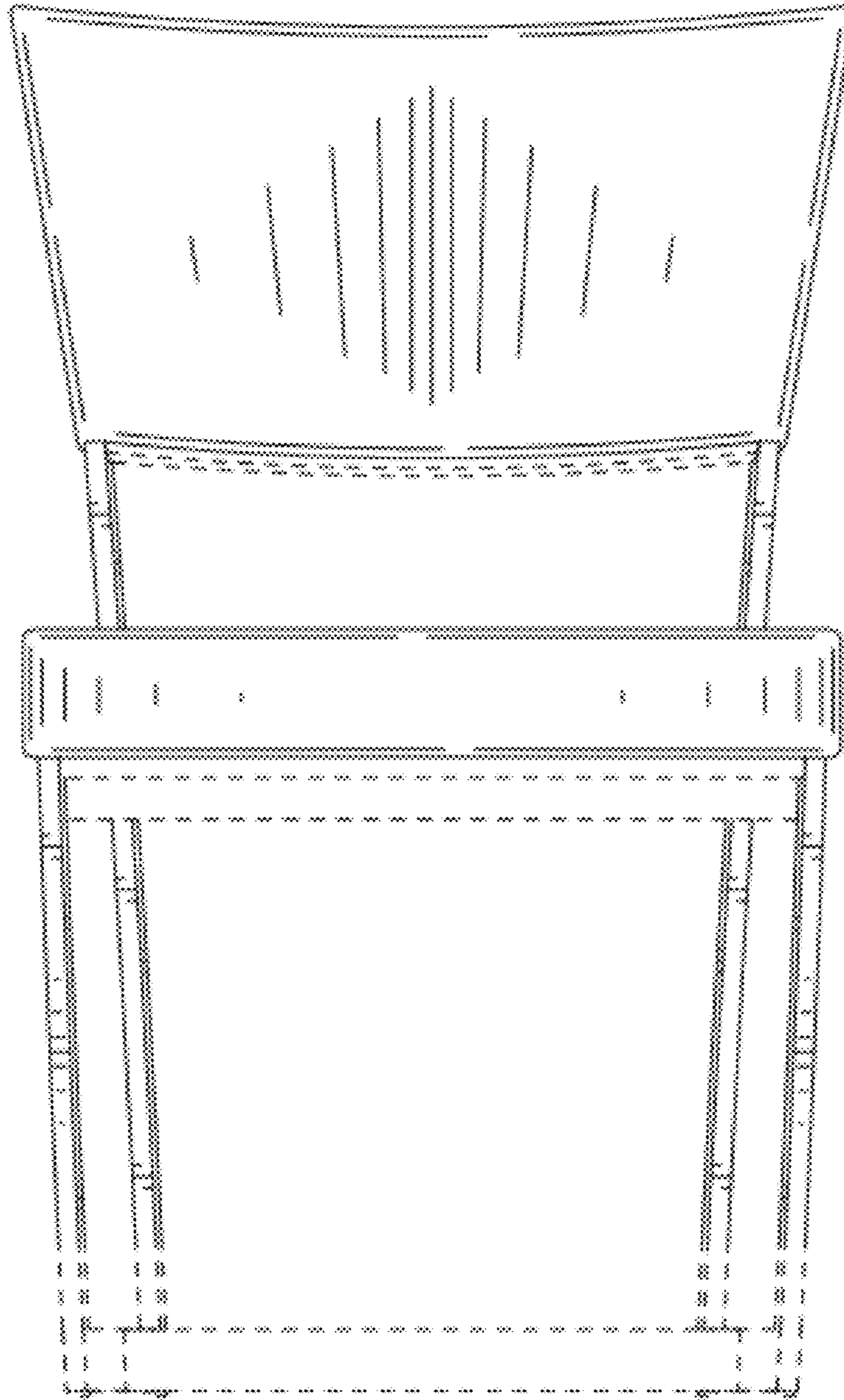

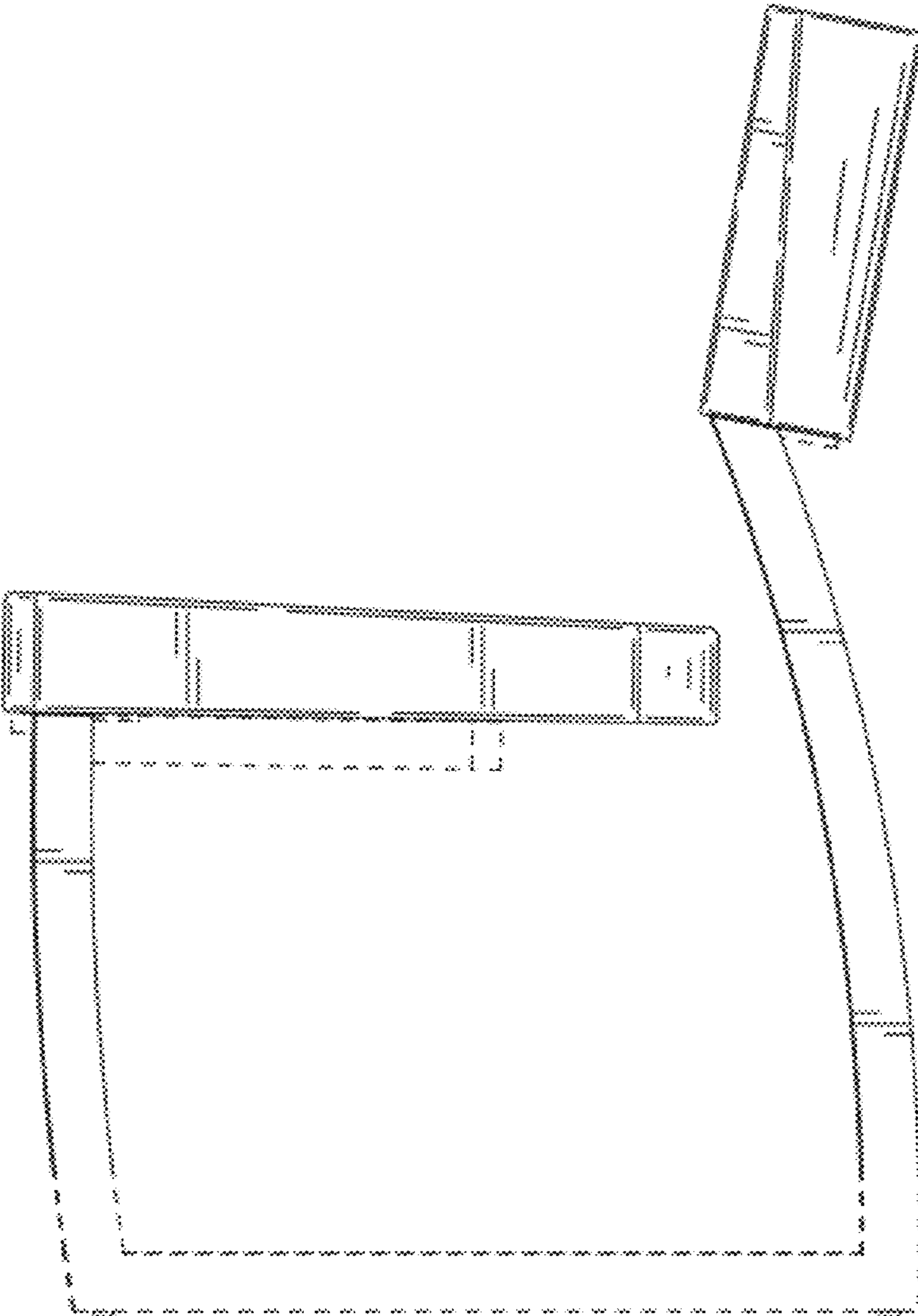

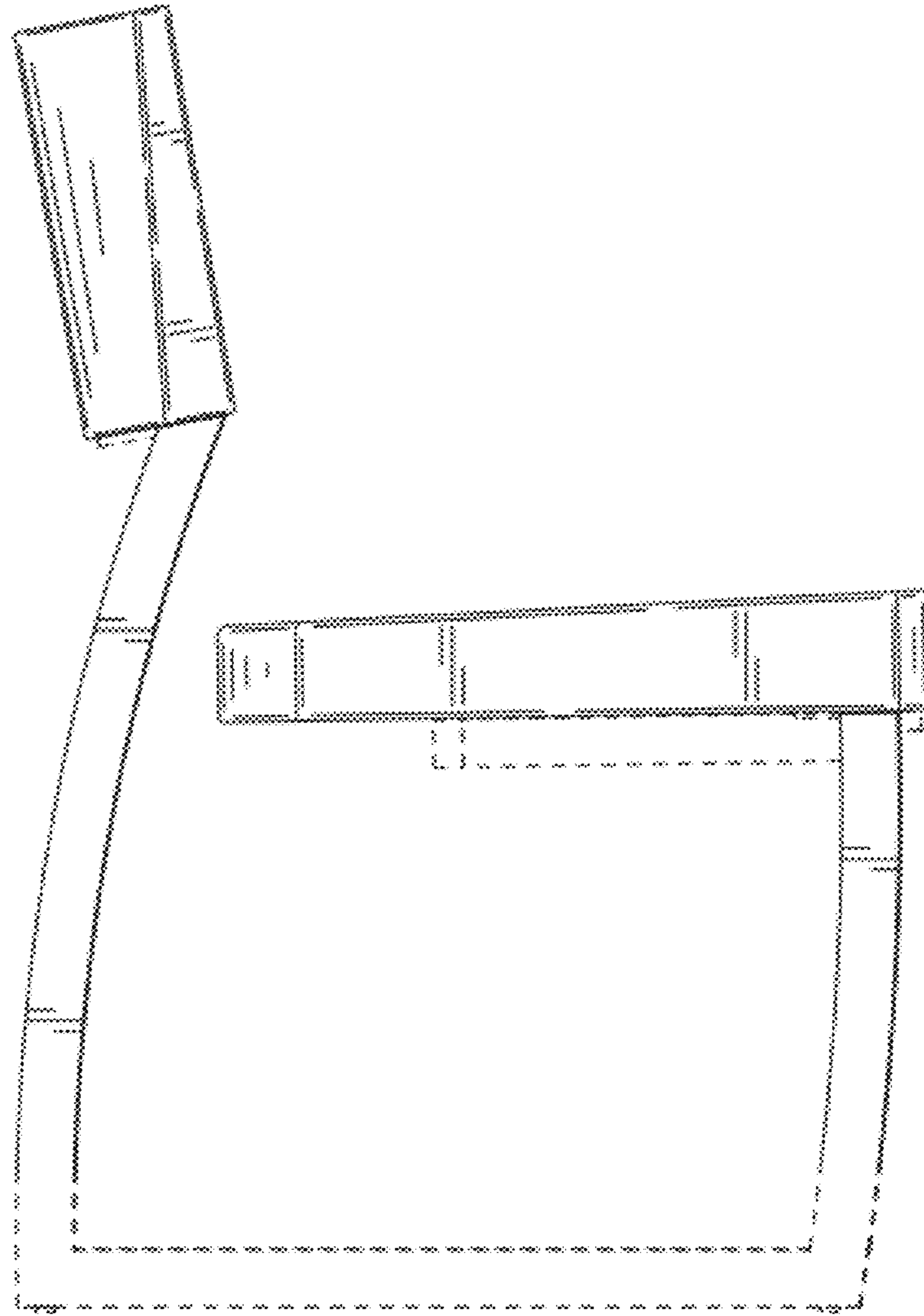

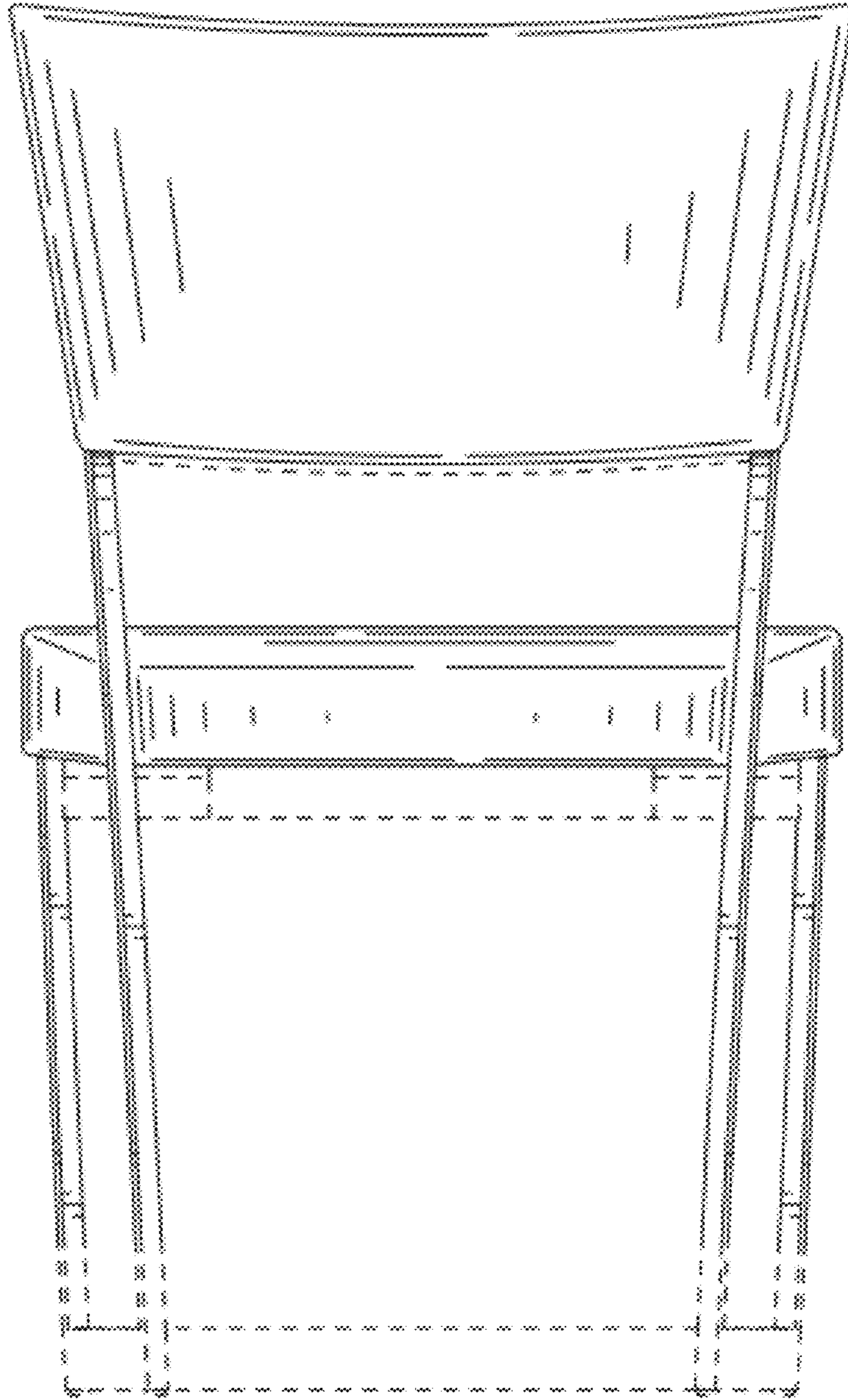

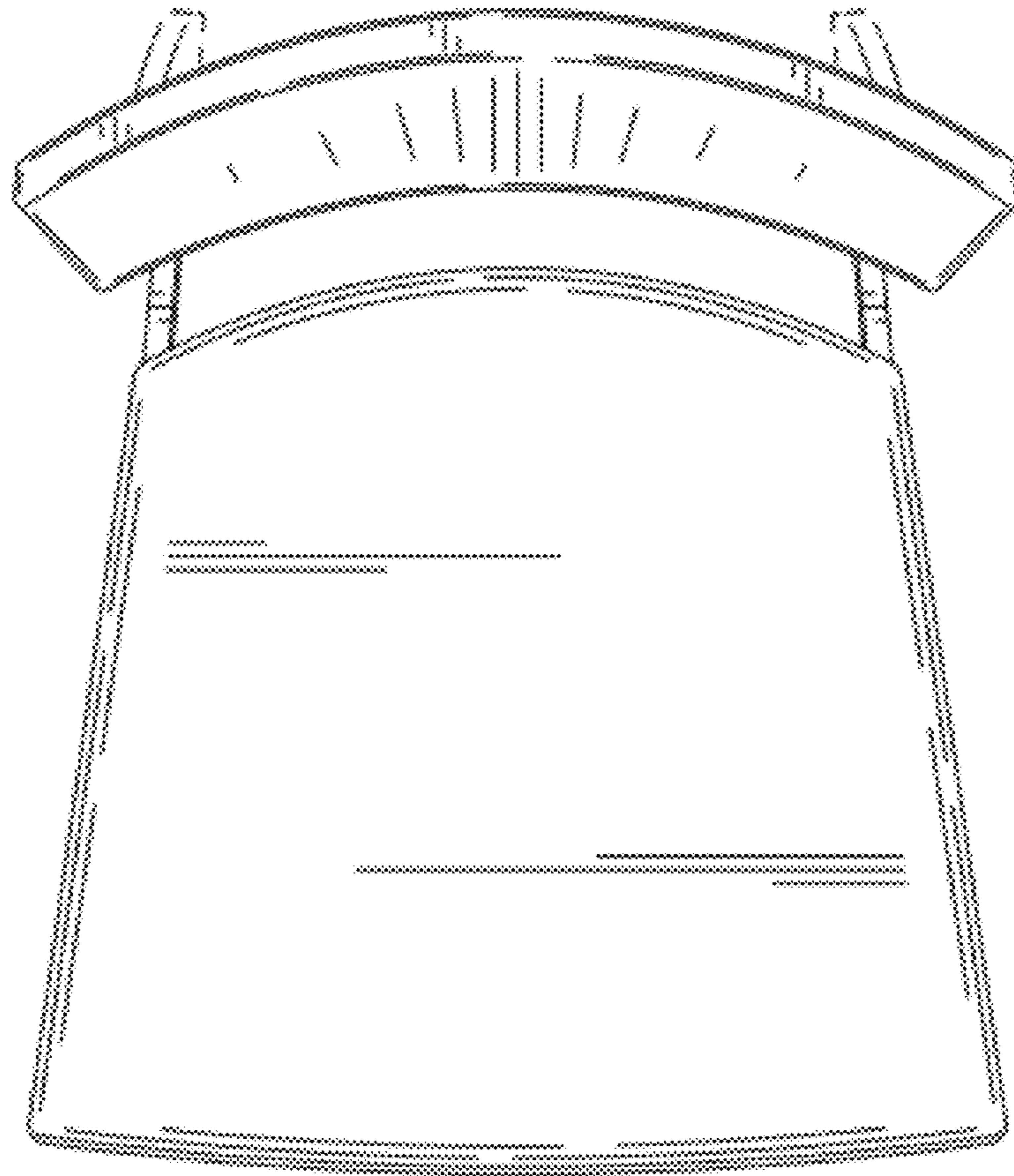
