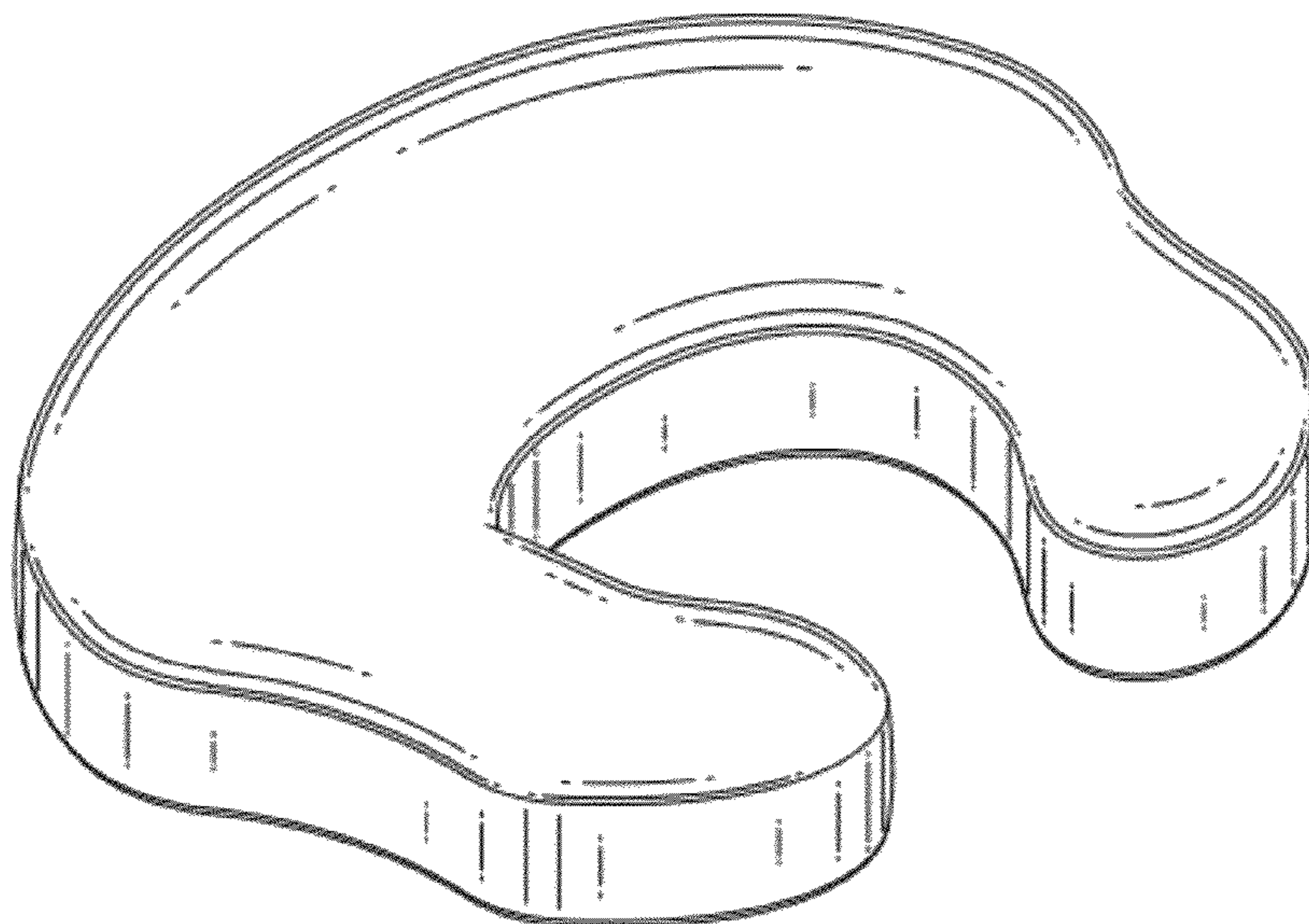
(57) **CLAIM**

The ornamental design for an infant support pillow, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an infant support pillow, according to the present invention.
FIG. 2 is a top view of the infant support pillow of FIG. 1;
FIG. 3 is a side view of the infant support pillow of FIG. 1, the opposite side being a mirror image thereof;

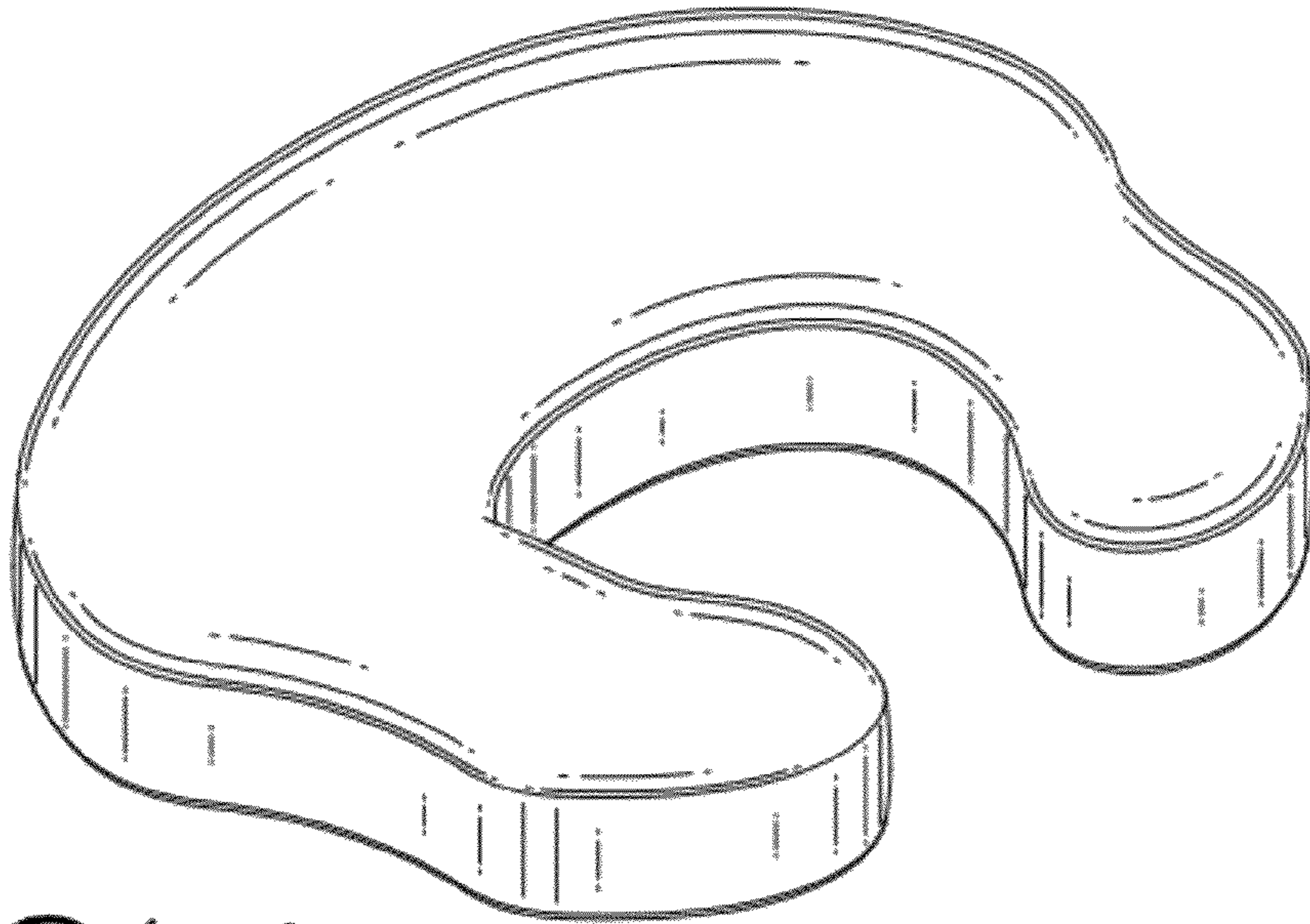

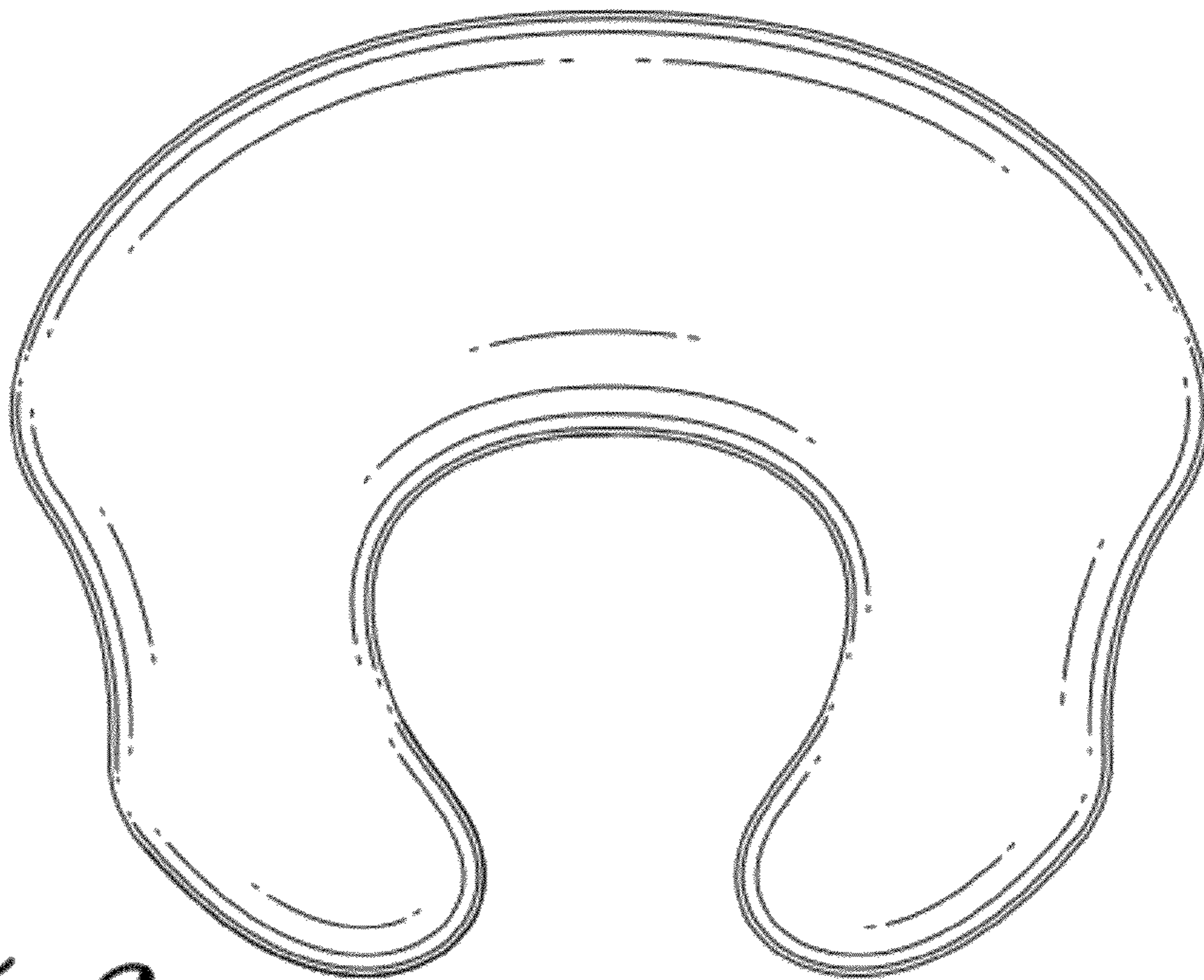

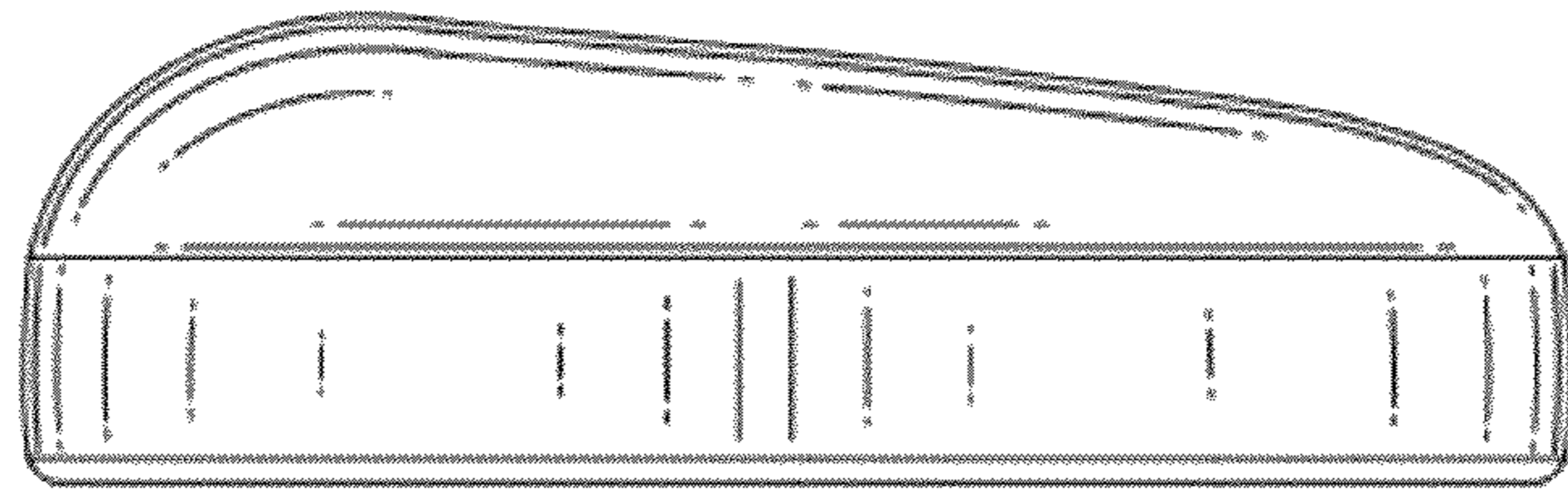

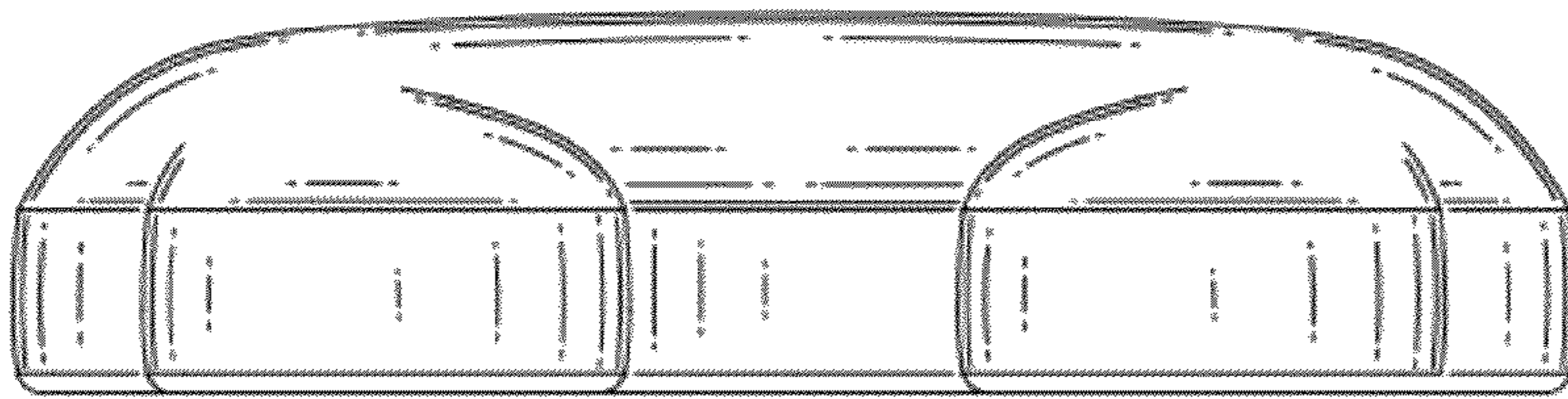

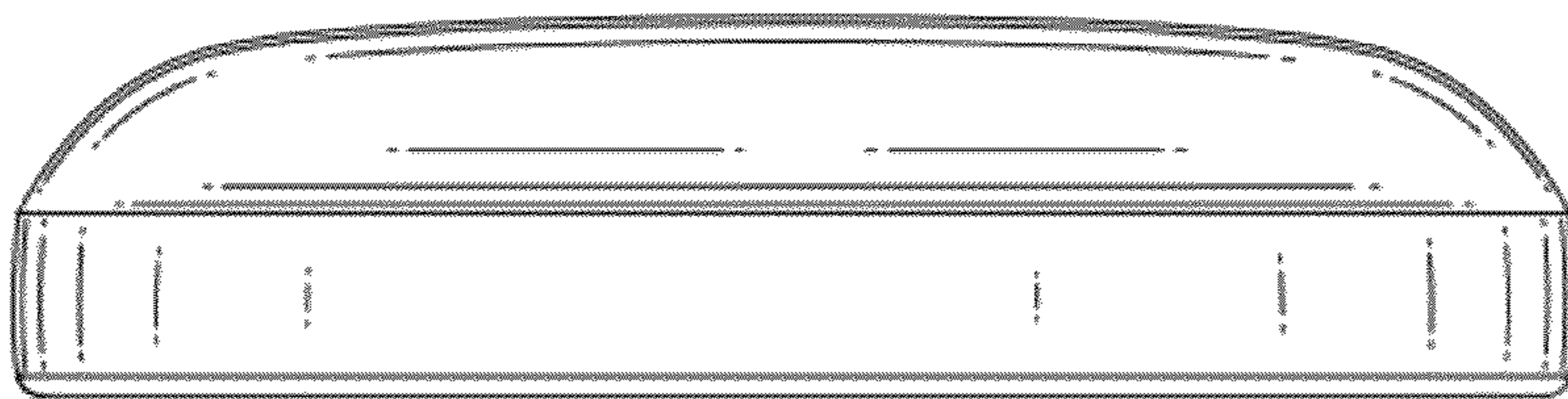

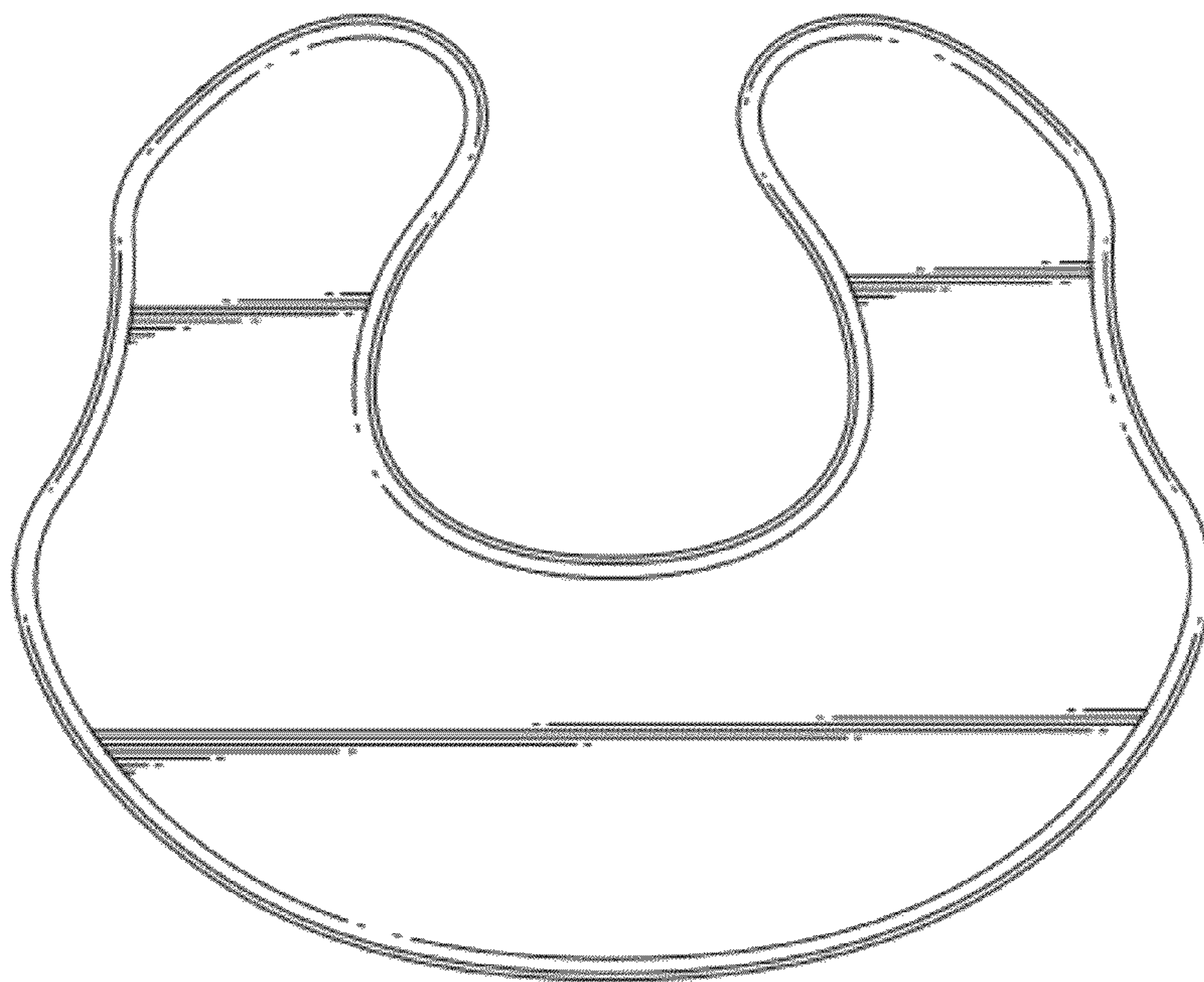
