DESCRIPTION

FIG. 1 is a front perspective view showing a cooking appliance according to a first embodiment of our new ornamental design;

FIG. 2 is a top view thereof;

FIG. 3 is a right side view thereof, with the left side view thereof being a mirror image thereof;

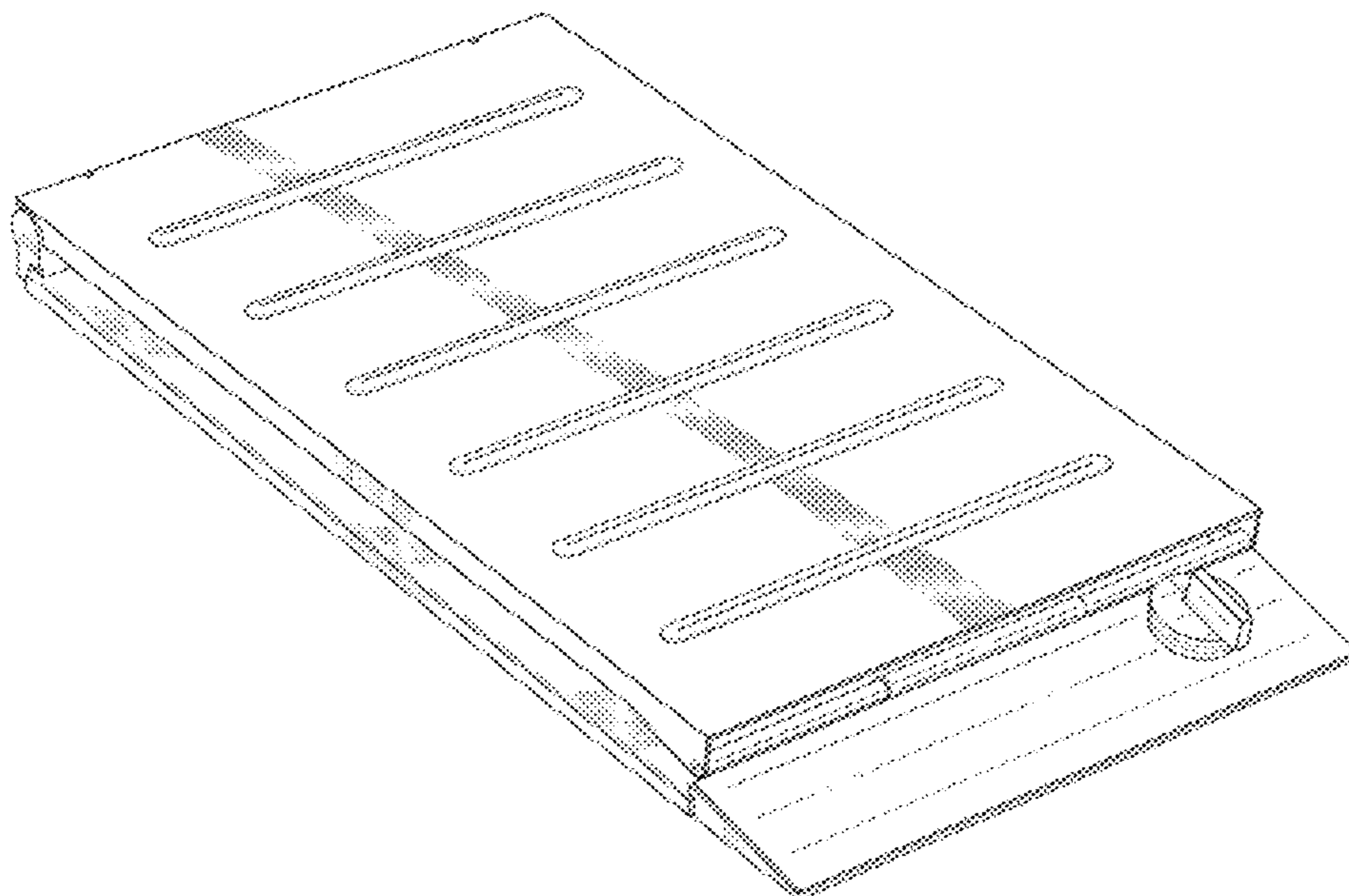
FIG. 4 is a bottom view thereof;

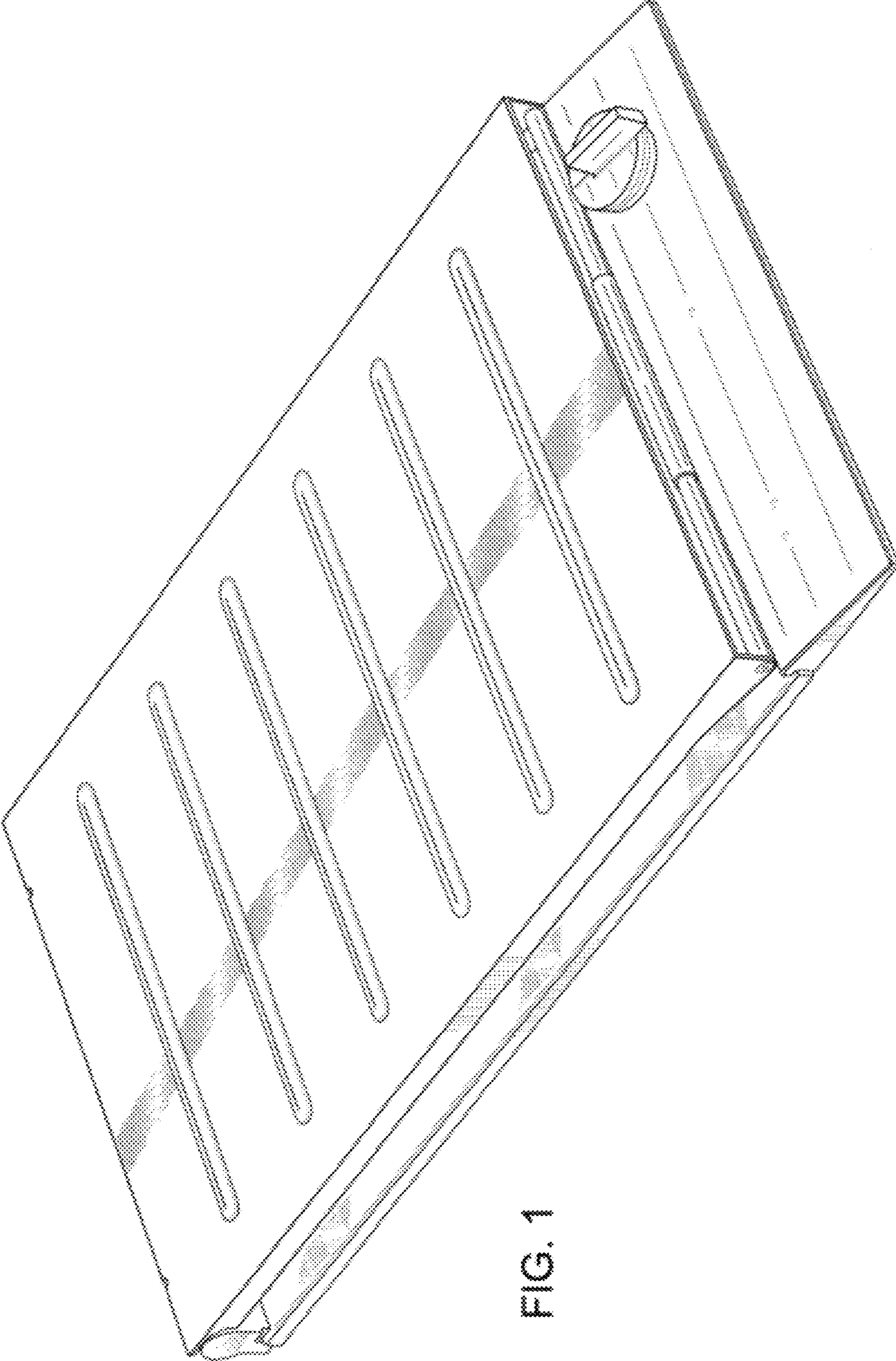

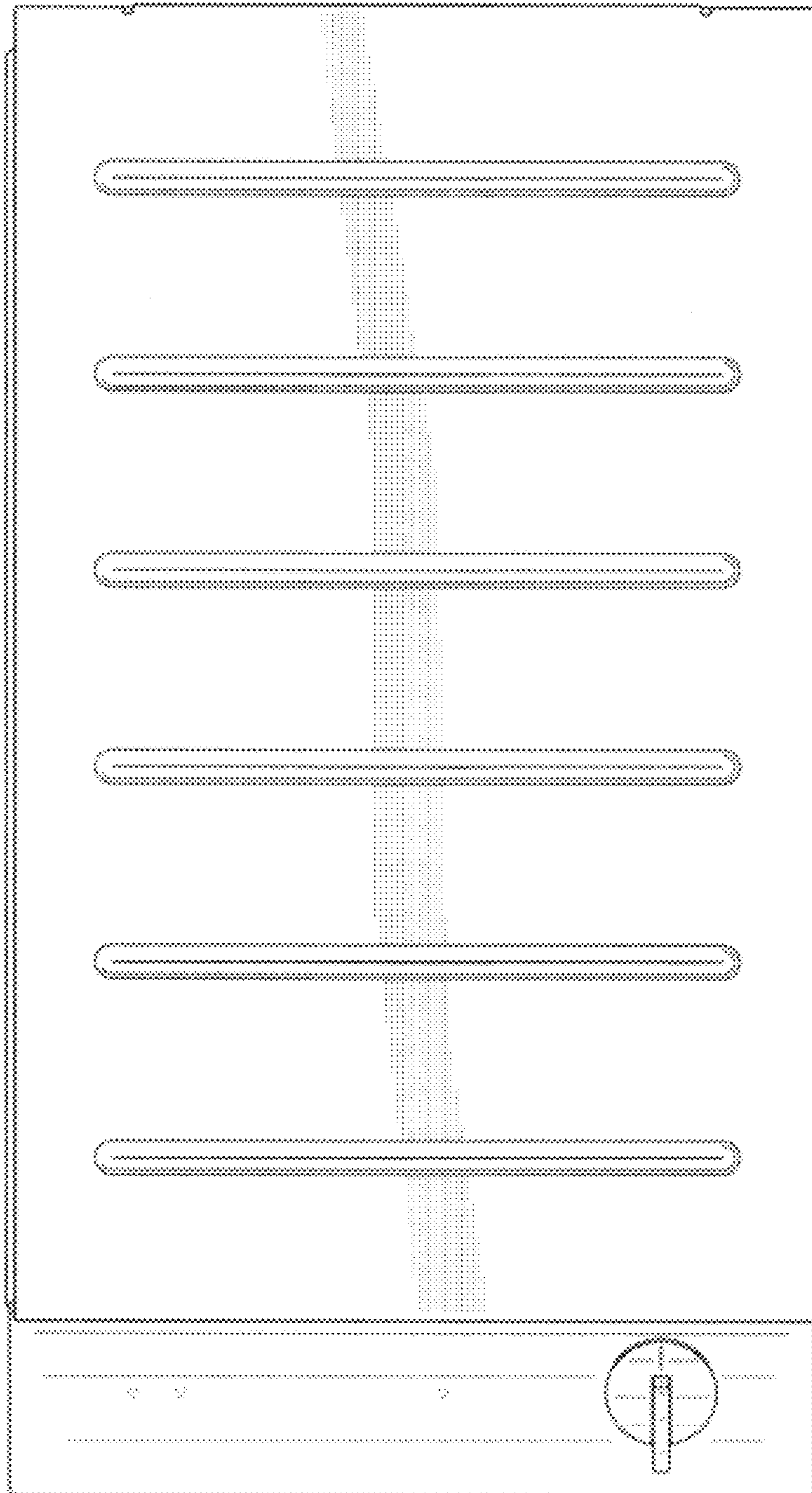

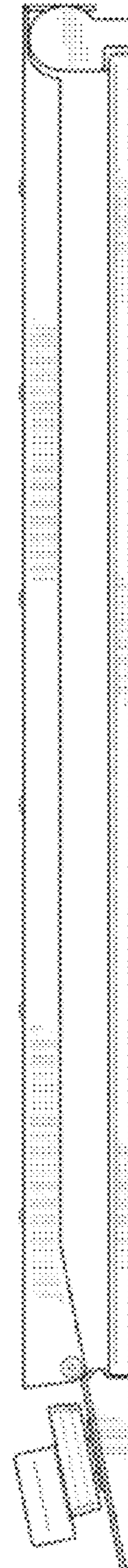

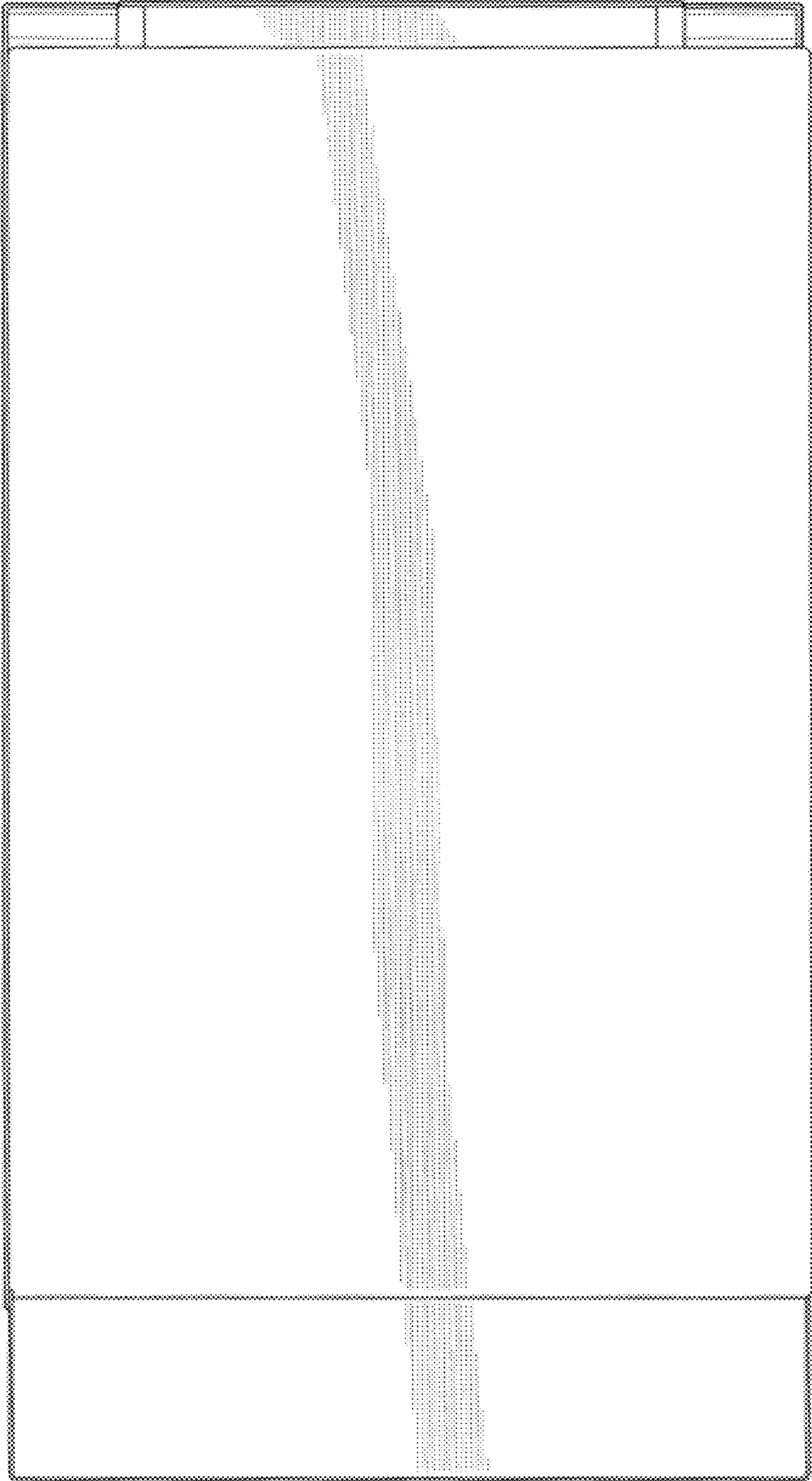

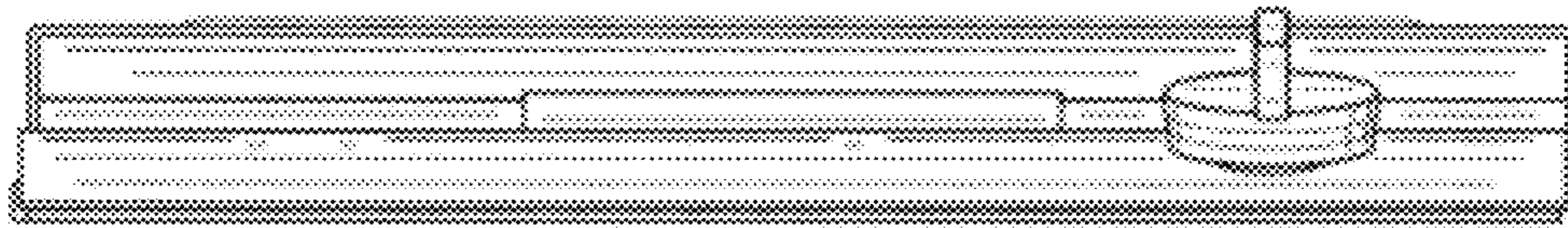

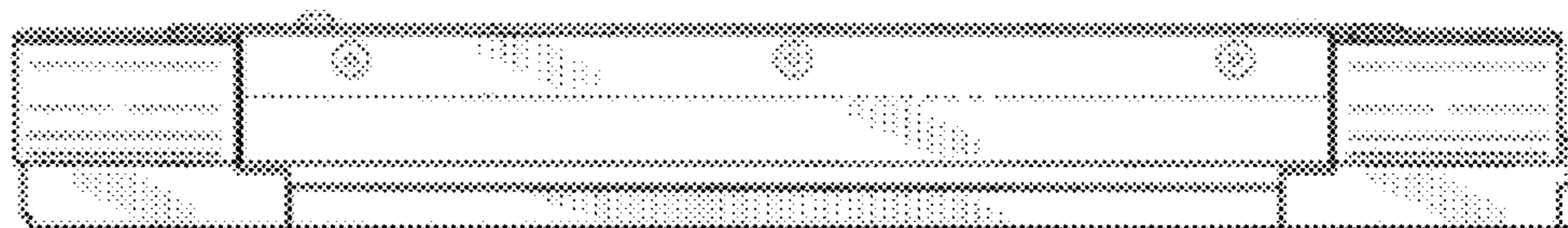
