DESCRIPTION

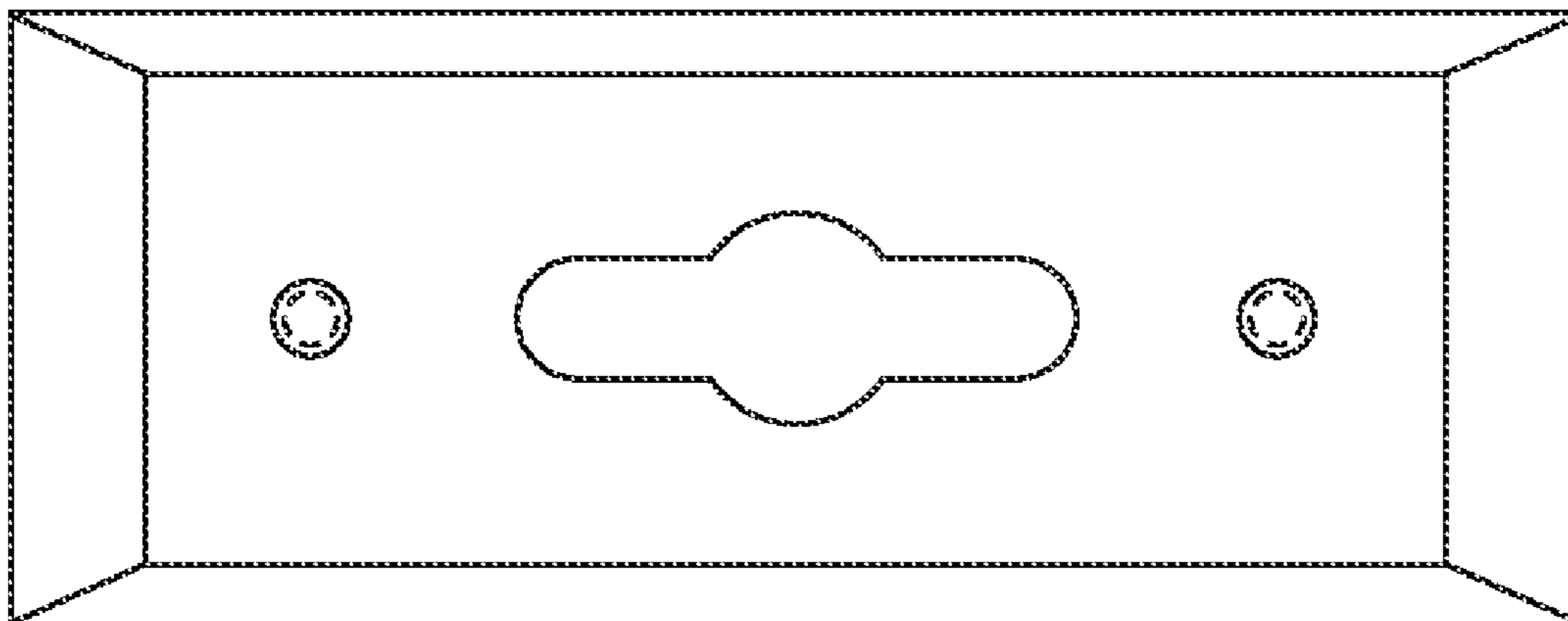

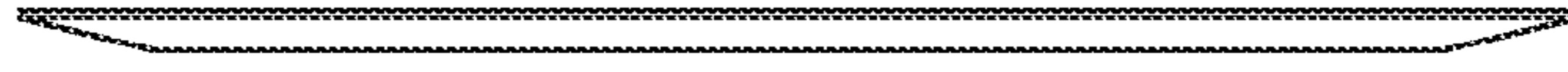

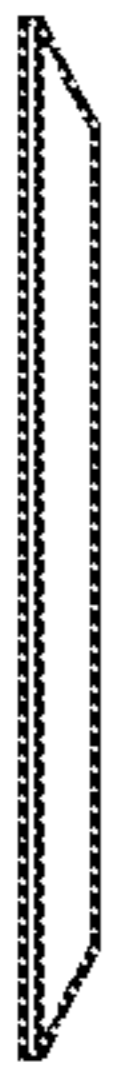
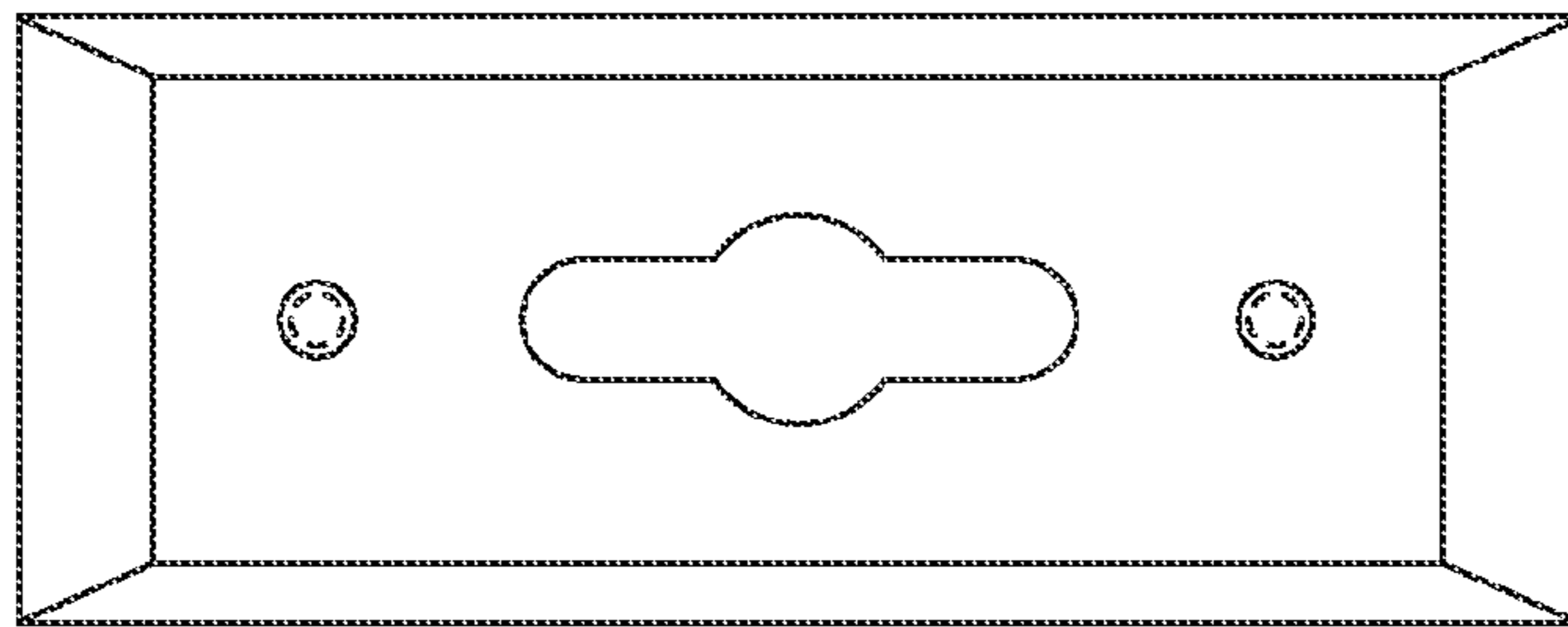

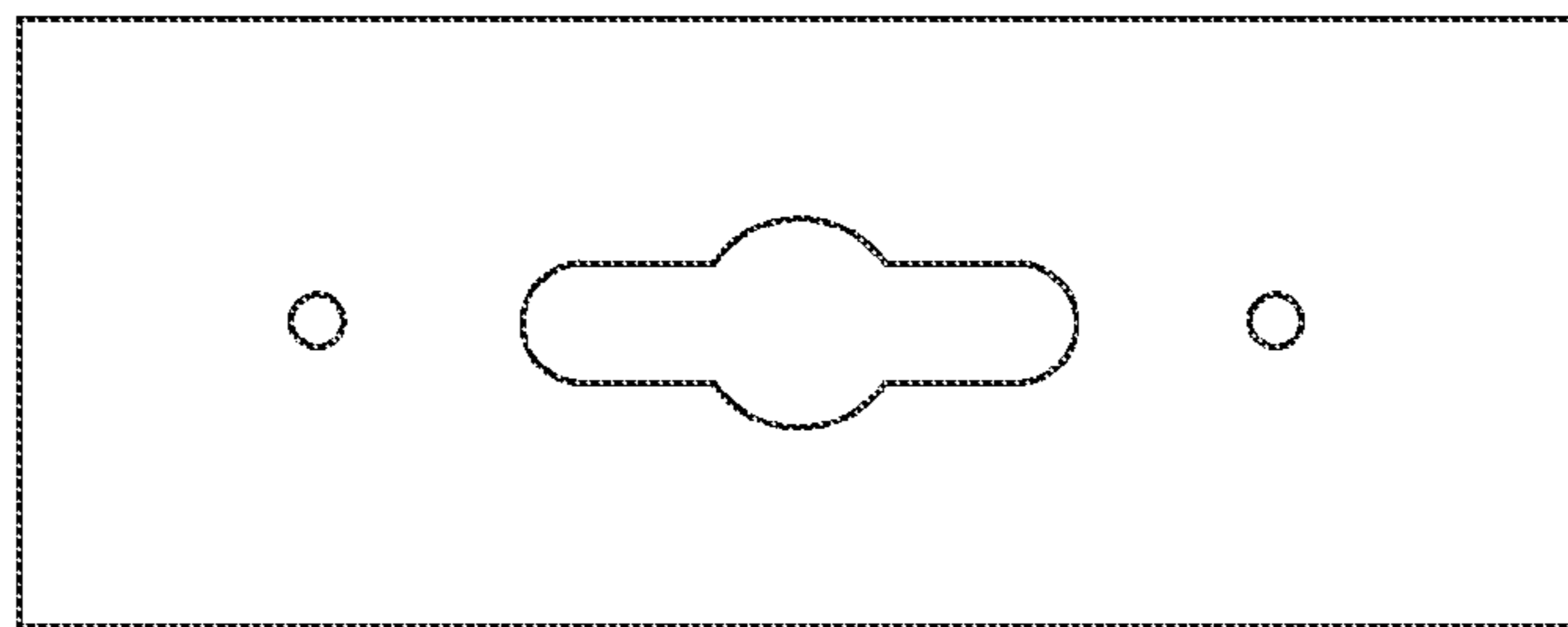
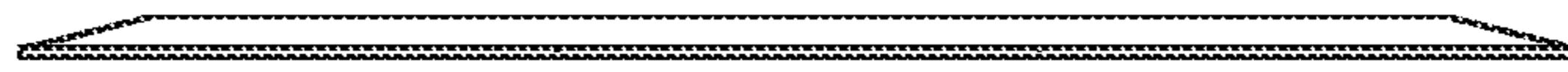

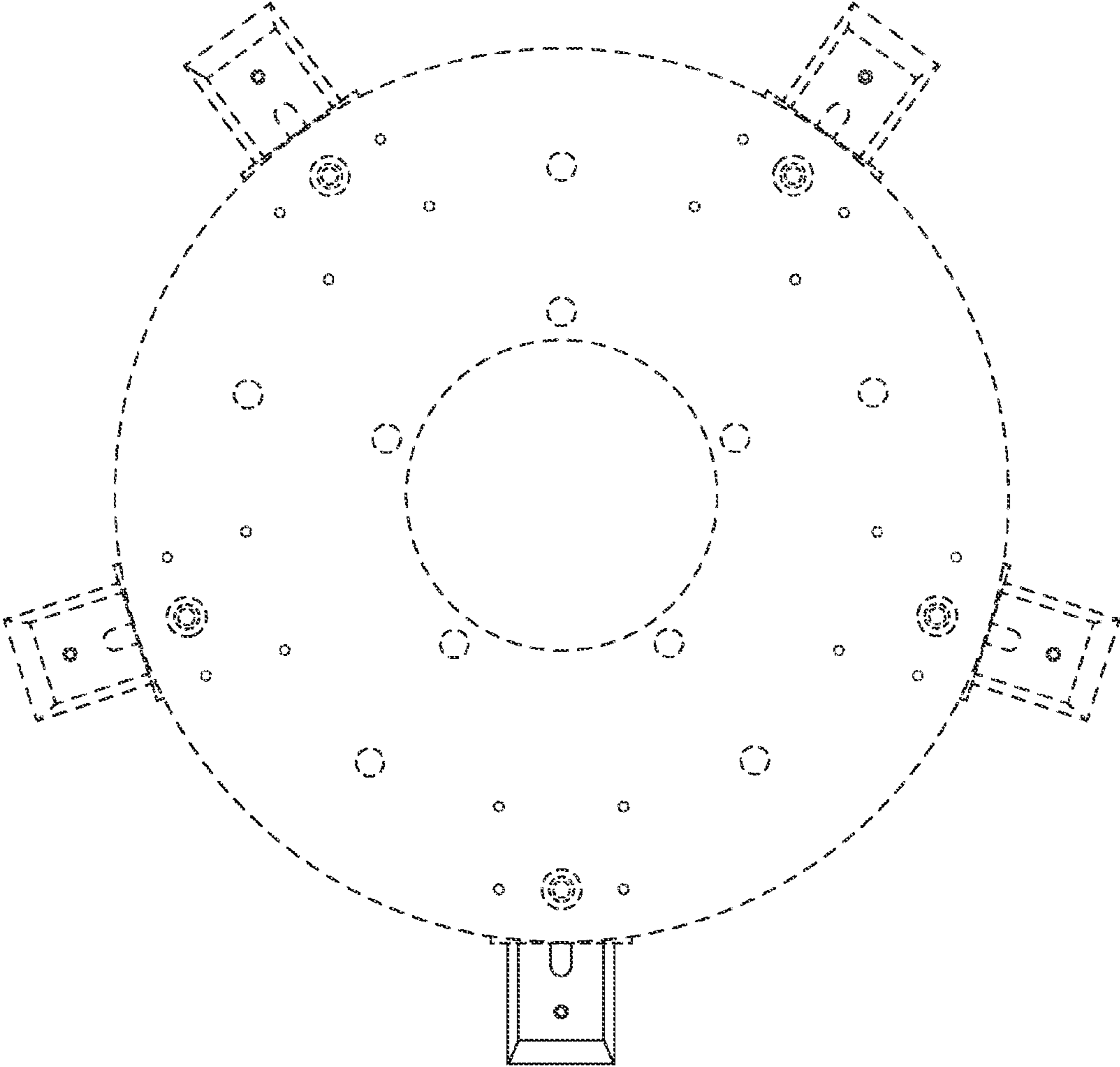

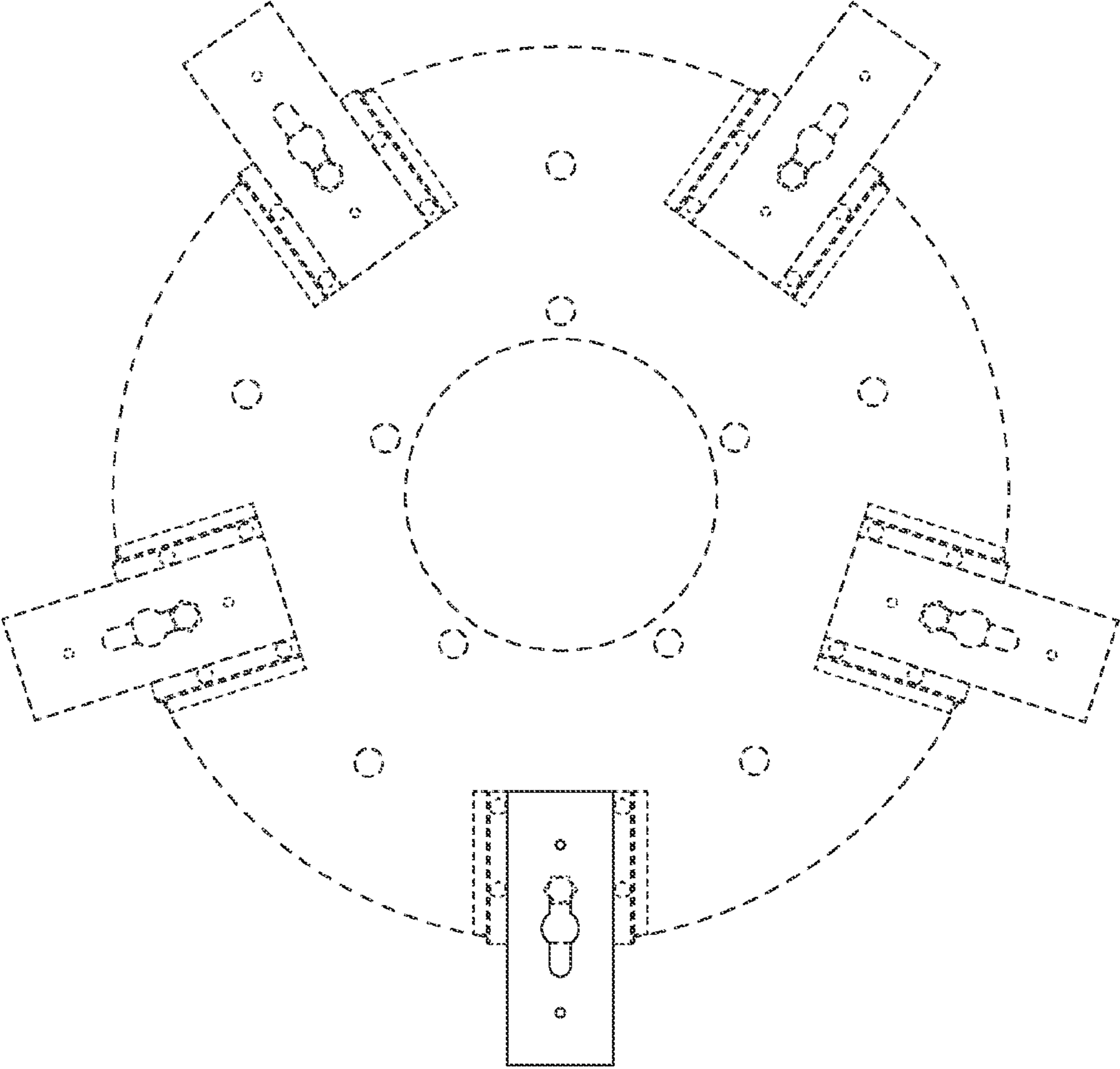
