The ornamental design for a vehicle license plate frame, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vehicle license plate frame, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof, the left side being a mirror image;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a rear perspective view thereof.

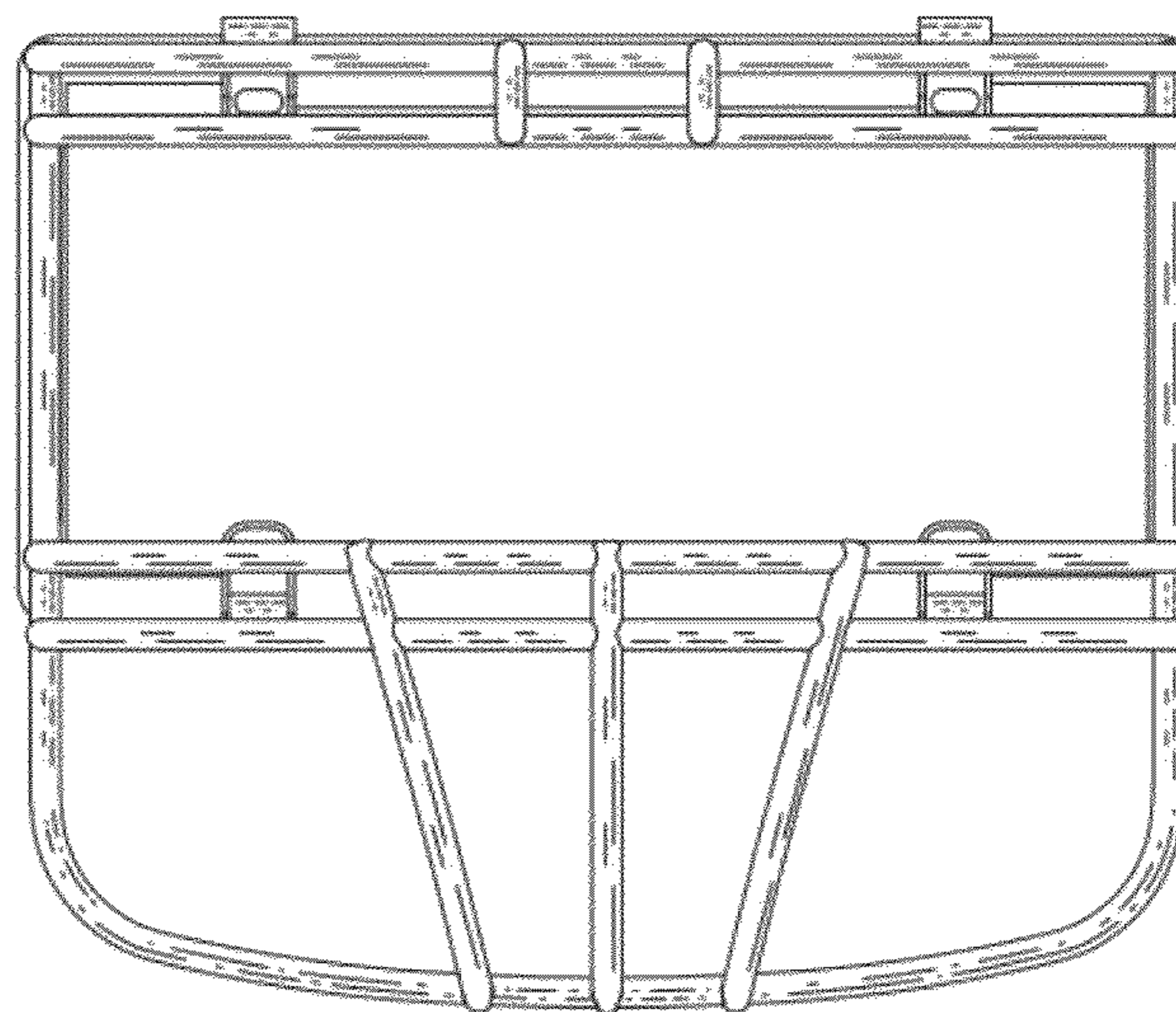
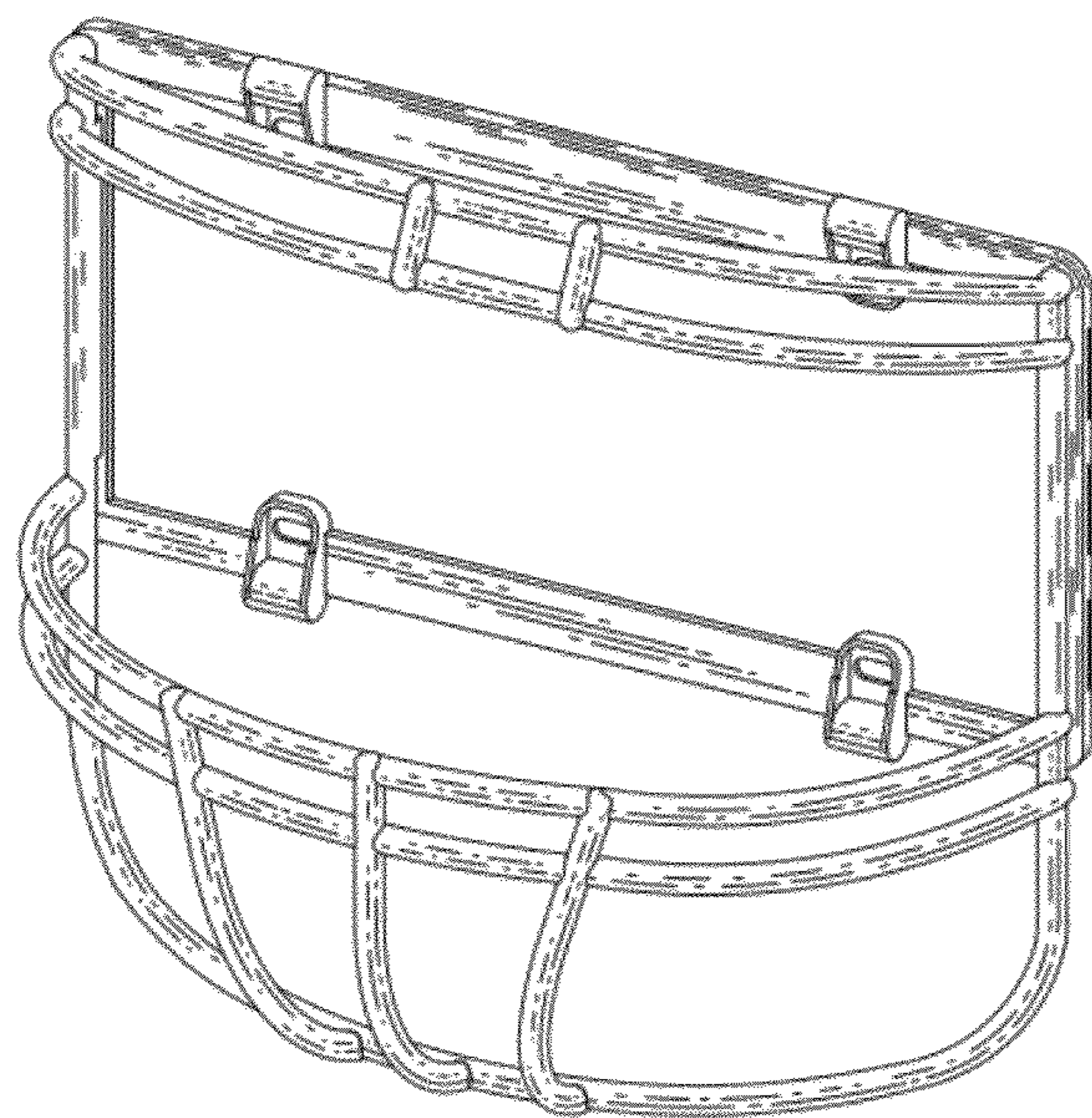

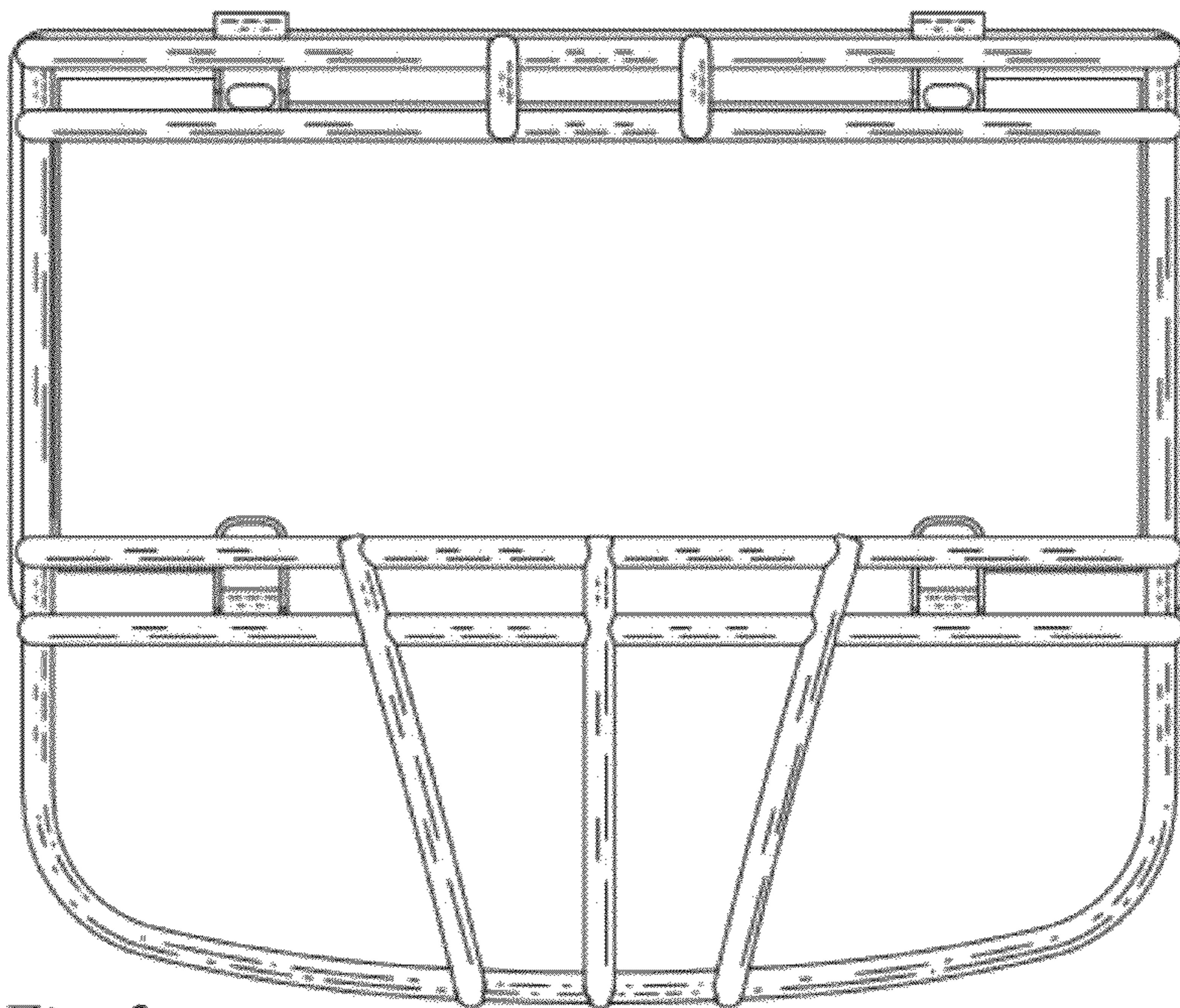

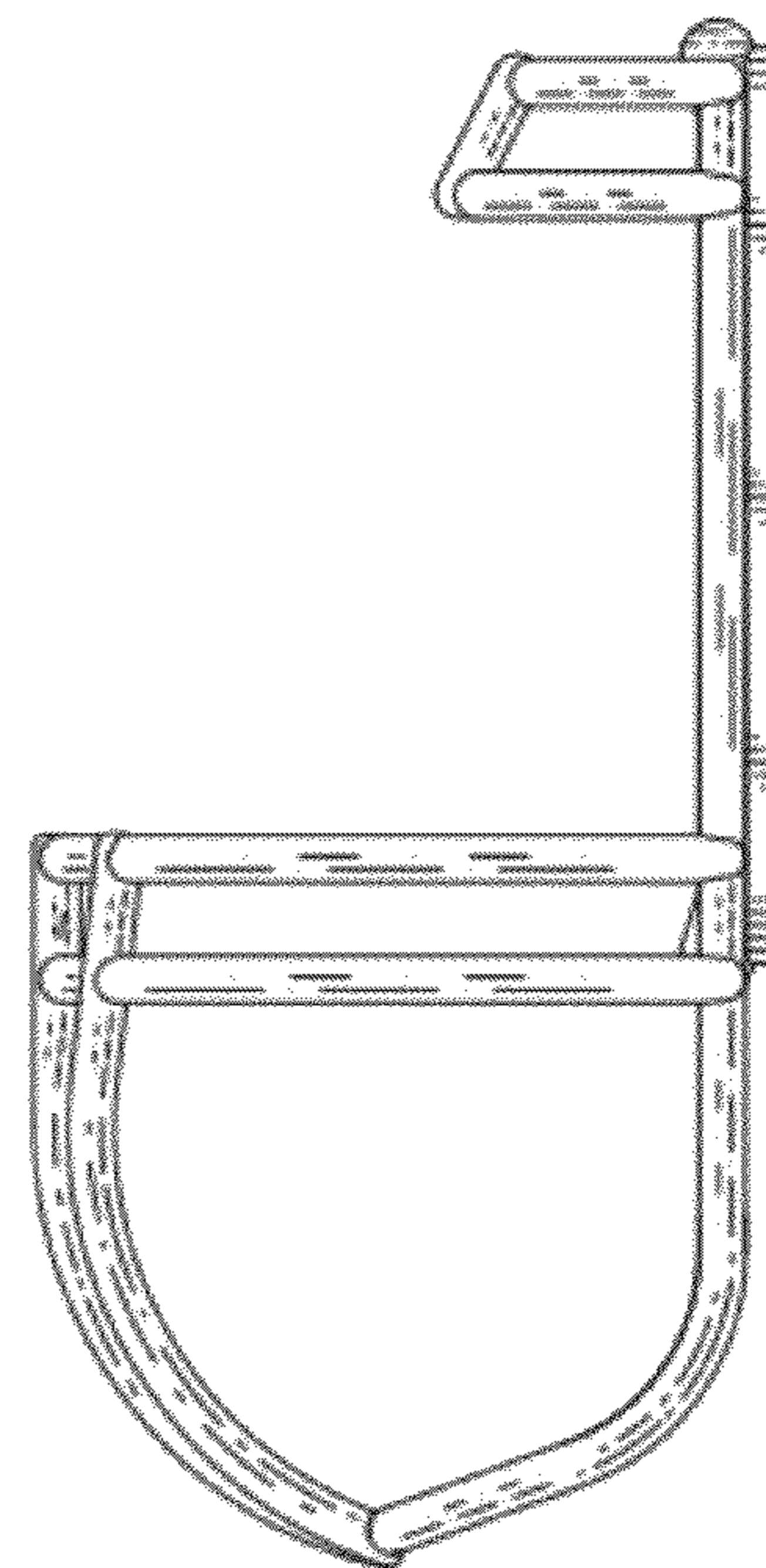

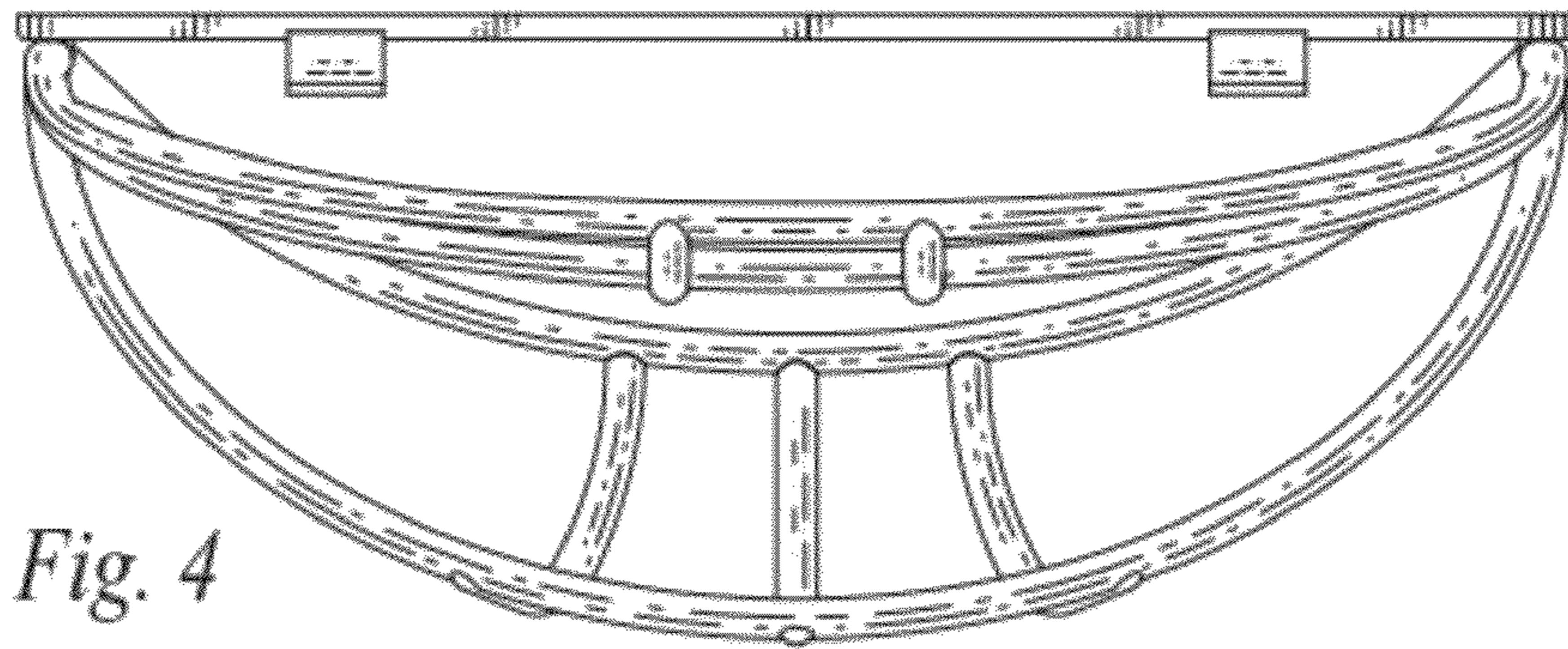

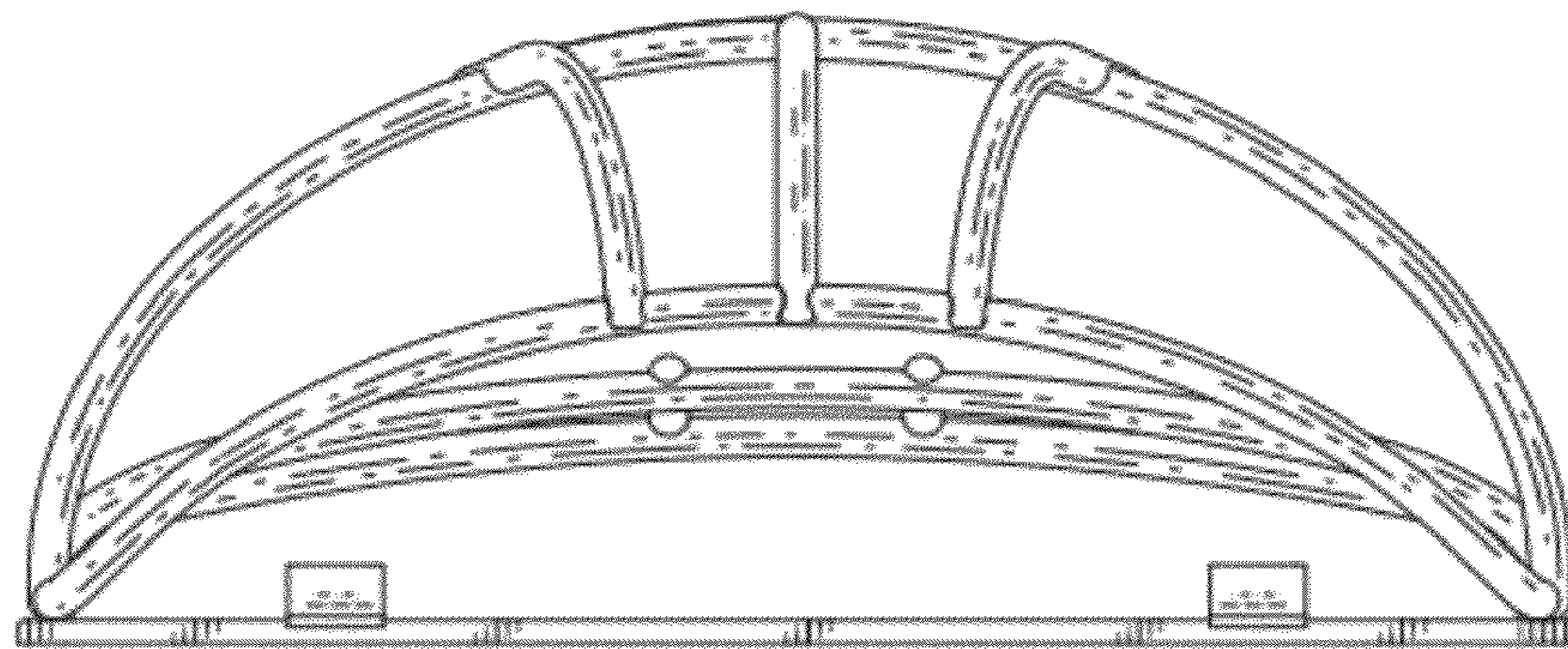

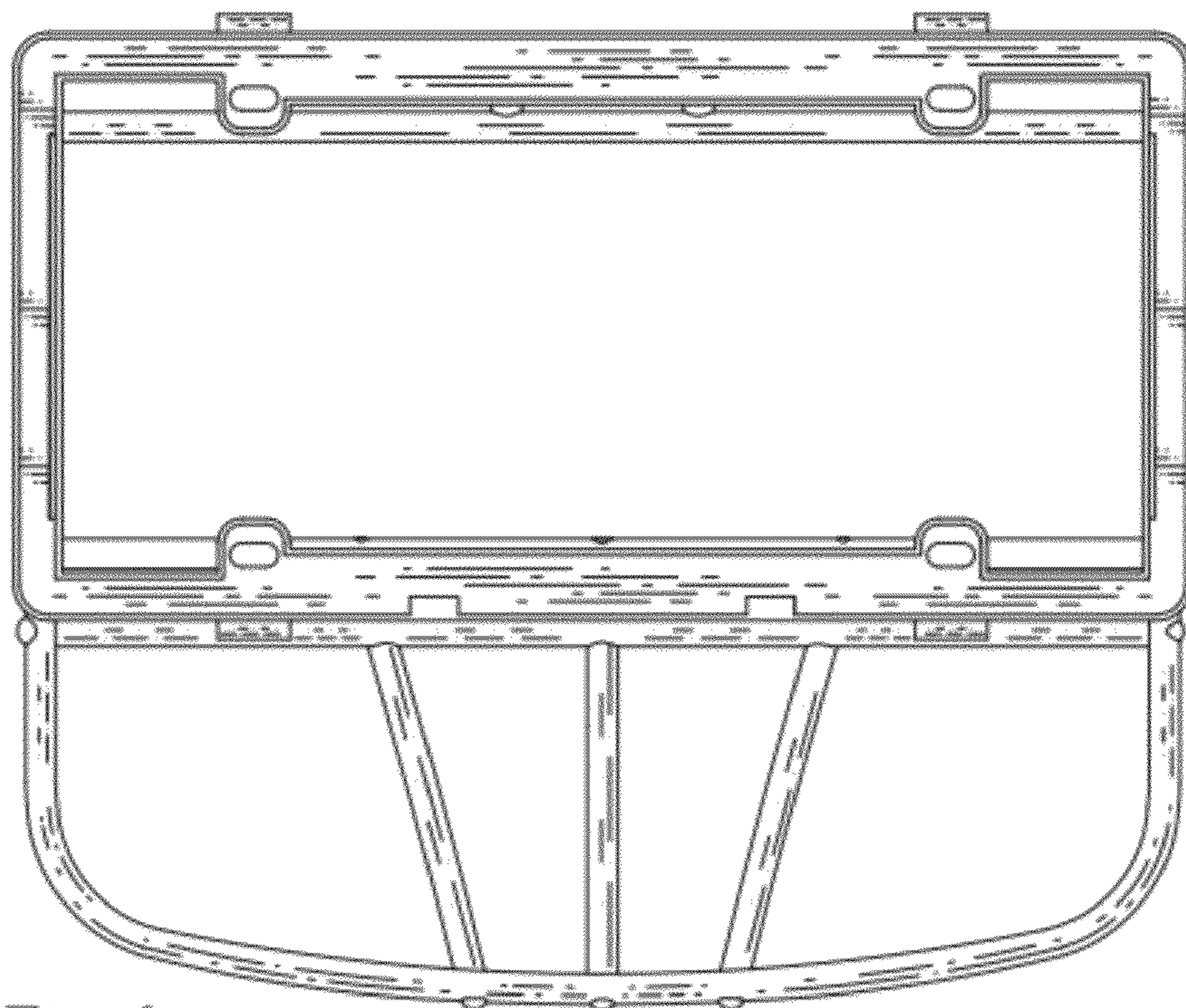

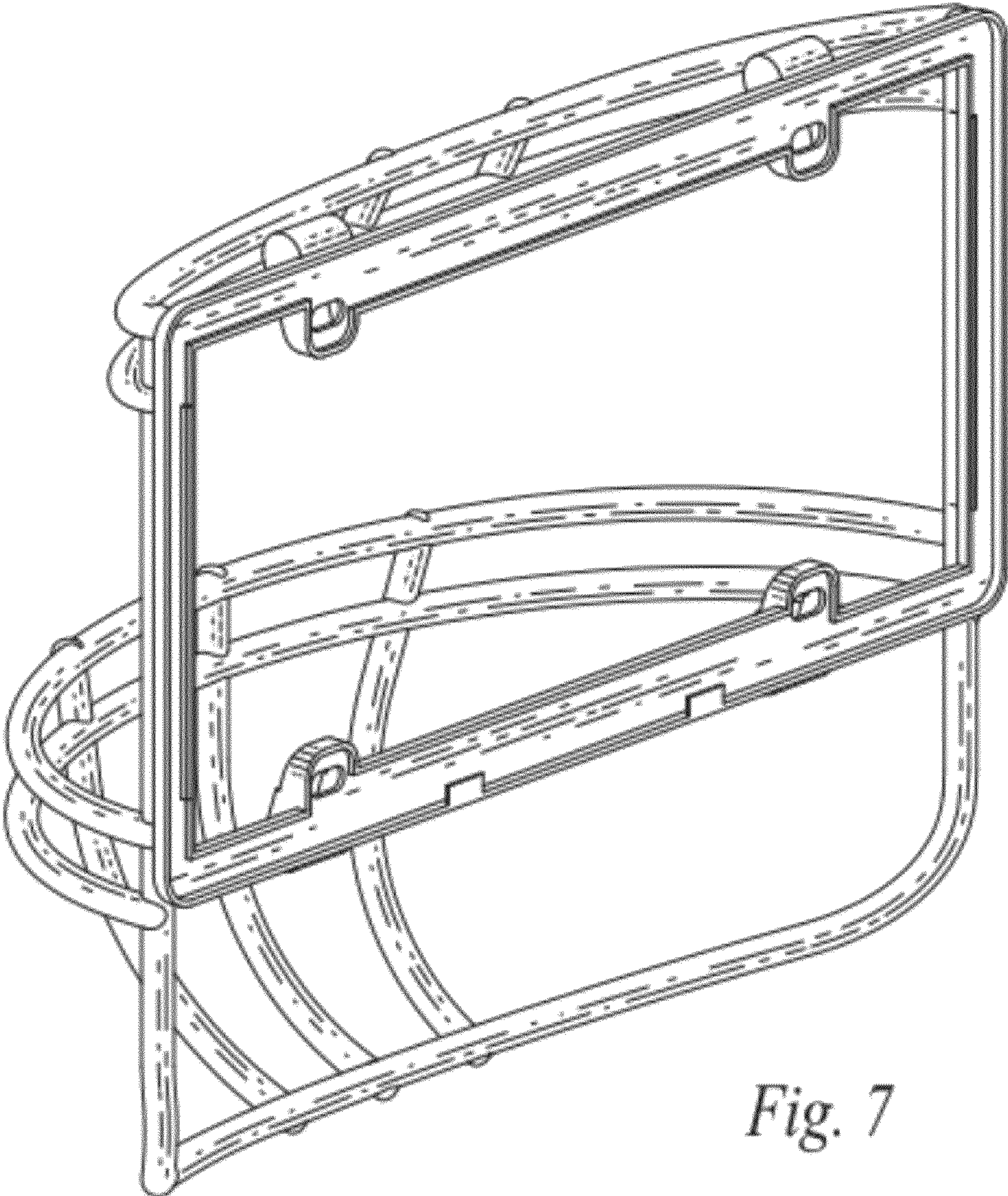
