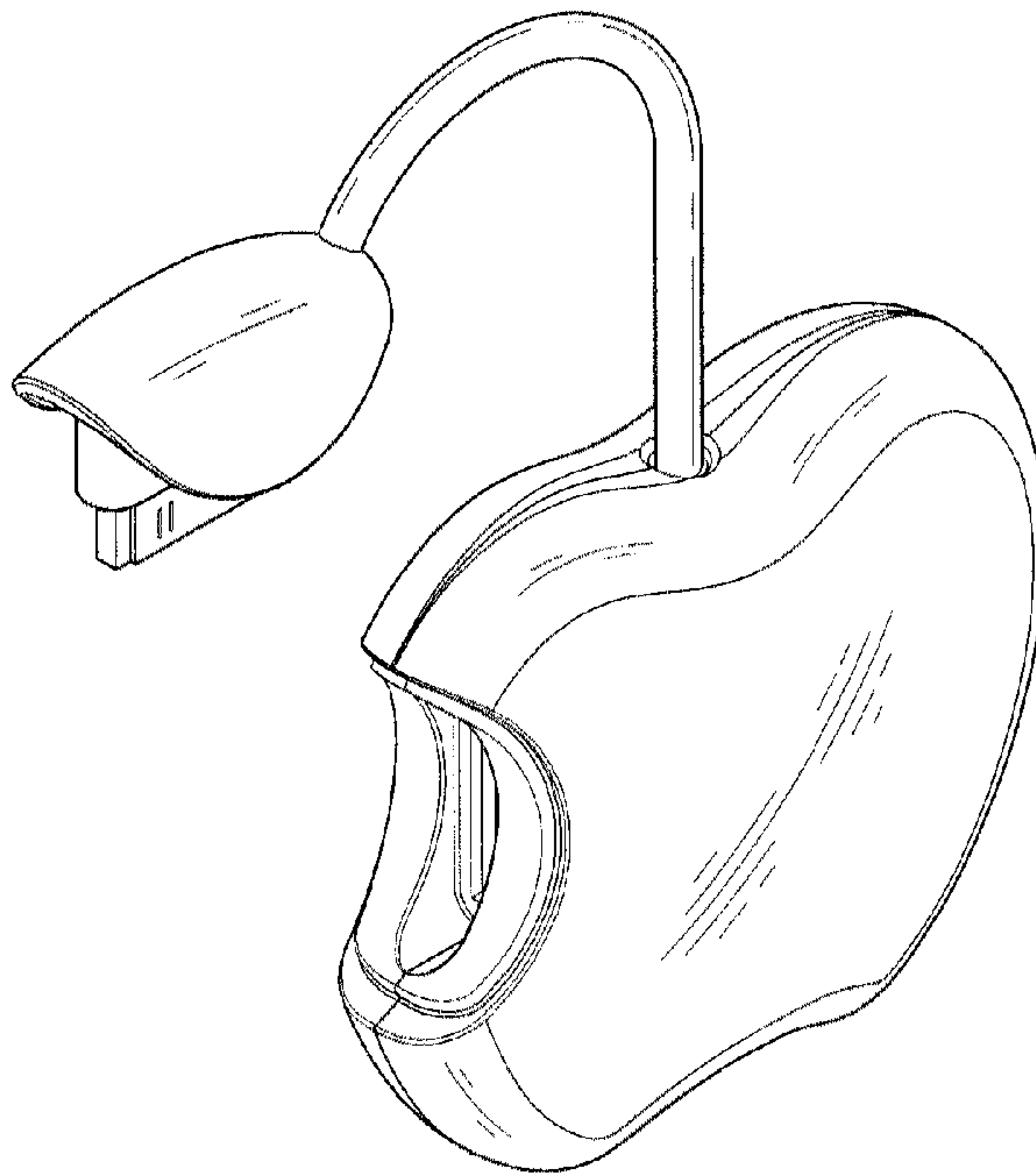
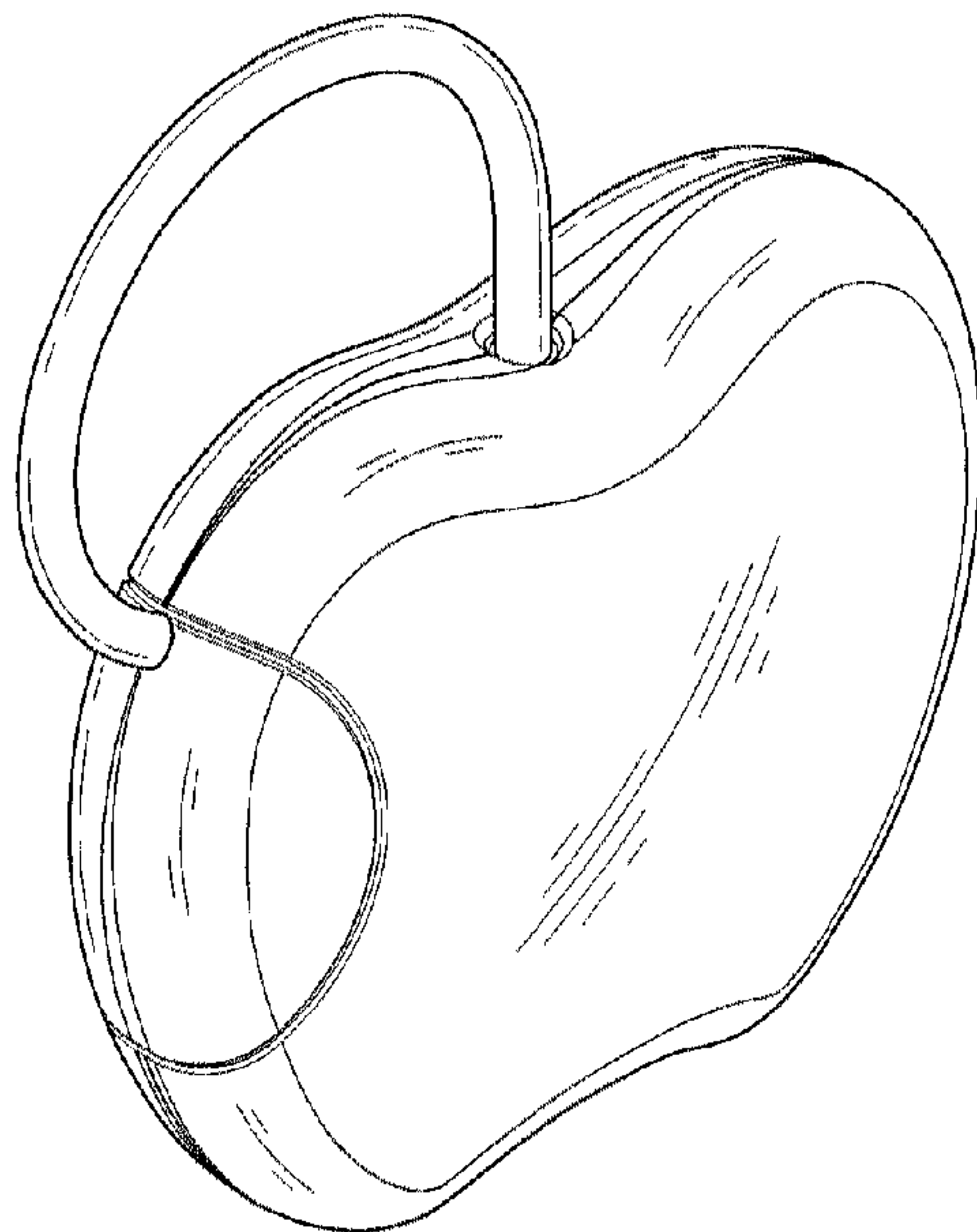
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a portable power charger showing my new design;
 FIG. 2 is a perspective view thereof from another angle;
 FIG. 3 is a front elevational view thereof; the rear elevational view being a mirror image thereof;

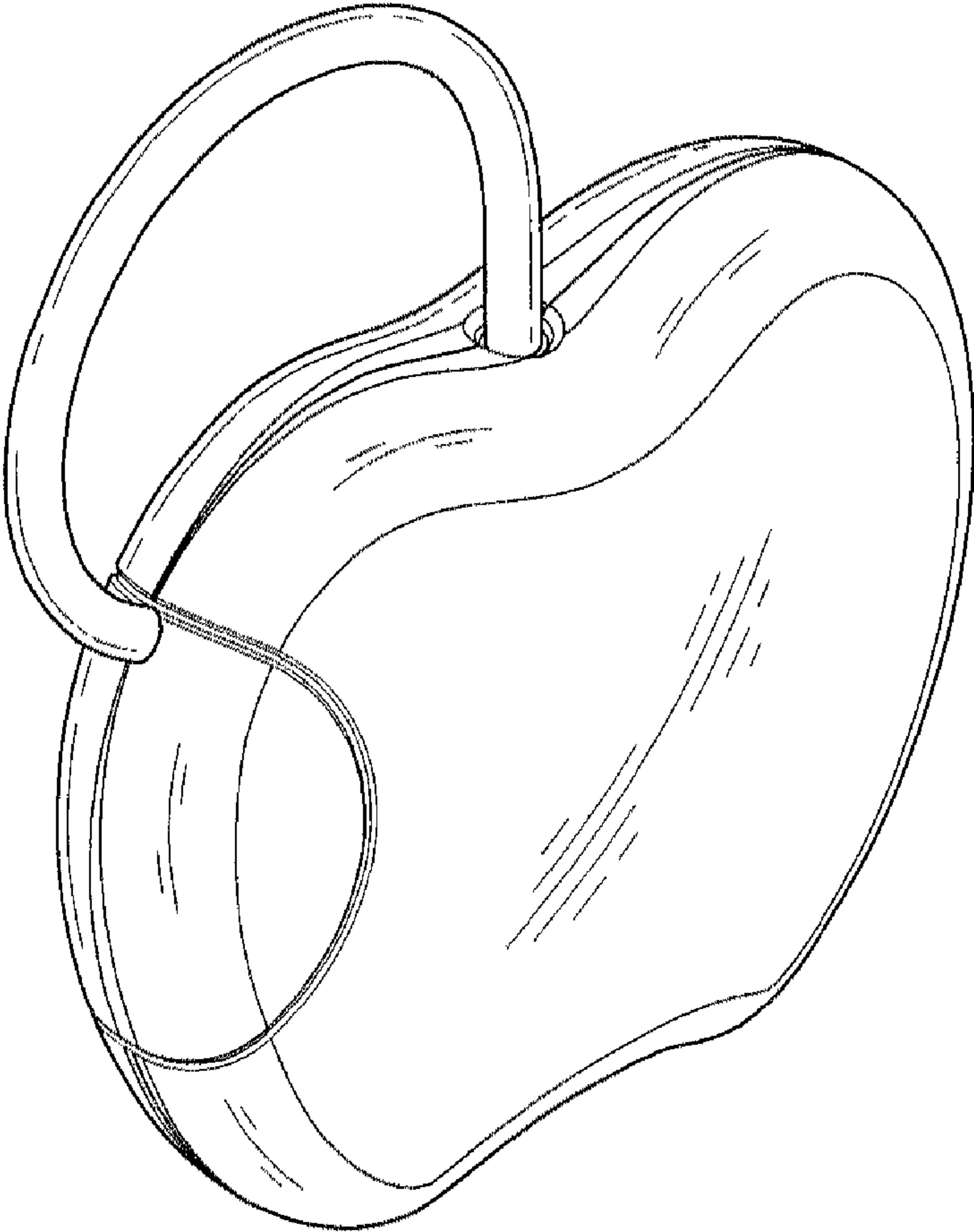

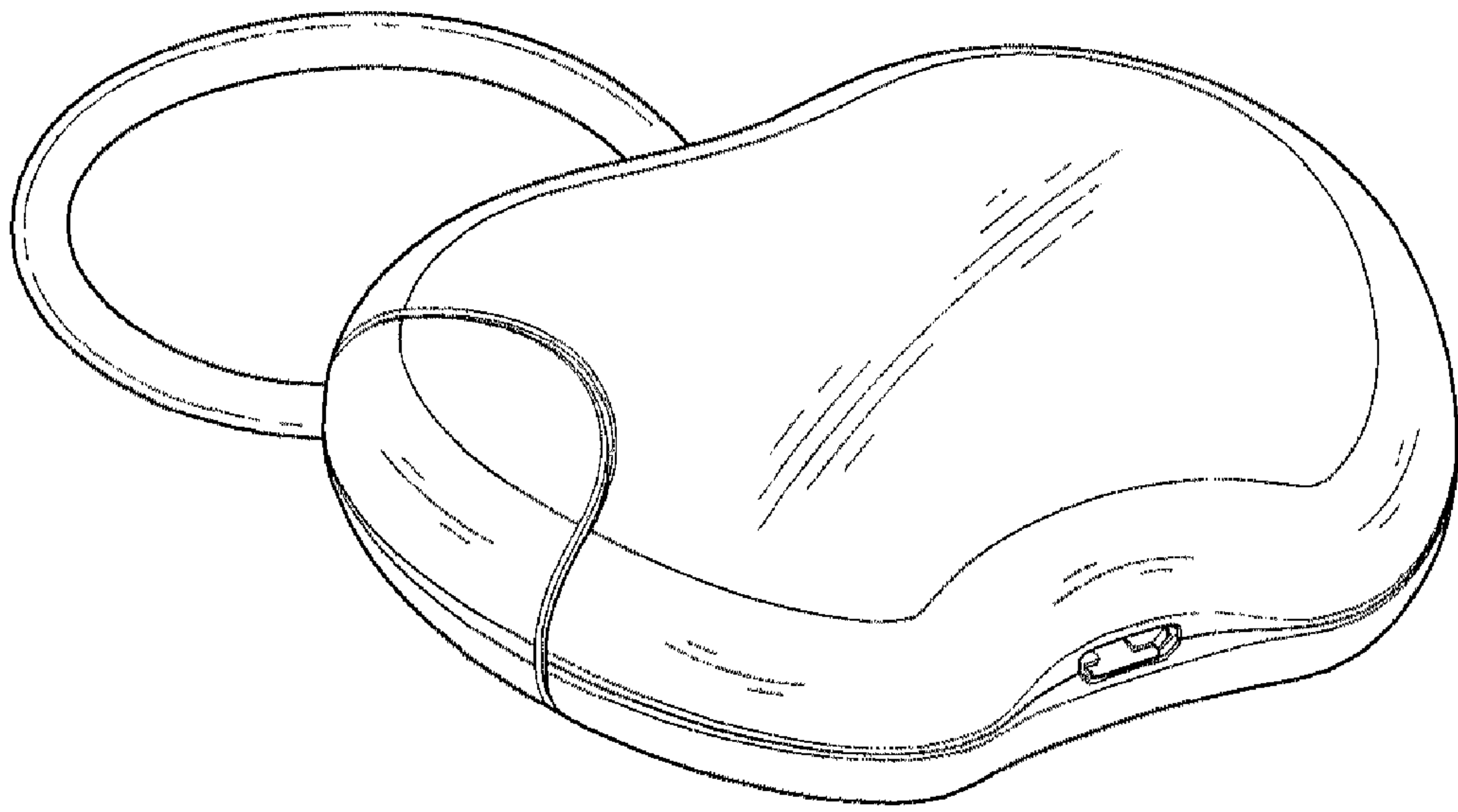

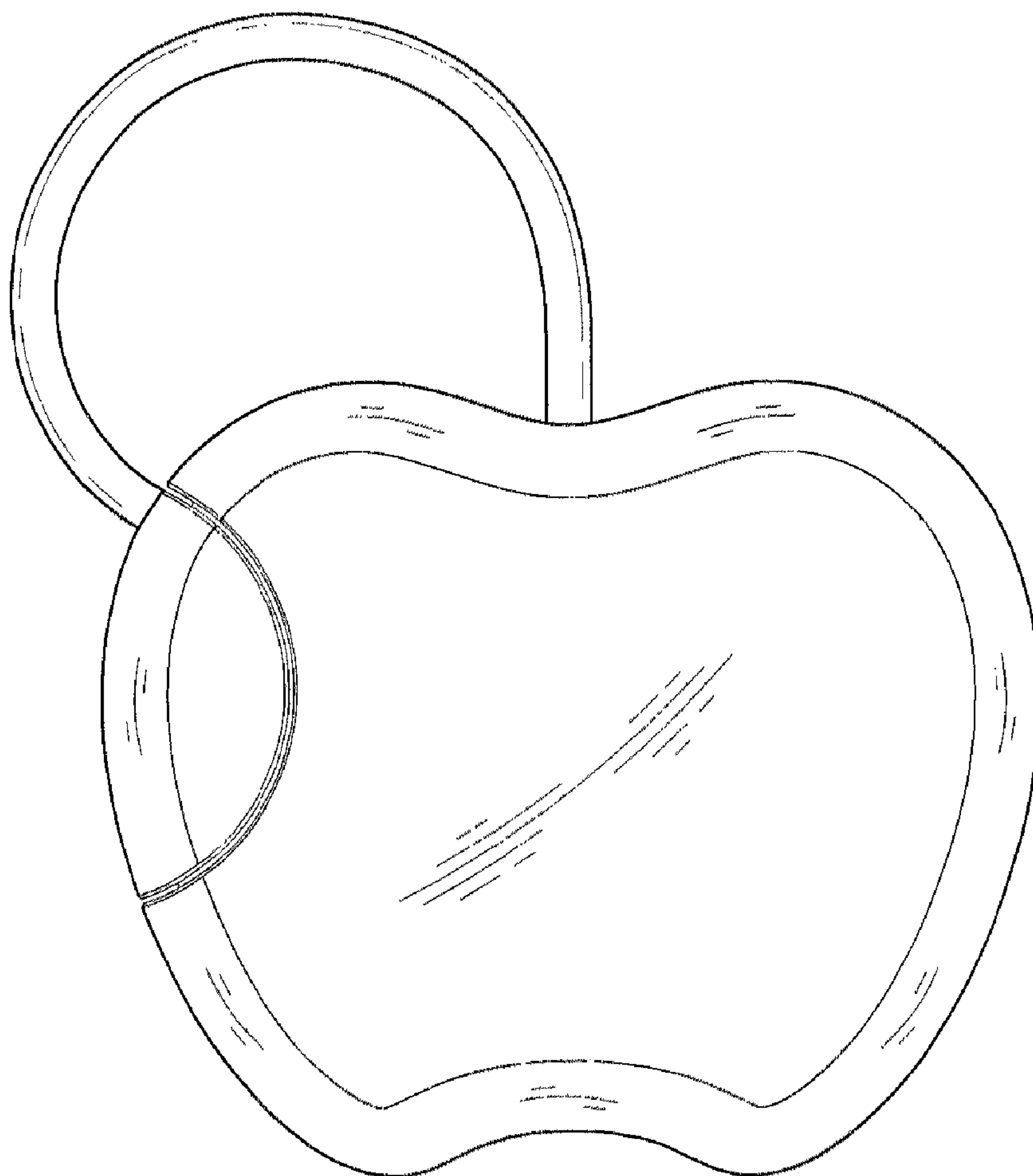

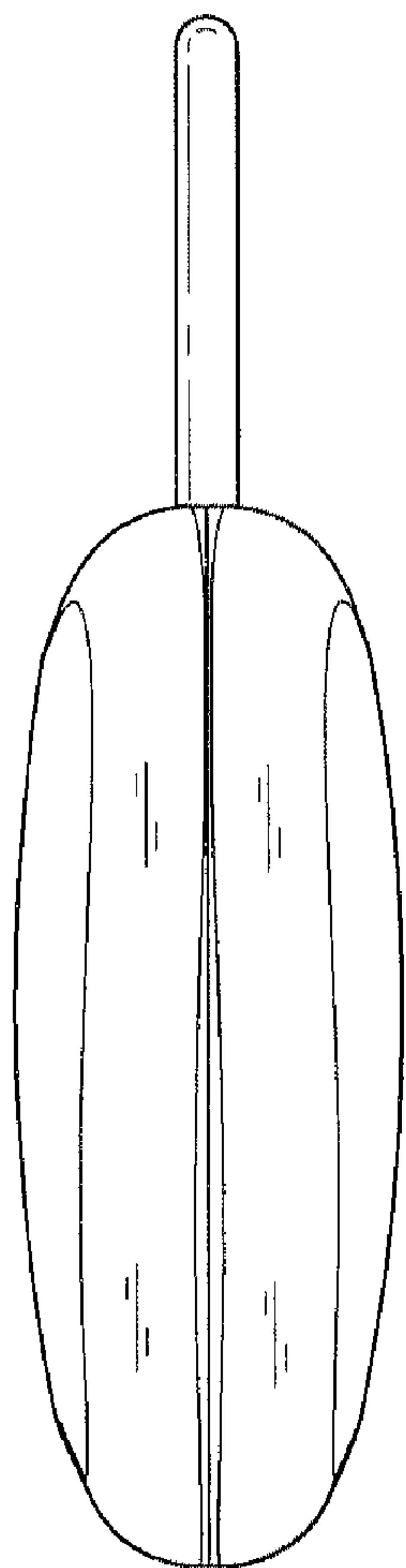

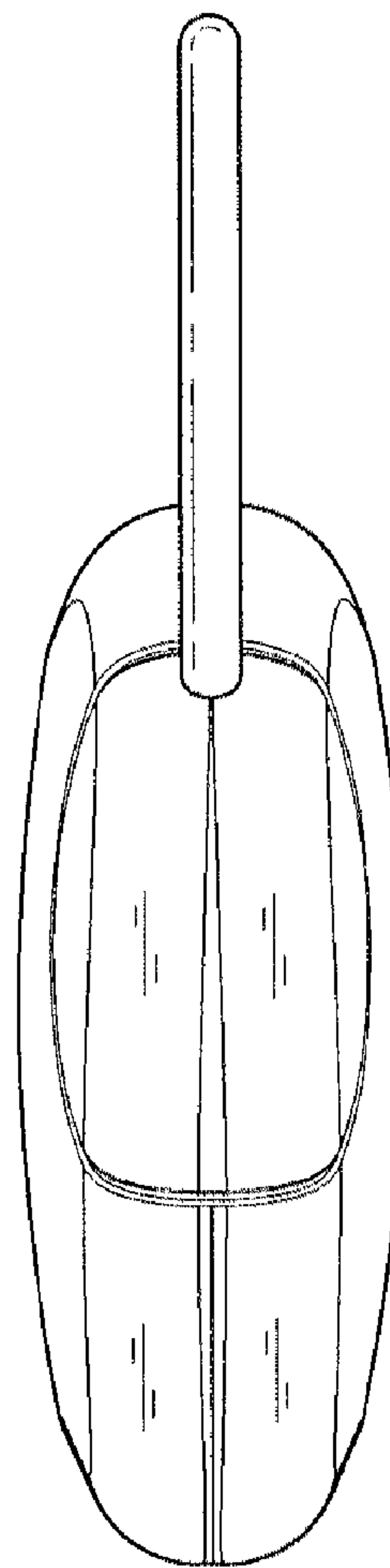

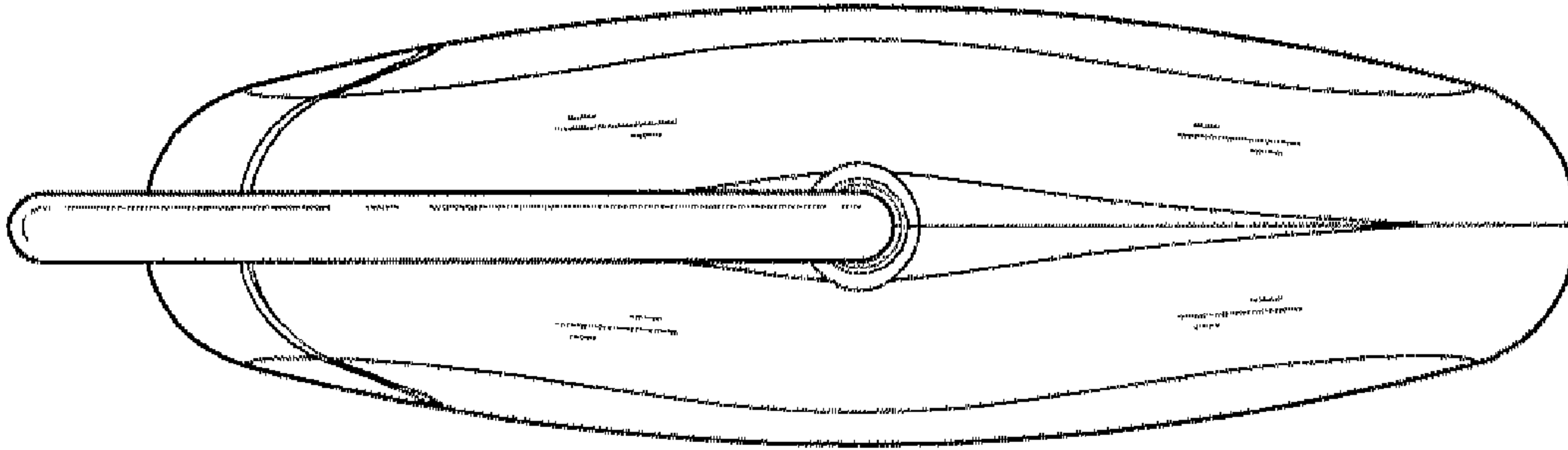

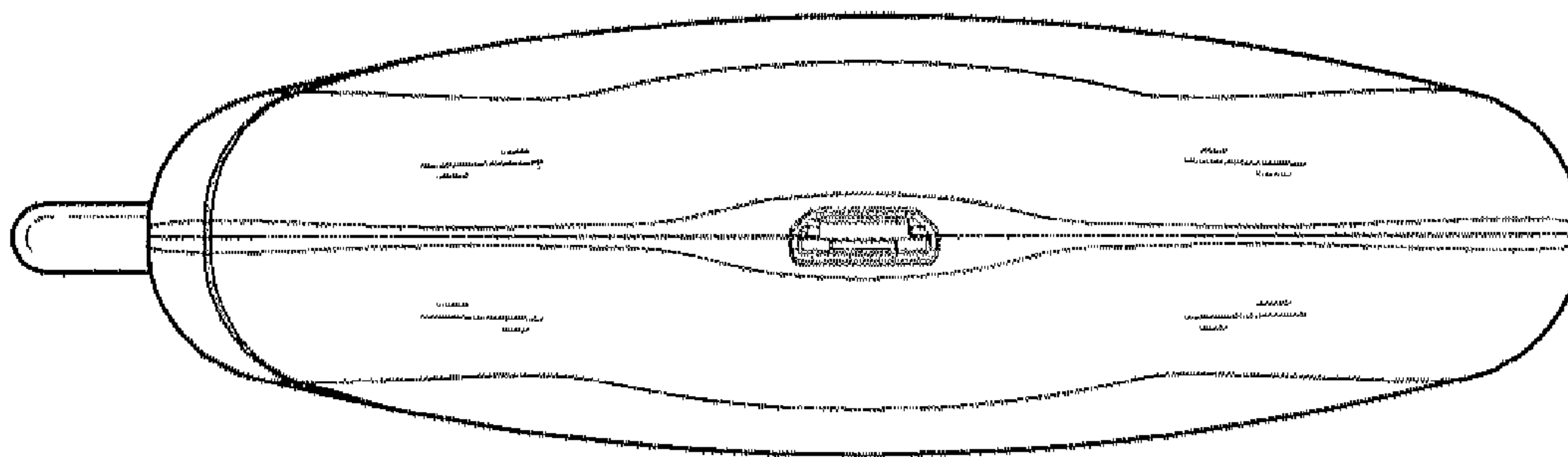

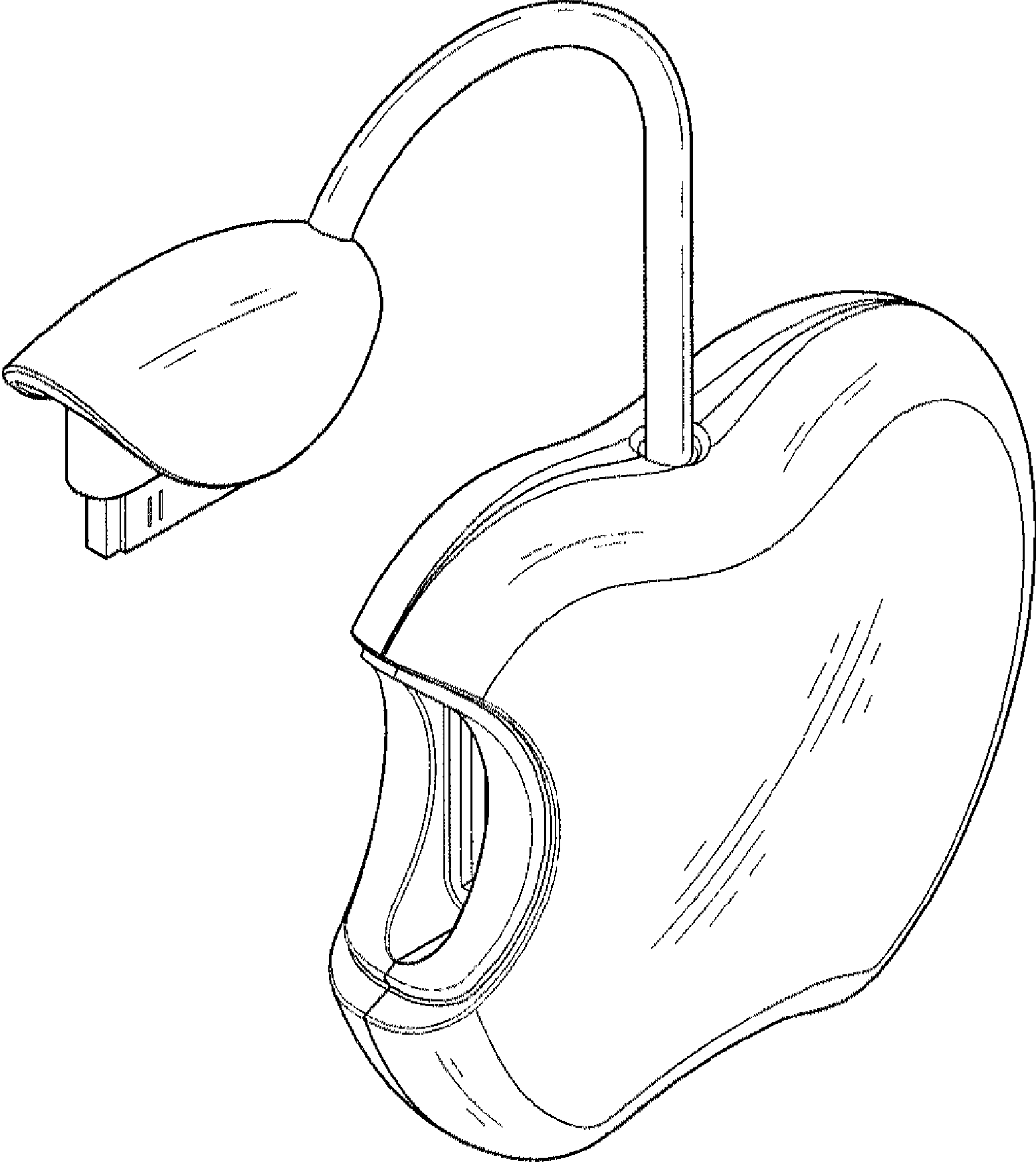
