(57) **CLAIM**

The ornamental design for a tubing protecting cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a tubing protecting cover showing my new design, the top plan view and the bottom plan view being identical to the front elevational view; FIG. 2 is a rear elevational view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a perspective view thereof; and, FIG. 6 is a partial enlarged view thereof.

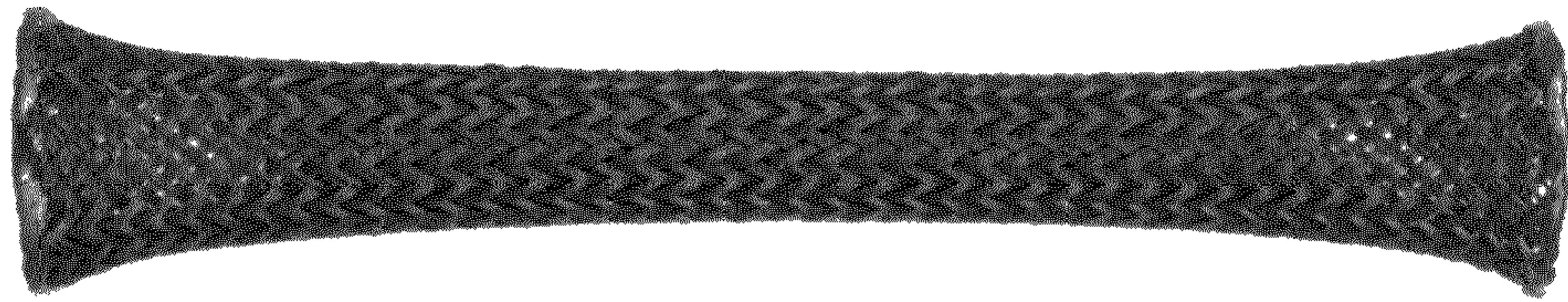

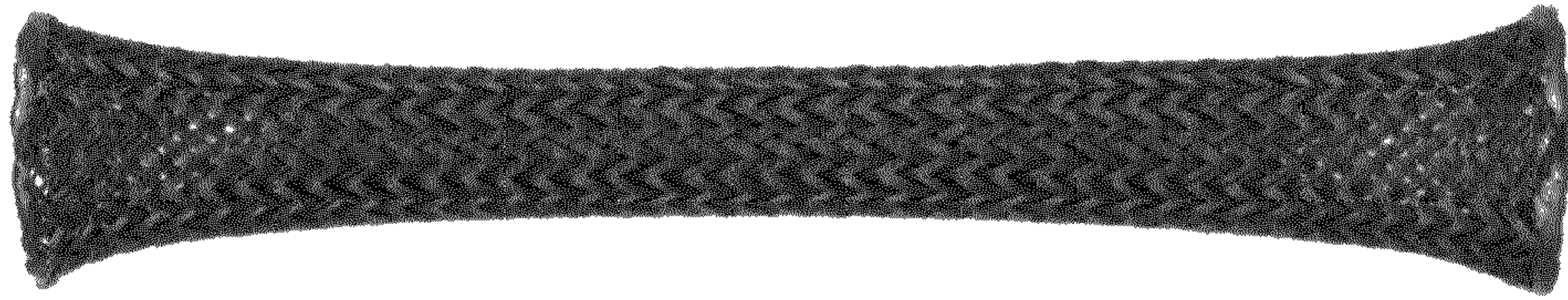

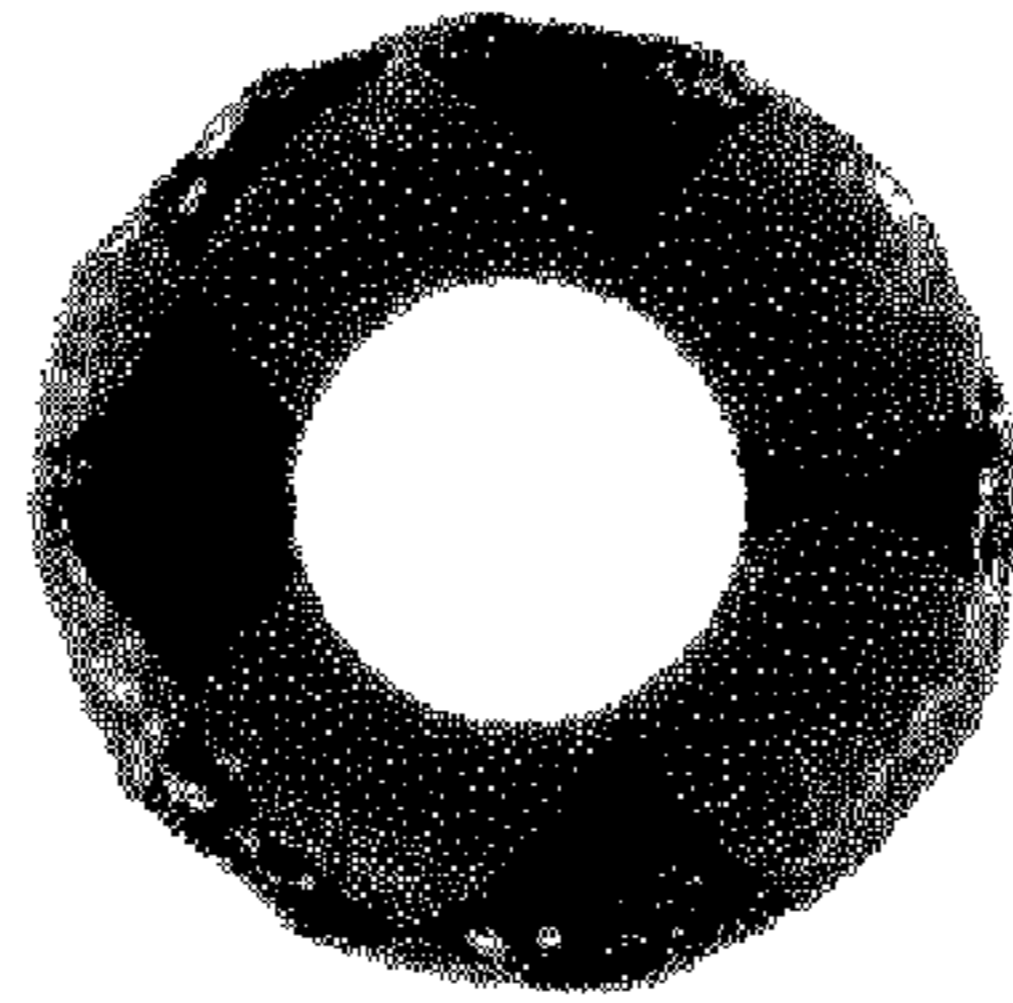

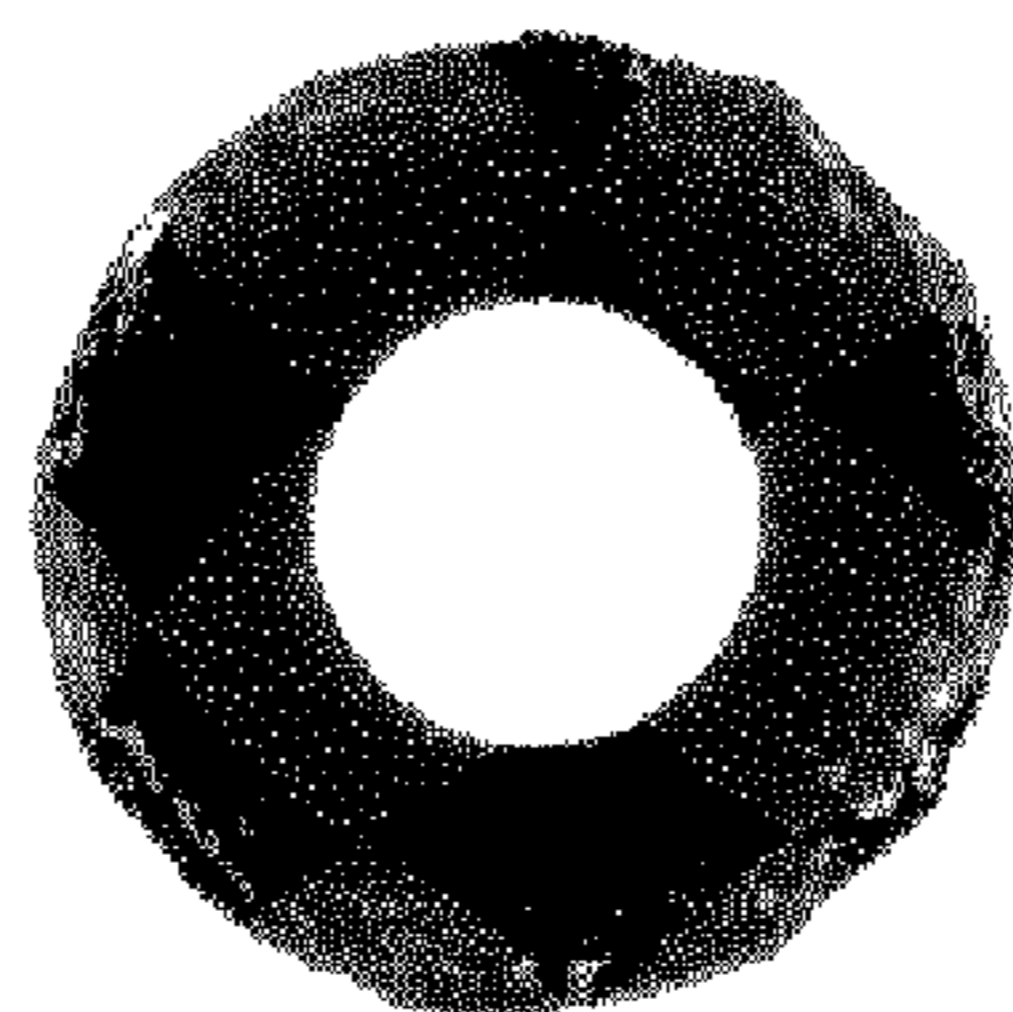

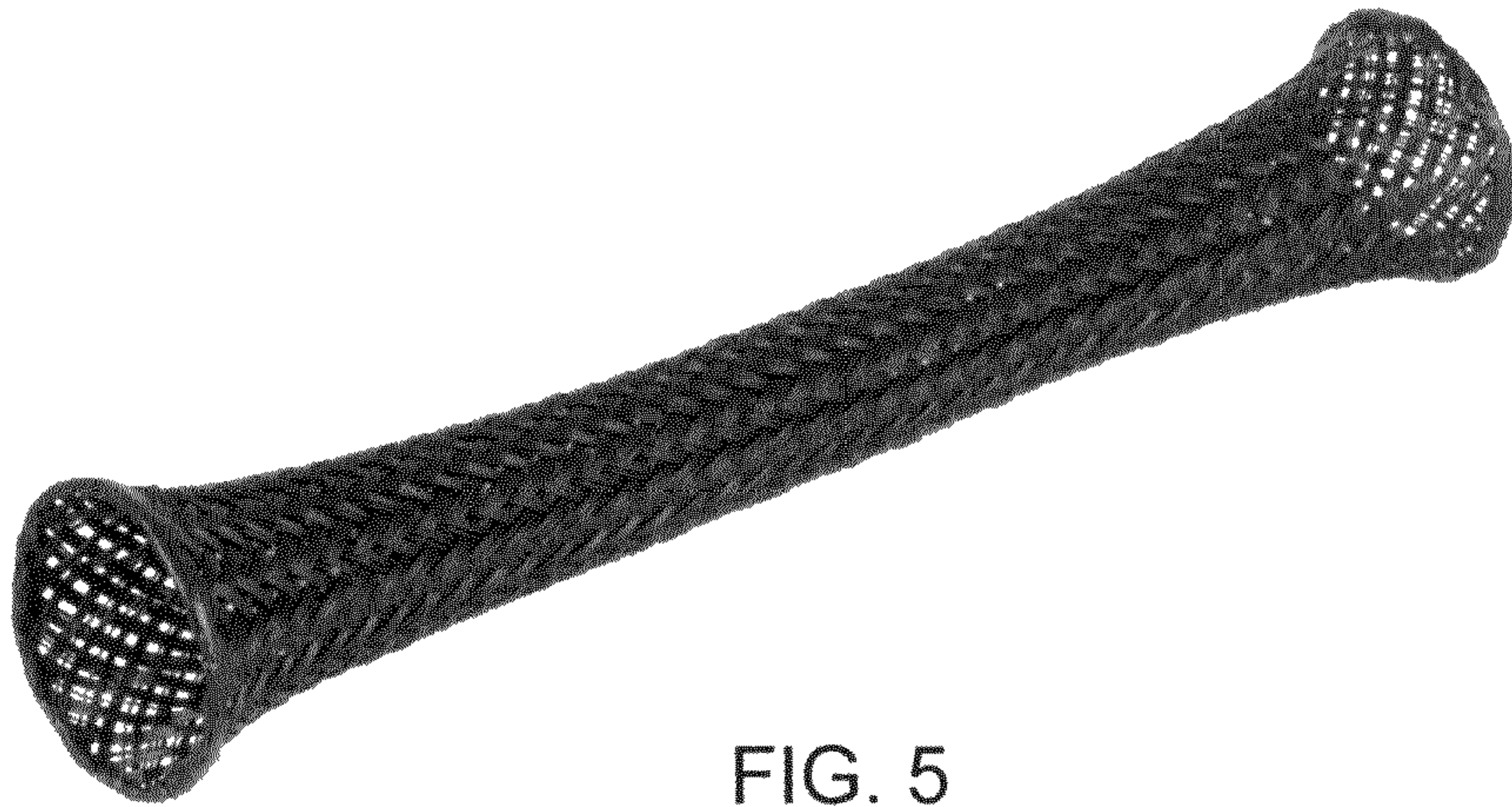
