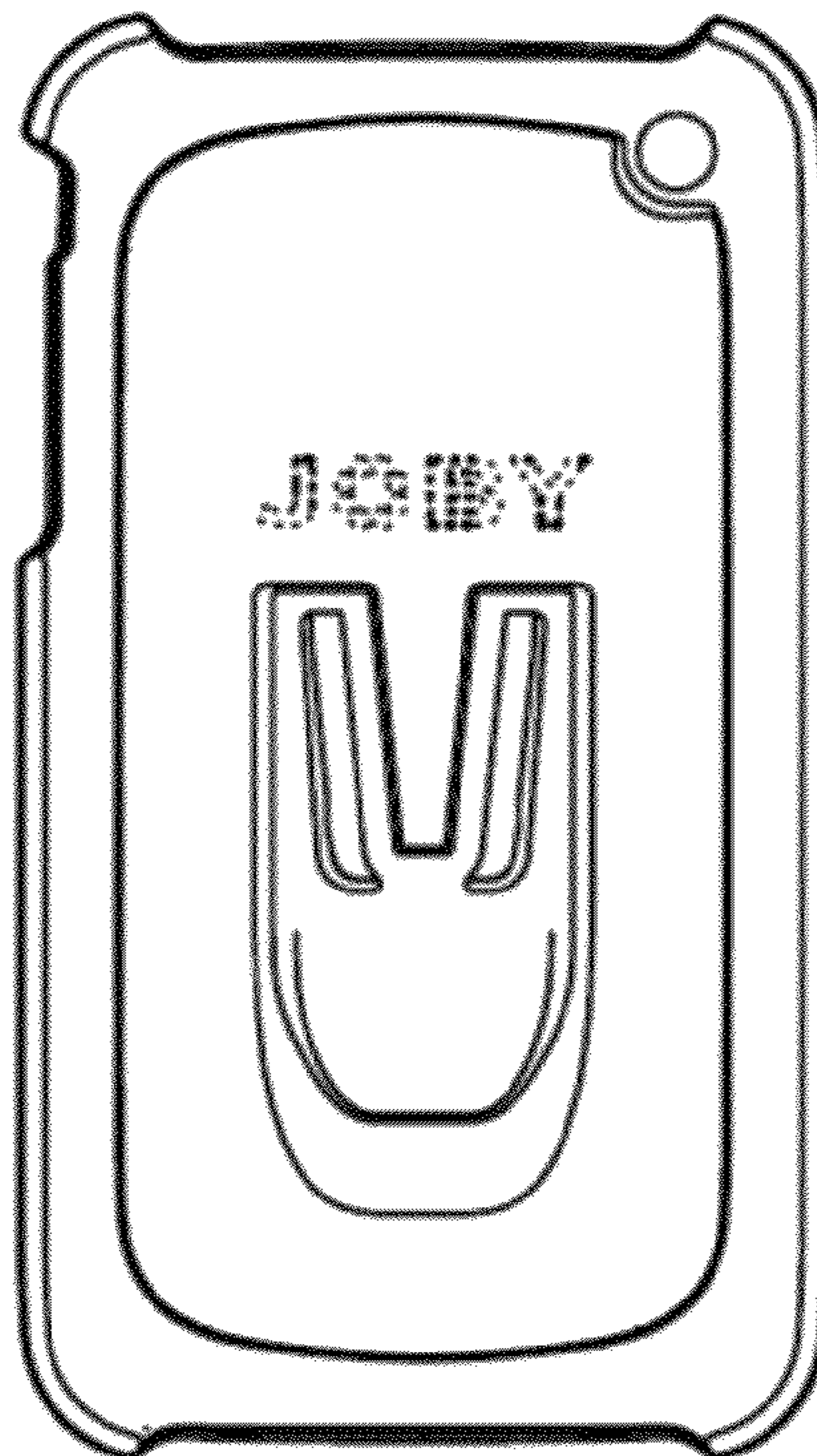
The ornamental design for a device case with clip, as shown and described.

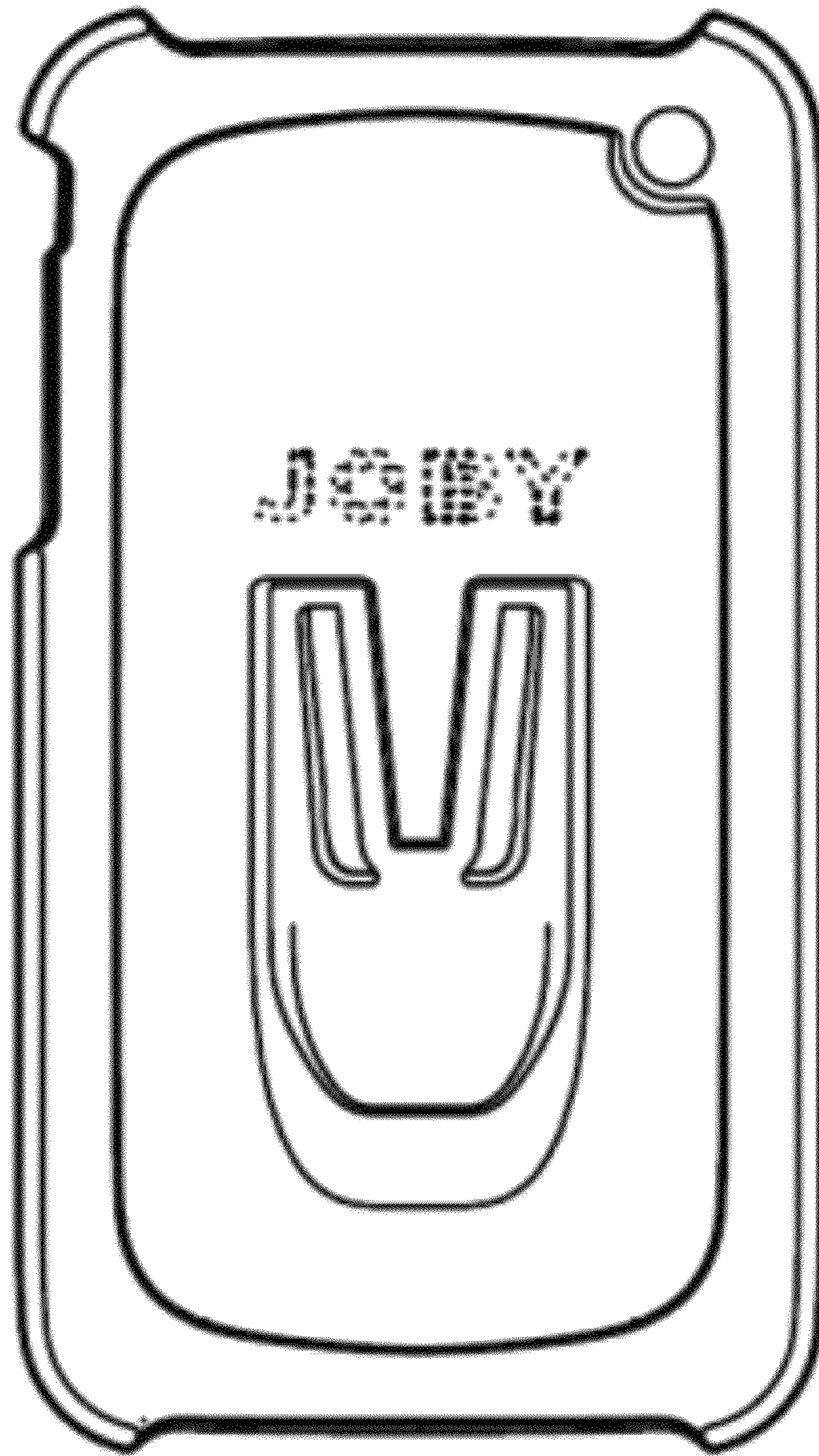

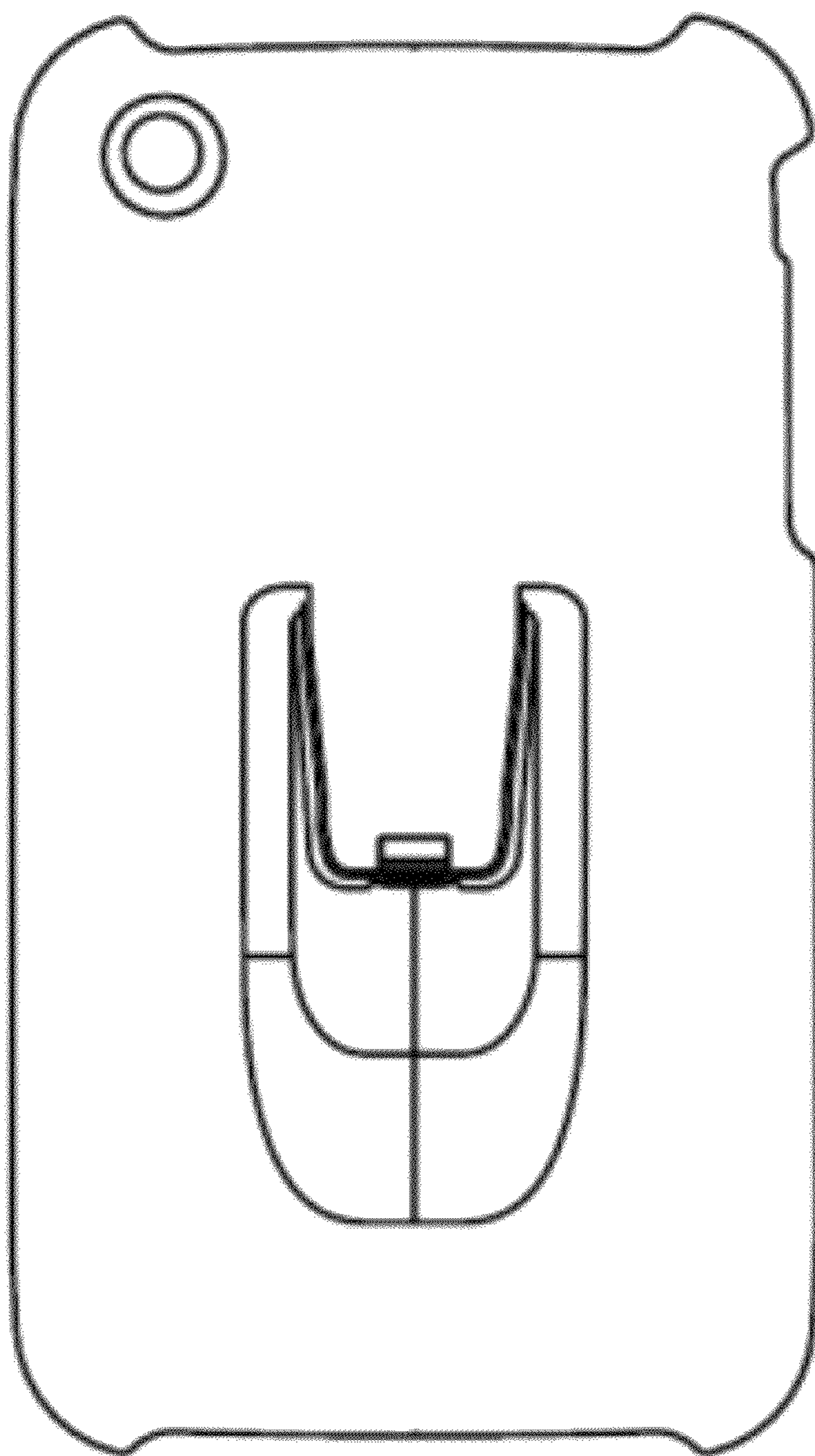

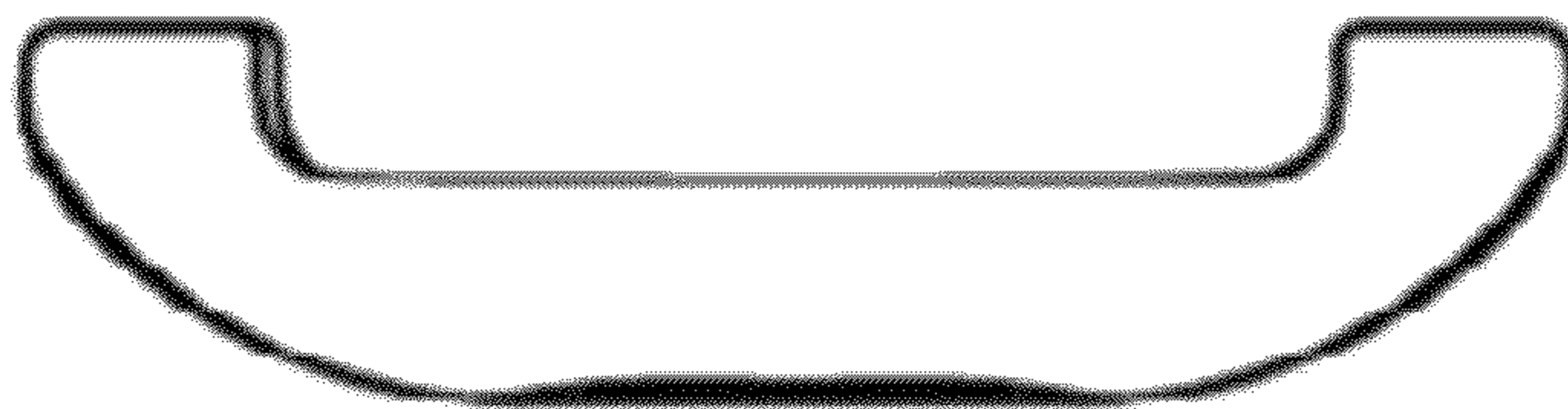

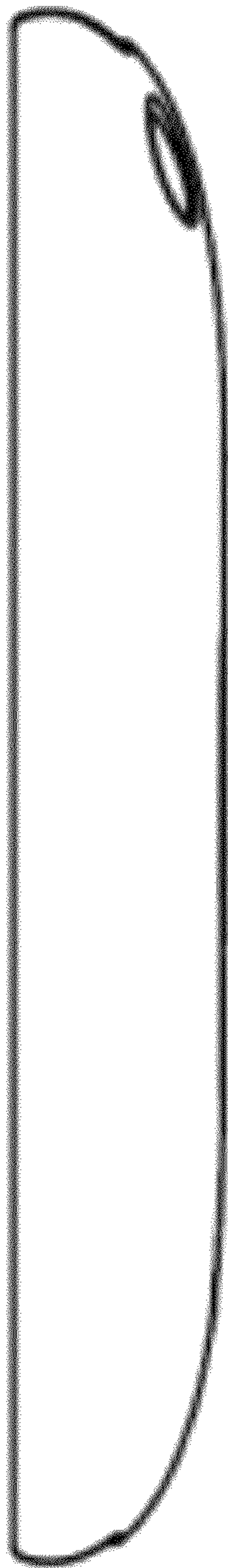

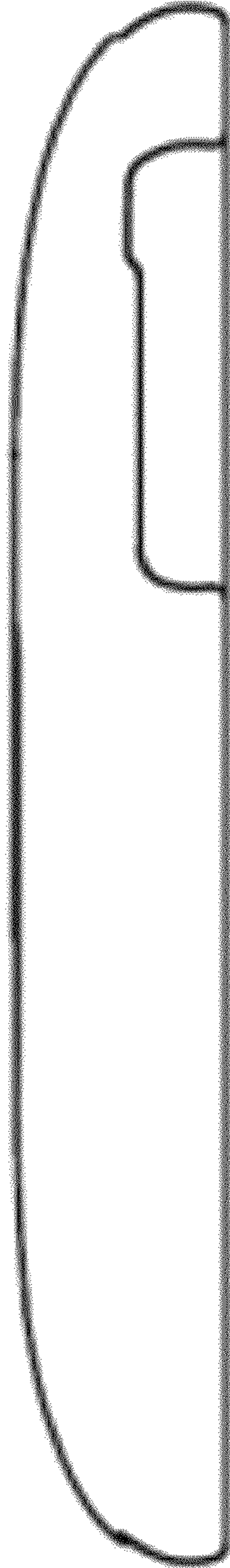

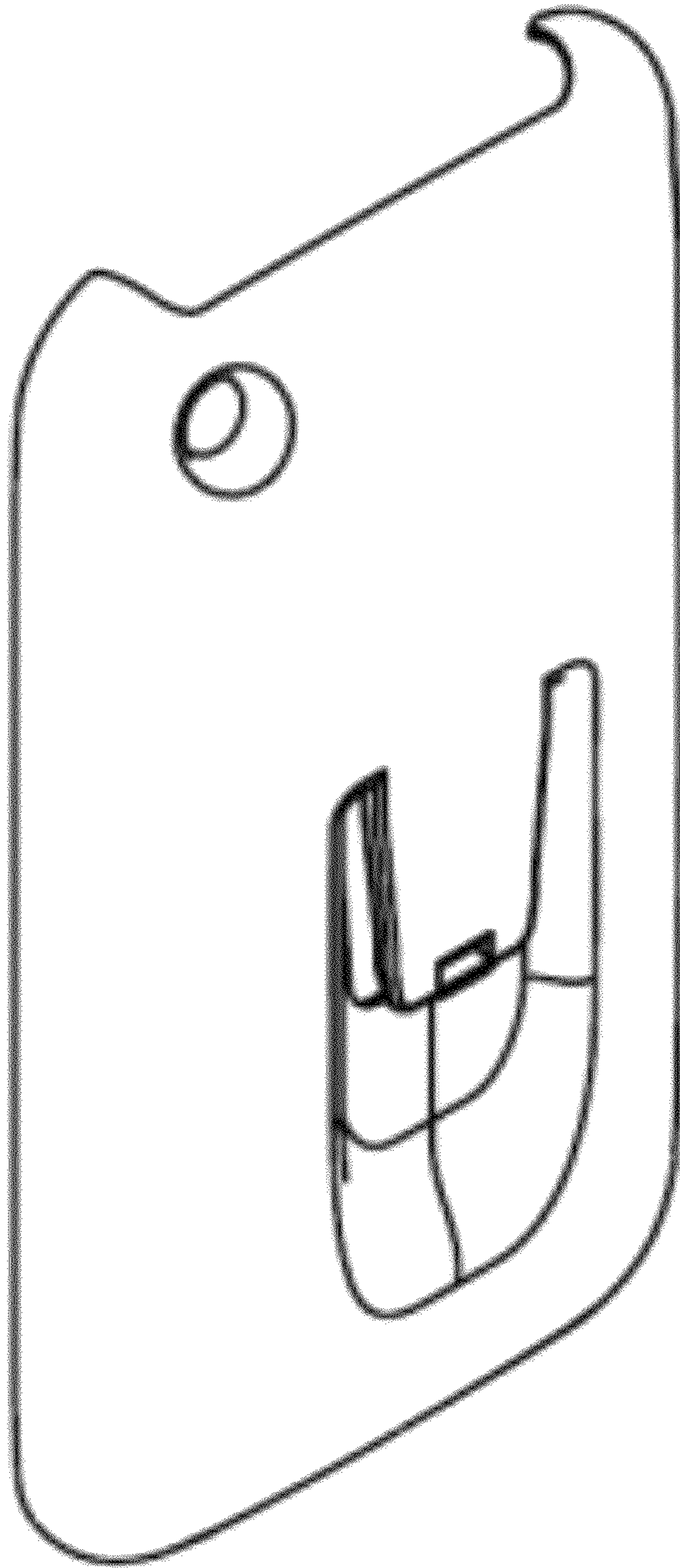
