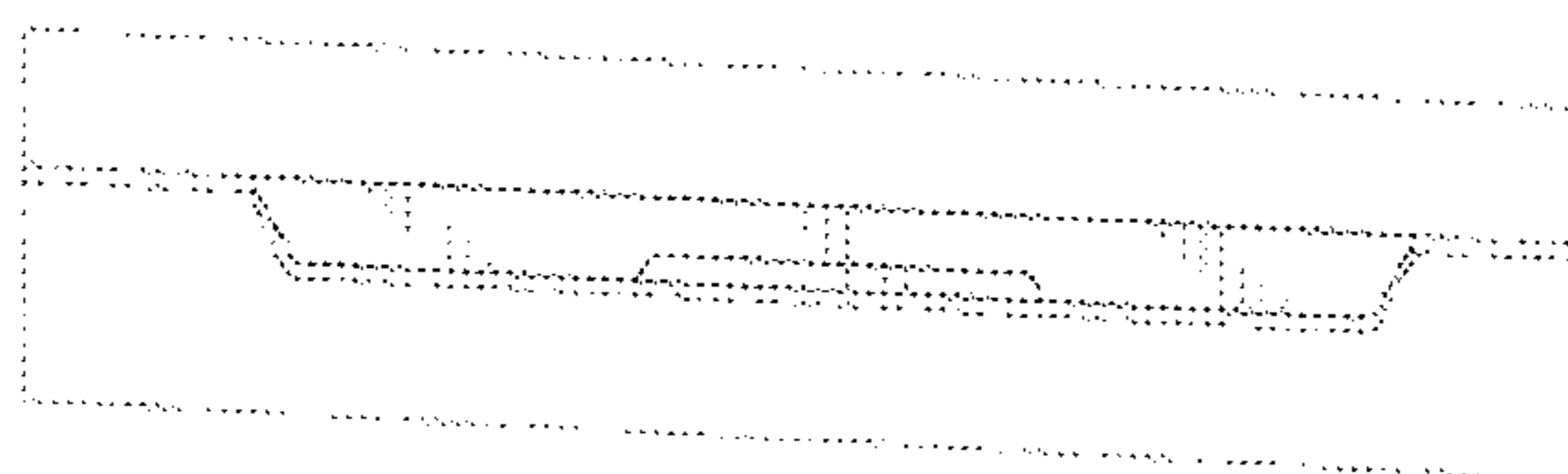
FIG. 9 is an enlarged view of an indicated portion of FIG. 2.

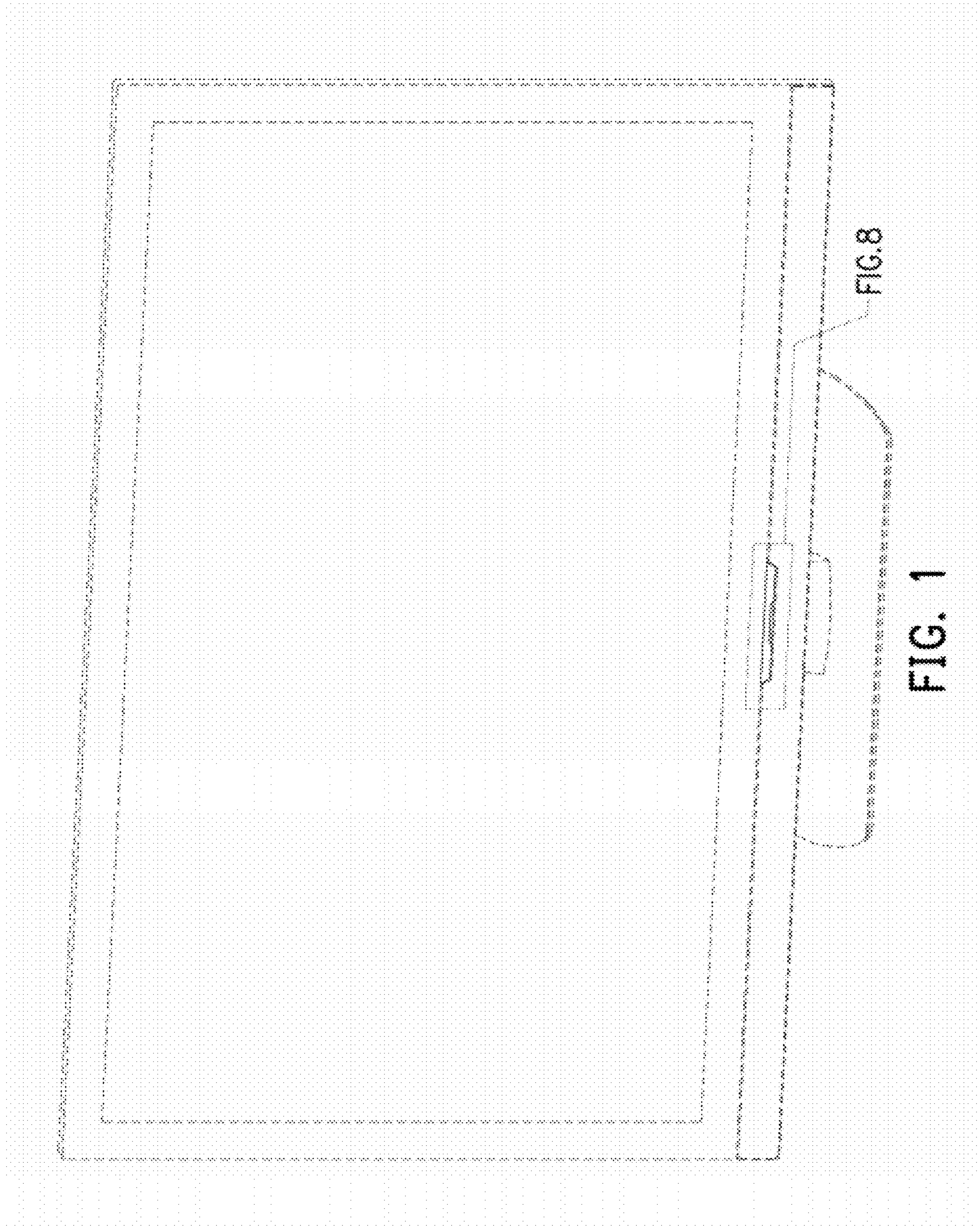

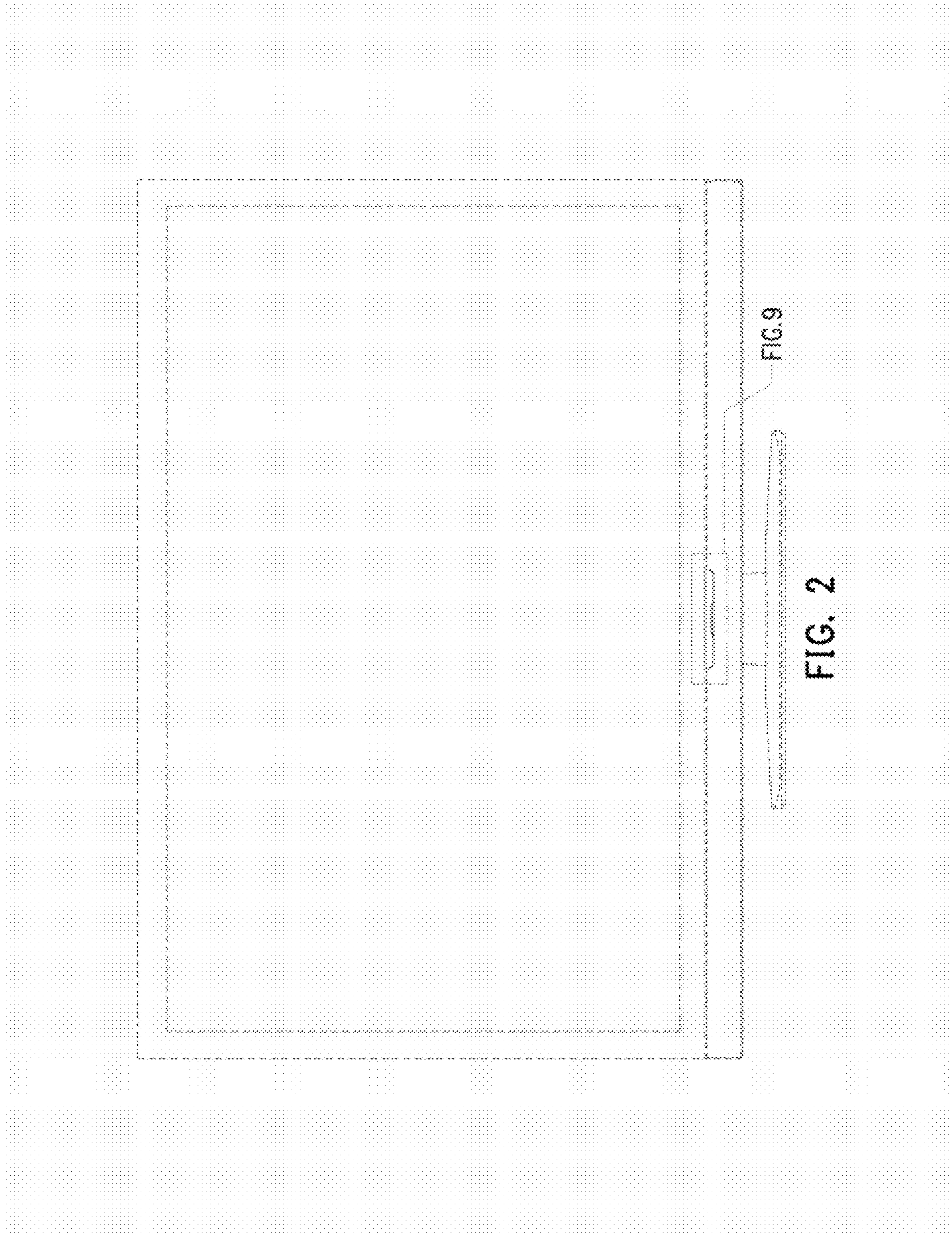

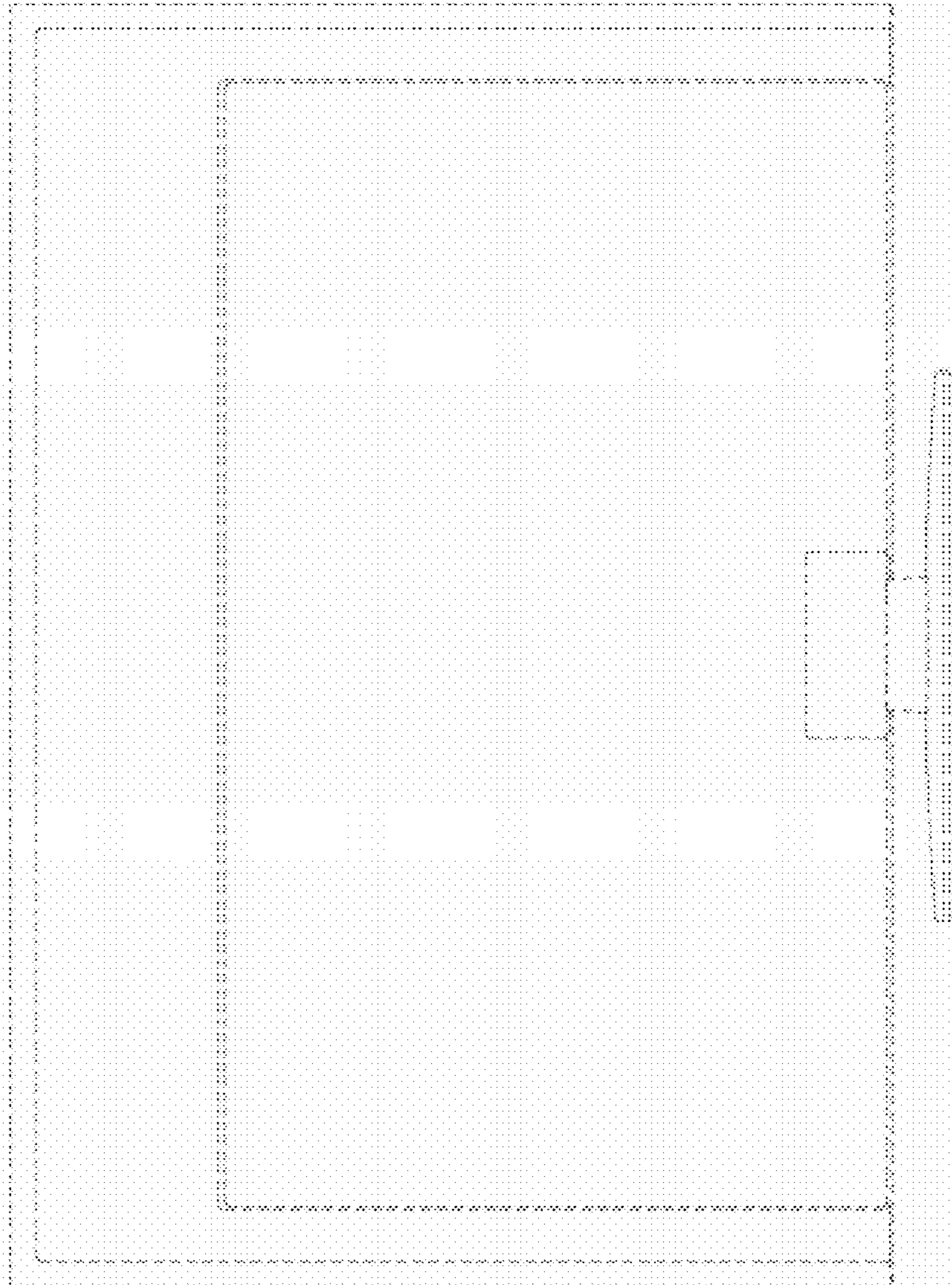

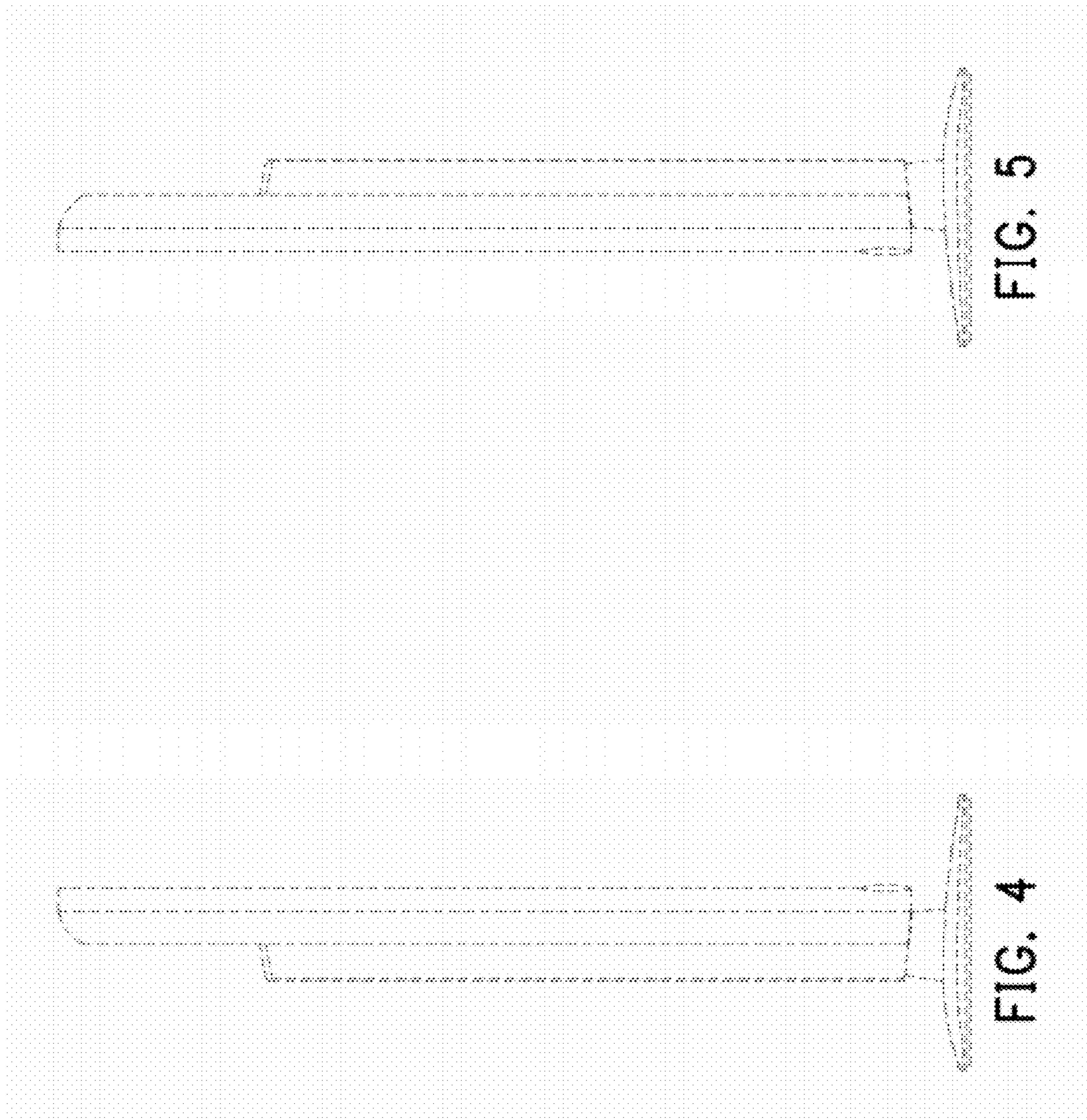

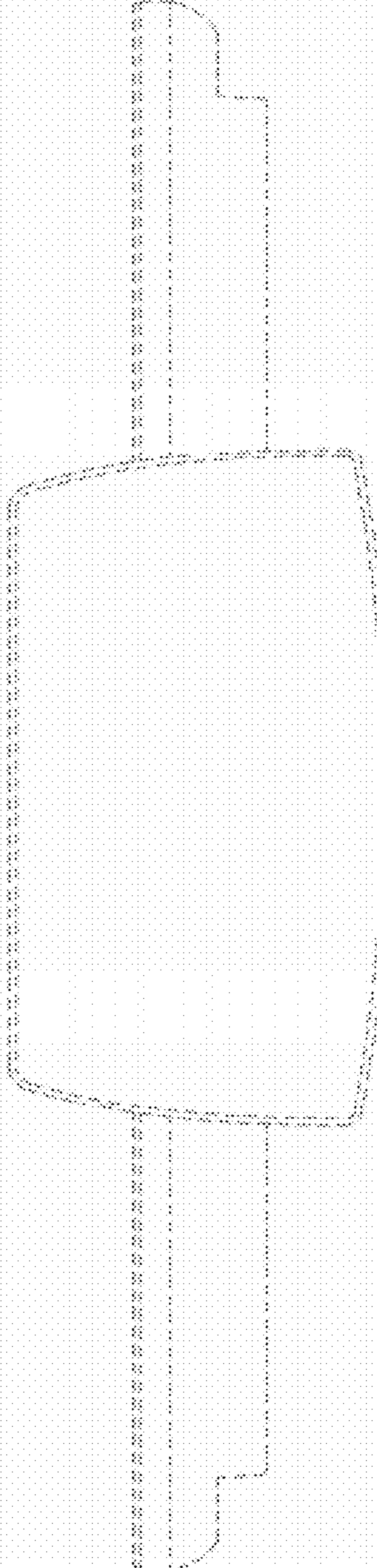

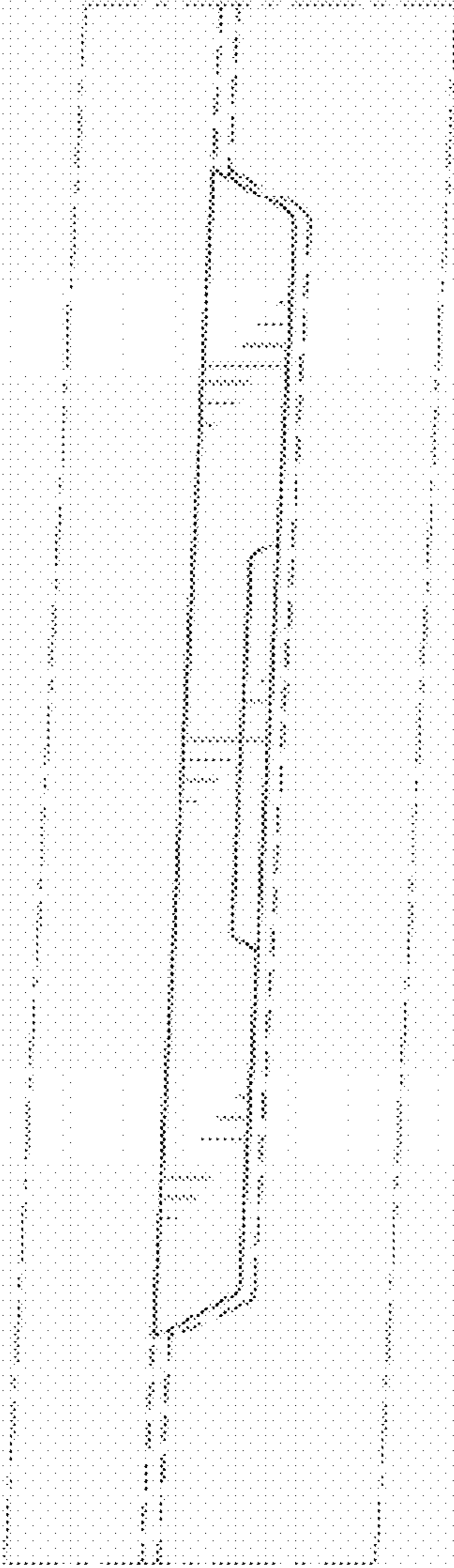

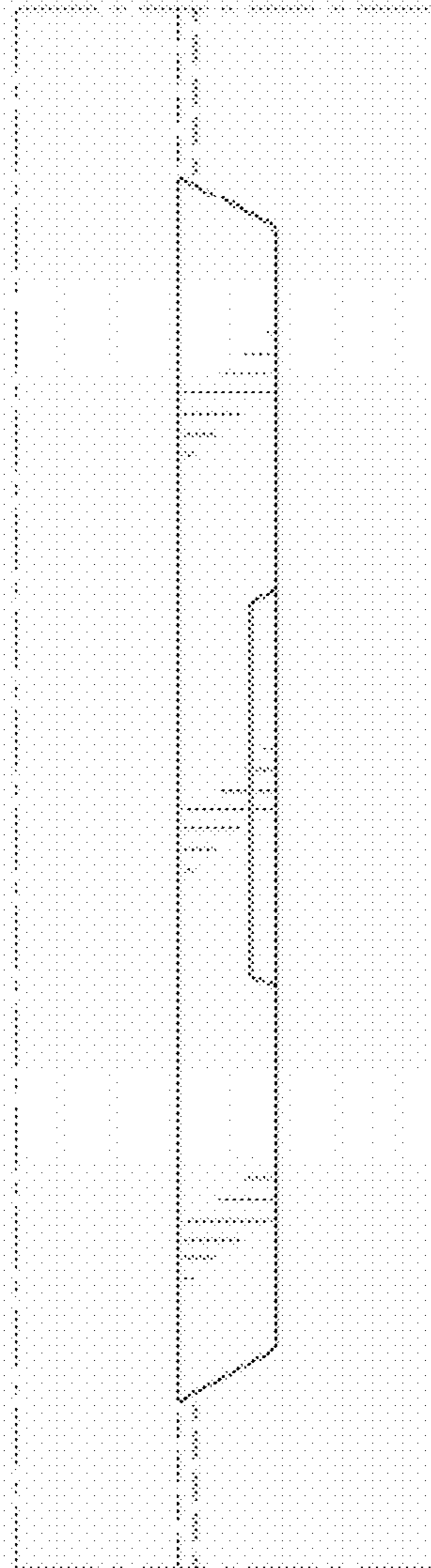
