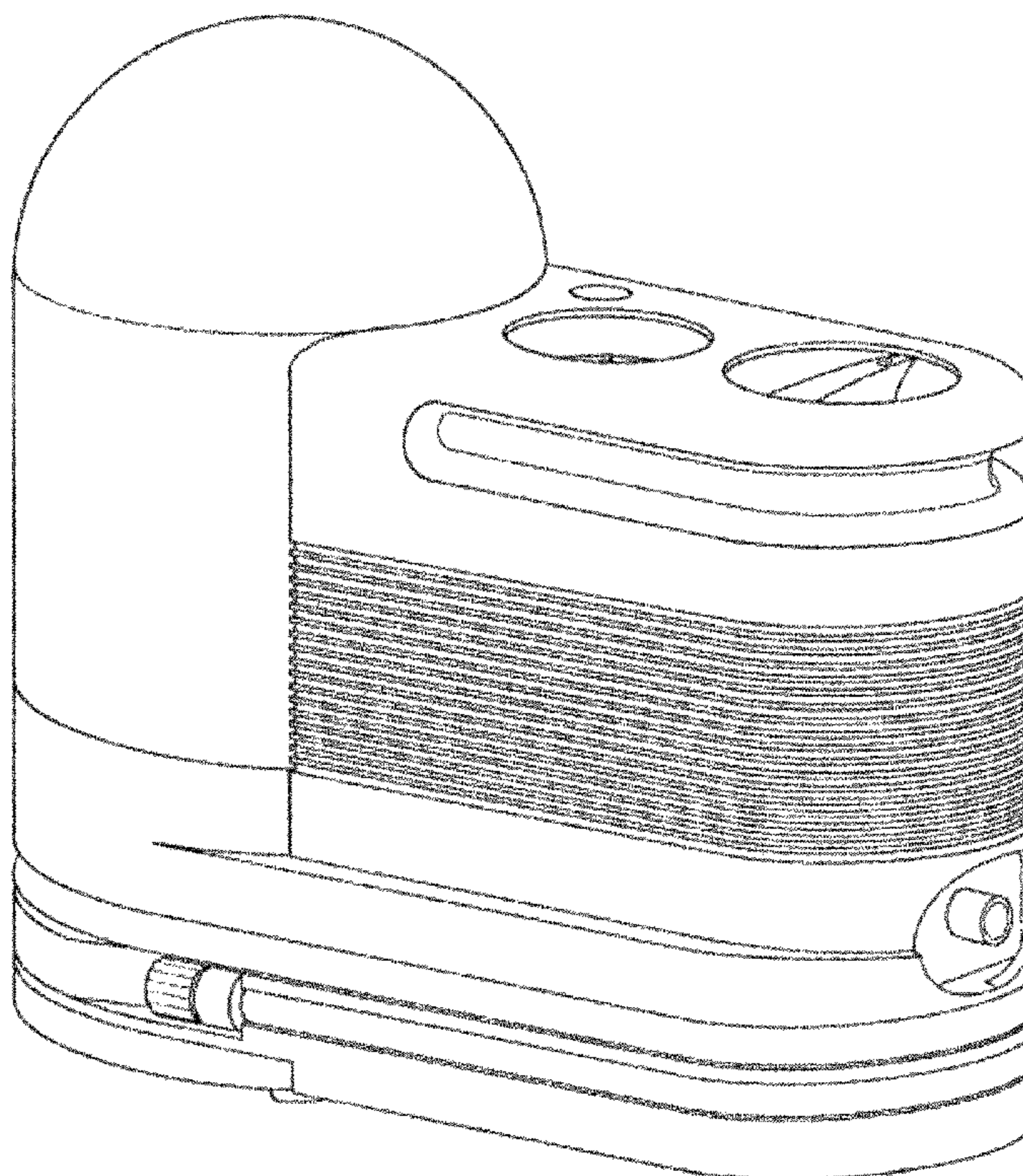
(57) **CLAIM**

I claim the ornamental design for a fitting for tyre inflation and tyre repair, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of my new design for a fitting for tyre inflation and tyre repair  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a left side view thereof; and,  
FIG. 7 is a perspective view thereof from the front right side.  
The broken lines in FIGS. 1, 2, 4 and 6 are included for the purpose of illustrating portions of fitting for tyre inflation and tyre repair that form no part of the claimed design.

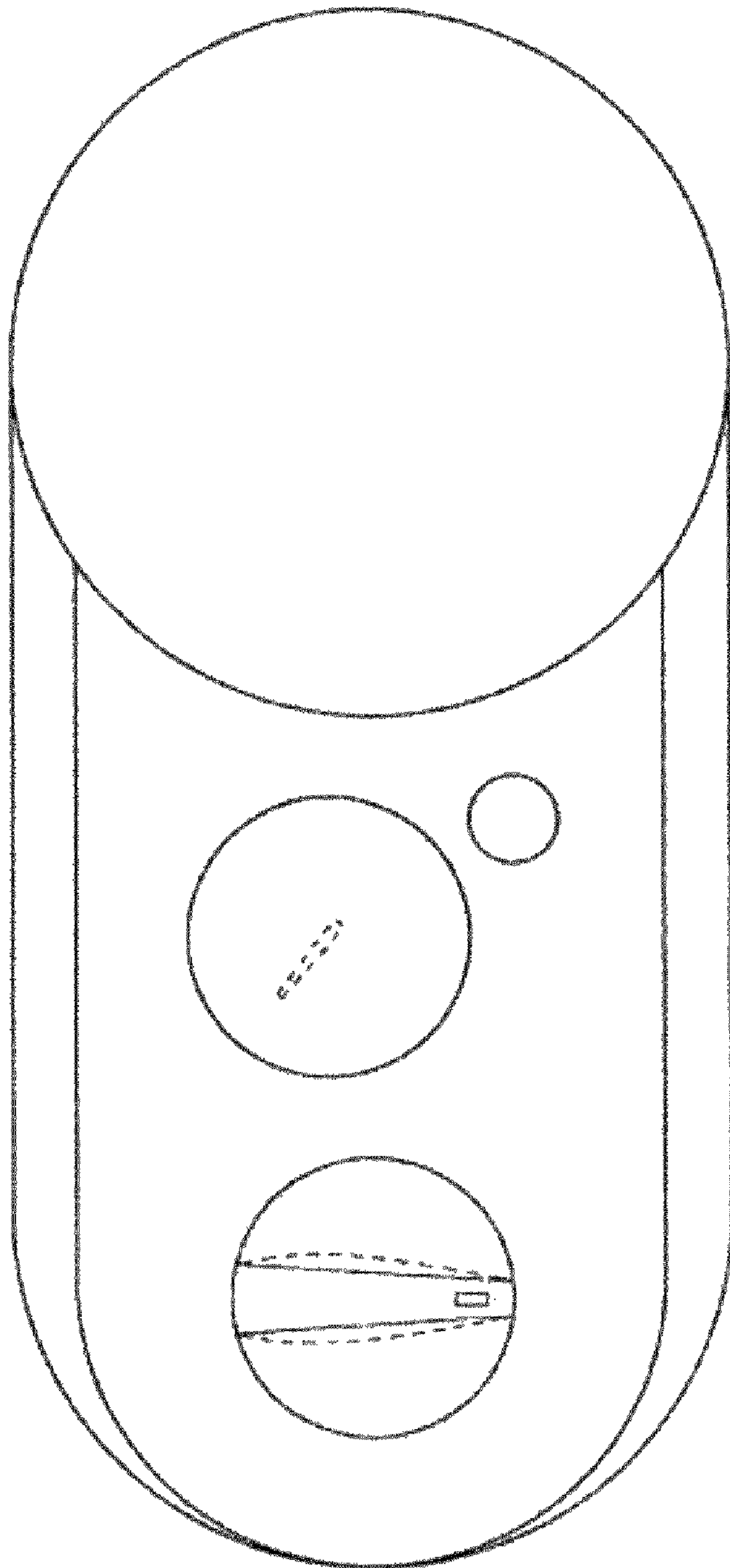

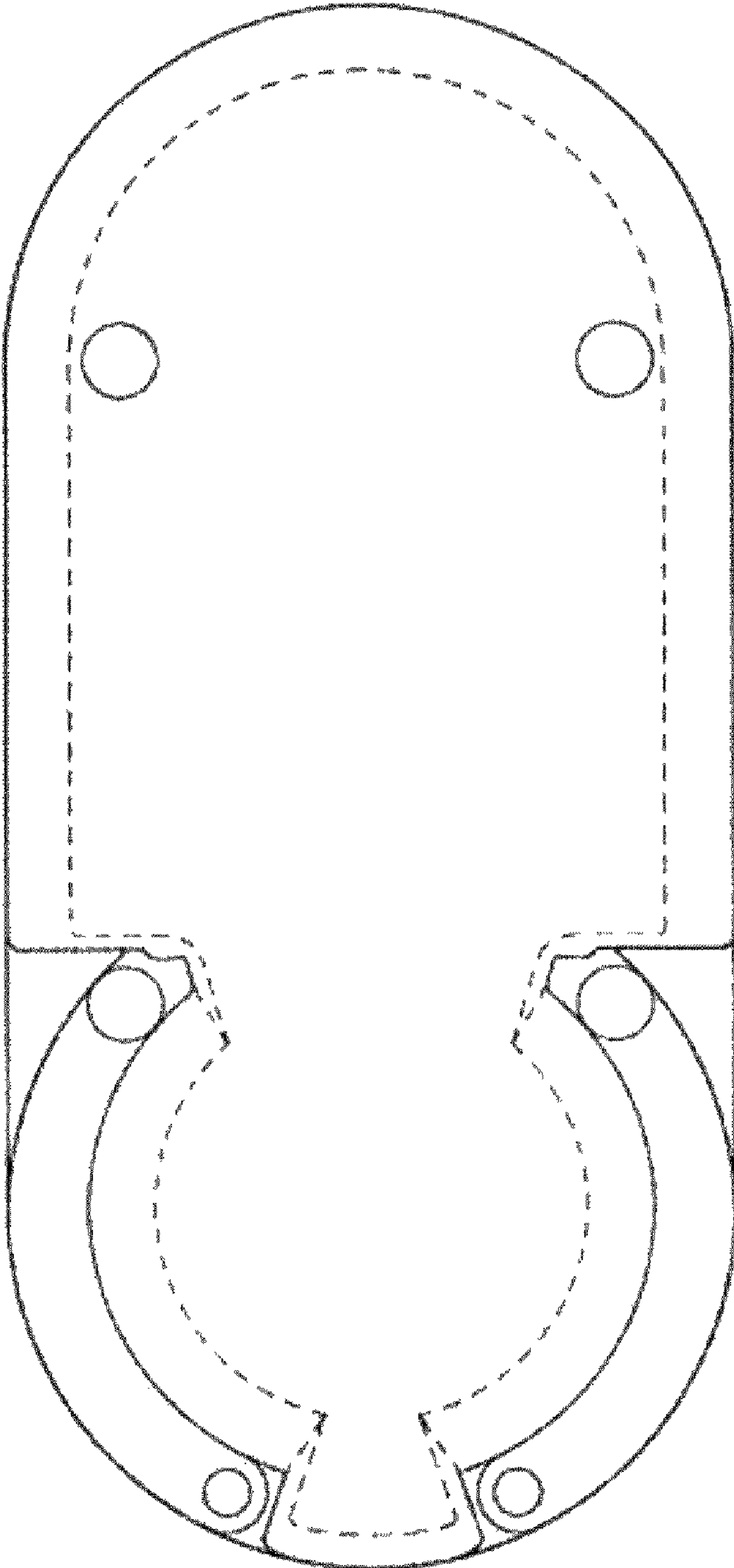

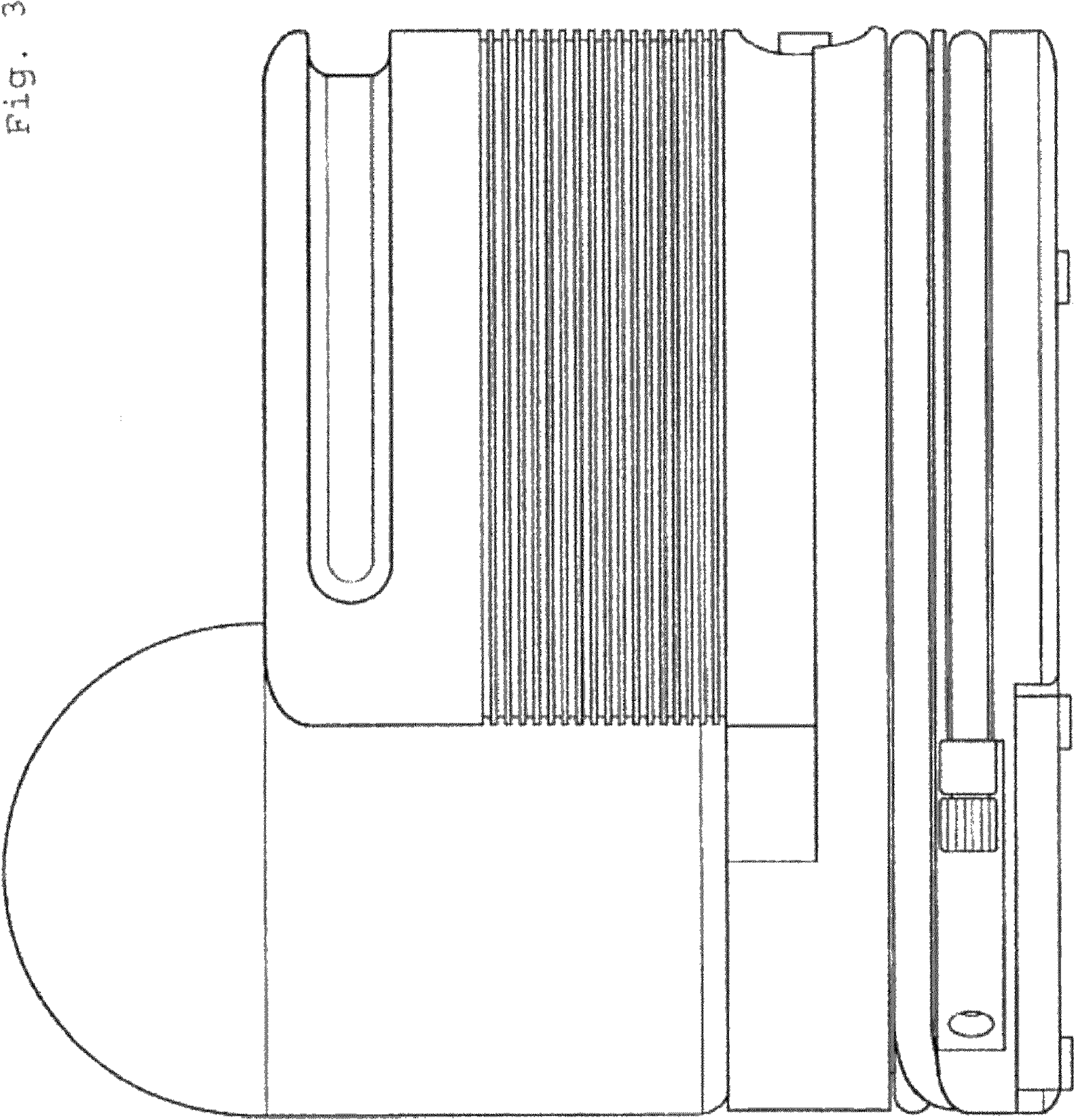
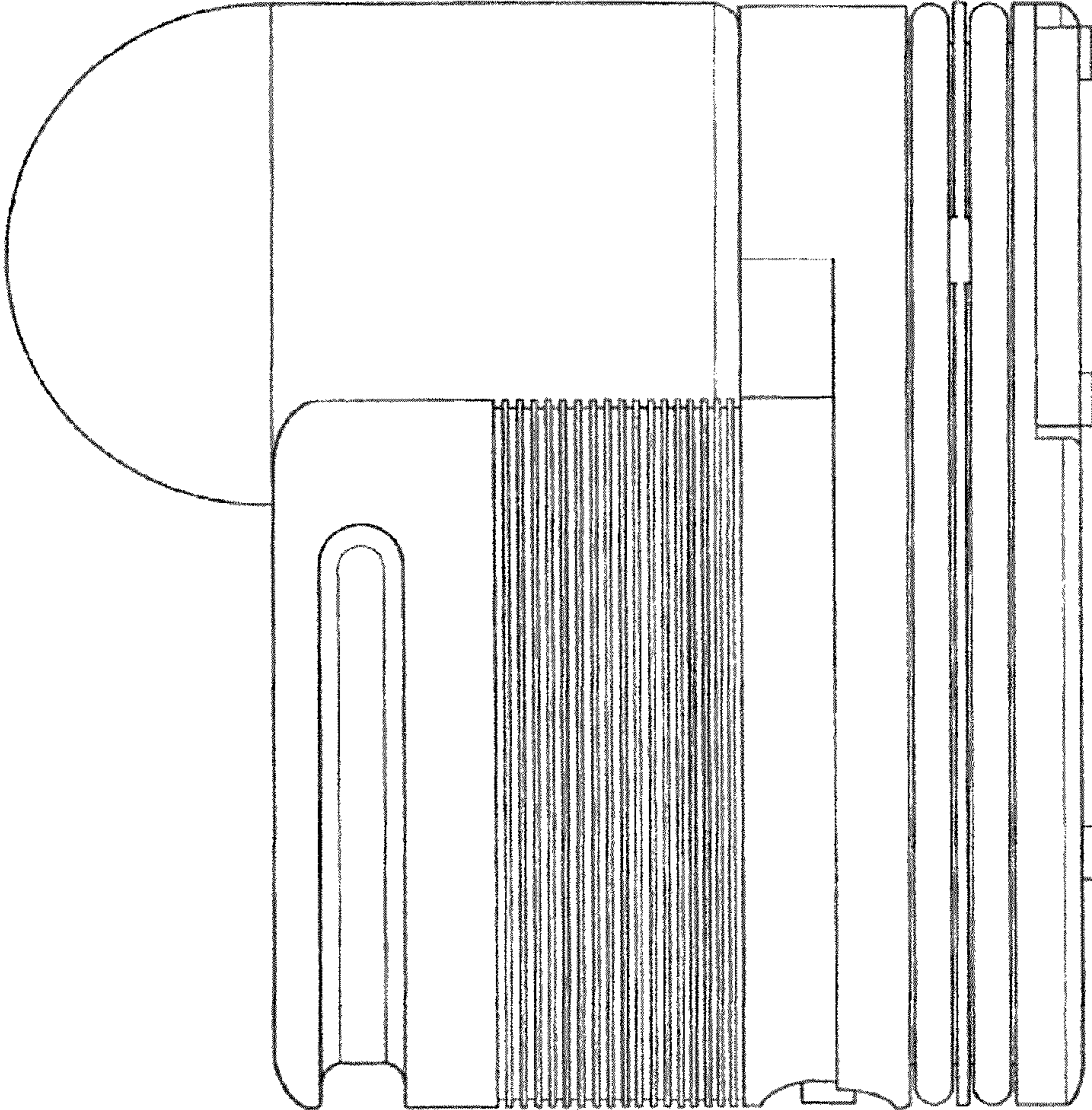

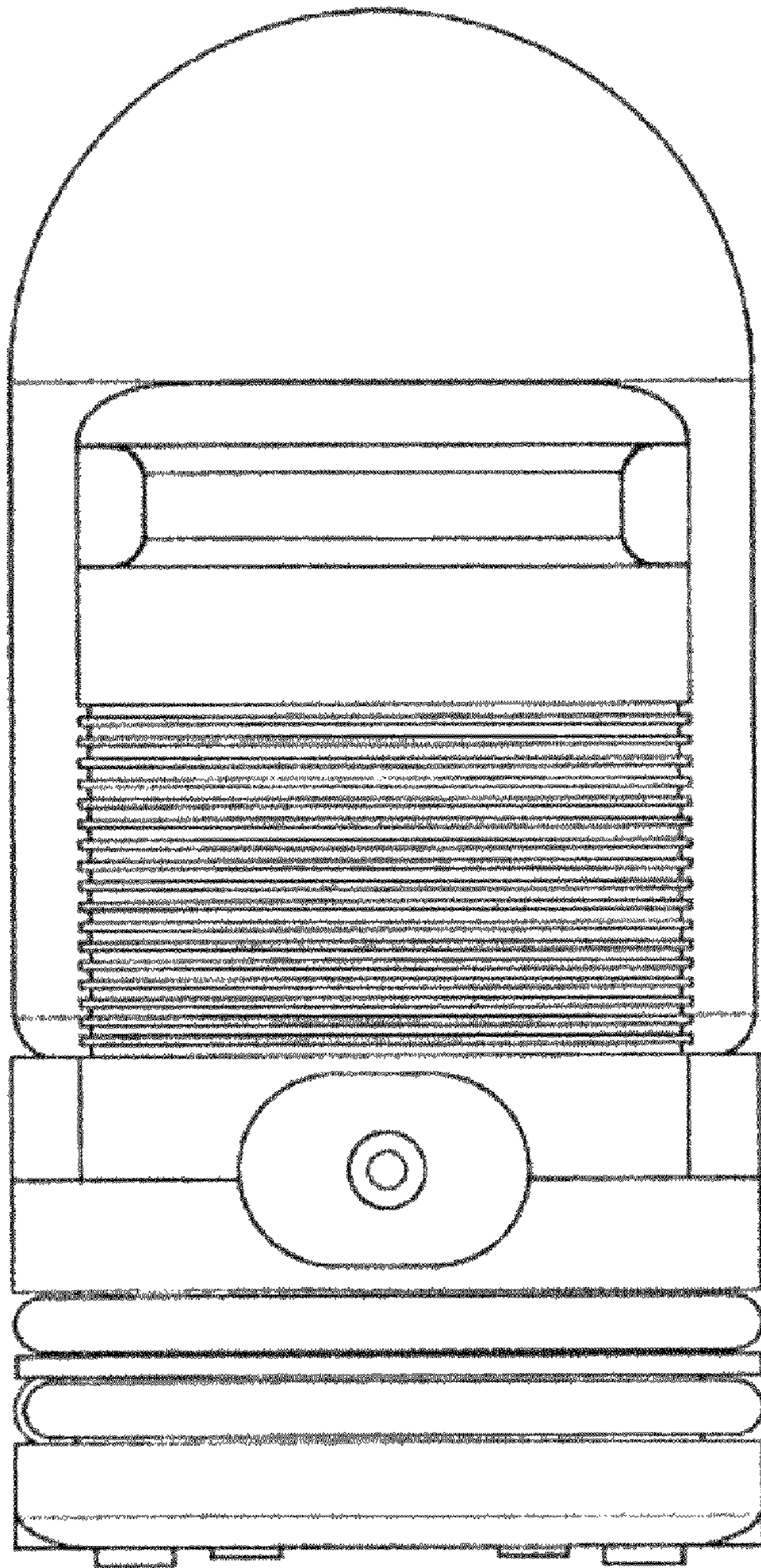

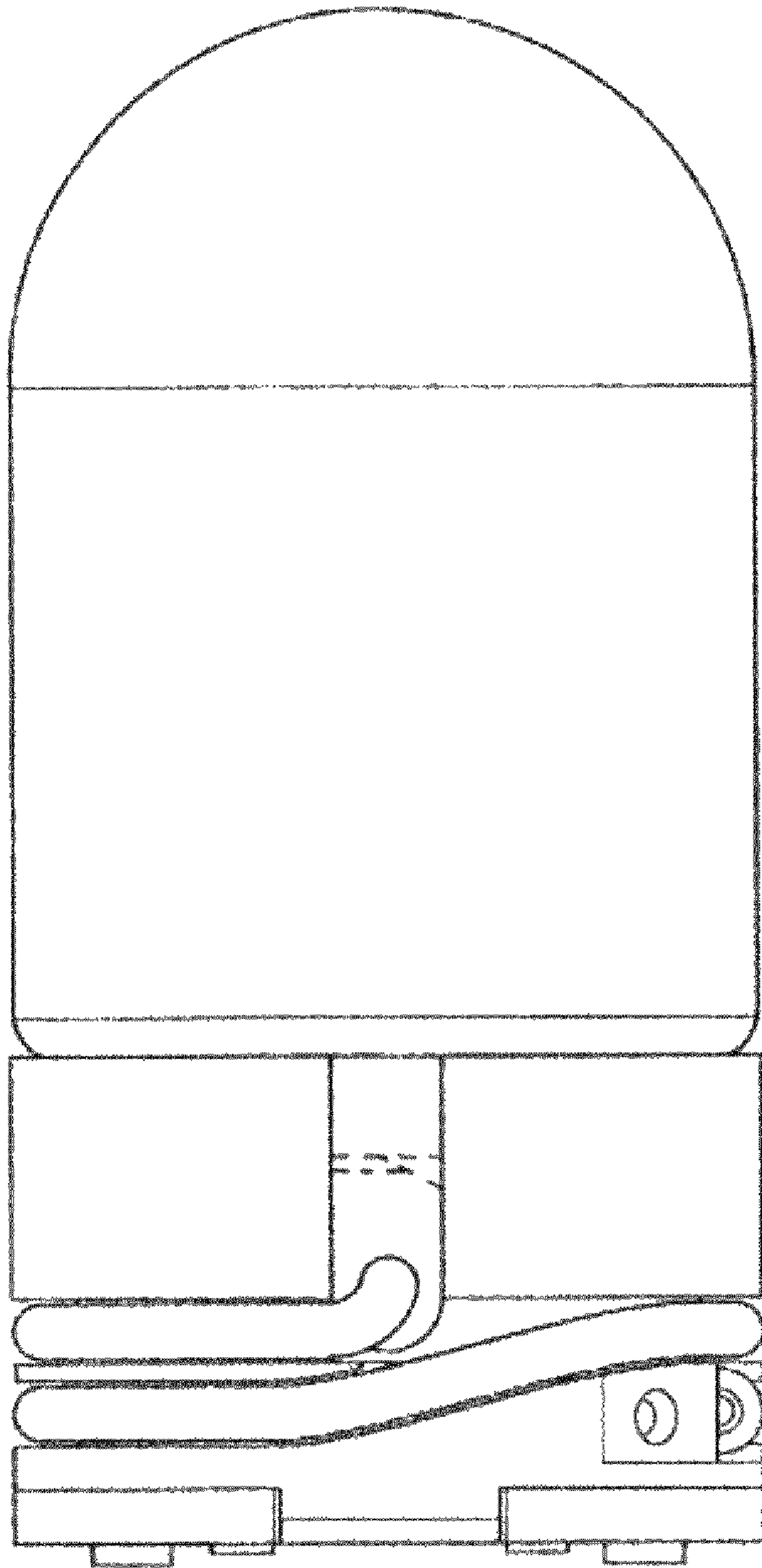

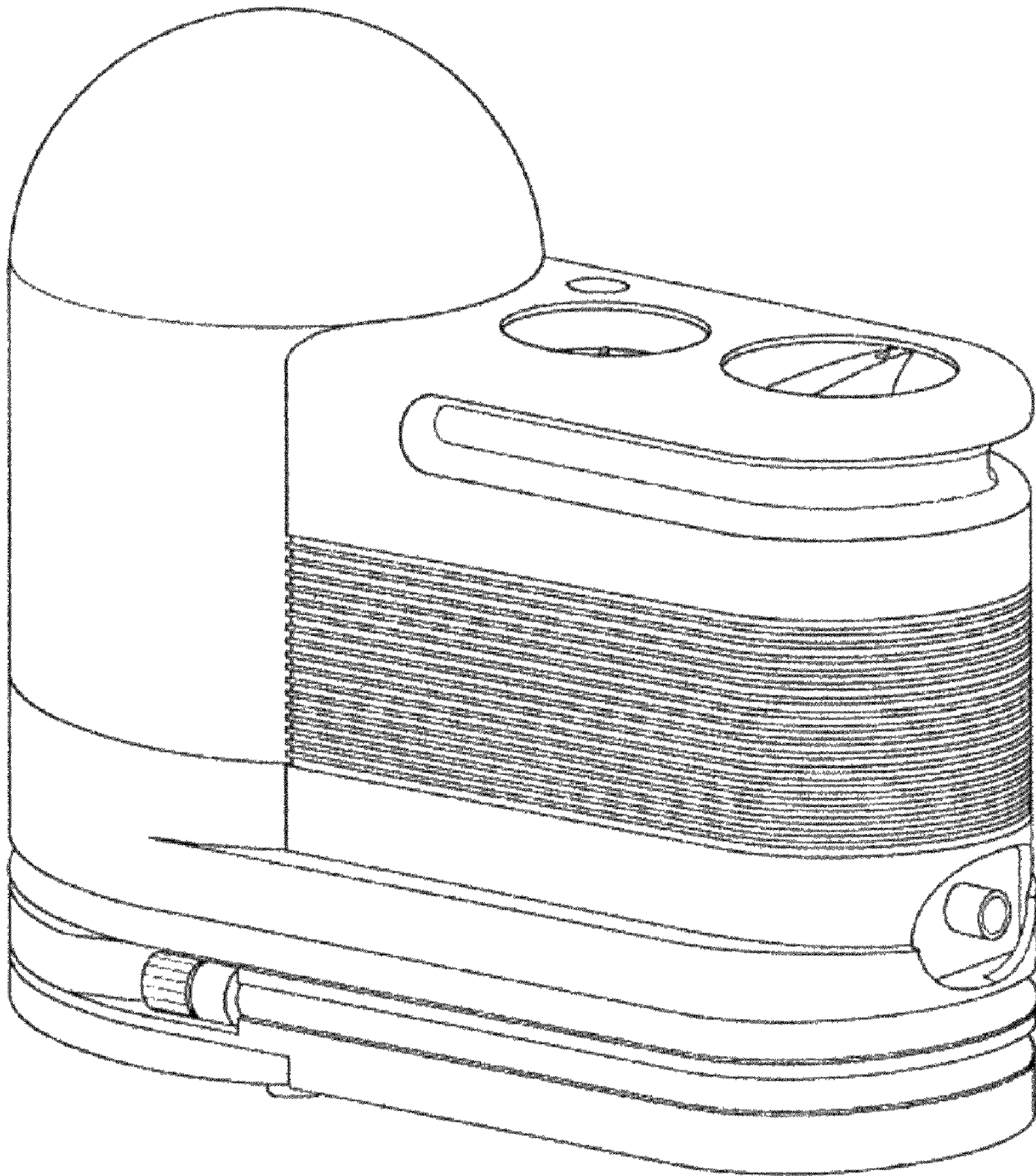
