(57) **CLAIM**

We claim the ornamental design for a faucet, as shown and described.

**DESCRIPTION**

FIG. 3 is a rear elevation view of the claimed design of FIG. 1;

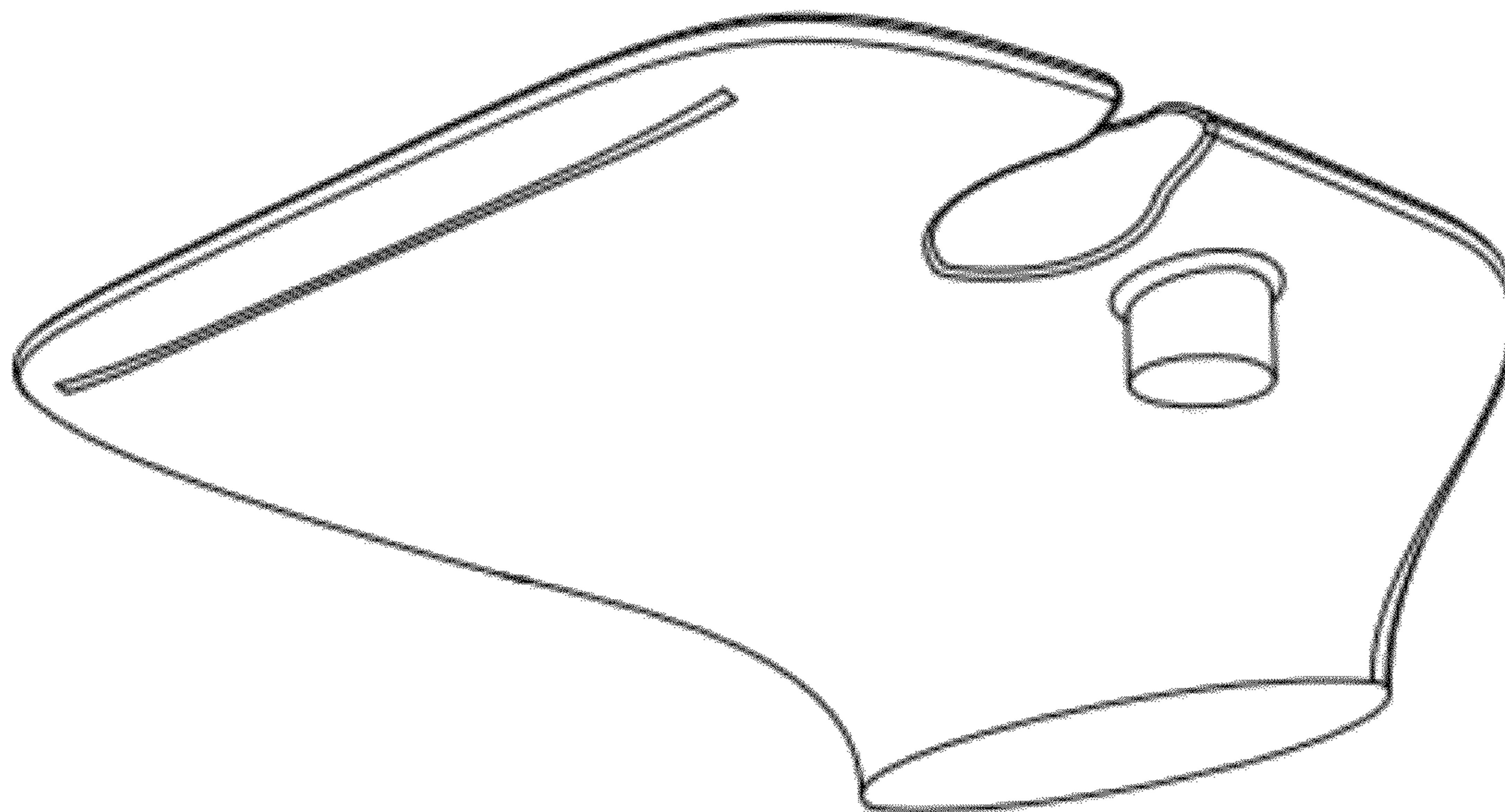
FIG. 4 is a left-side elevation view of the claimed design of FIG. 1;

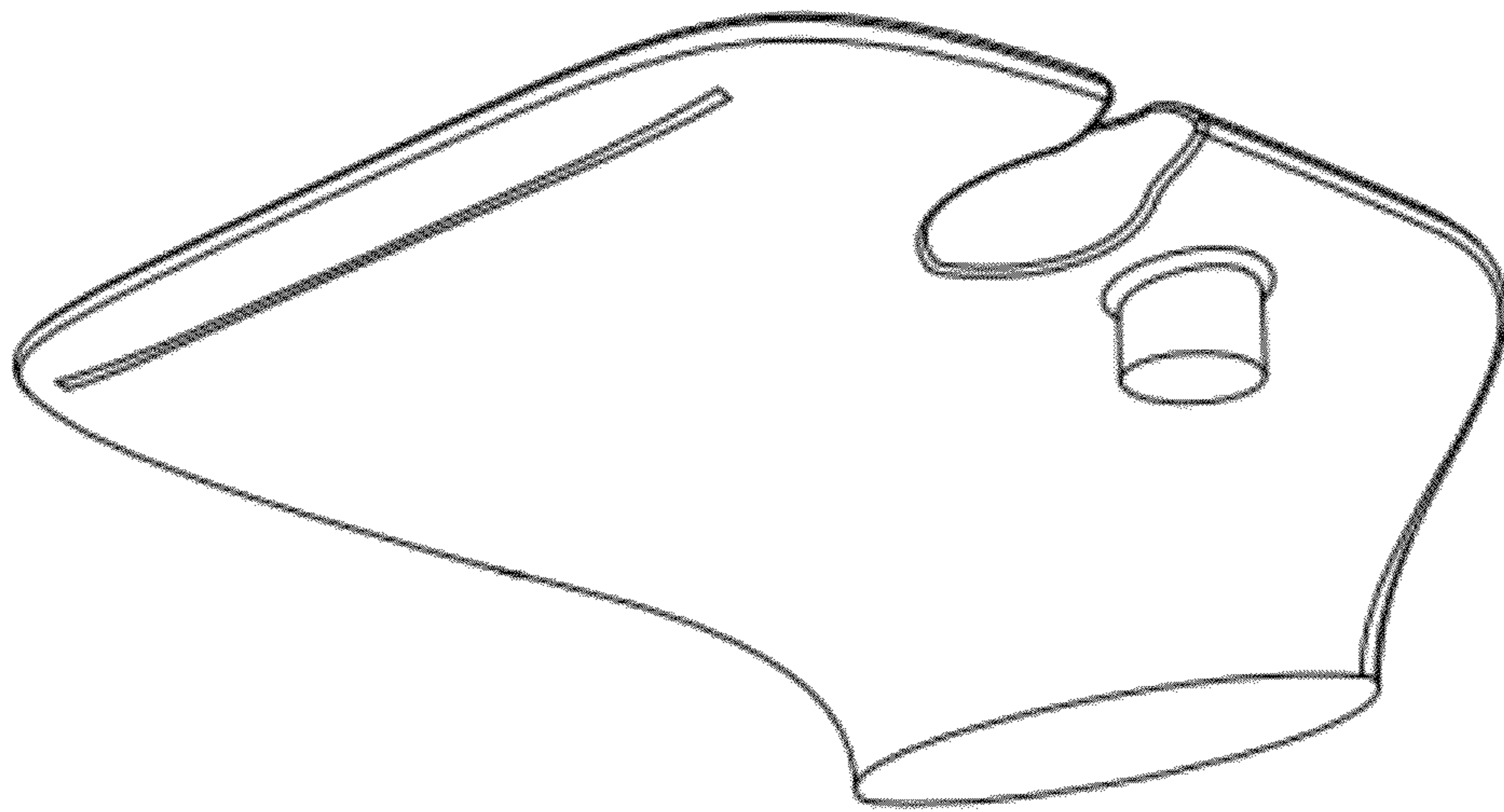

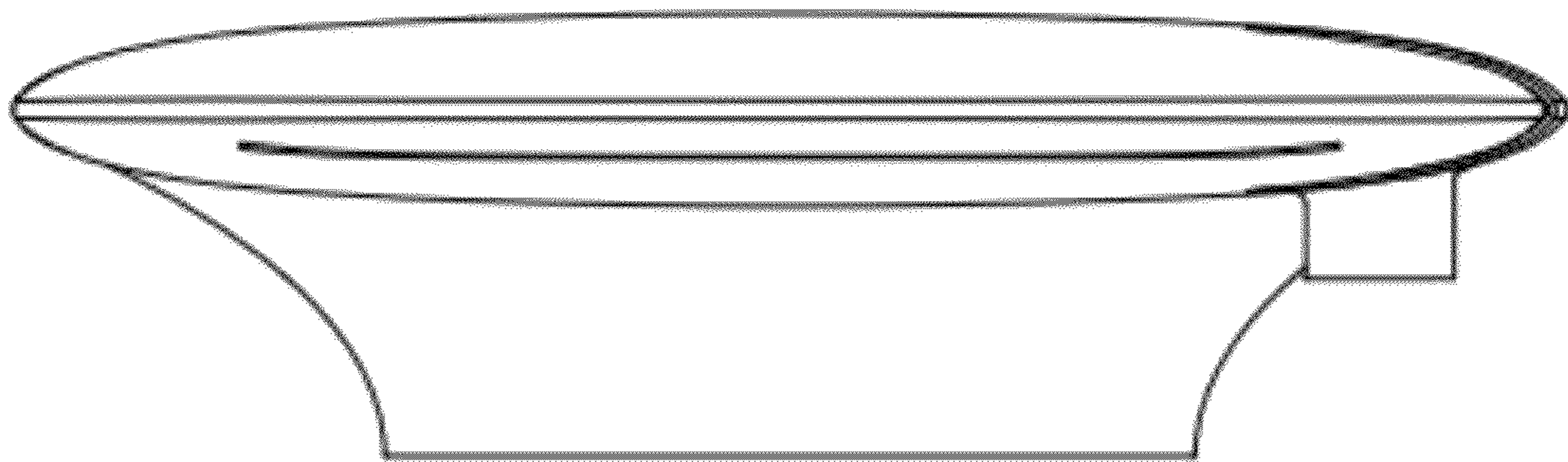

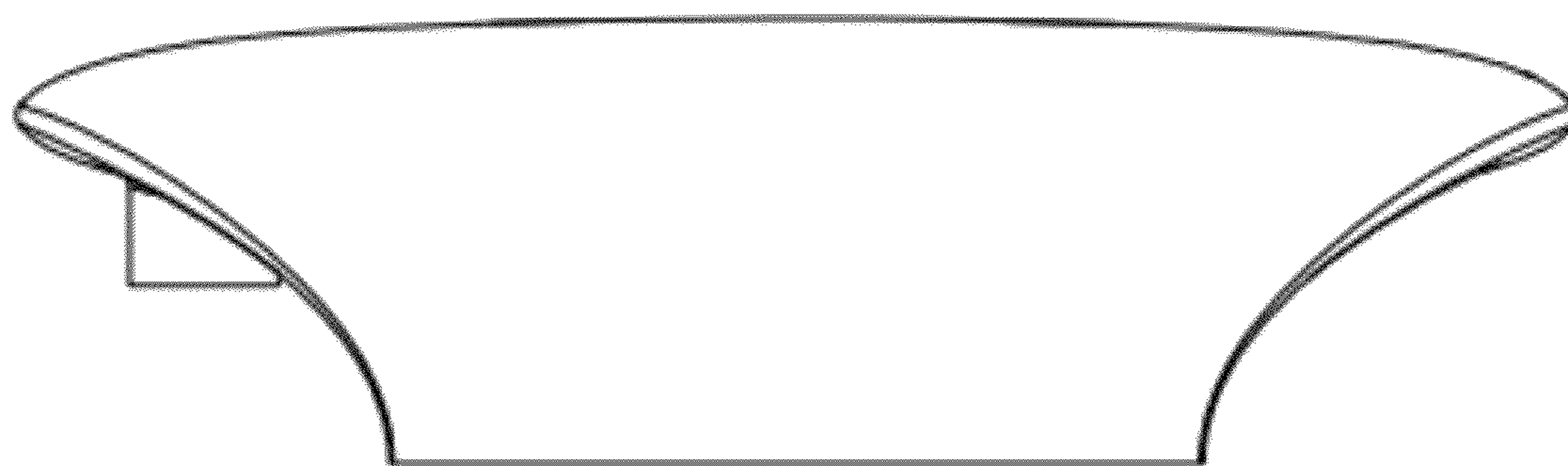

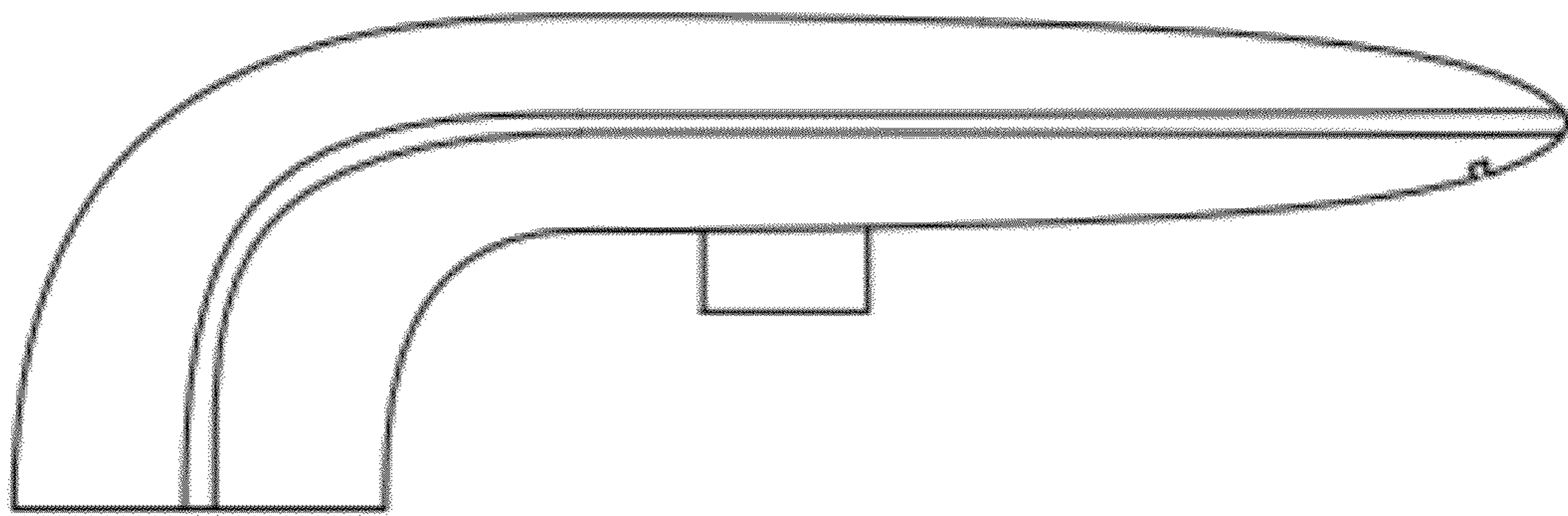

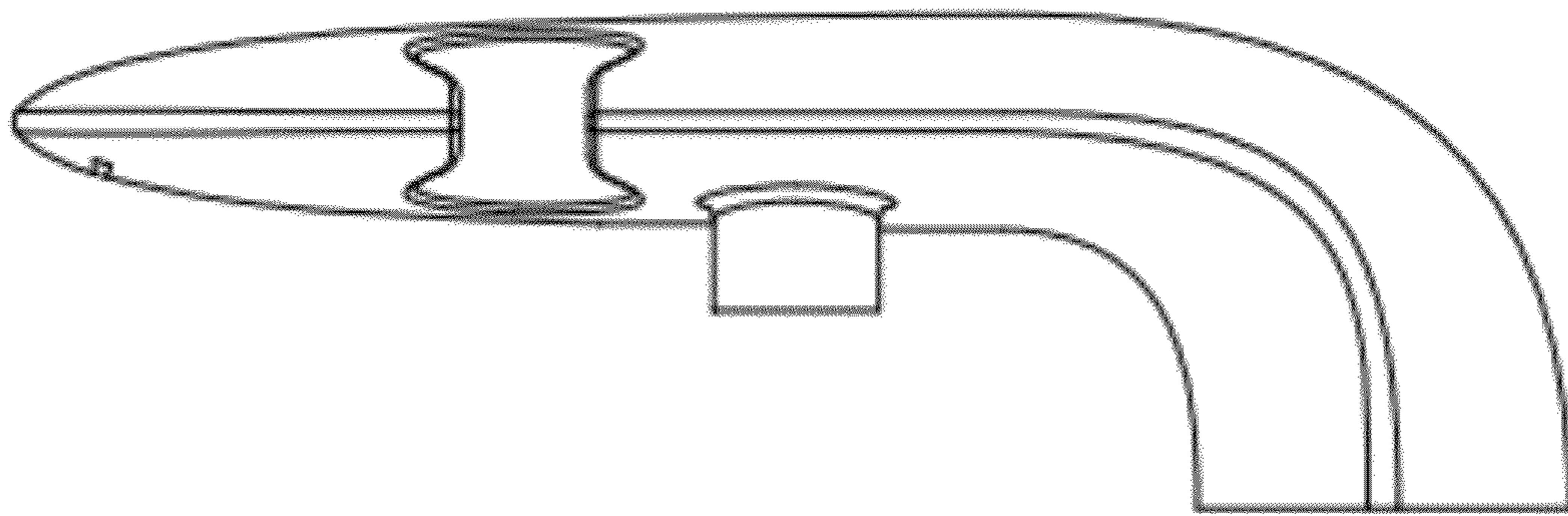

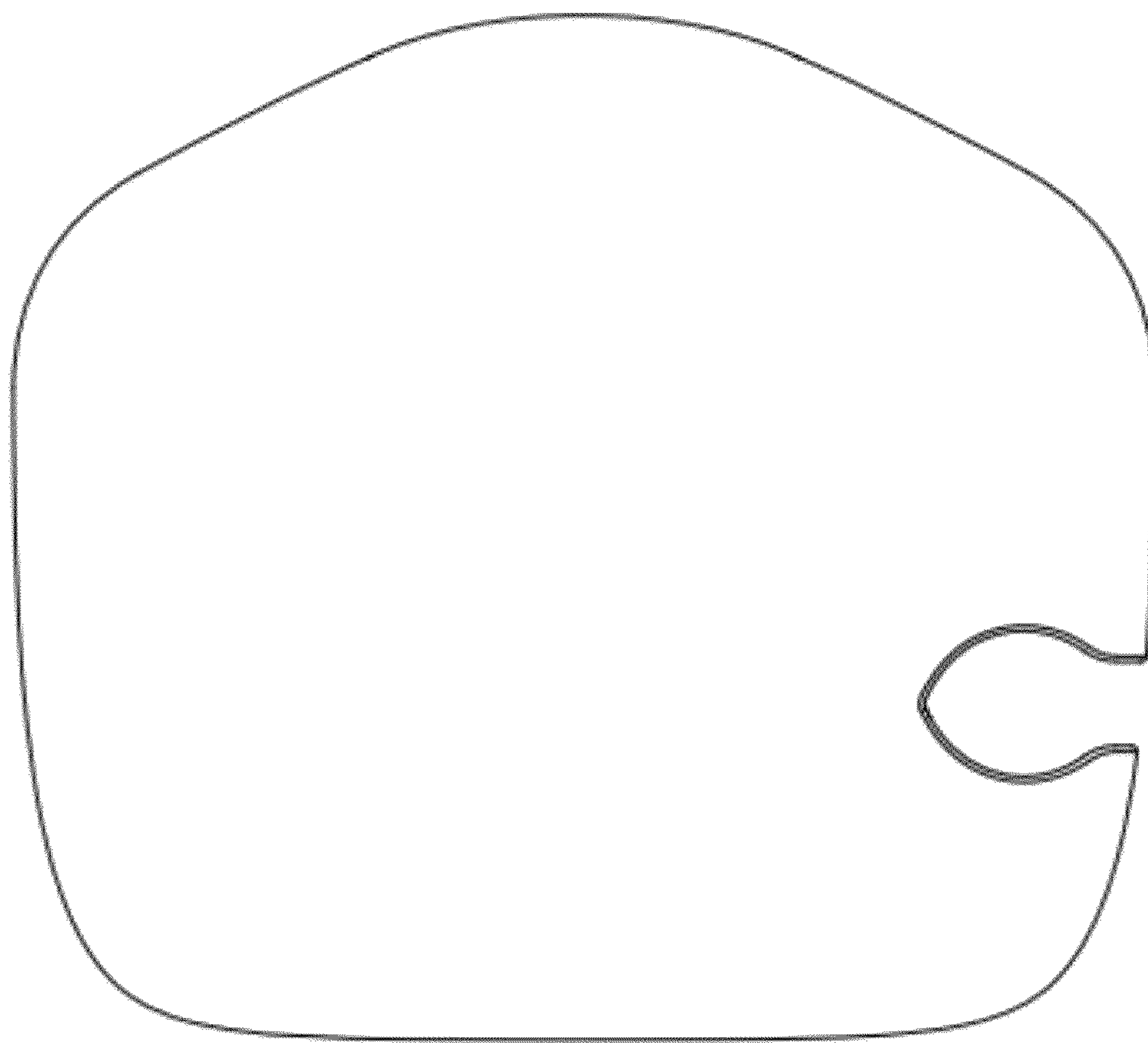

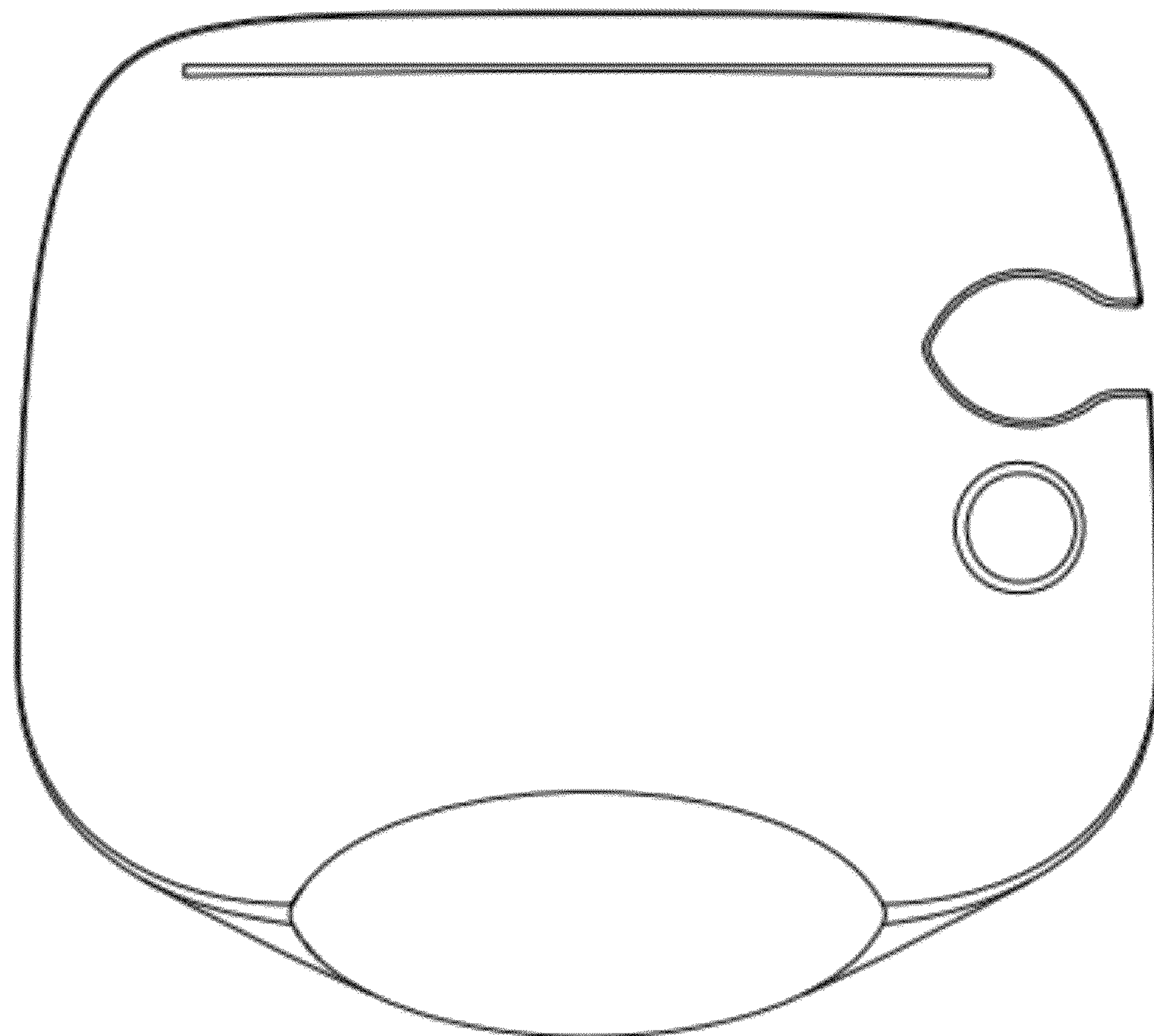
