FIG. 19 is a perspective view of a first embodiment of a fourth set of pavers;

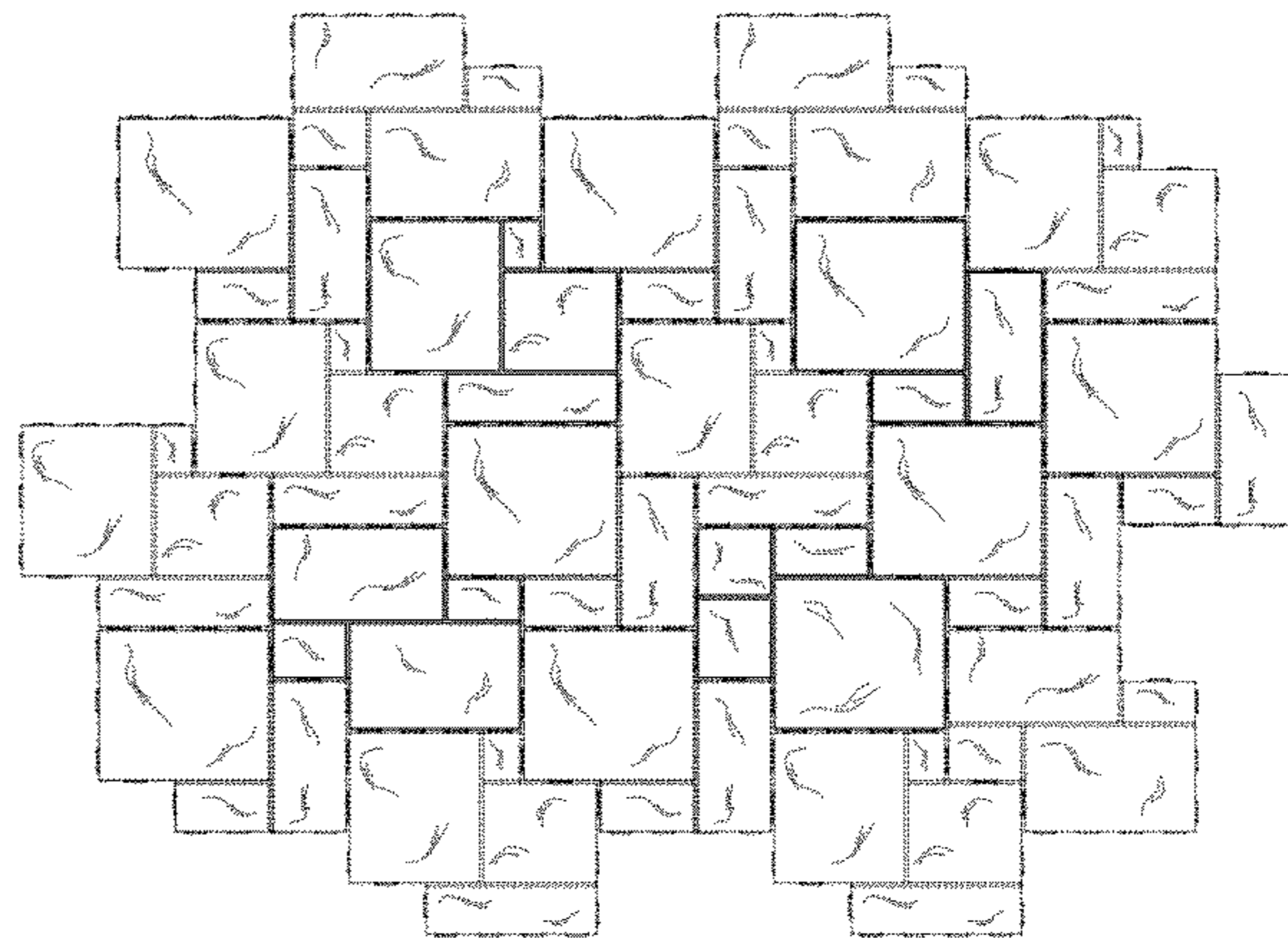
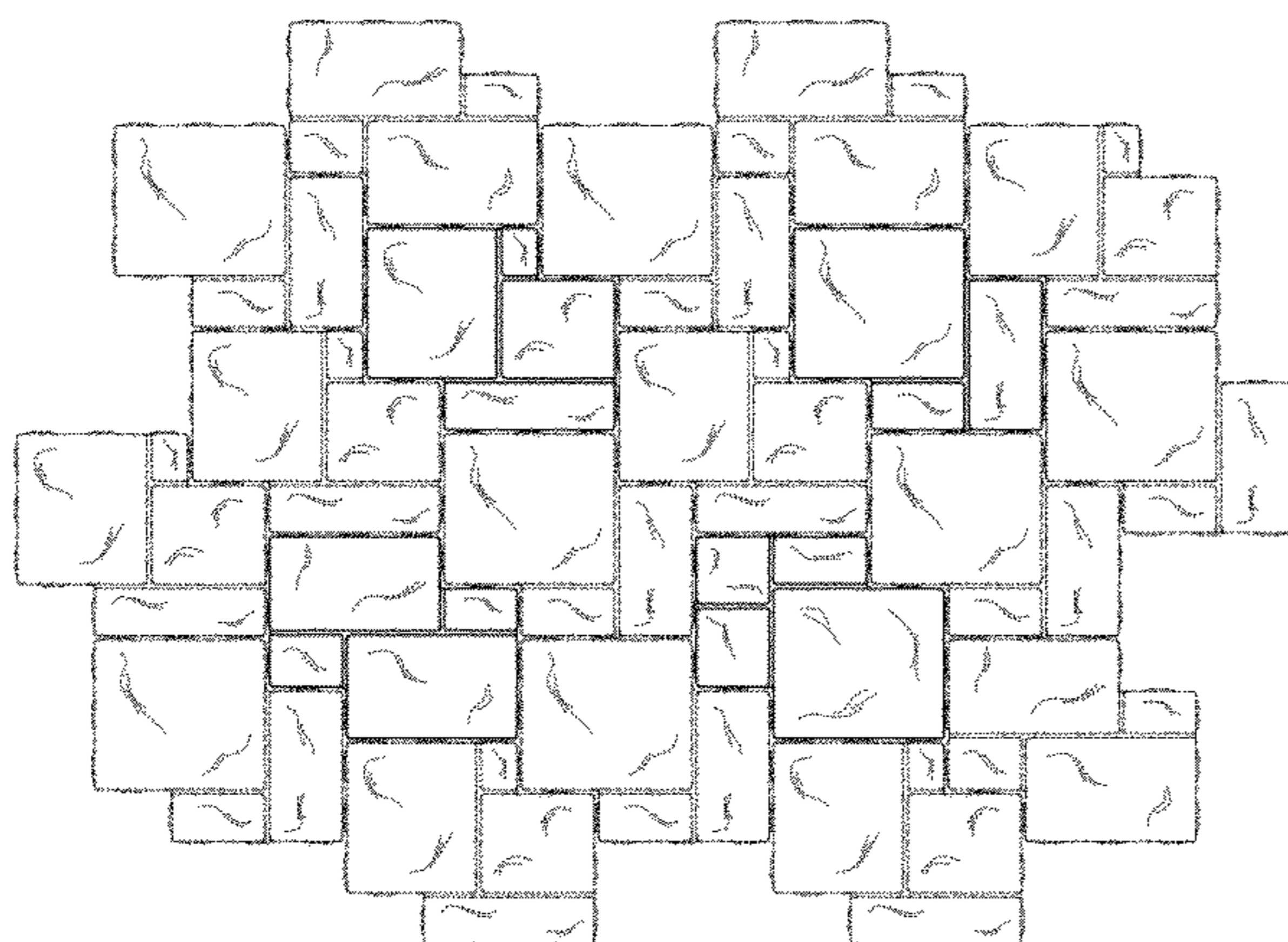


FIG. 20 is a top view of the first embodiment of the fourth set of pavers;

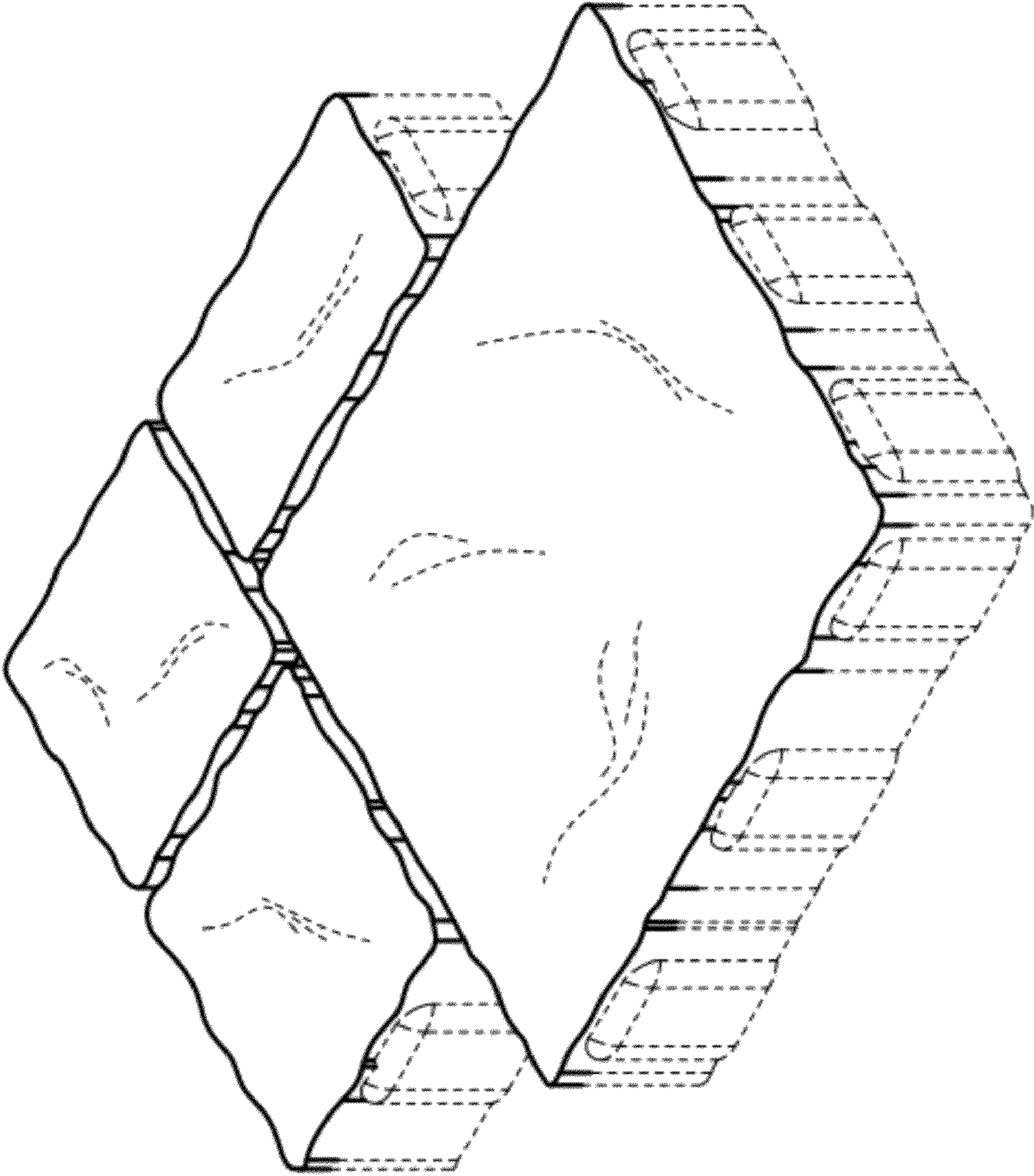

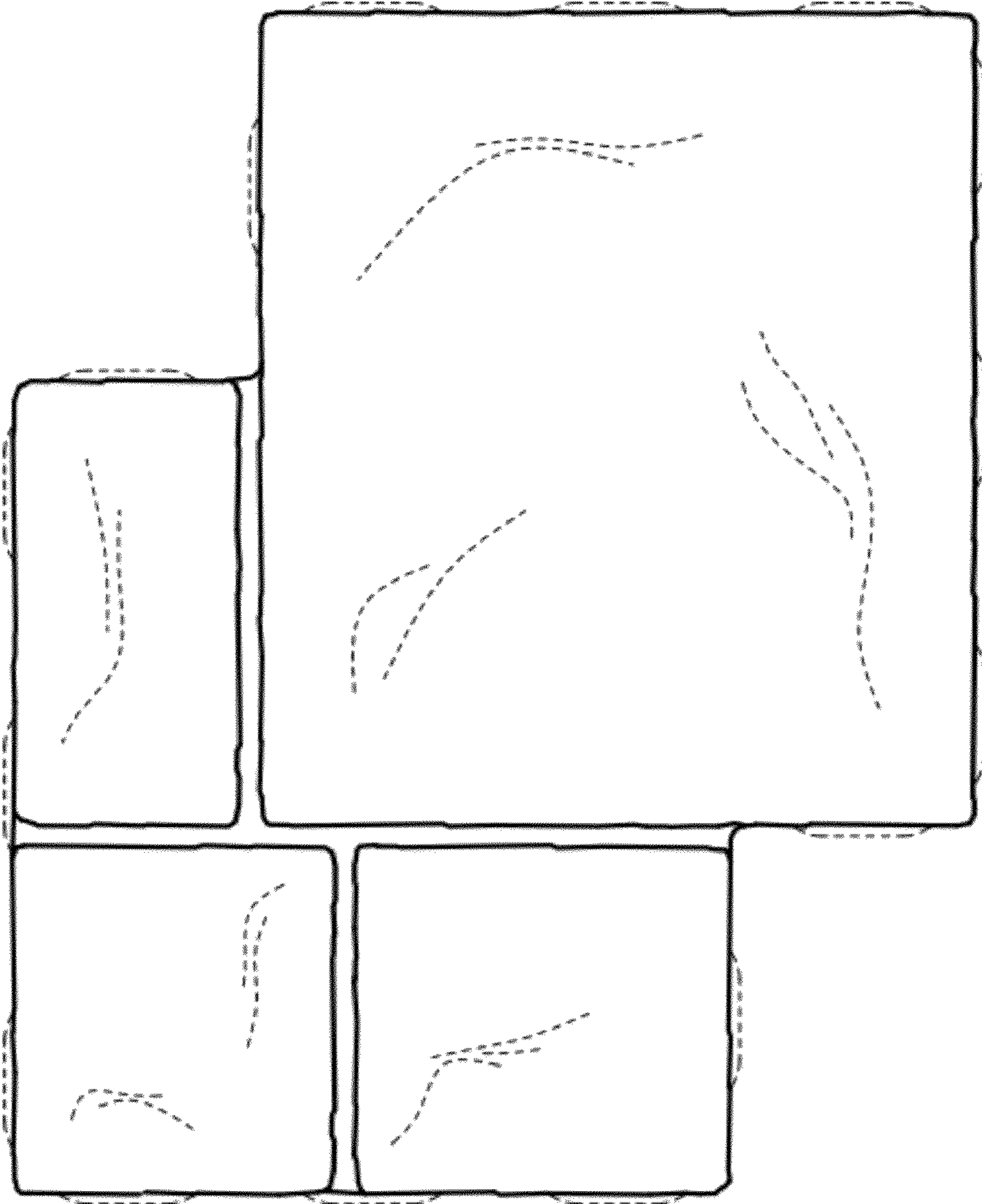

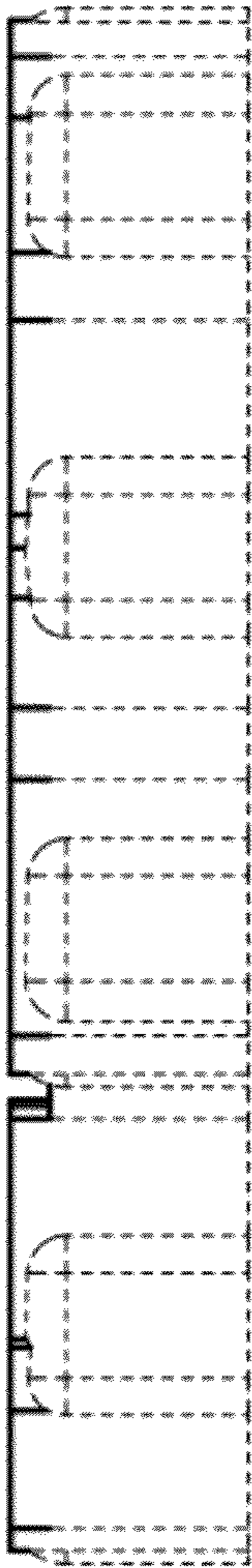

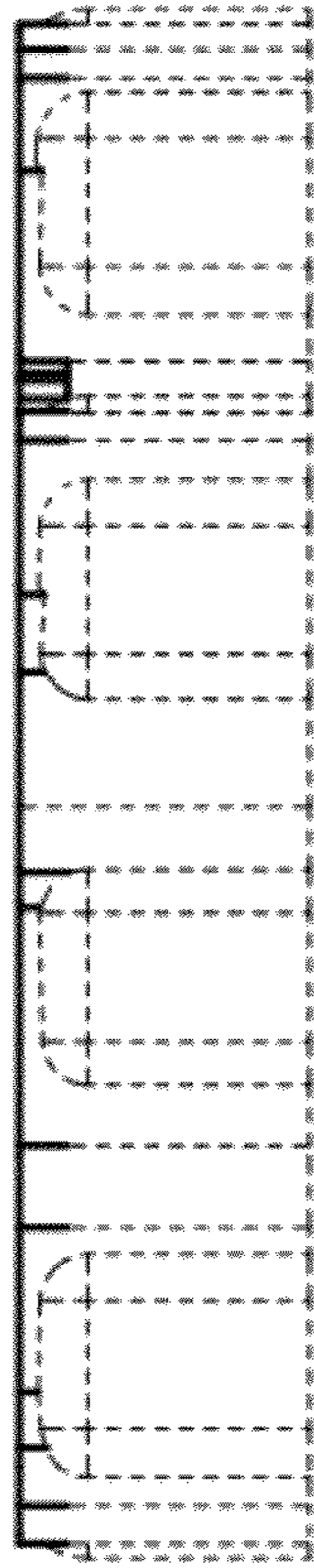

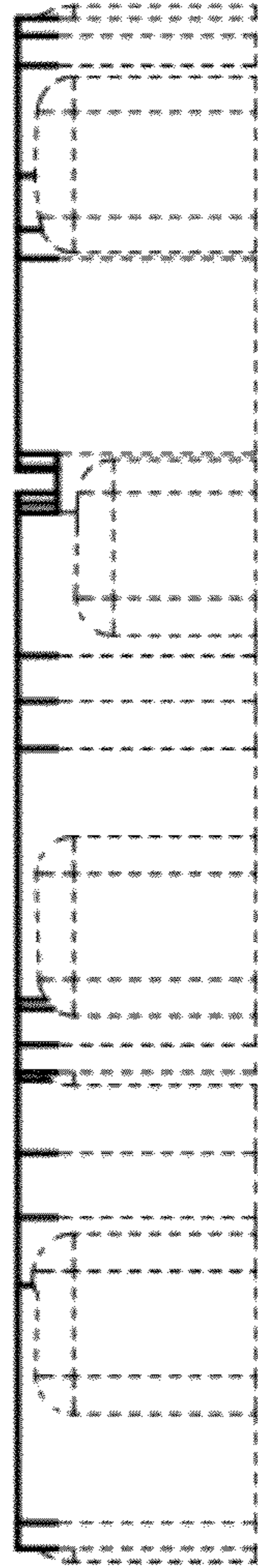

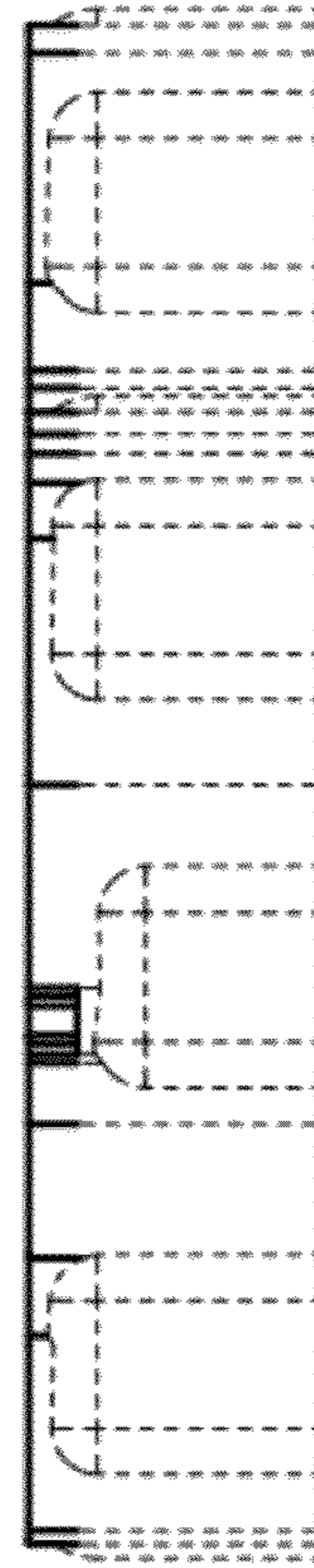

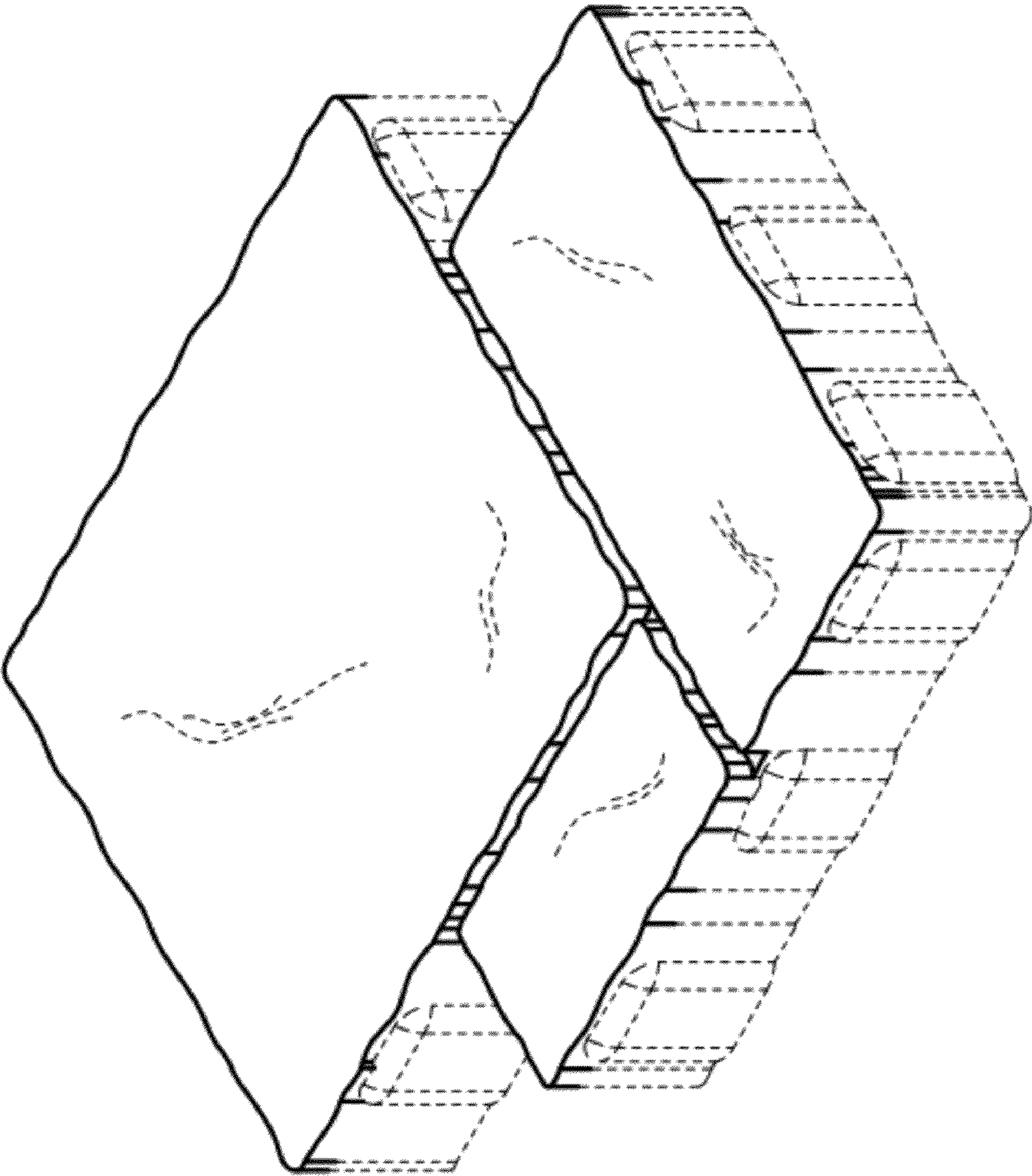

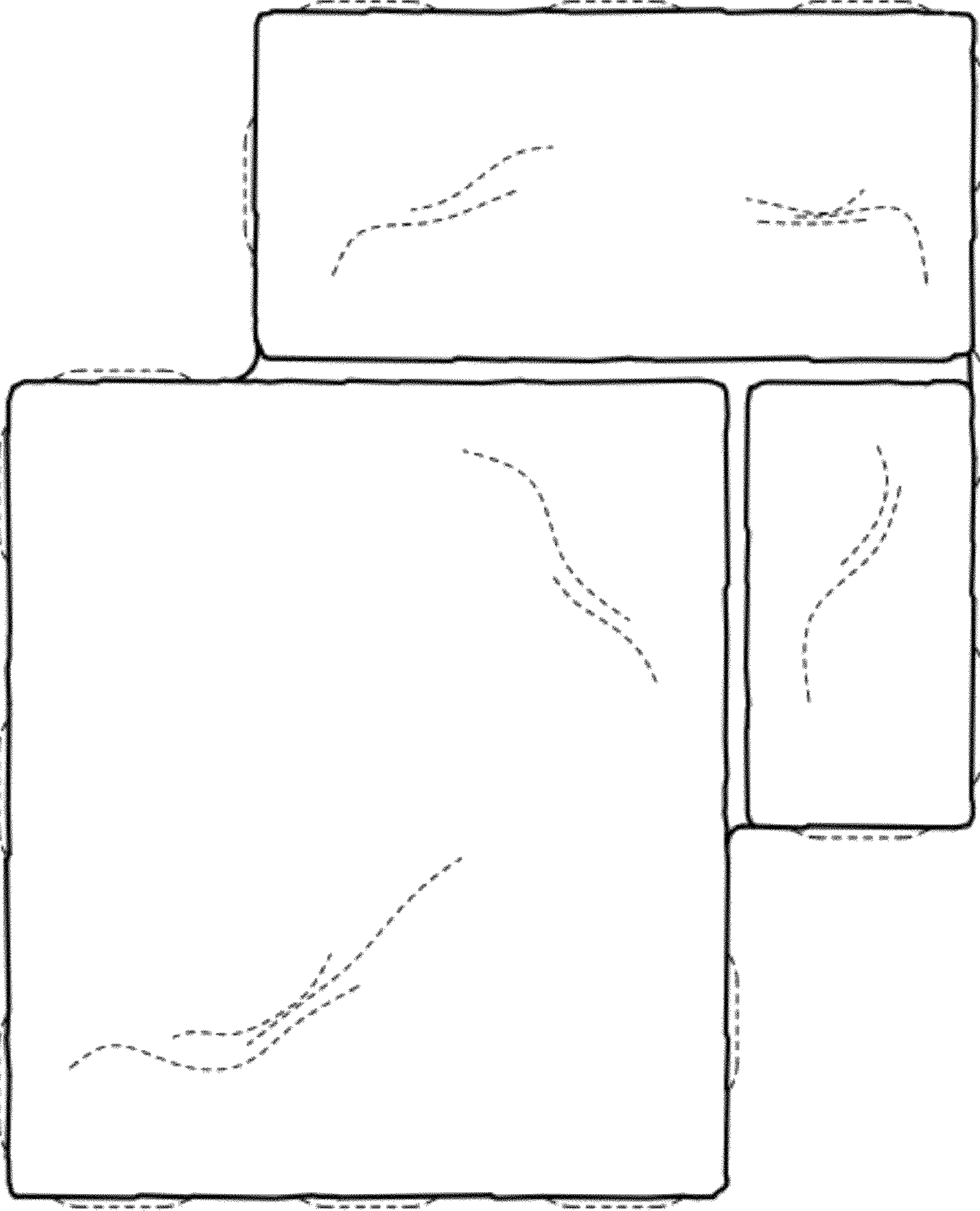

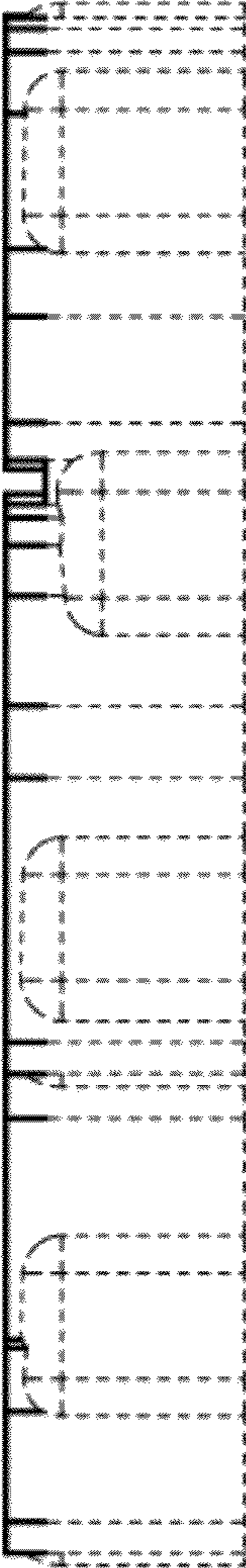

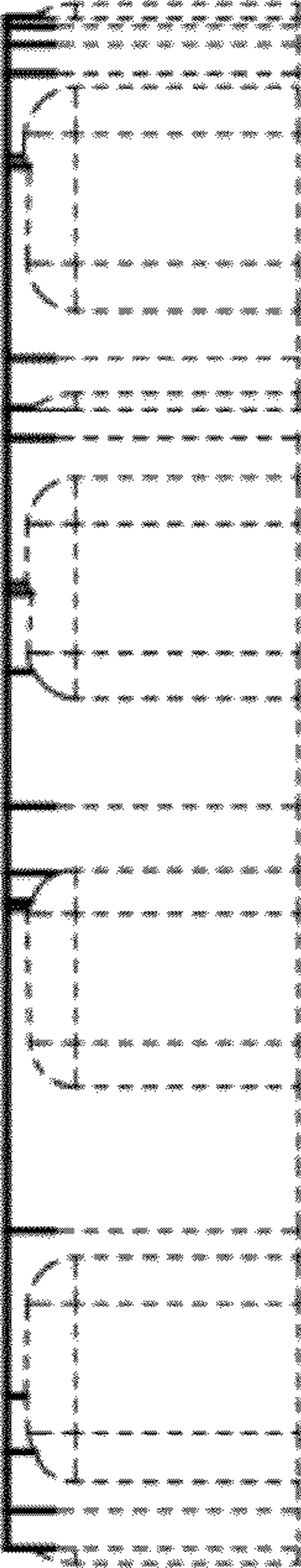

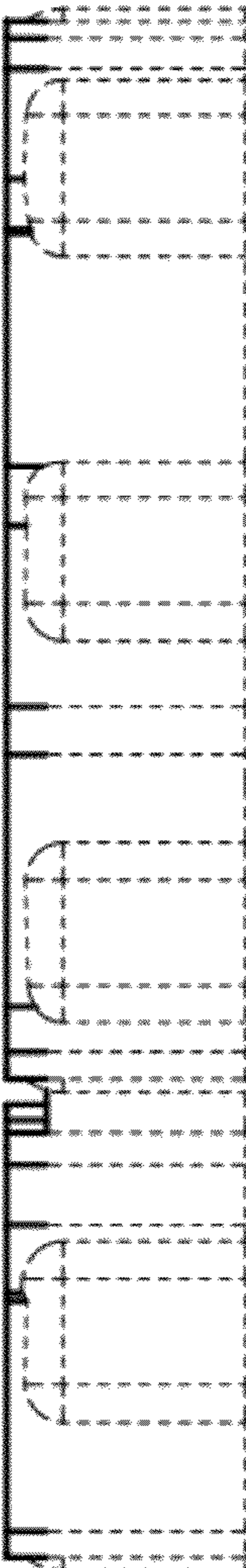

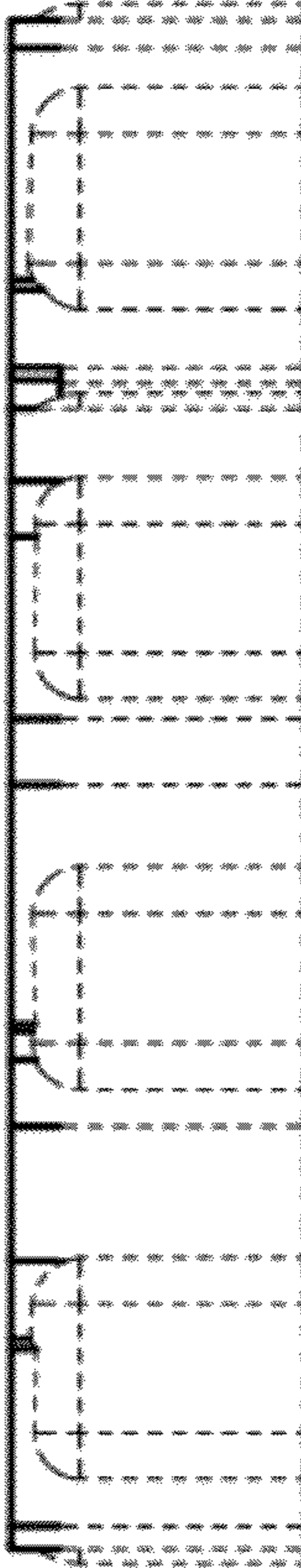

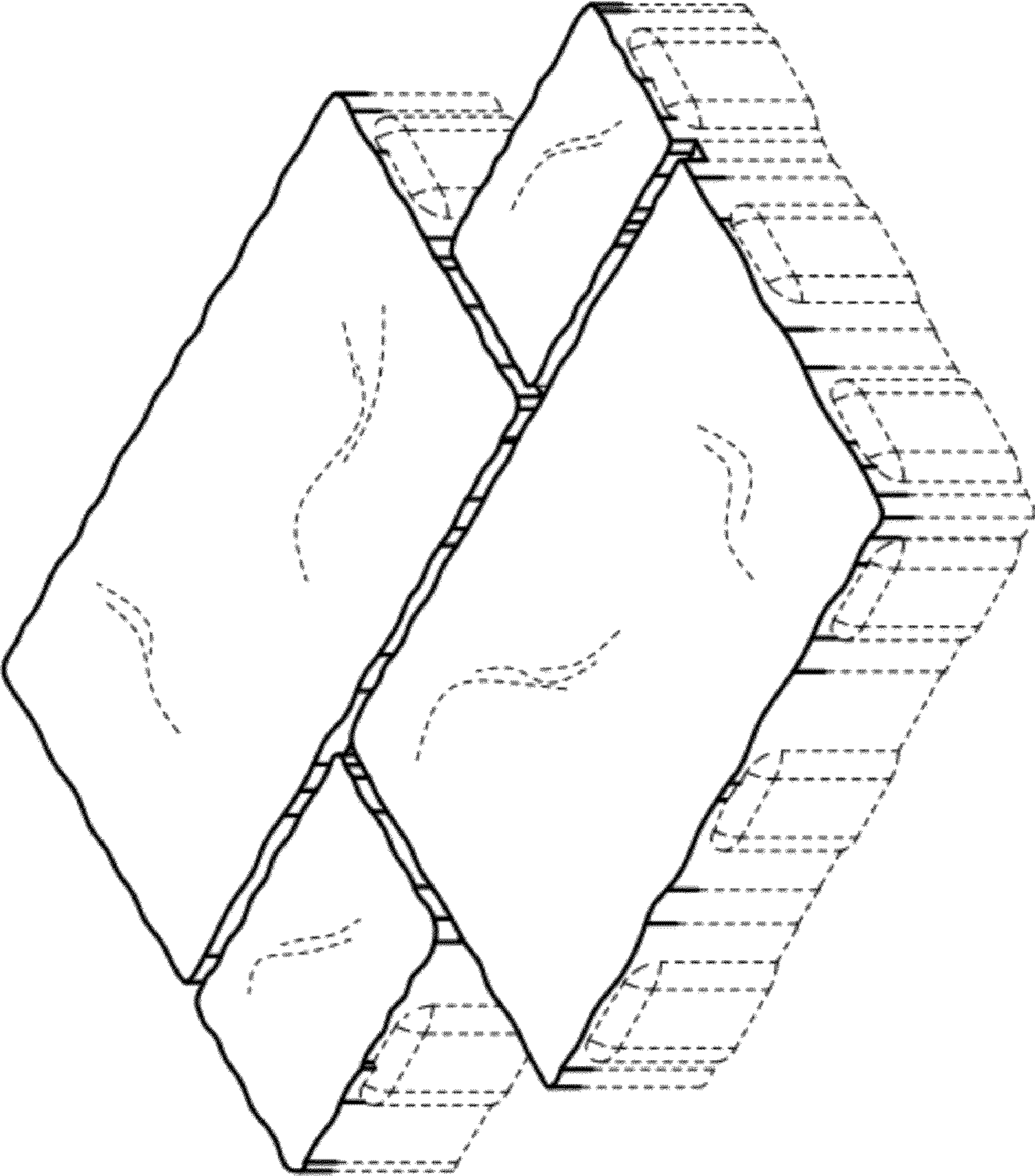

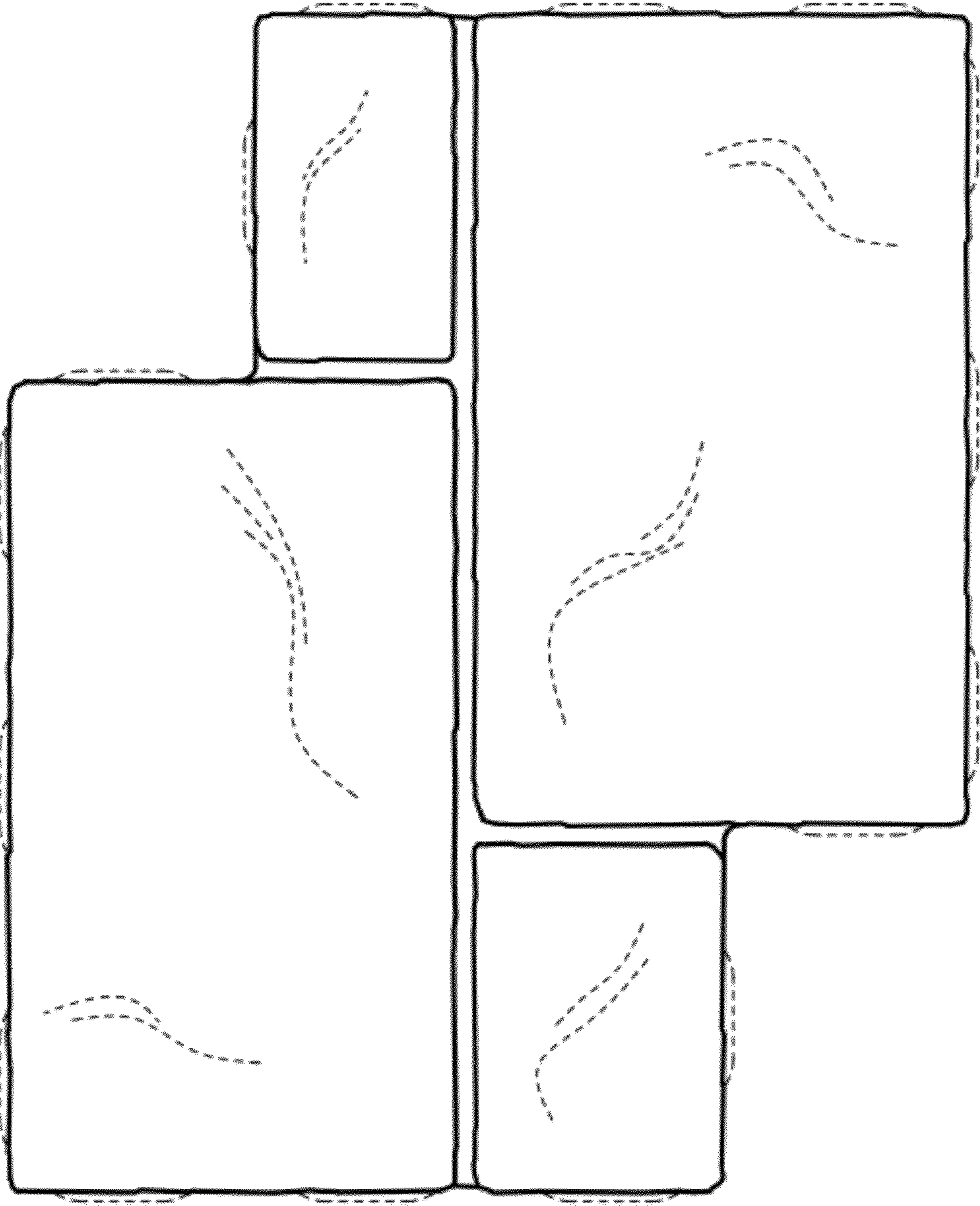

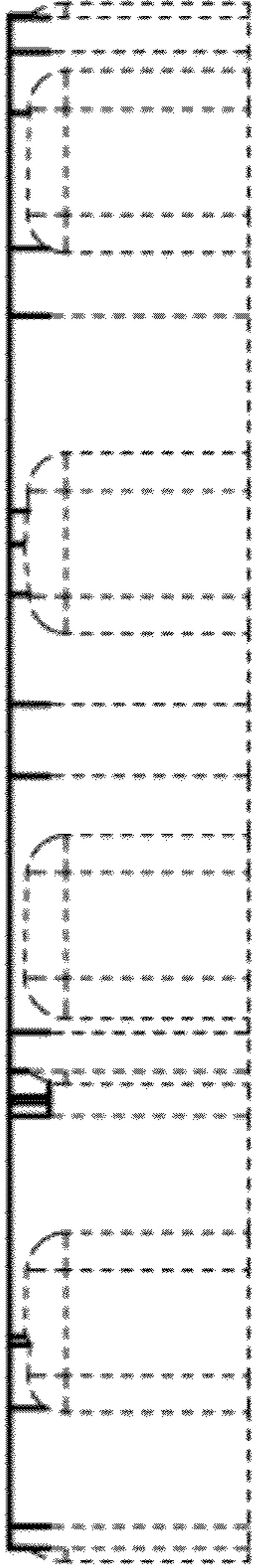

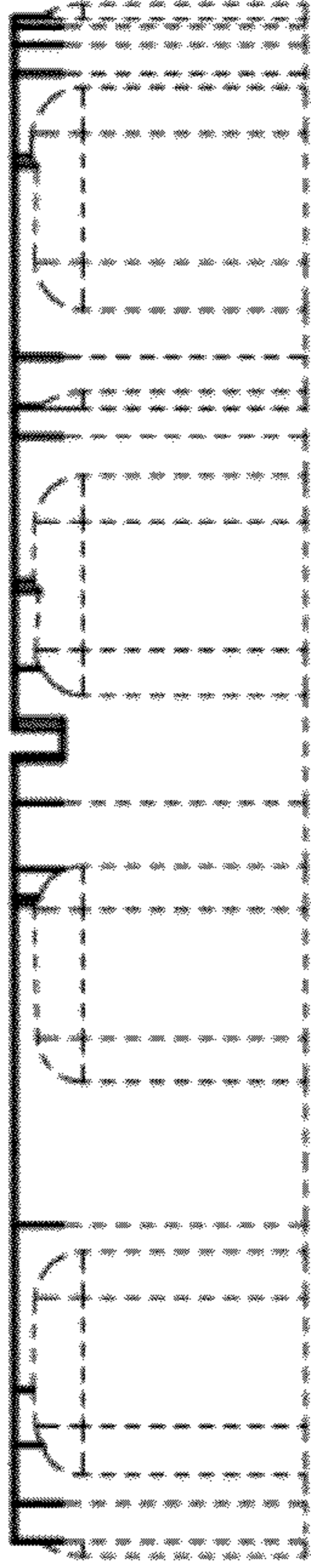

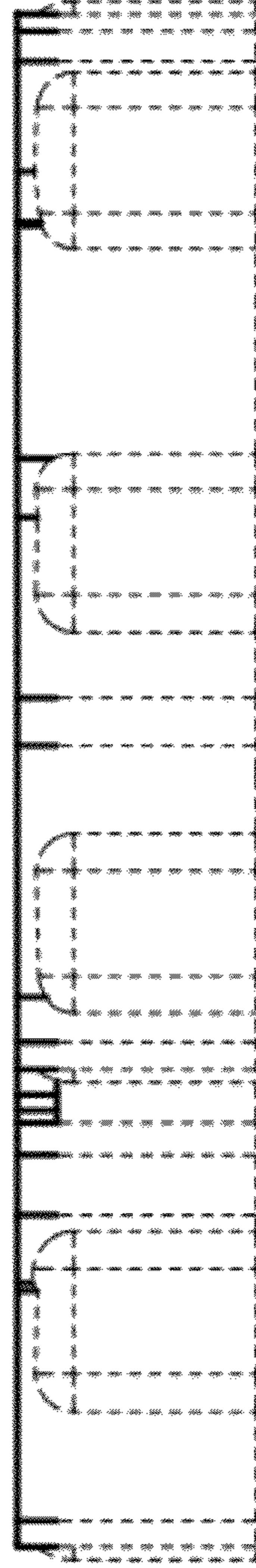

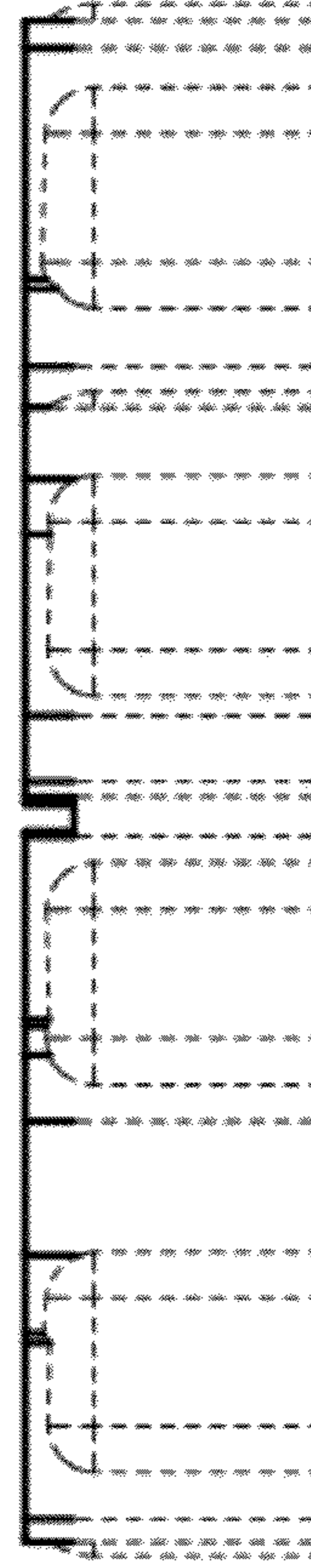

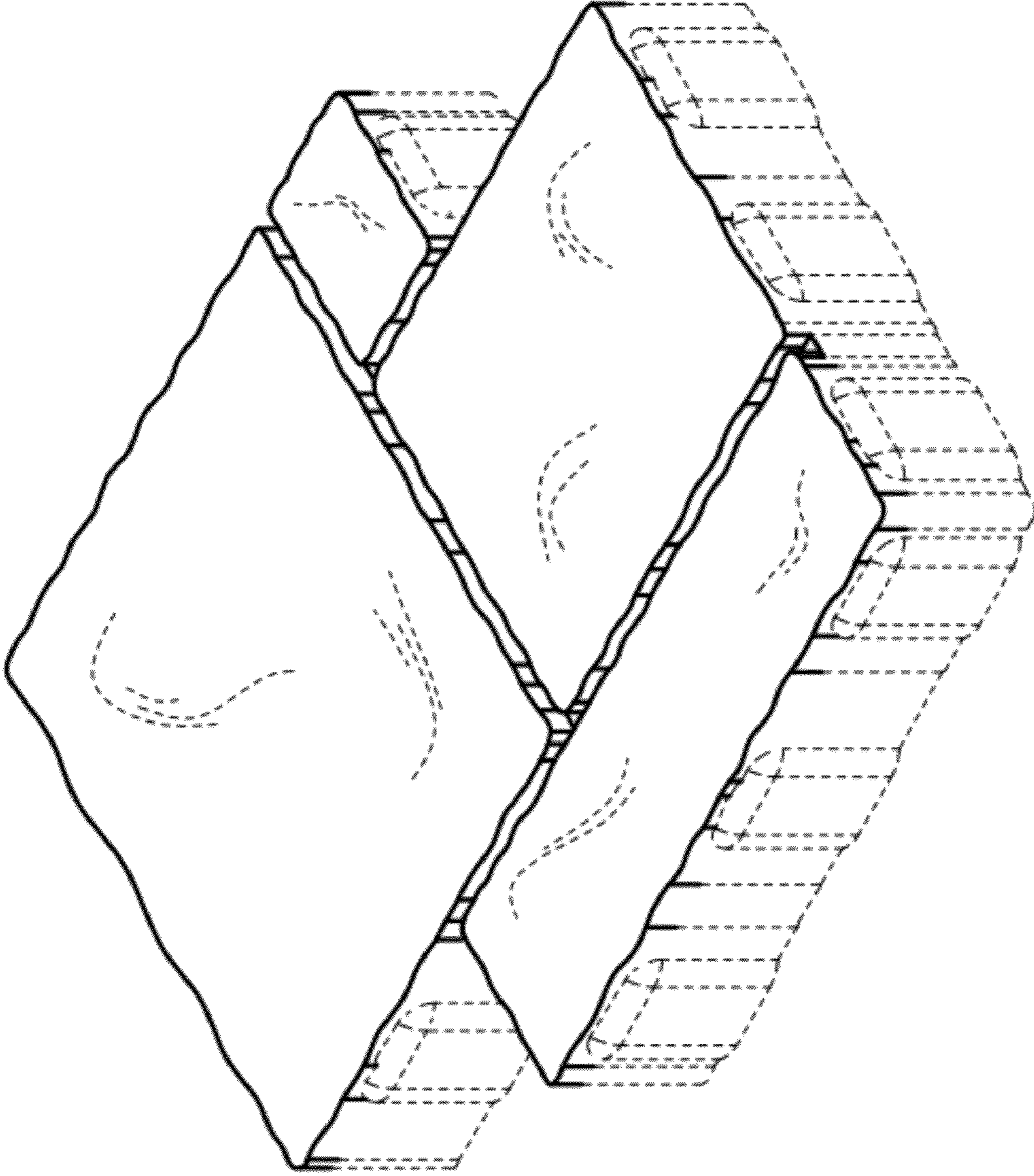

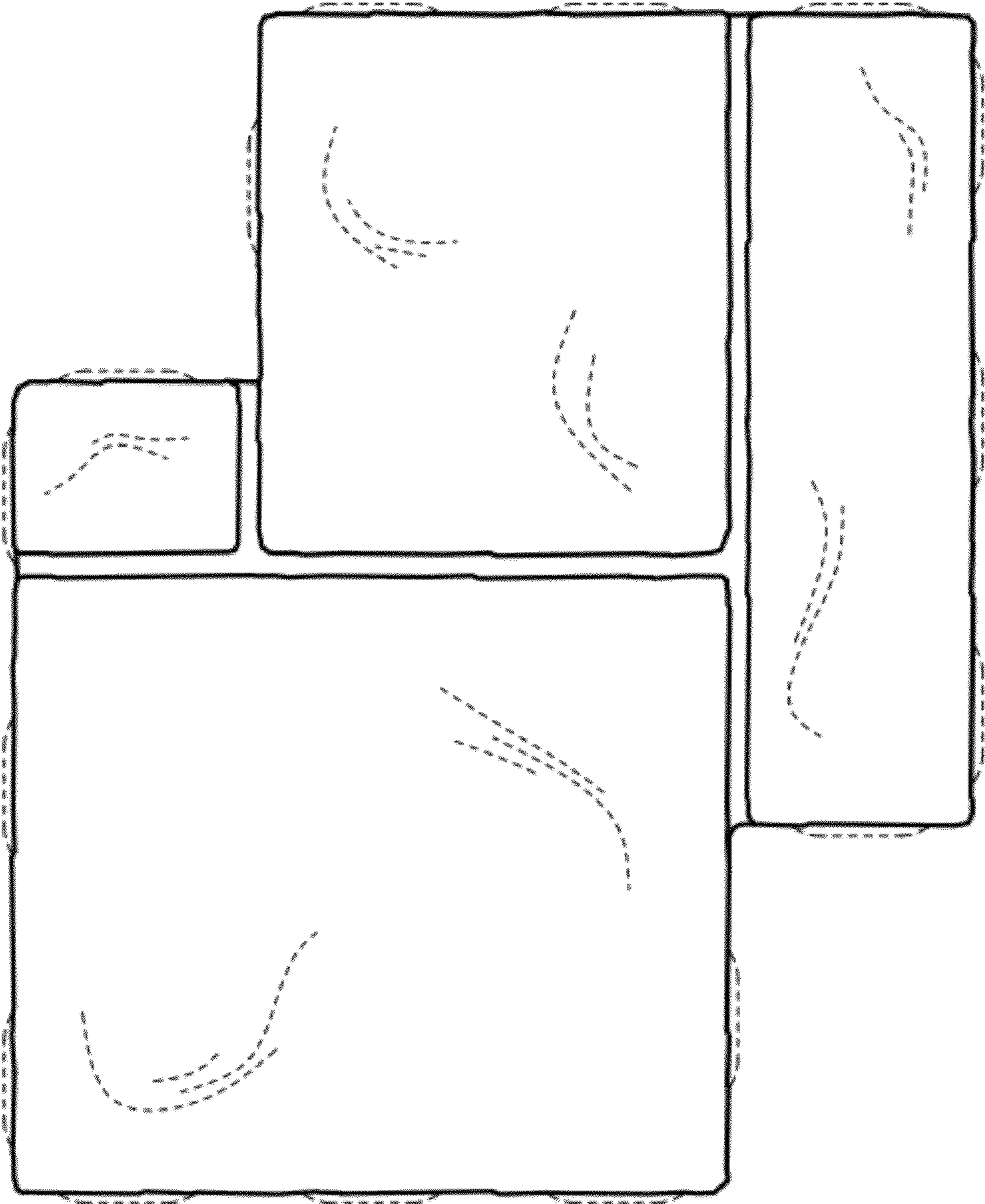

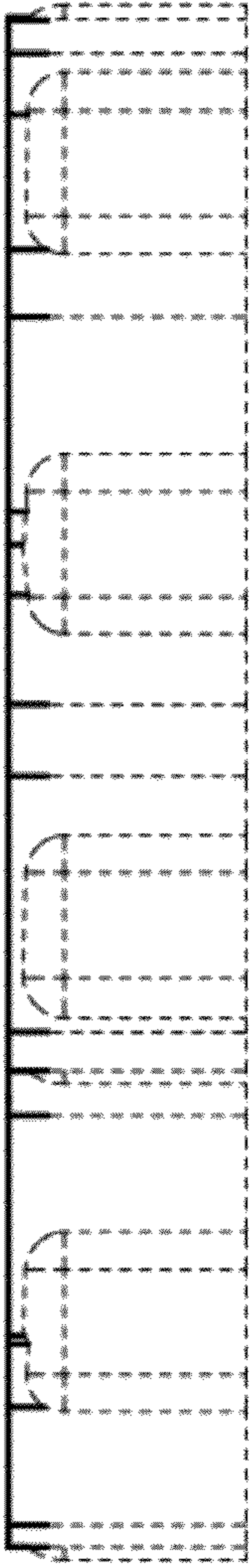

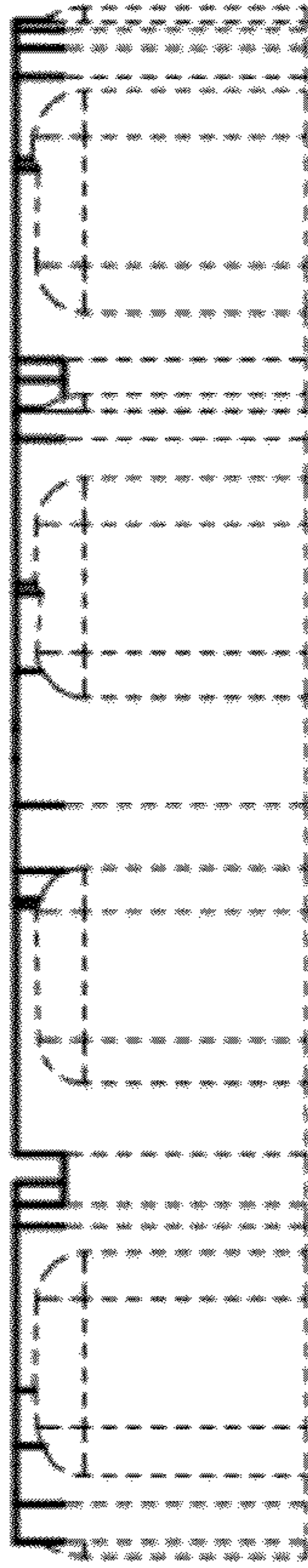

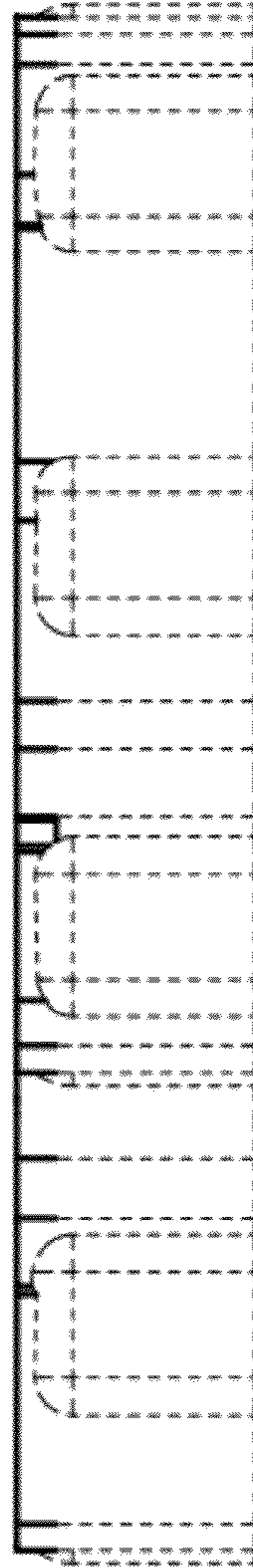

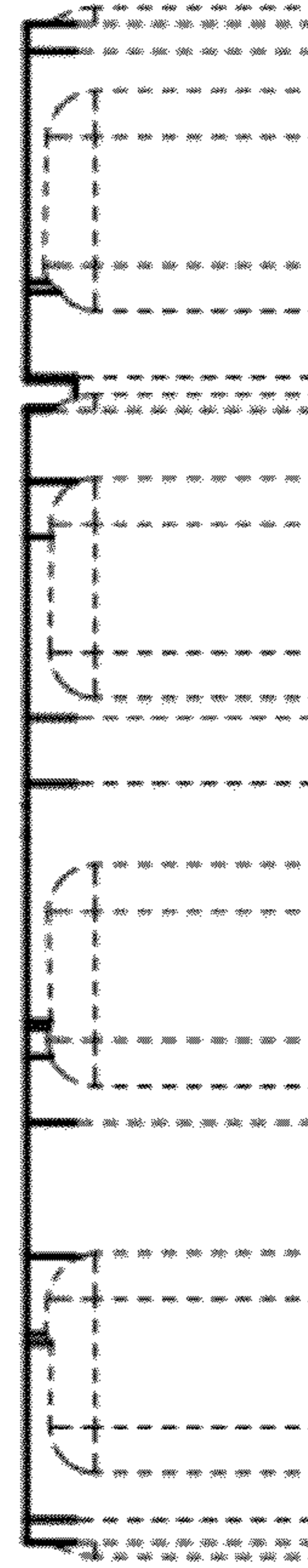

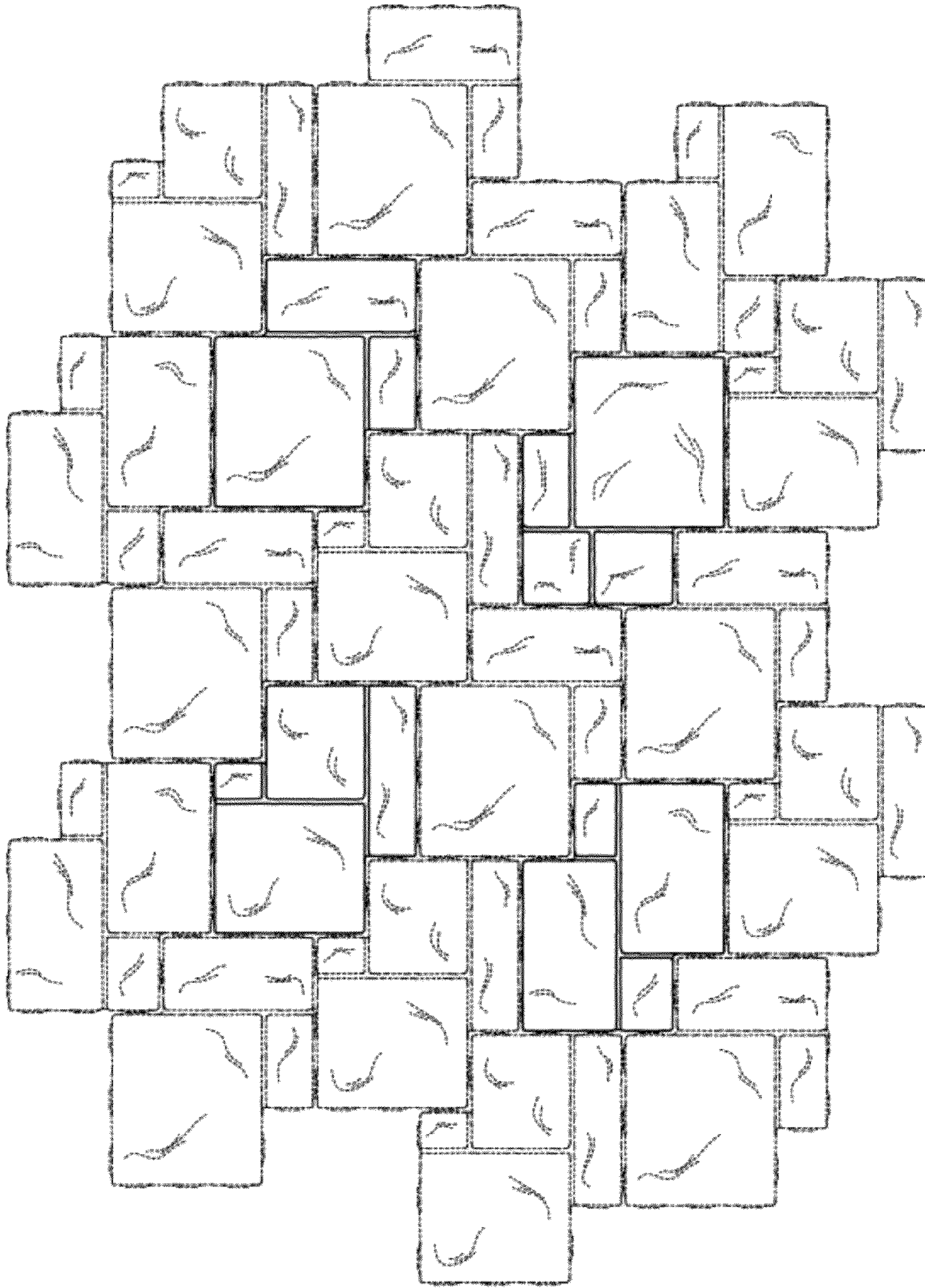

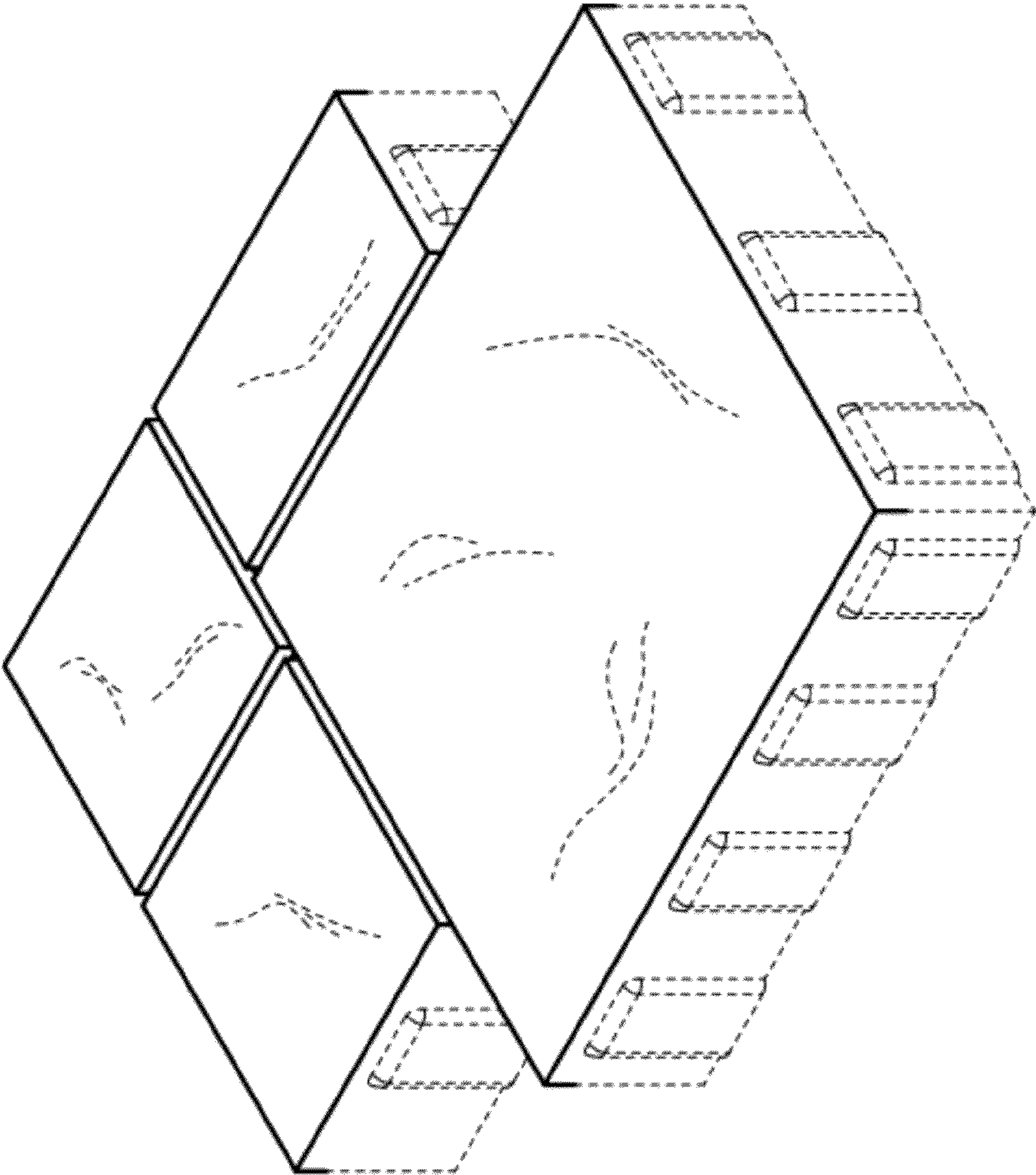

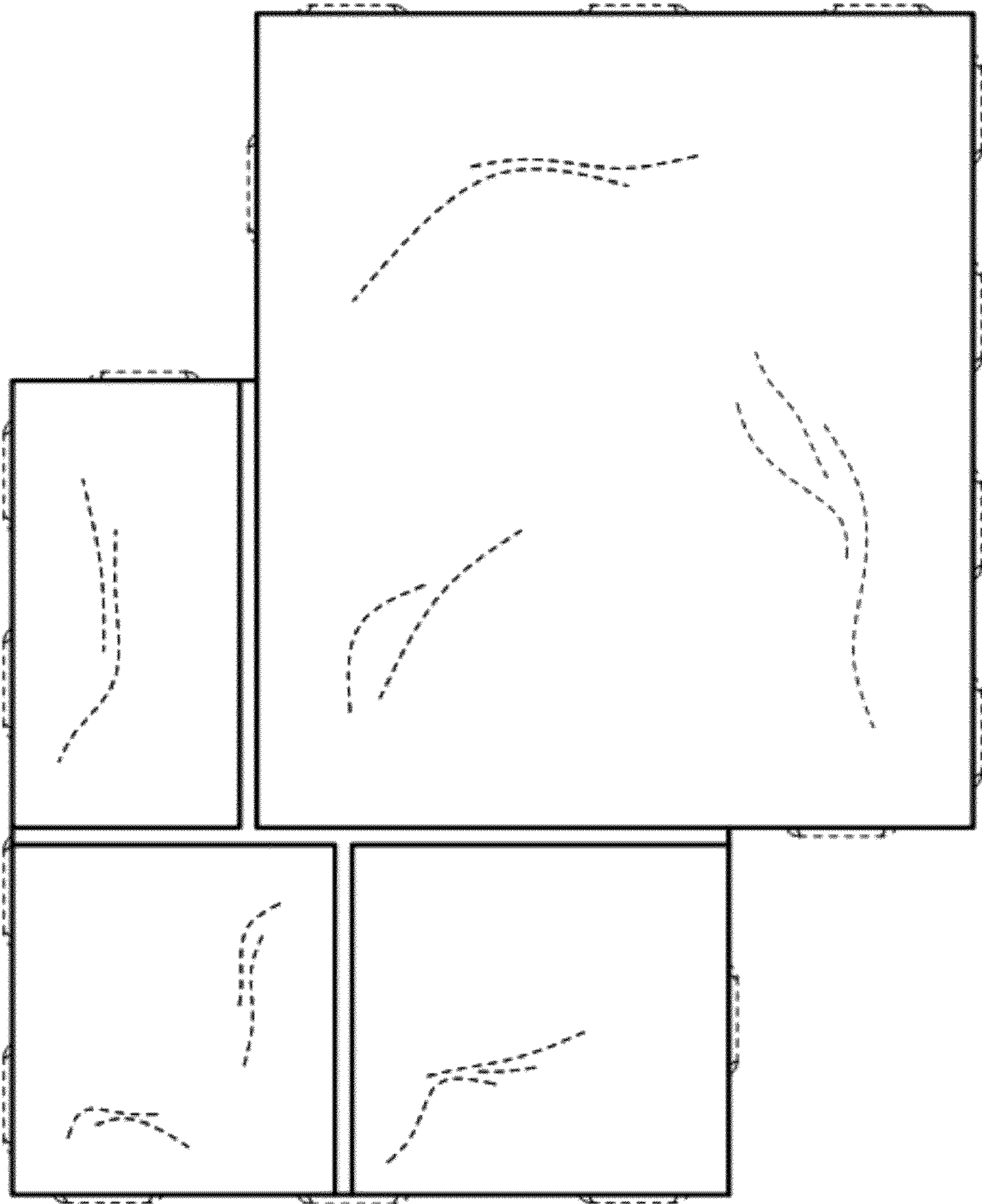

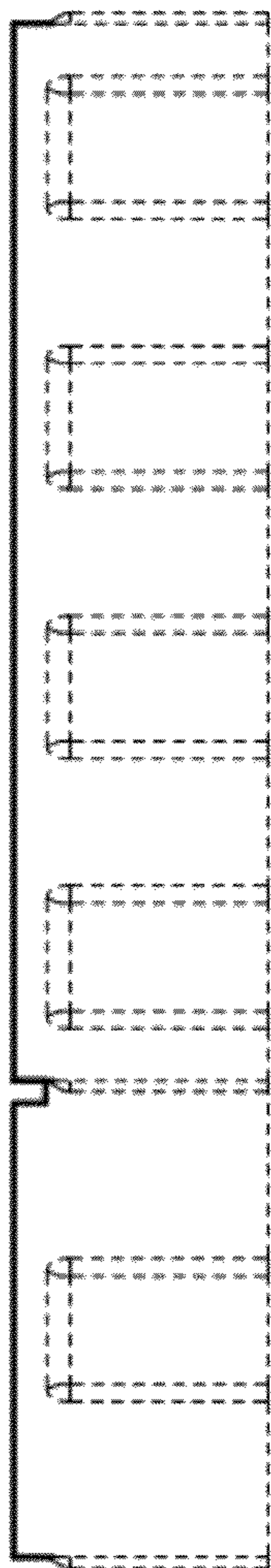

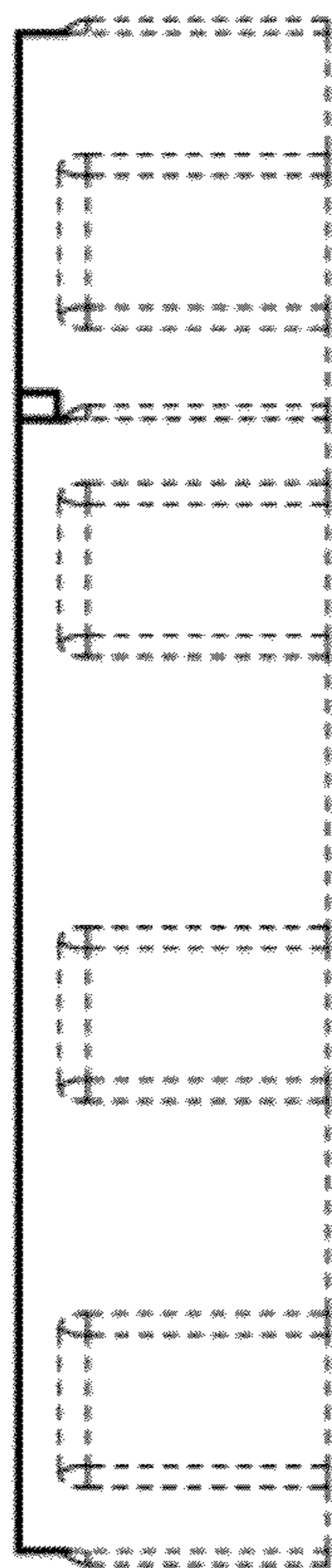

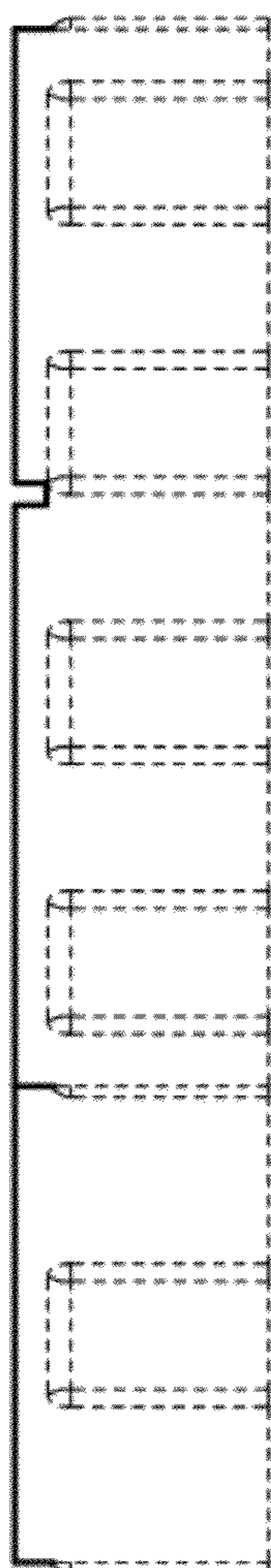

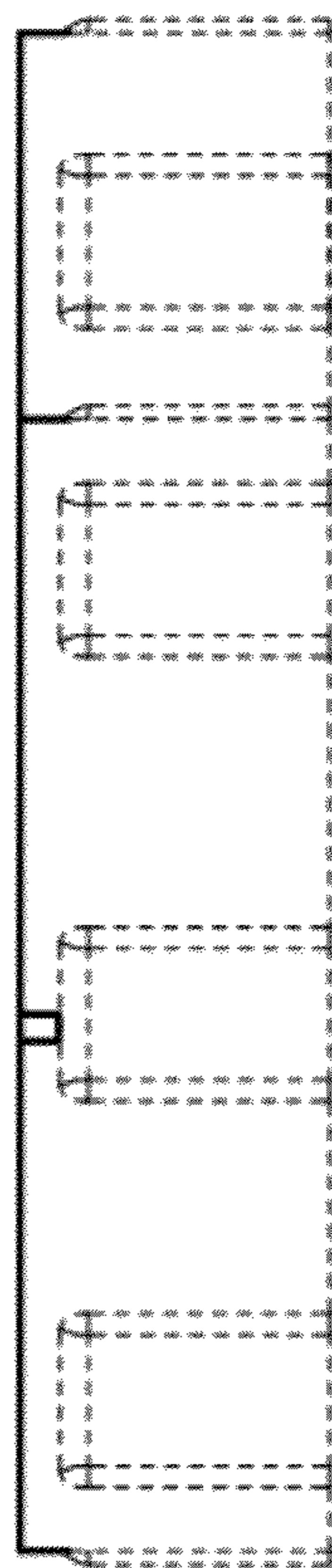

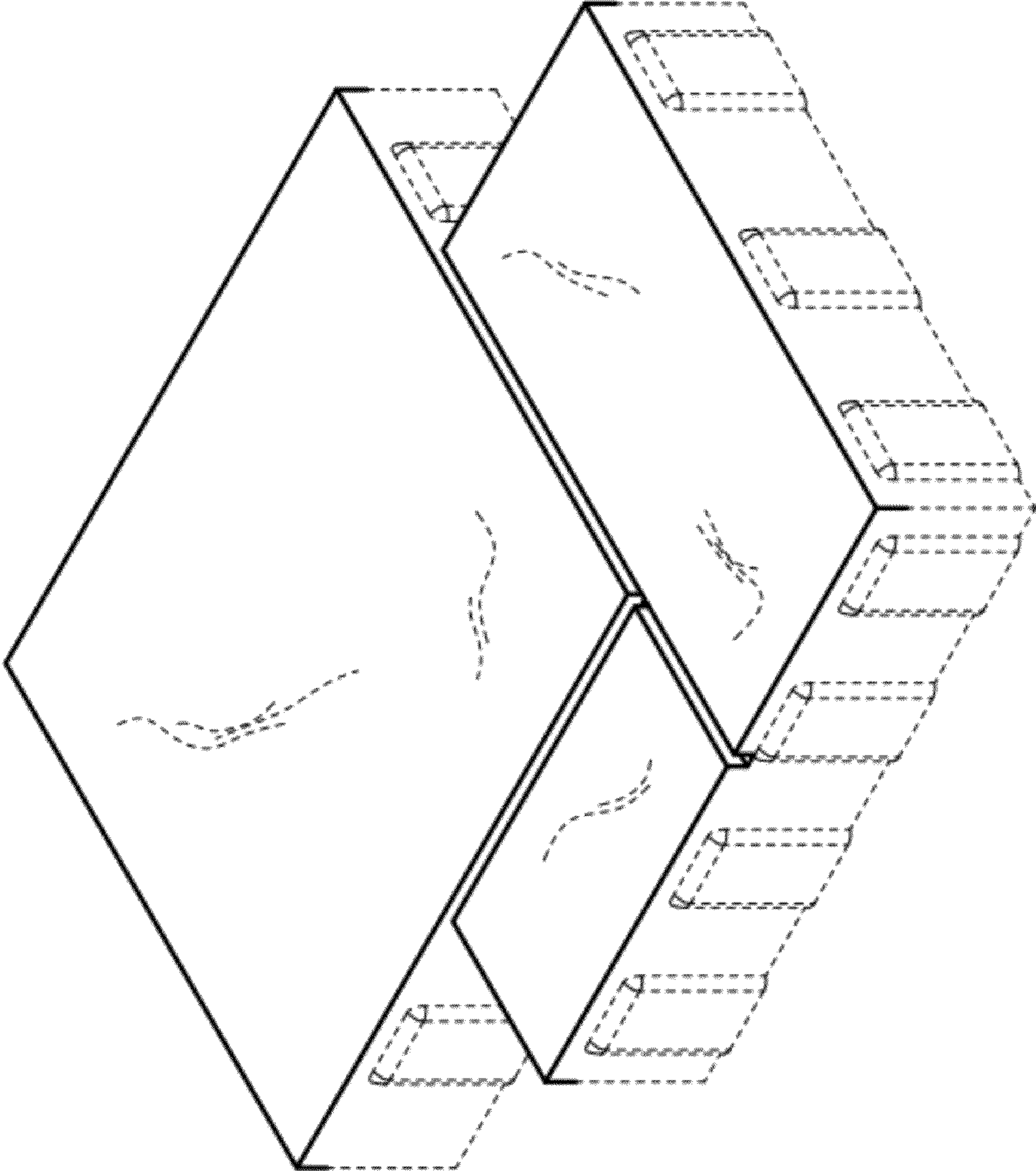

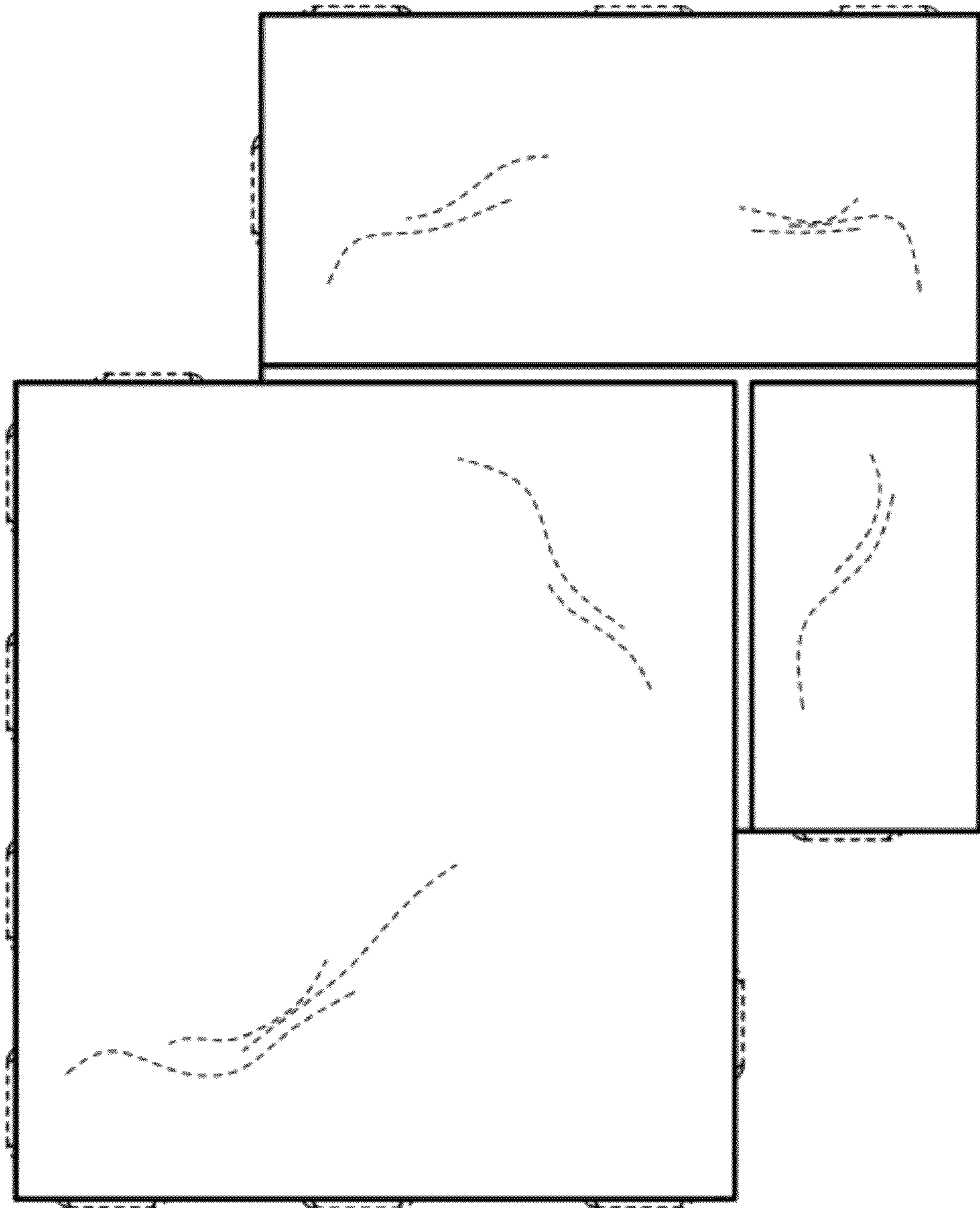

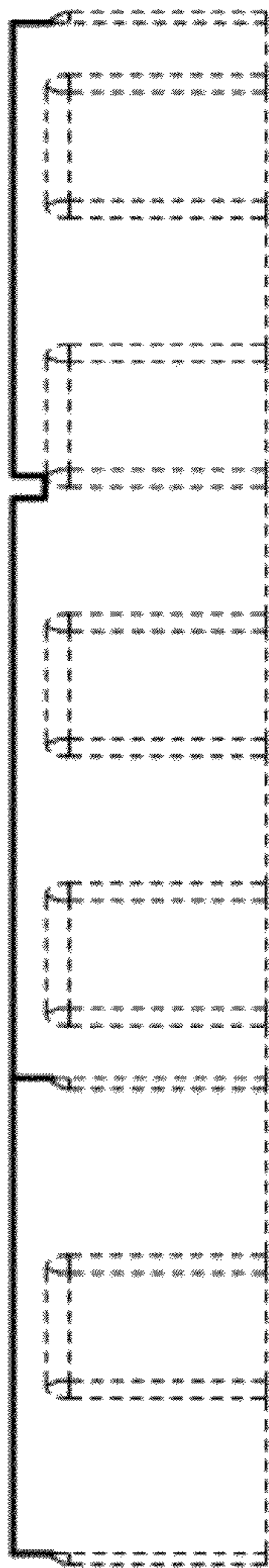

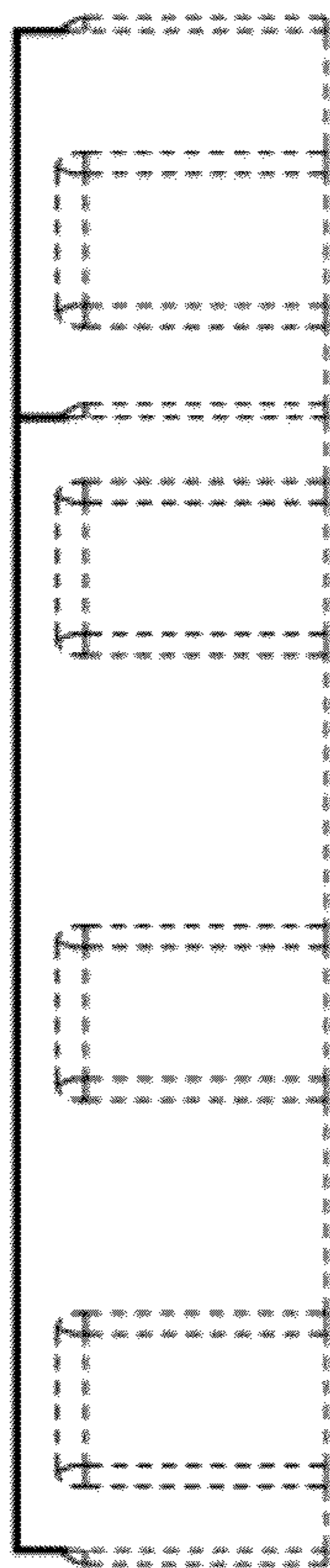

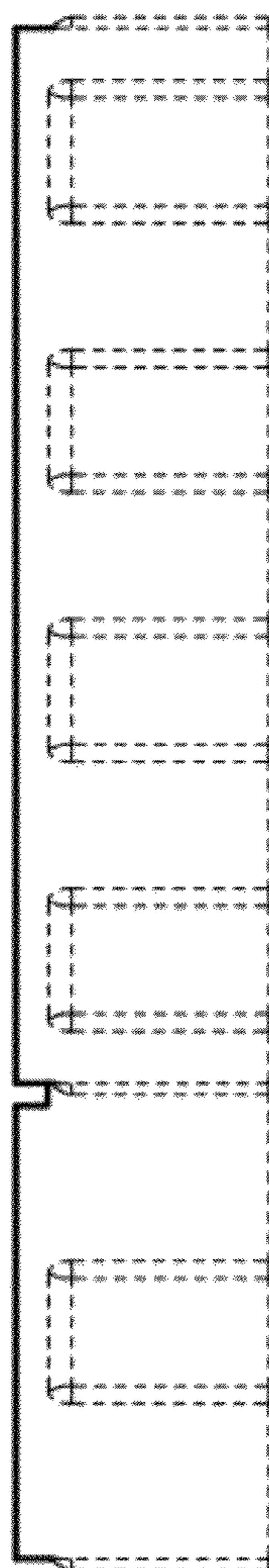

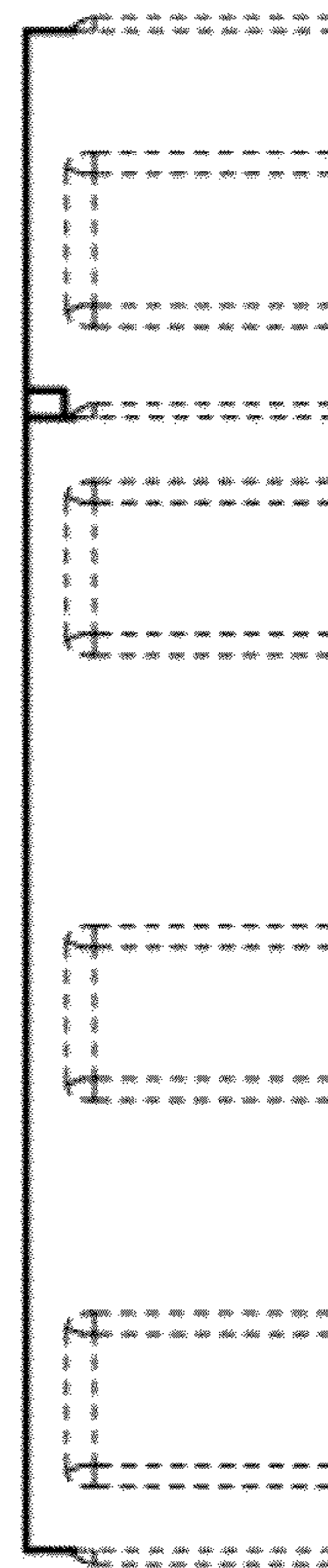

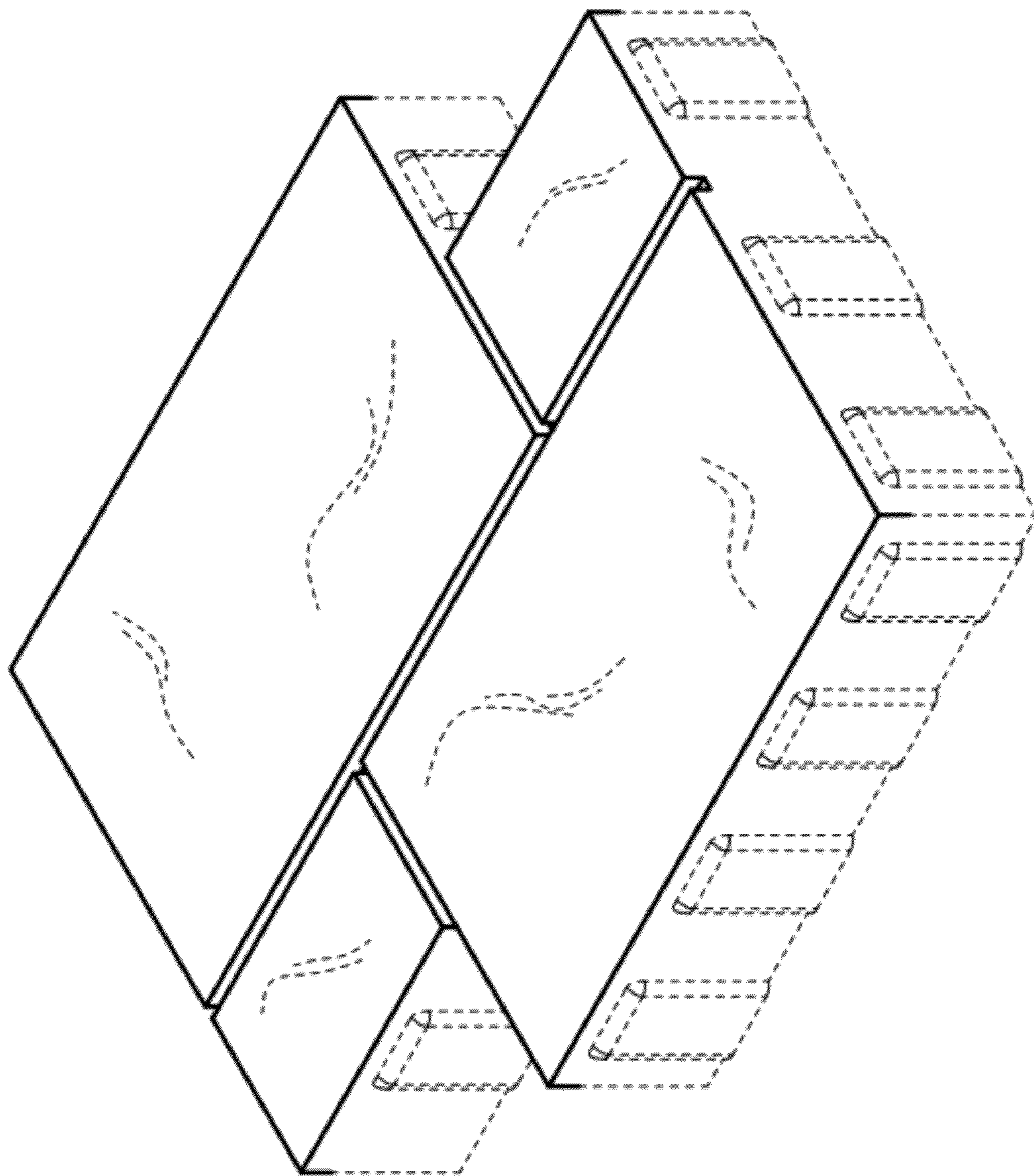

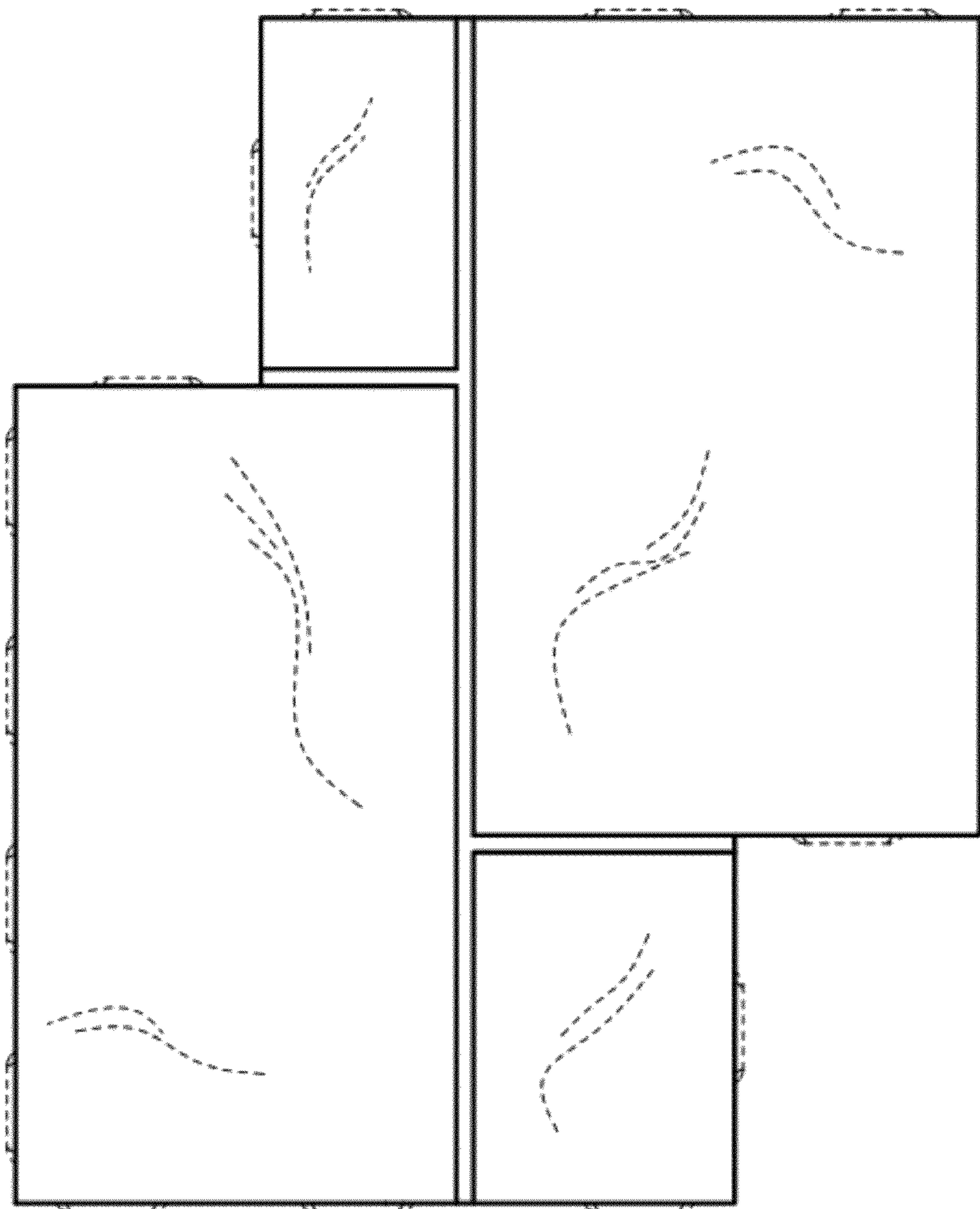

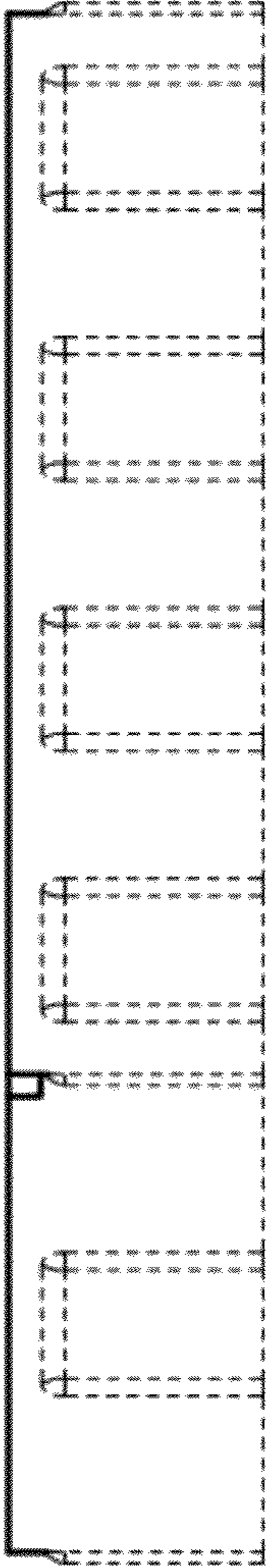

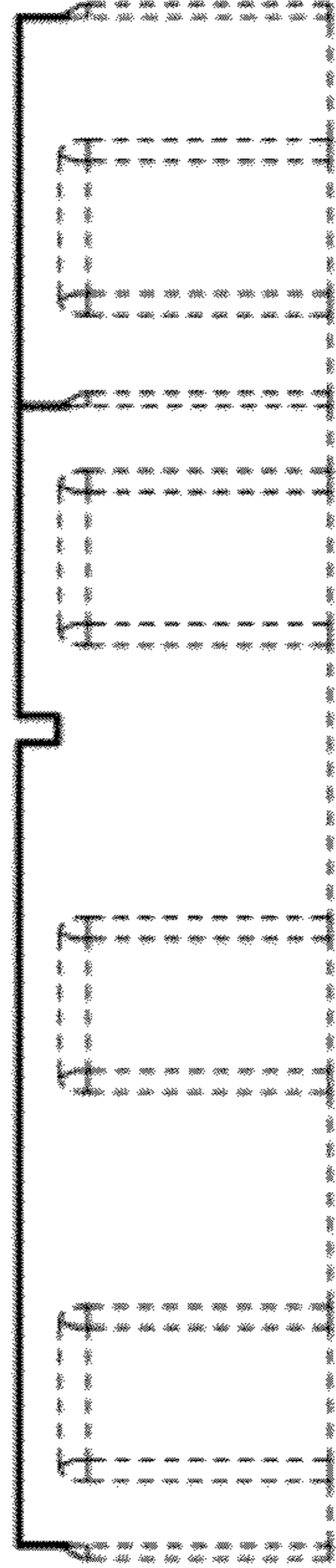

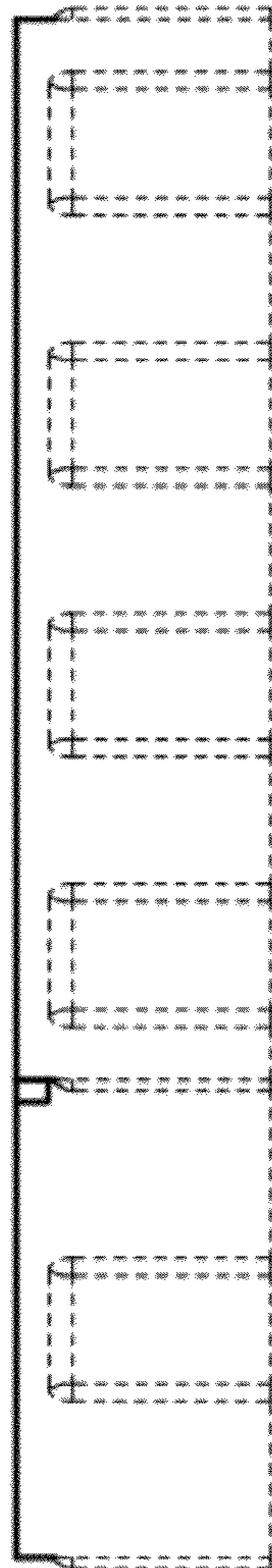

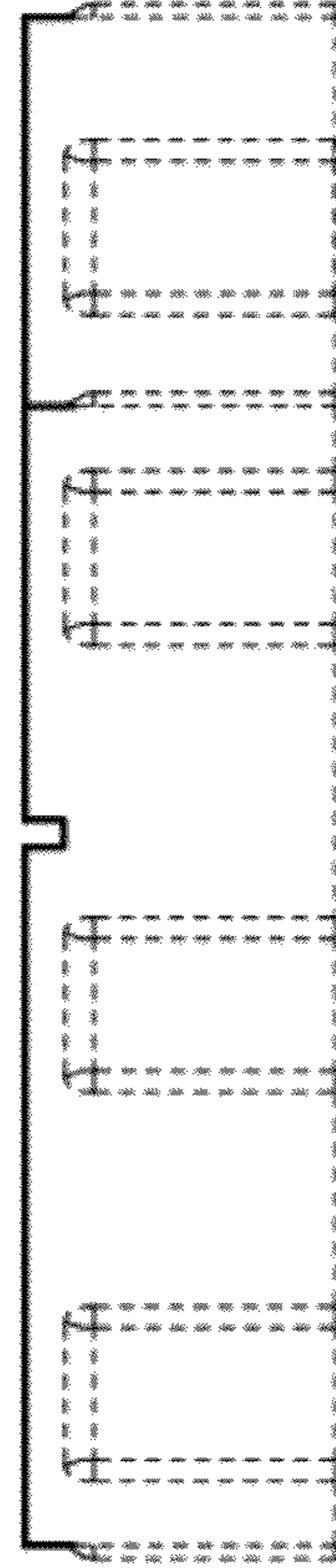

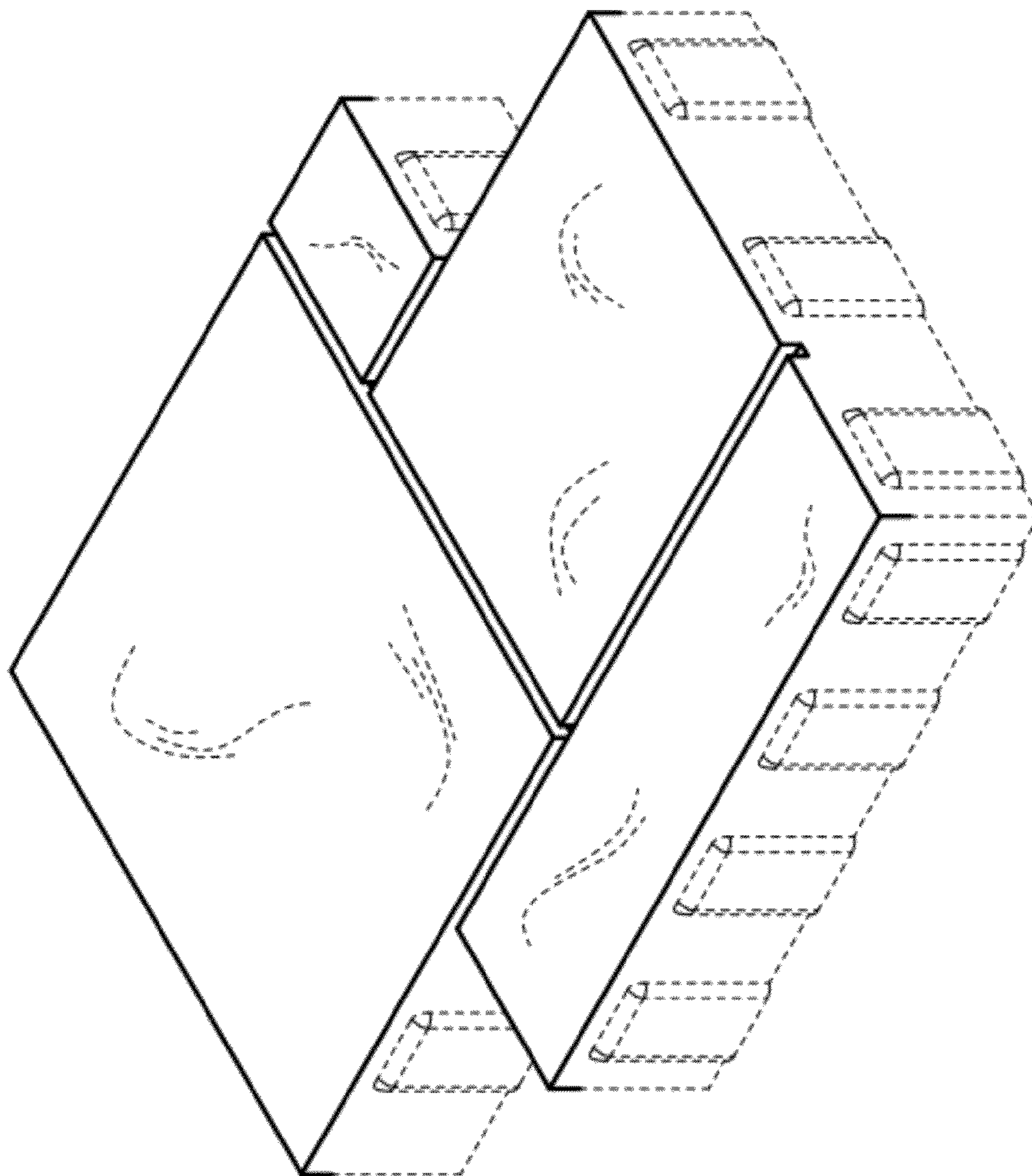

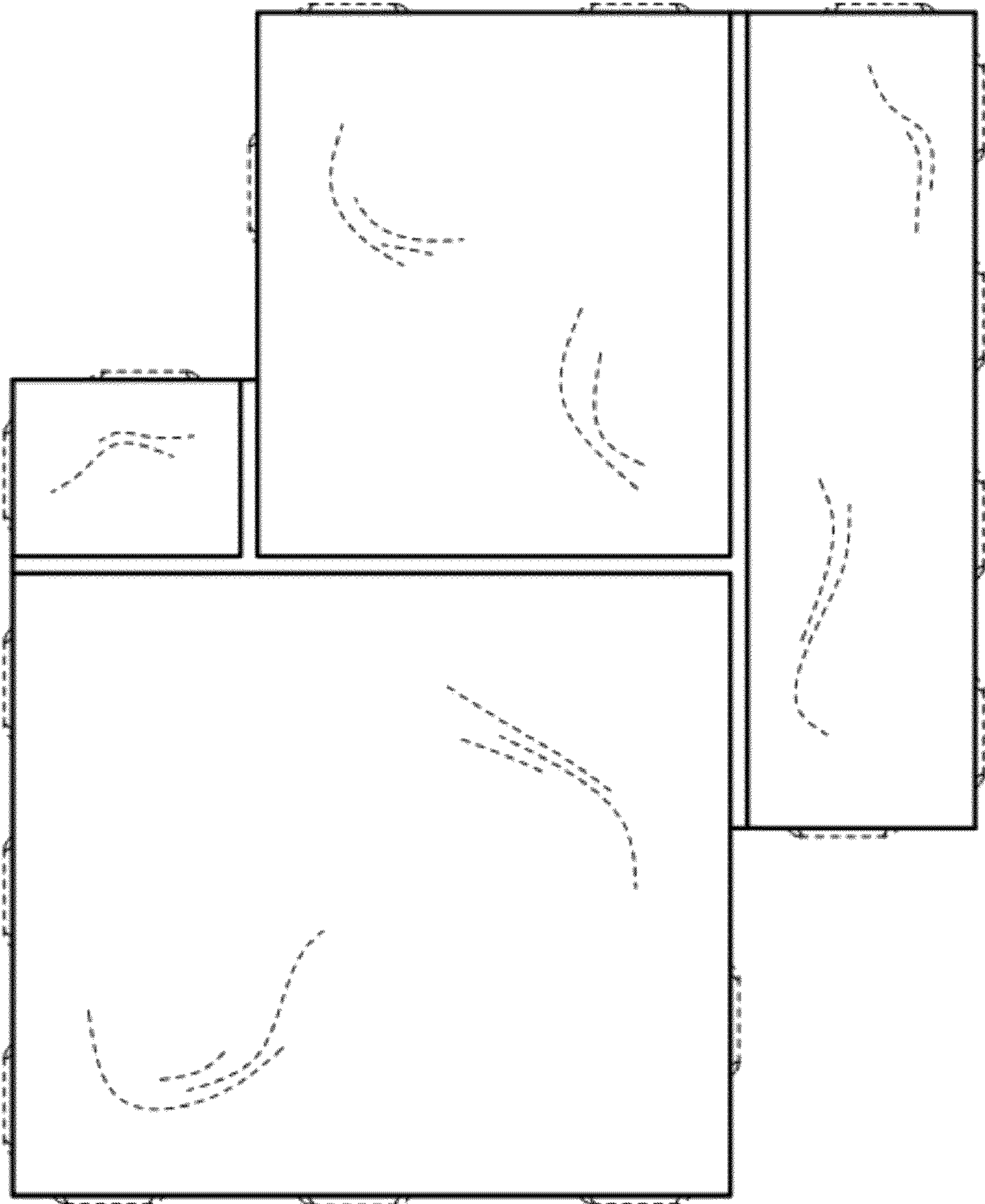

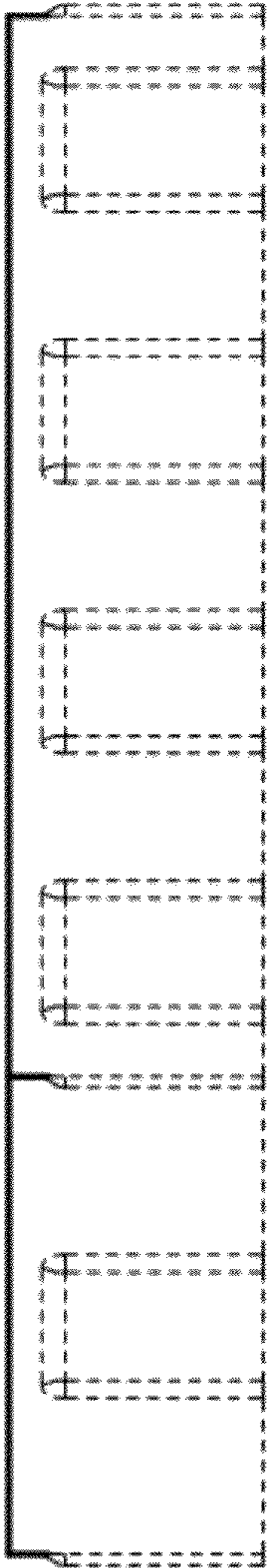

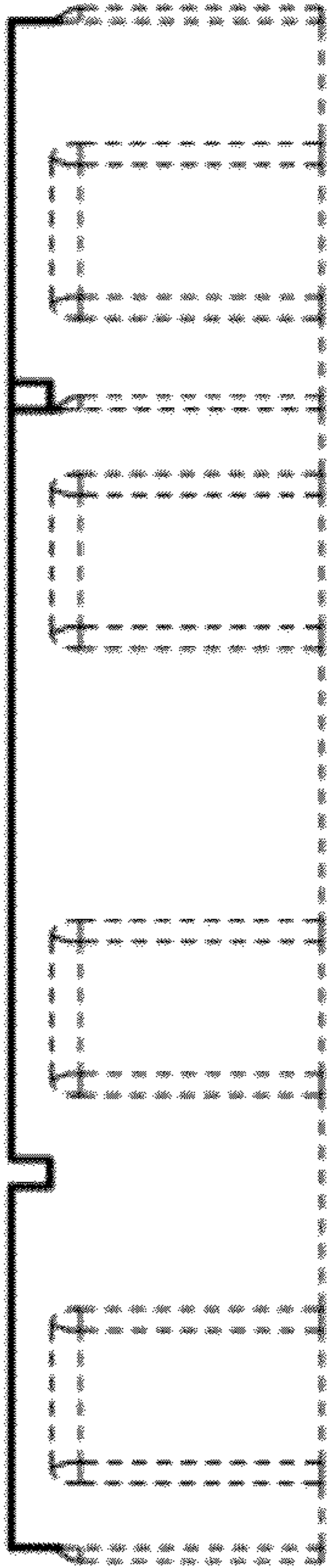

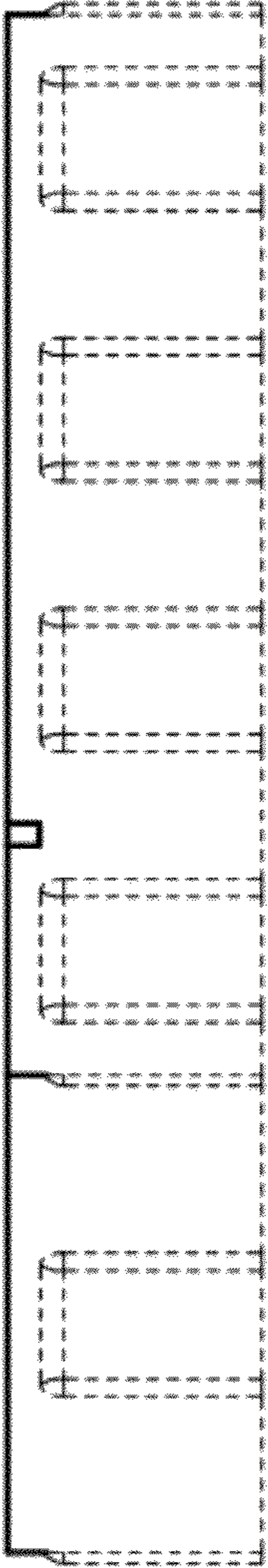

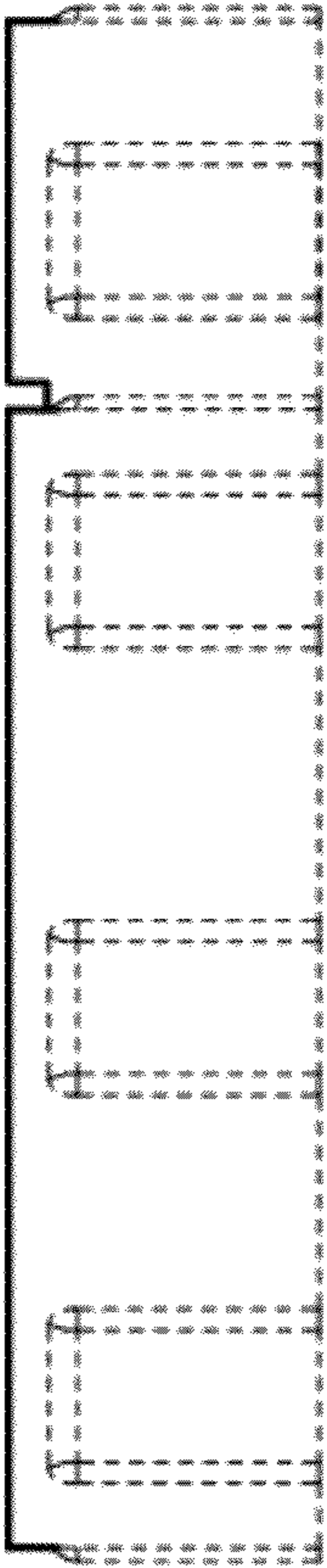

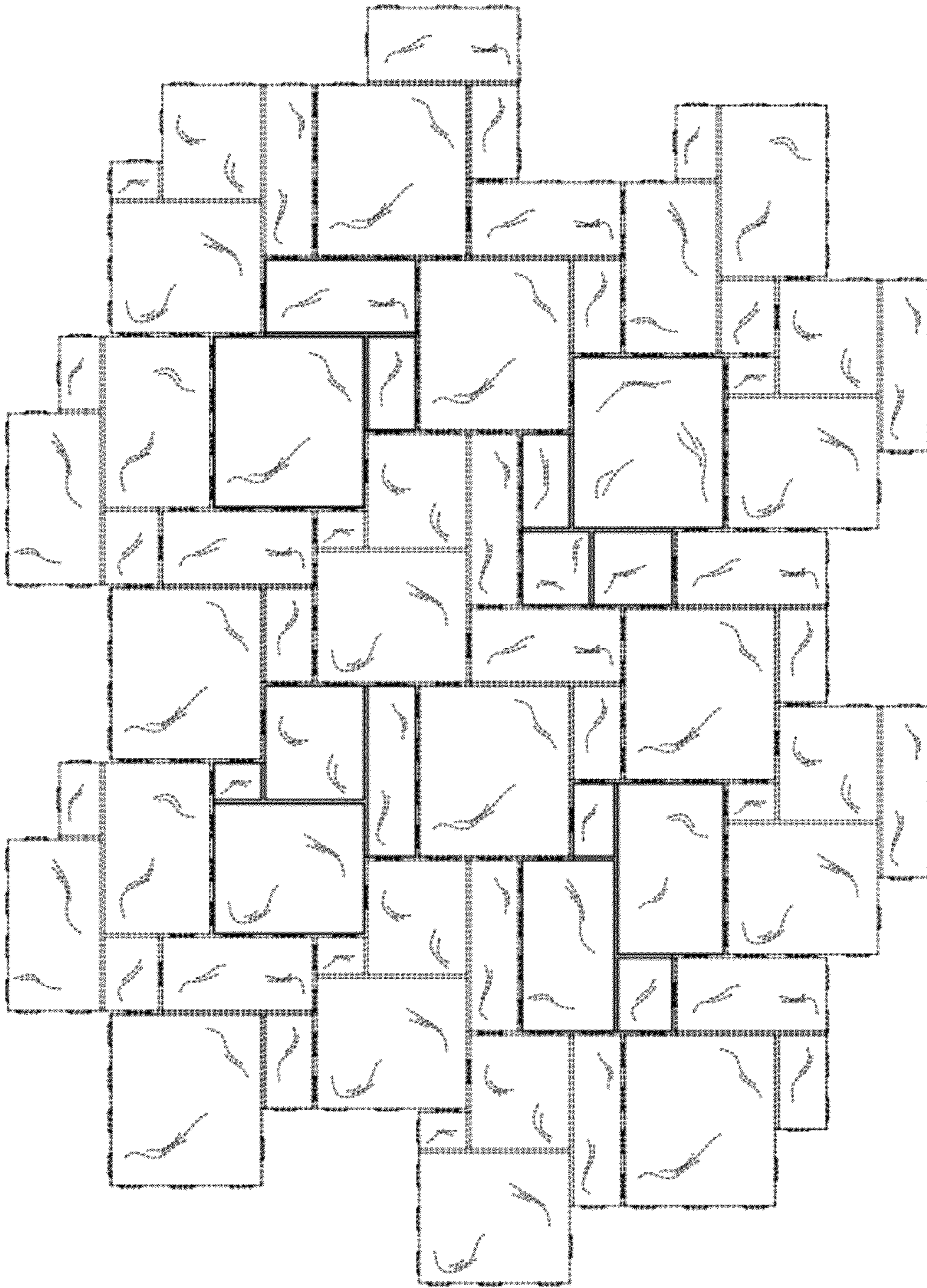
