DESCRIPTION

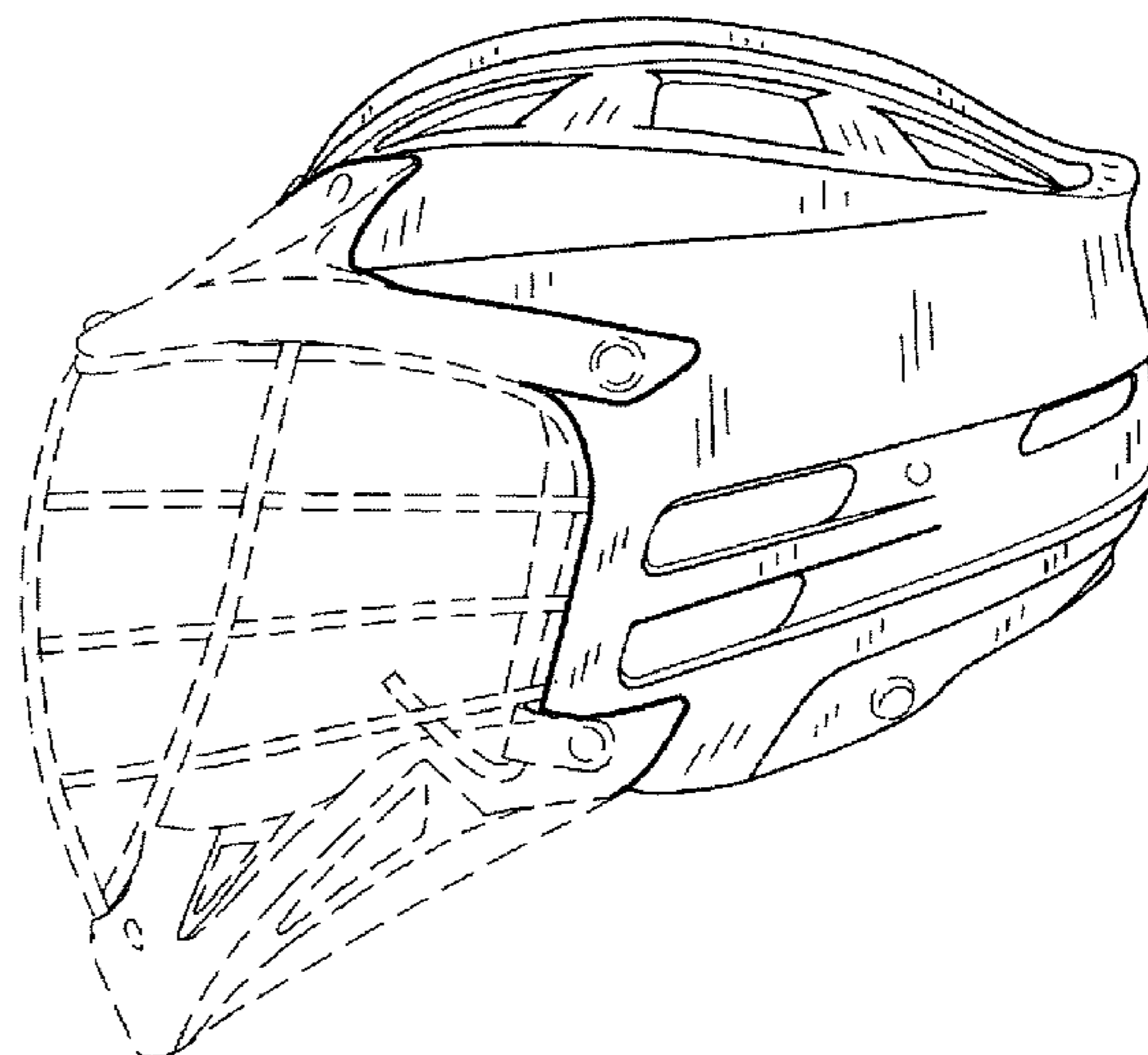
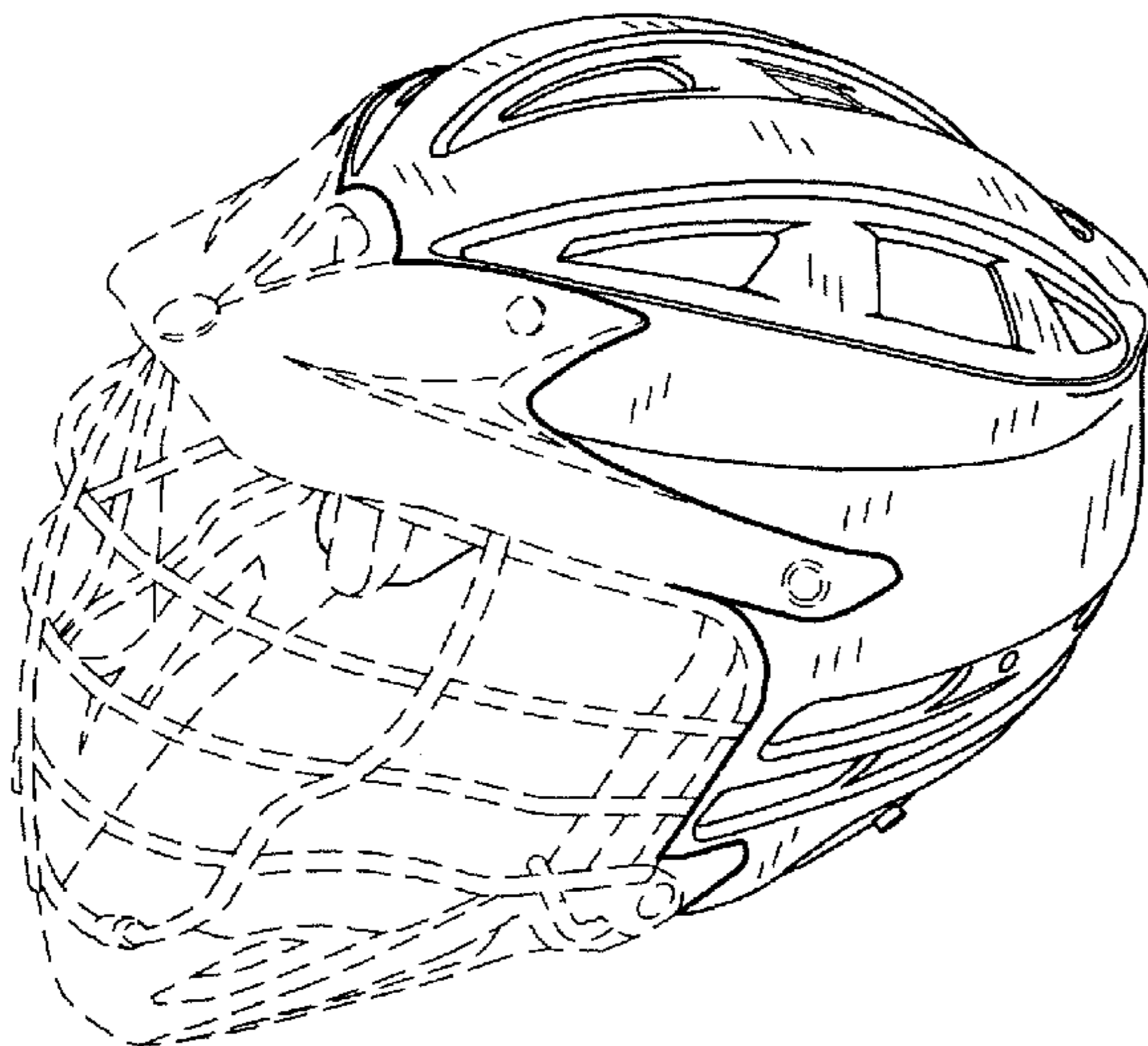

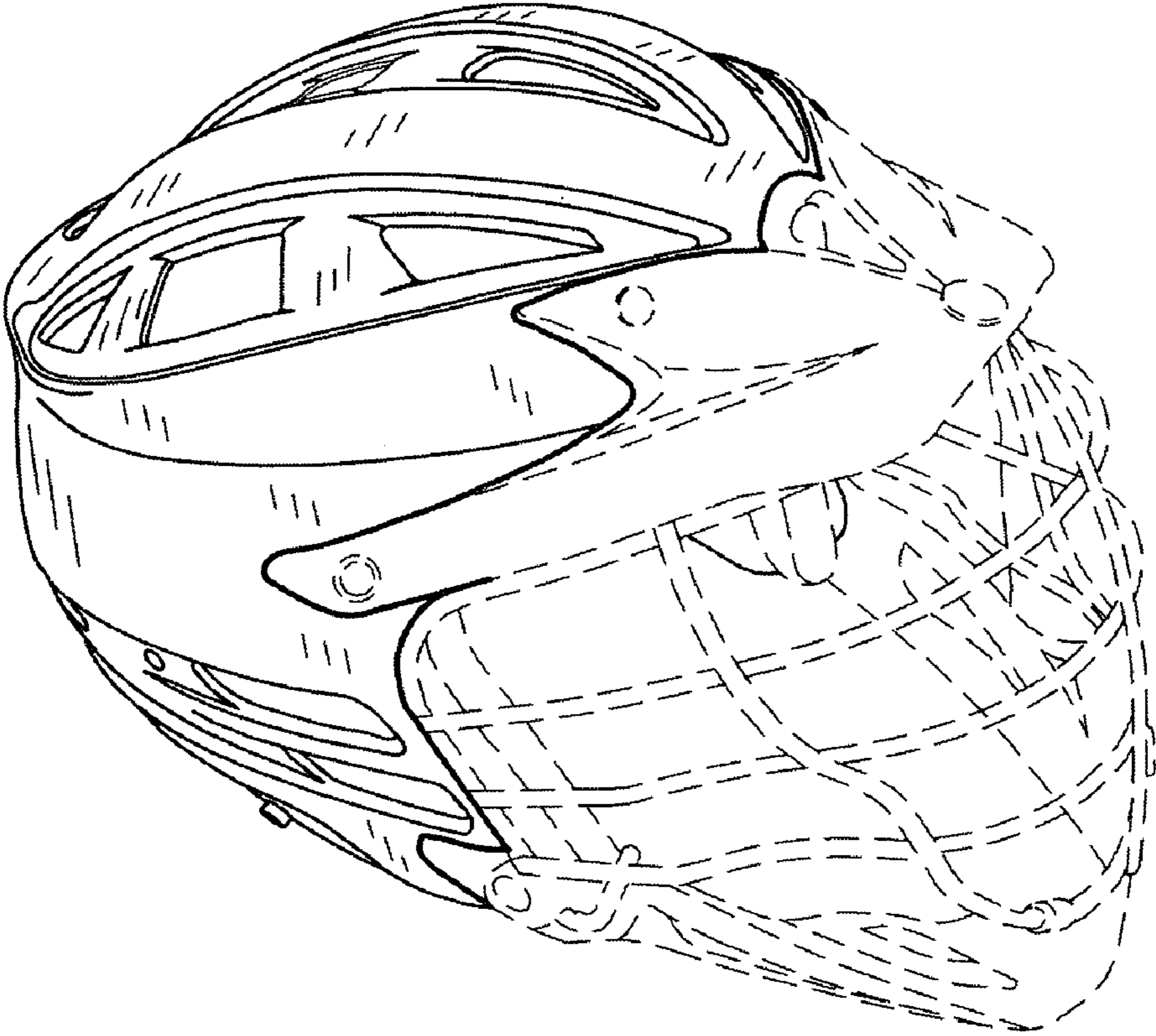

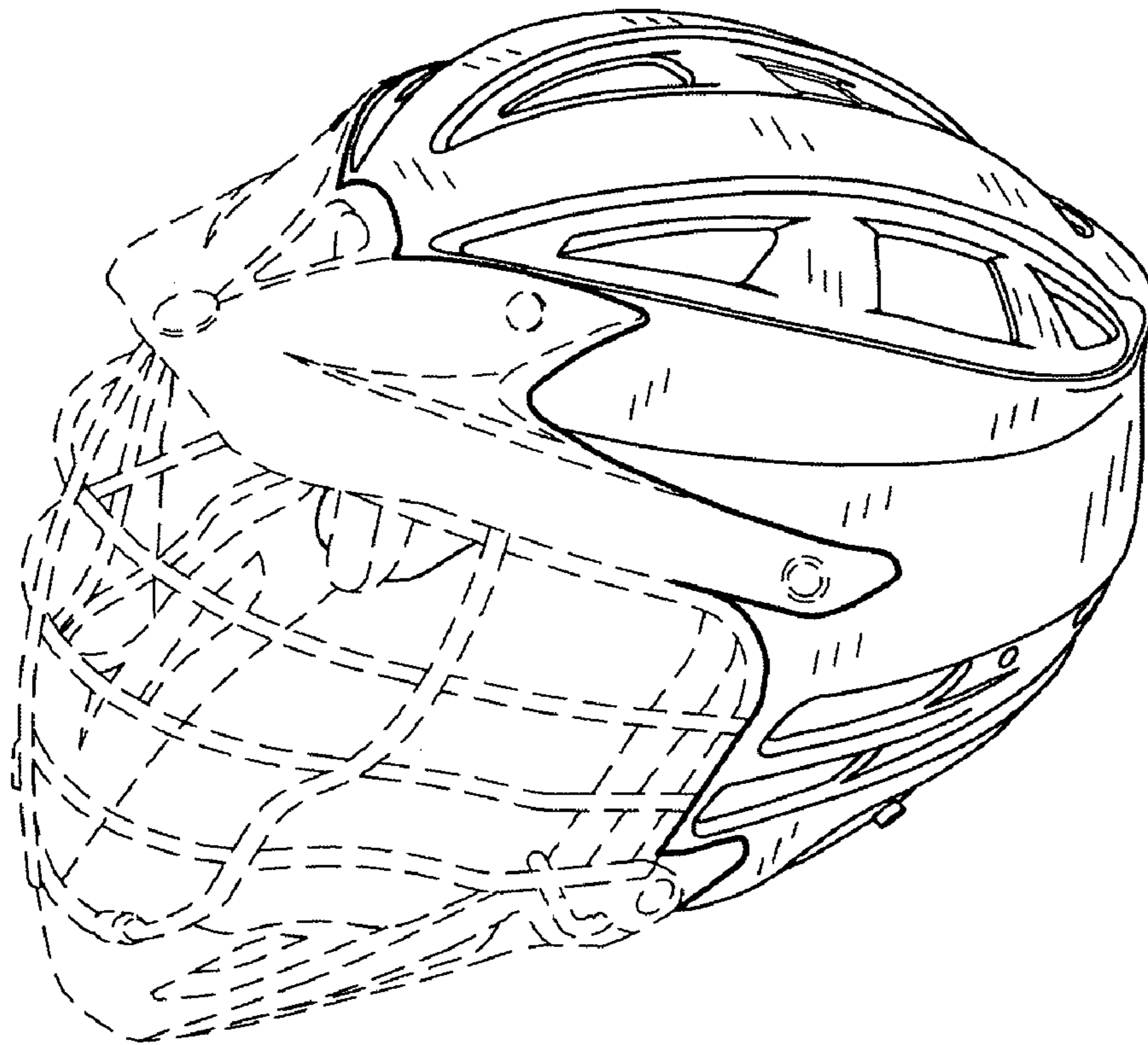

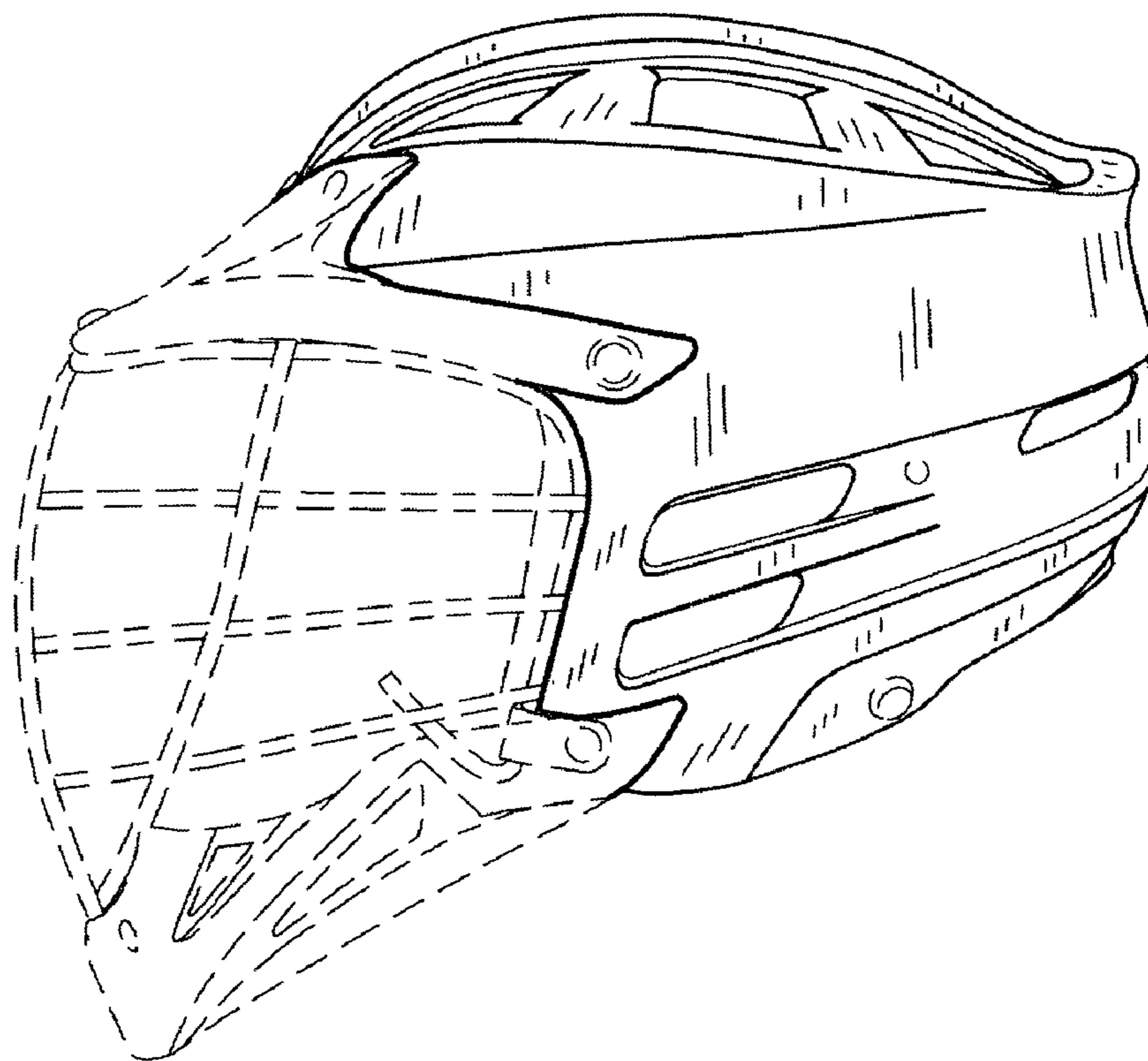

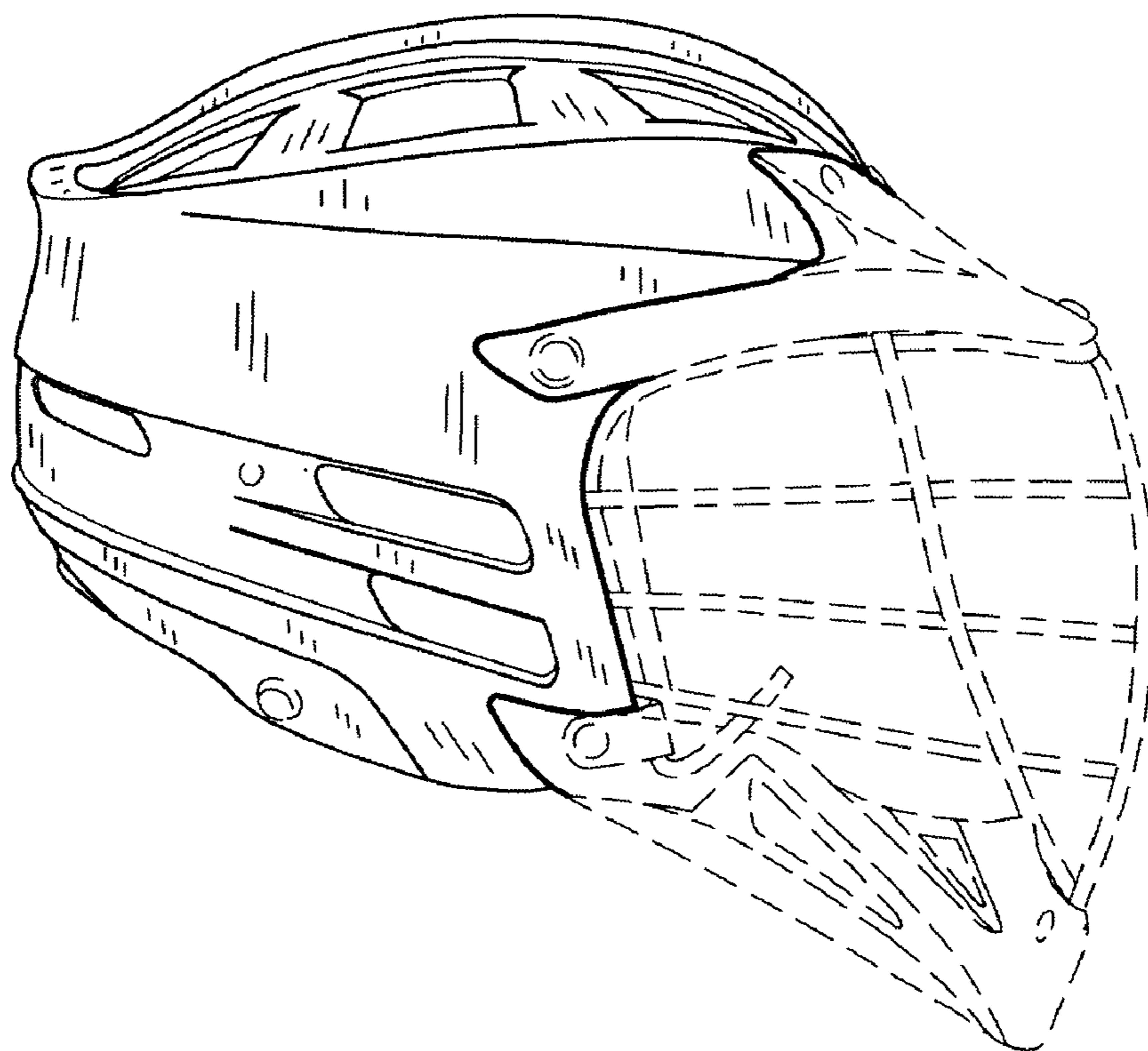

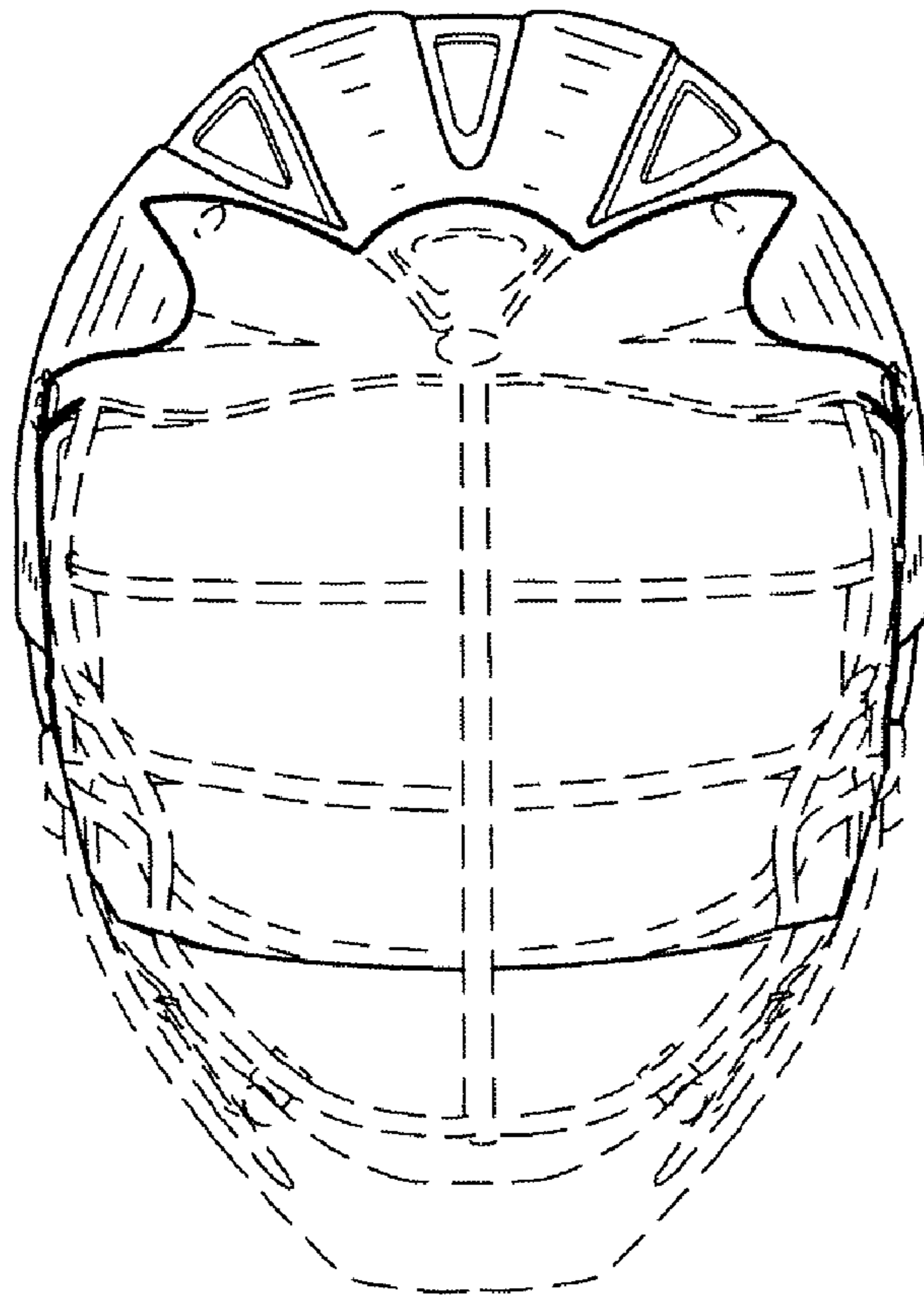

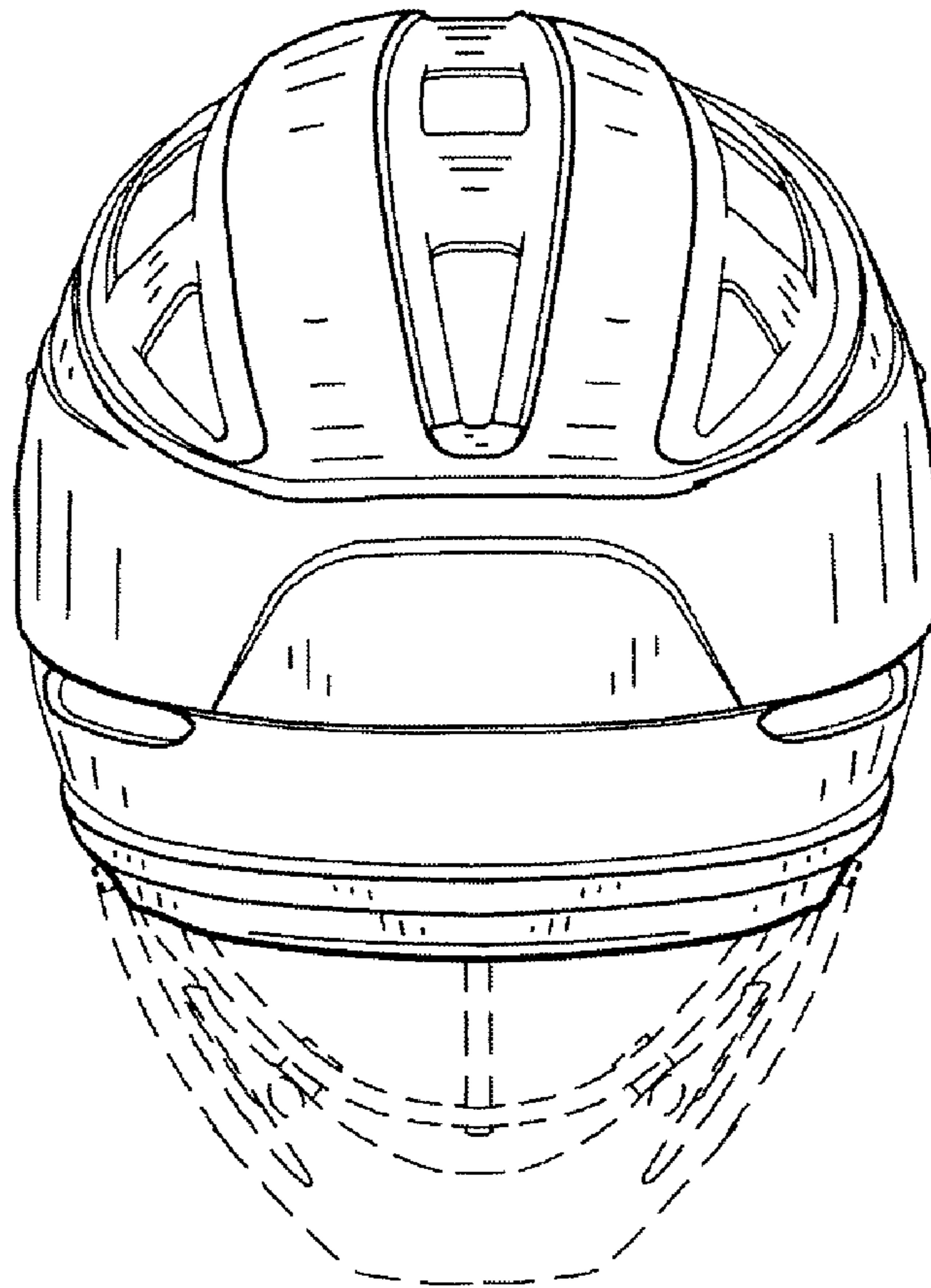

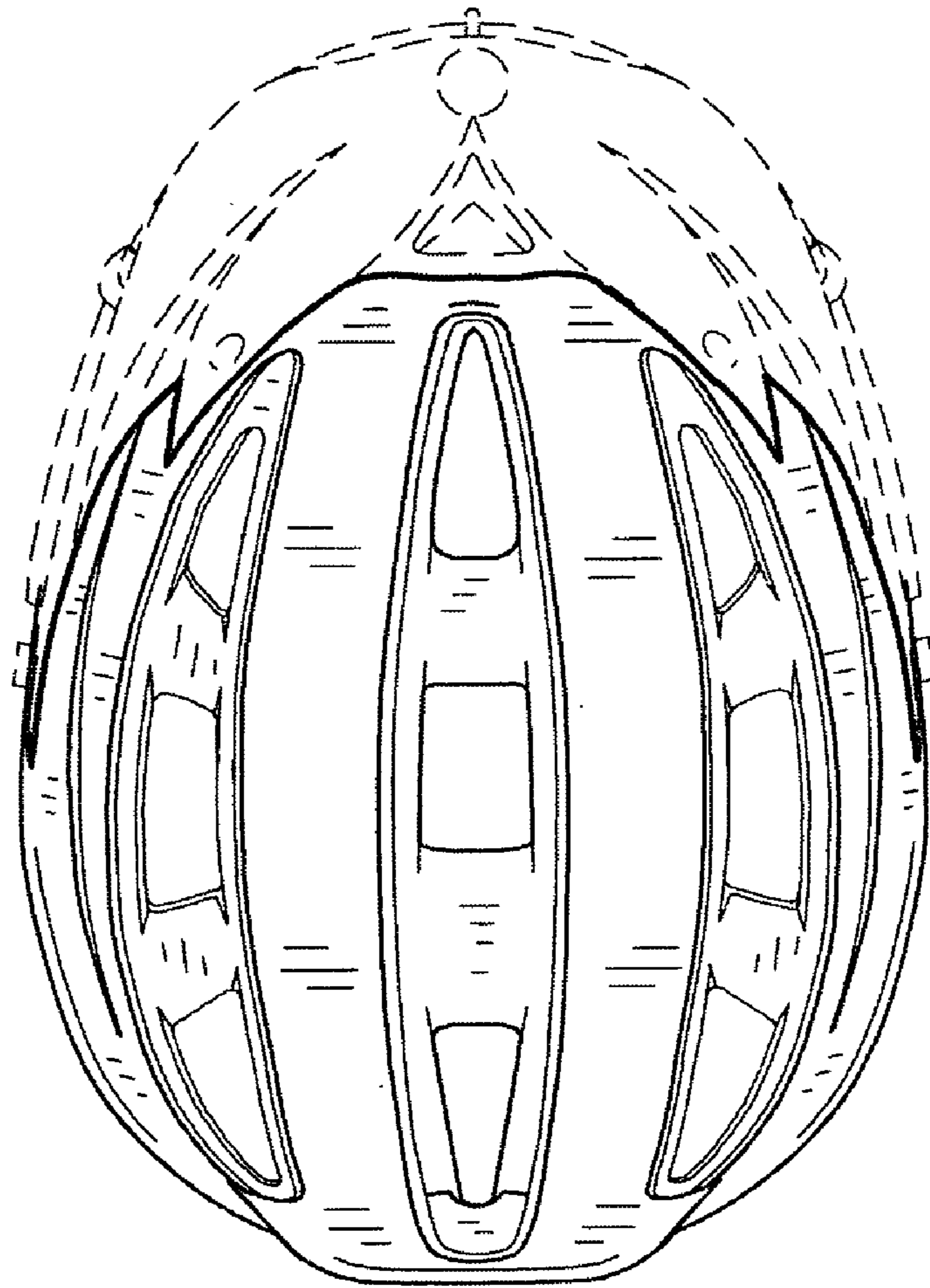

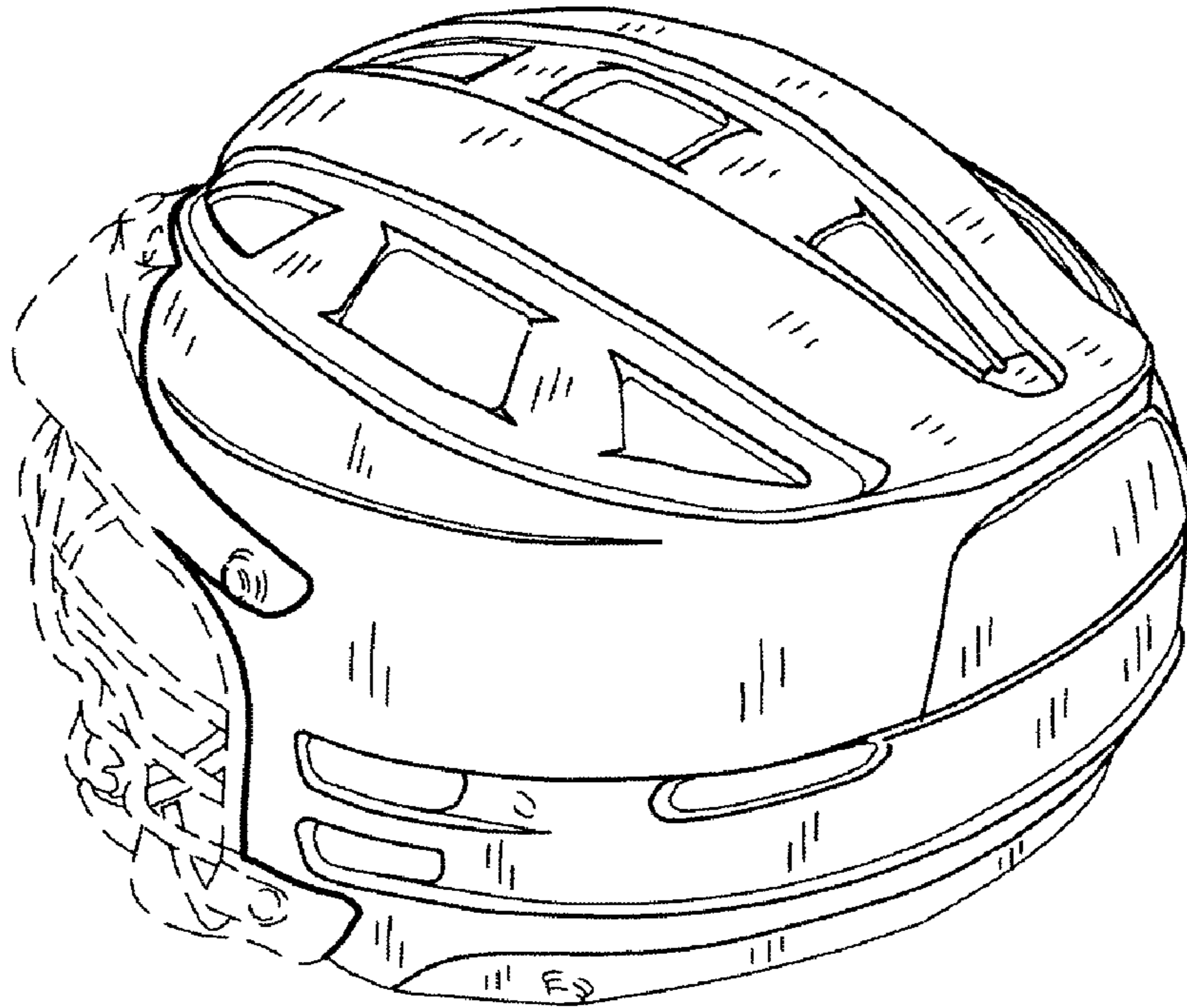
