The ornamental design for pants, as shown and described.

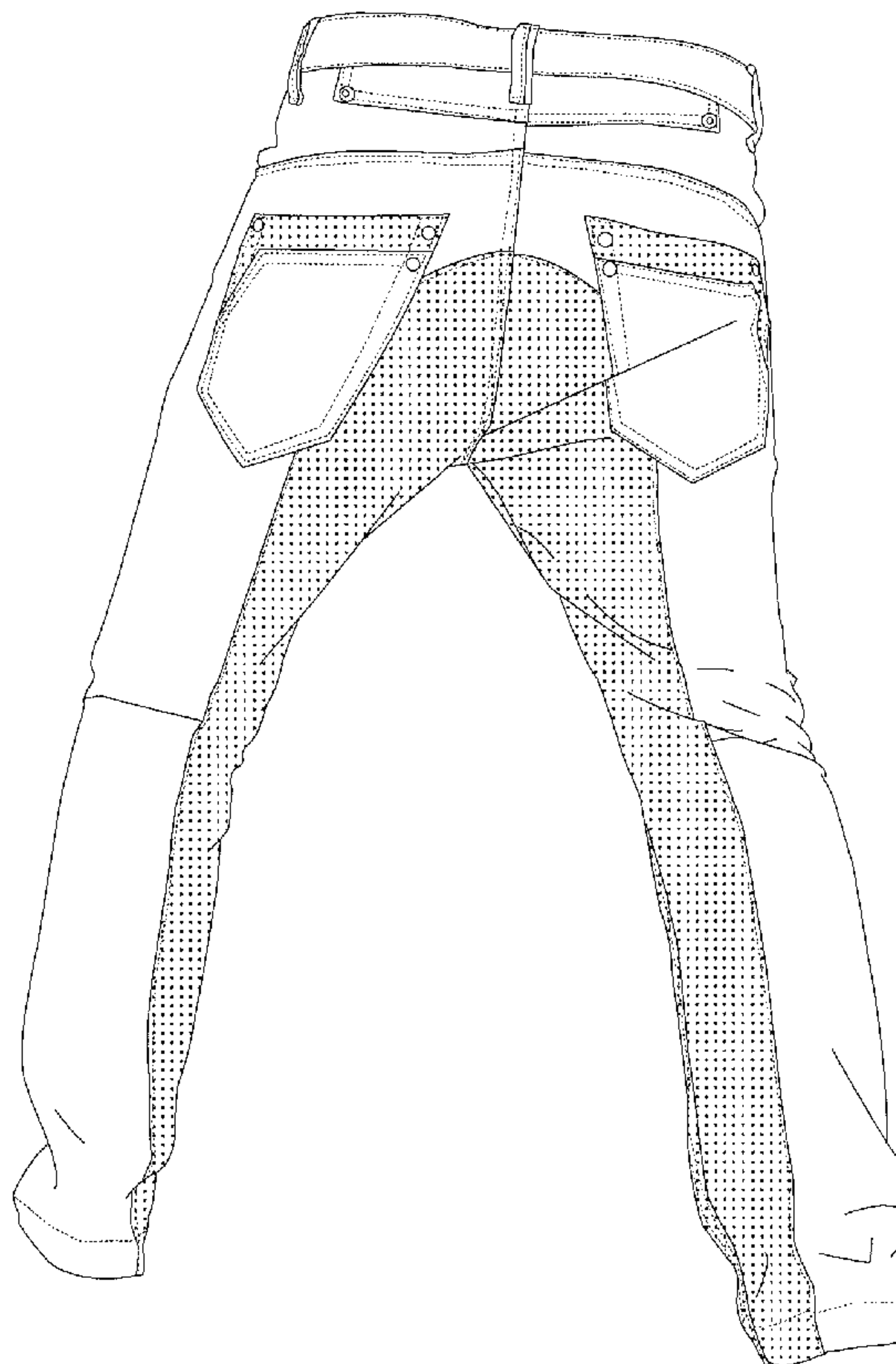
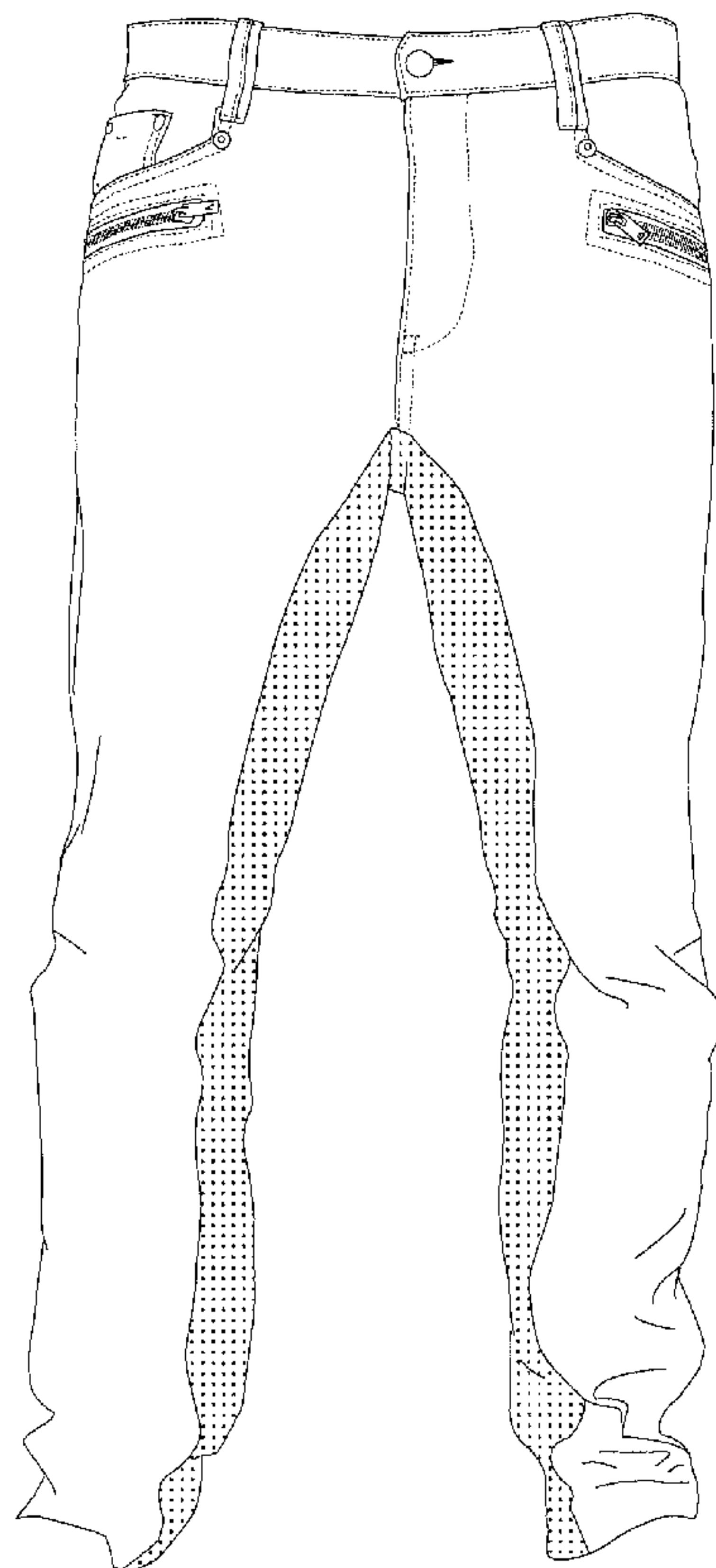
**DESCRIPTION**

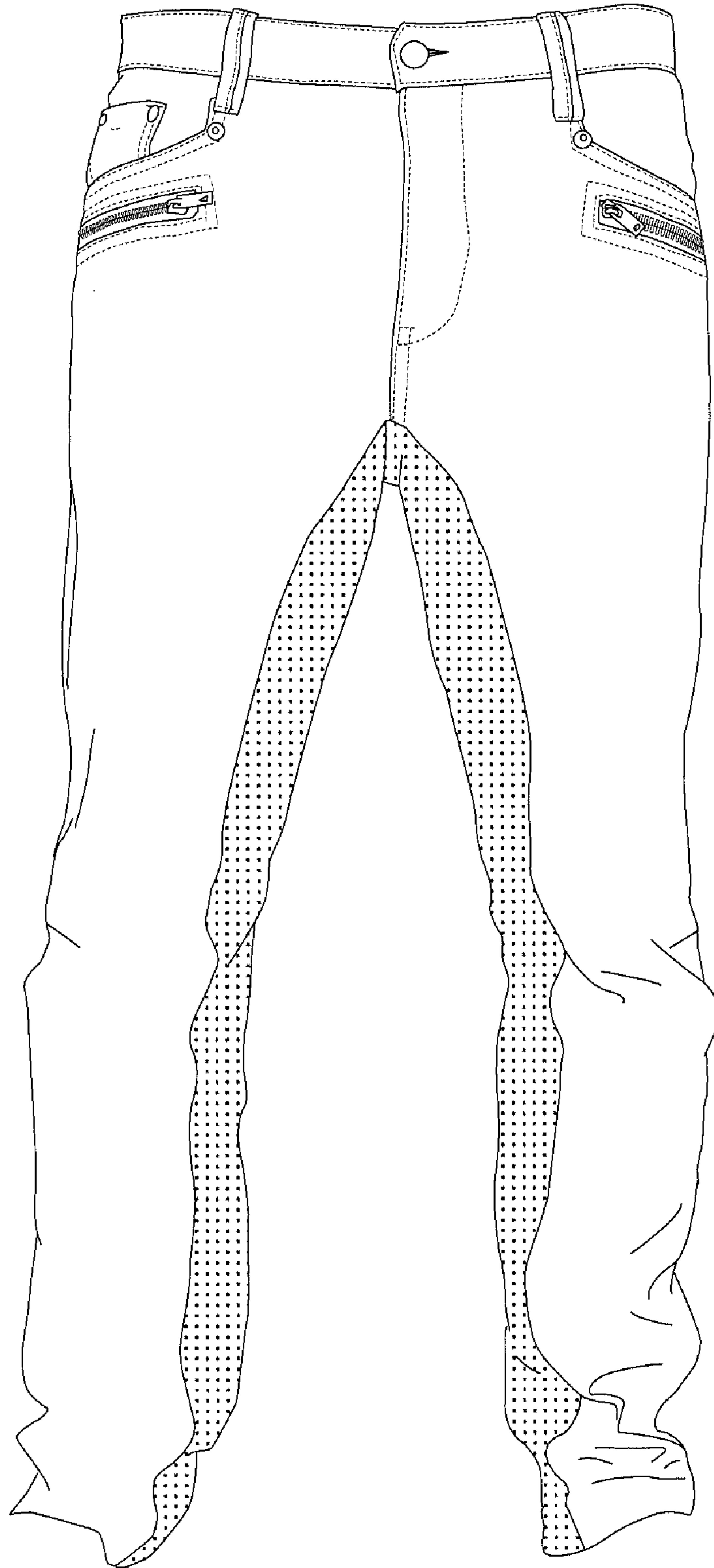

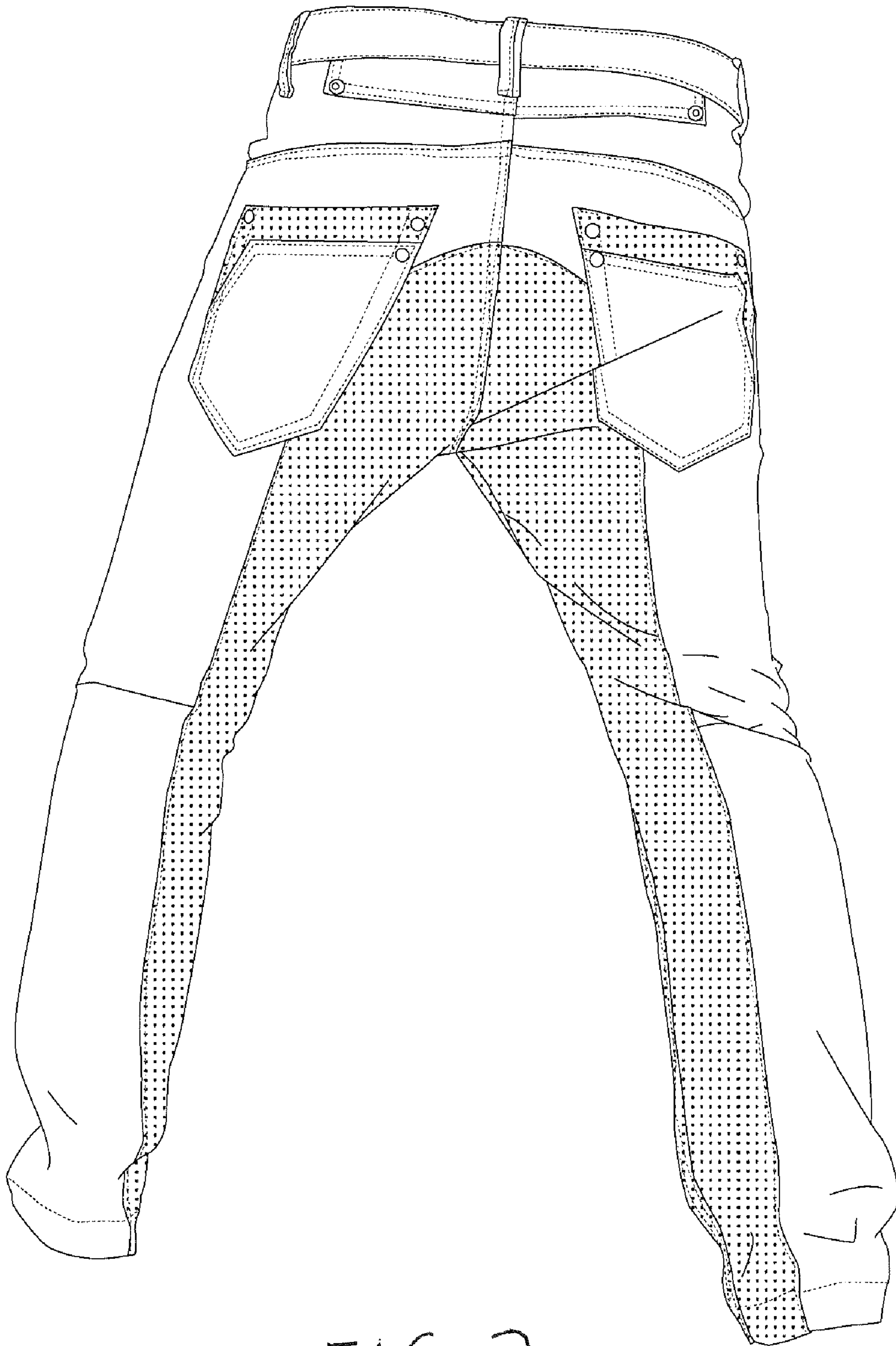
