(57) **CLAIM**

I claim the ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a rear elevational view of a garment, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top rear perspective view thereof; the lower portions of the sleeves shown rotated forward; and,

FIG. 4 is a bottom front perspective view thereof.

The broken lines in FIG. 1, showing portions of the human figure, form no part of the claimed design. The broken lines in FIGS. 2 and 4 represent the portions of the garment, which form no part of the claim.

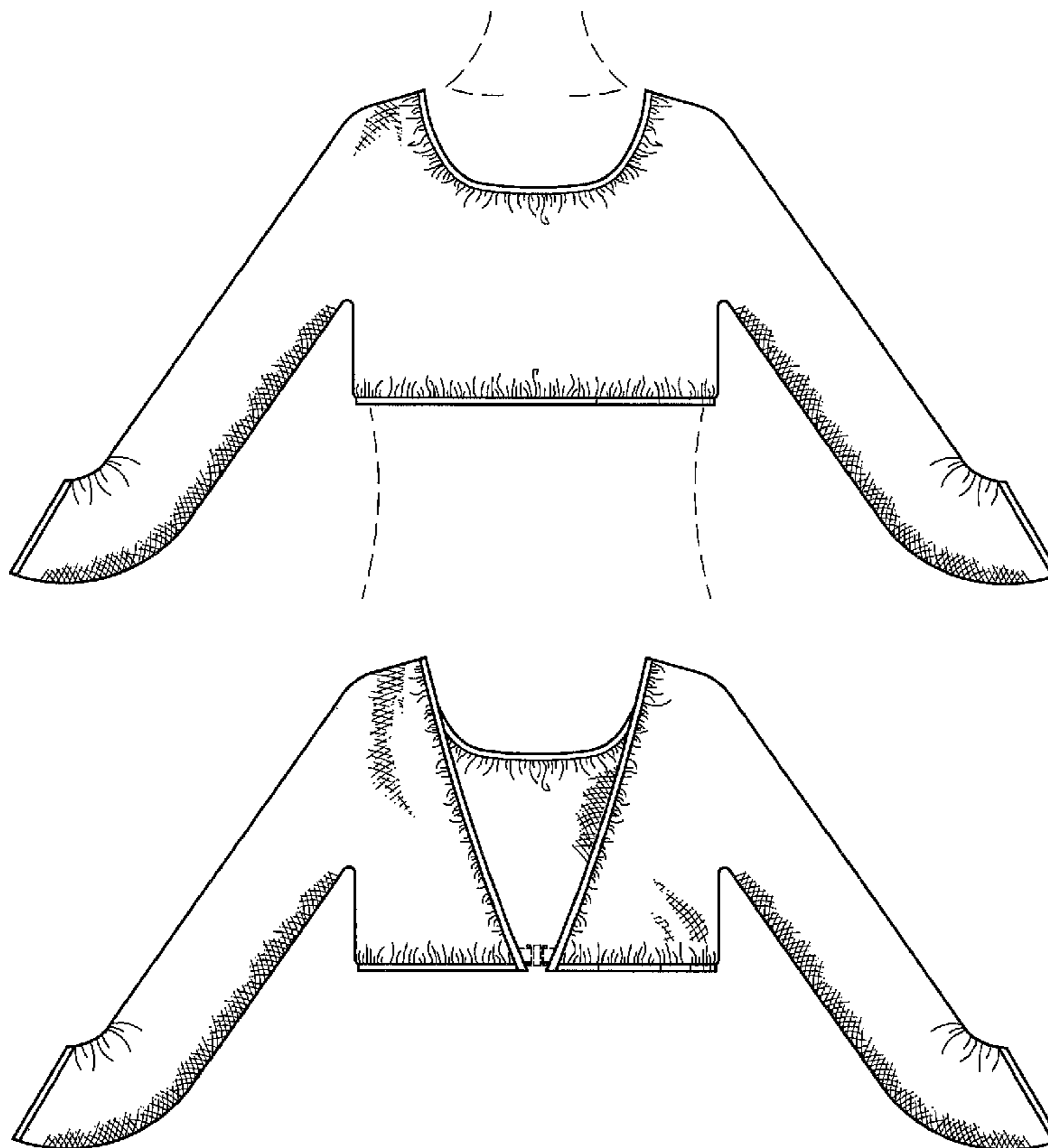

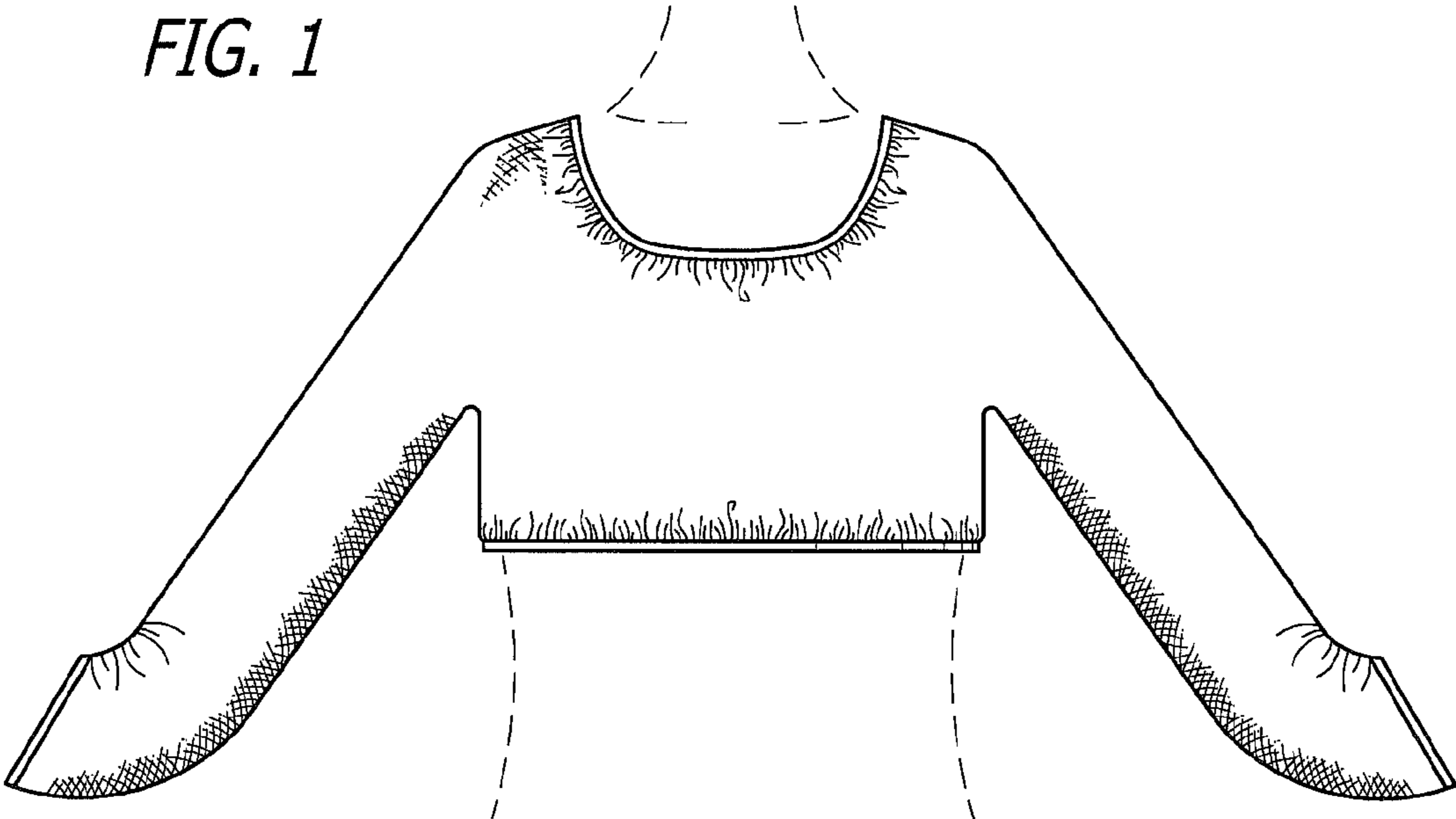

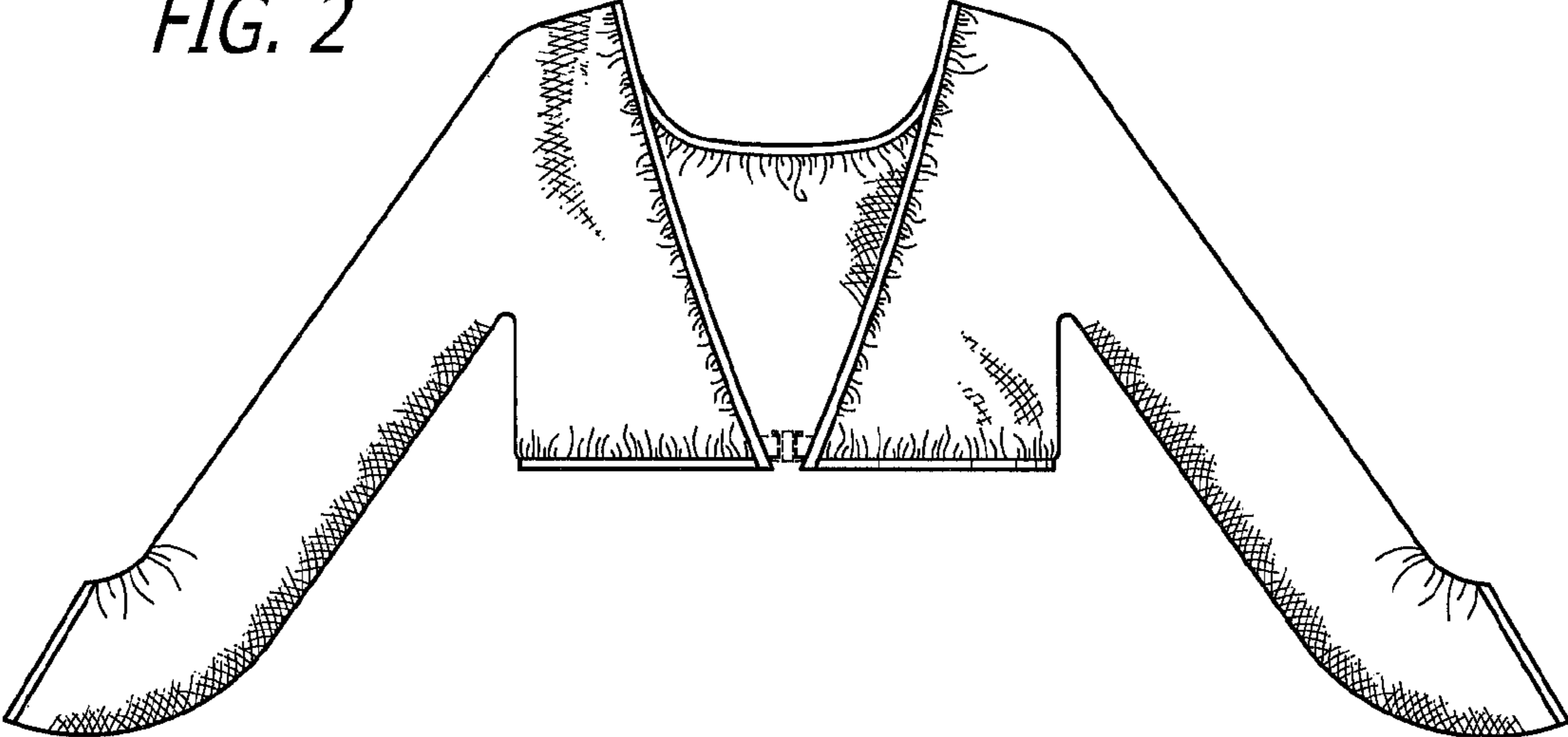

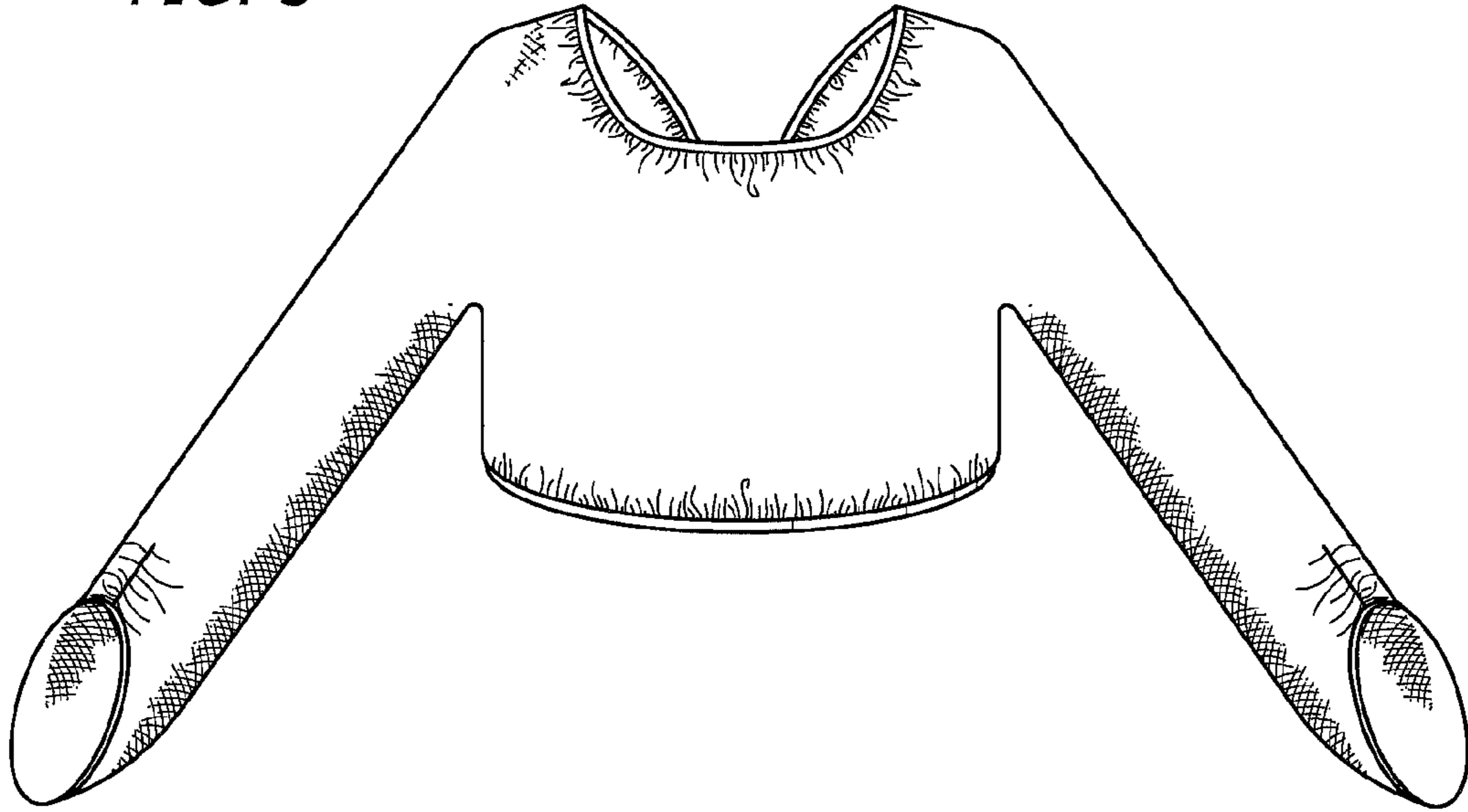
