(57) **CLAIM**

The ornamental design for the produce washing bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the produce washing bowl in accordance with the present invention;  
FIG. 2 is a rear view of the embodiment of the produce washing bowl depicted in FIG. 1;  
FIG. 3 is a left side view of the embodiment of the produce washing bowl depicted in FIG. 1;  
FIG. 4 is a right side view of the embodiment of the produce washing bowl depicted in FIG. 1;

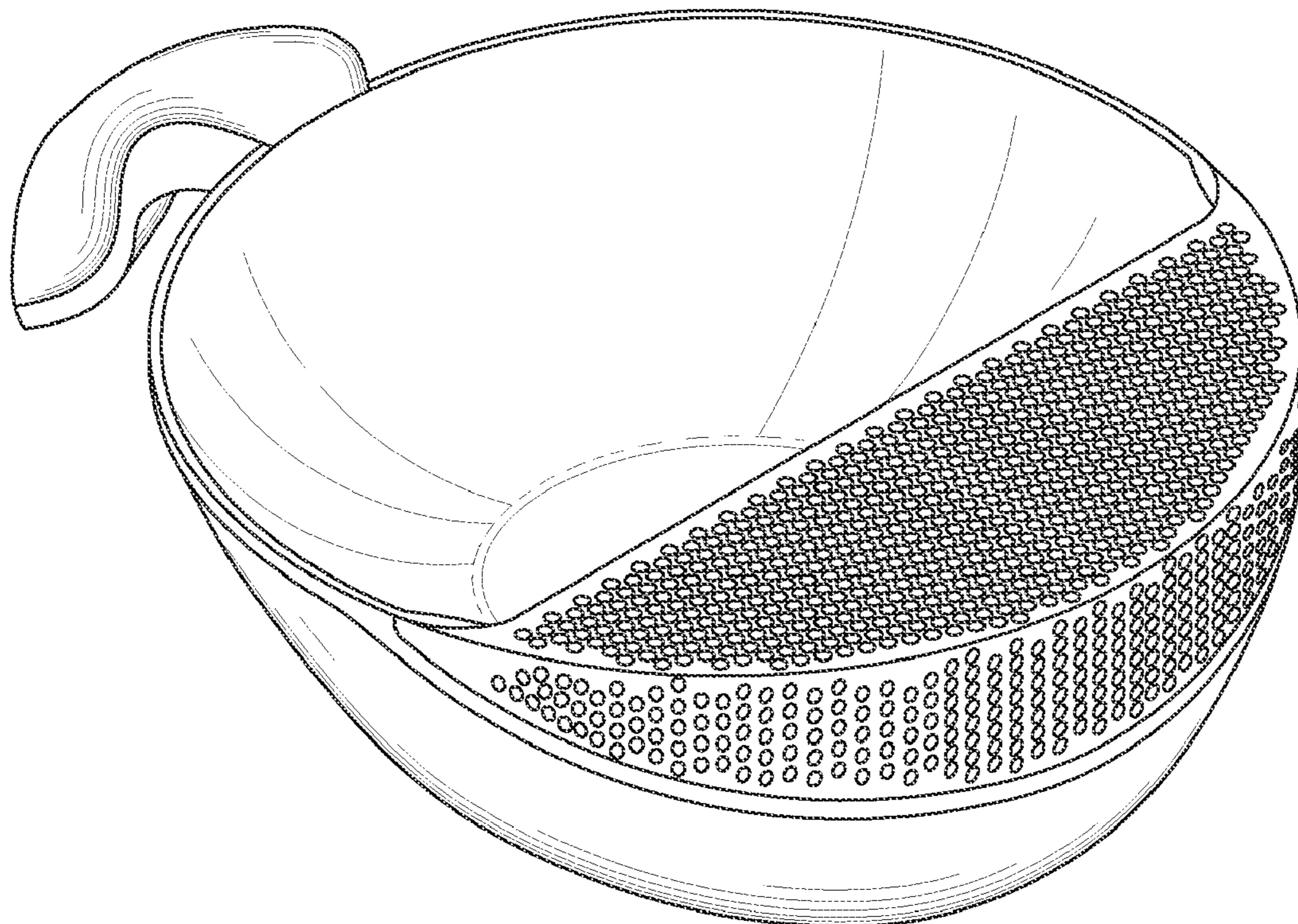

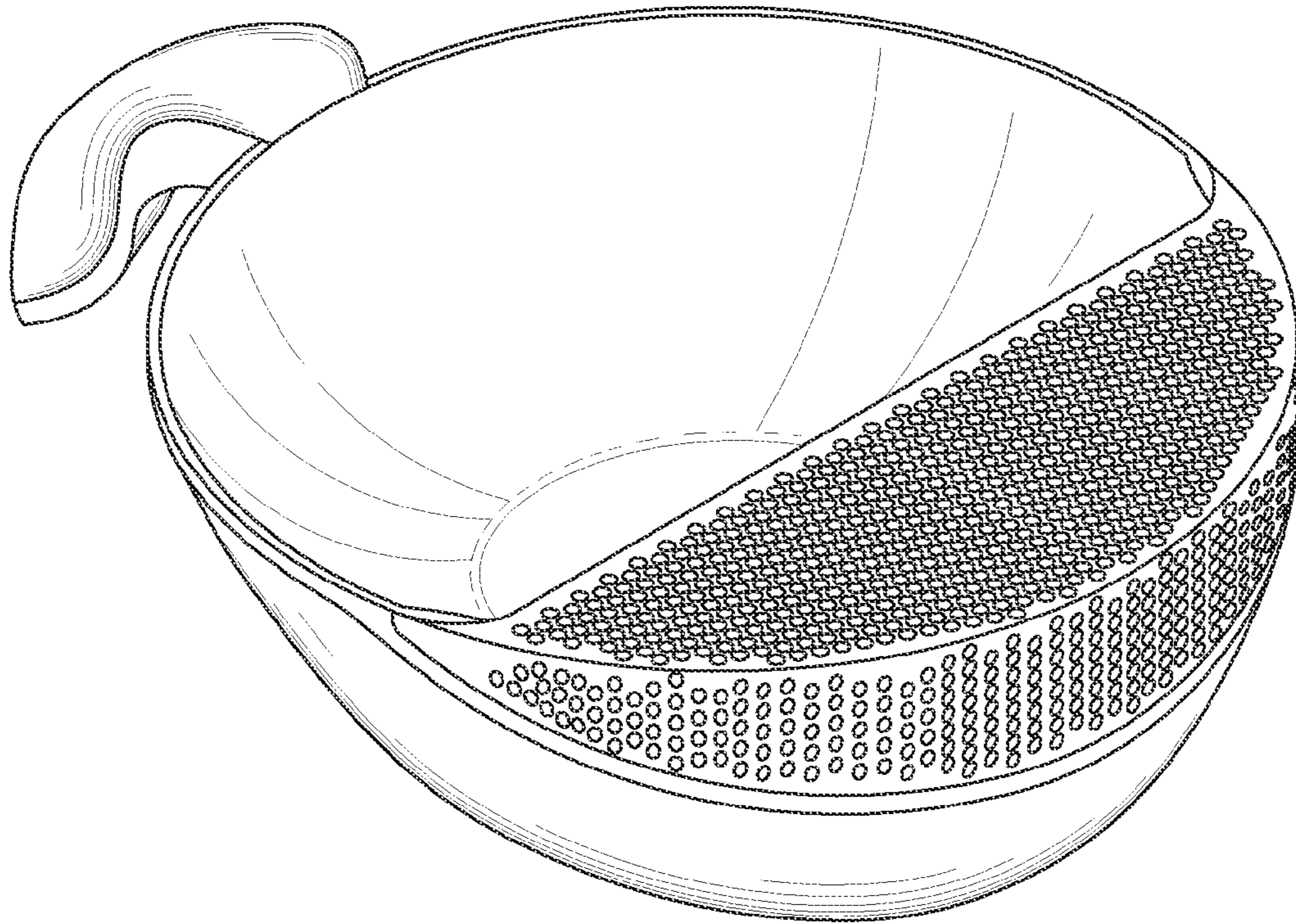

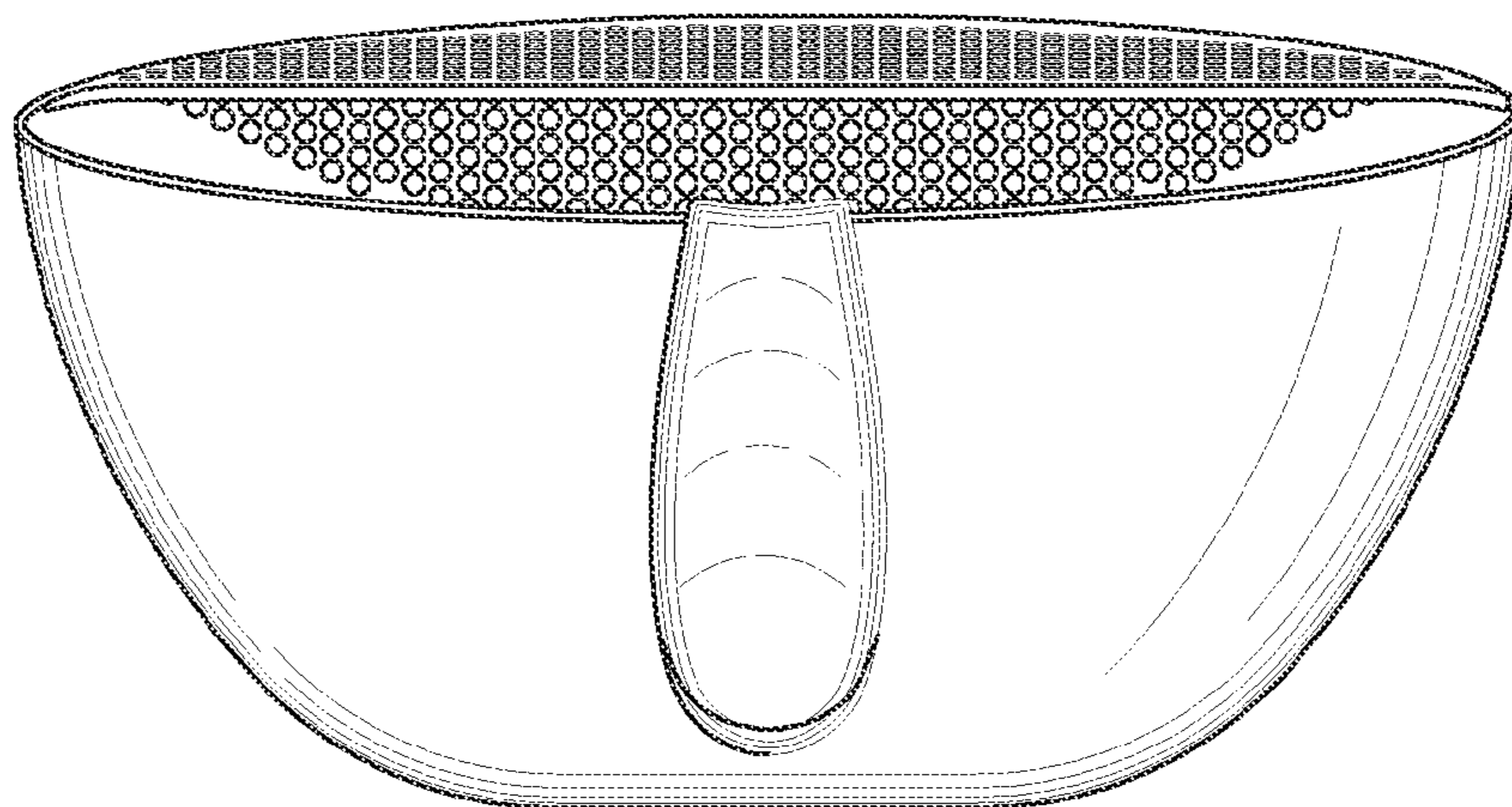

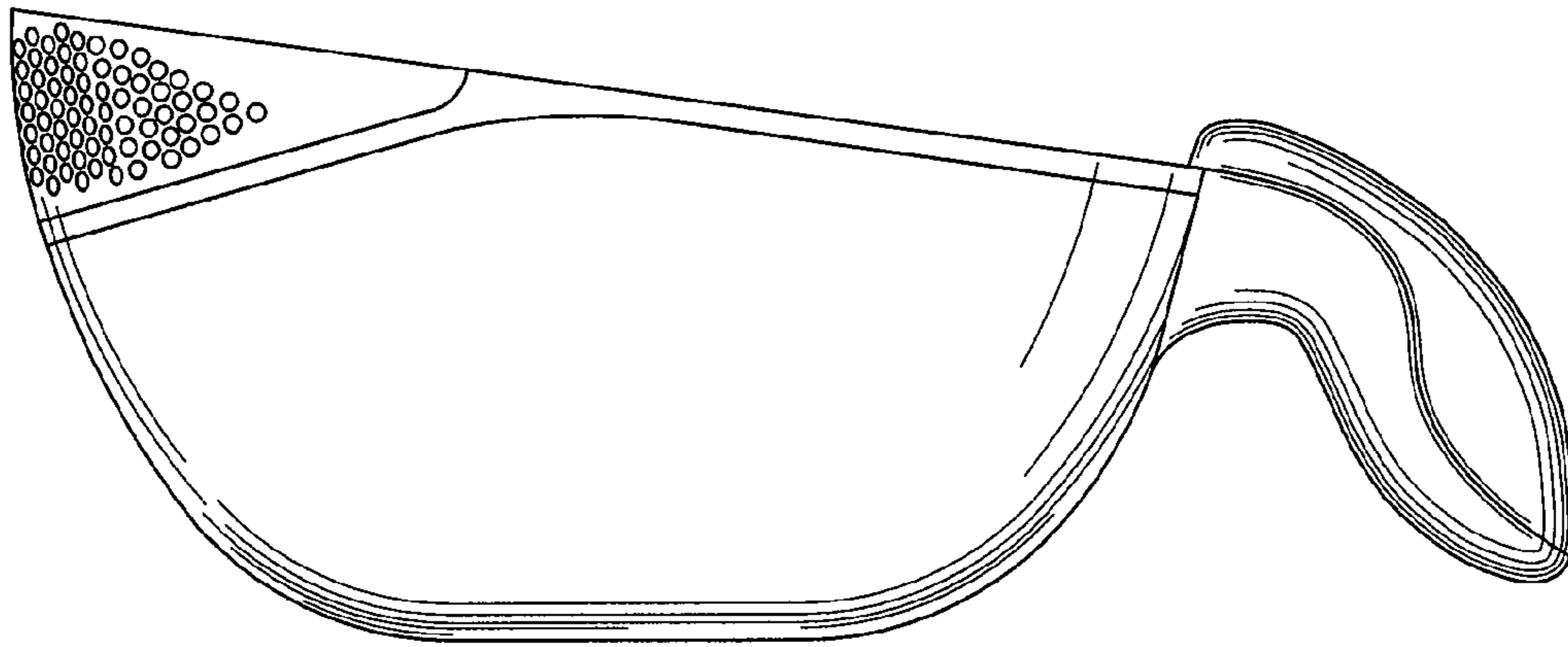

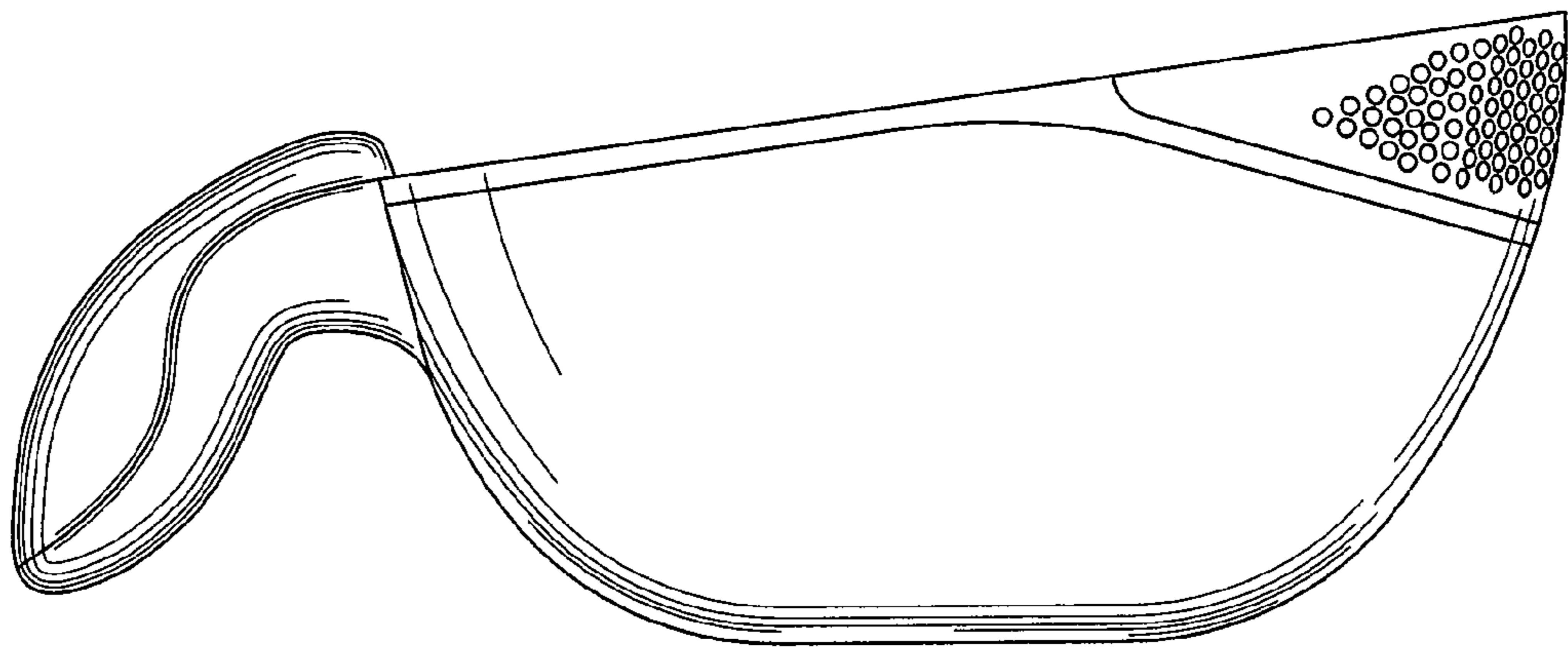

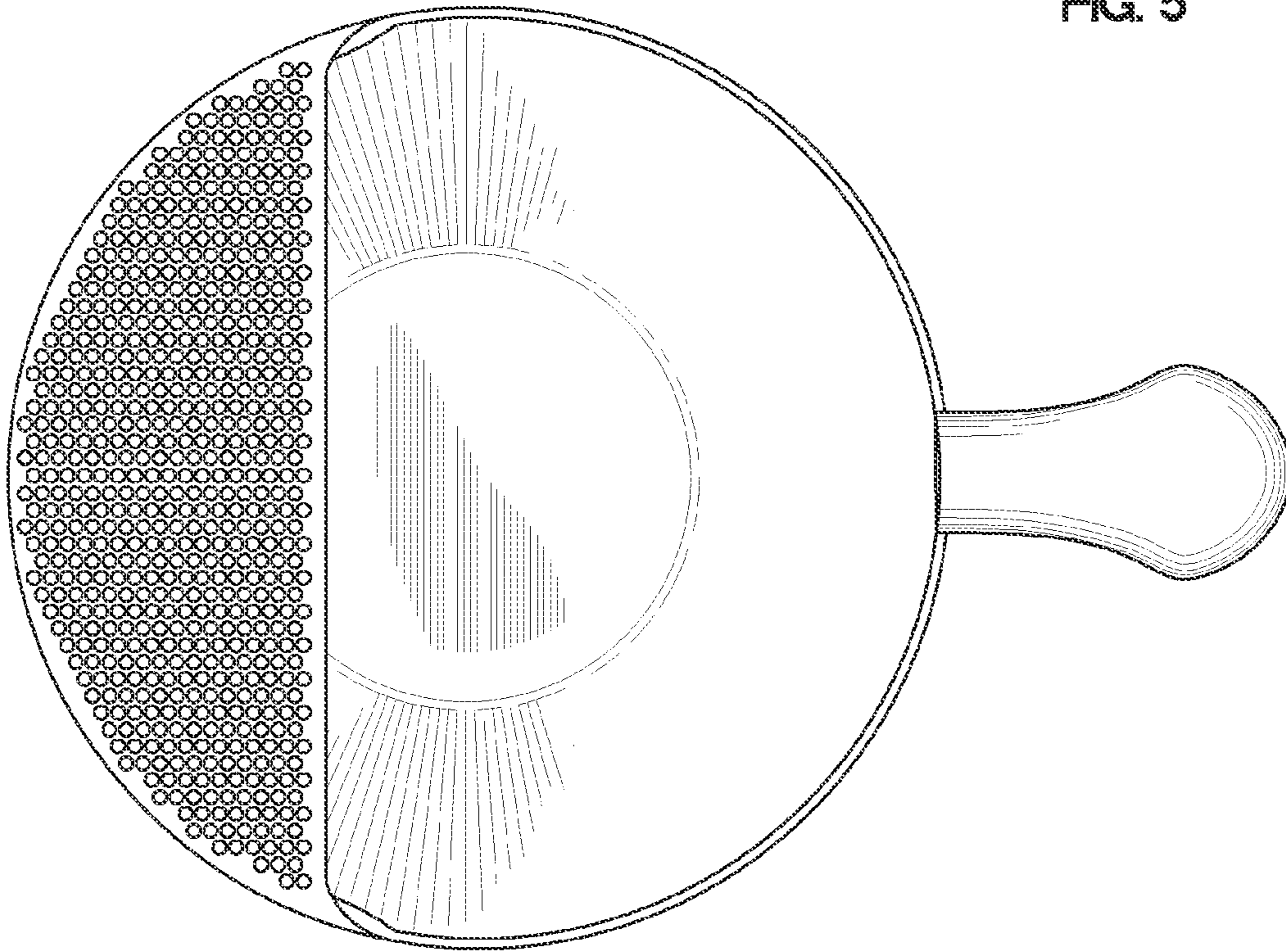

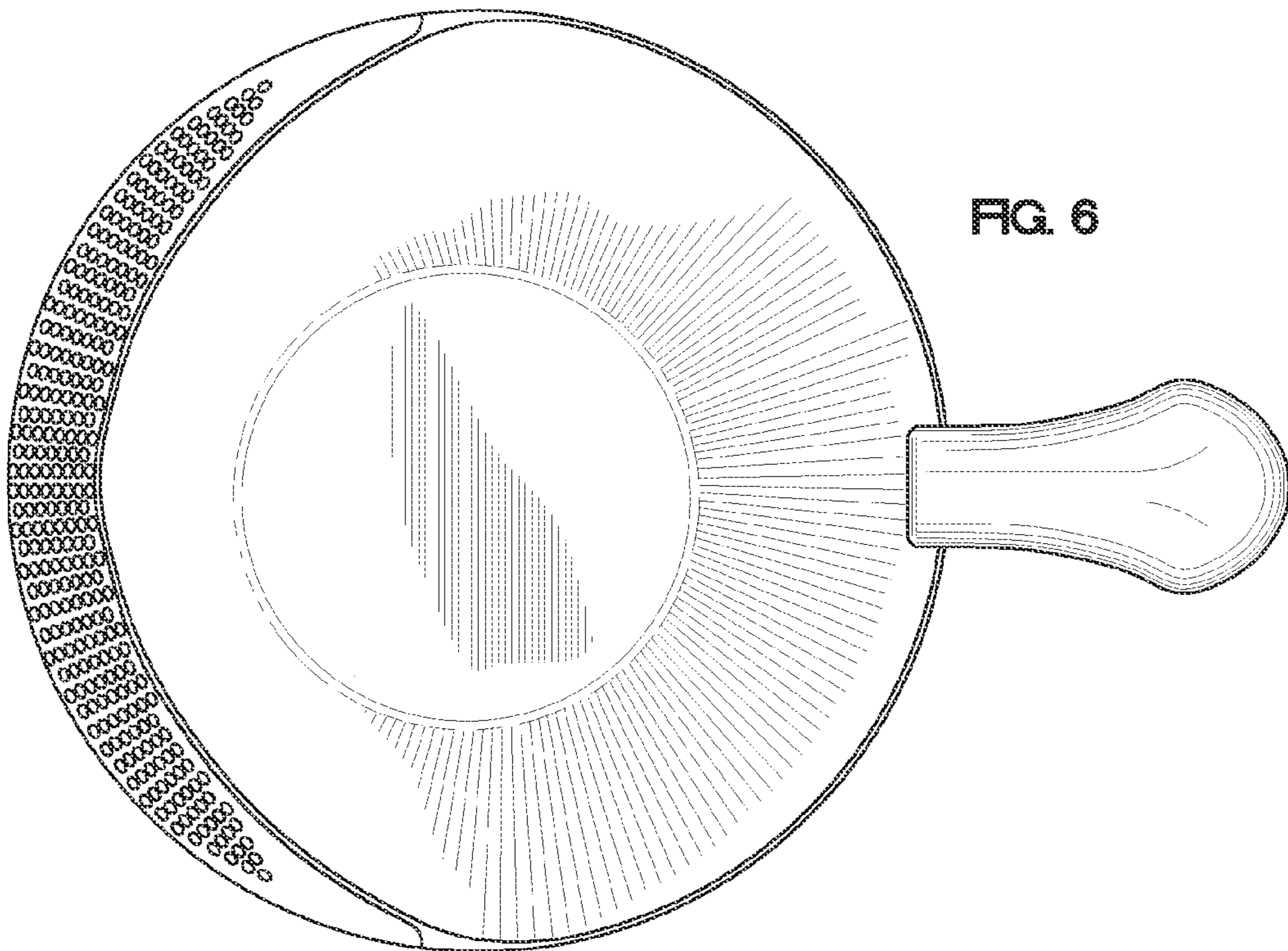
