The ornamental design for a pendant, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged top view of a first embodiment of the pendant;

FIG. 2 is an enlarged bottom view of the pendant illustrated in FIG. 1;

FIG. 3 is a right elevational view of the pendant illustrated in FIG. 1;

FIG. 4 is a left elevational view of the pendant illustrated in FIG. 1;

FIG. 5 is a front view of the pendant illustrated in FIG. 1;

FIG. 6 is a rear view of the pendant illustrated in FIG. 1;

FIG. 7 is a perspective view of the pendant illustrated in FIG. 1

FIG. 8 is an enlarged top view of a second embodiment of the pendant;

FIG. 9 is an enlarged bottom view of the pendant illustrated in FIG. 8;

FIG. 10 is a right elevational view of the pendant illustrated in FIG. 8;

FIG. 11 is a left elevational view of the pendant illustrated in FIG. 8;

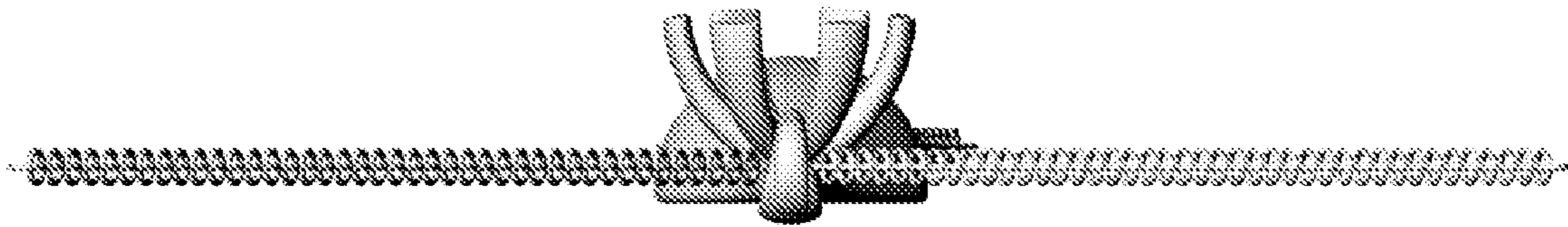

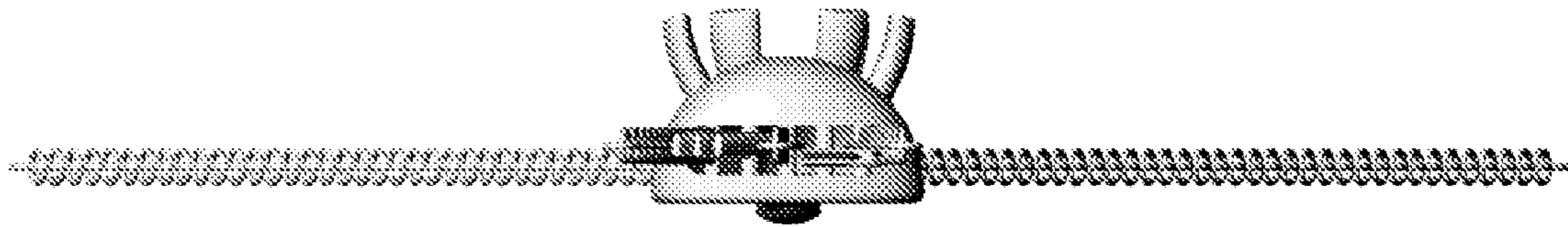

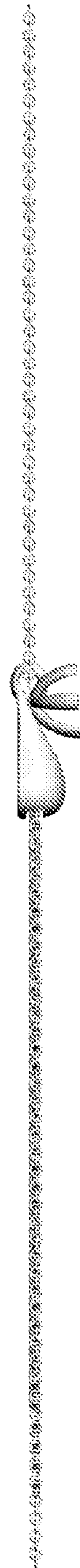

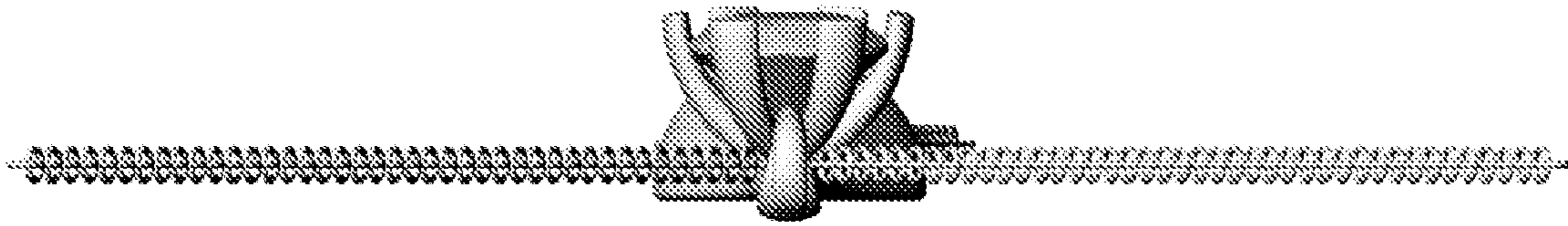

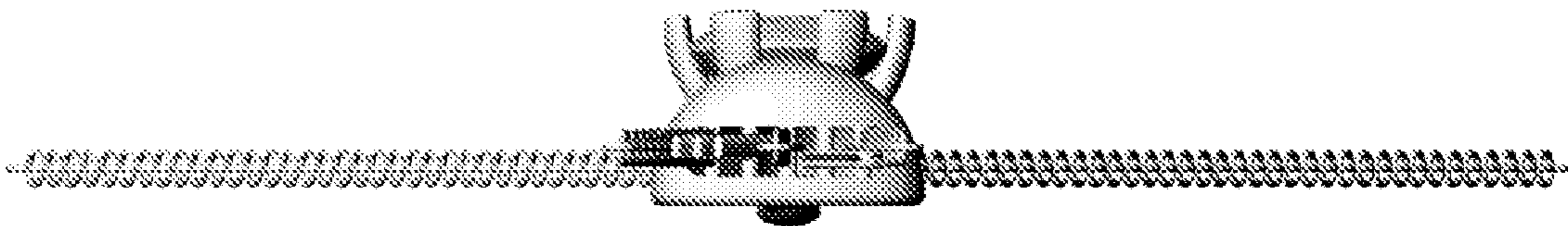

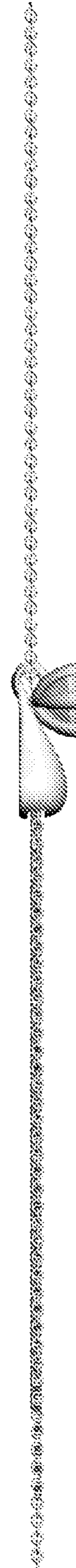
