I claim the ornamental design for a electric vehicle supply equipment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front-right perspective view of an embodiment of an electric vehicle supply equipment;

FIG. 2 is a front view of the electric vehicle supply equipment of FIG. 1;

FIG. 3 is a rear view of the electric vehicle supply equipment of FIG. 1;

FIG. 4 is a left side view of the electric vehicle supply equipment of FIG. 1;

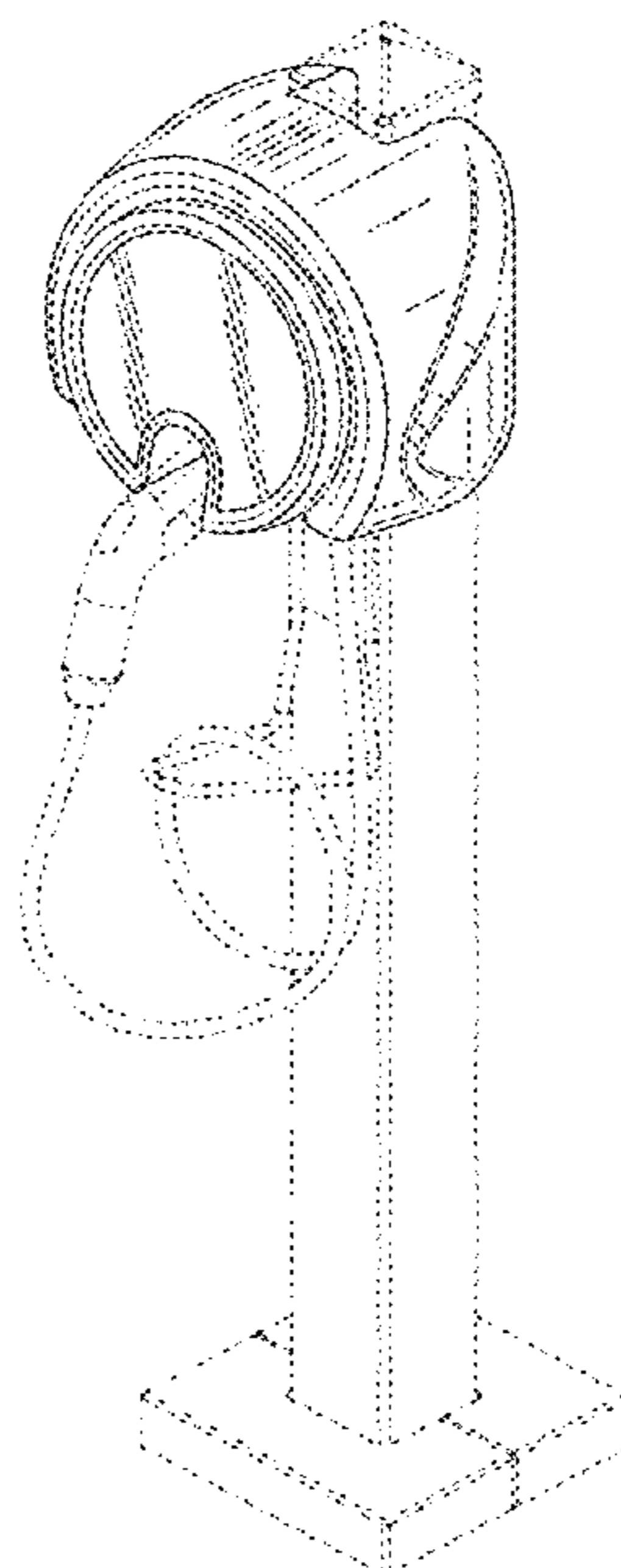
FIG. 5 is a right side view of the electric vehicle supply equipment of FIG. 1;

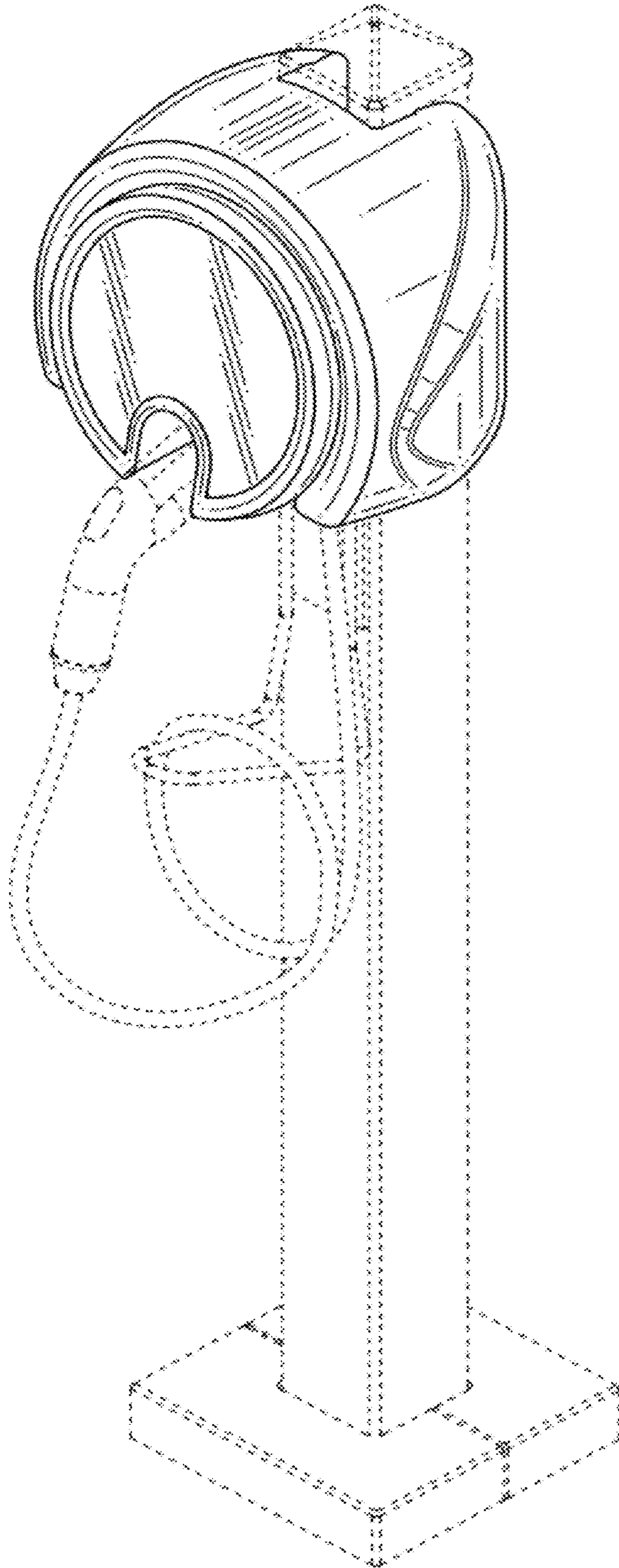

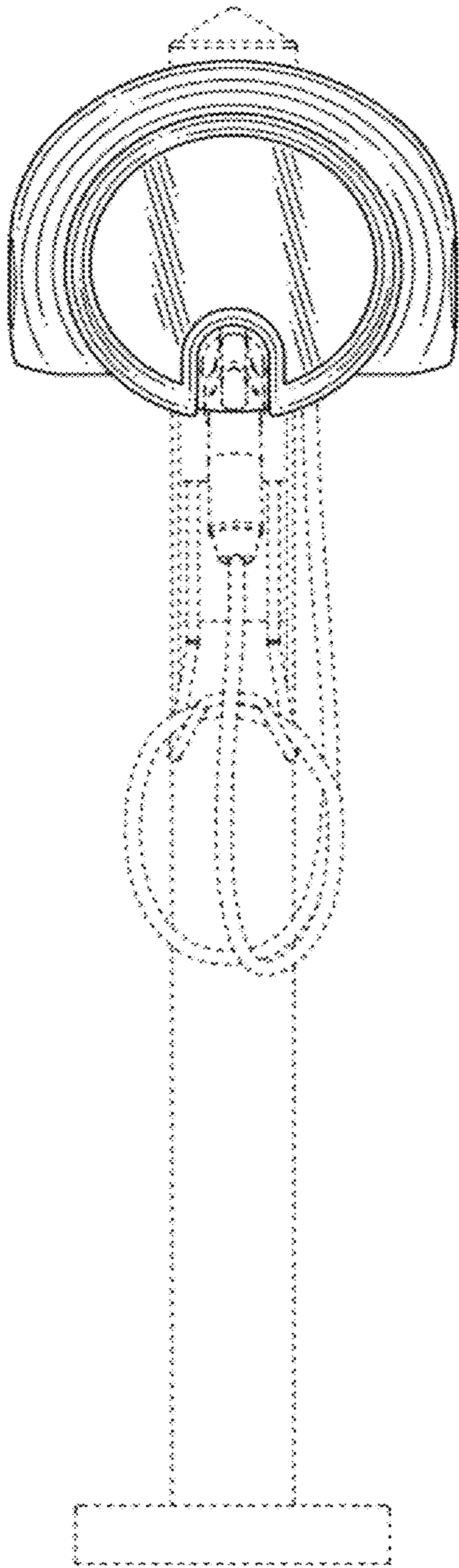

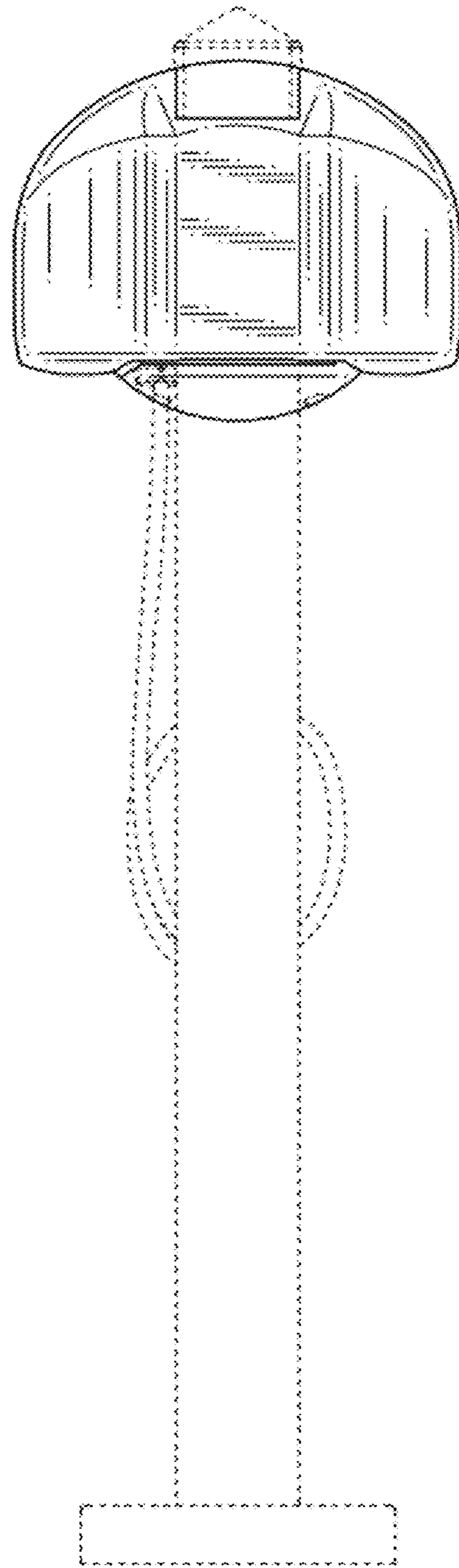

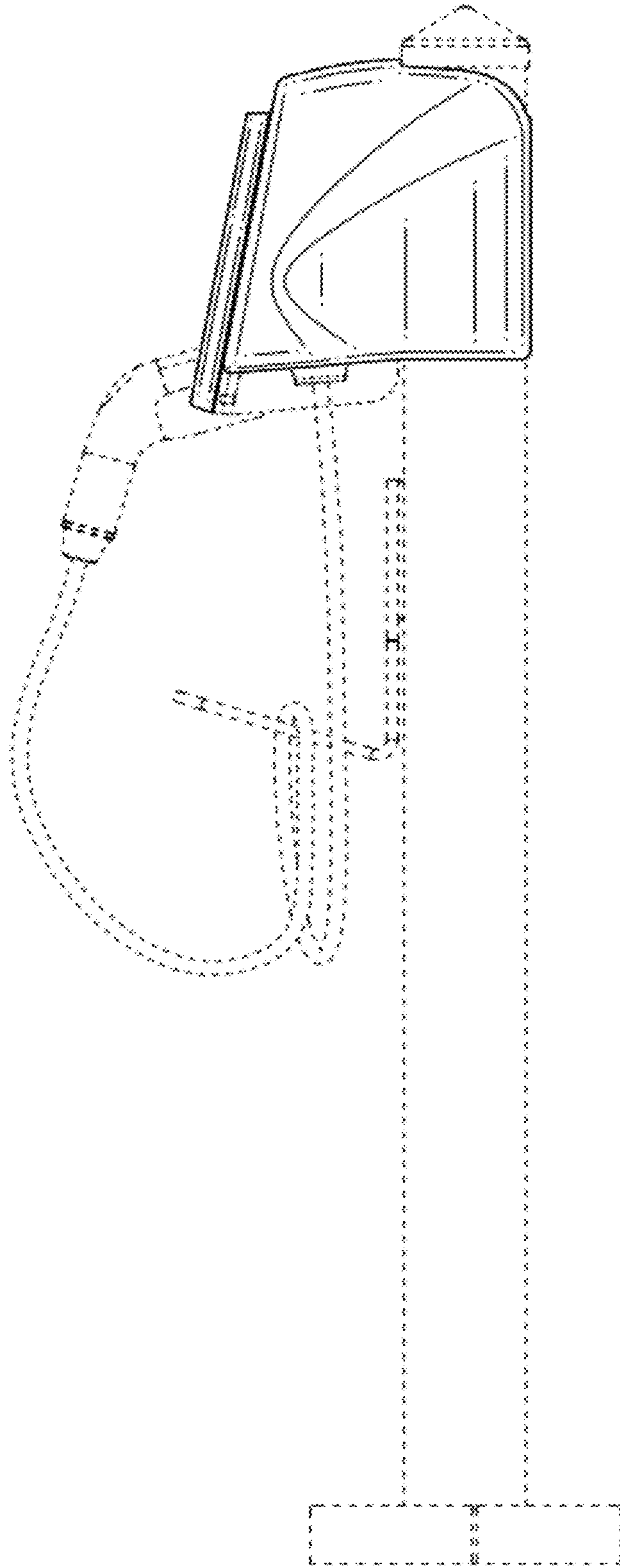

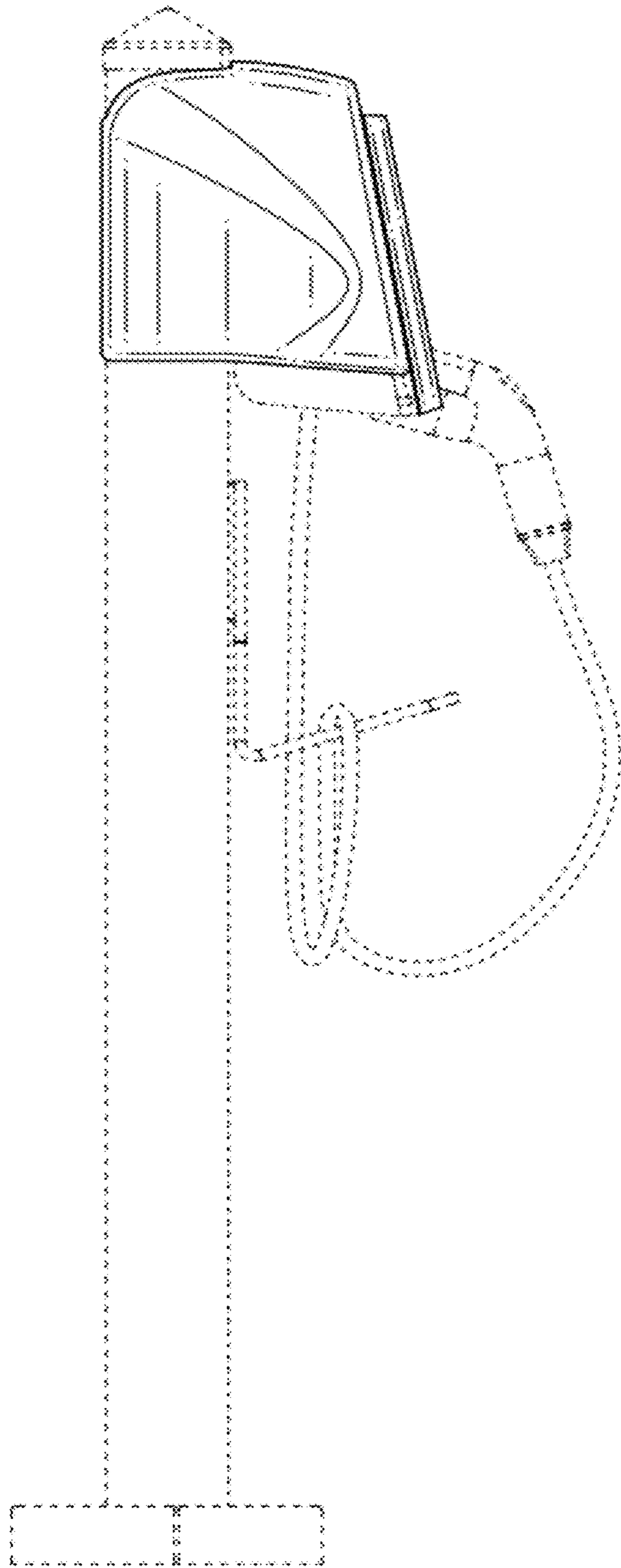

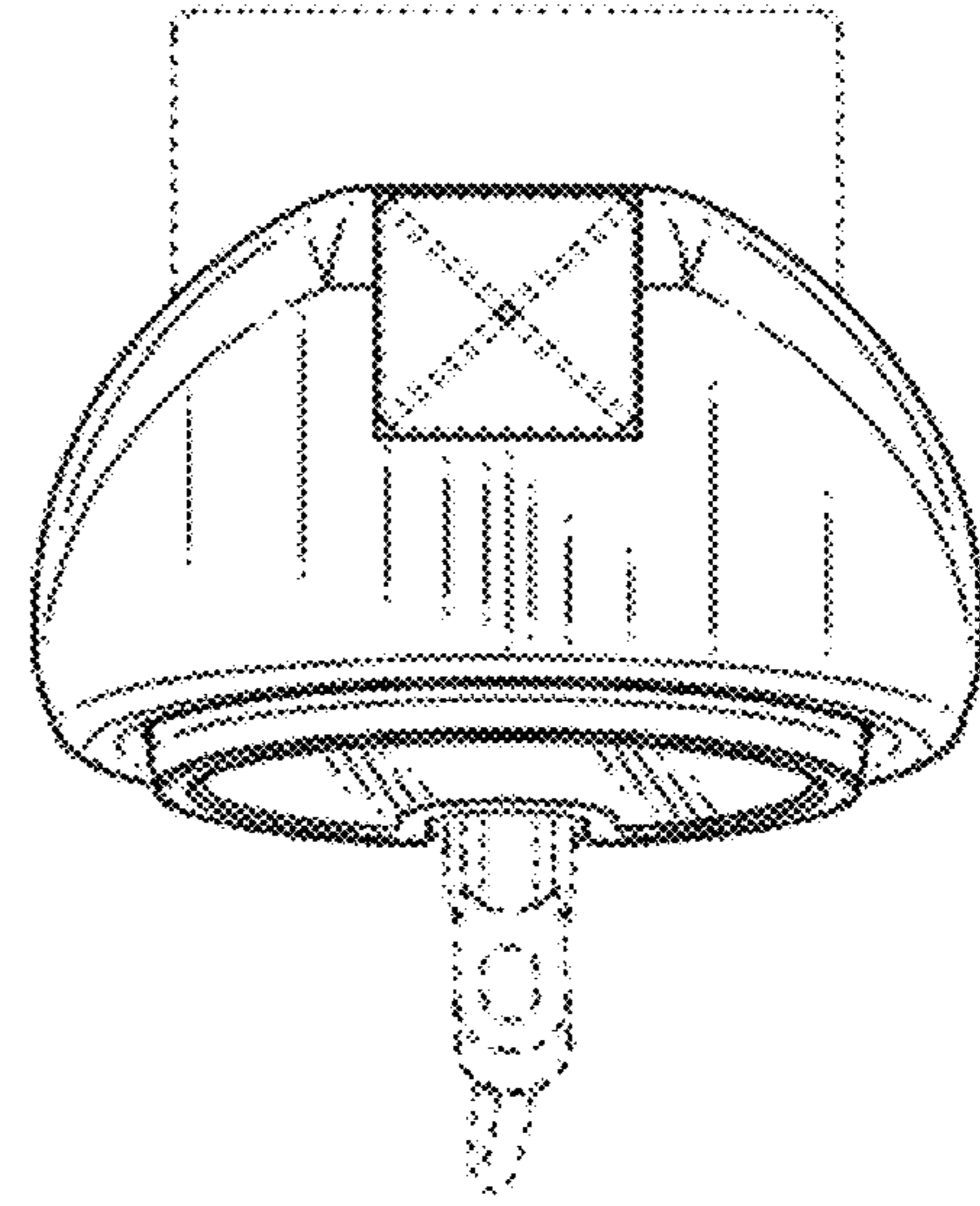

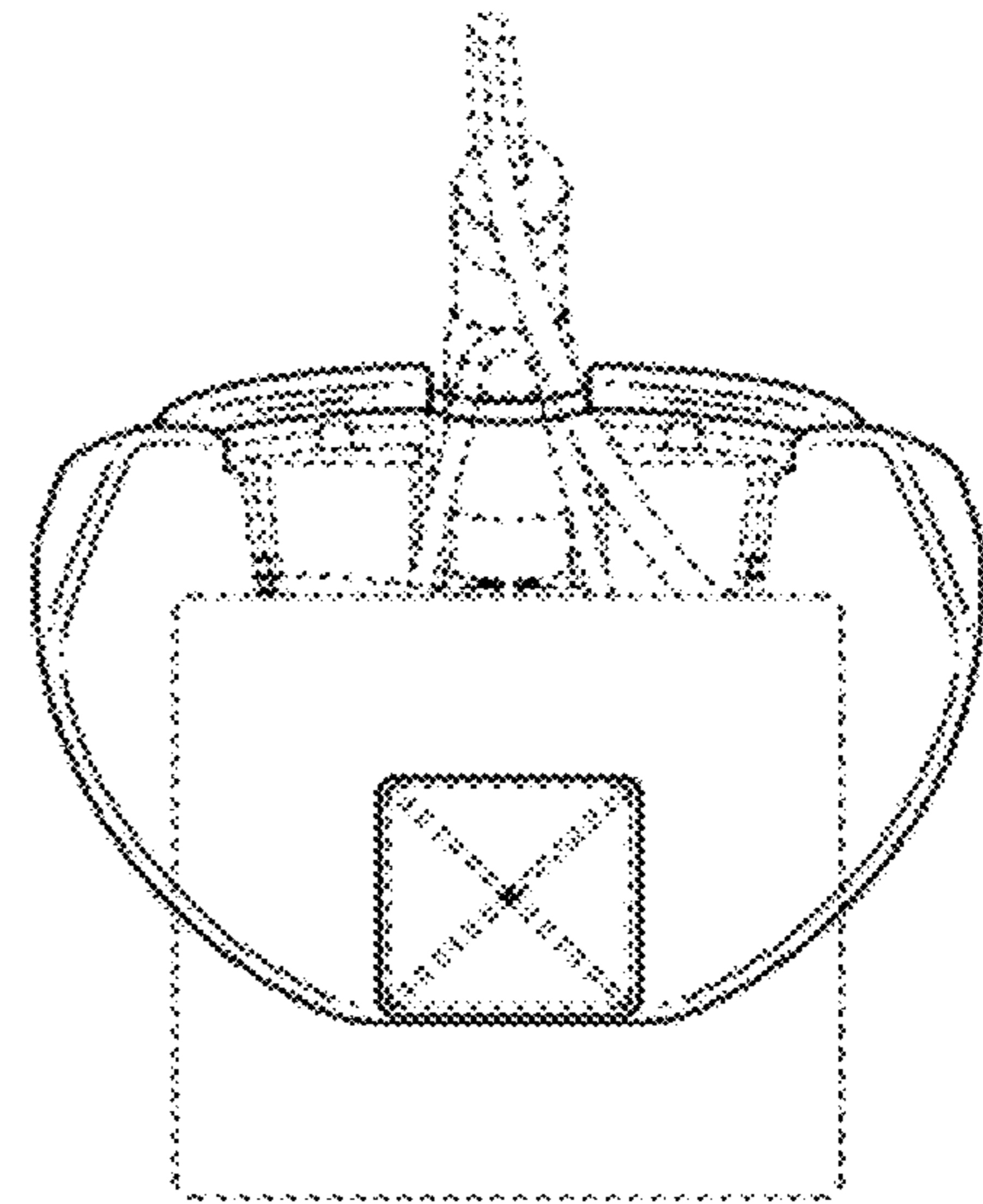
